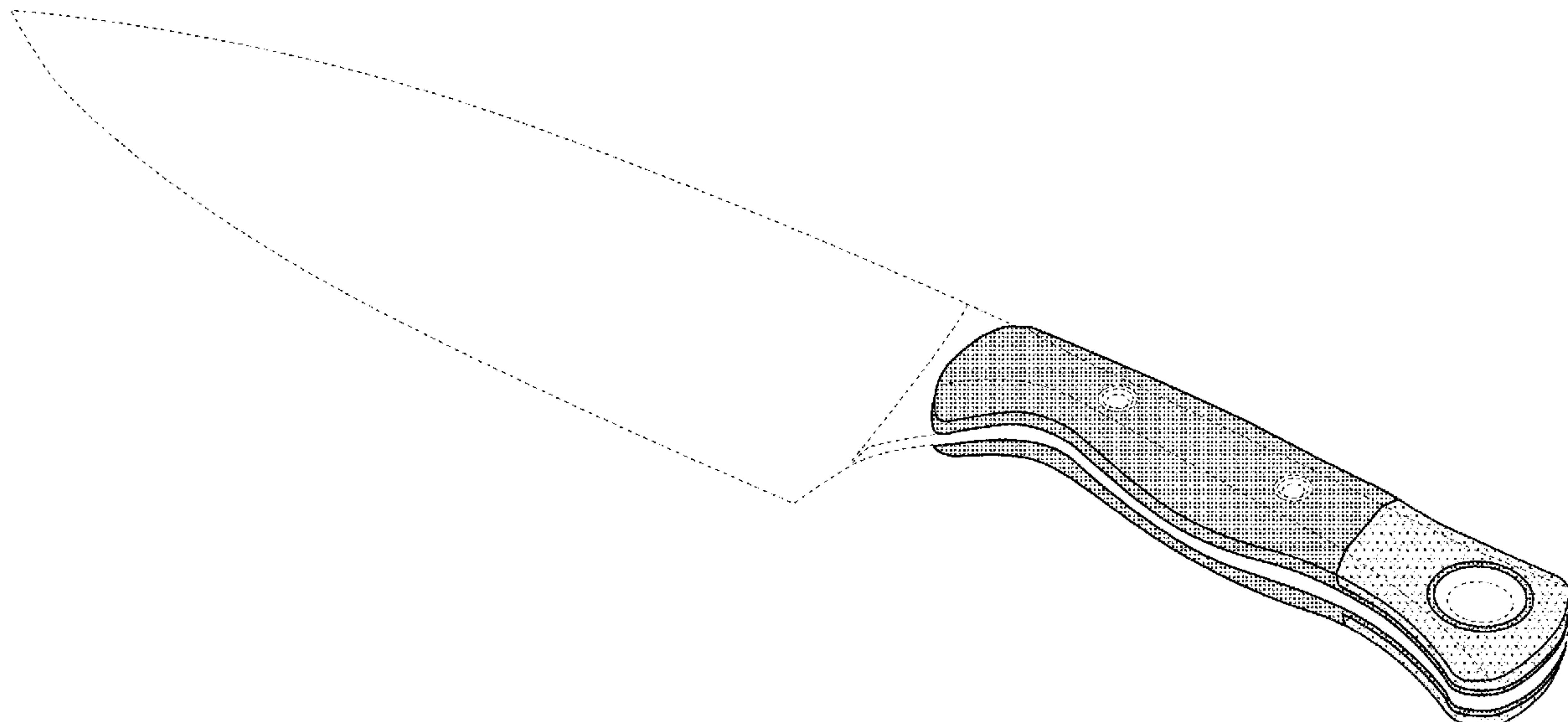
FIG. 1 is a perspective view of a knife, showing our new

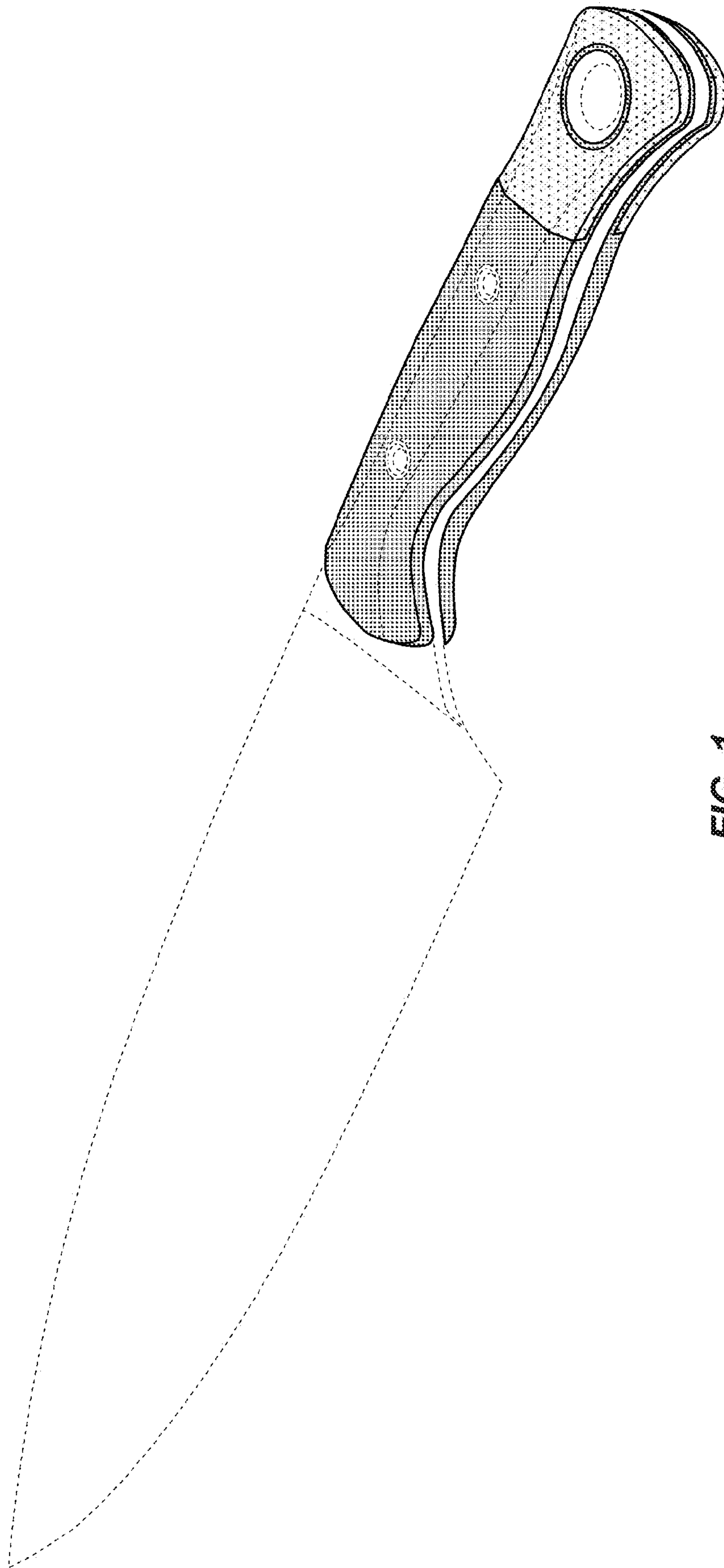

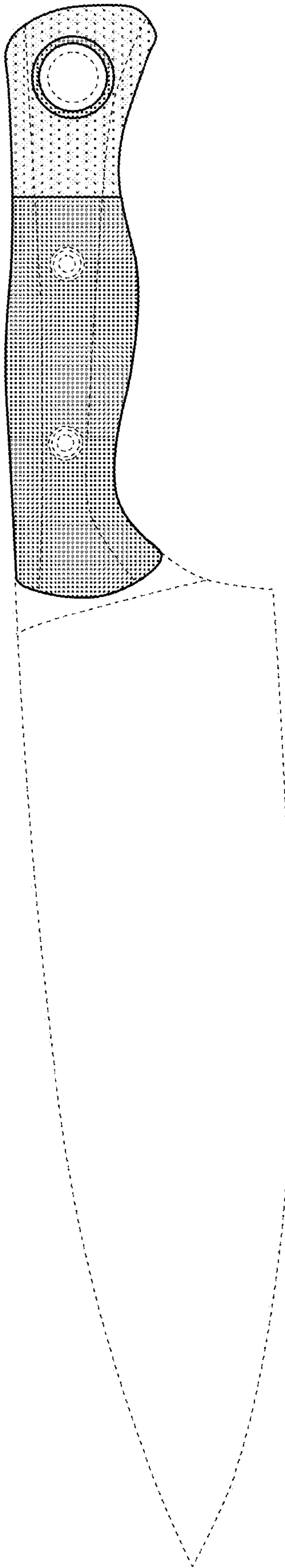

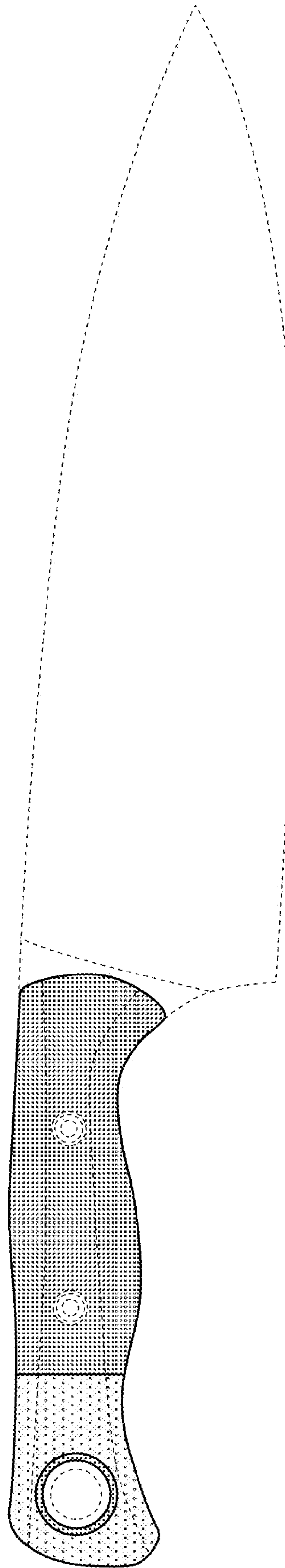

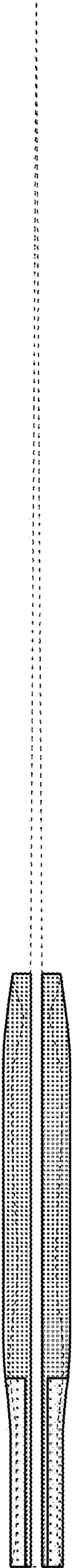

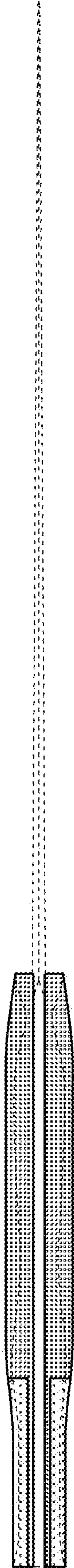

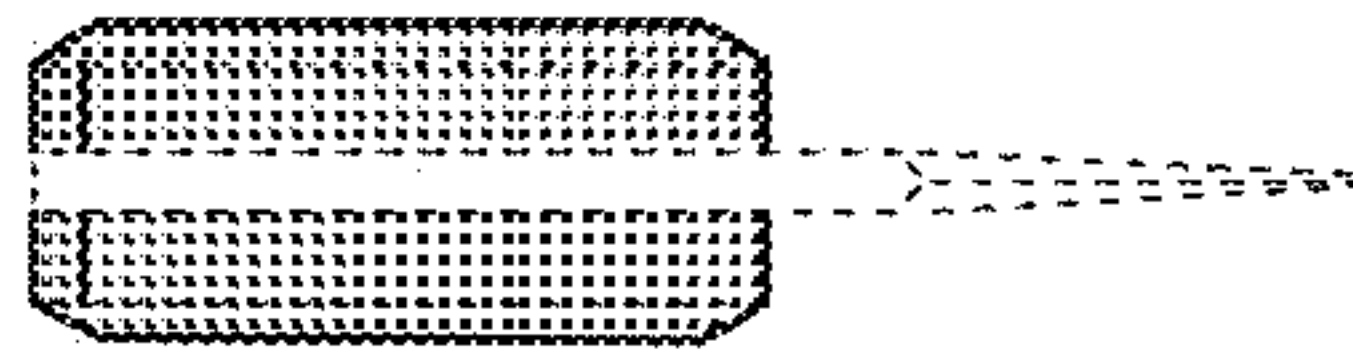

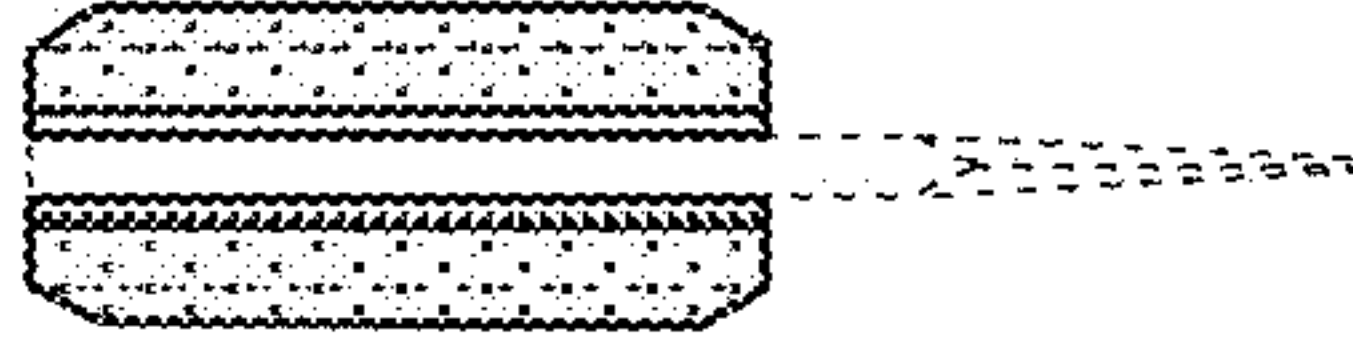

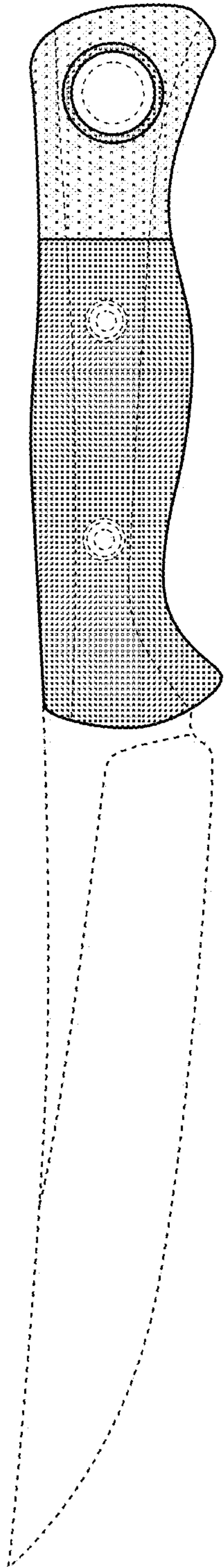

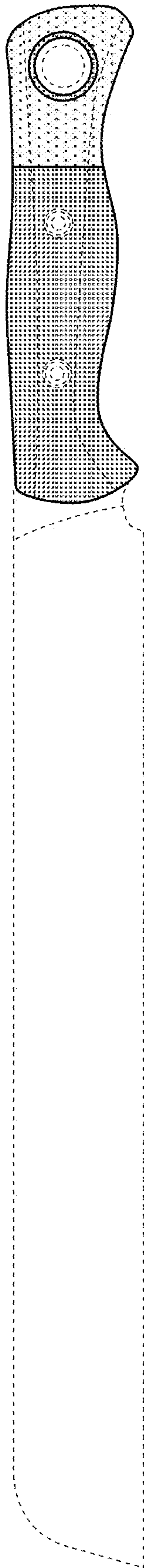

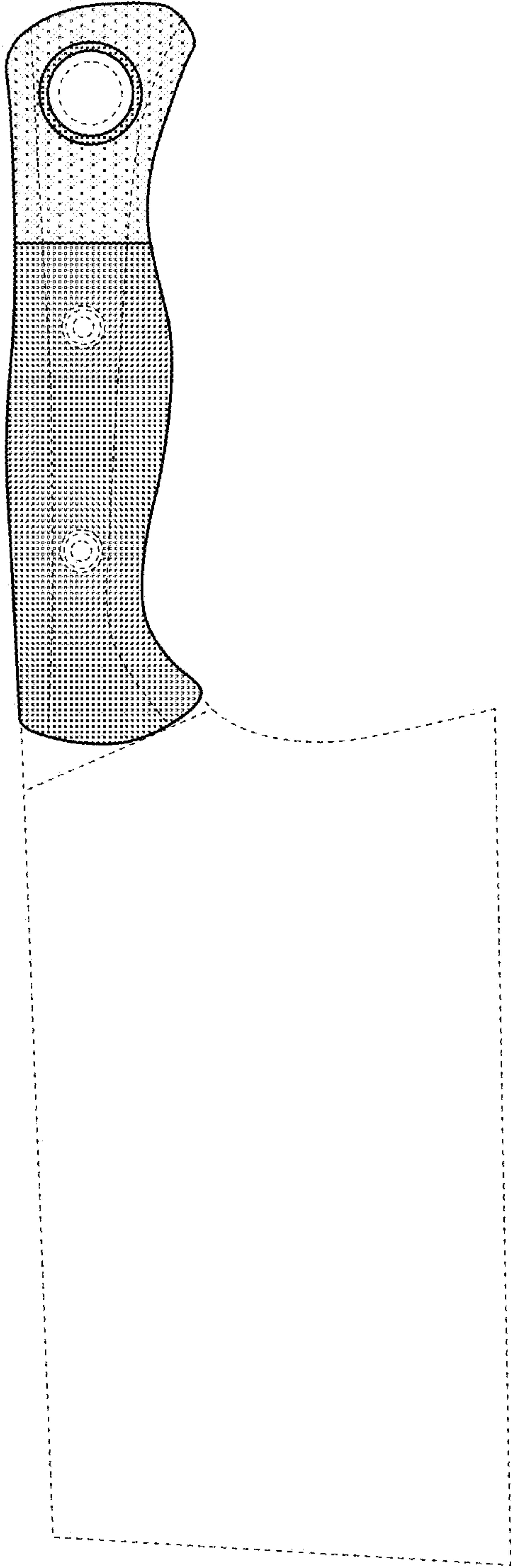

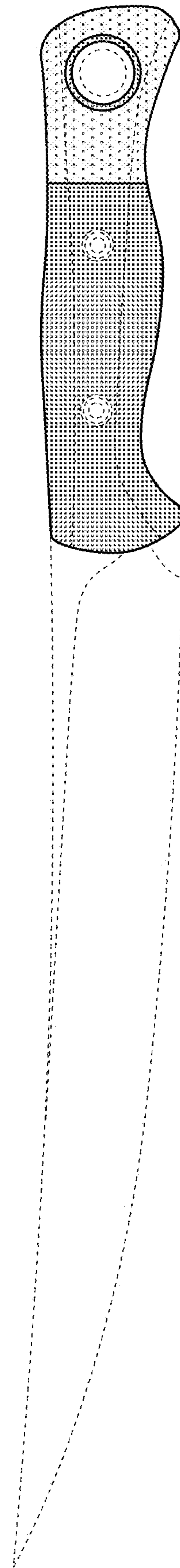
