FIG. 1 is a top perspective view of the cutting board my new design.

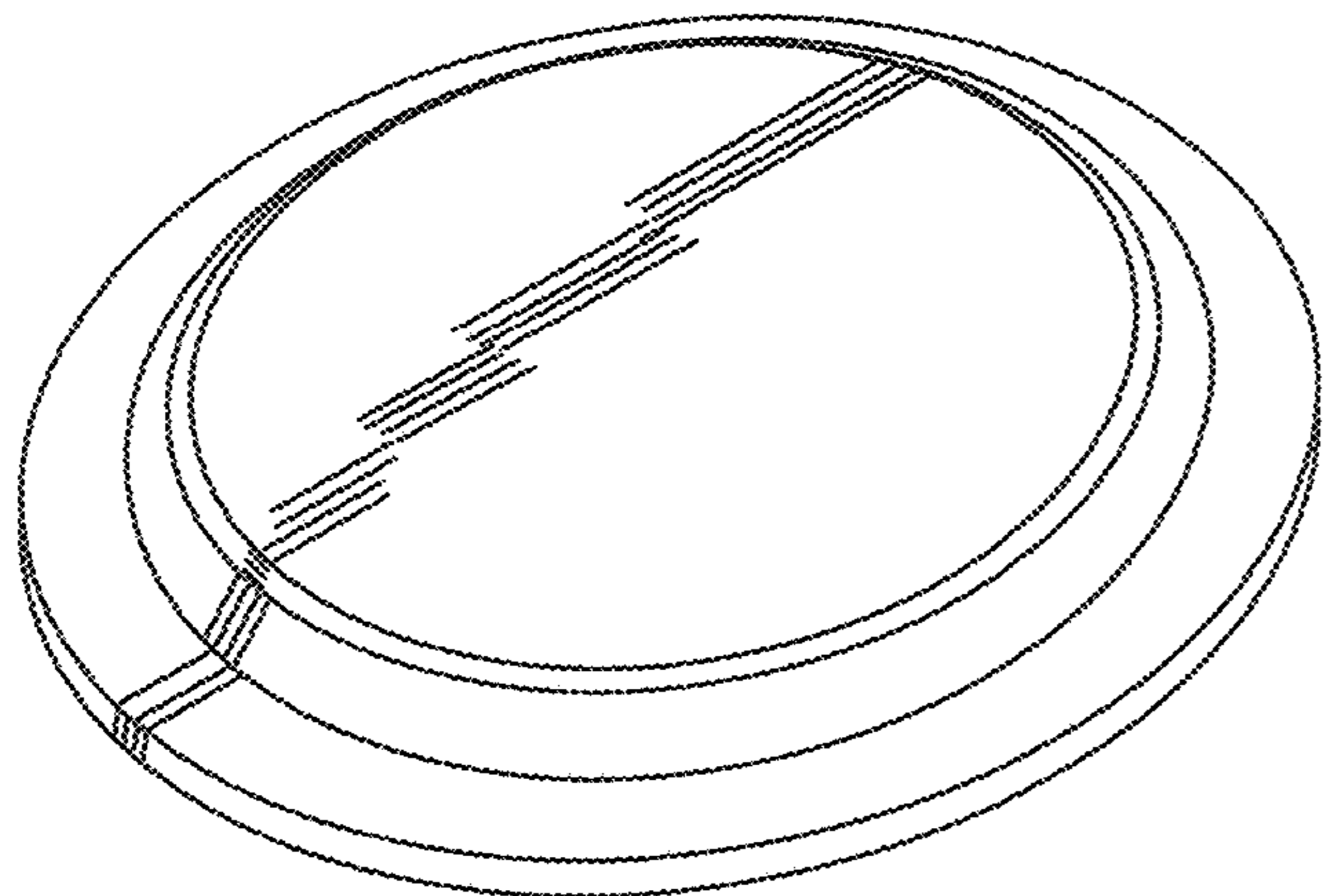
FIG. 2 is a side view elevation thereof;

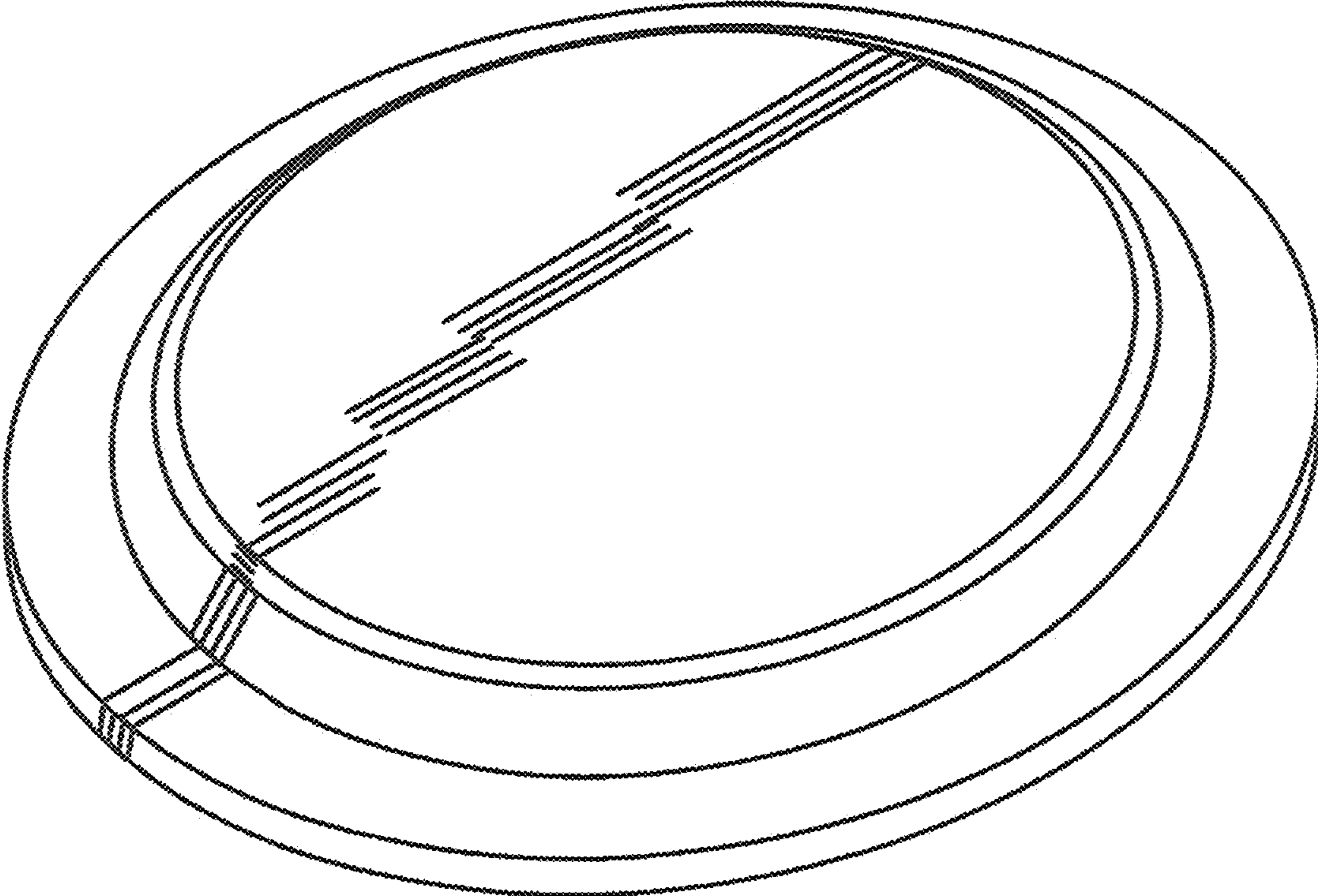

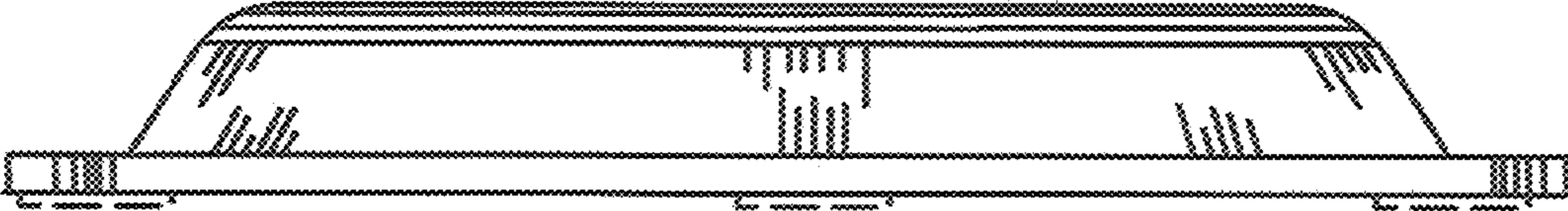

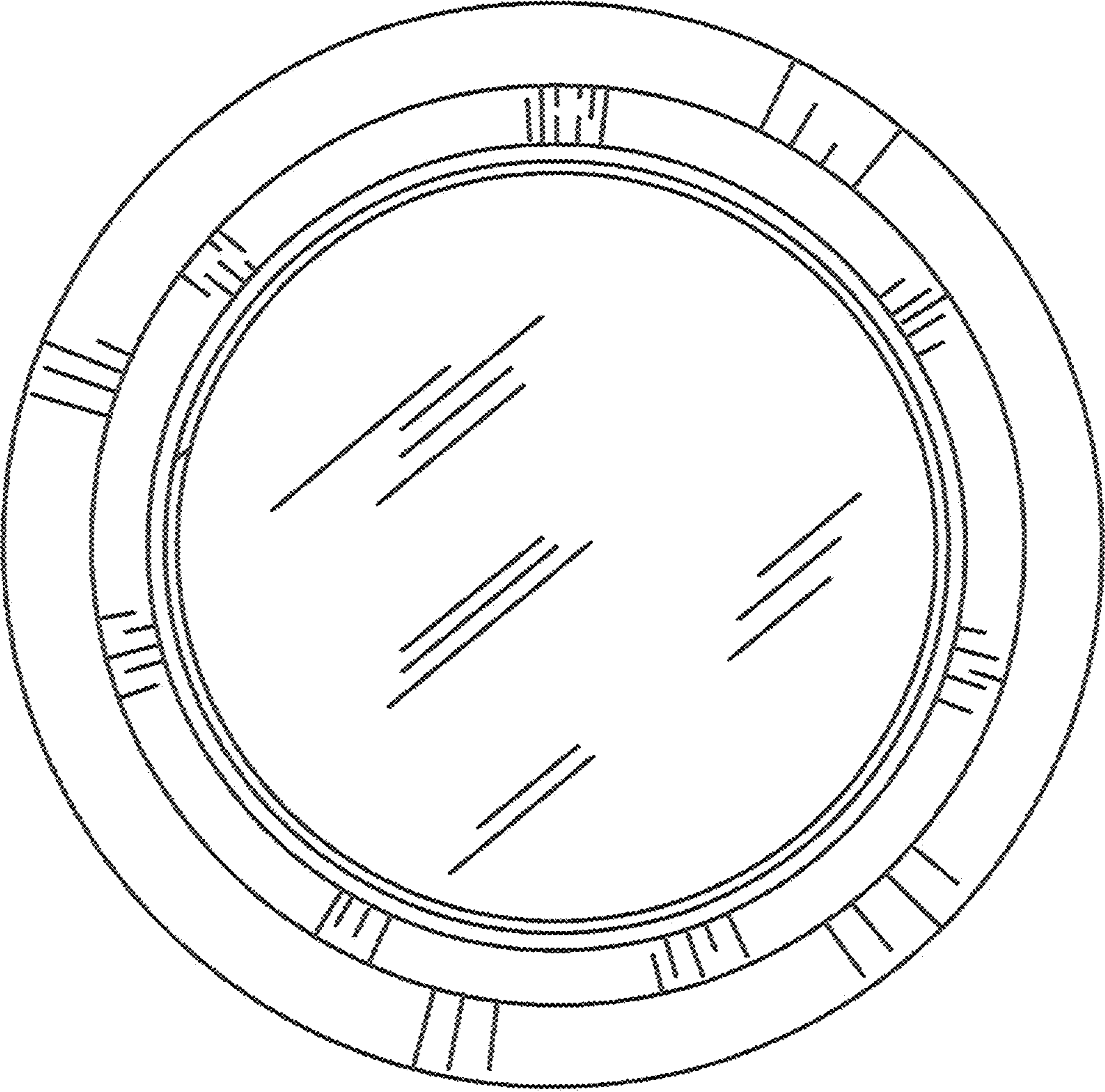

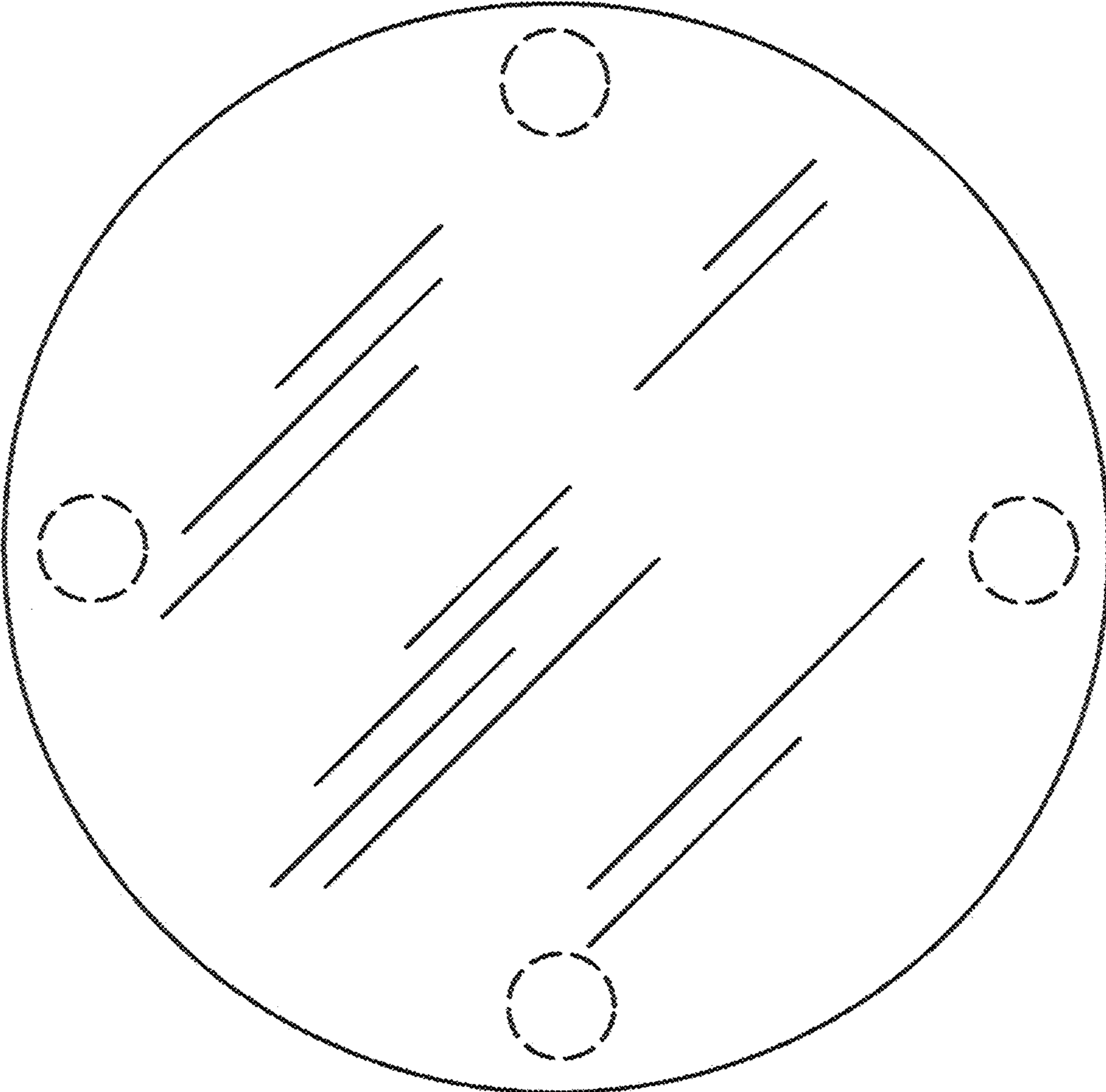
