(57) **CLAIM**

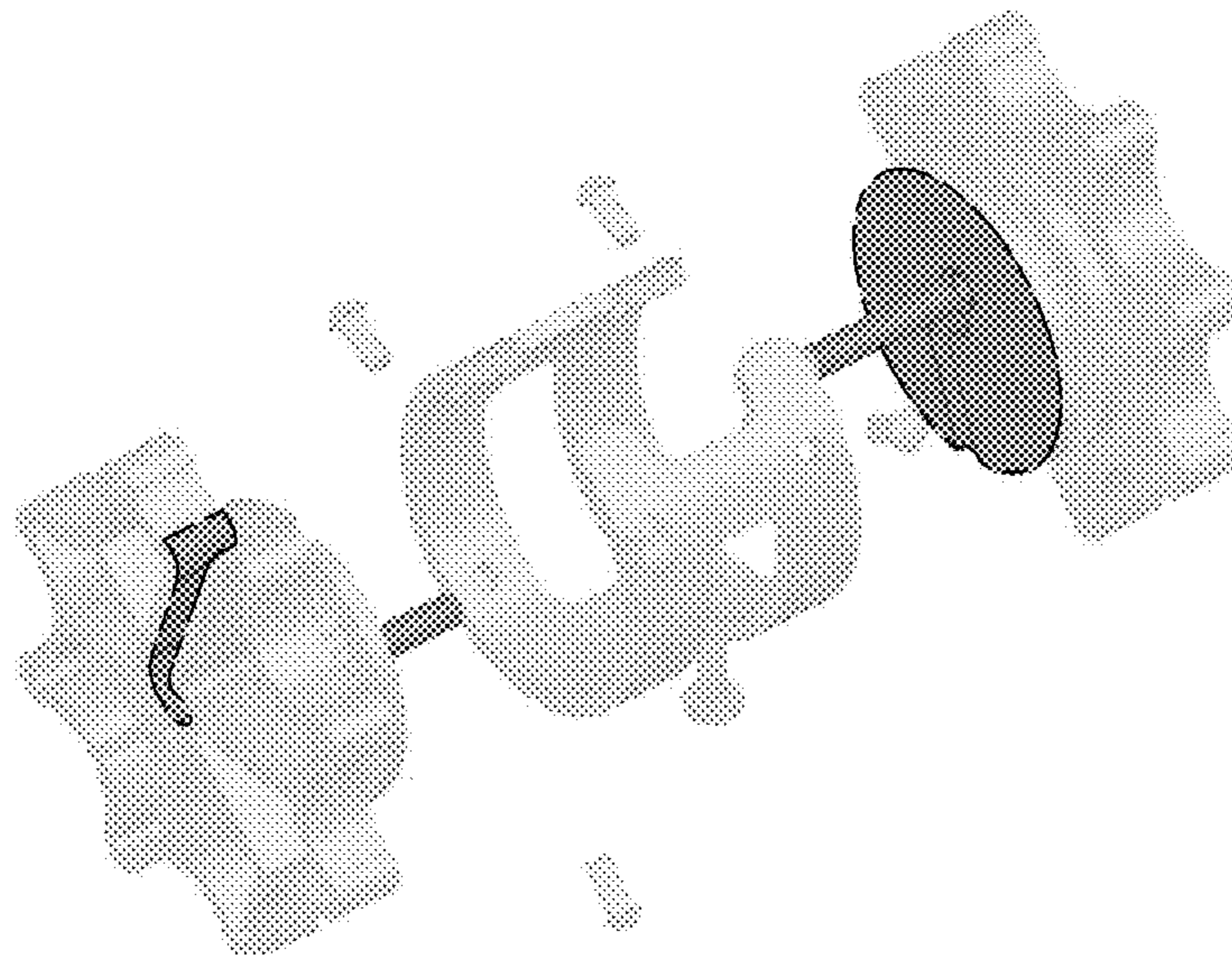
The ornamental design for a fencing tool, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a fencing tool showing my new design;  
 FIG. 2 is front view thereof;  
 FIG. 3 is a rear view thereof;  
 FIG. 4 is a left side view thereof;  
 FIG. 5 is a right side view thereof;  
 FIG. 6 is a top view thereof;

 FIG. 10 is an exploded rear view thereof;  
 FIG. 11 is an exploded left side view thereof;

 FIG. 13 is an exploded top view thereof; and,  
 FIG. 14 is an exploded bottom view thereof.

The greyscale shading shown in FIGS. 1-14 is provided solely for the purpose of showing surface contours. The dash-dot lines in FIGS. 1-14 and the areas within the dash-dot lines shown in phantom show portions of the fencing tool that form no part of the claimed design.

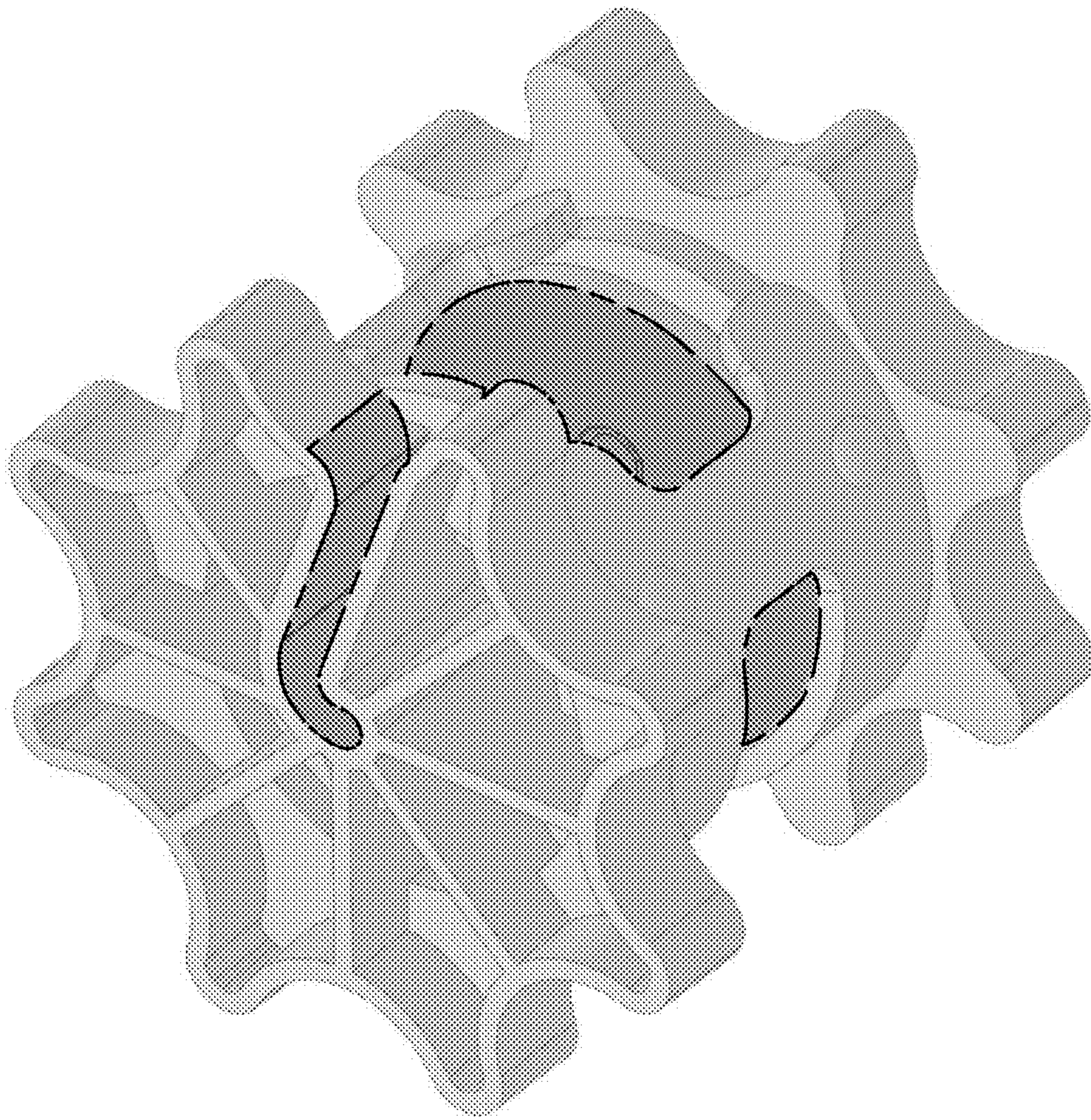

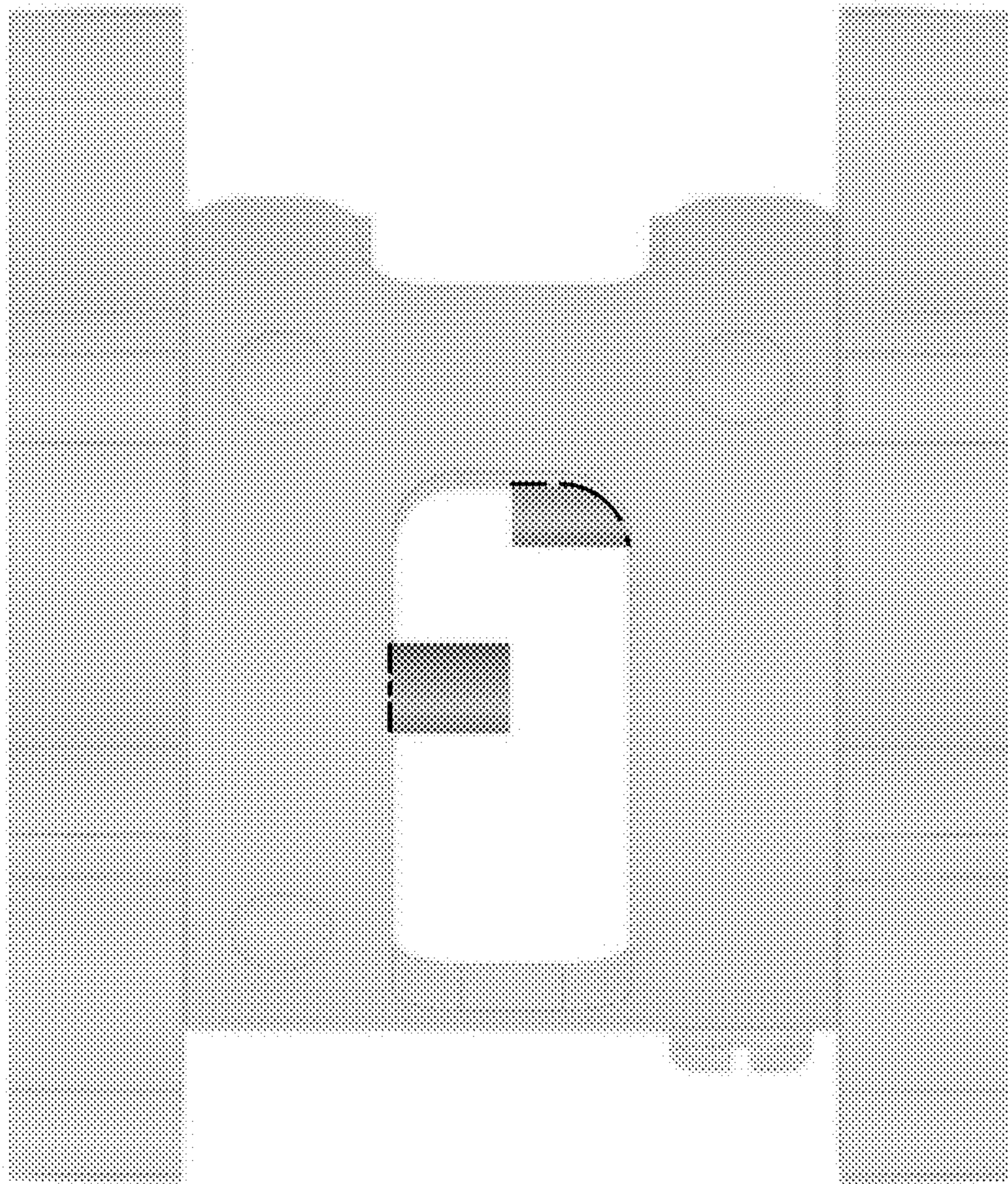

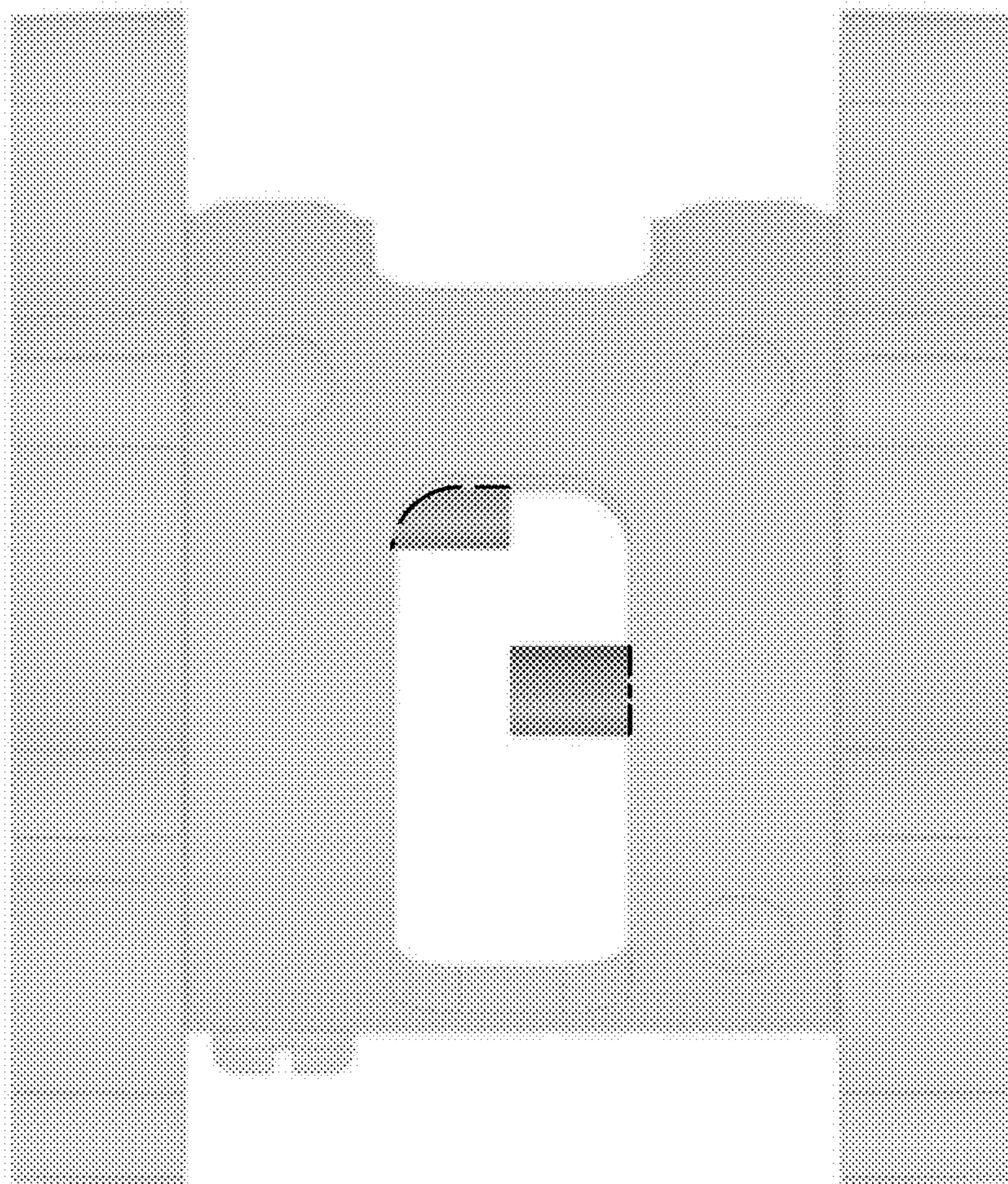

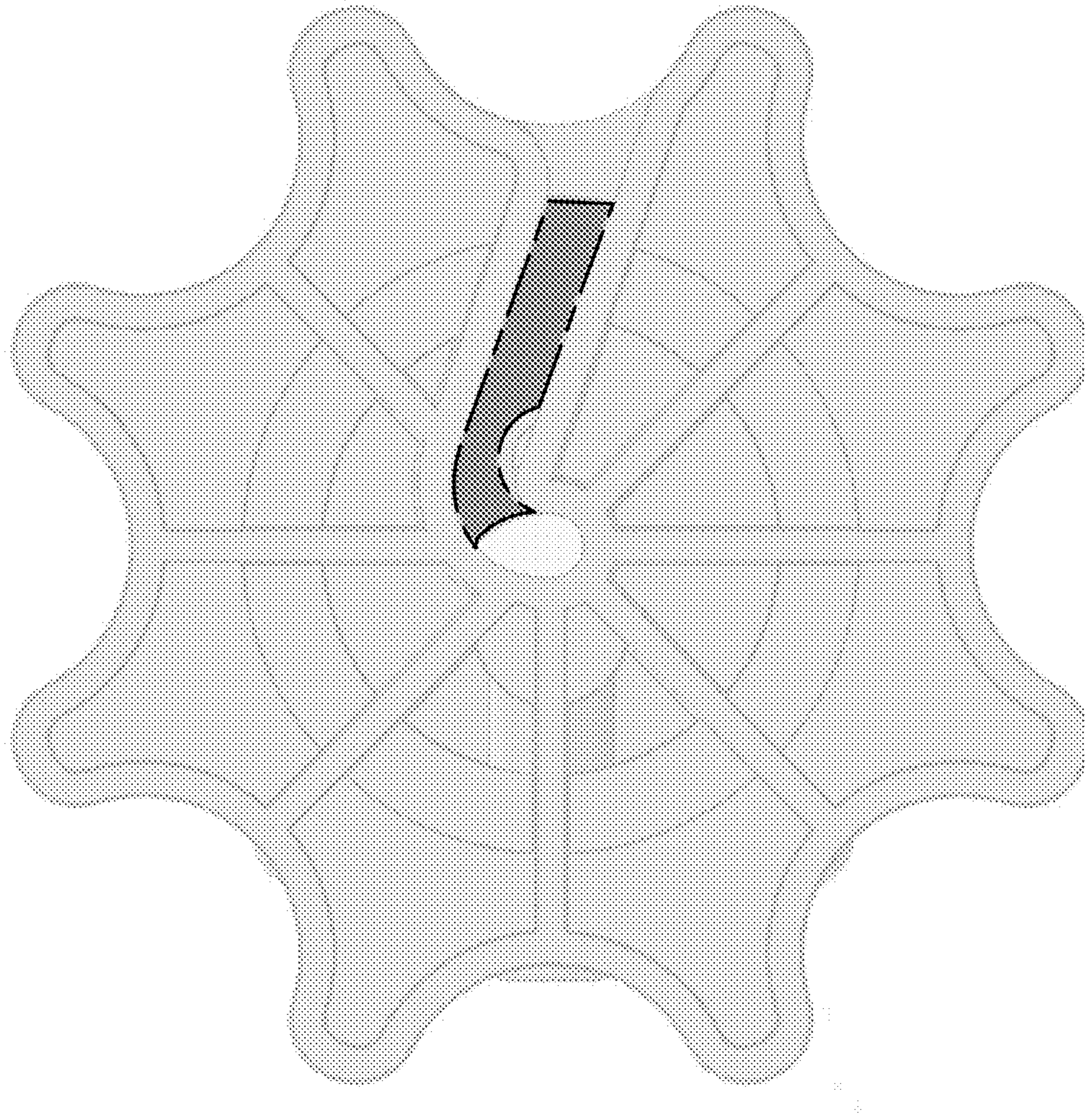

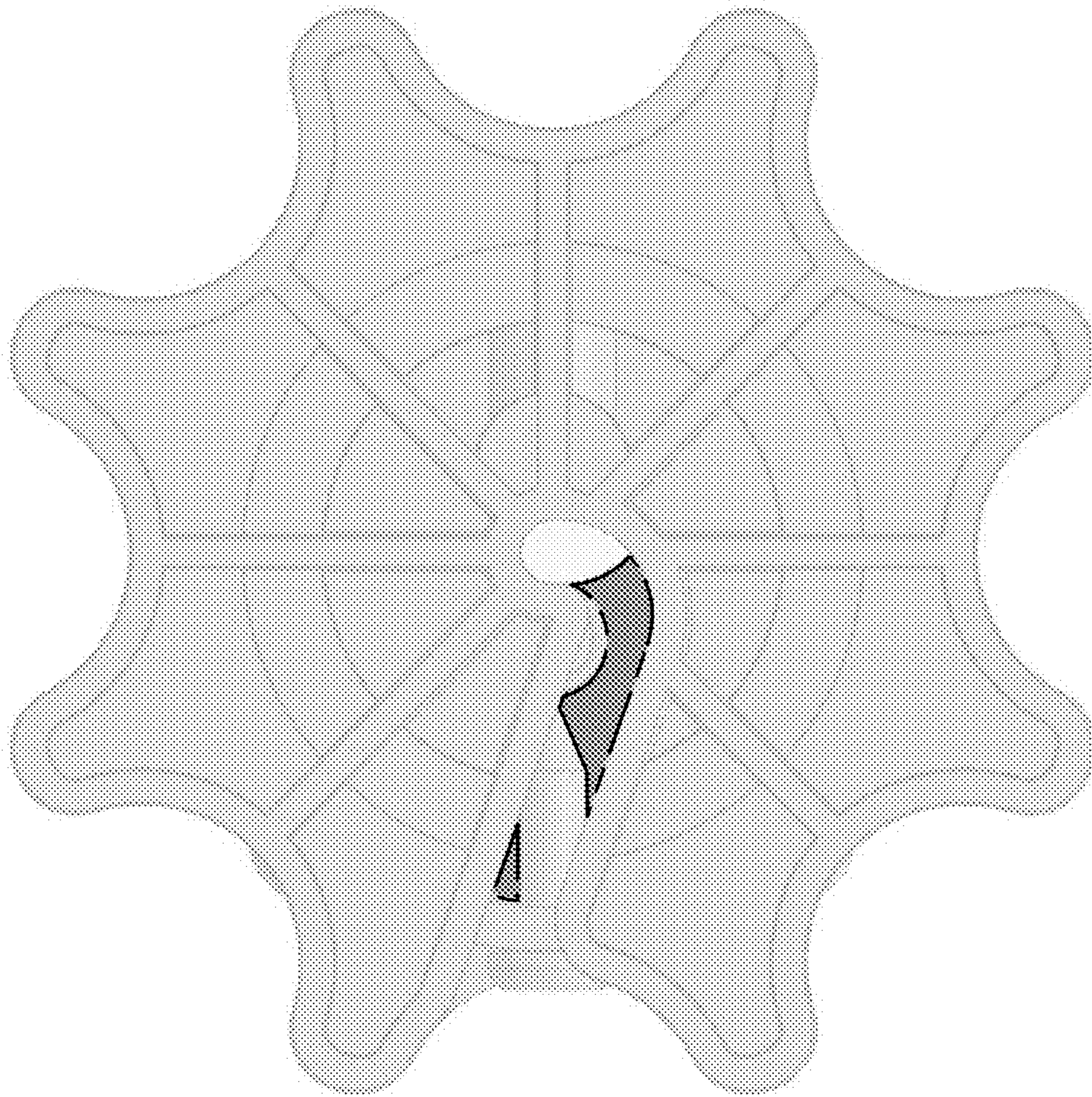

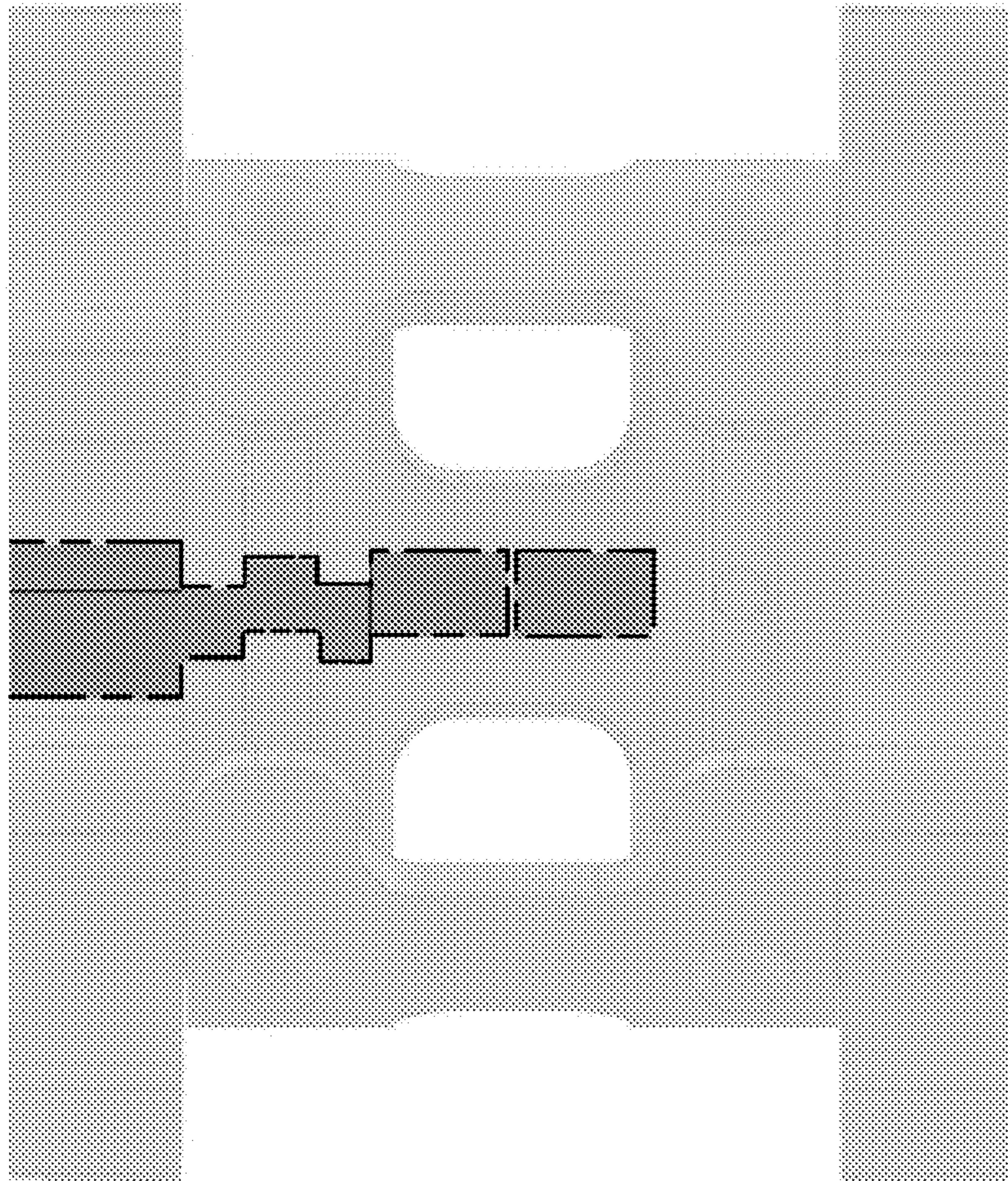

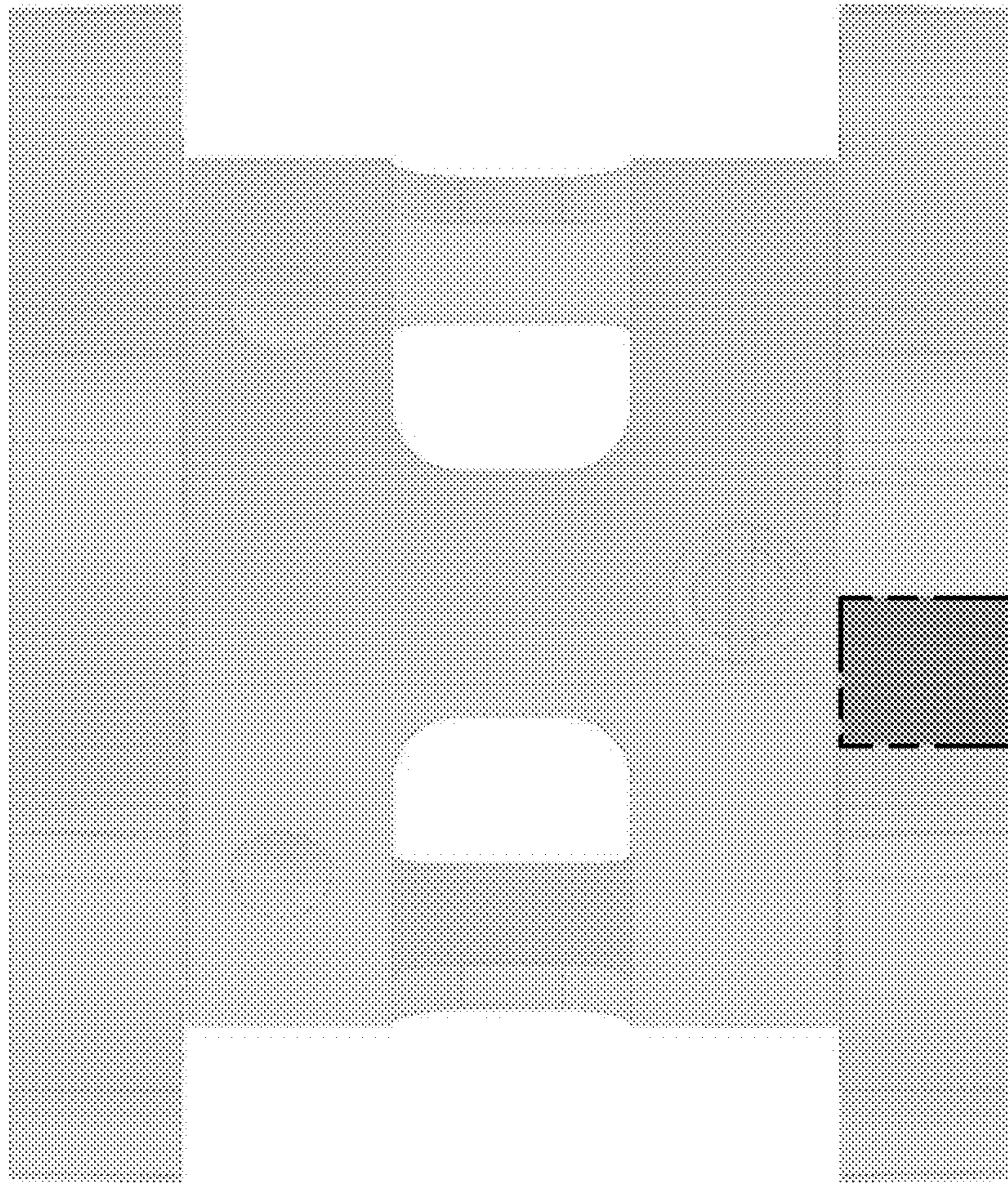

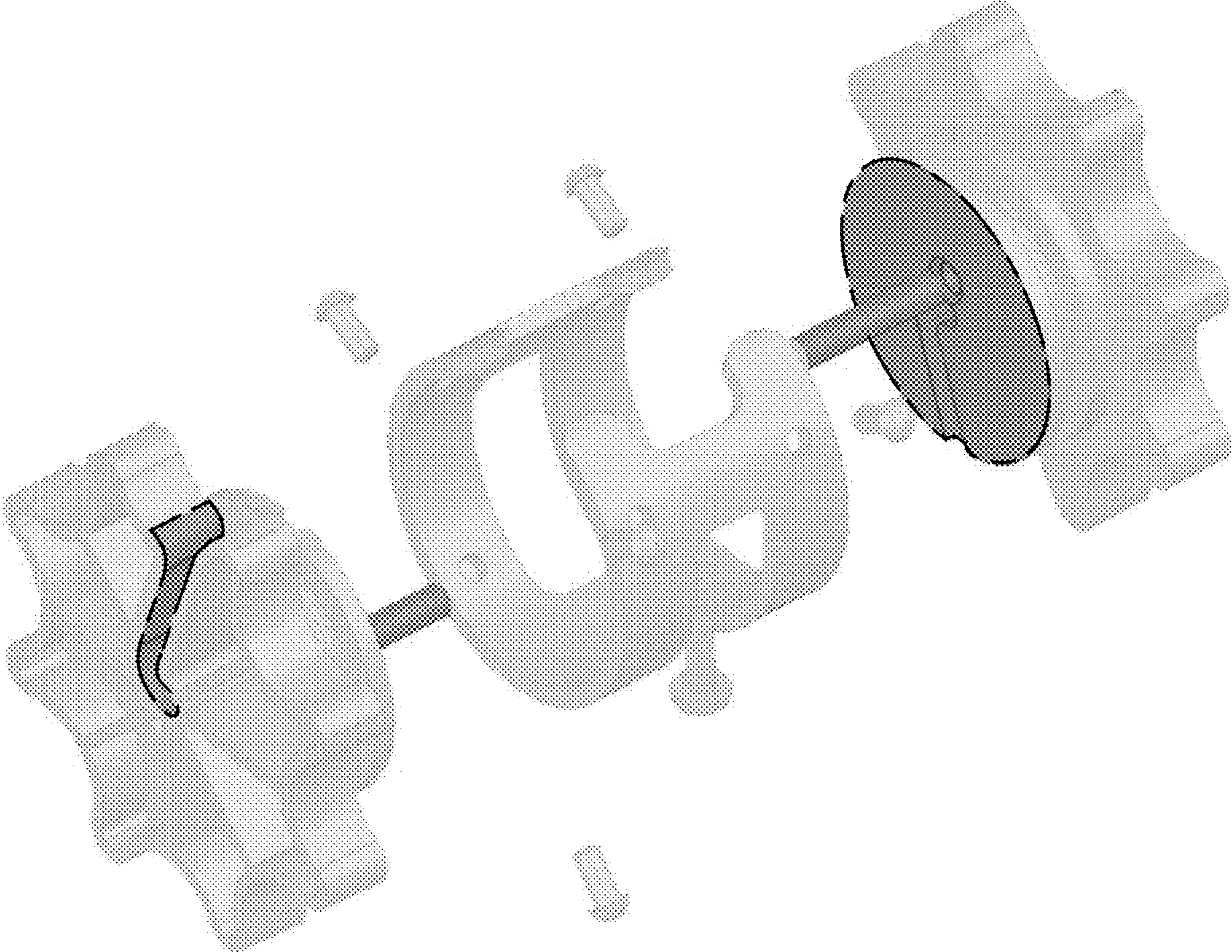

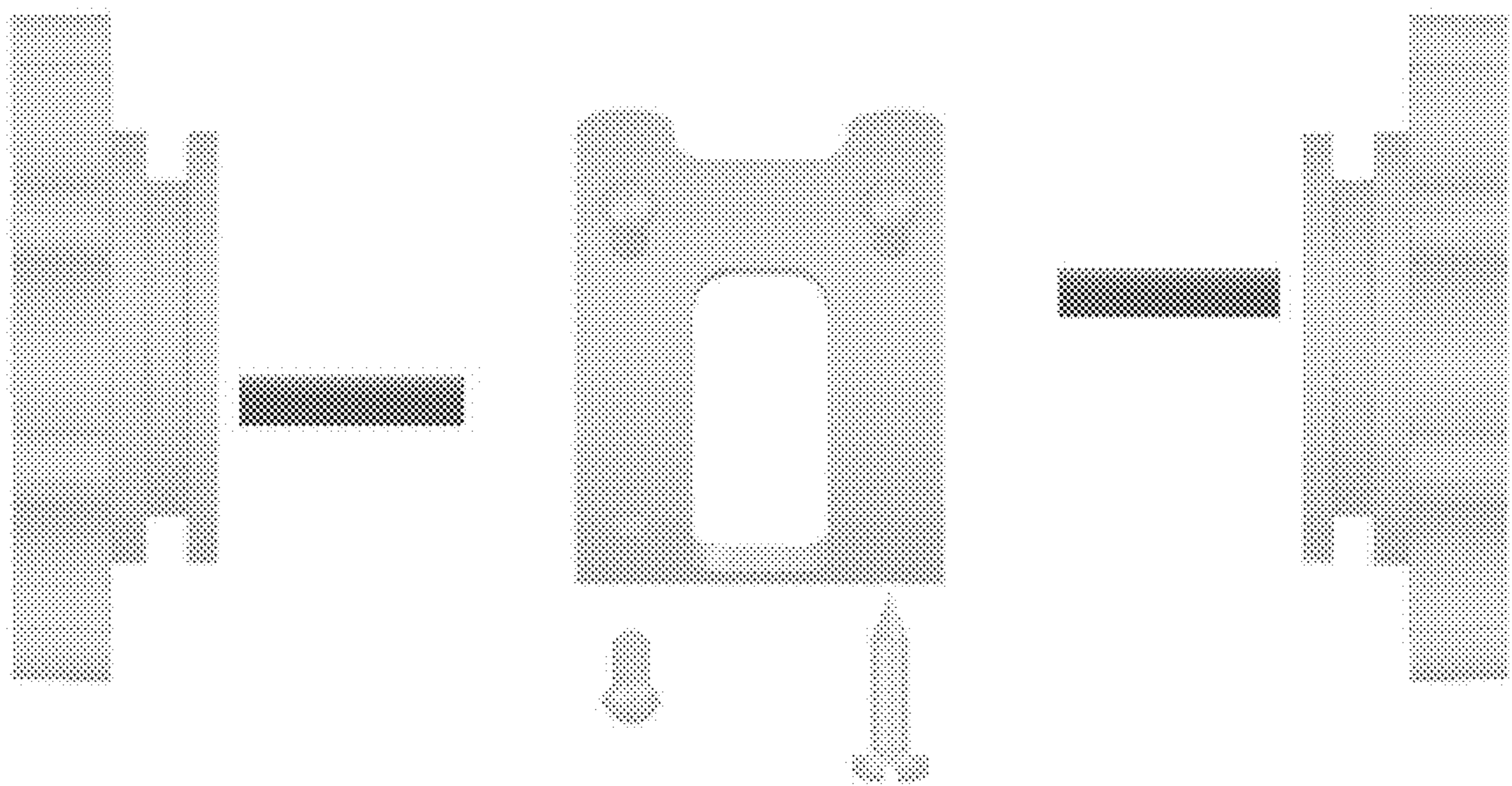

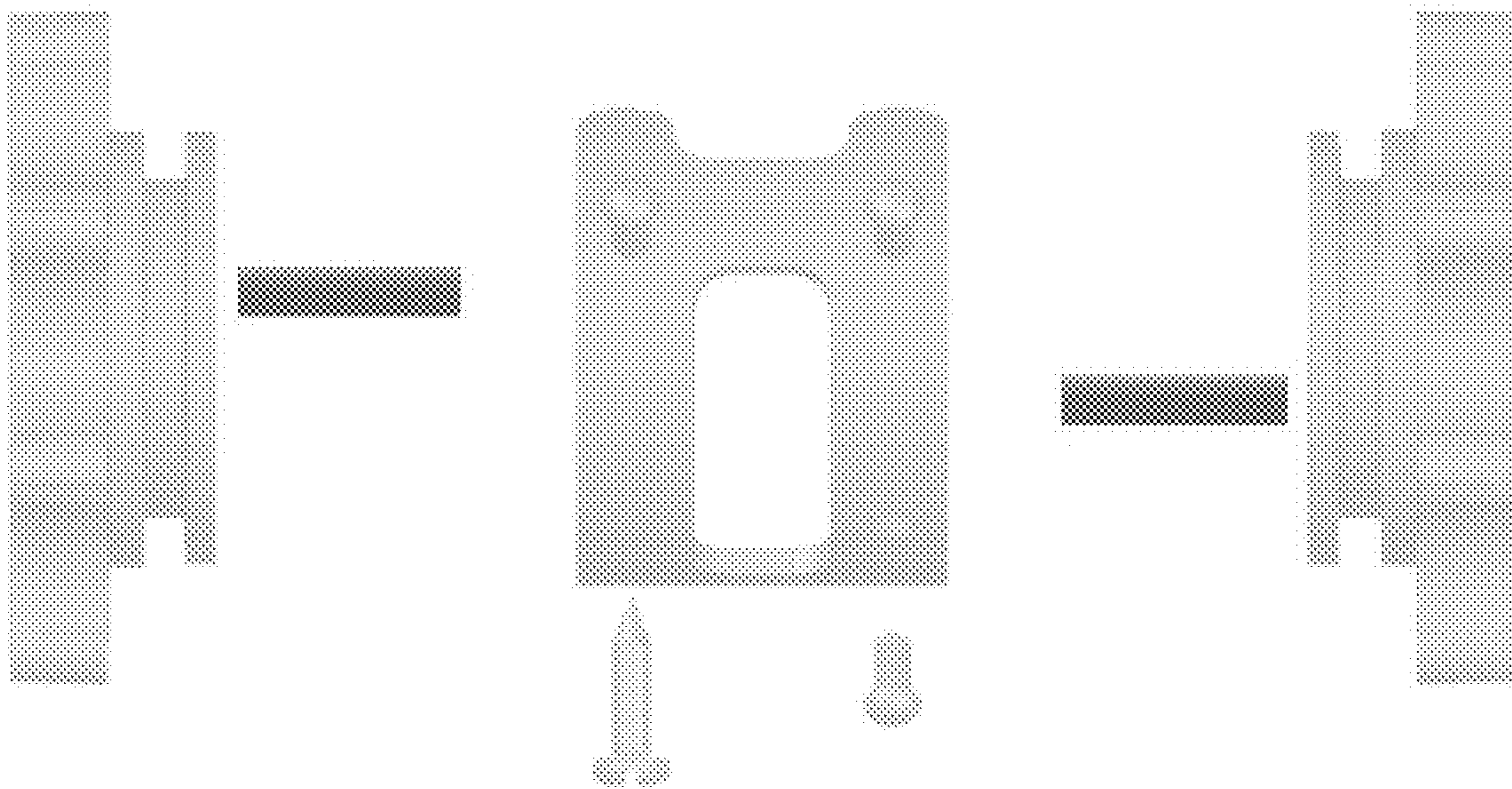

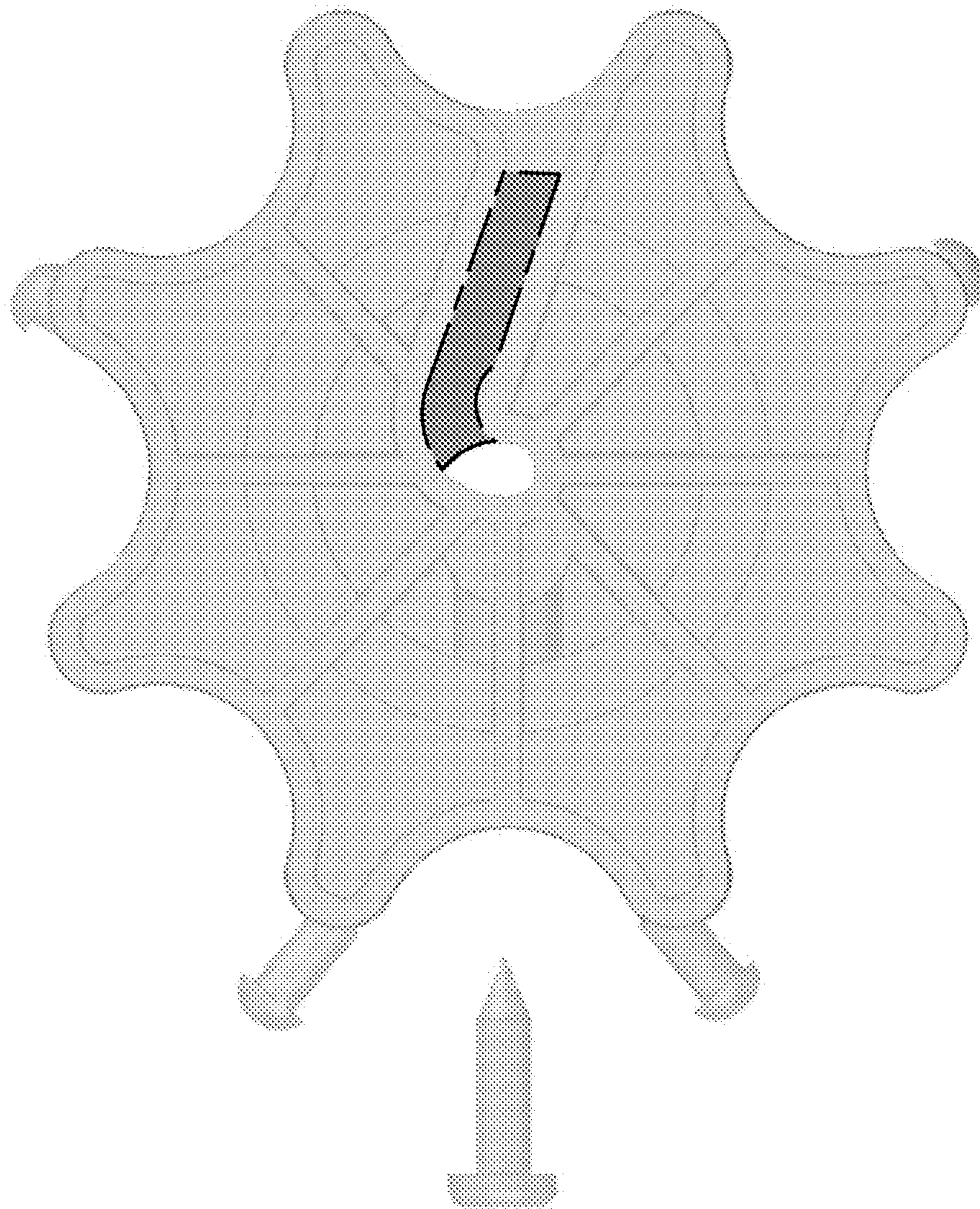

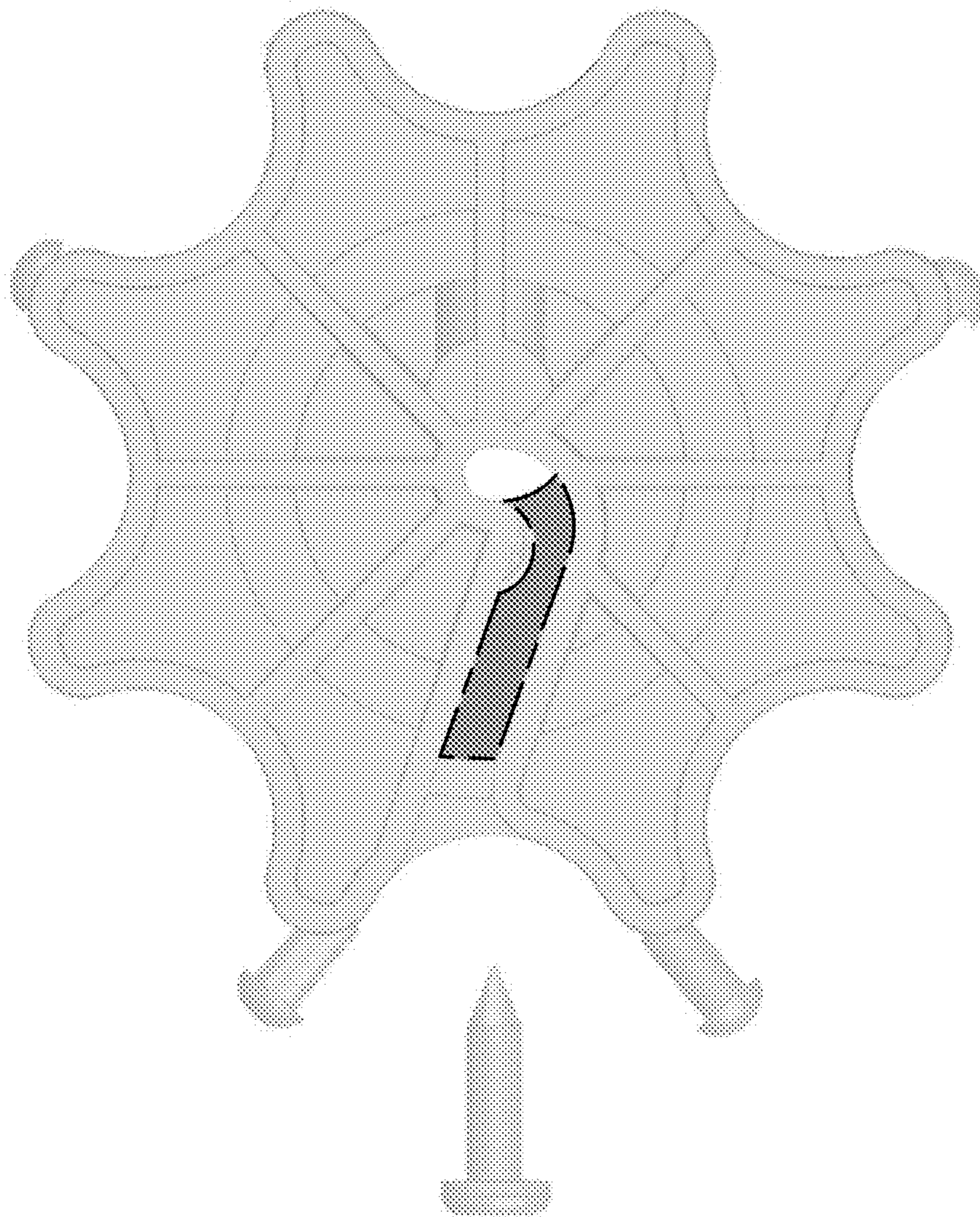

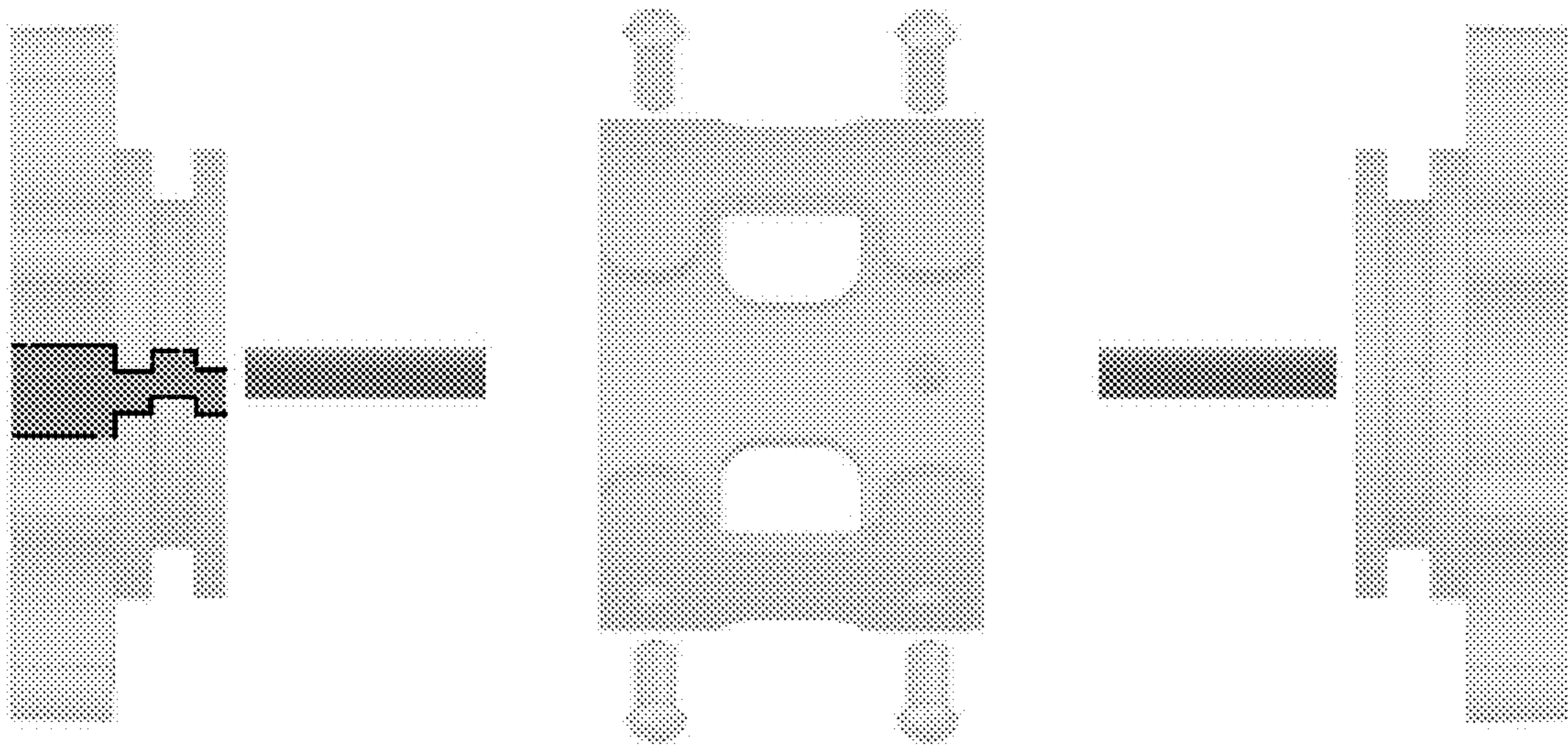

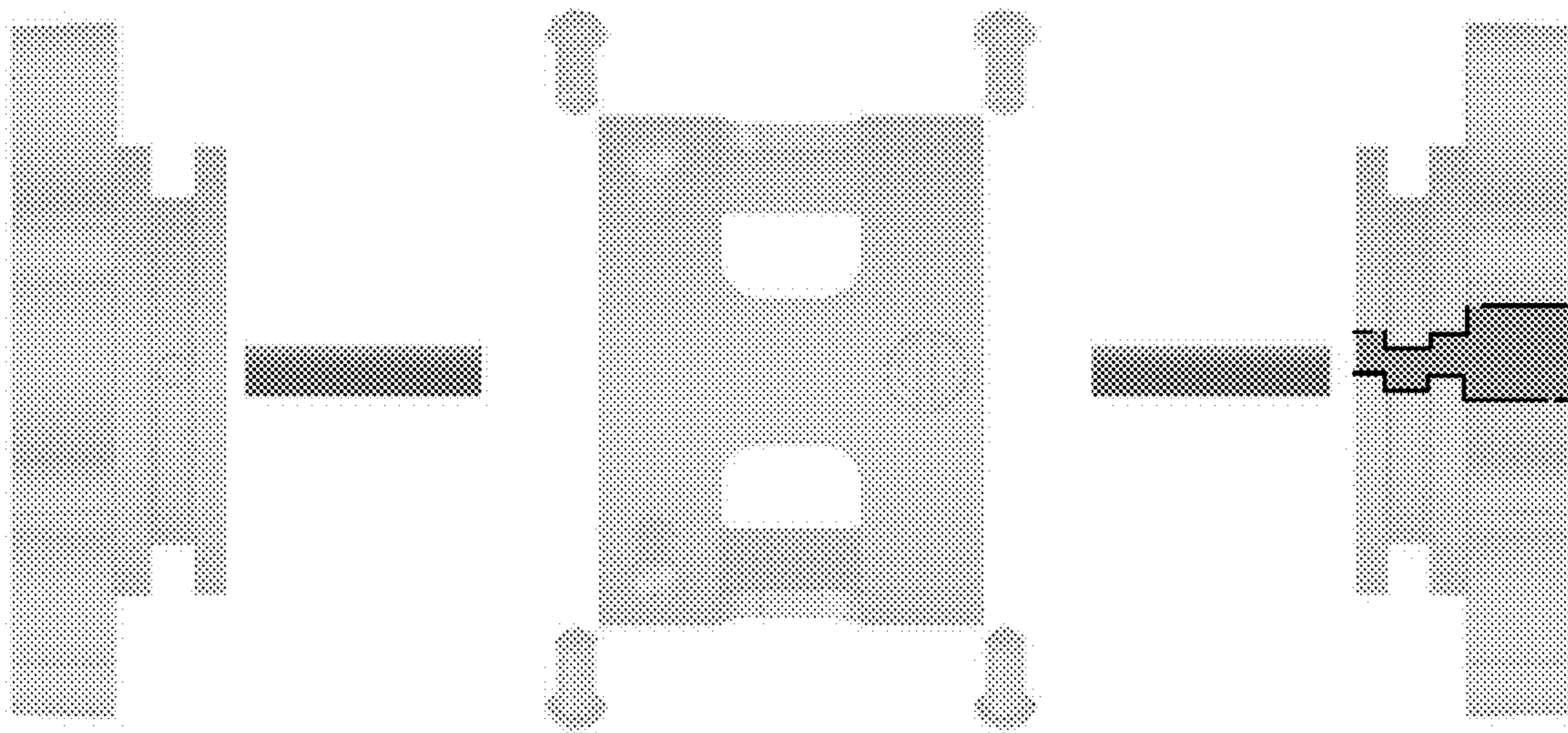
