(57) **CLAIM**

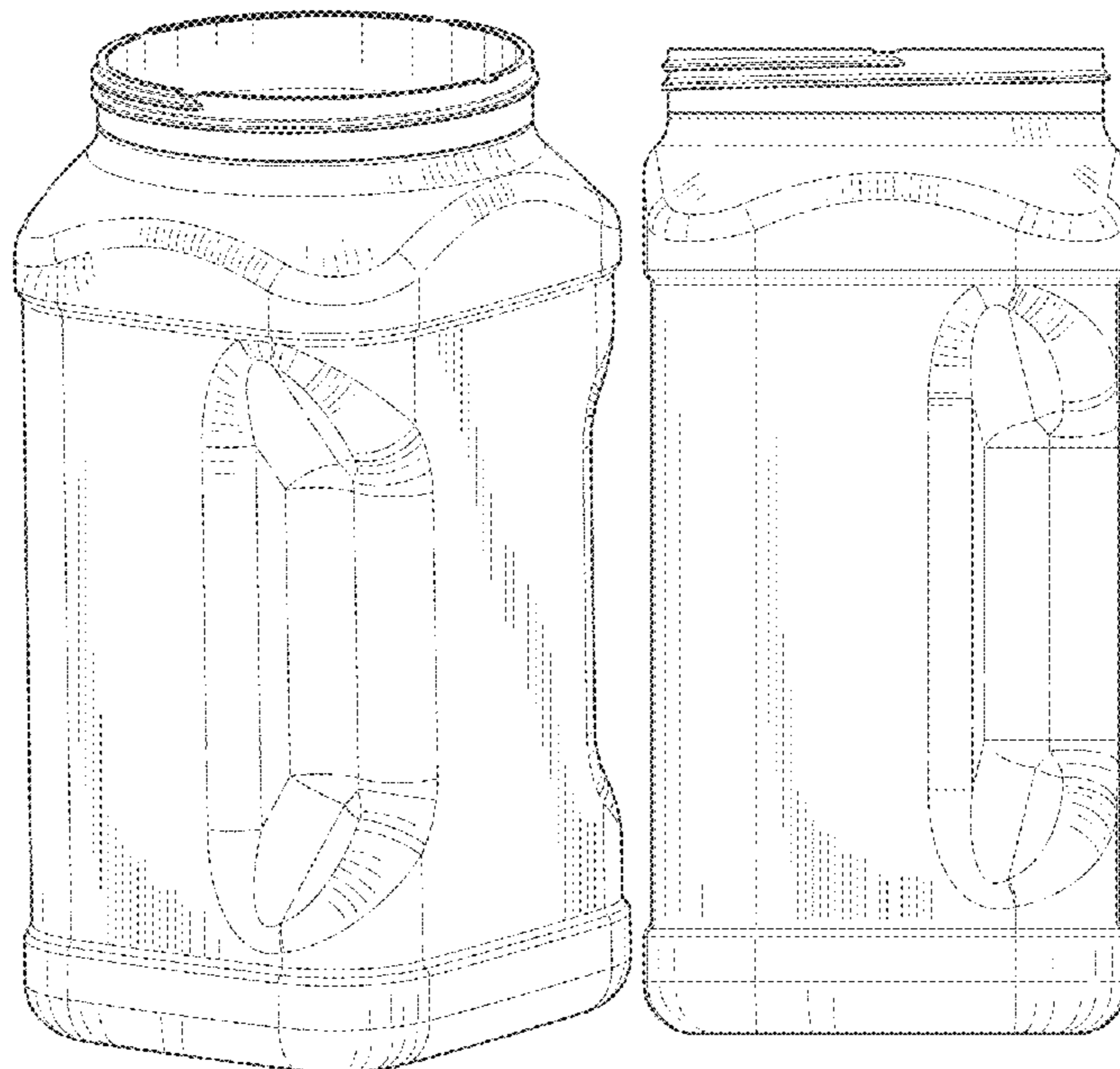
The ornamental design for a snack container, as shown and described.

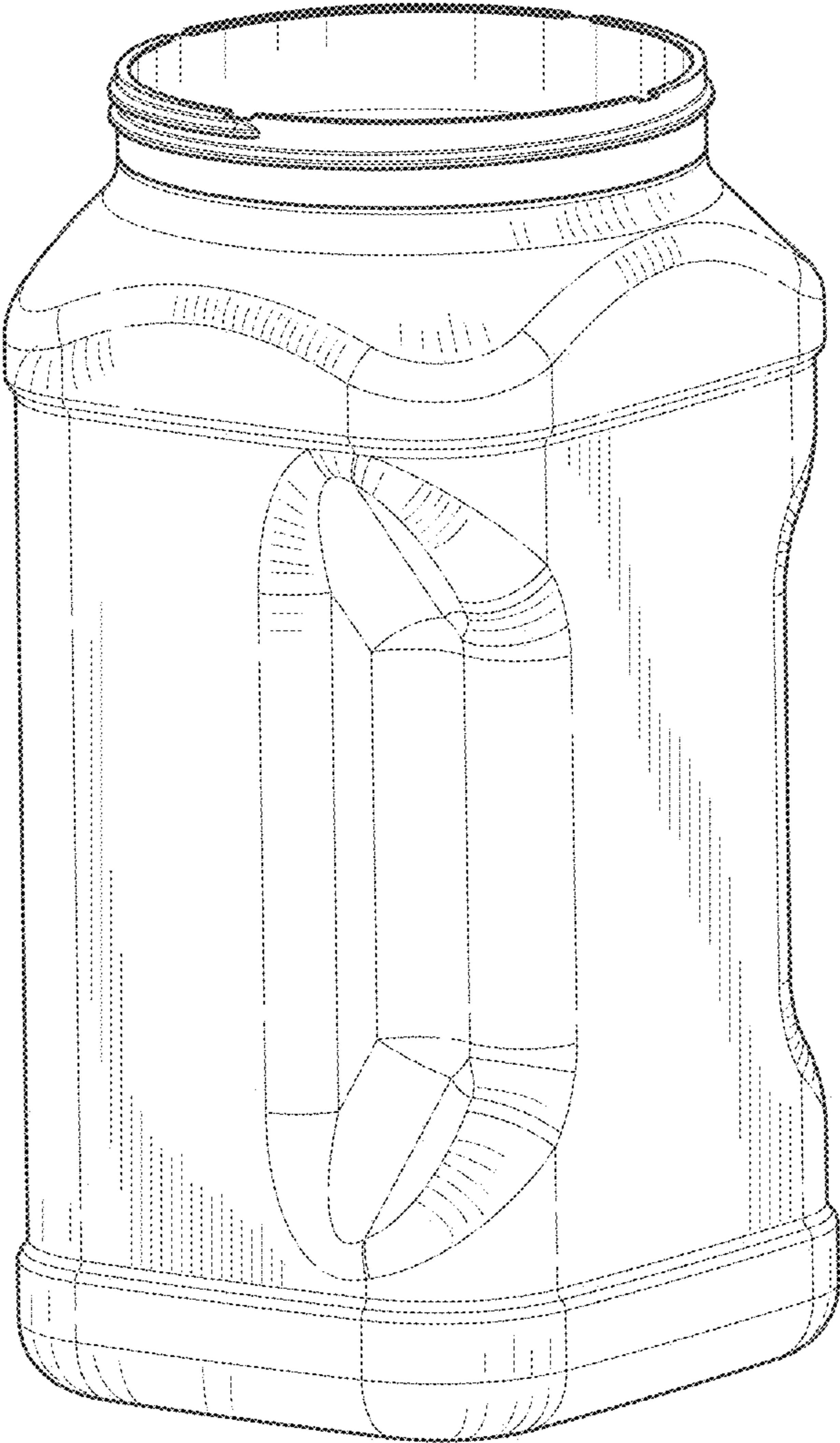

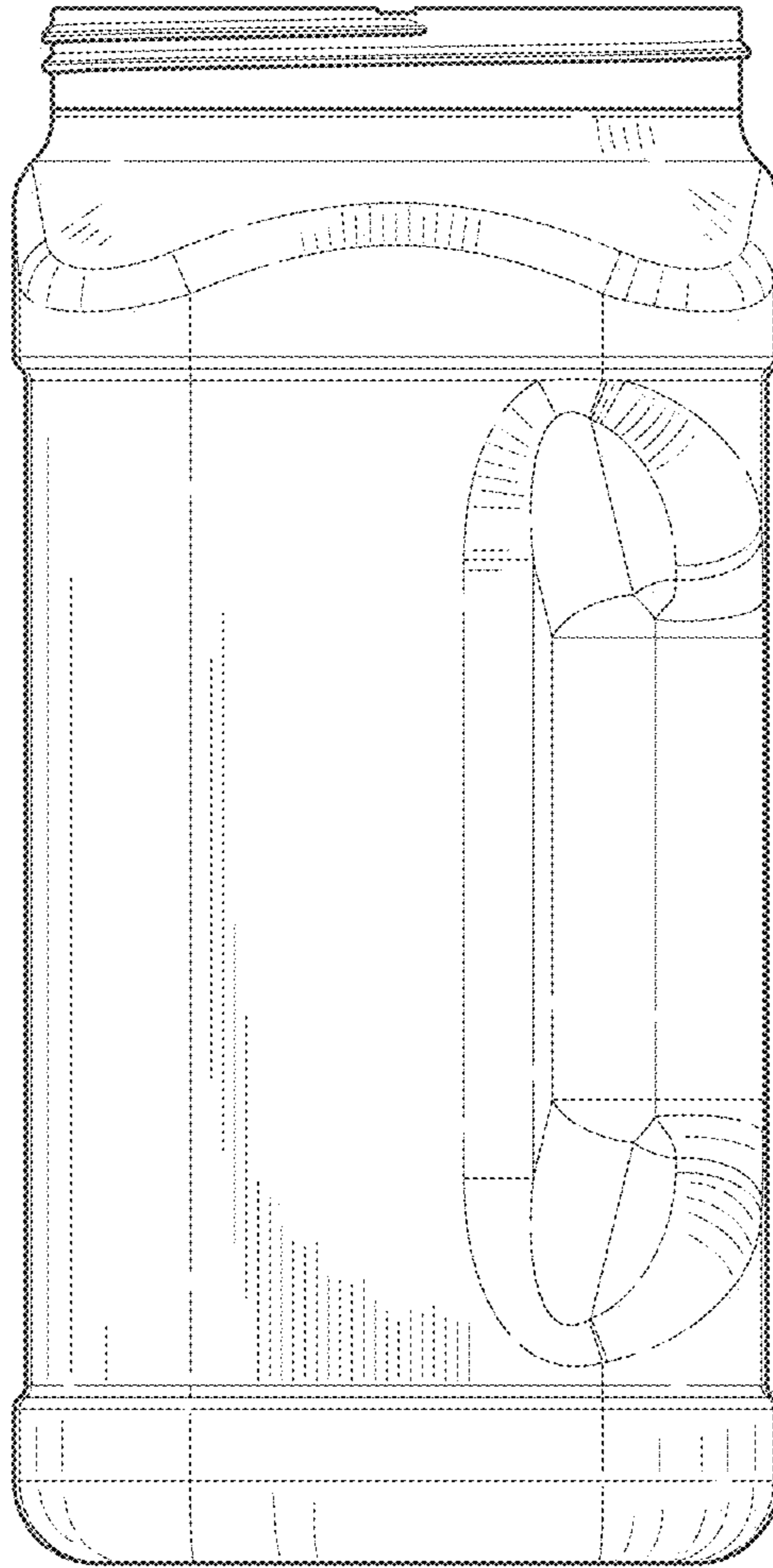

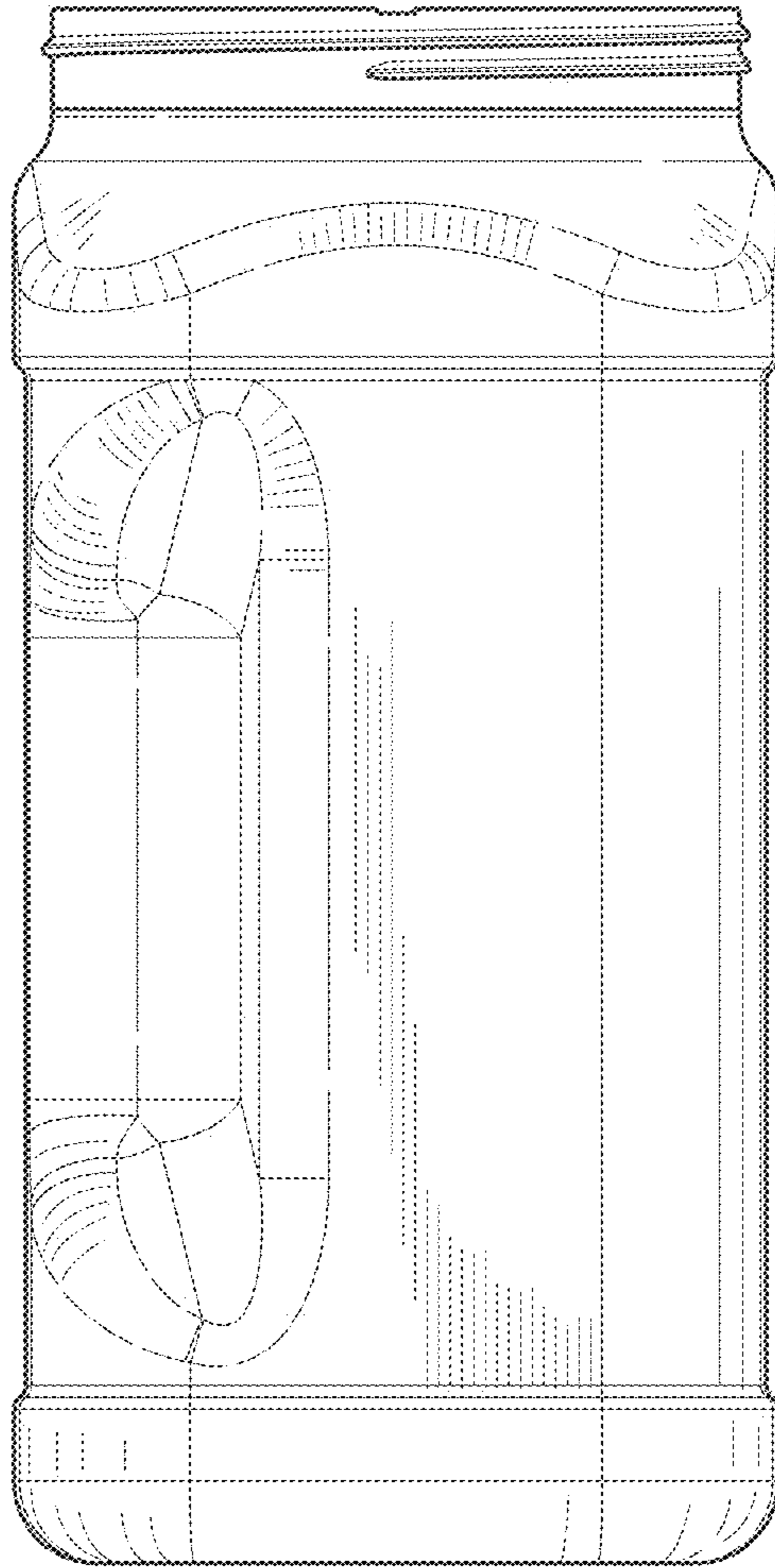

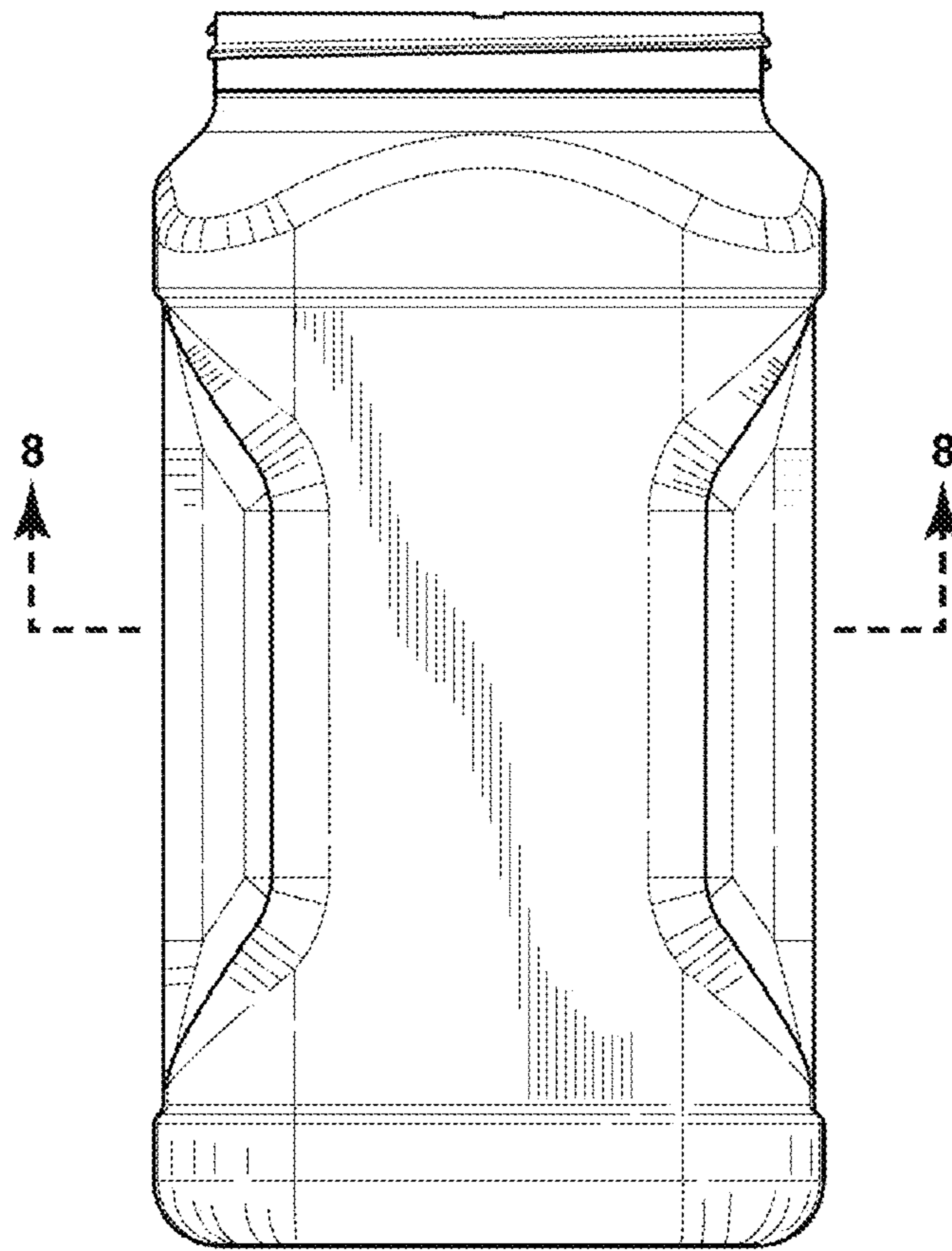

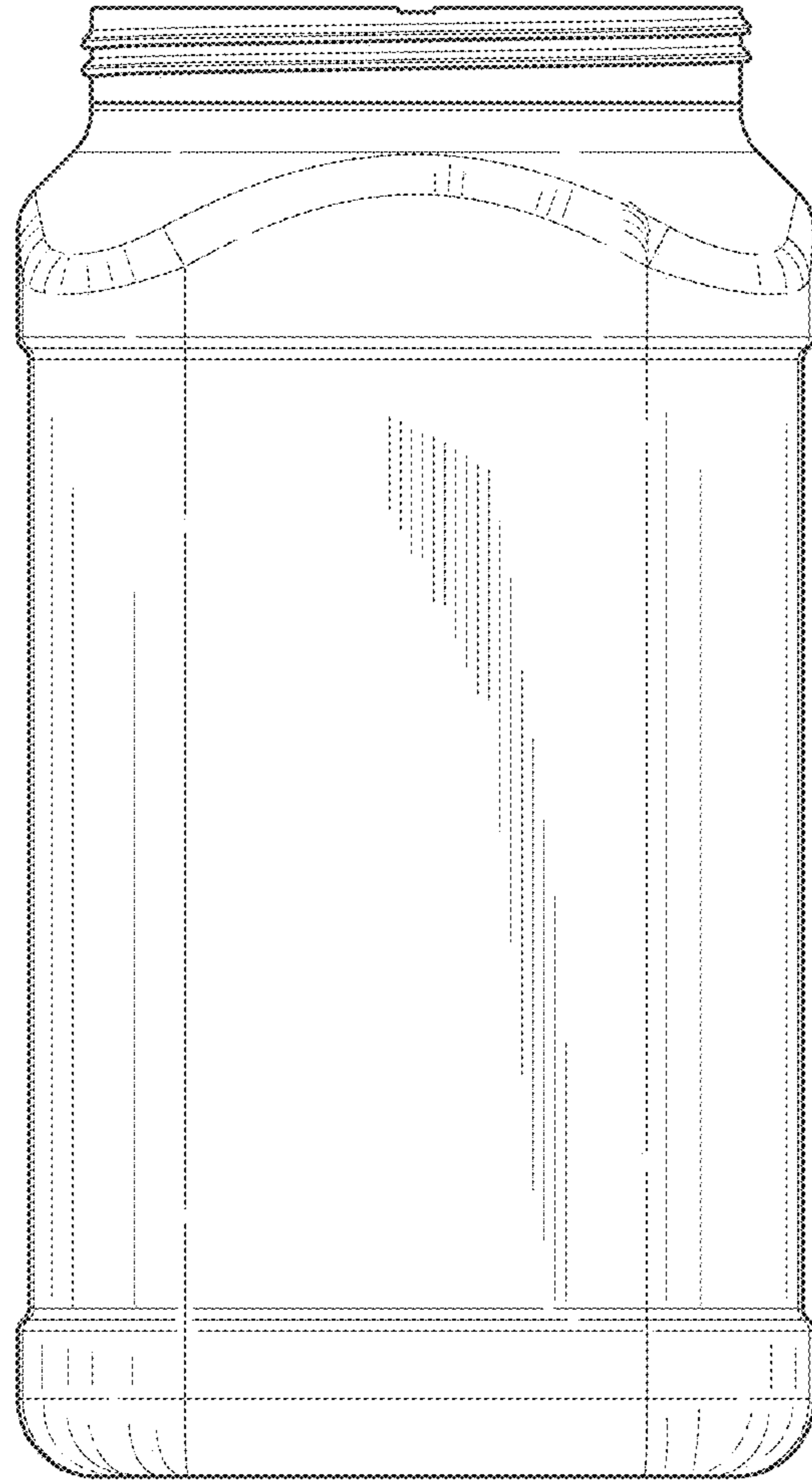
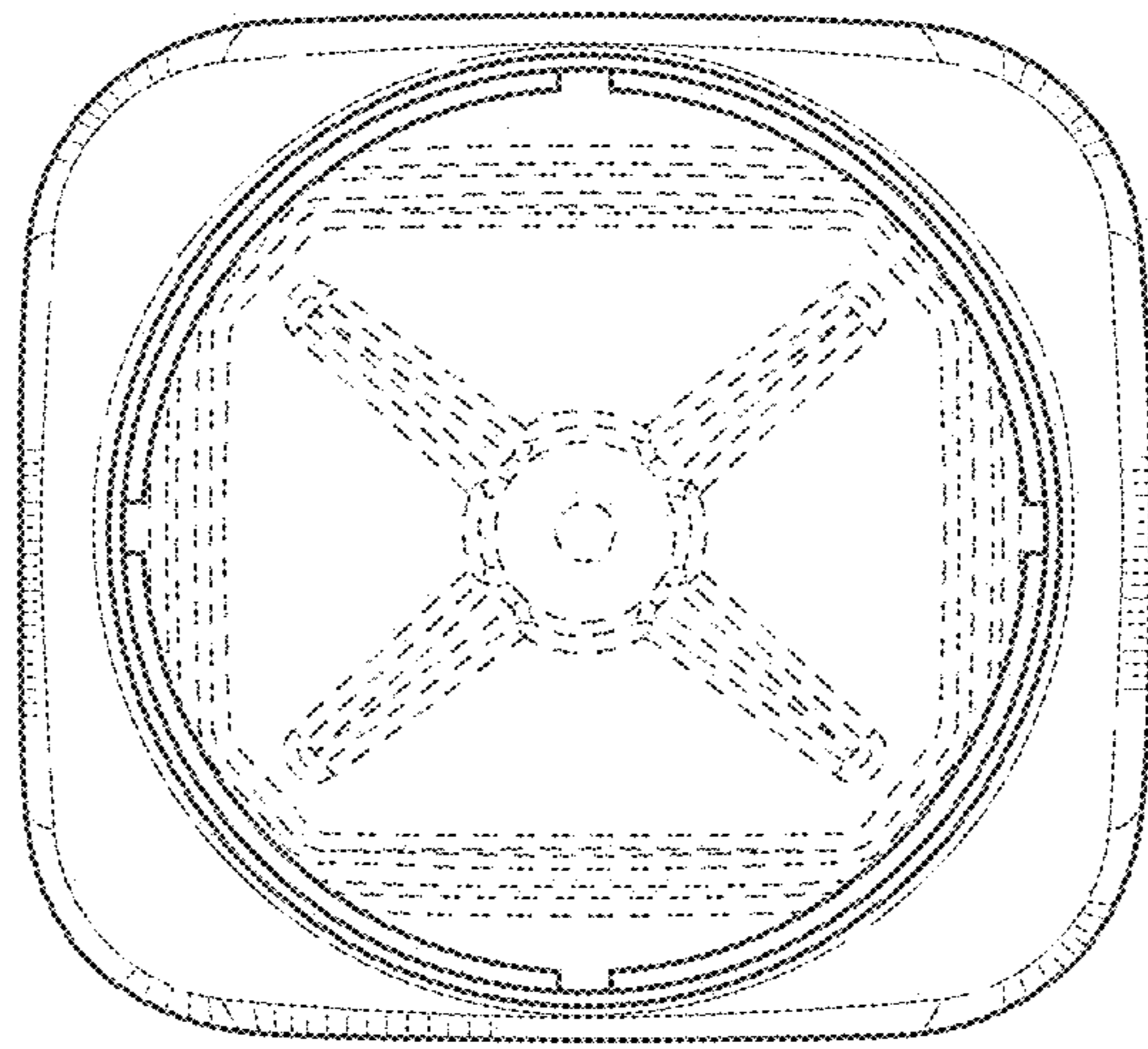
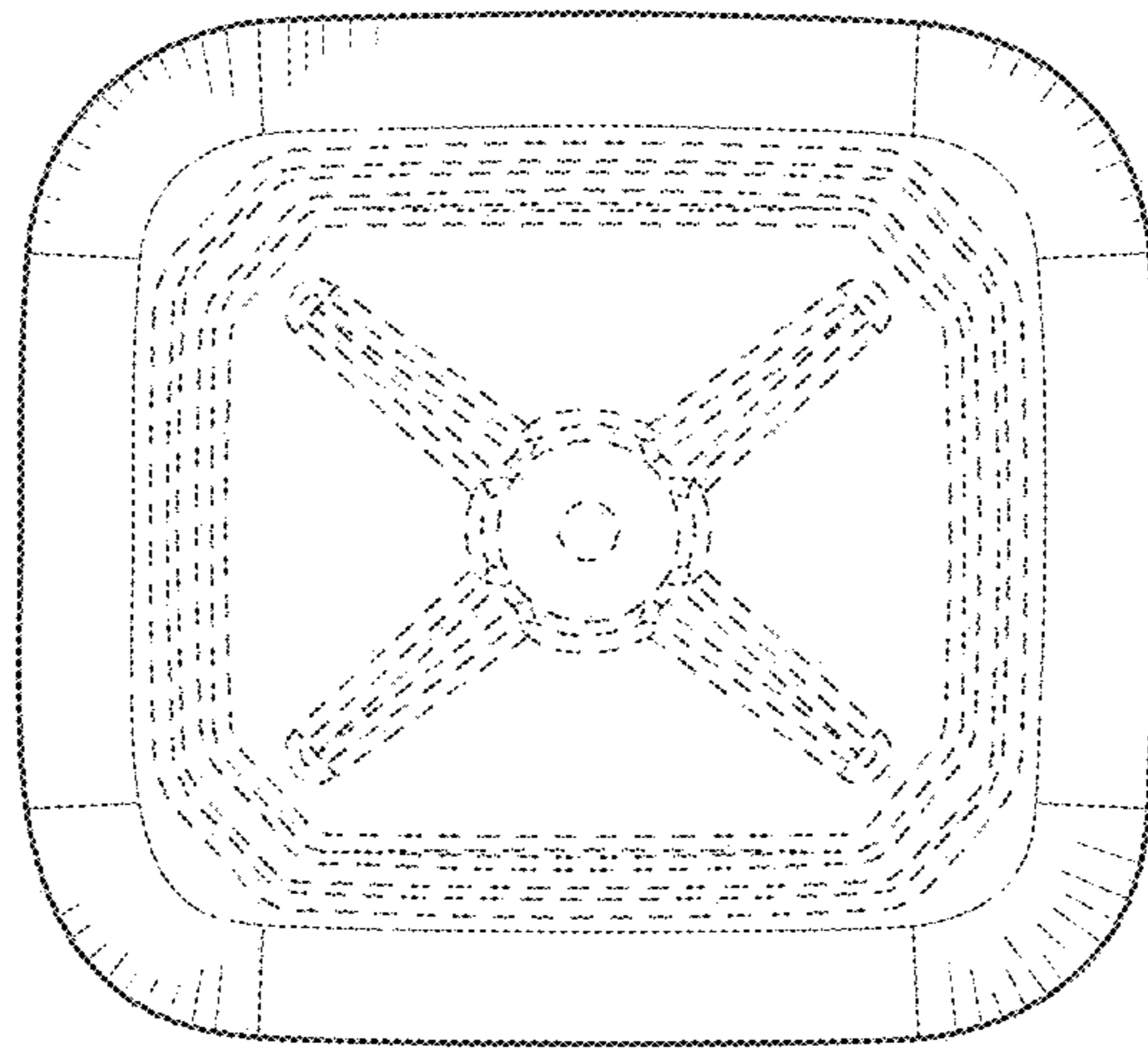

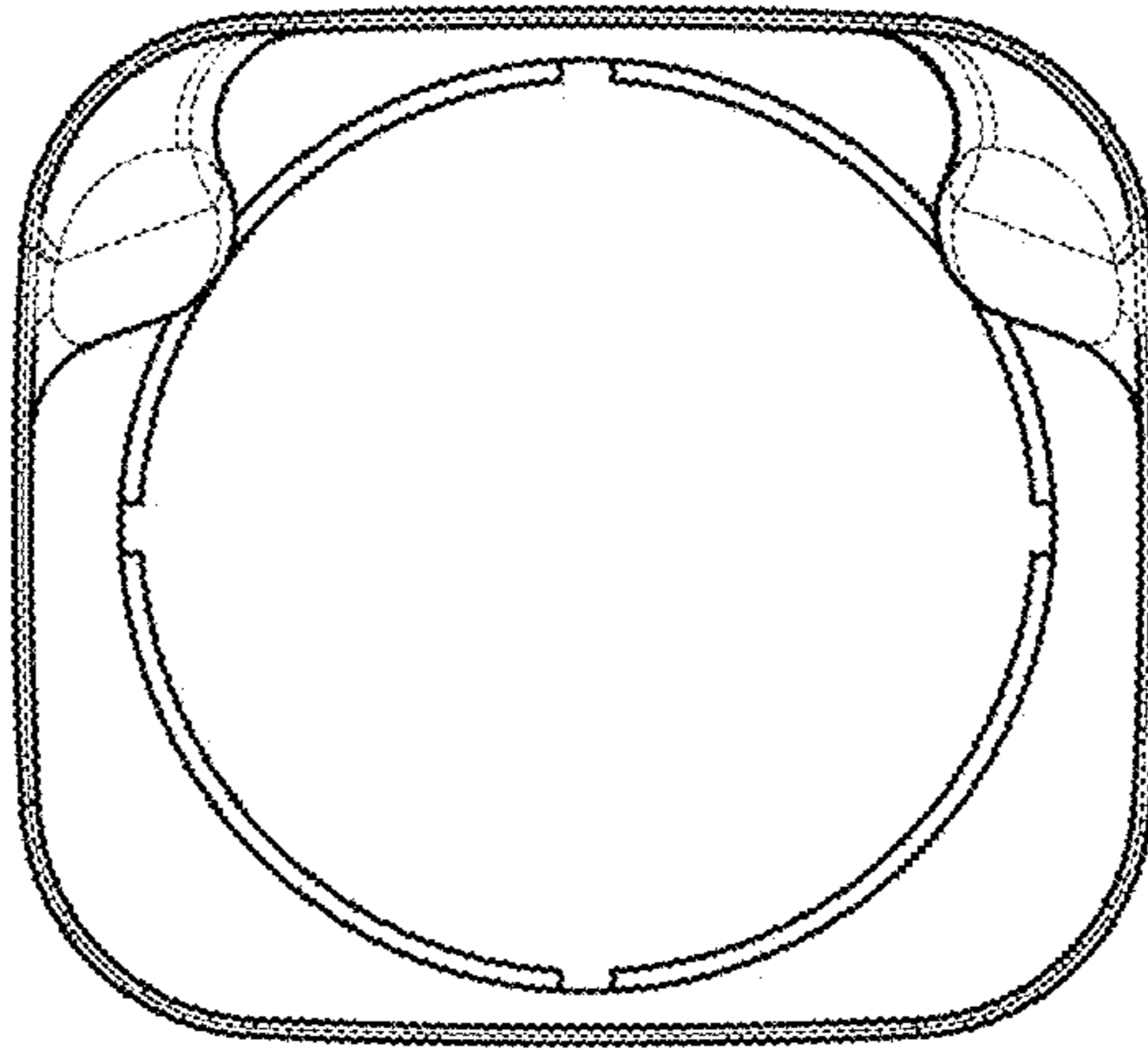
