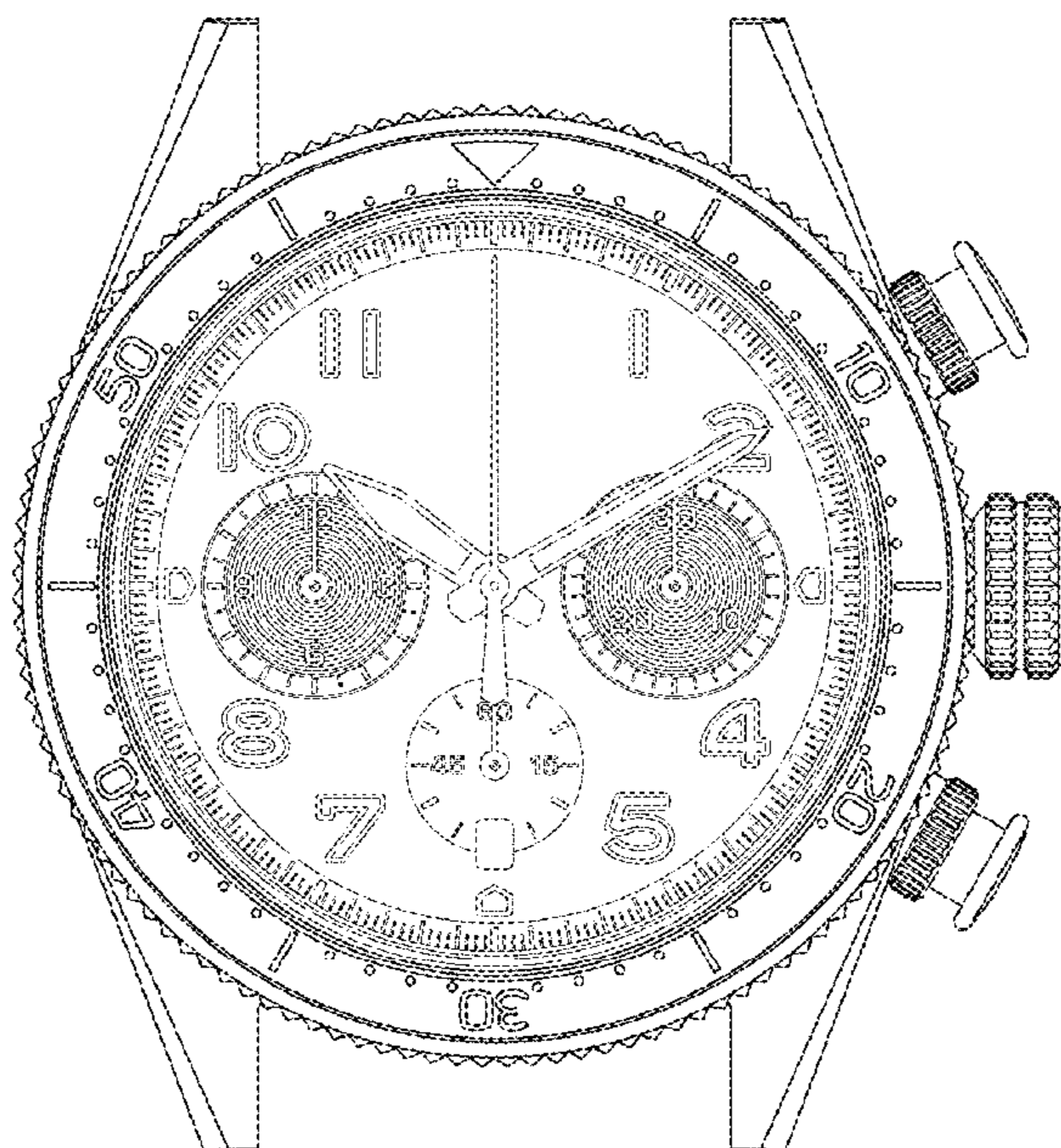
(57) **CLAIM**

The ornamental design for a watch, as shown and described.

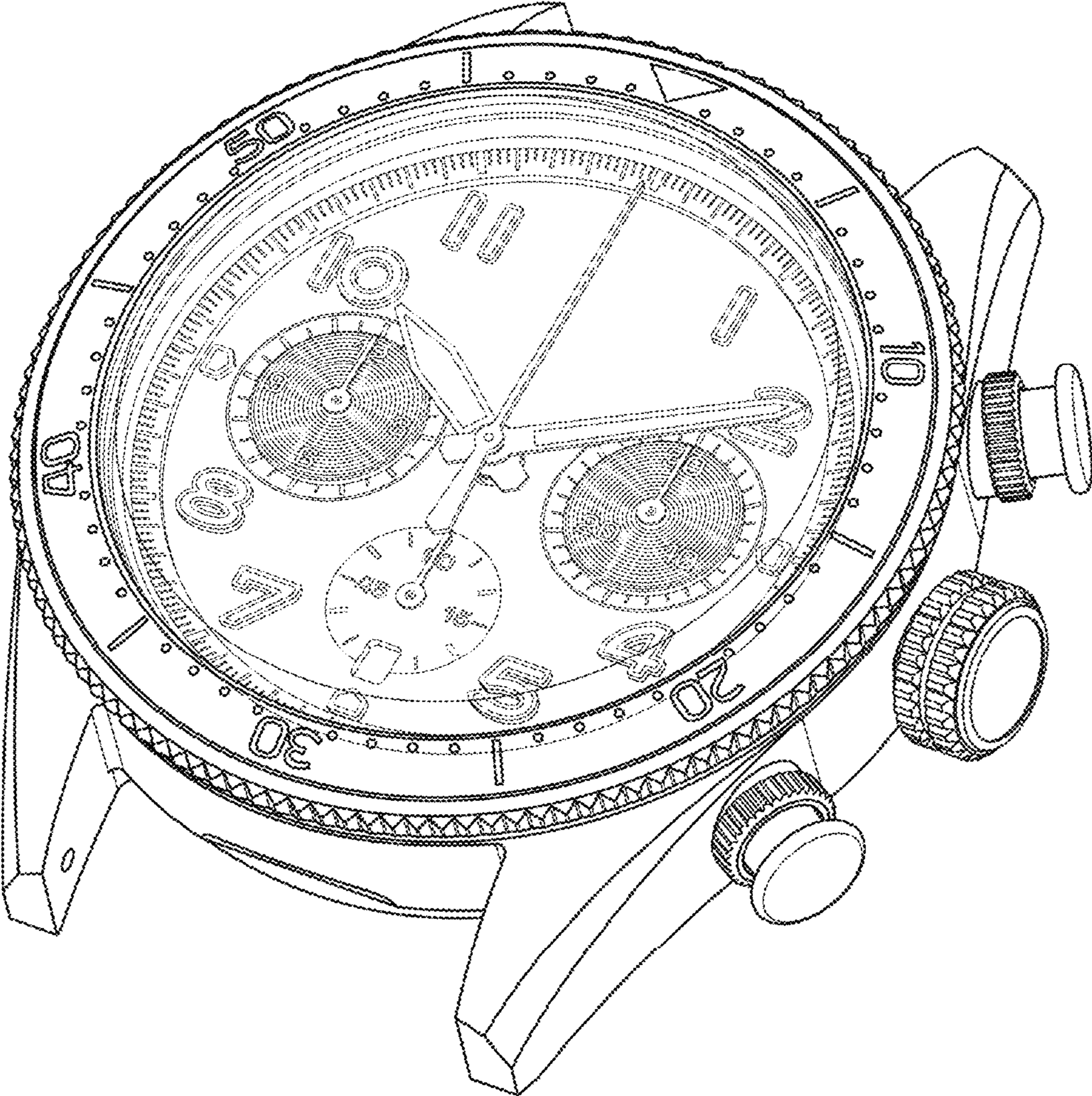
DESCRIPTION

- 1.7 is a left view thereof.

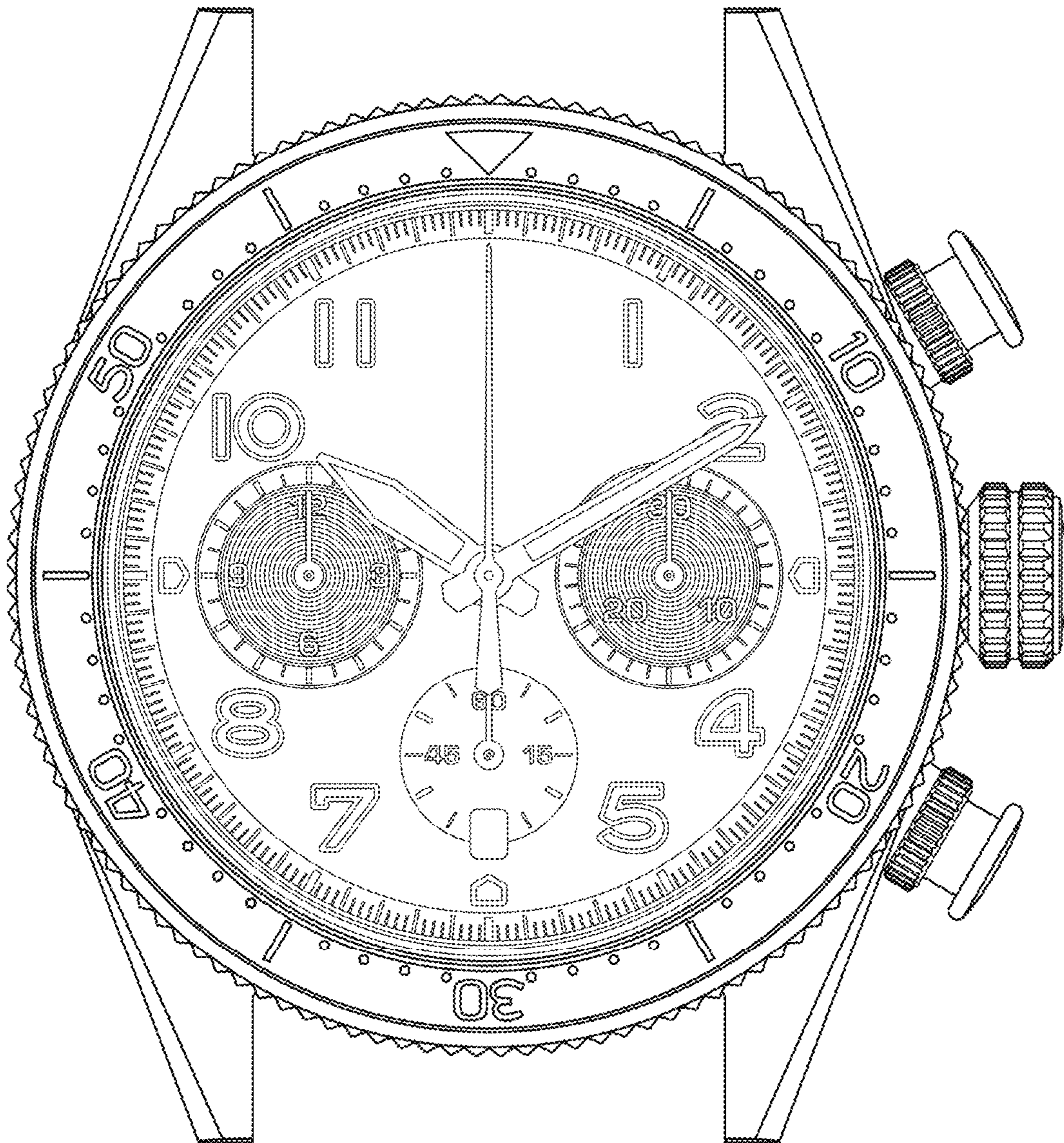

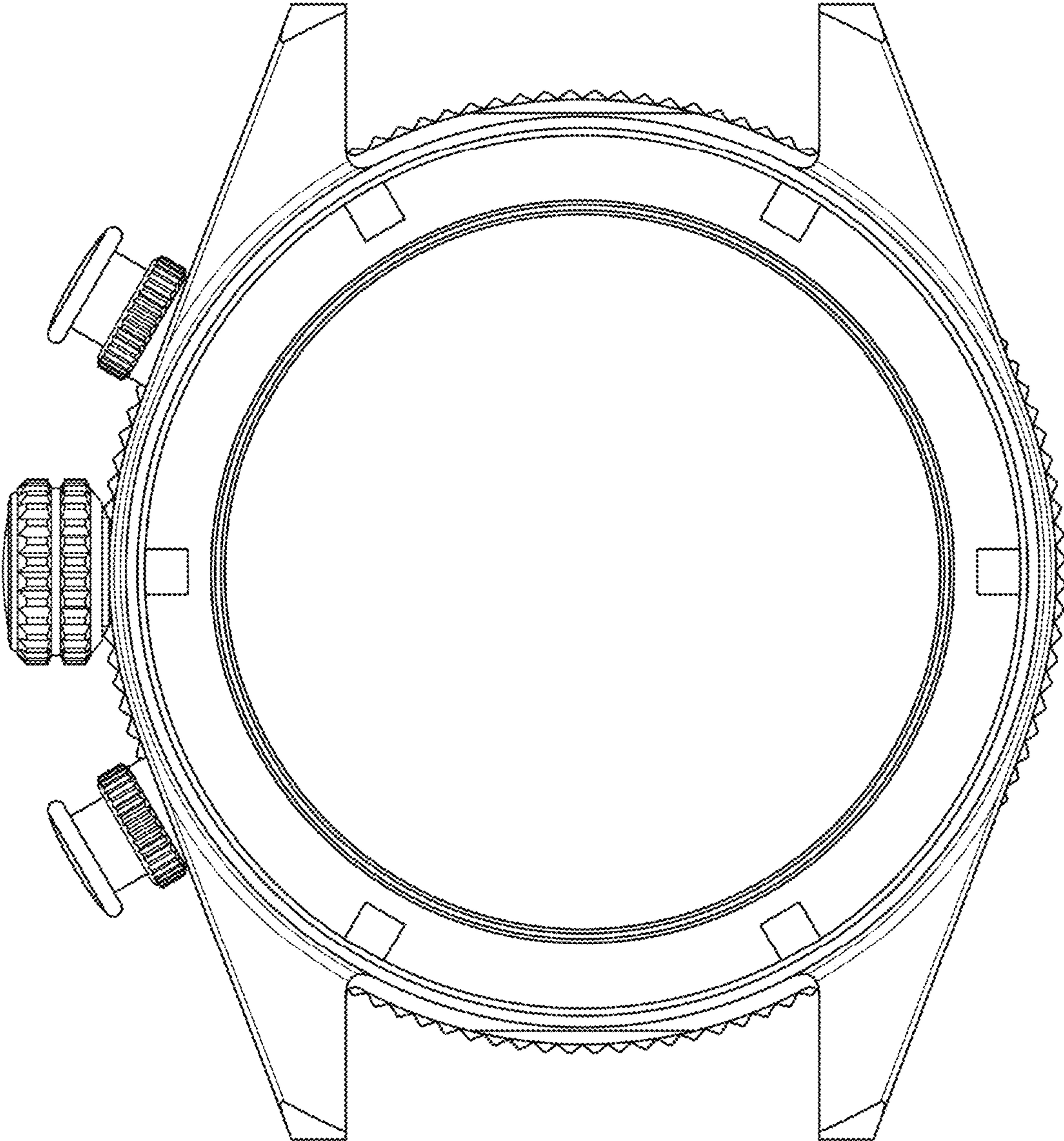

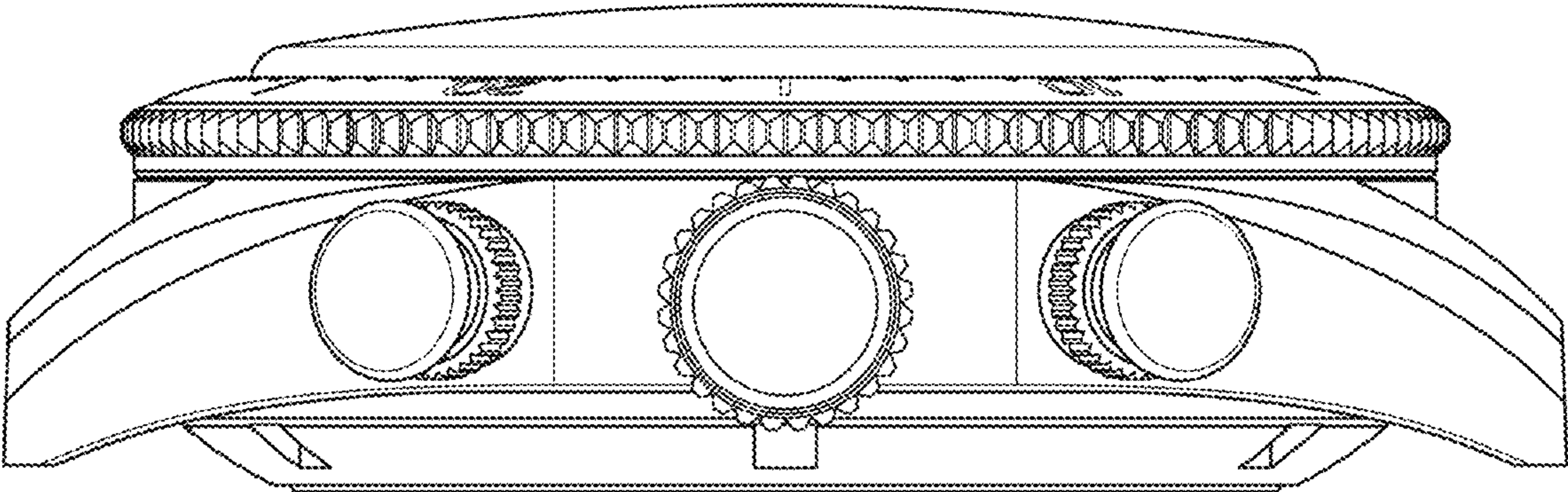

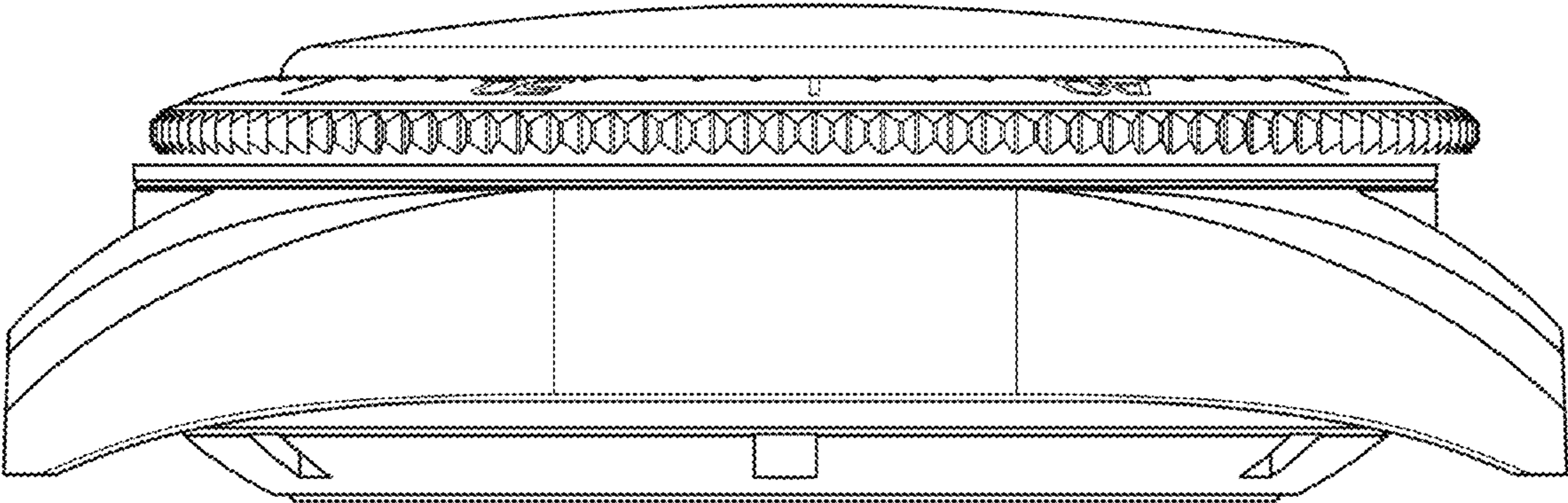

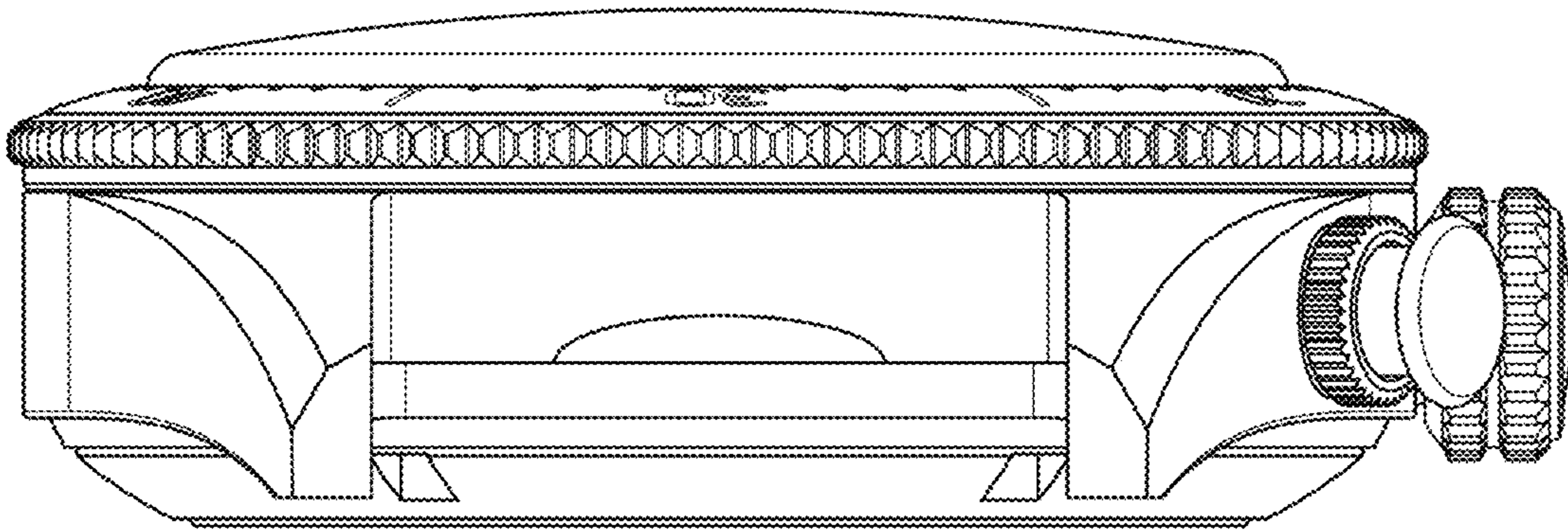
