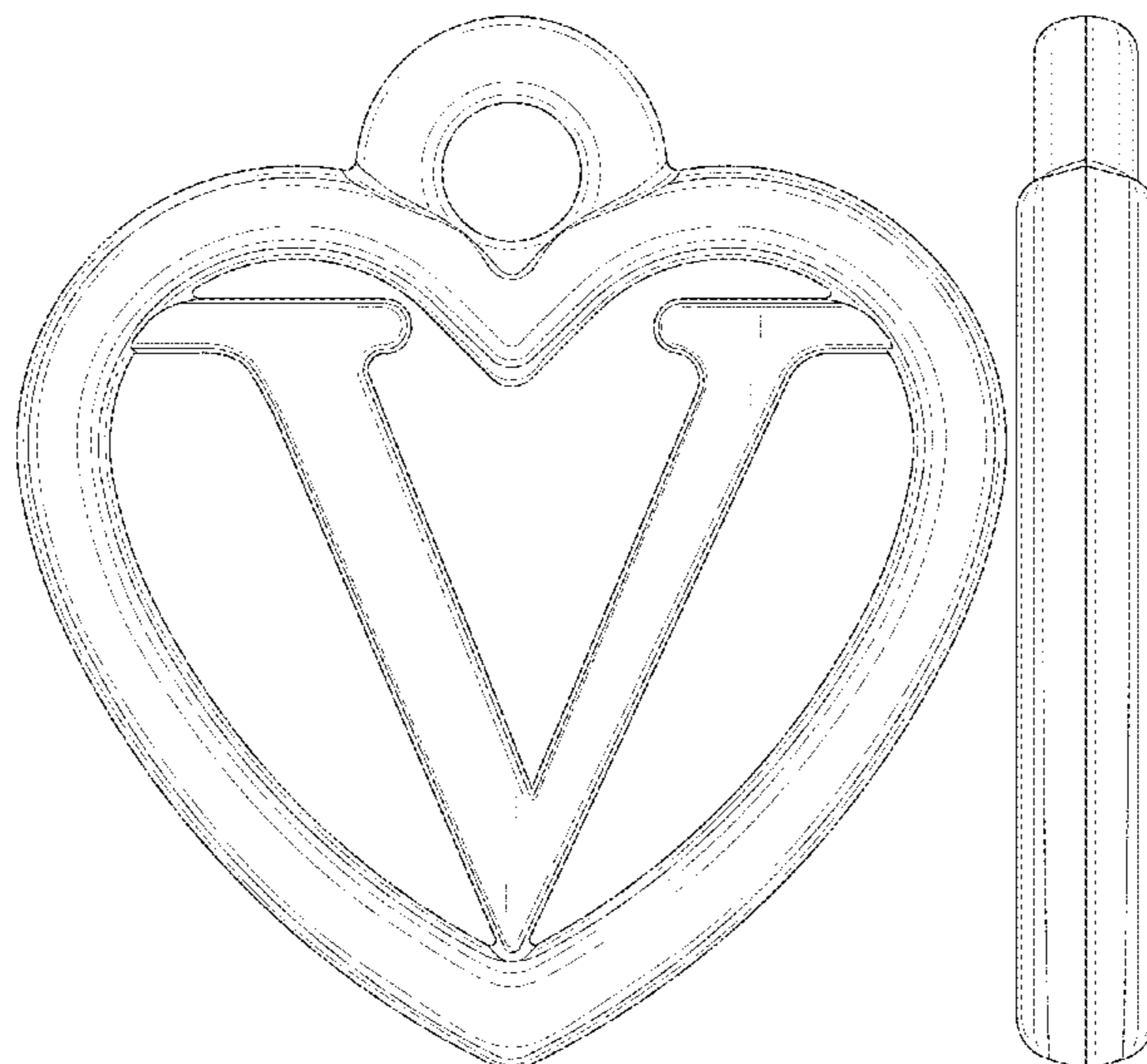
The ornamental design for a charm, as shown.

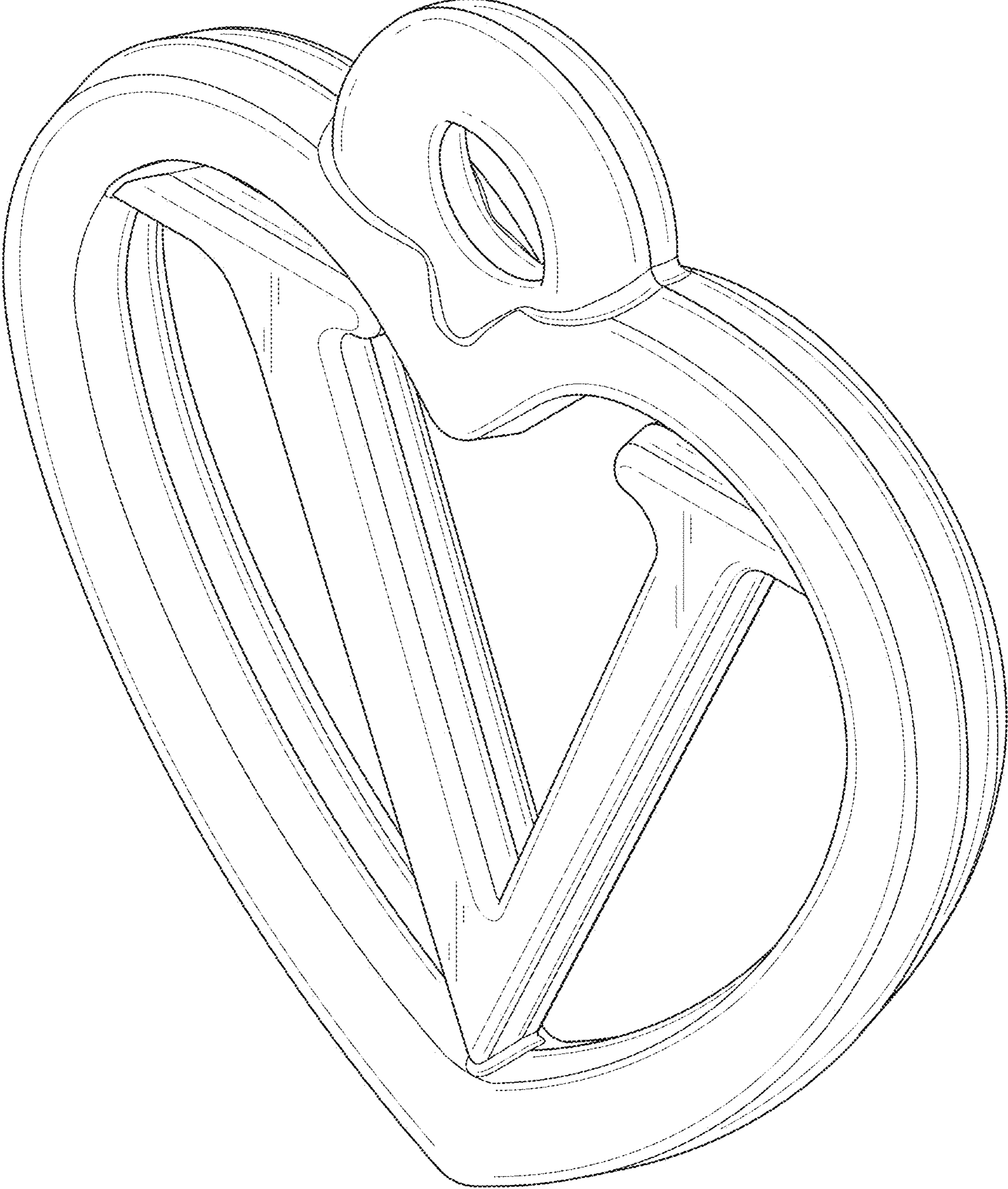

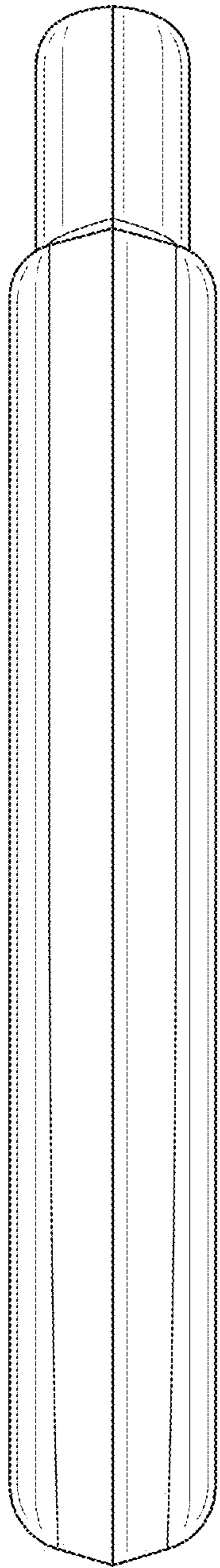

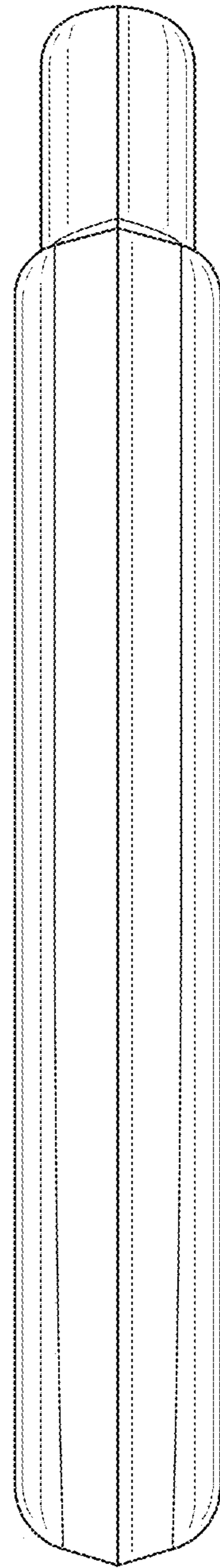

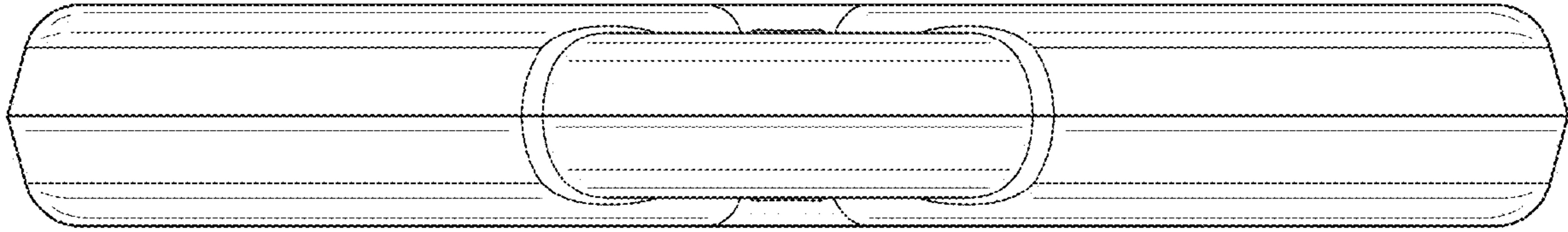

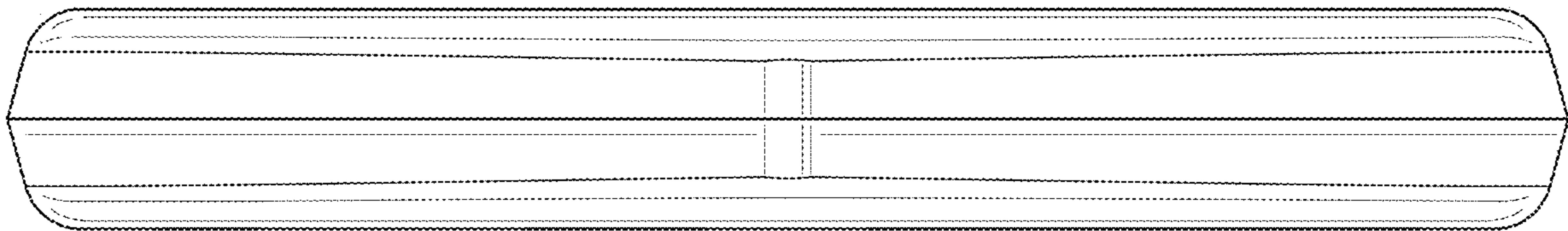
