(57) **CLAIM**

The ornamental design for a vehicle with an interior compartment, as shown and described.

**DESCRIPTION**

This application is related to U.S. patent application Ser. No. 29/655,062, entitled "Vehicle," filed Jun. 29, 2018, the entire contents of which are incorporated herein by reference.

FIG. 18 is a right-side view thereof;

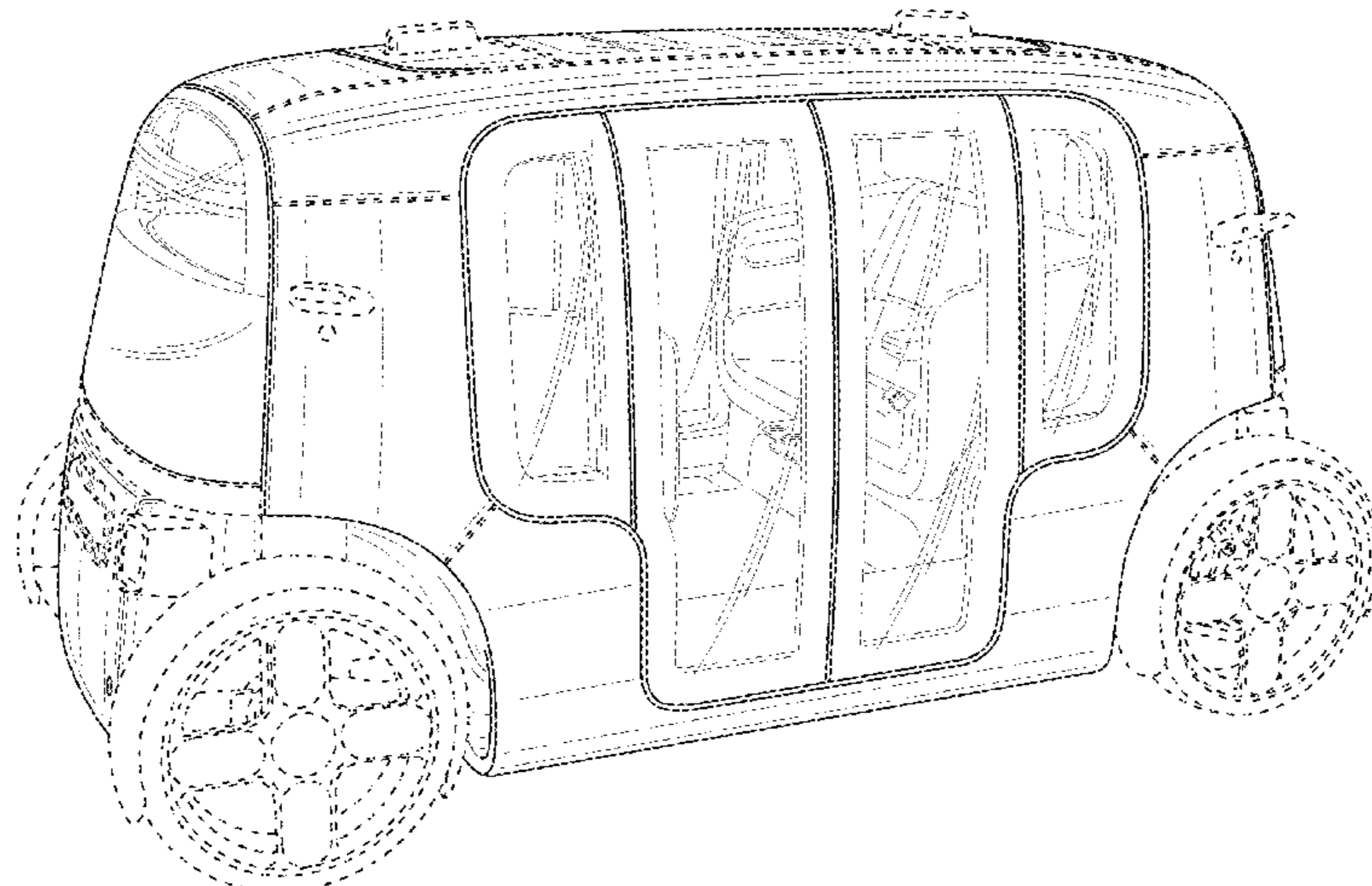
FIG. 19 is a left-side view thereof;

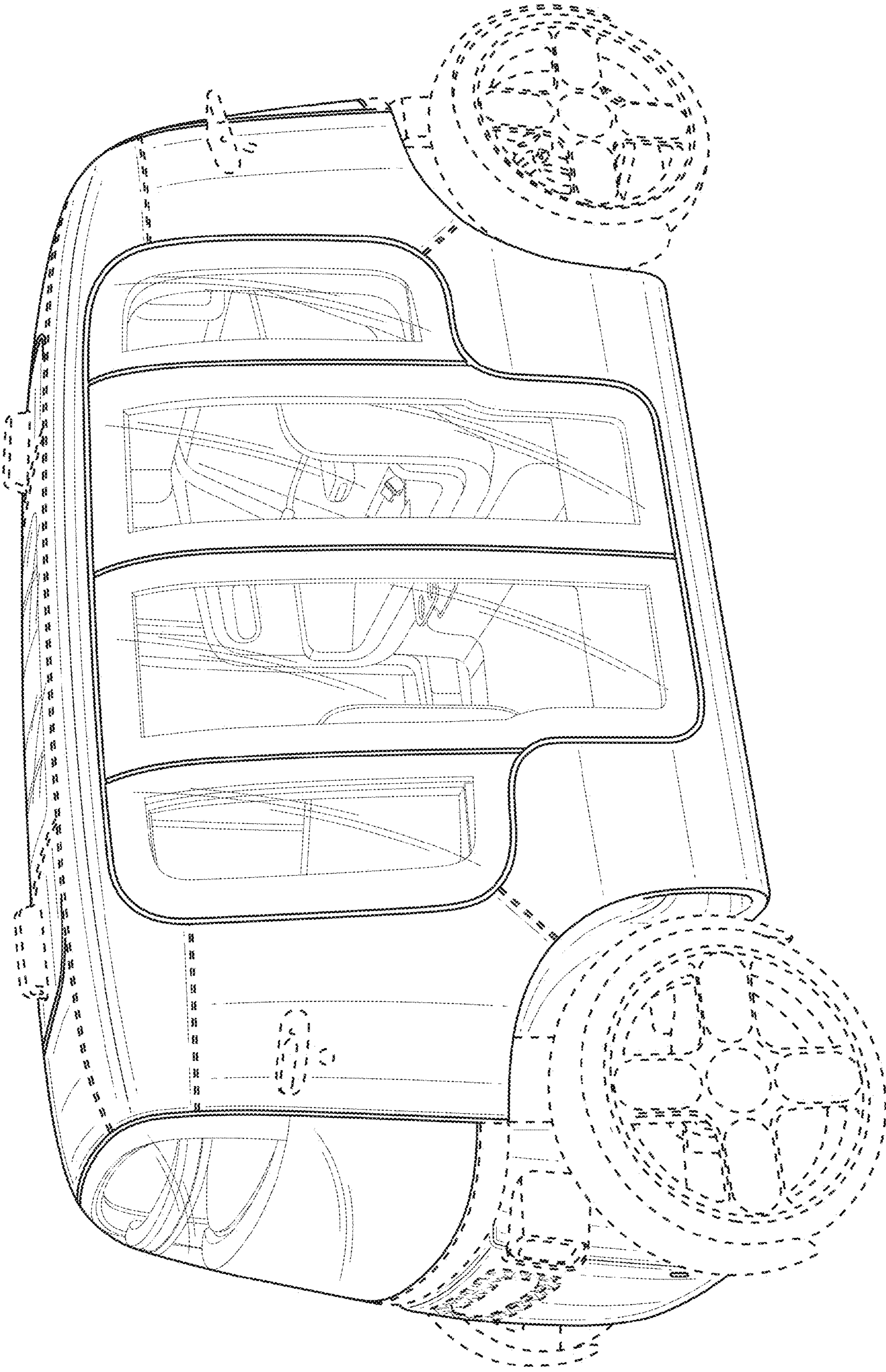

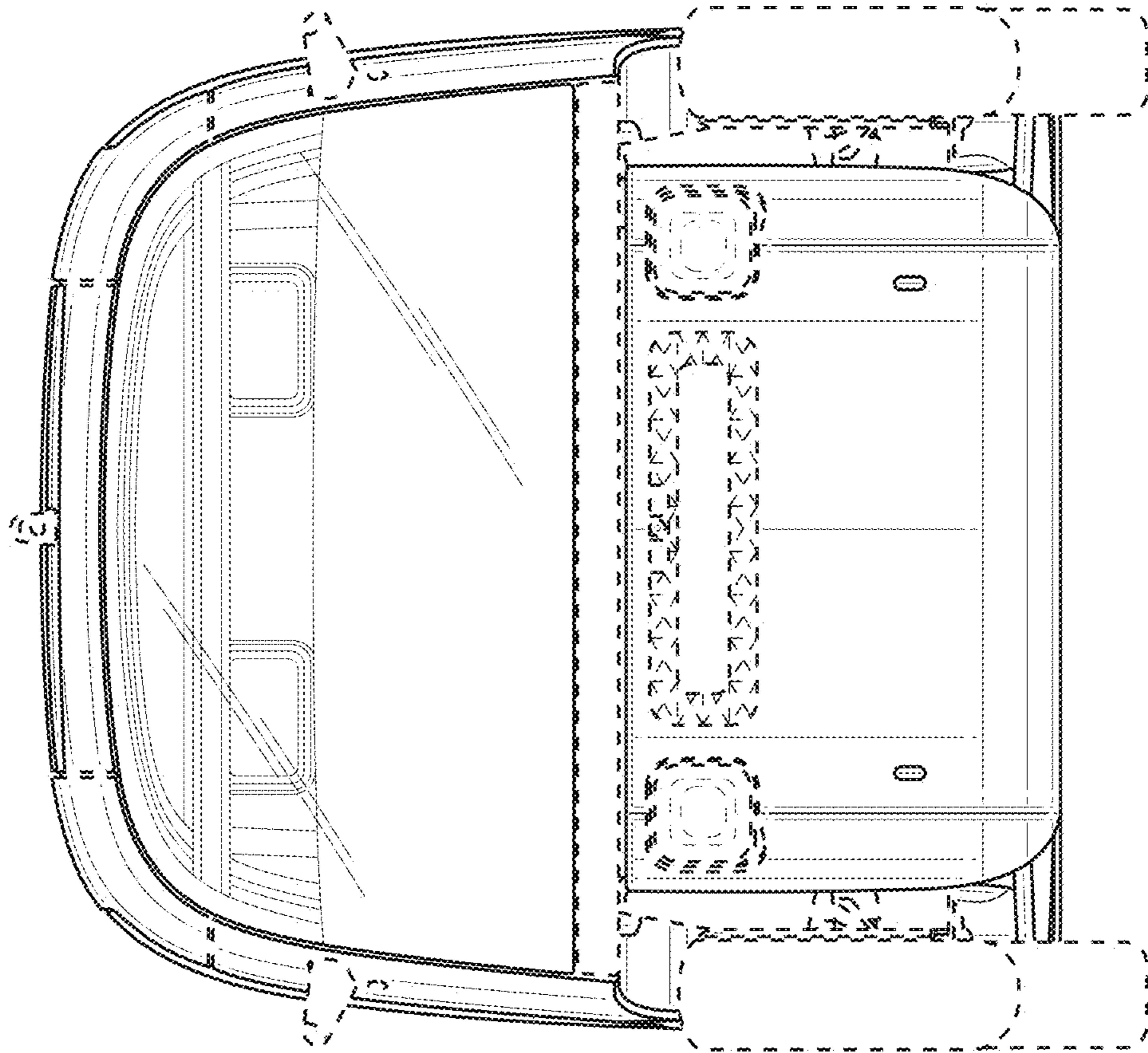

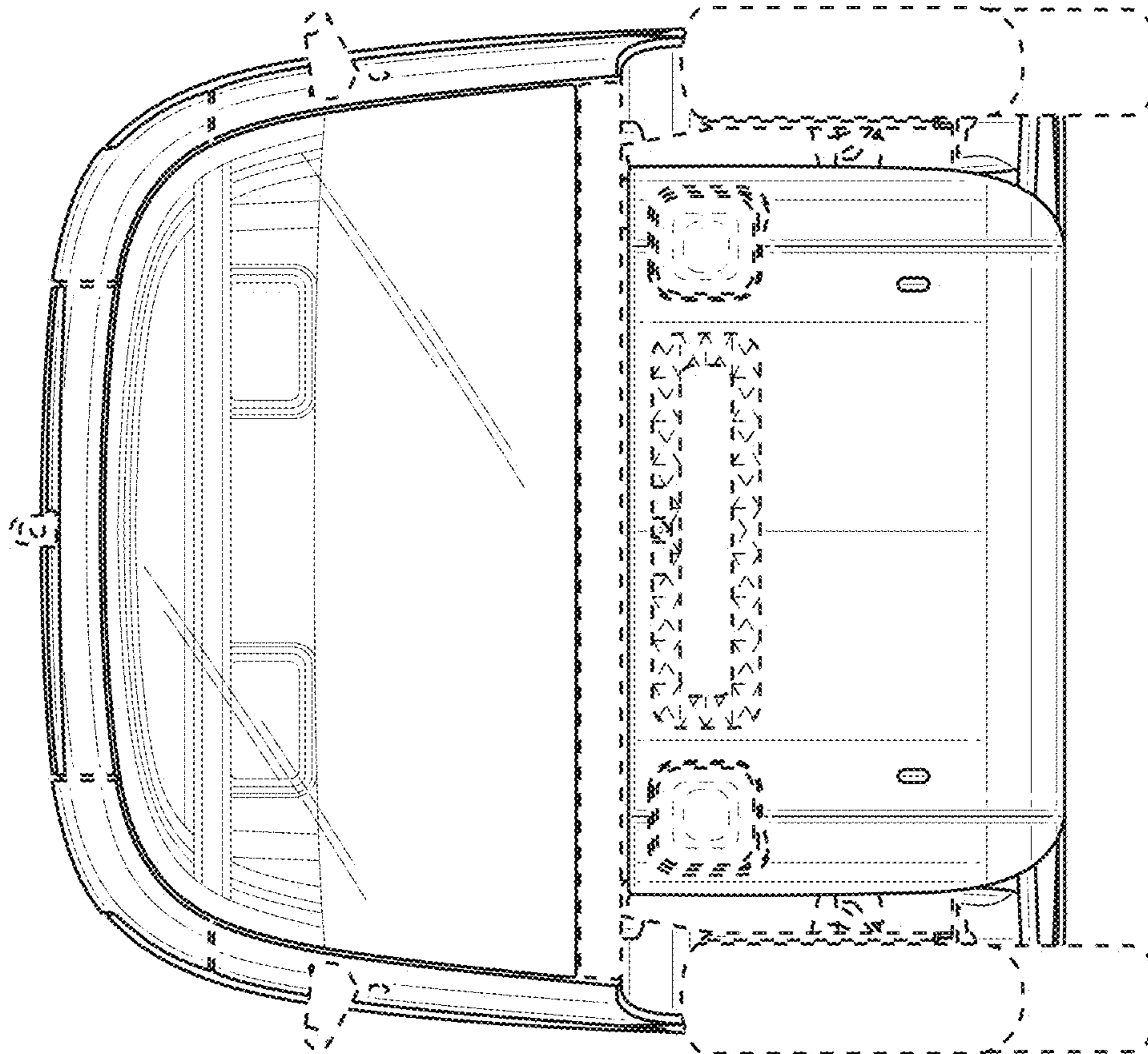

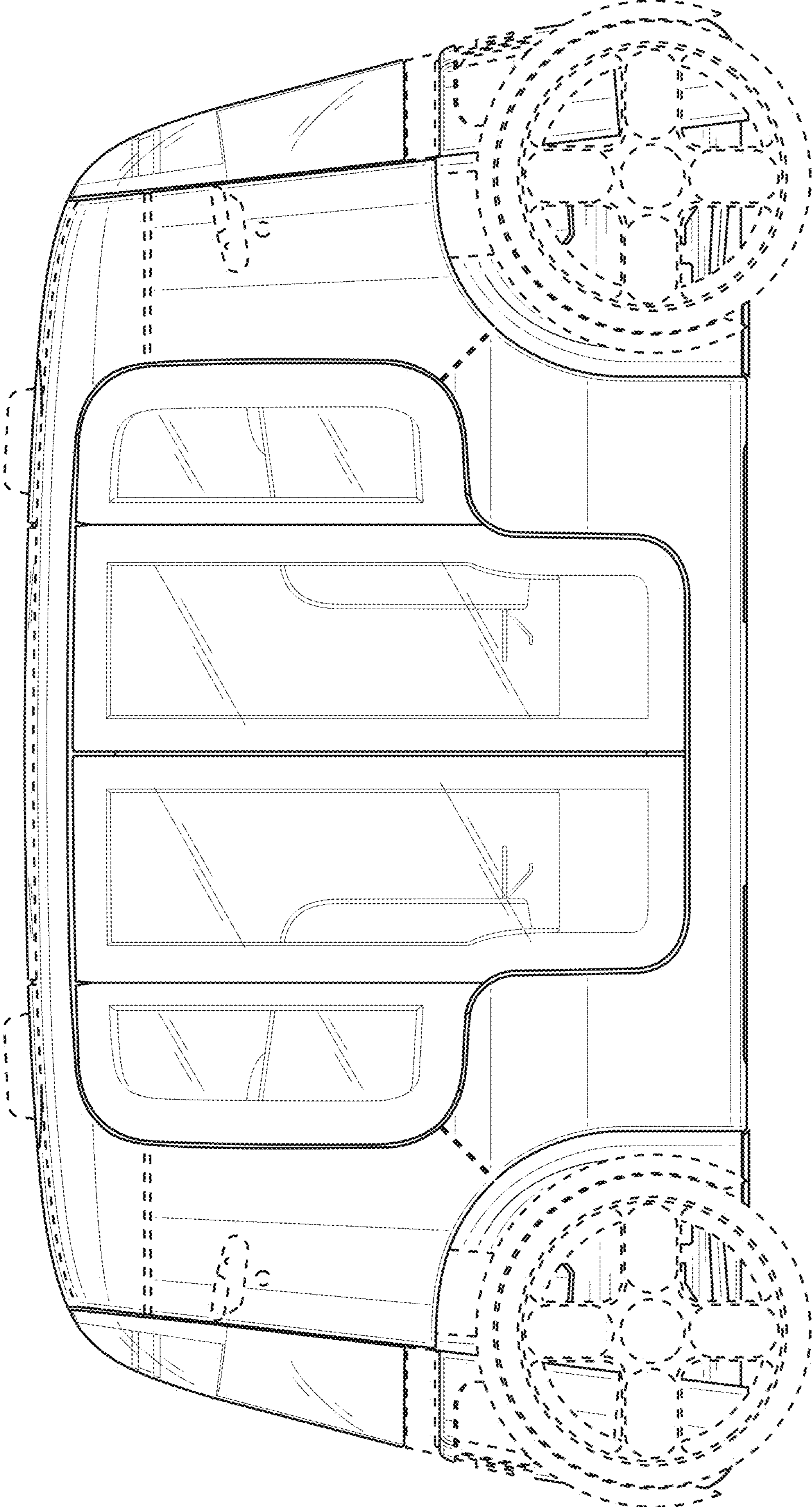

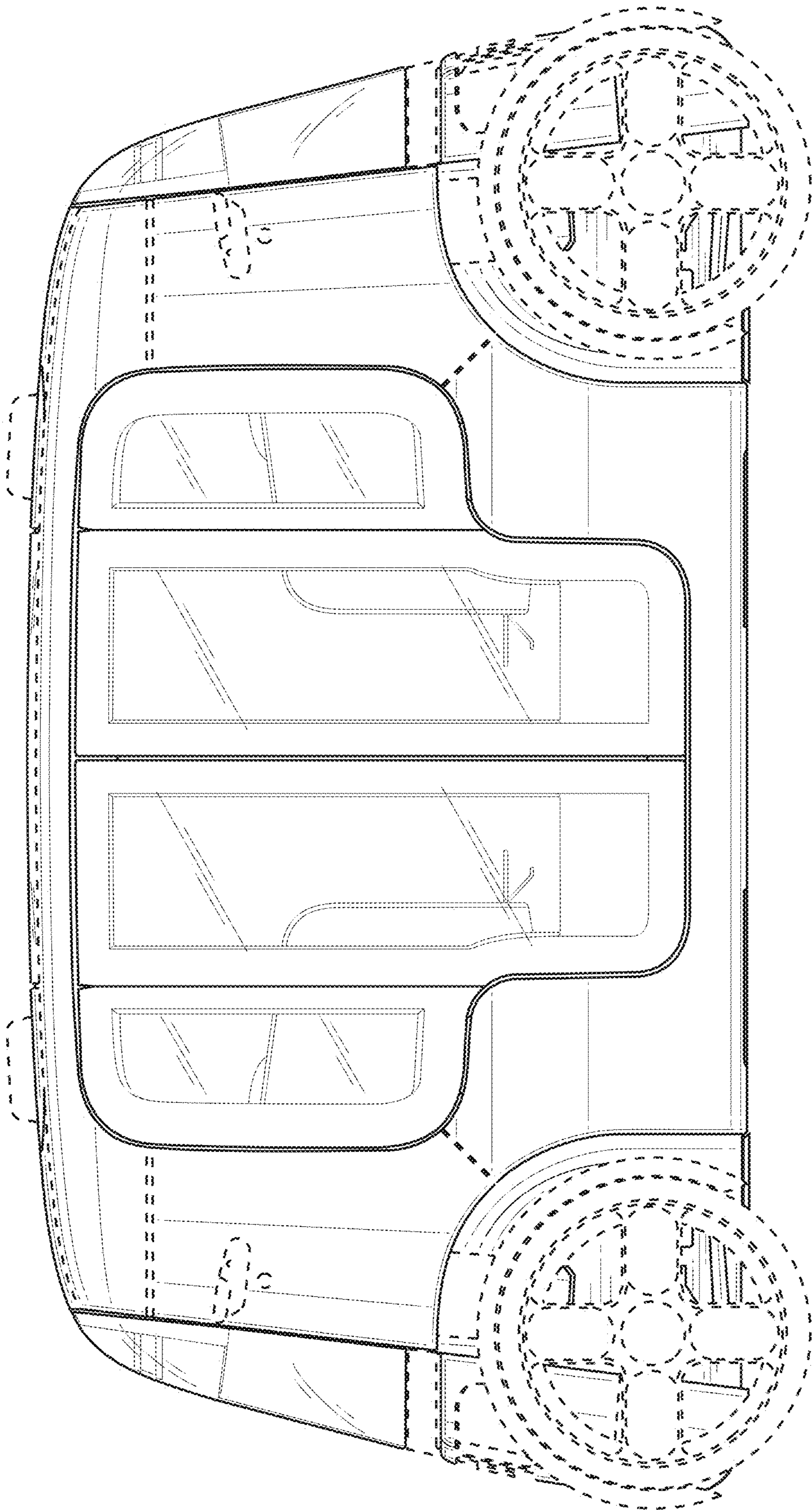

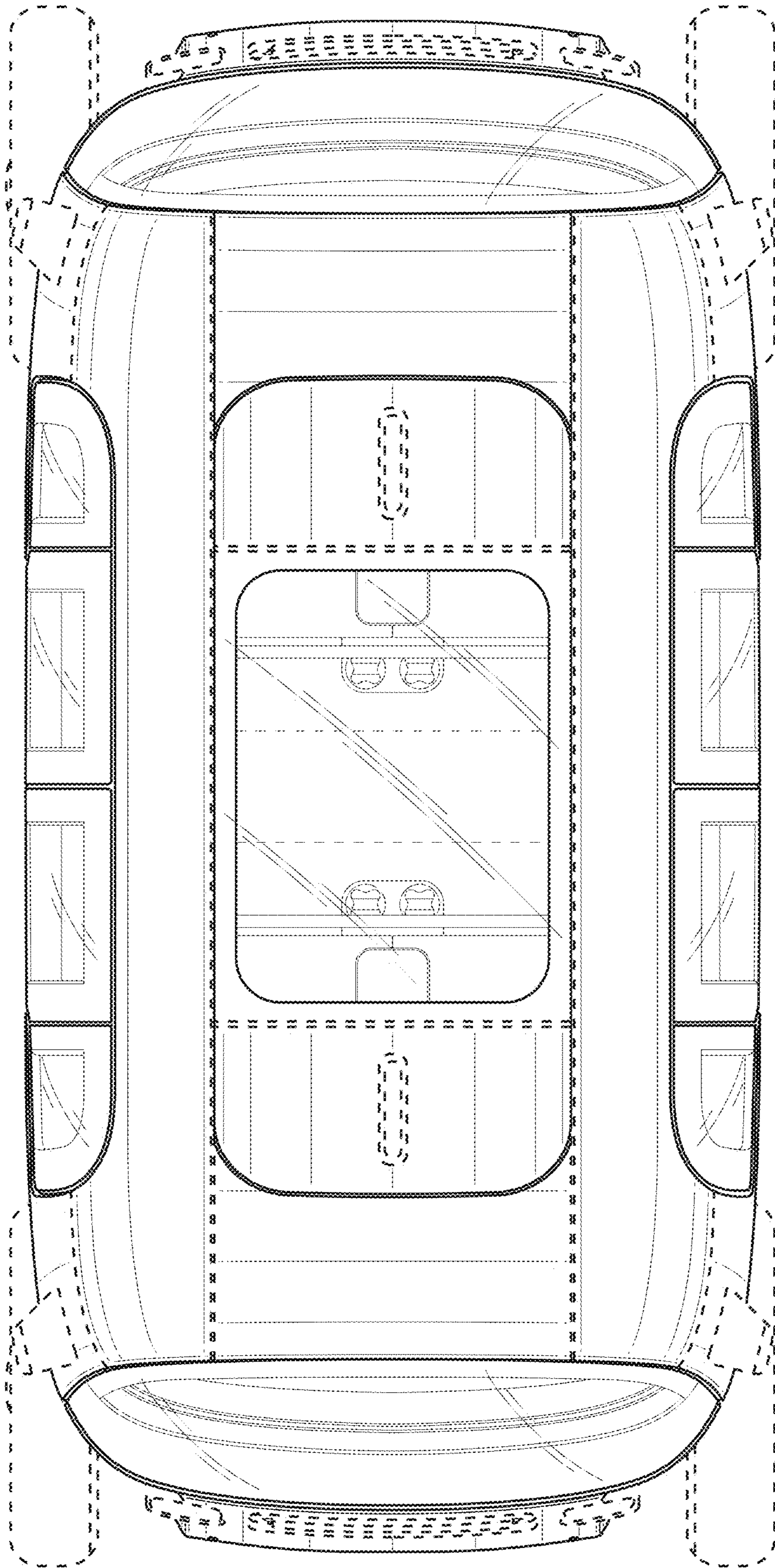

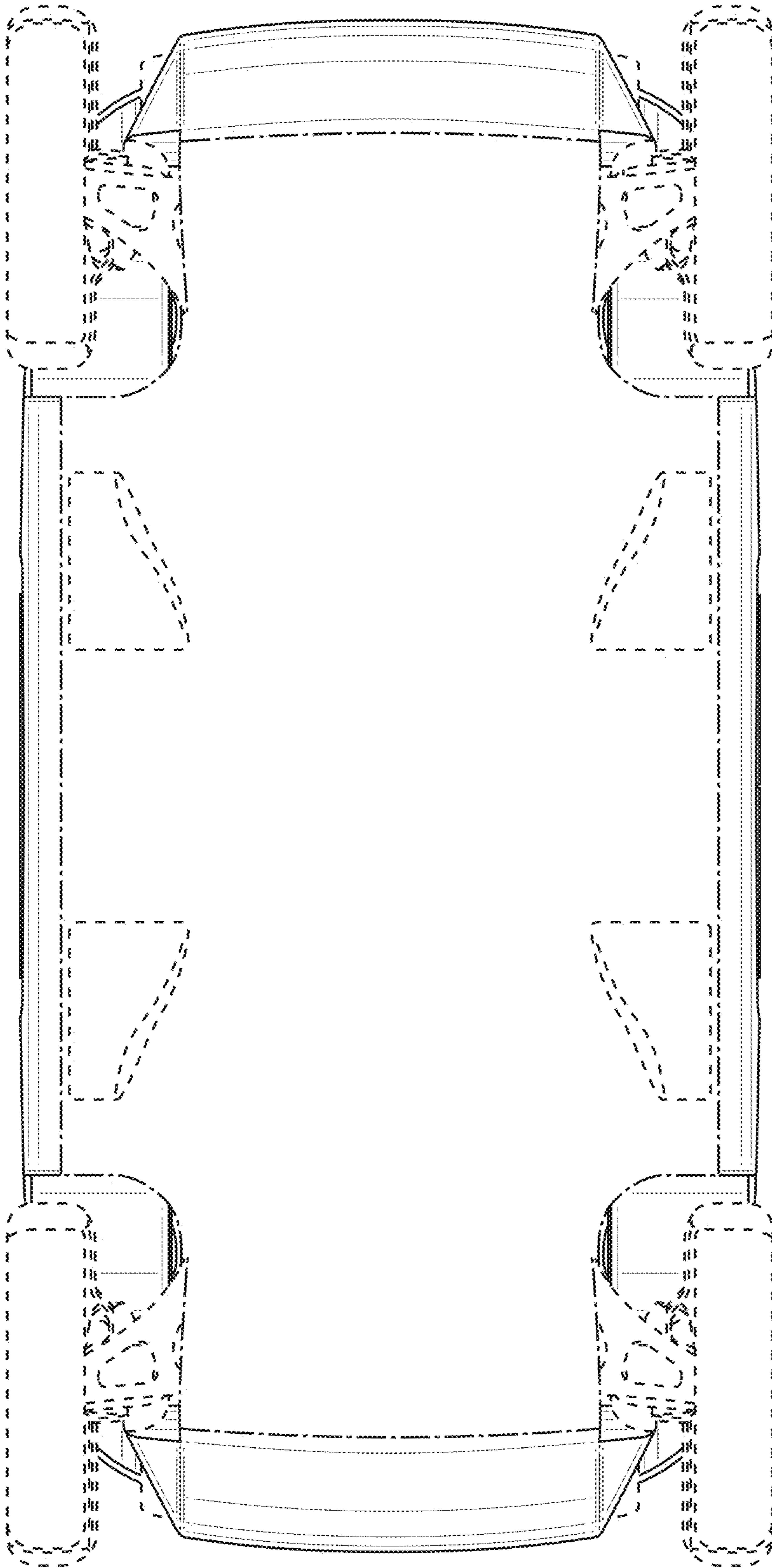

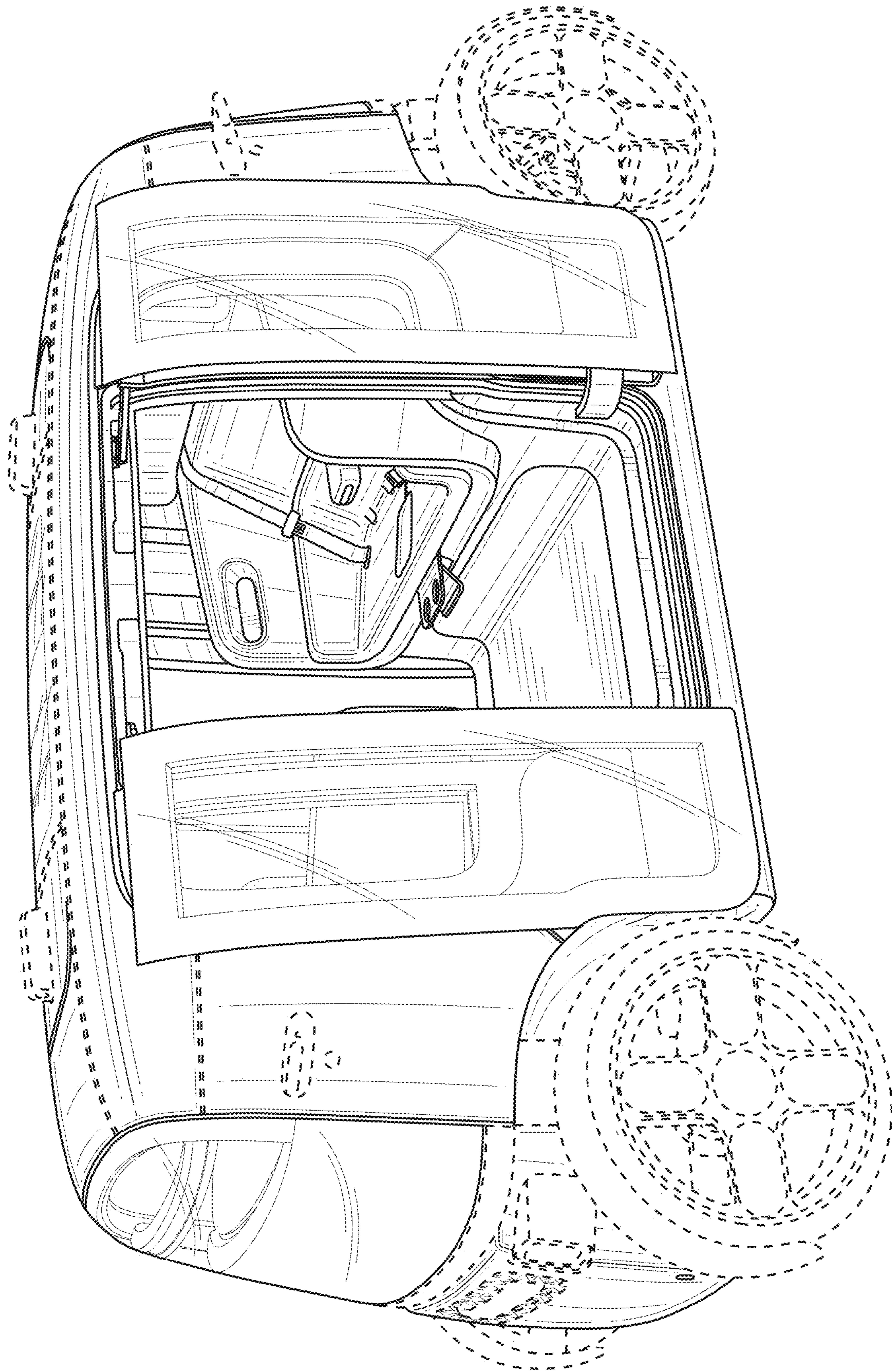

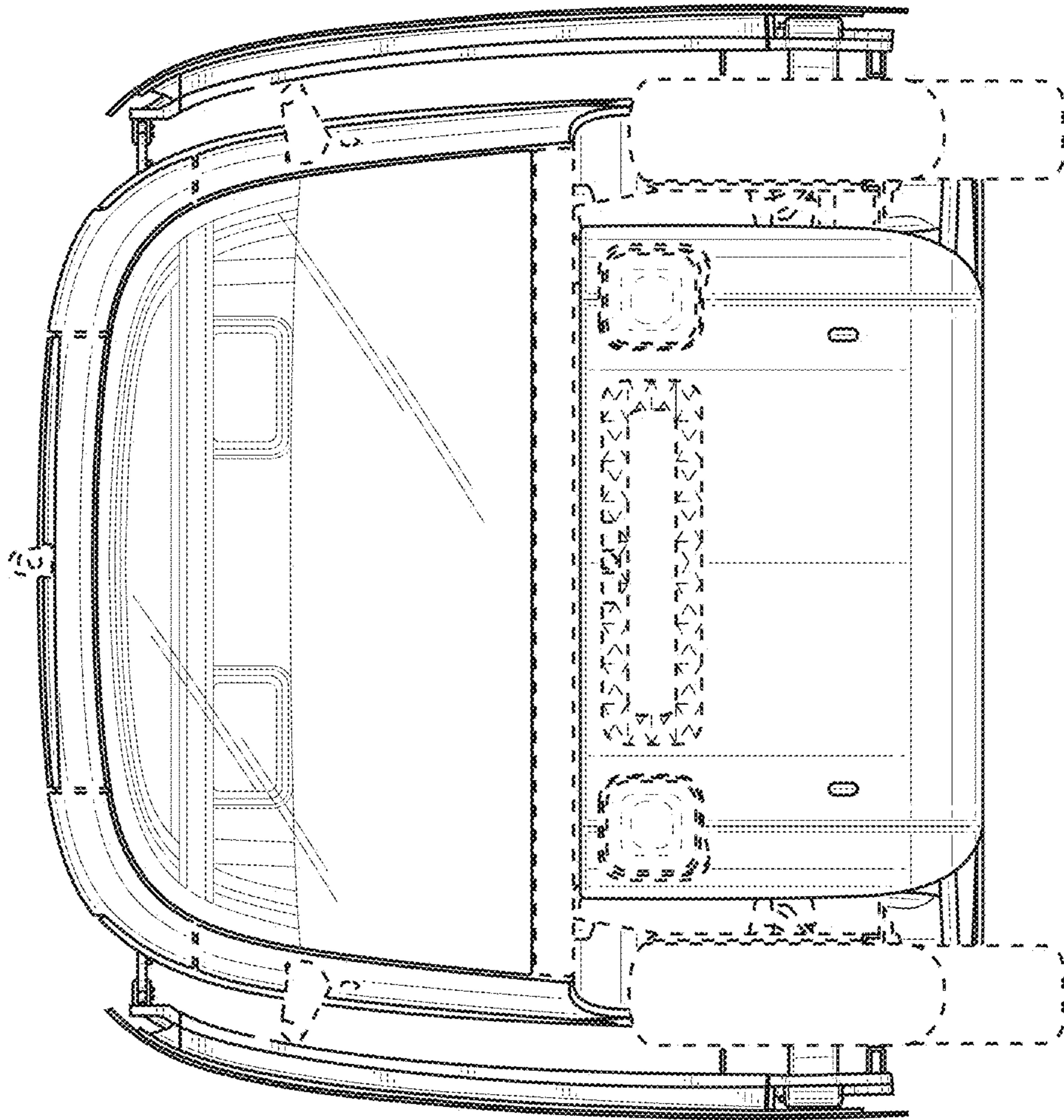

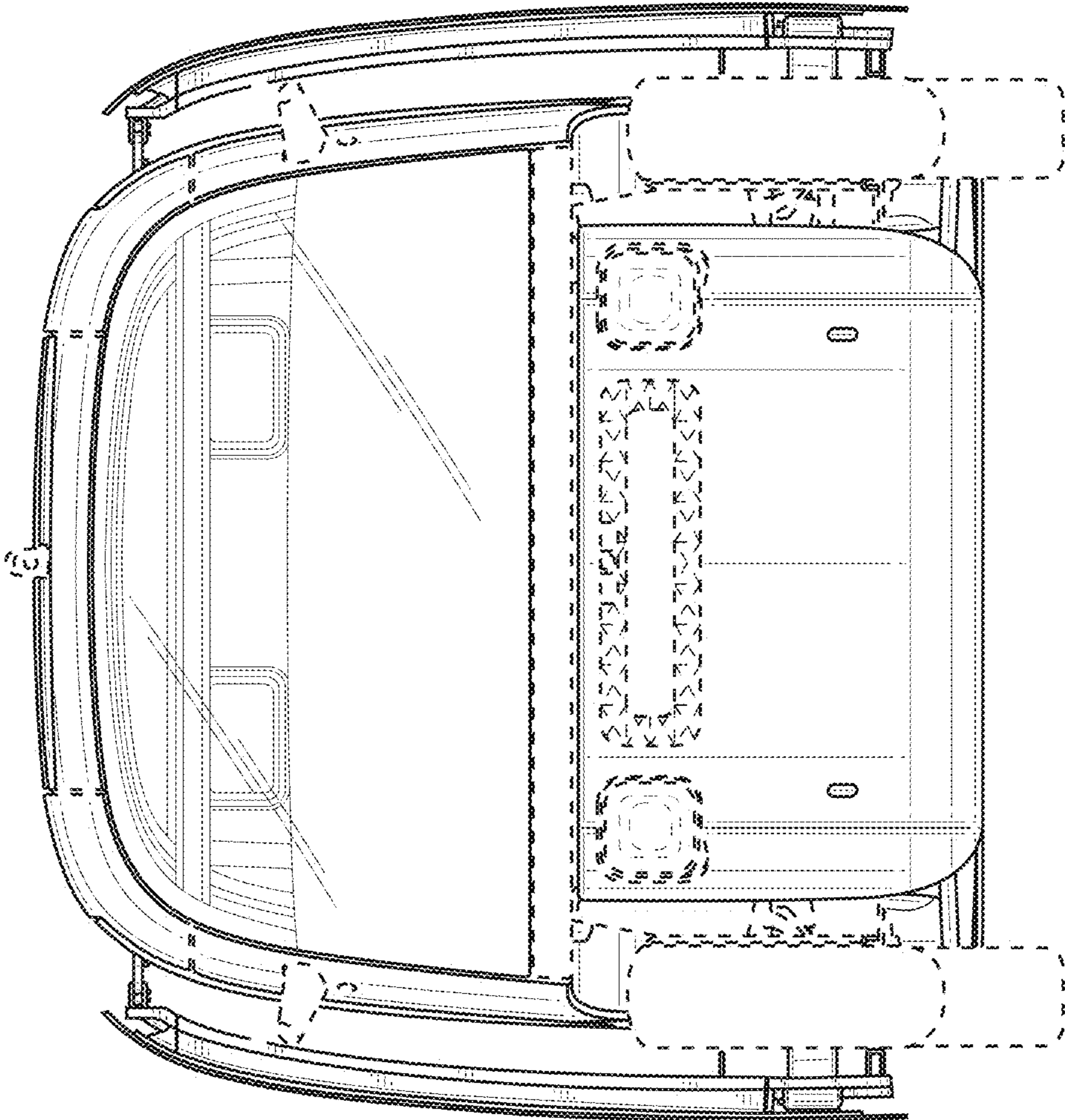

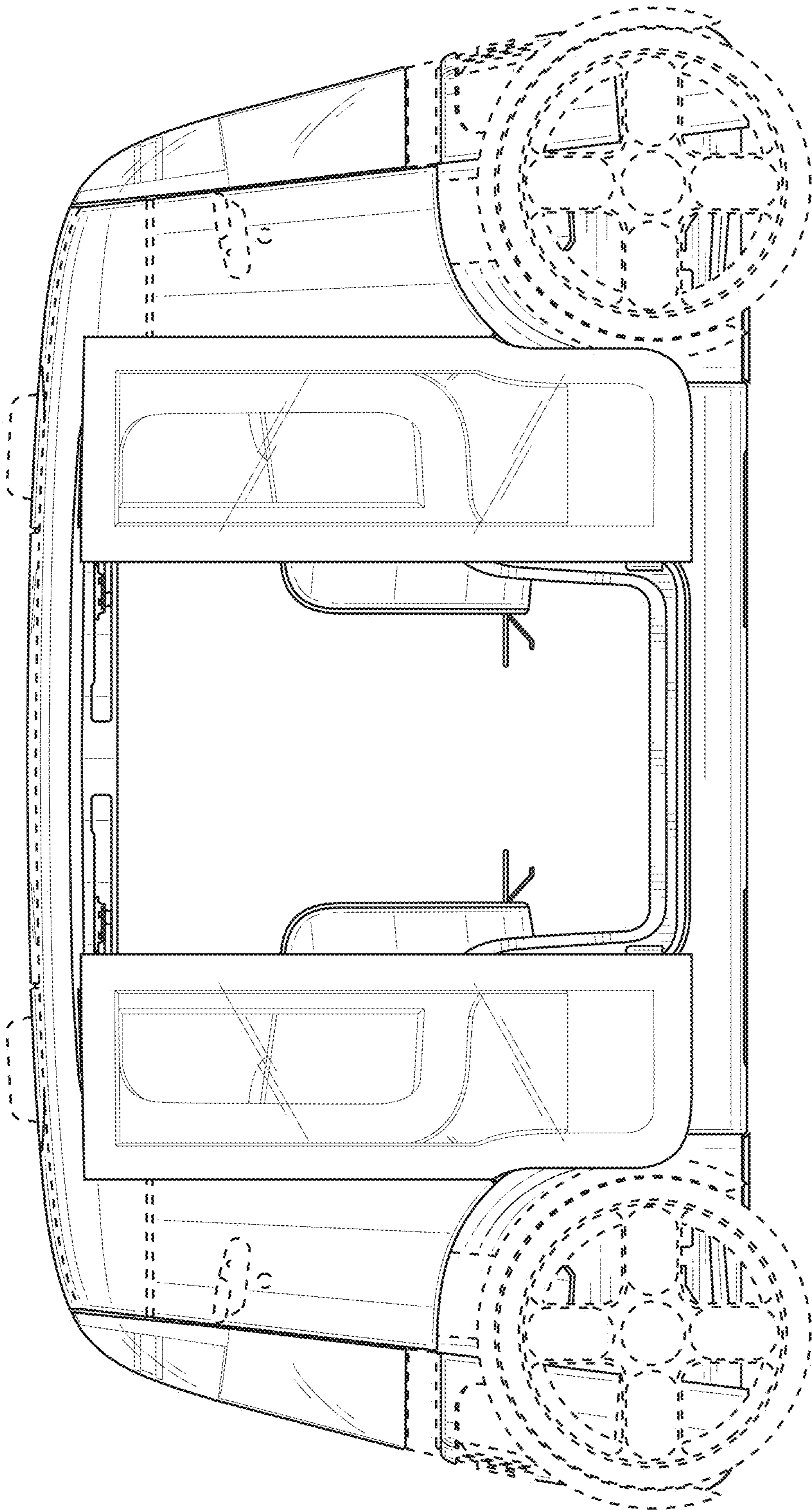

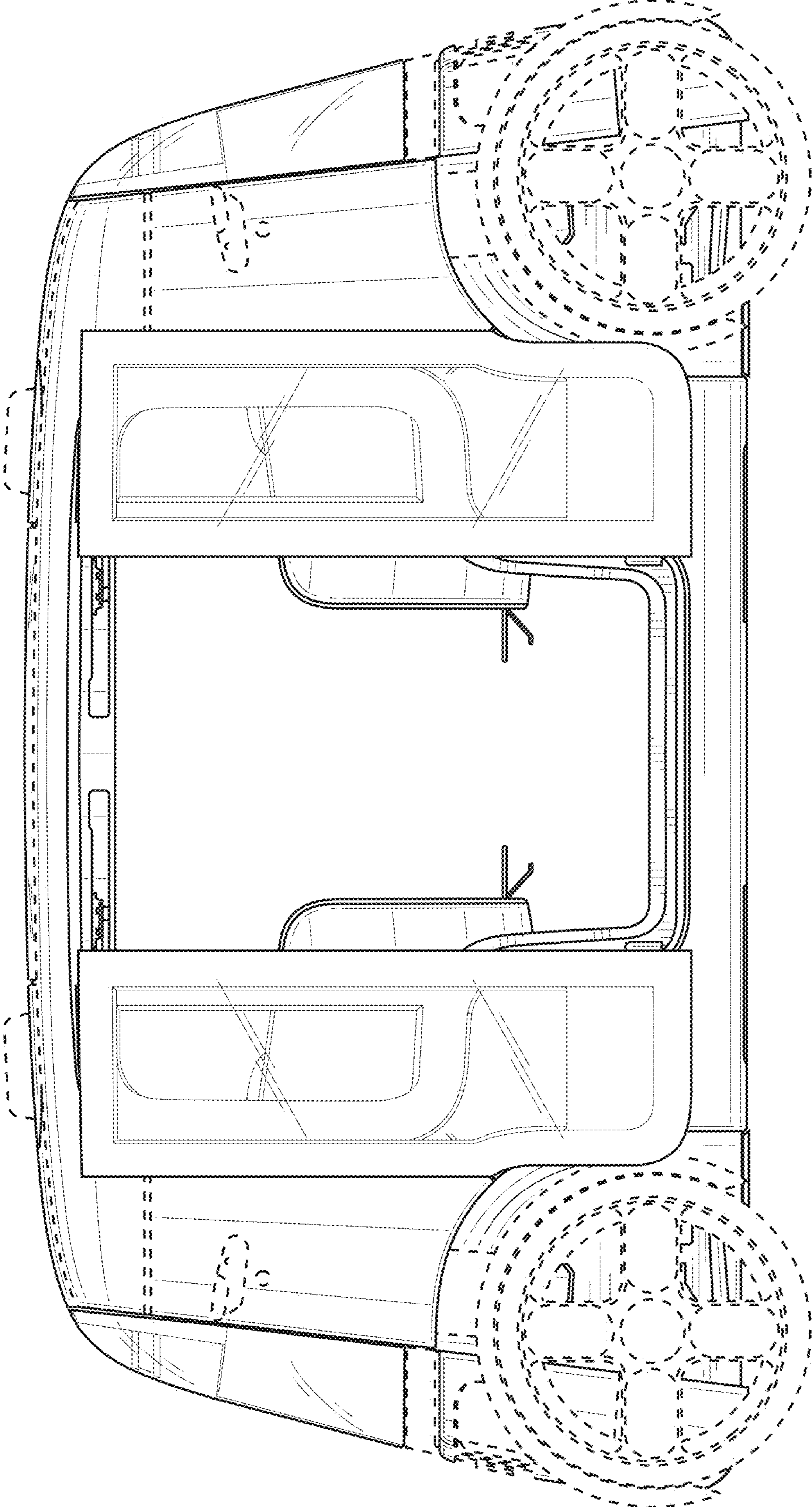

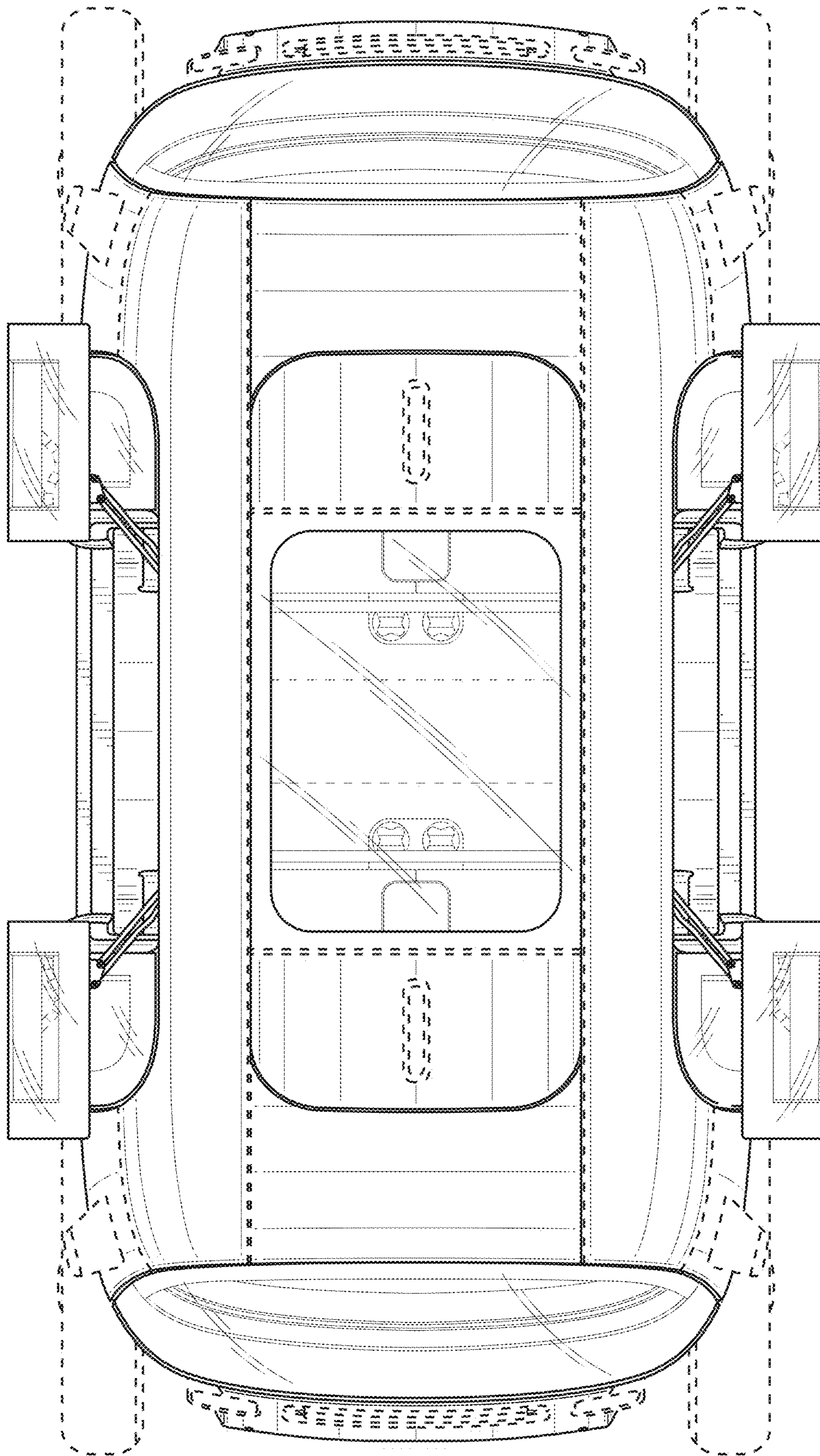

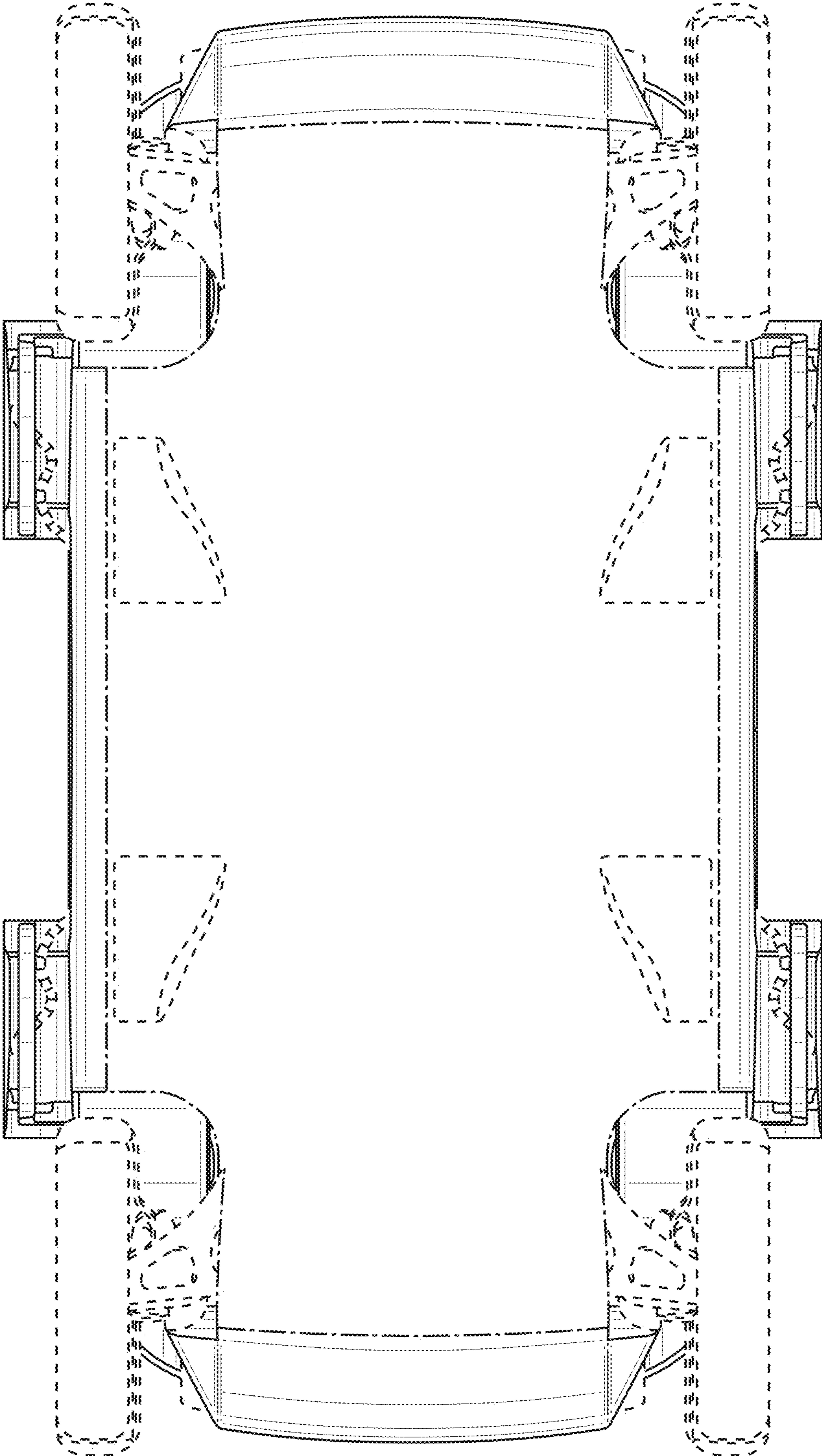

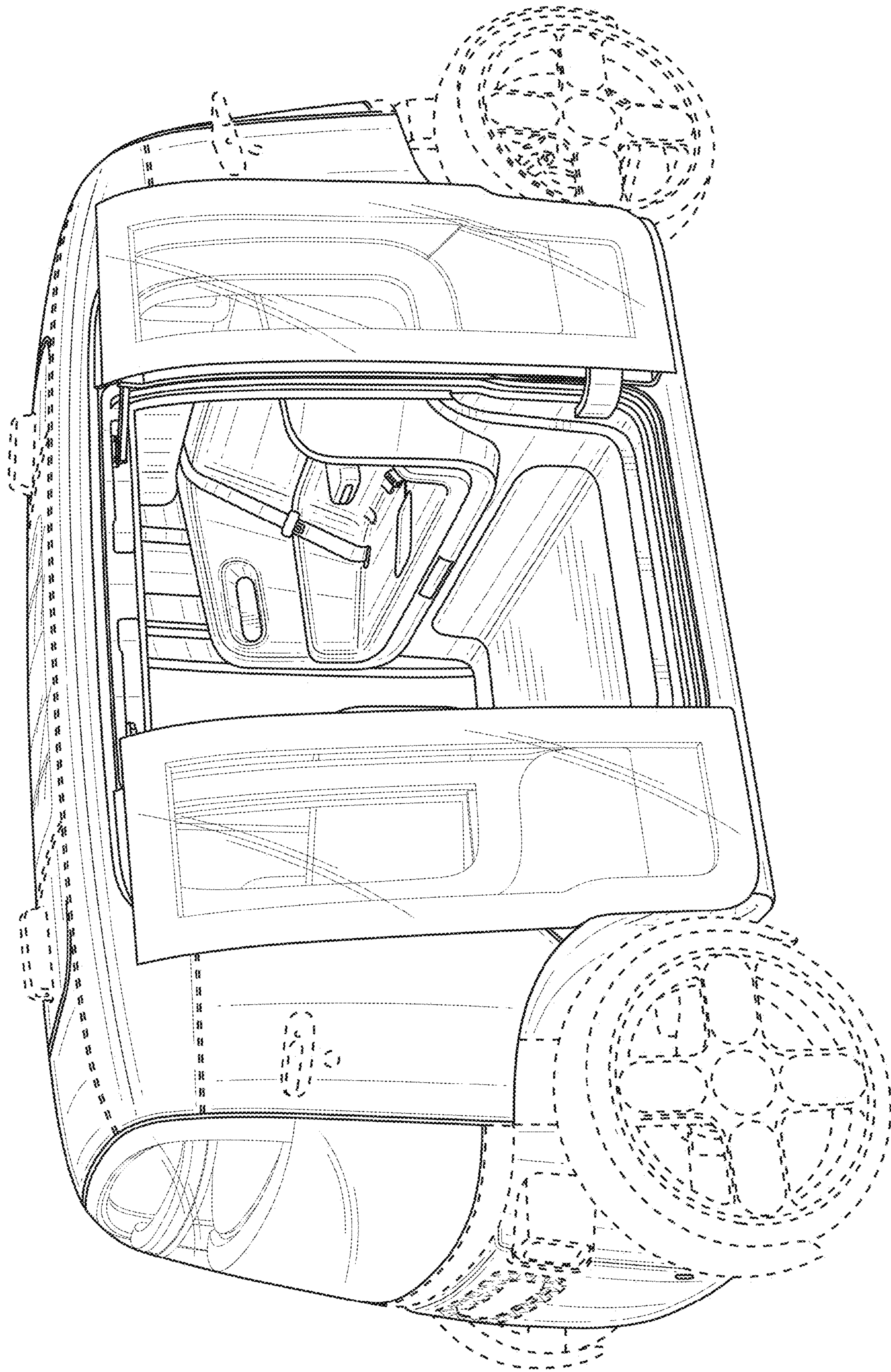

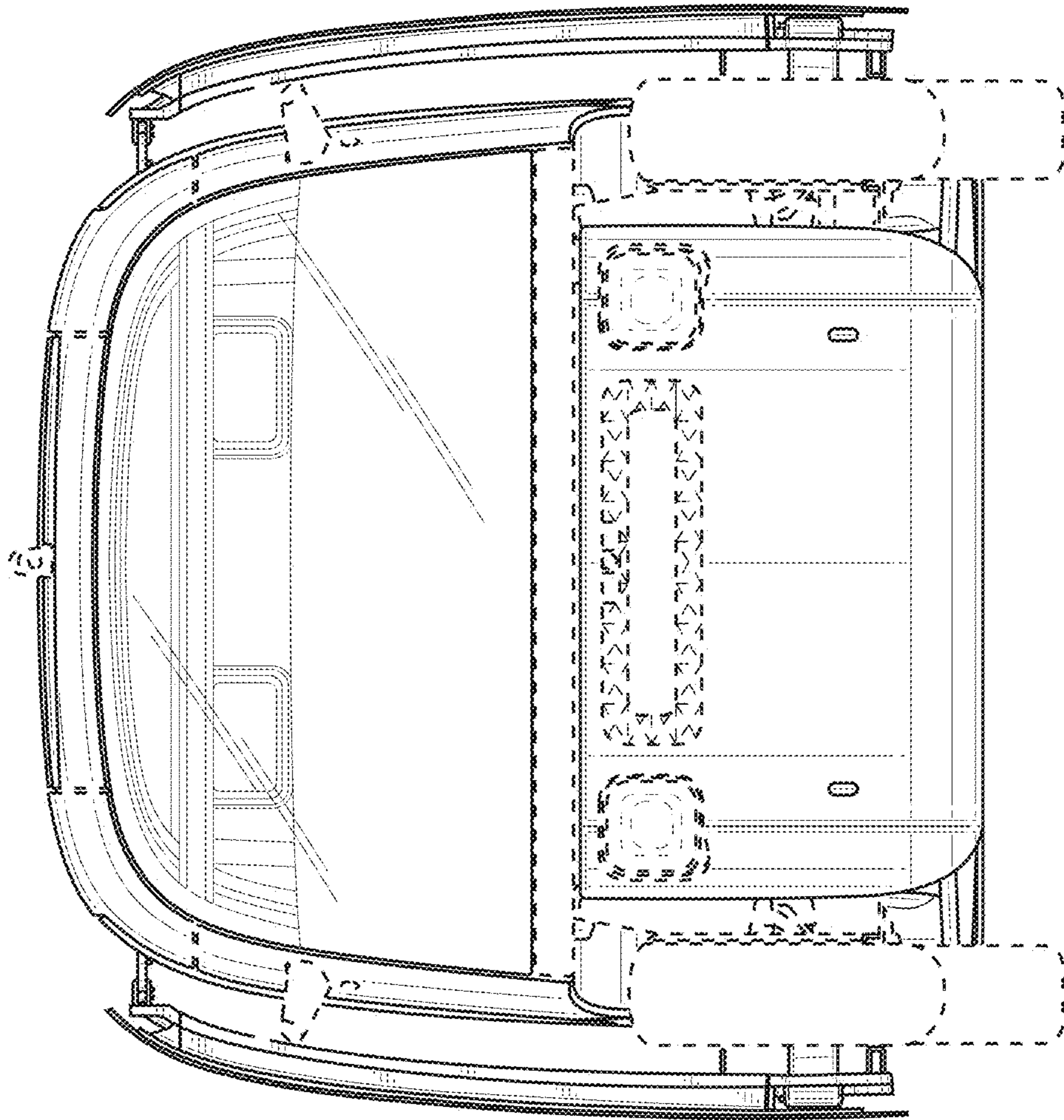

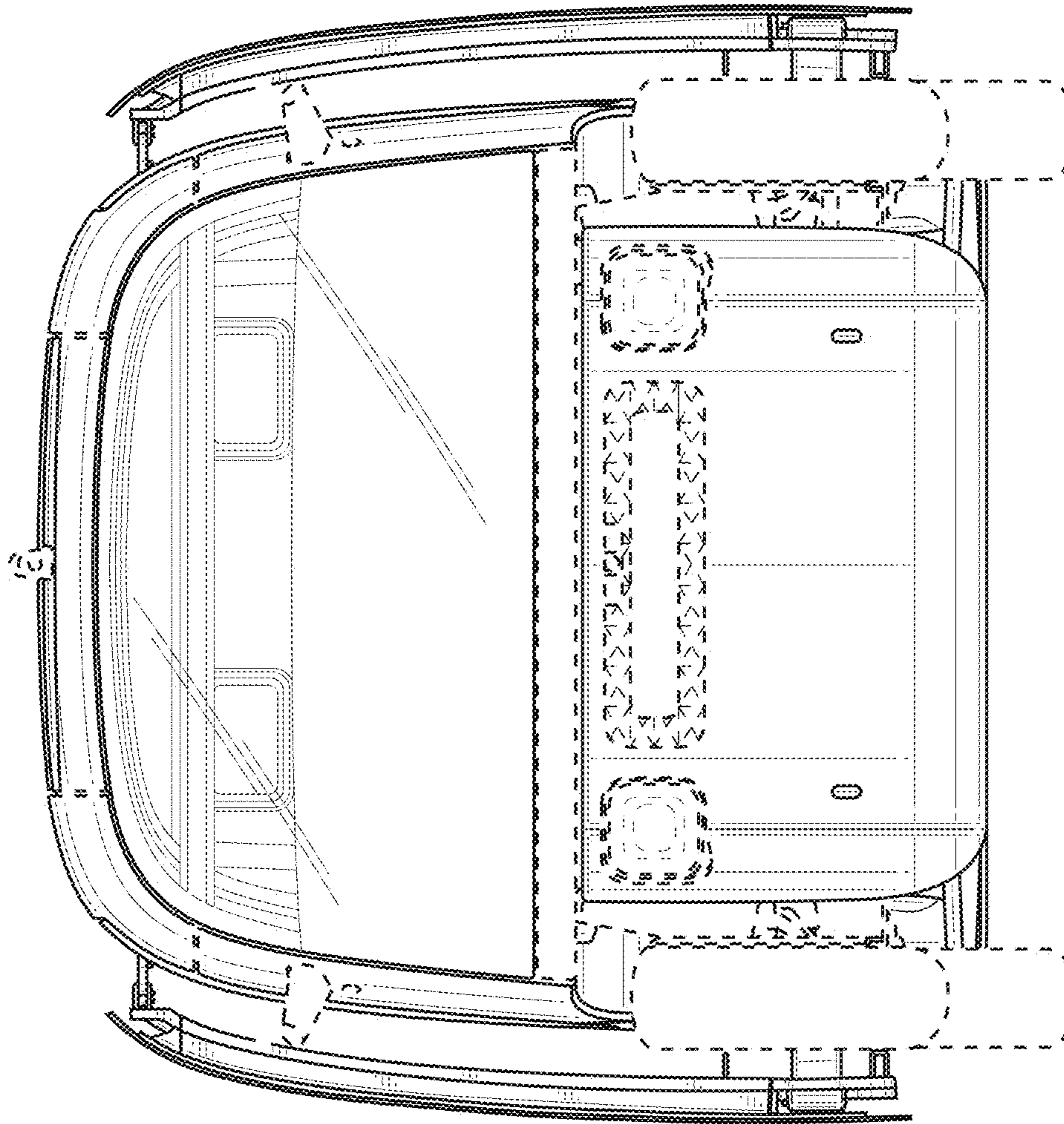

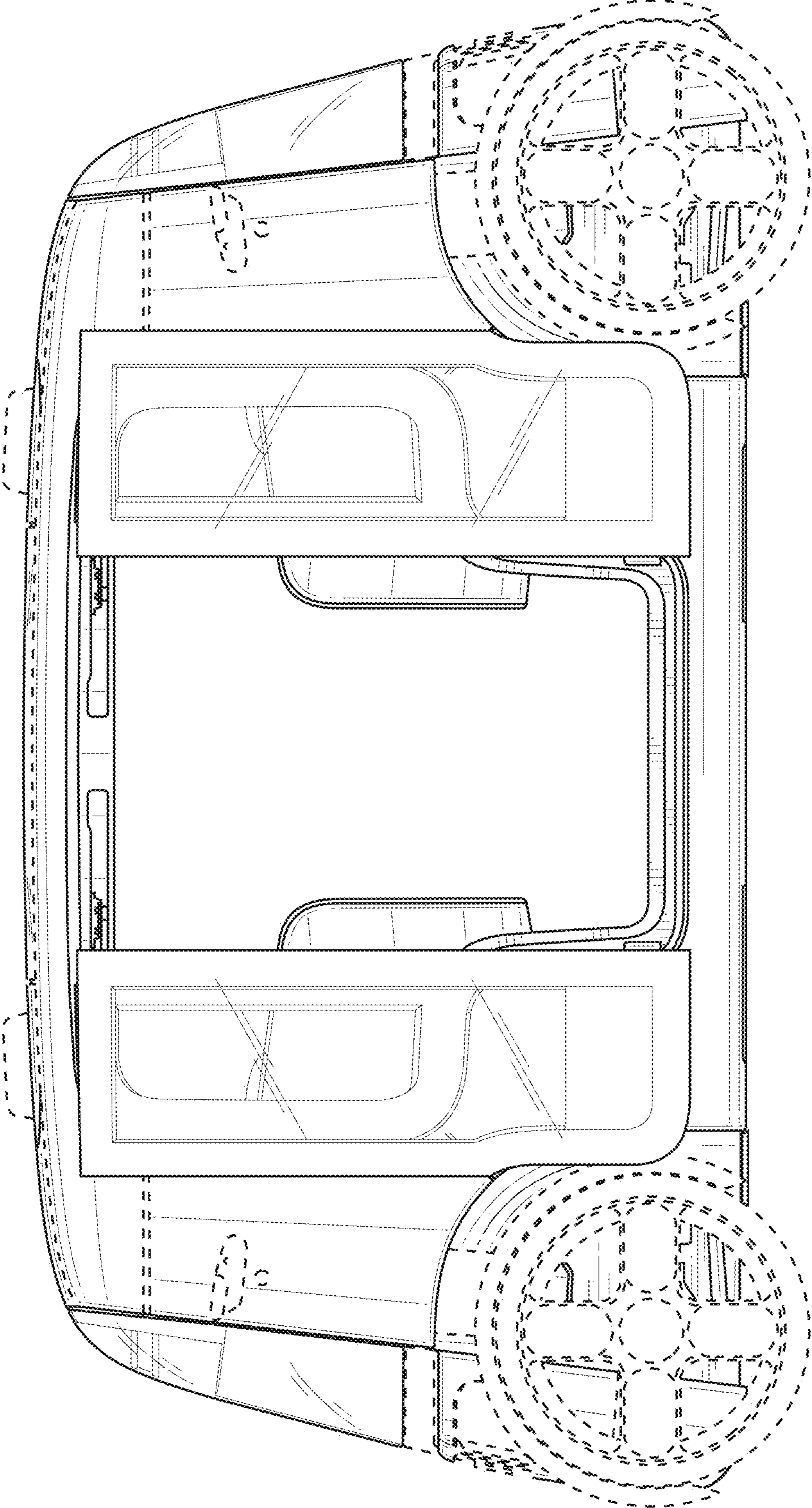

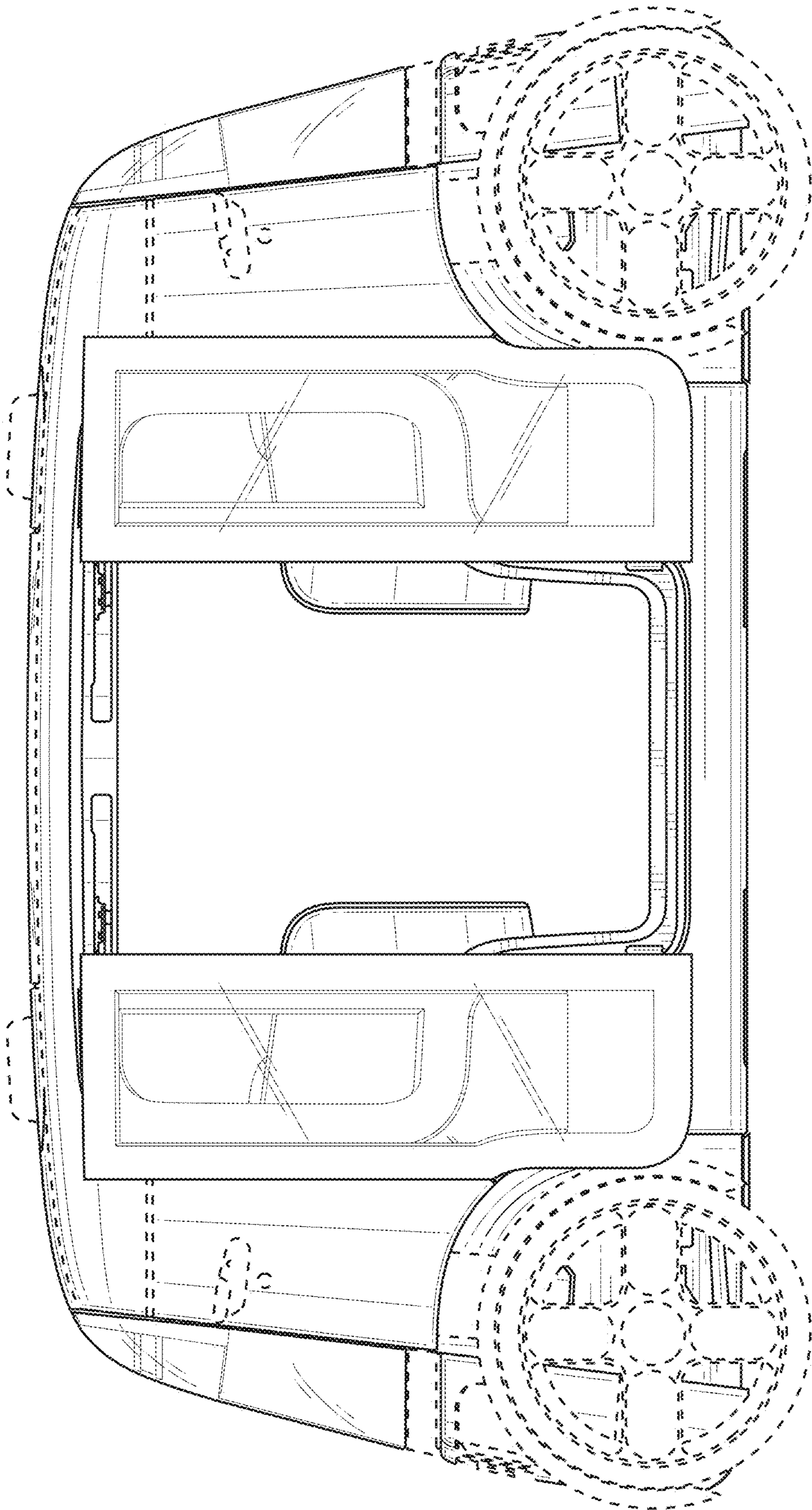

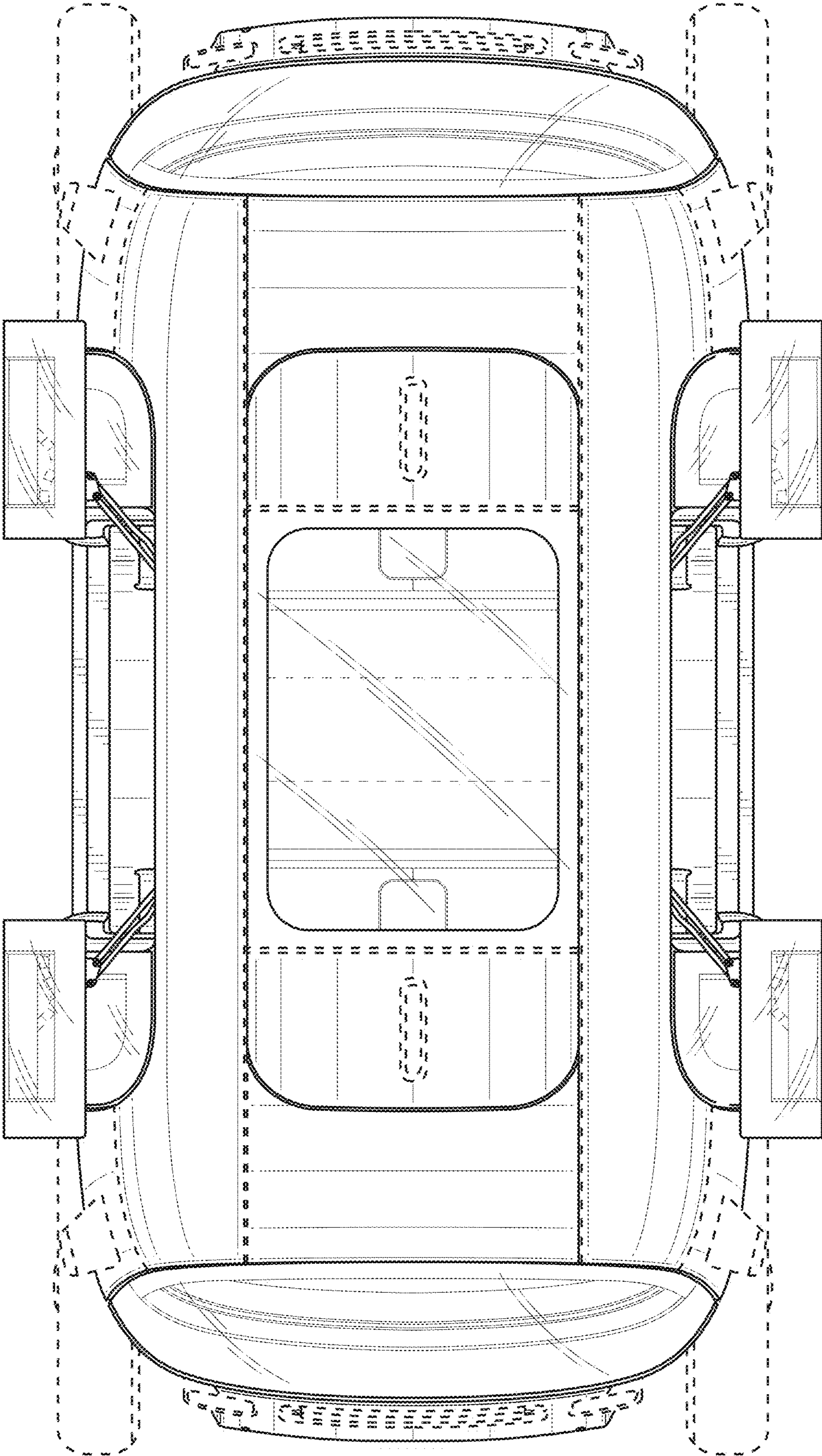

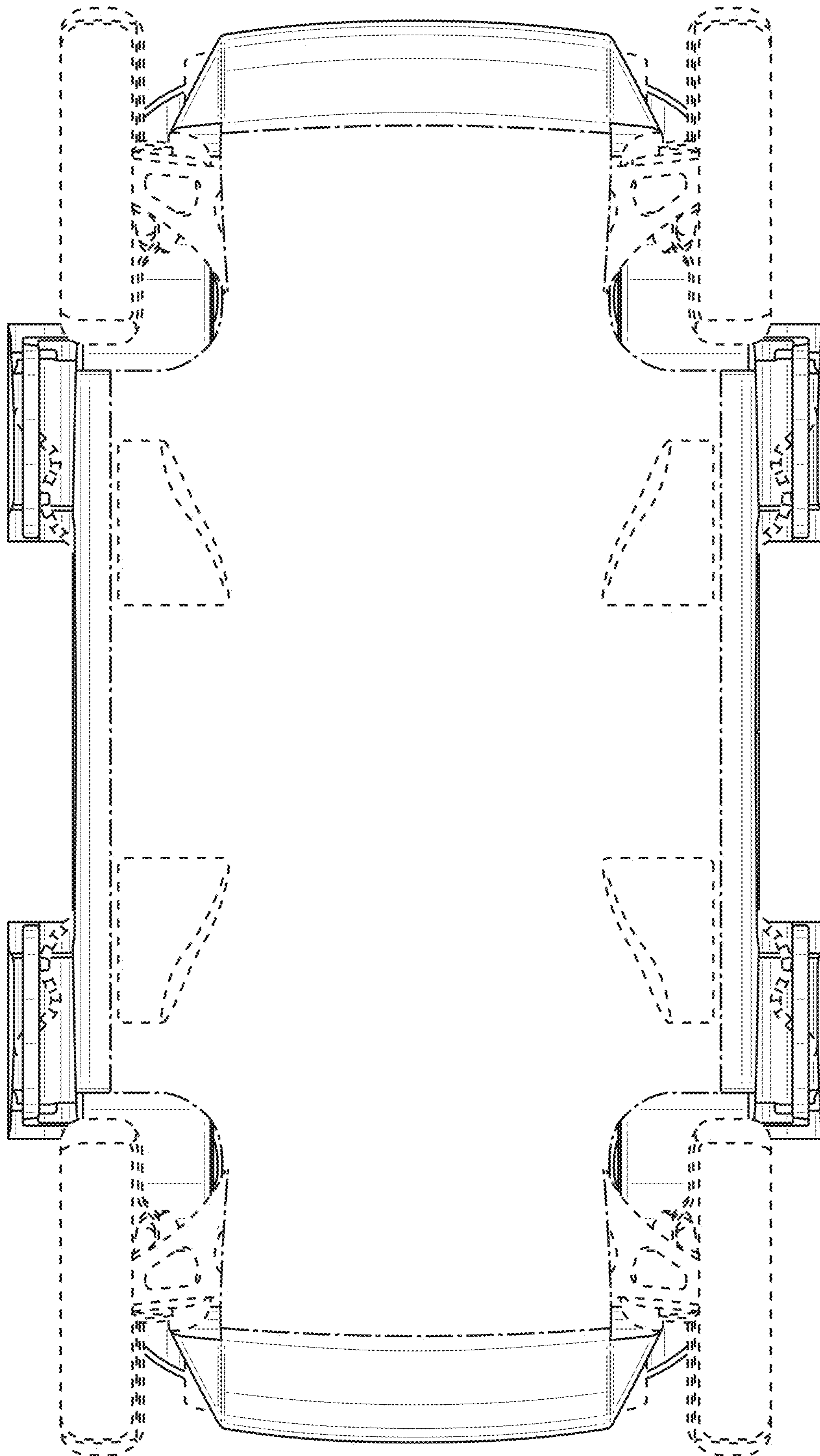
