FIG. 1 is a front perspective view of a motor vehicle, toy and/or replica;

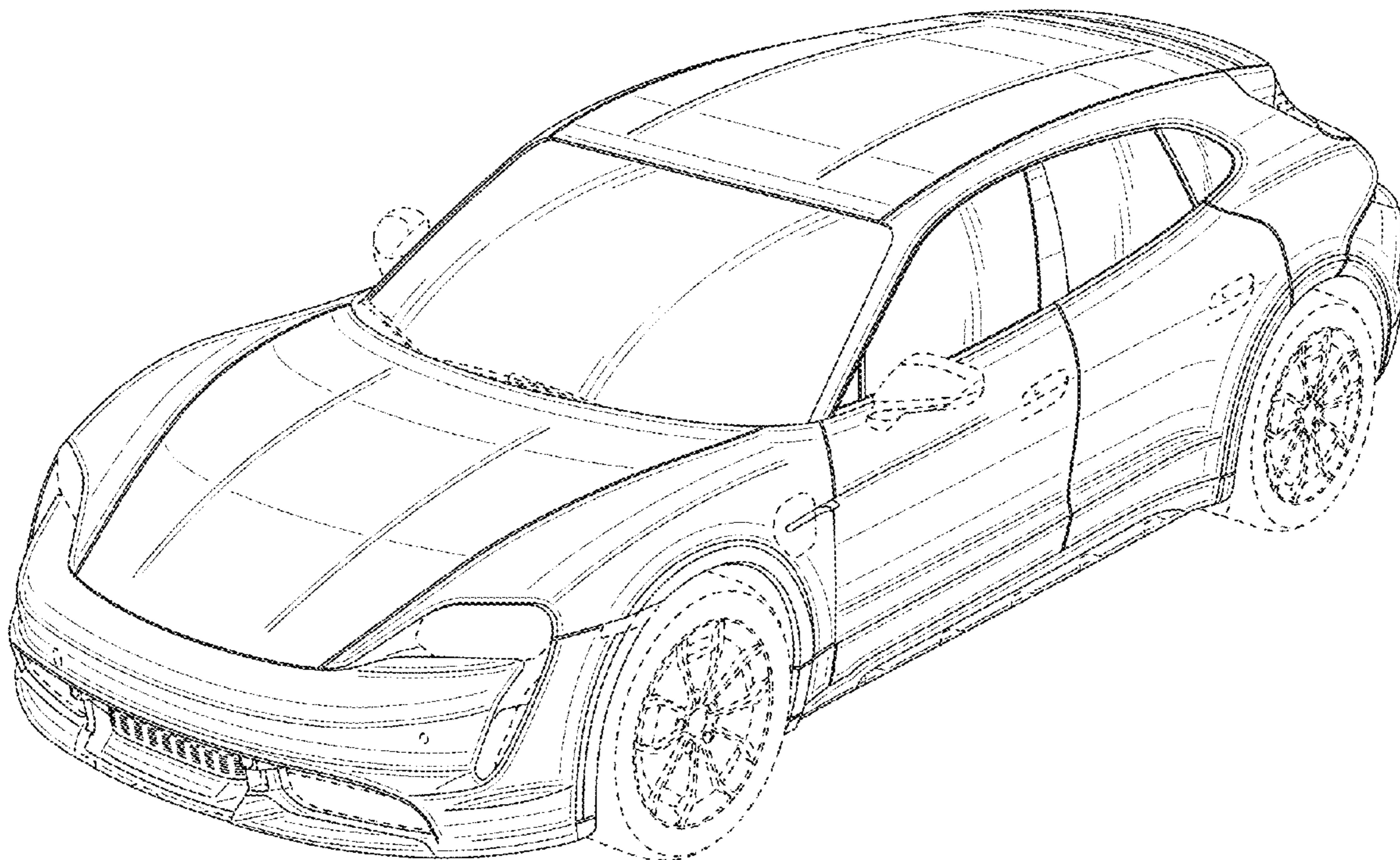
FIG. 2 is a front elevation view thereof;

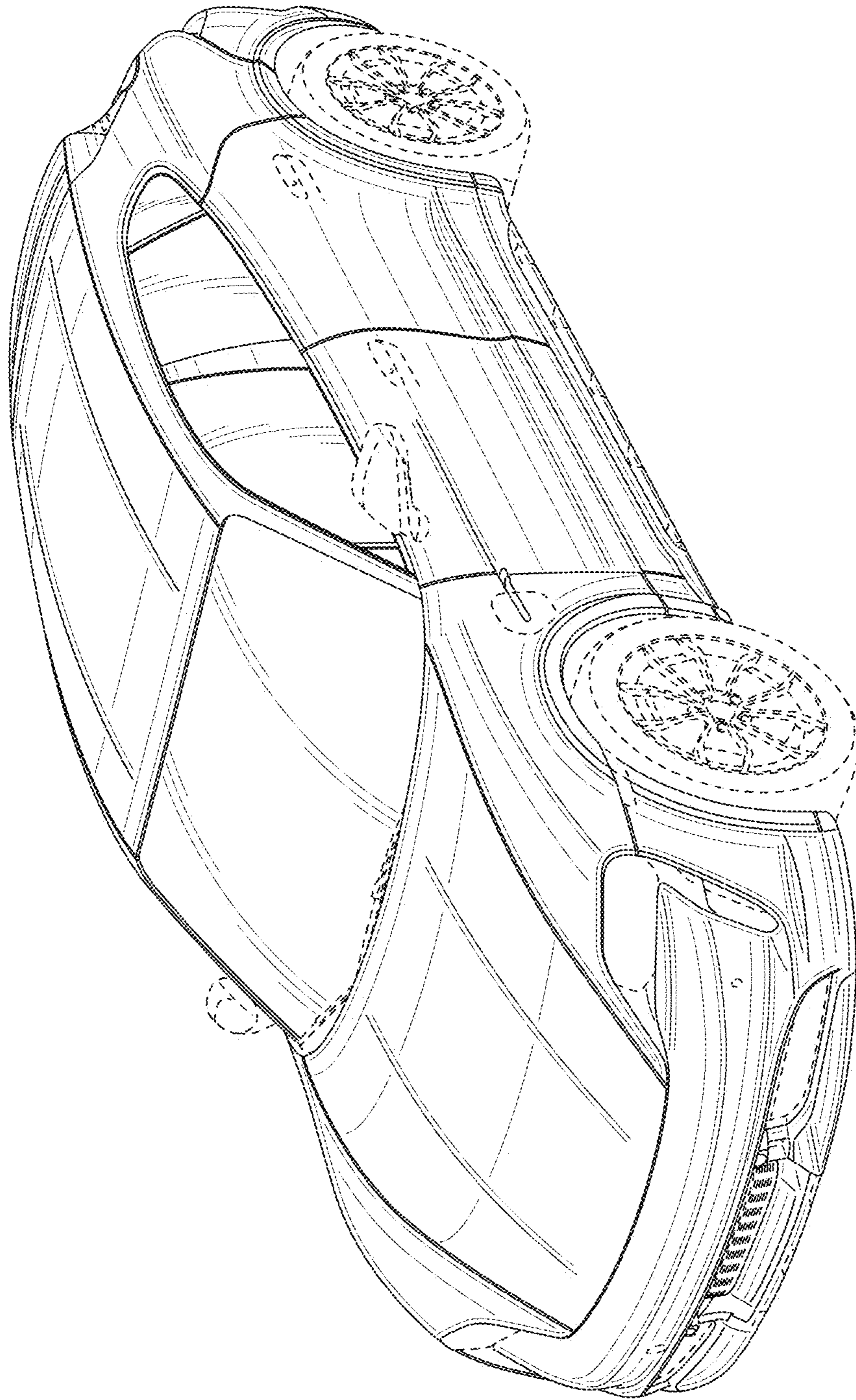

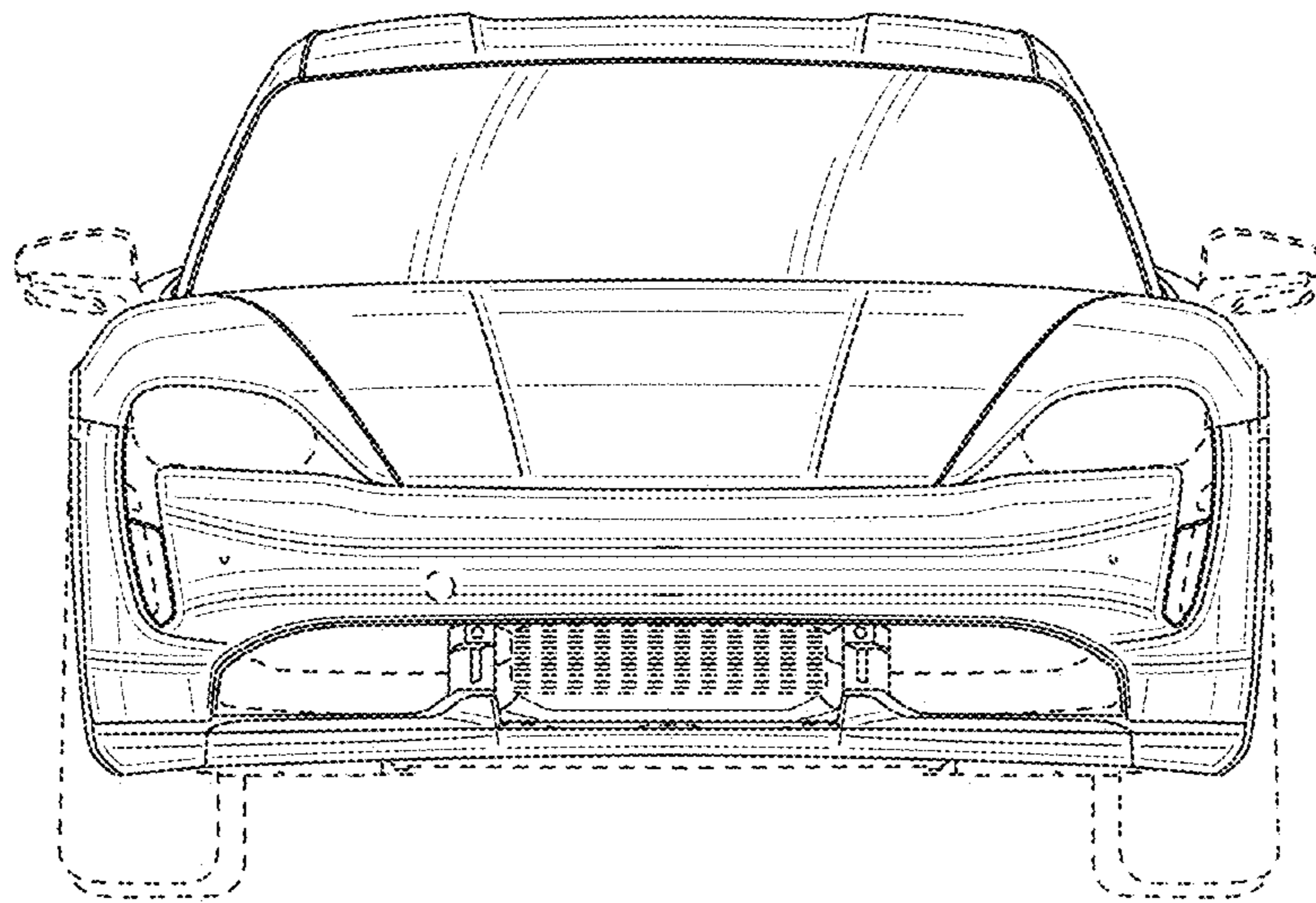

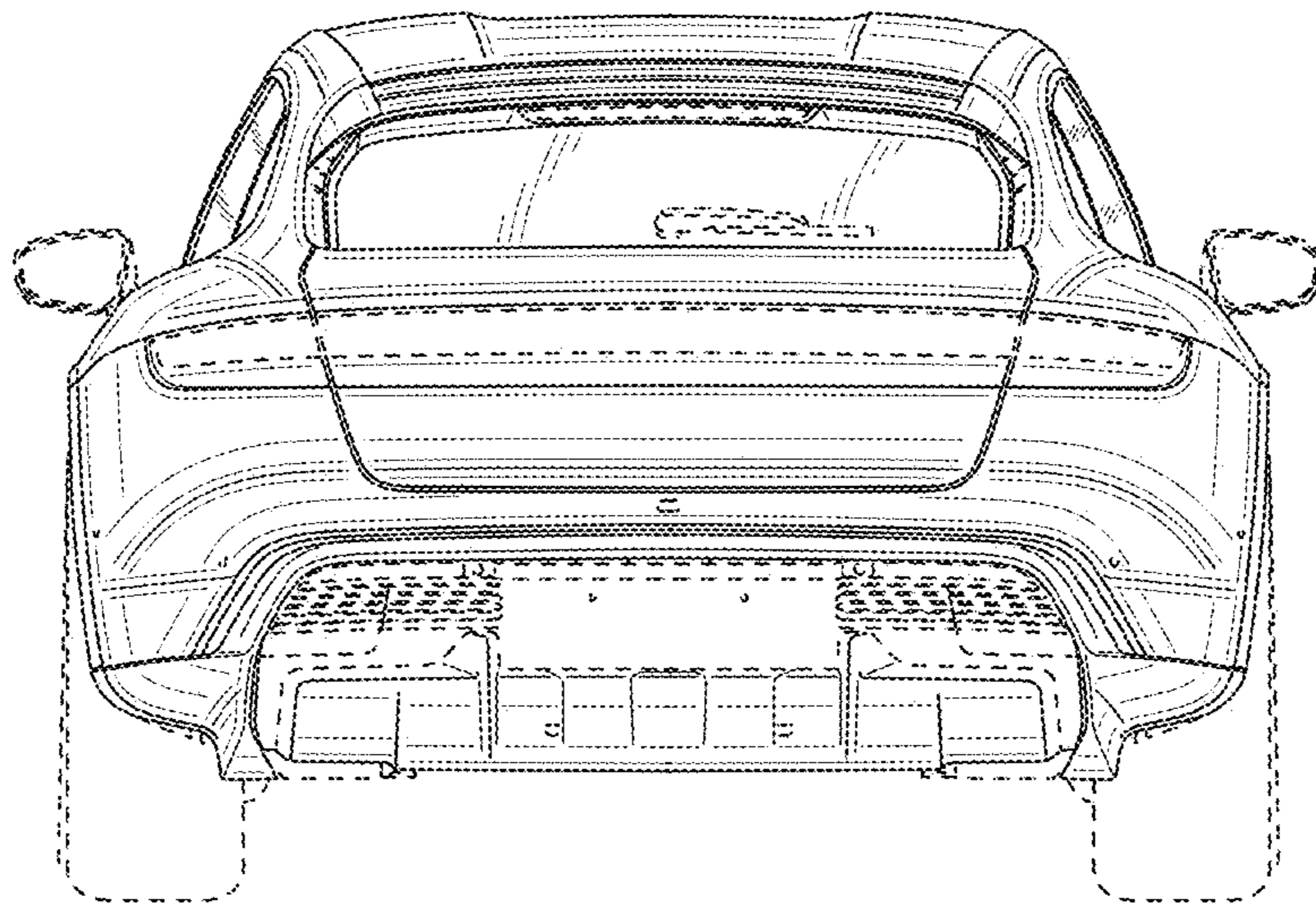

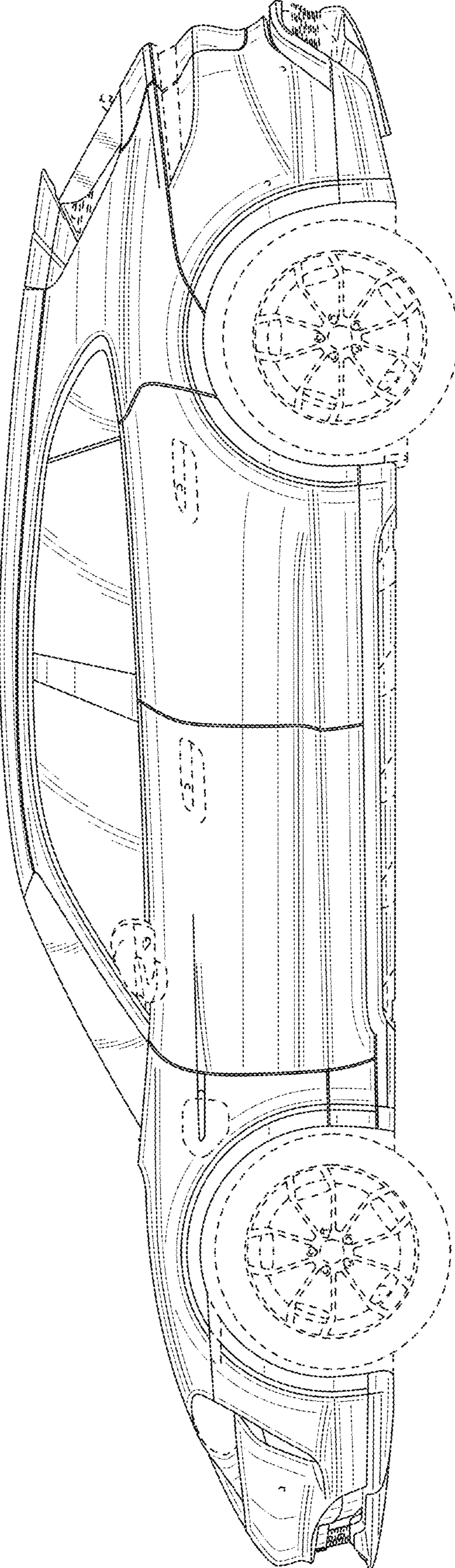

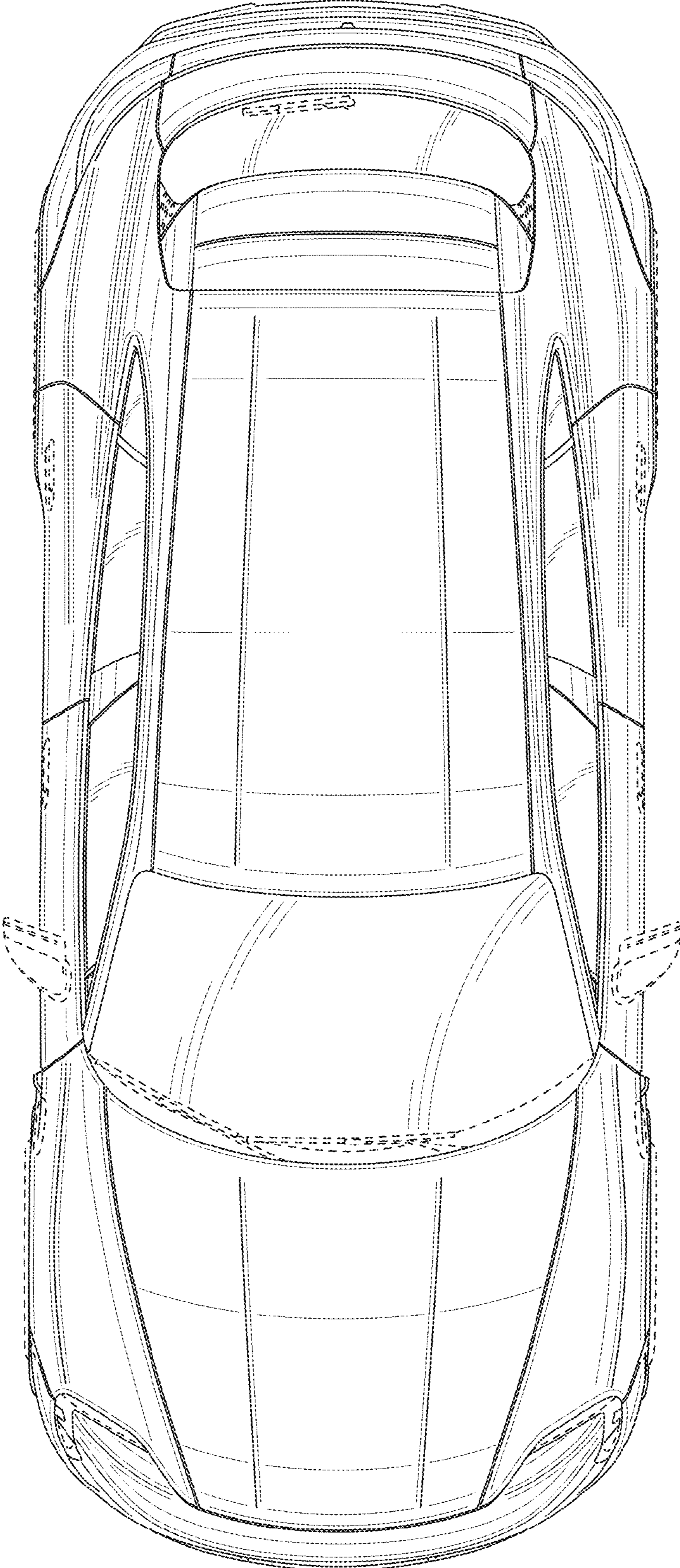
