DESCRIPTION

FIG. 11 is a partially enlarged view of a portion defined by lines 11-11 shown in FIG. 3;

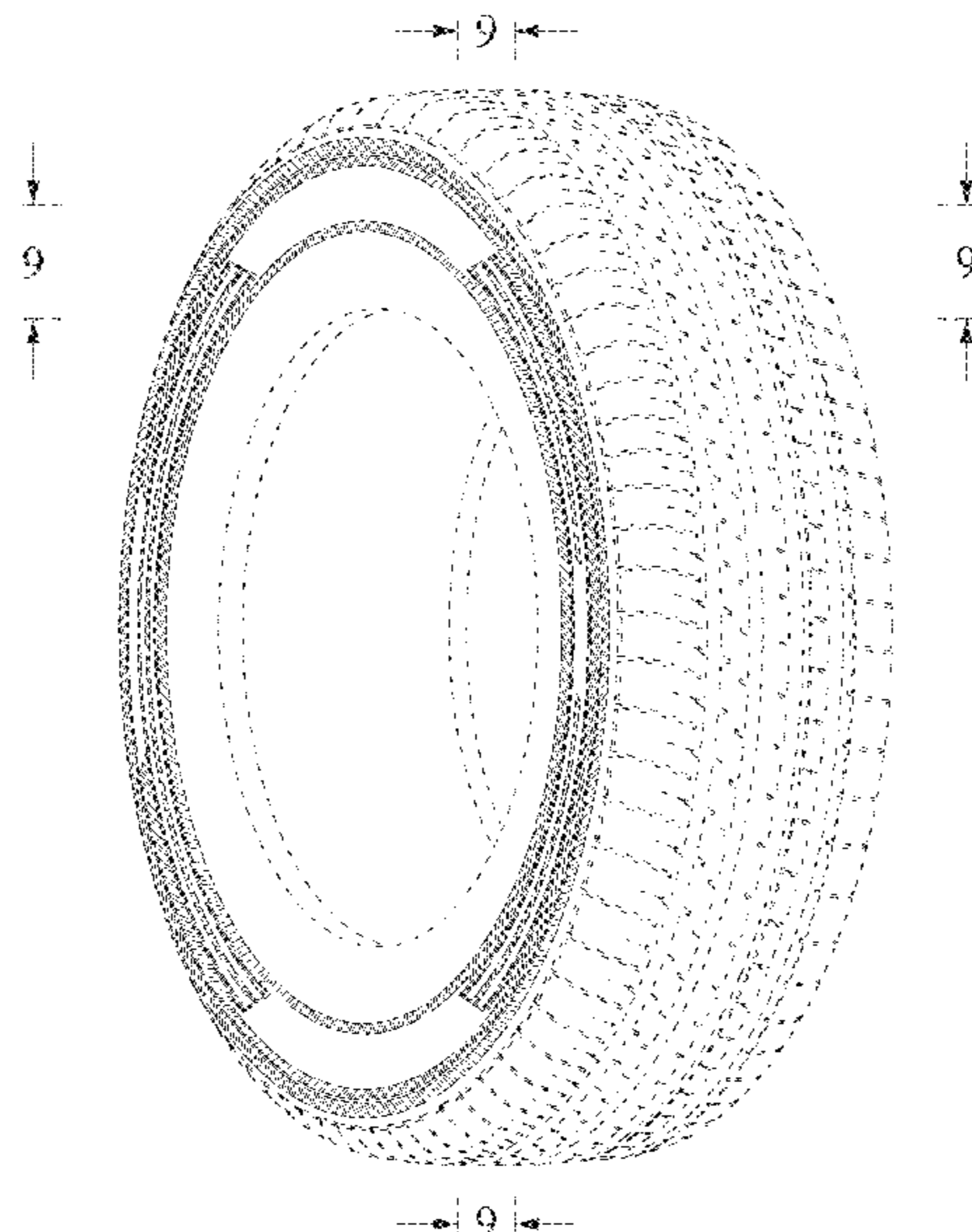
FIG. 12 is a partially enlarged view of a portion defined by lines 12-12 shown in FIG. 4;

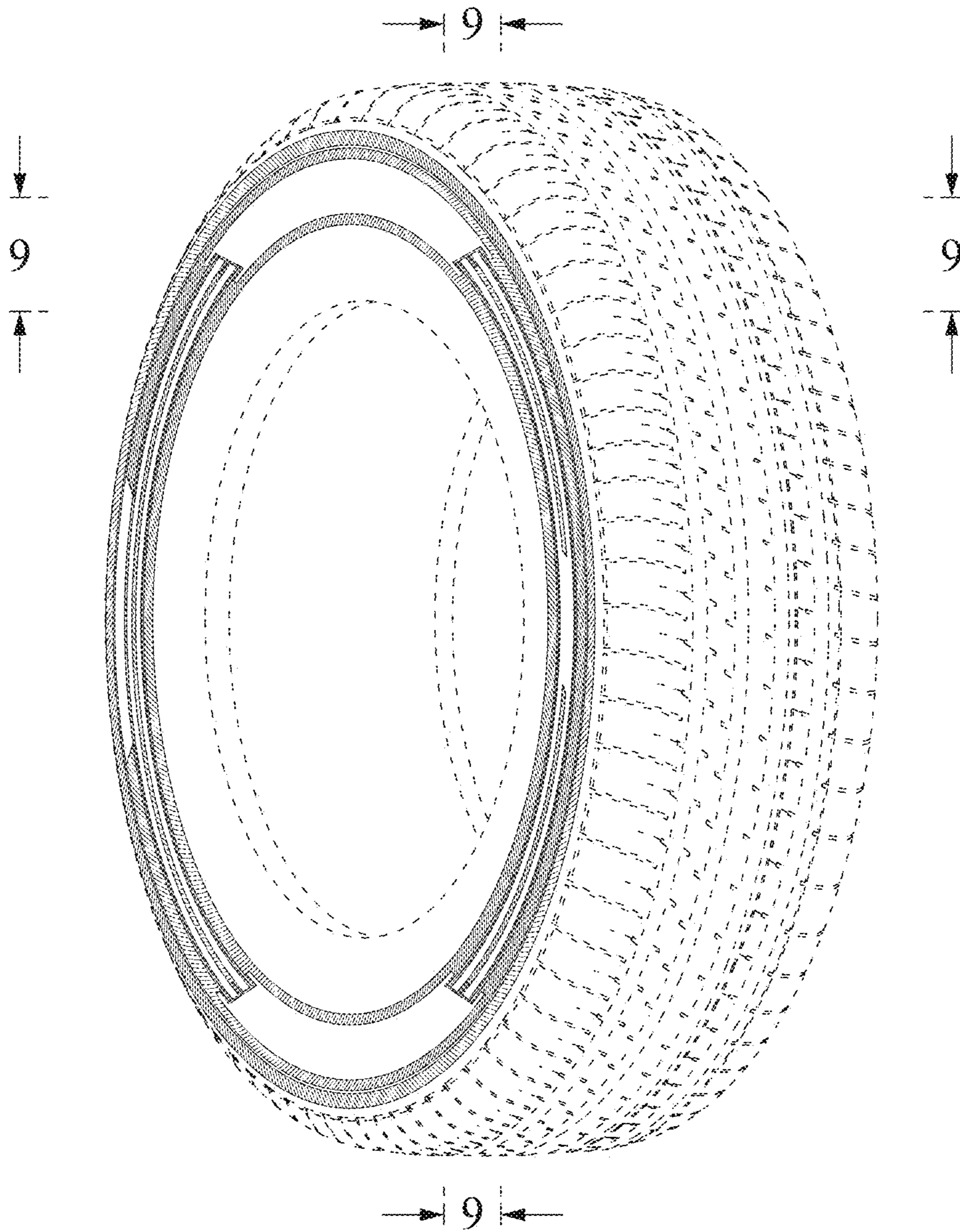

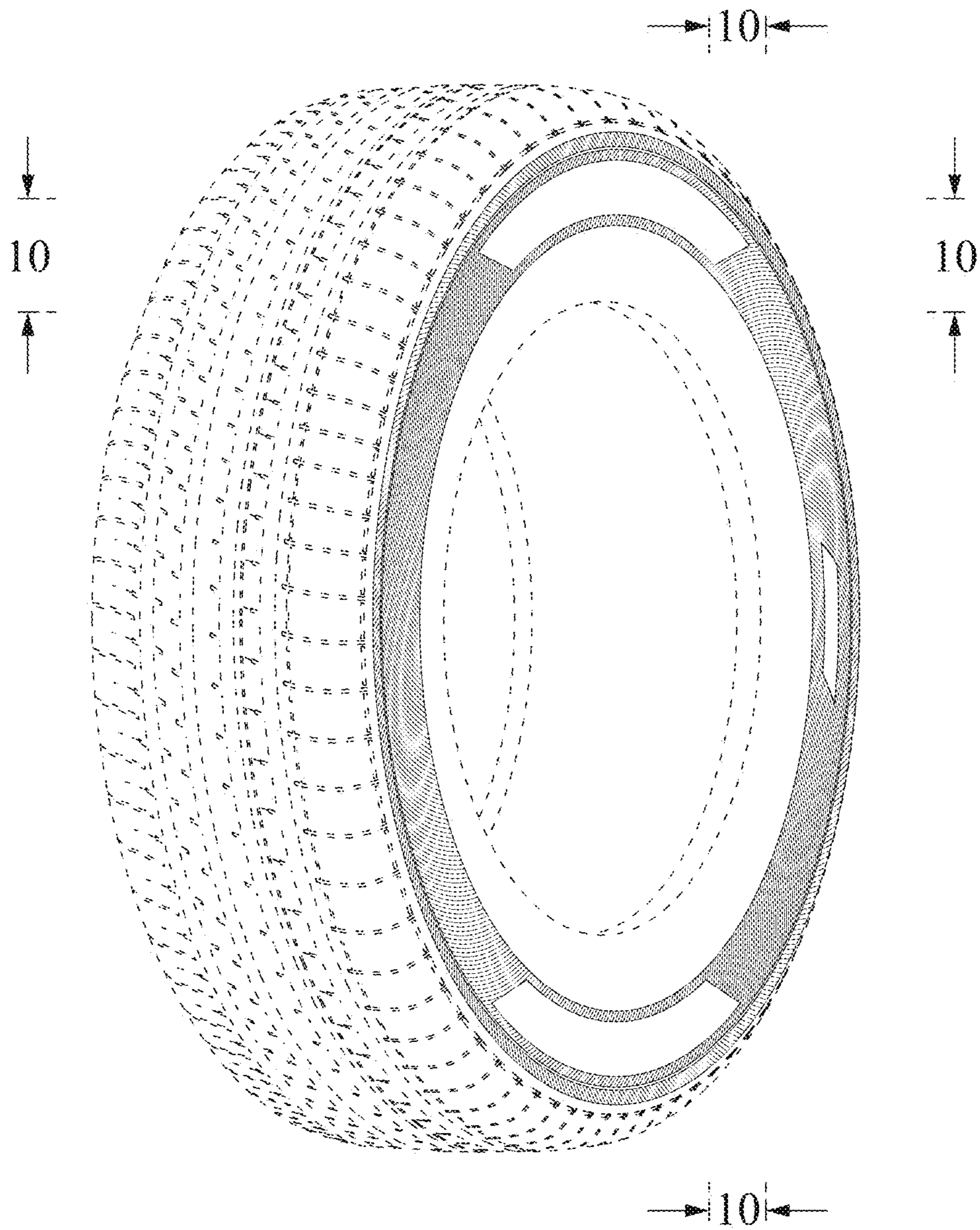

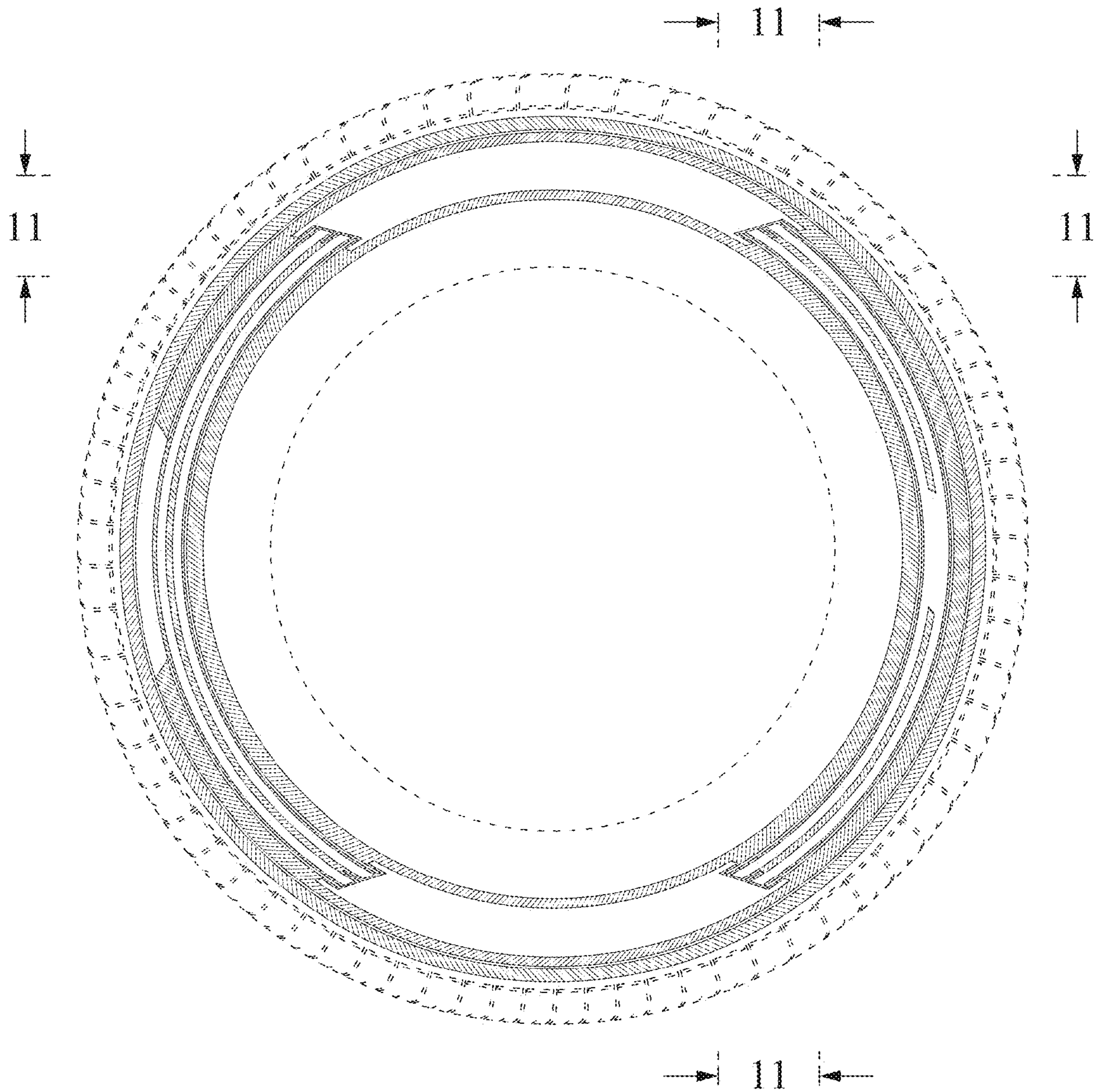

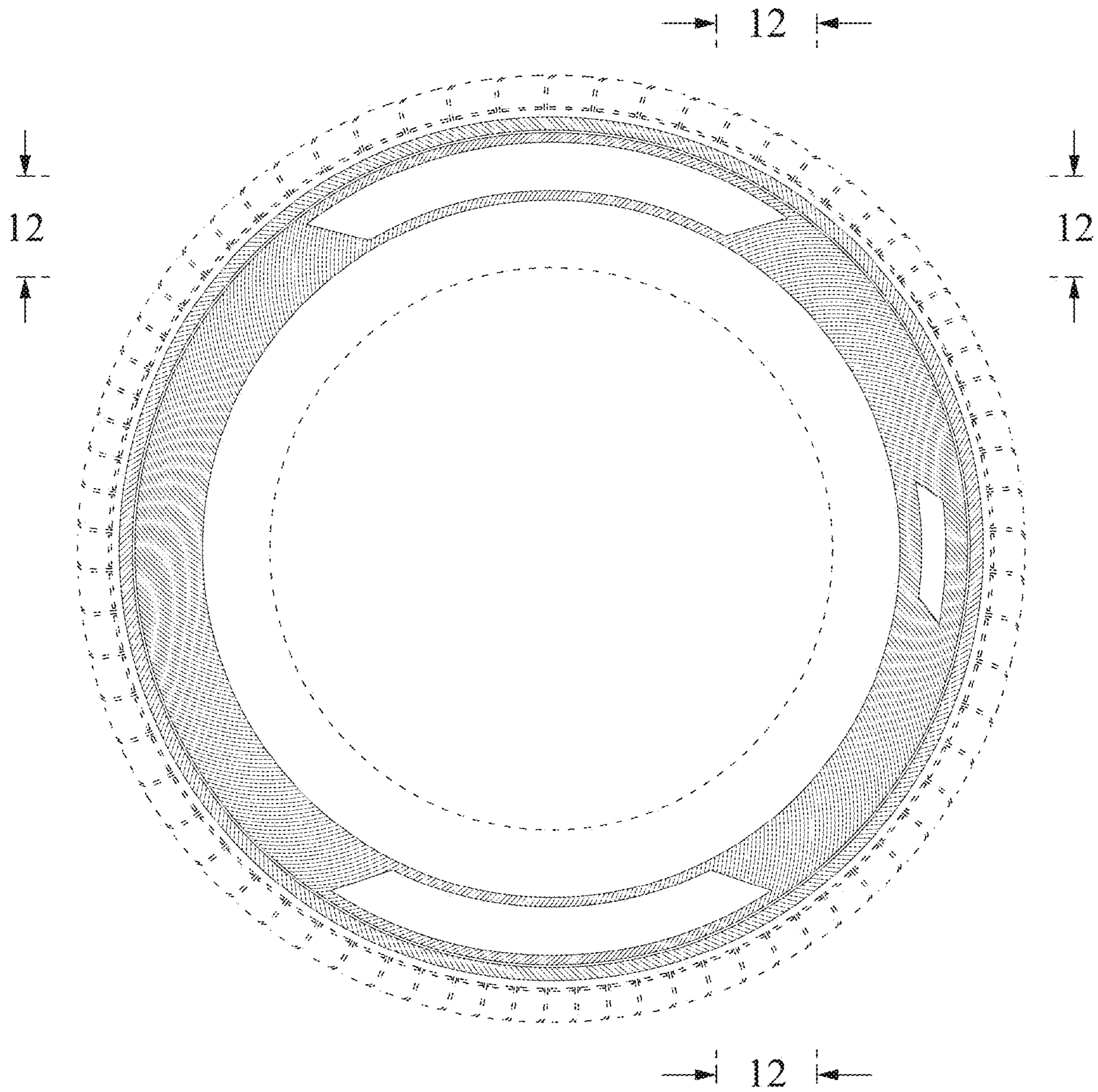

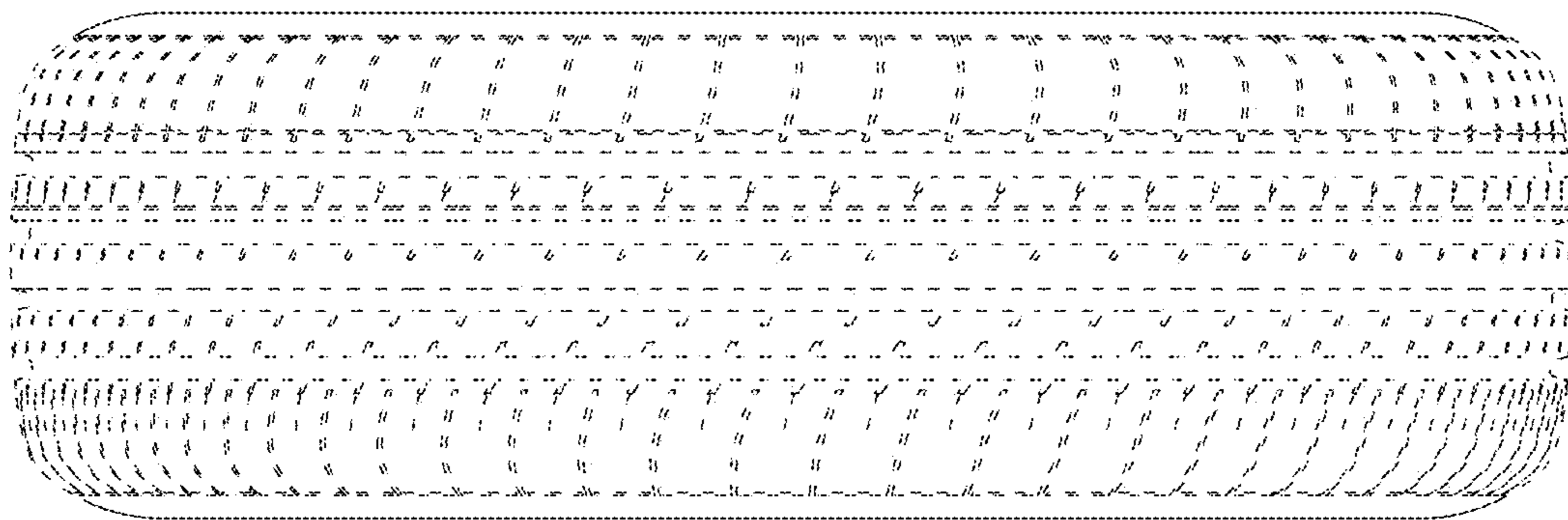

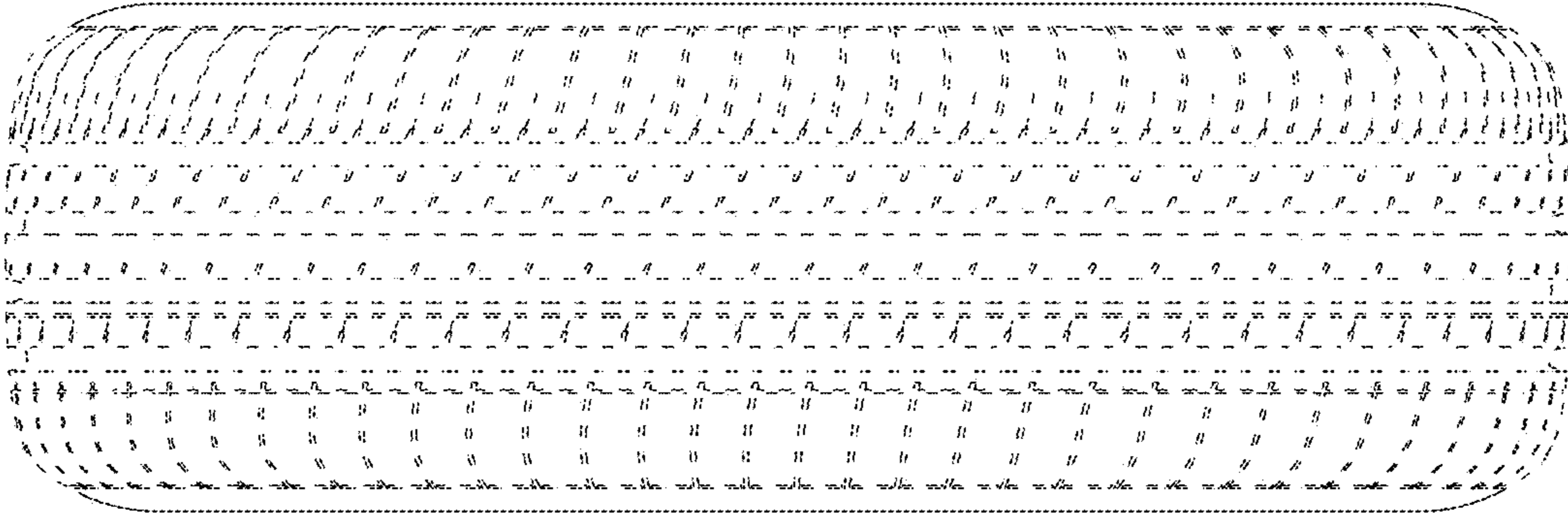

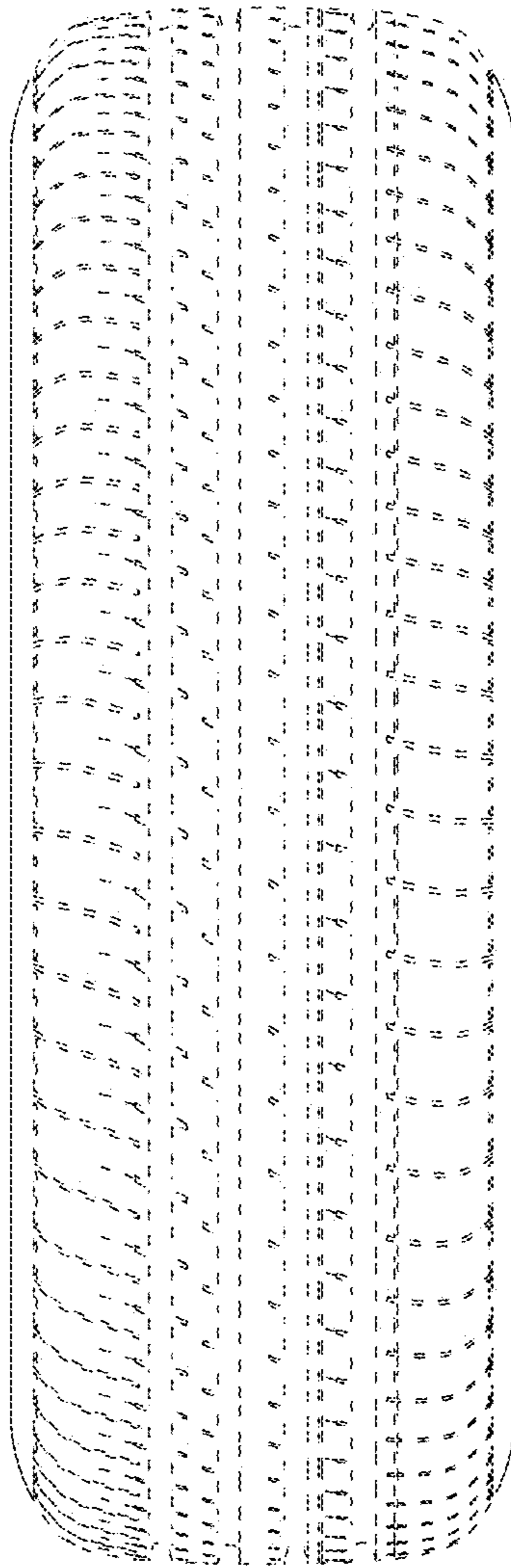

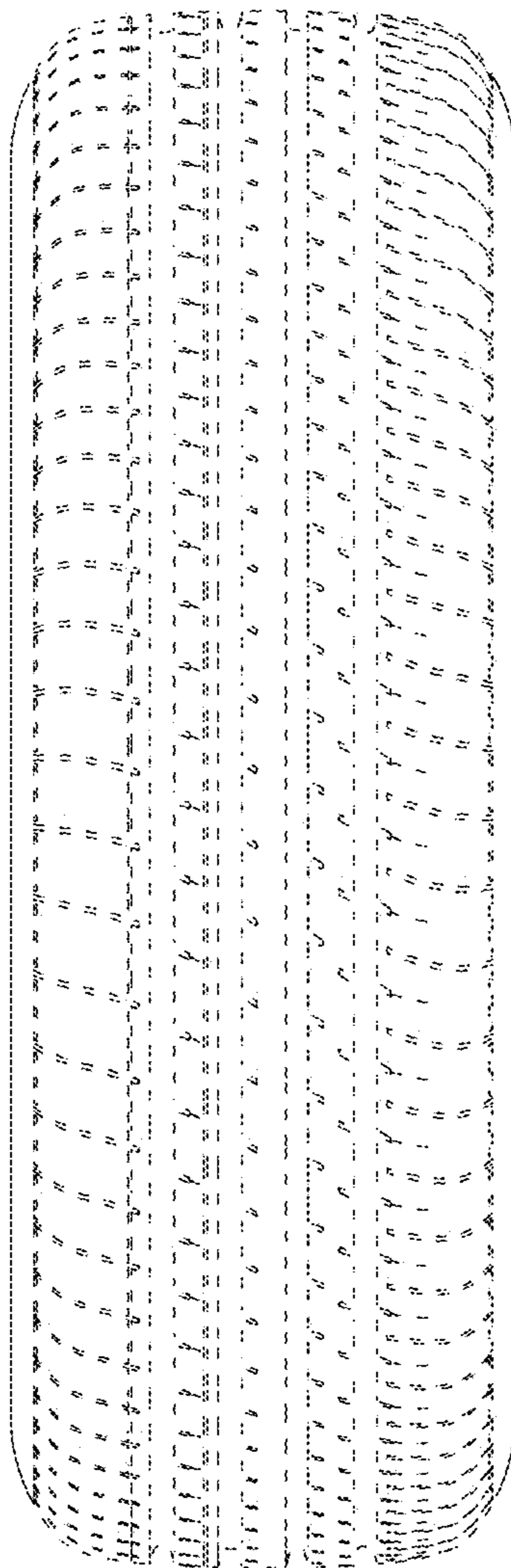

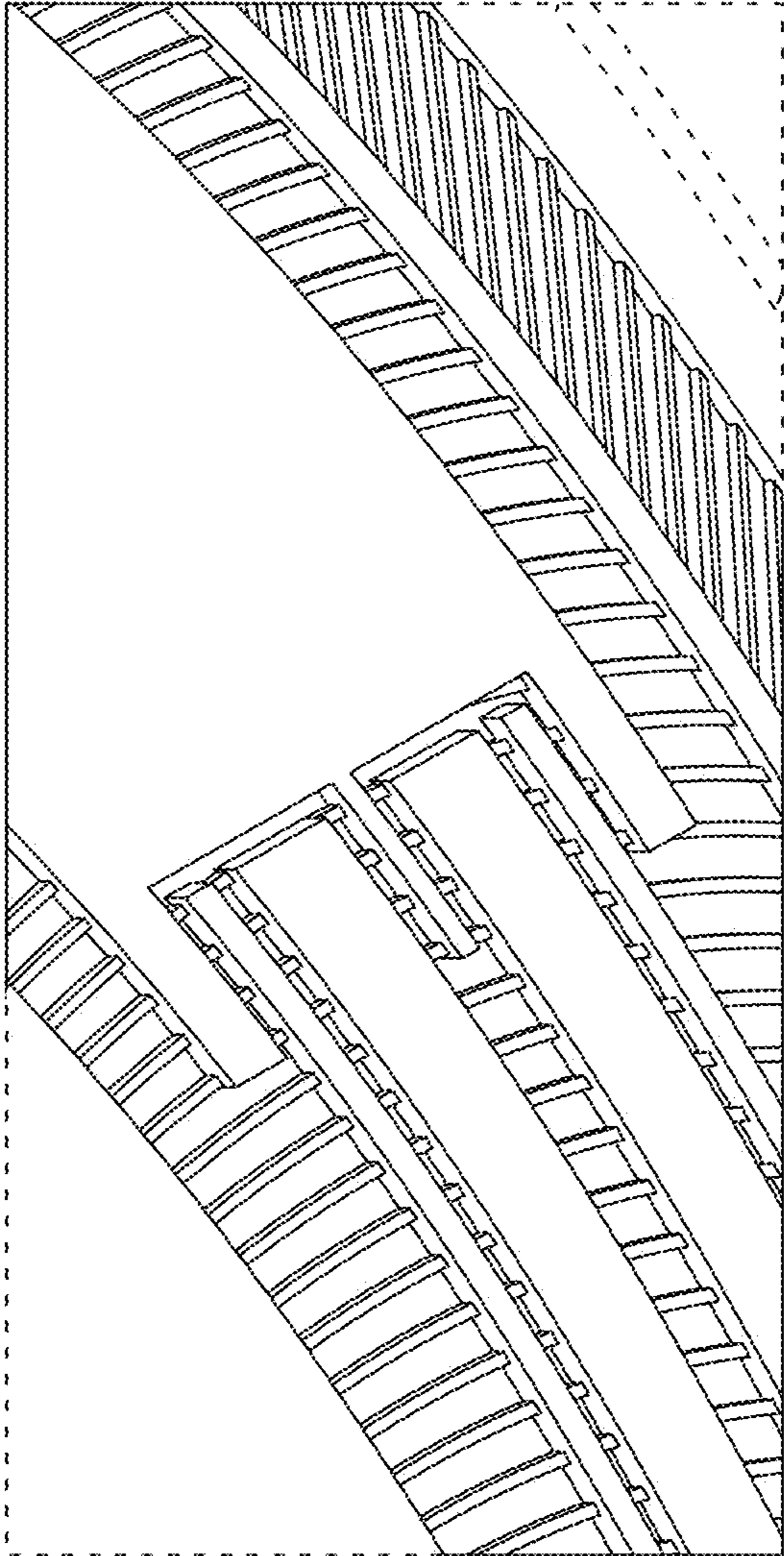

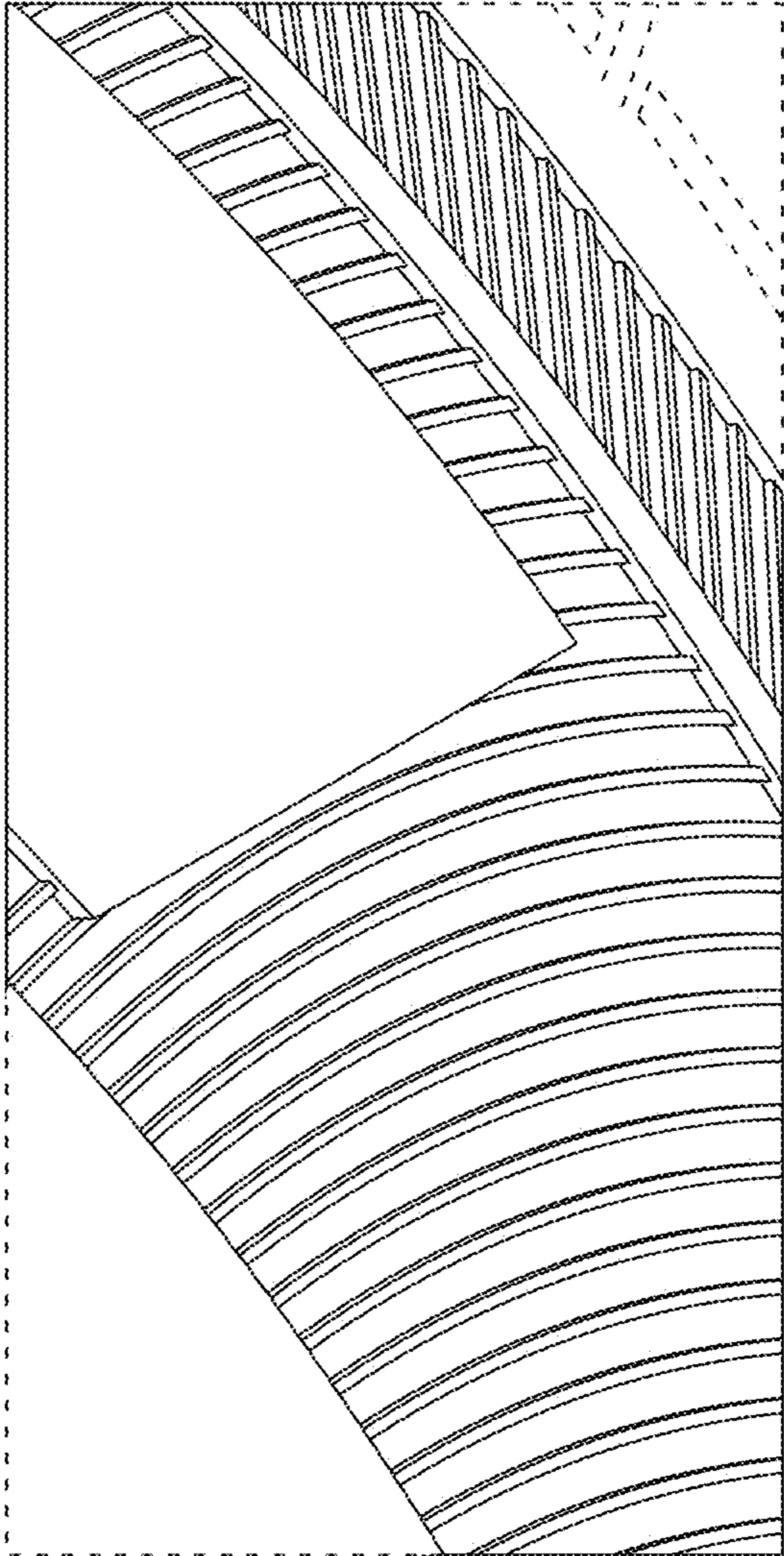

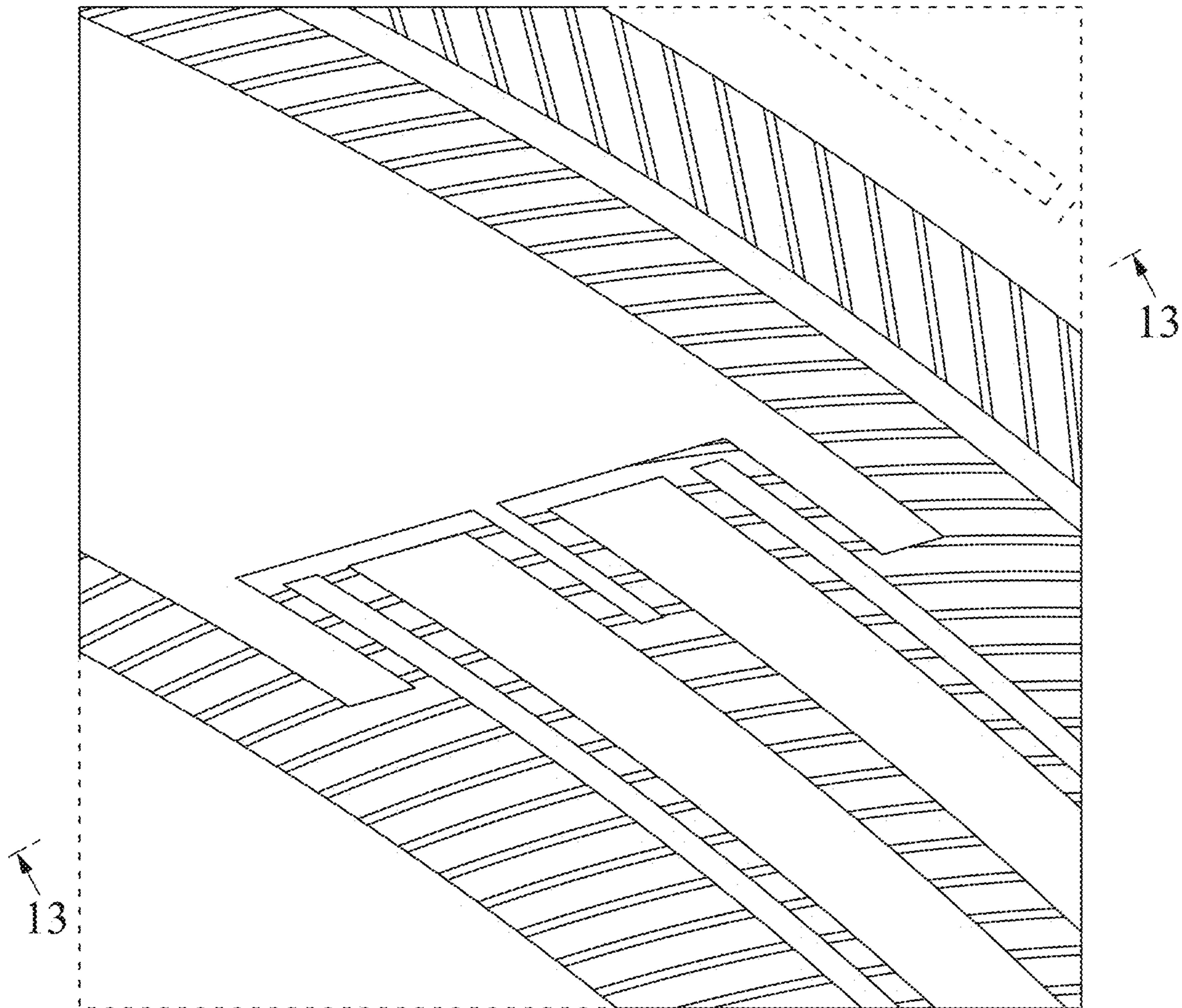

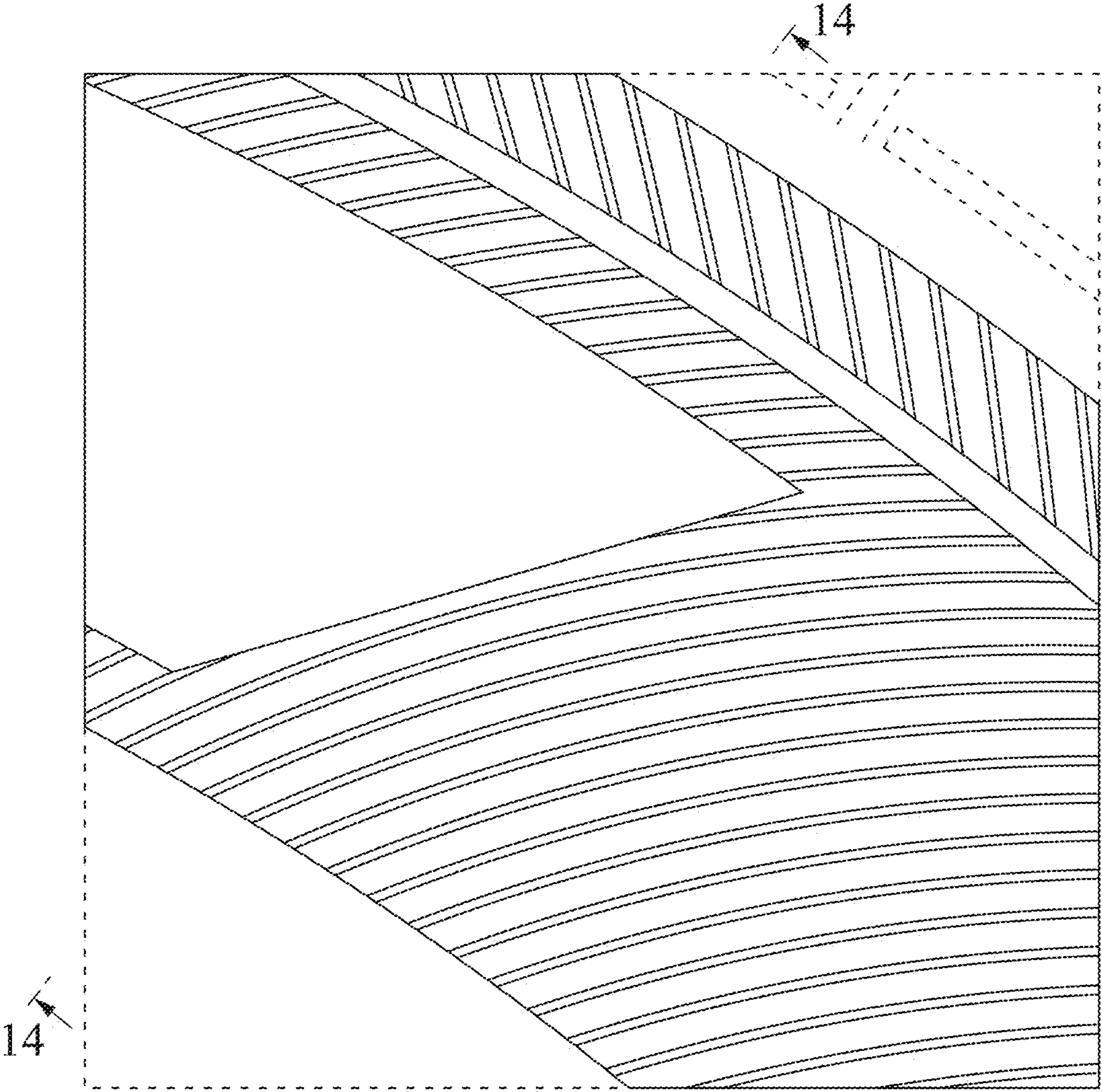

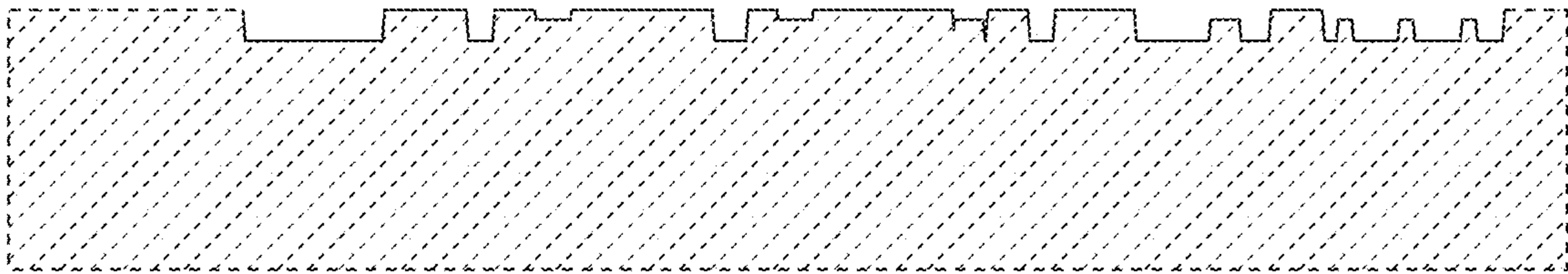
