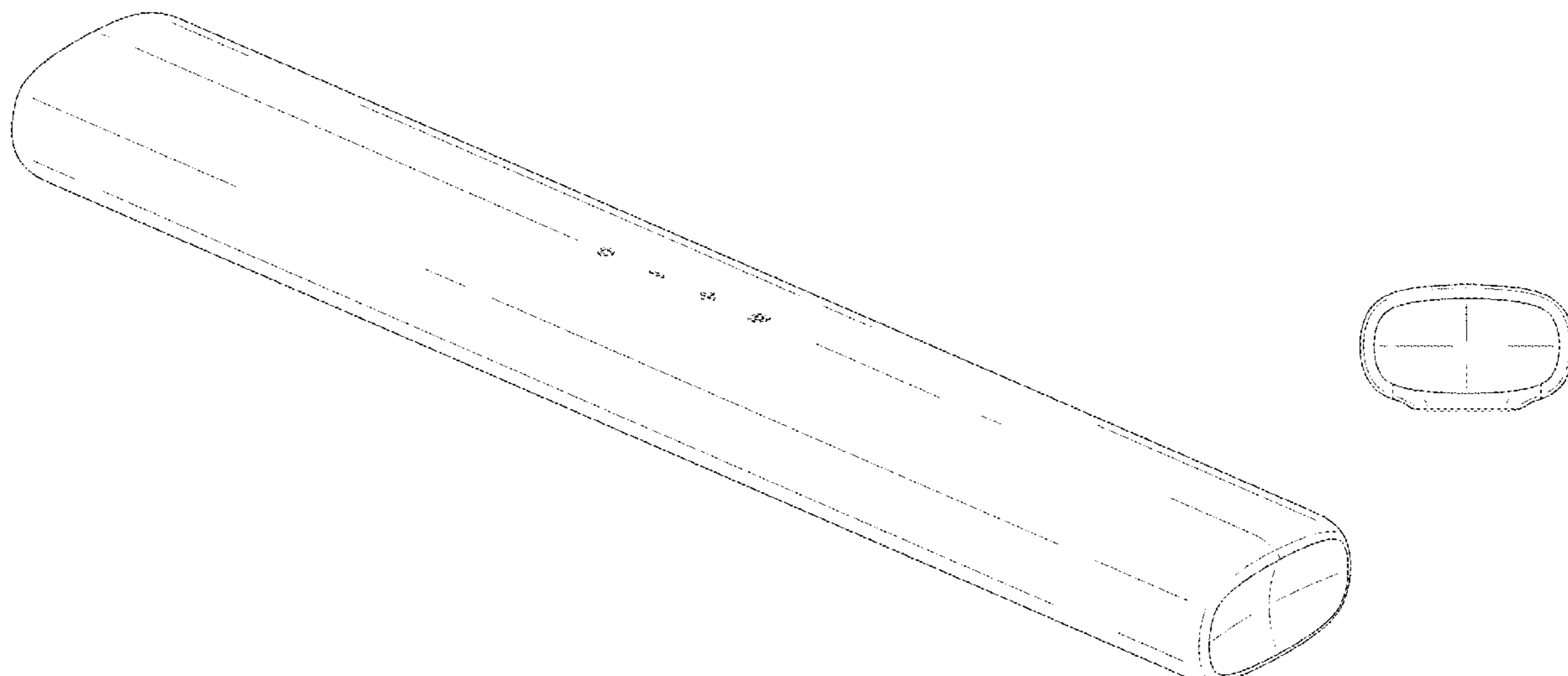
(57) **CLAIM**

new design;

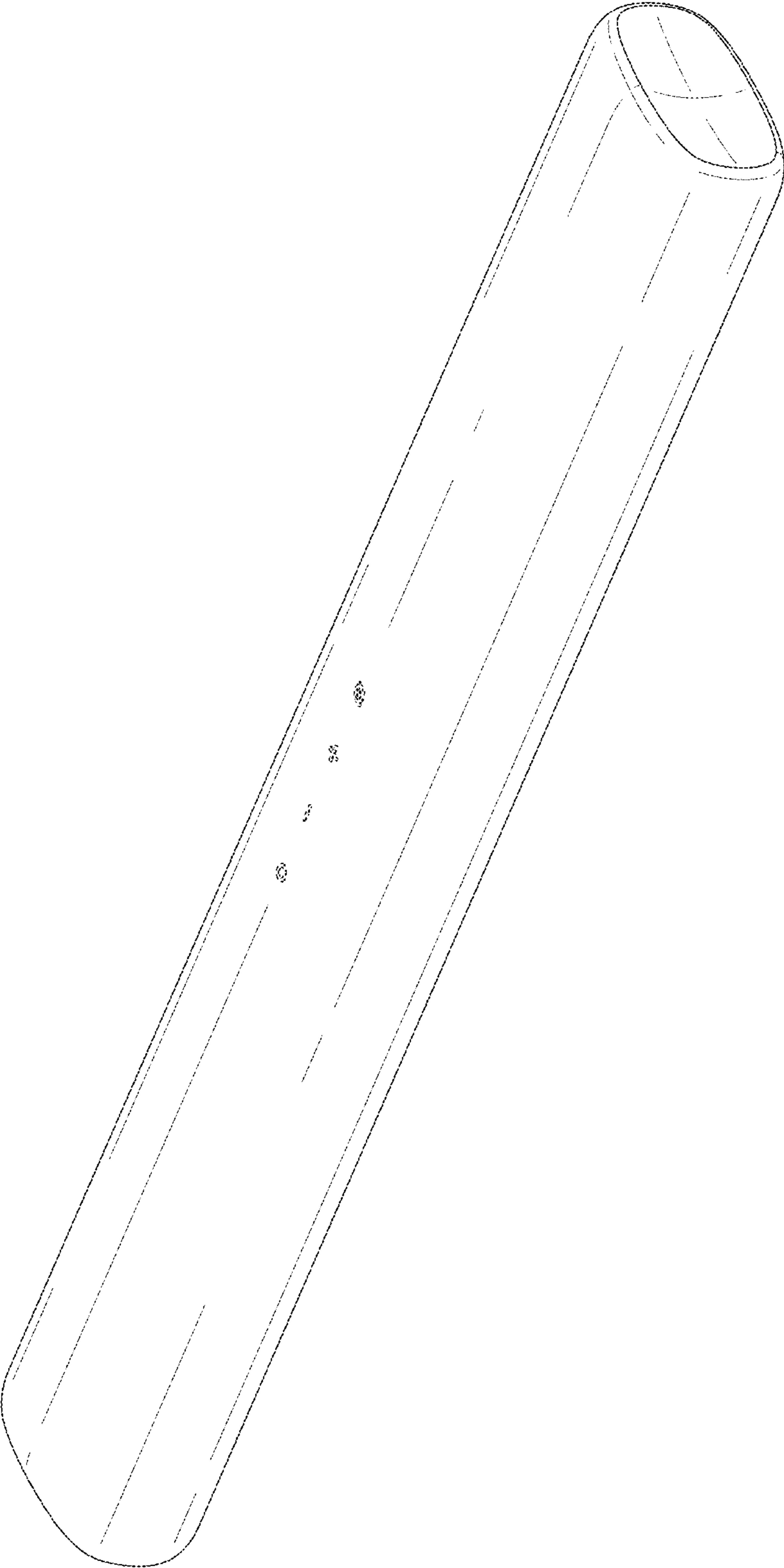

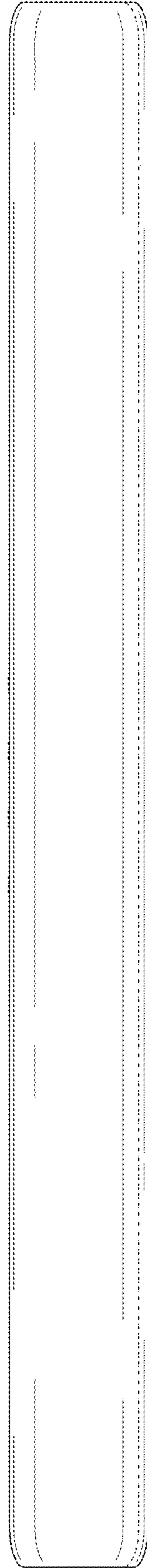

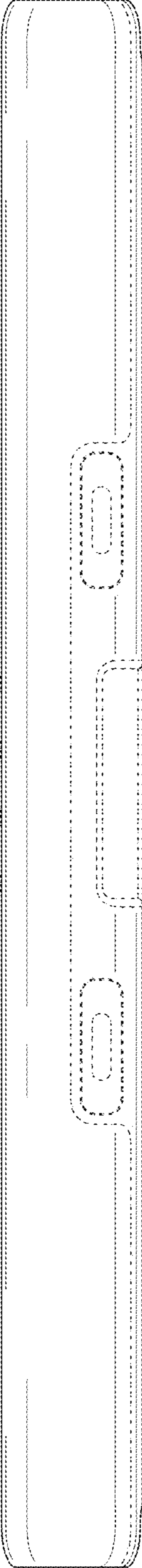

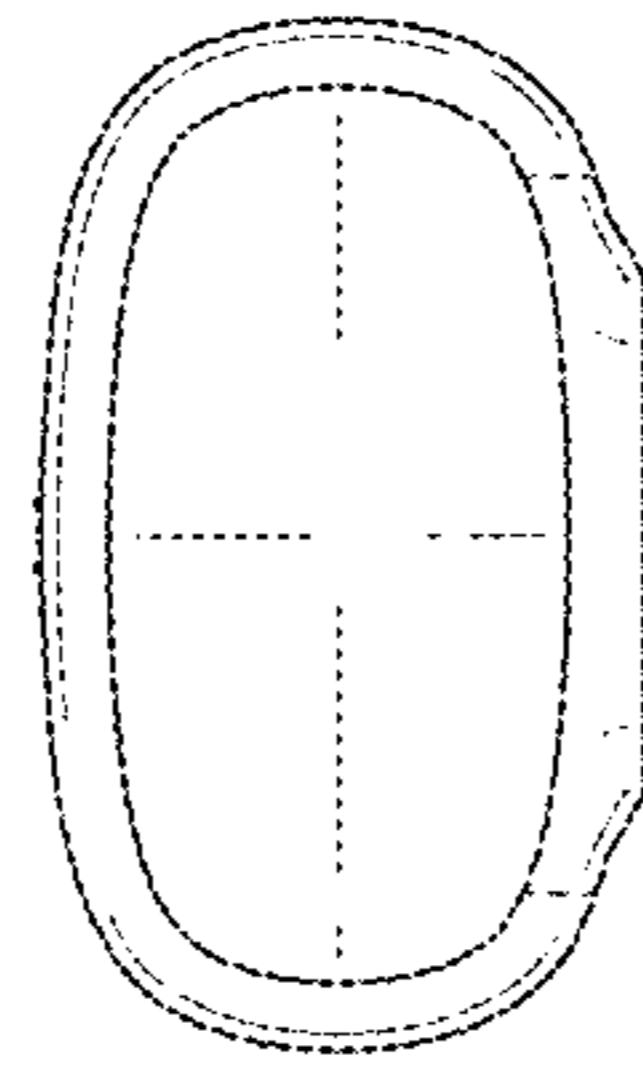

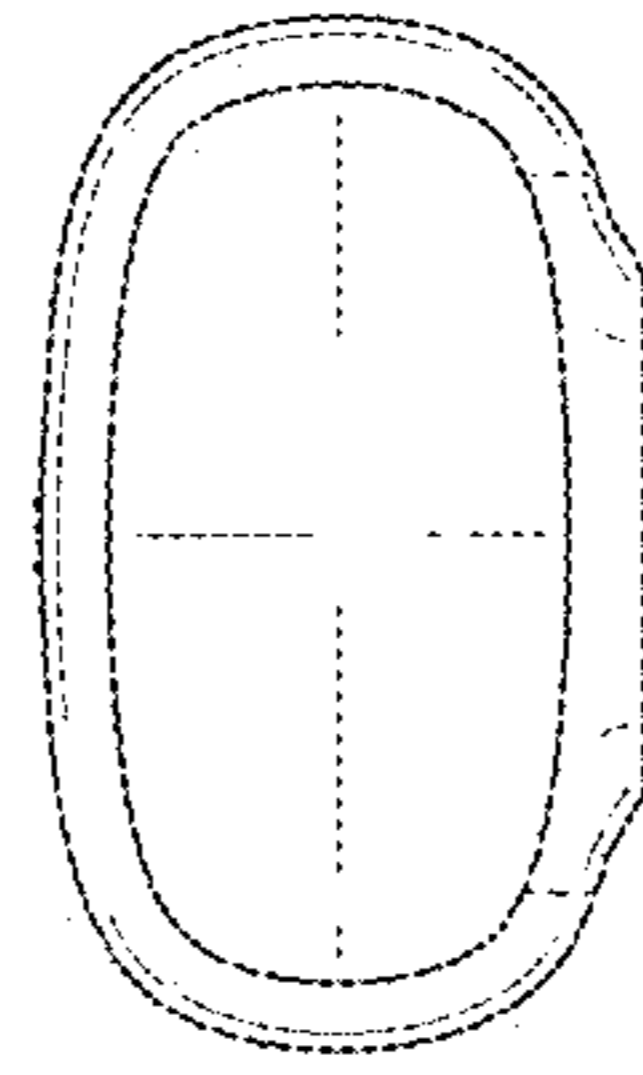

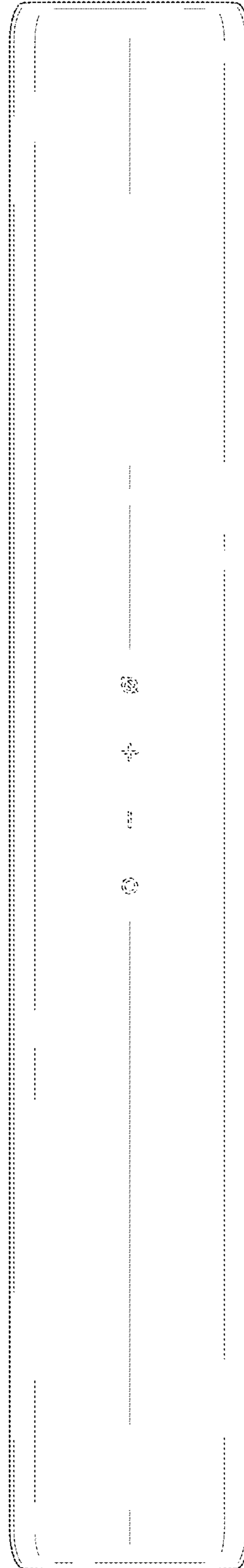

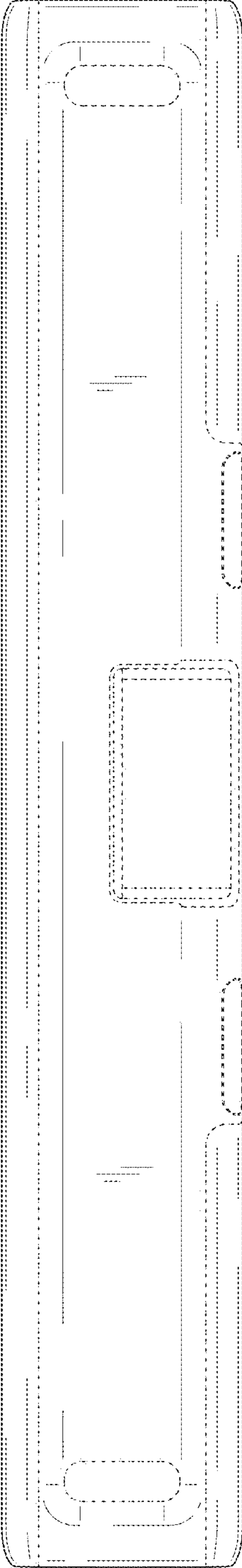
