(57) **CLAIM**

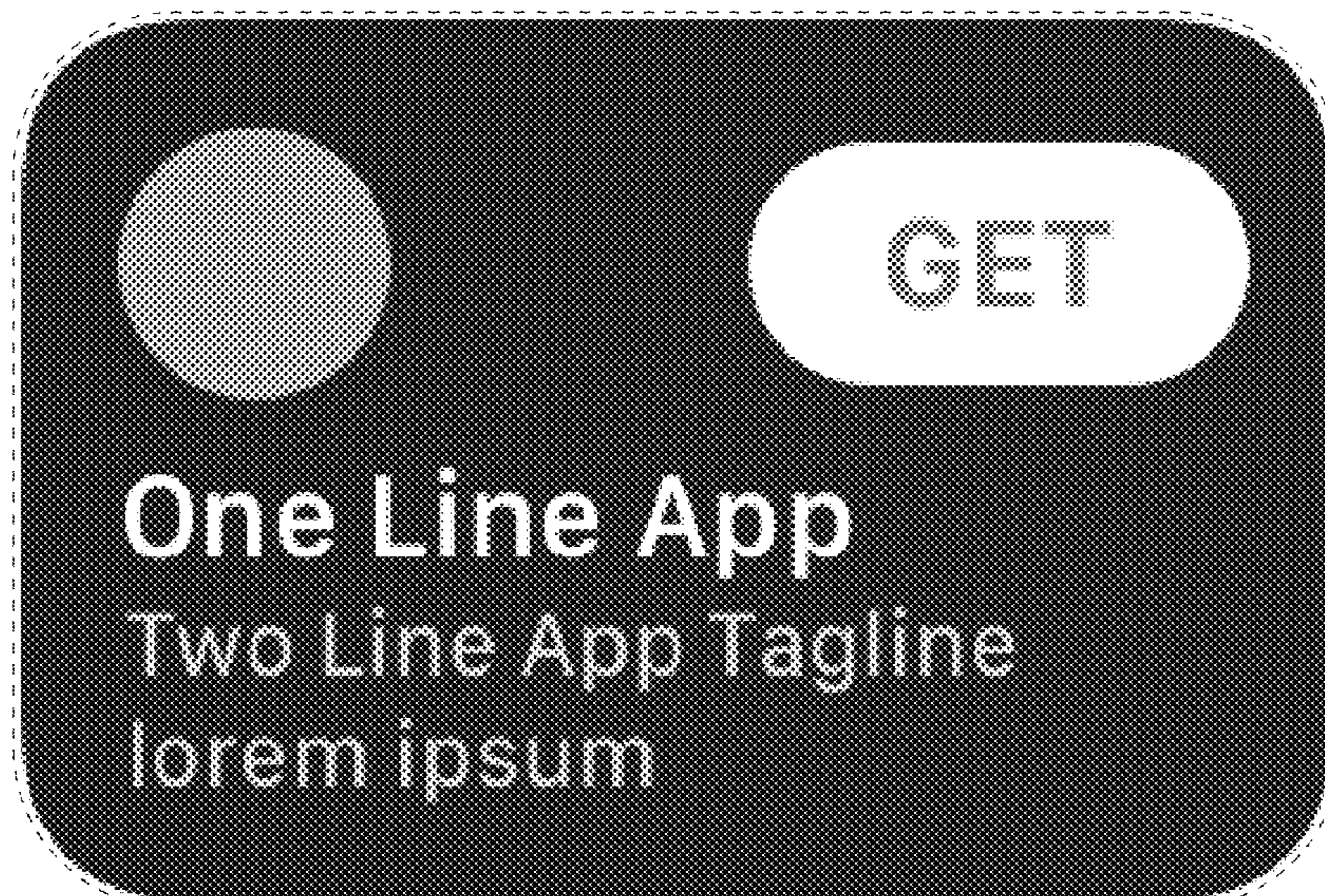
The ornamental design for an electronic device with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of an electronic device having a display screen with graphical user interface applied to the display screen, showing the claimed design; and, FIG. 2 is a front view of an alternative electronic device showing the graphical user interface of FIG. 1 applied thereto.

The broken lines in the figures show an electronic device having a display screen, or an alternative electronic device having a display screen, and form no part of the claimed design.

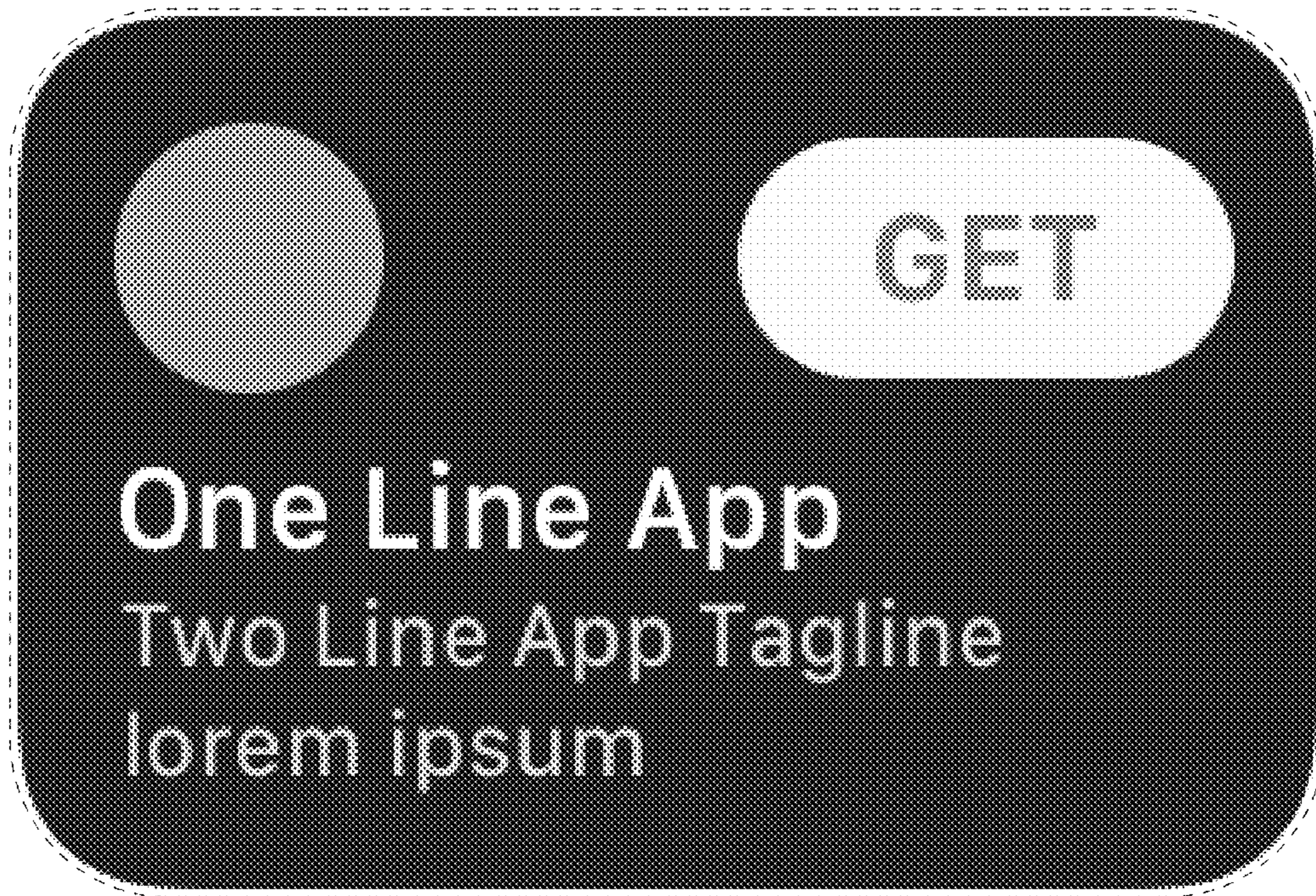

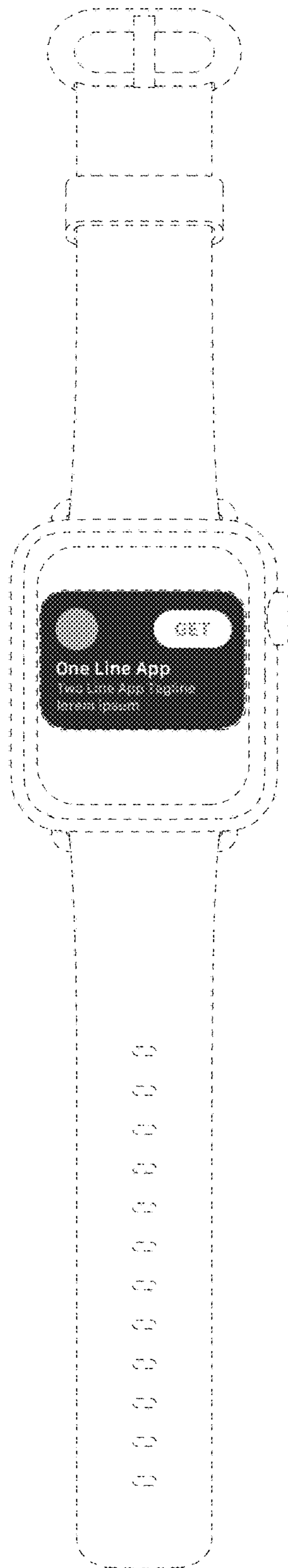
