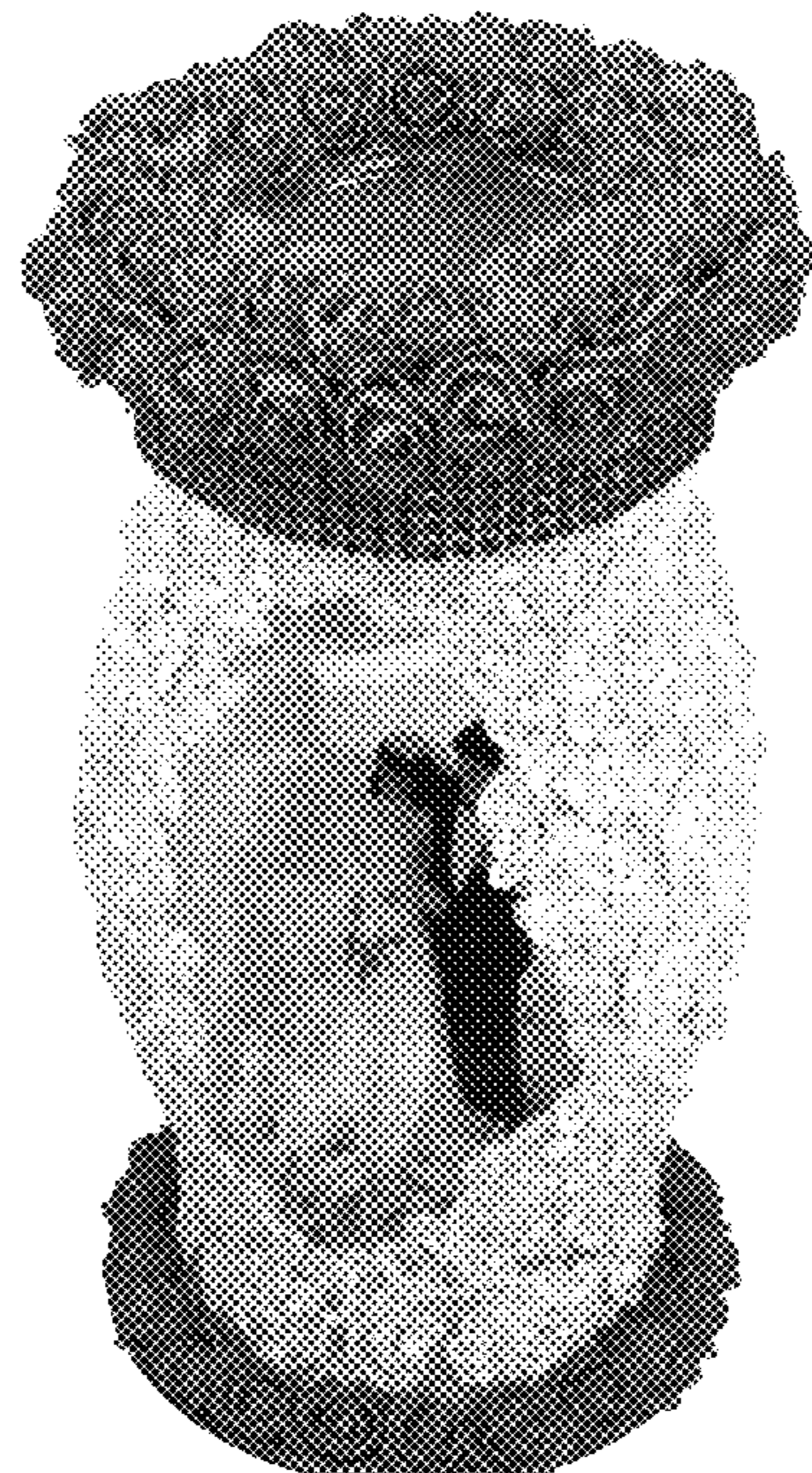

The ornamental design for the figurine candle holder, as shown and described.

DESCRIPTION
FIG. 1 is a top perspective view of a figurine candle holder of the present disclosure;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof; and,
FIG. 6 is a top view thereof.

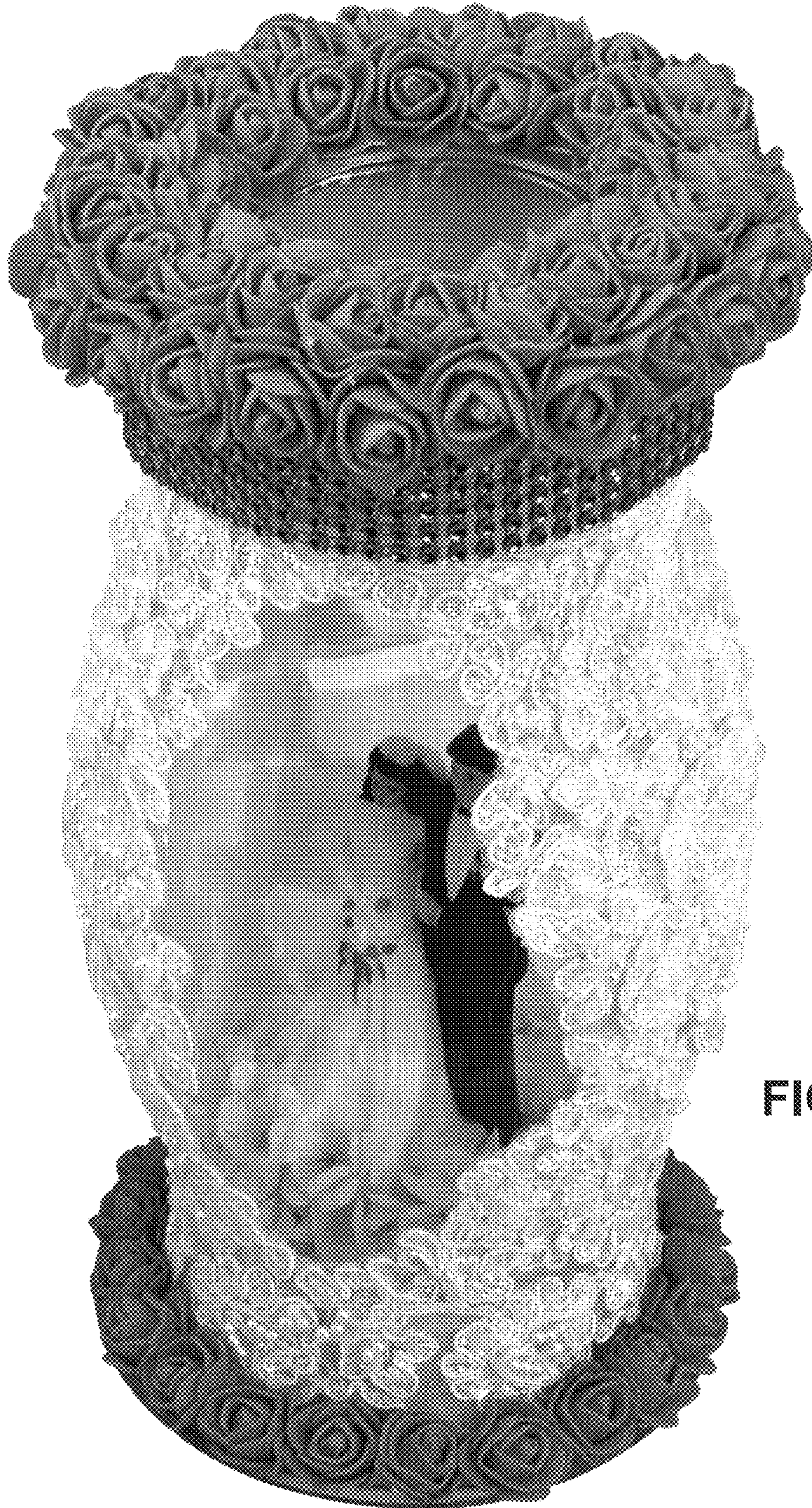
