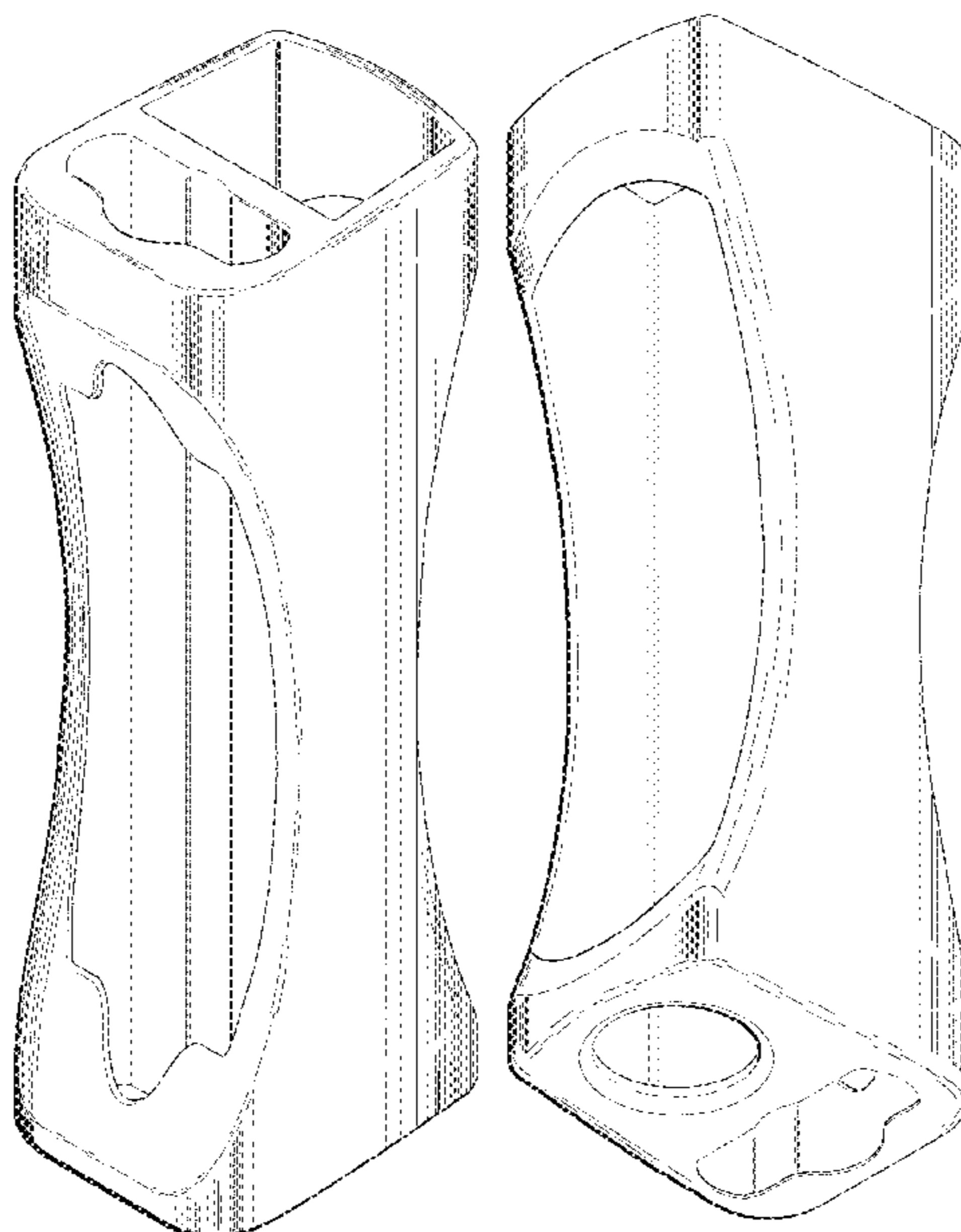
(57) **CLAIM**

The ornamental design for an accessory sleeve for e-cigarette or vaporizer, as shown and described.

DESCRIPTION

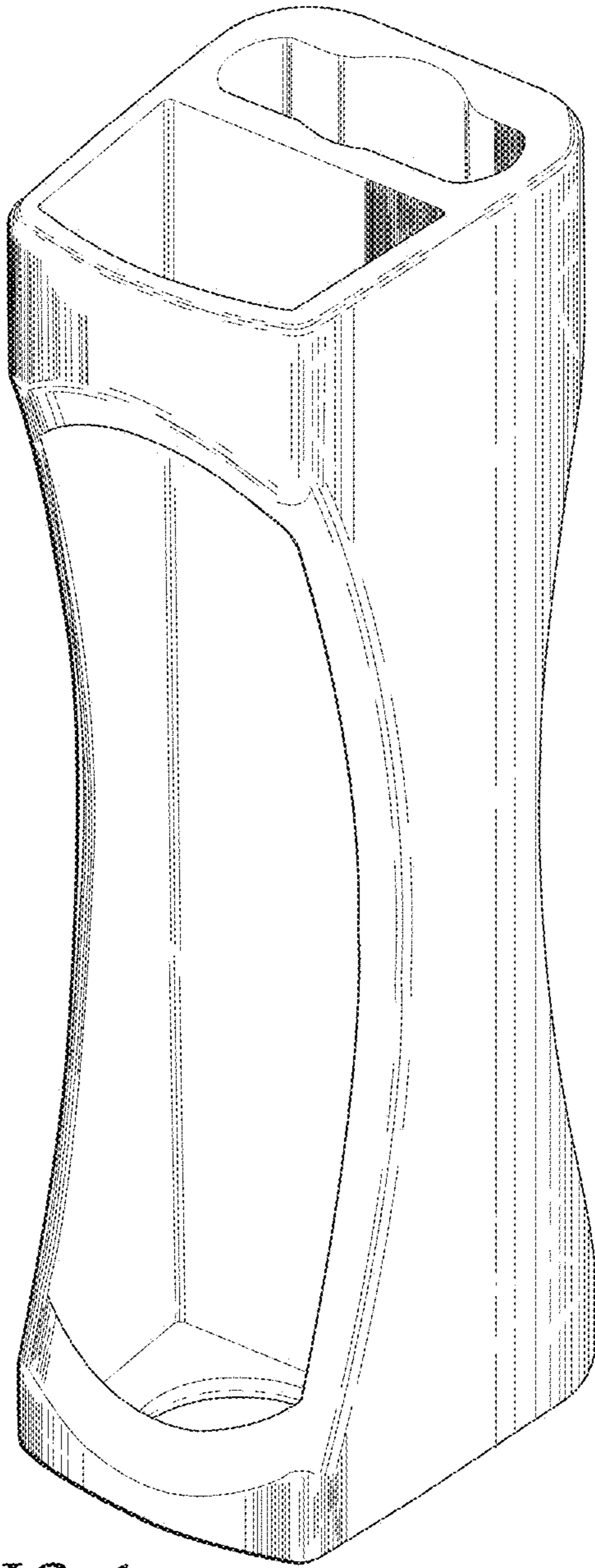

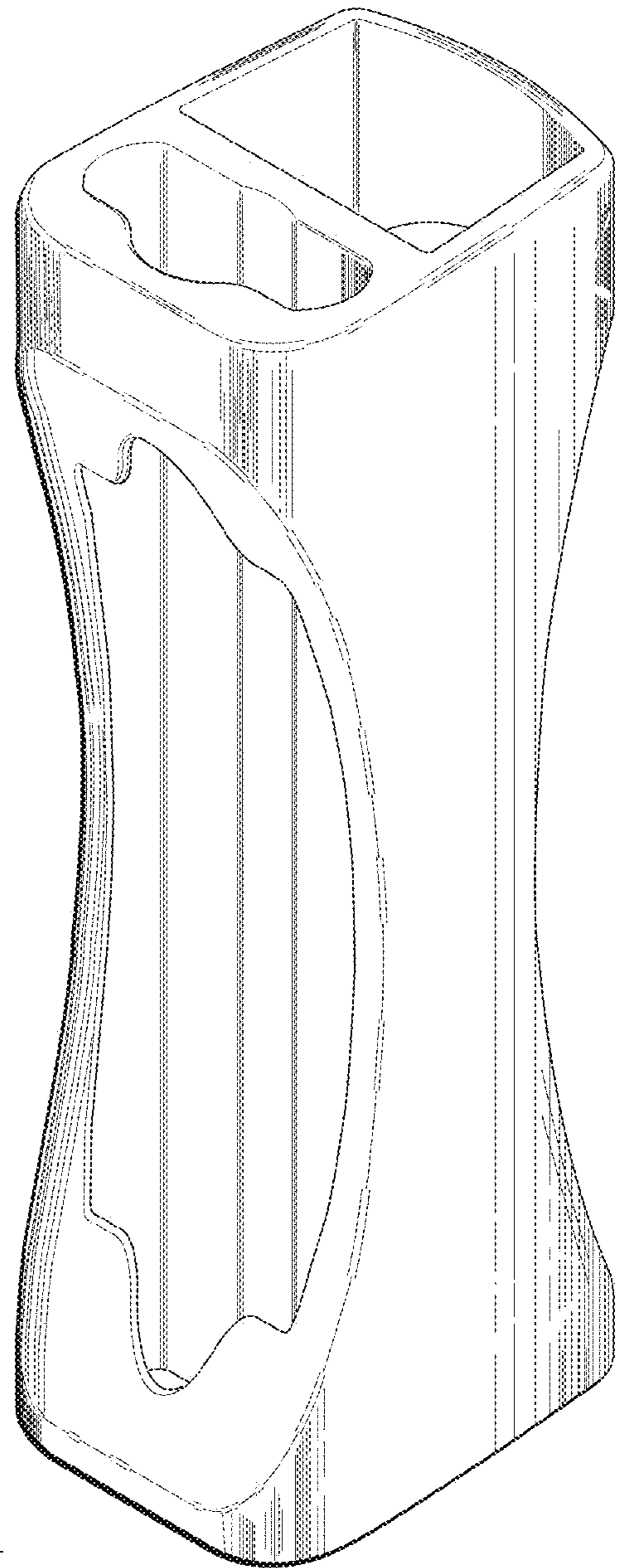

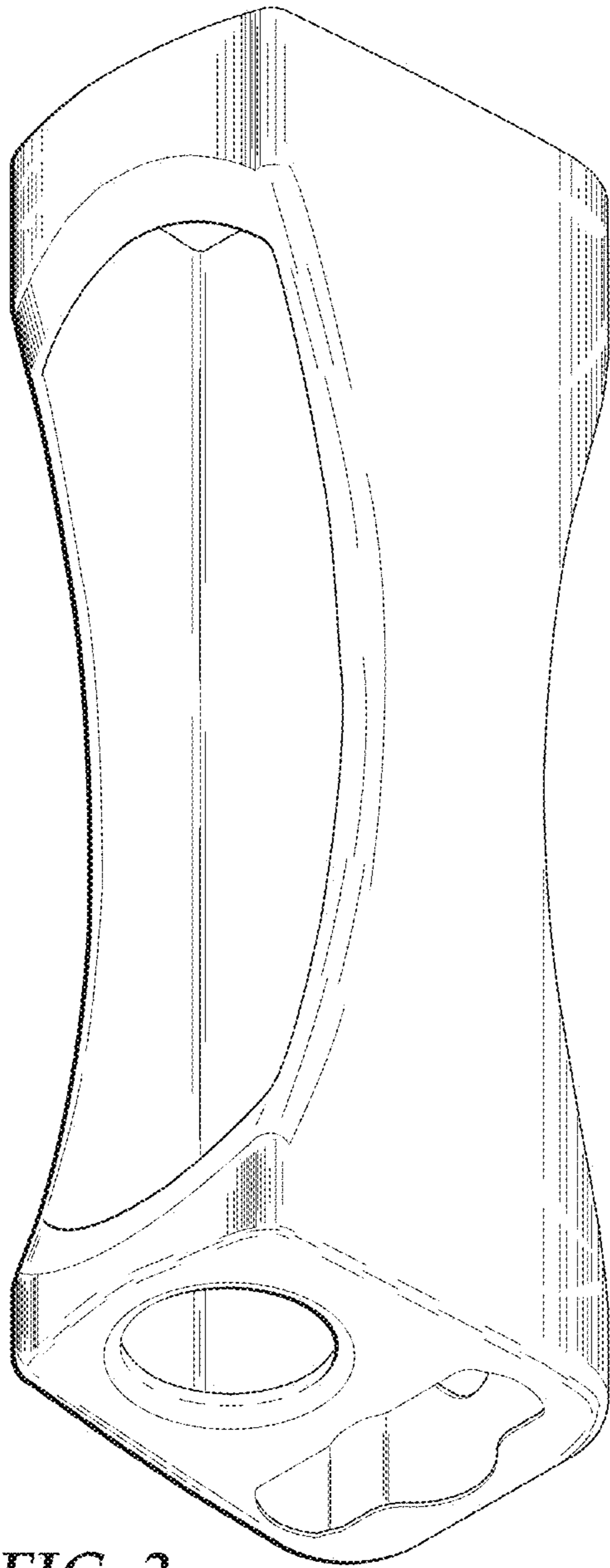

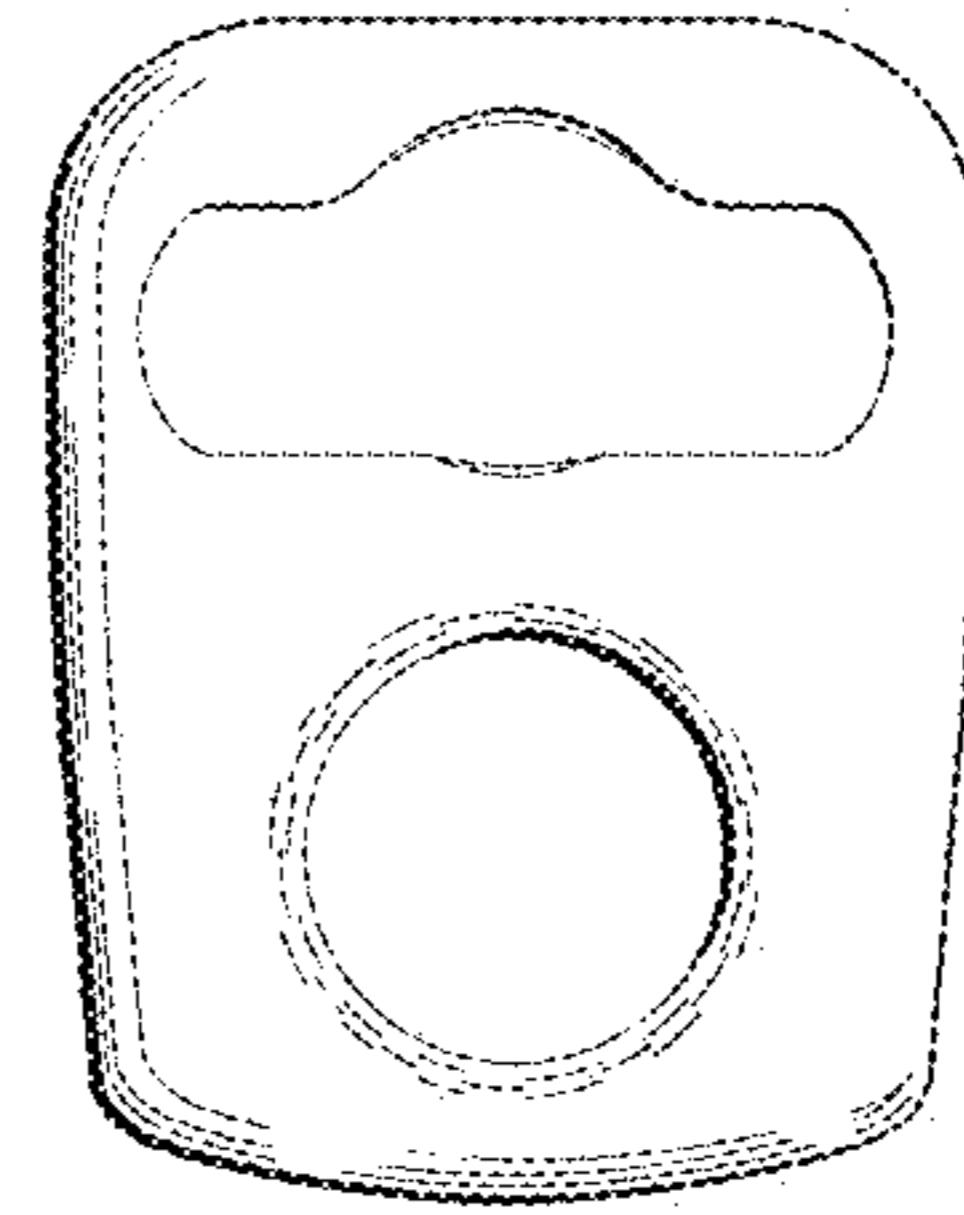

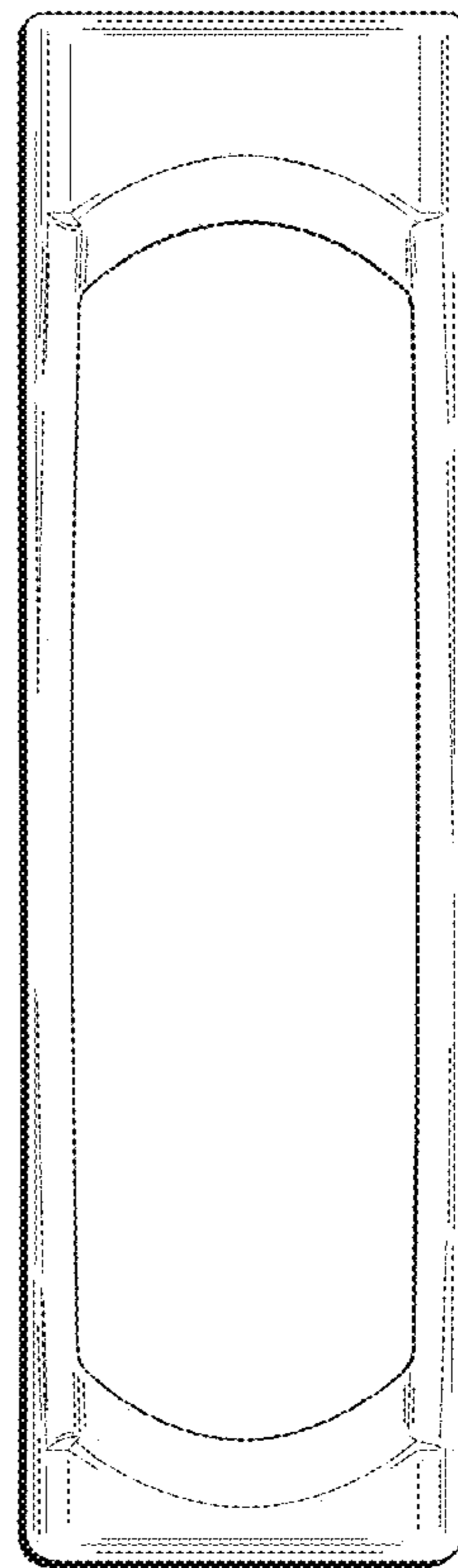

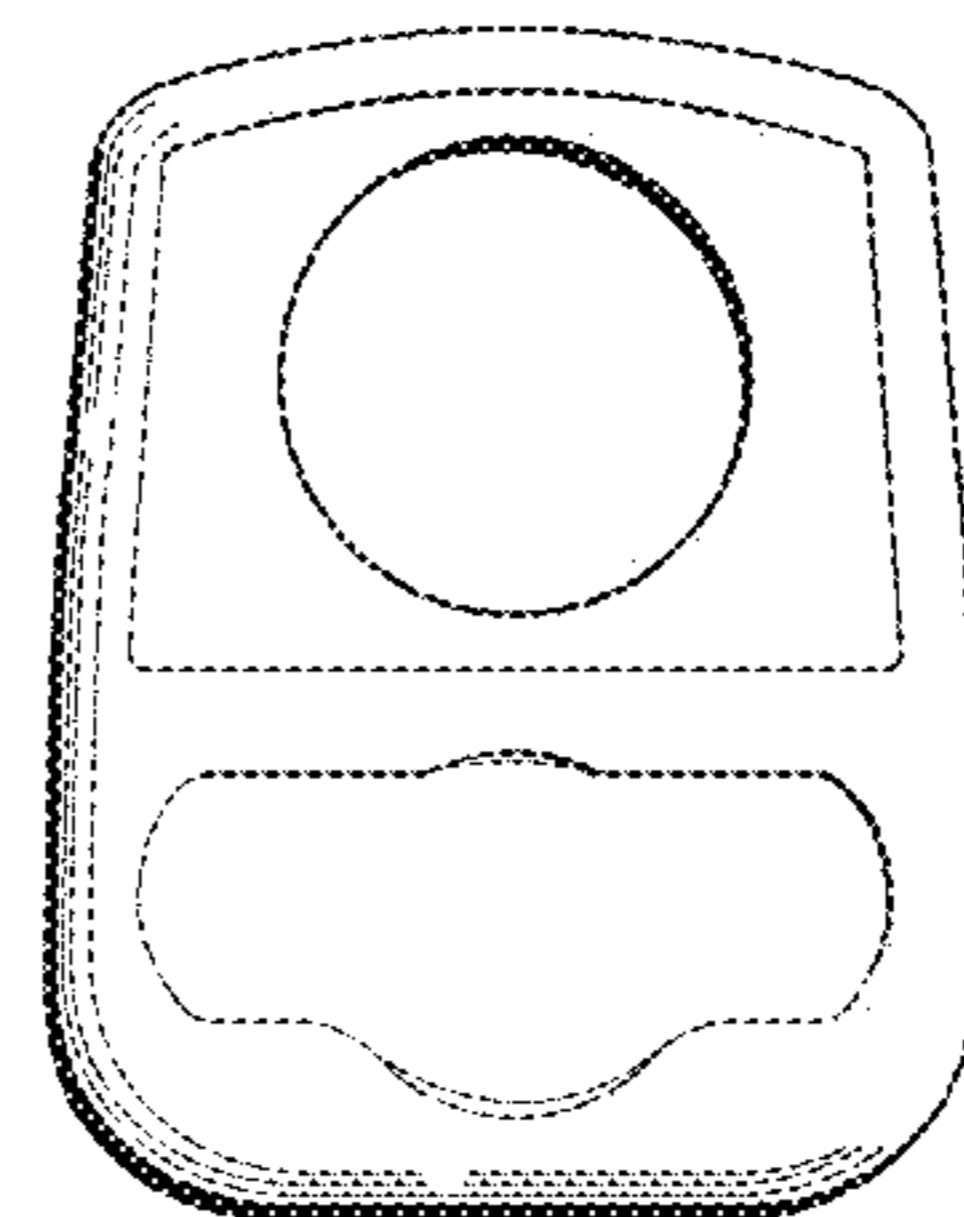

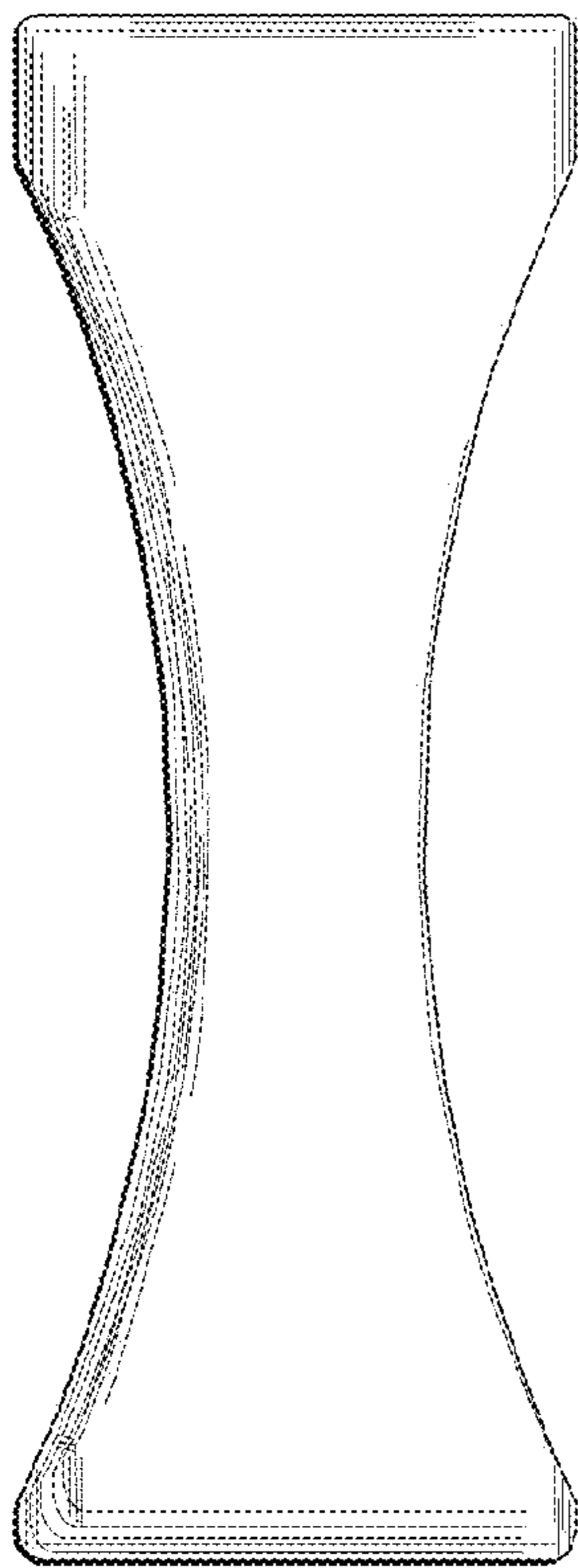

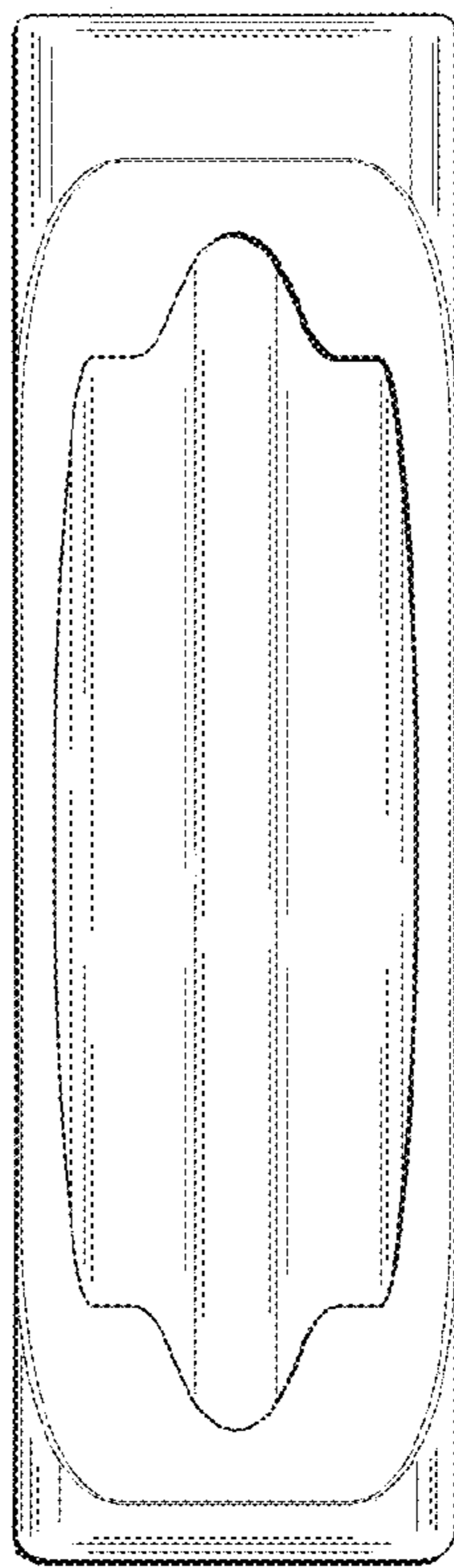

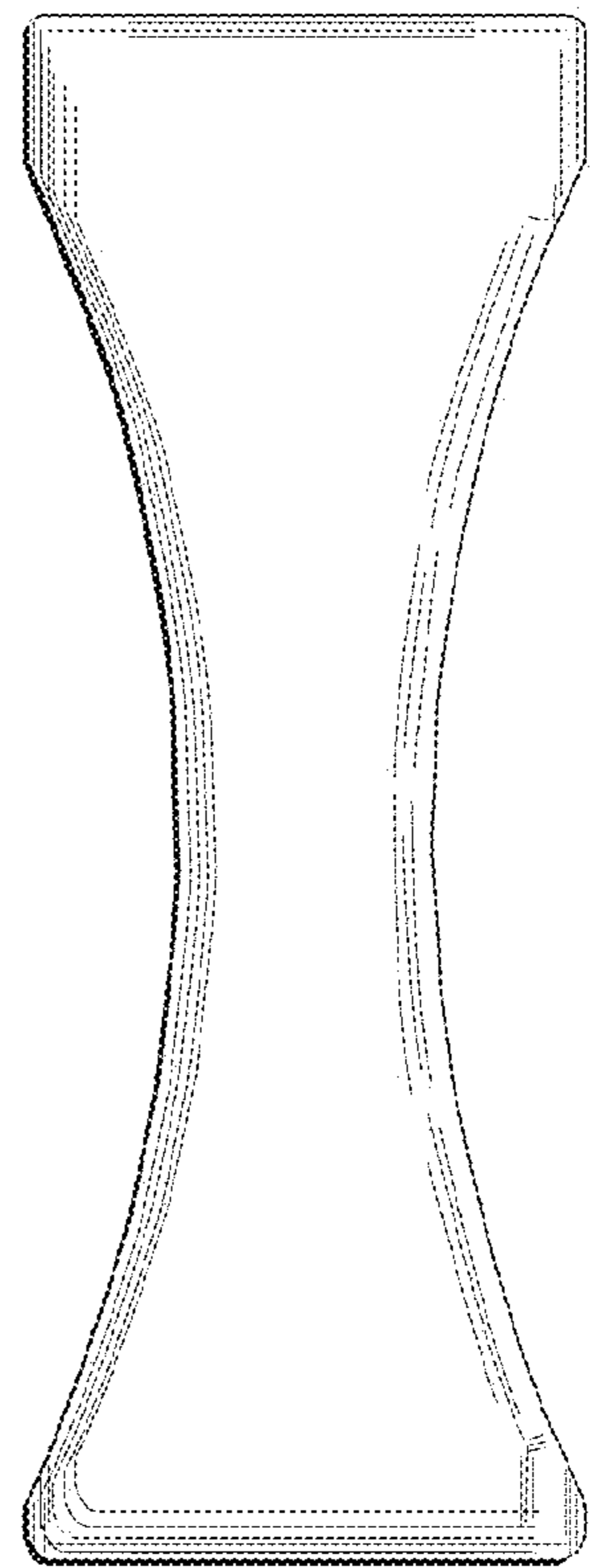
