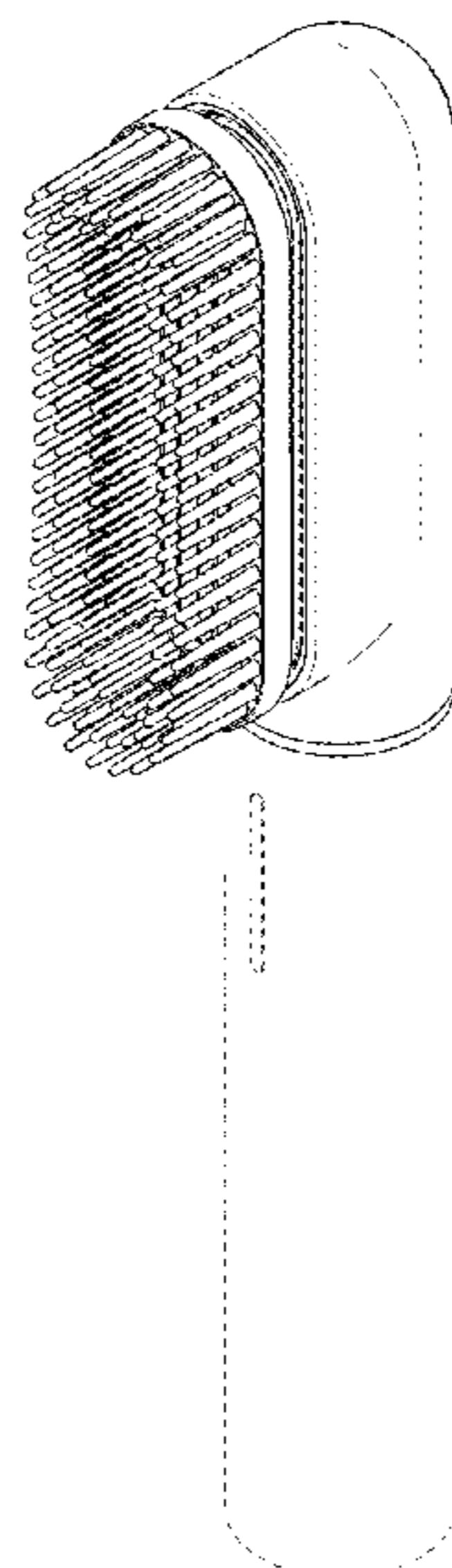
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front, right side, perspective view of a scalp treatment apparatus showing my new design;

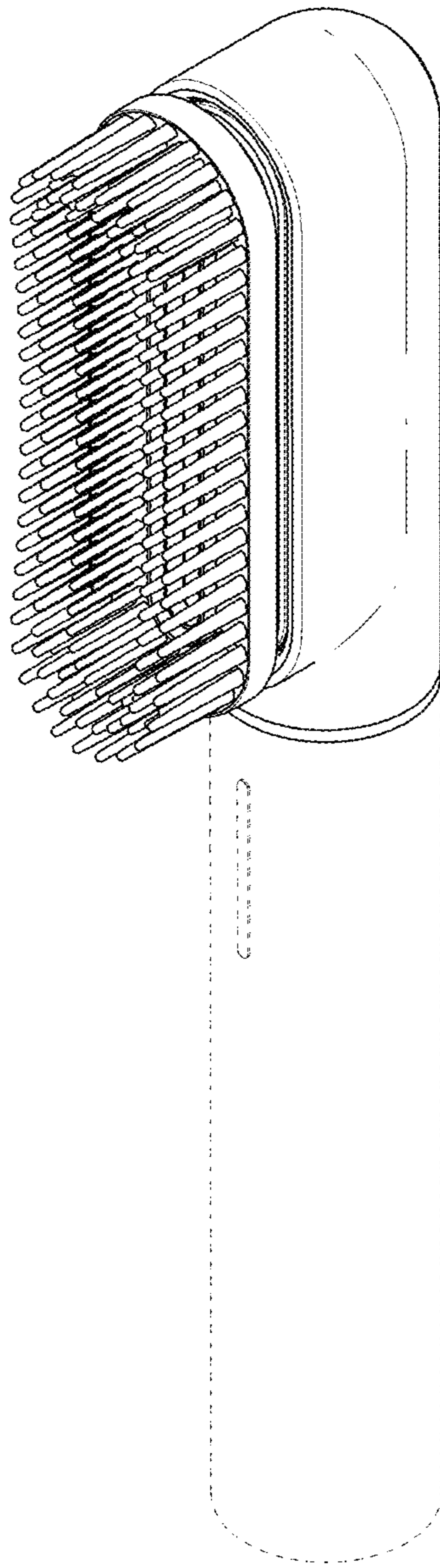

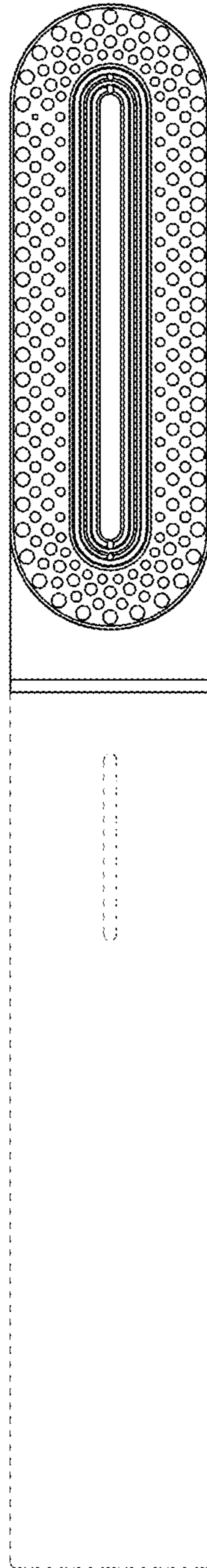

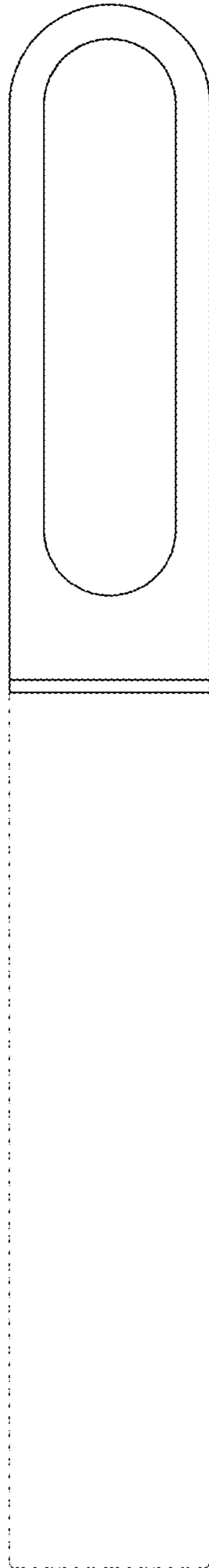

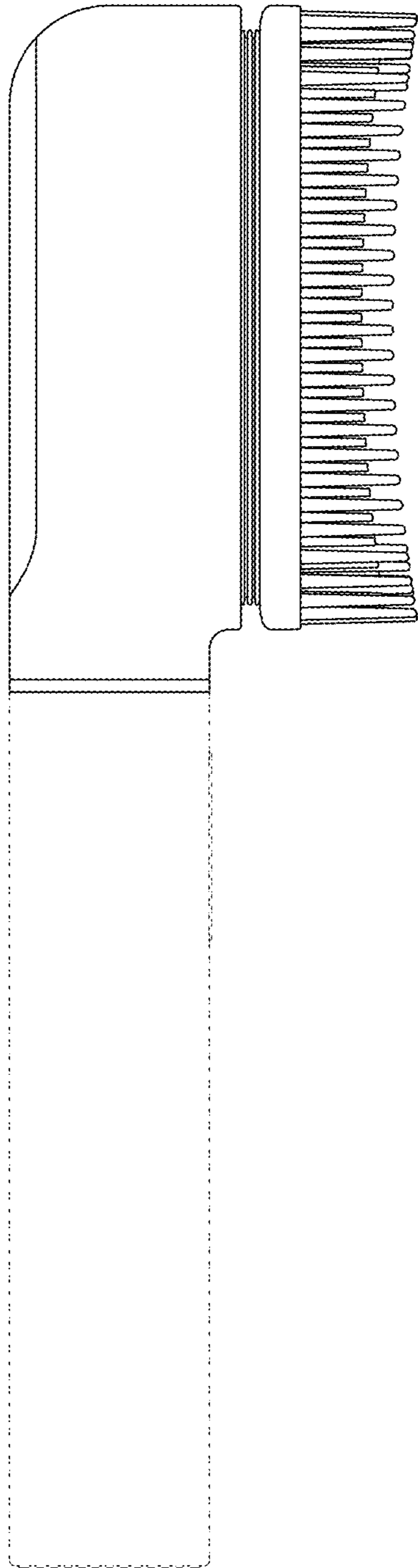

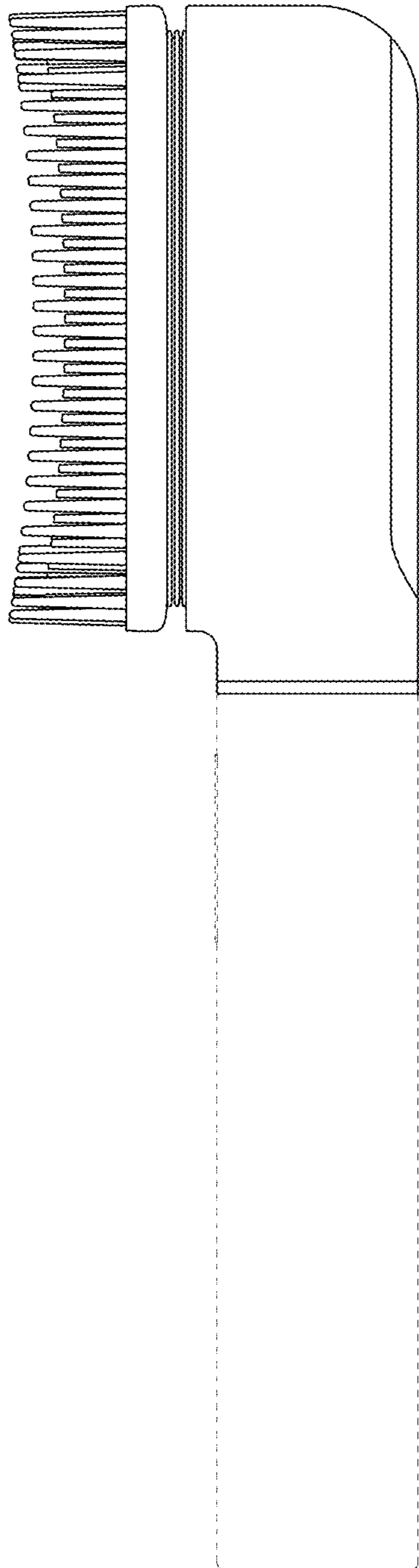

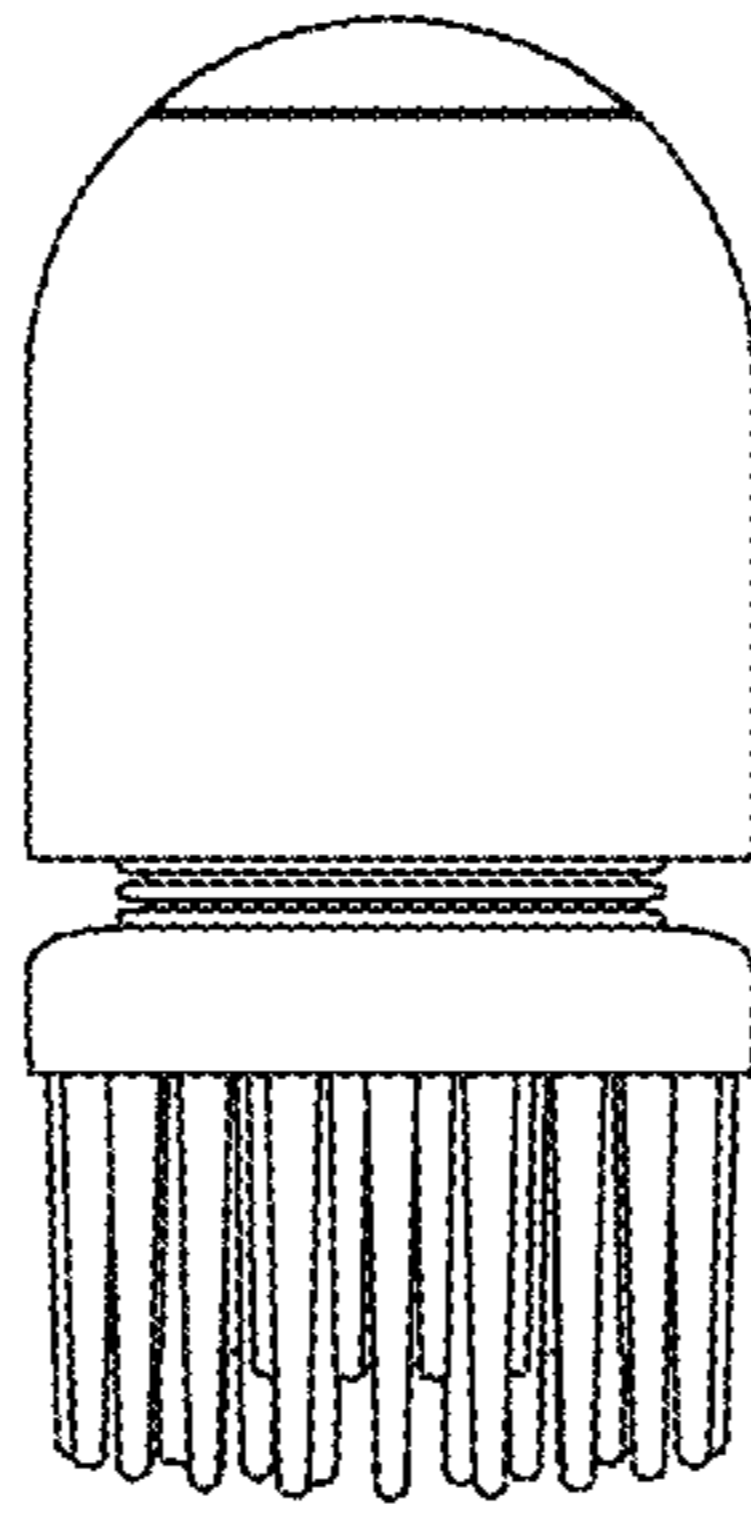
