(57) **CLAIM**

The ornamental design for an M1 vest, as shown and described.

DESCRIPTION

FIG. 1 is a front view of an M1 vest showing my new design; FIG. 2 is a back view of an M1 vest showing my new design; FIG. 3 is a side view of an M1 vest showing my new design; and, FIG. 4 is another side view of an M1 vest showing my new design.

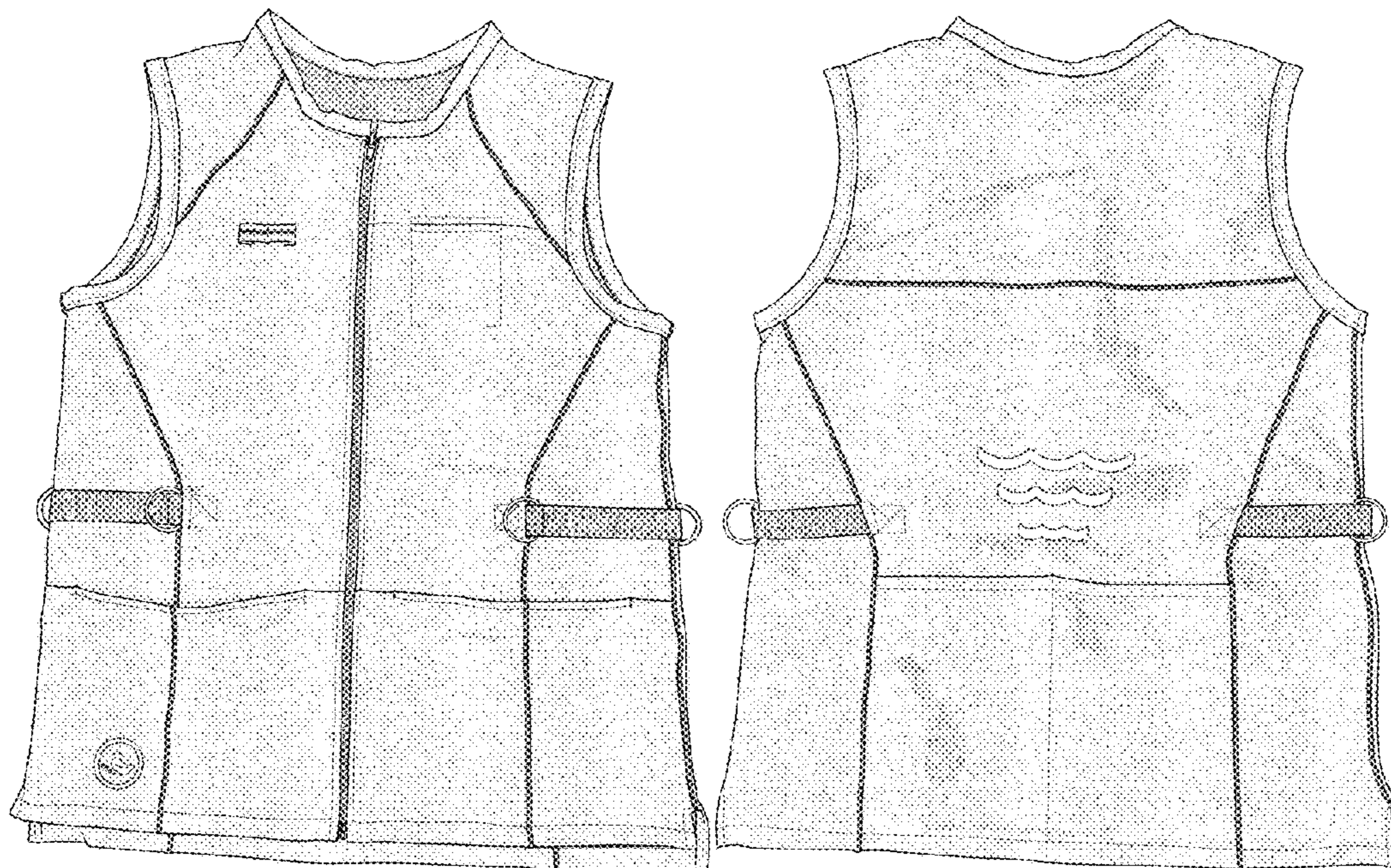

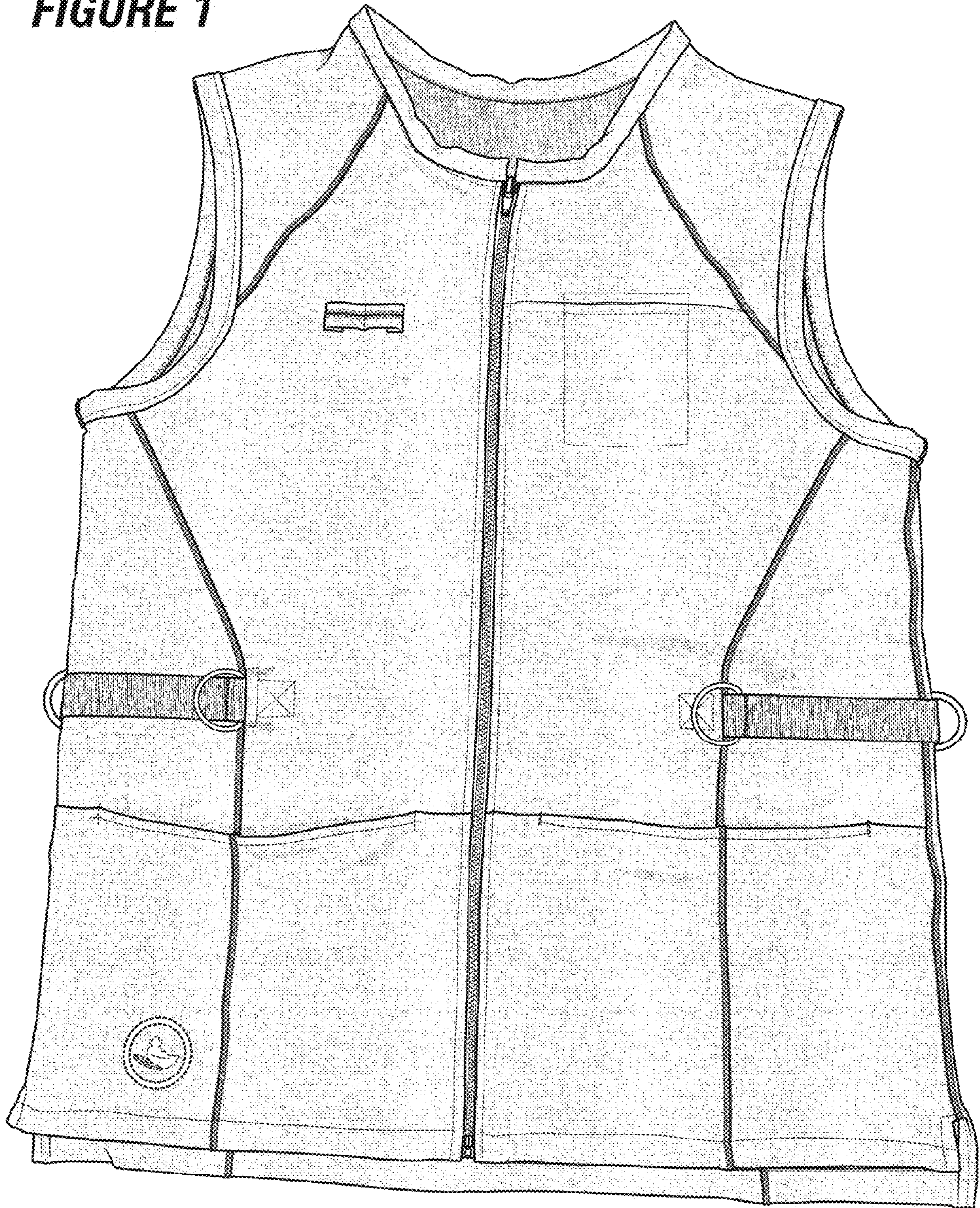

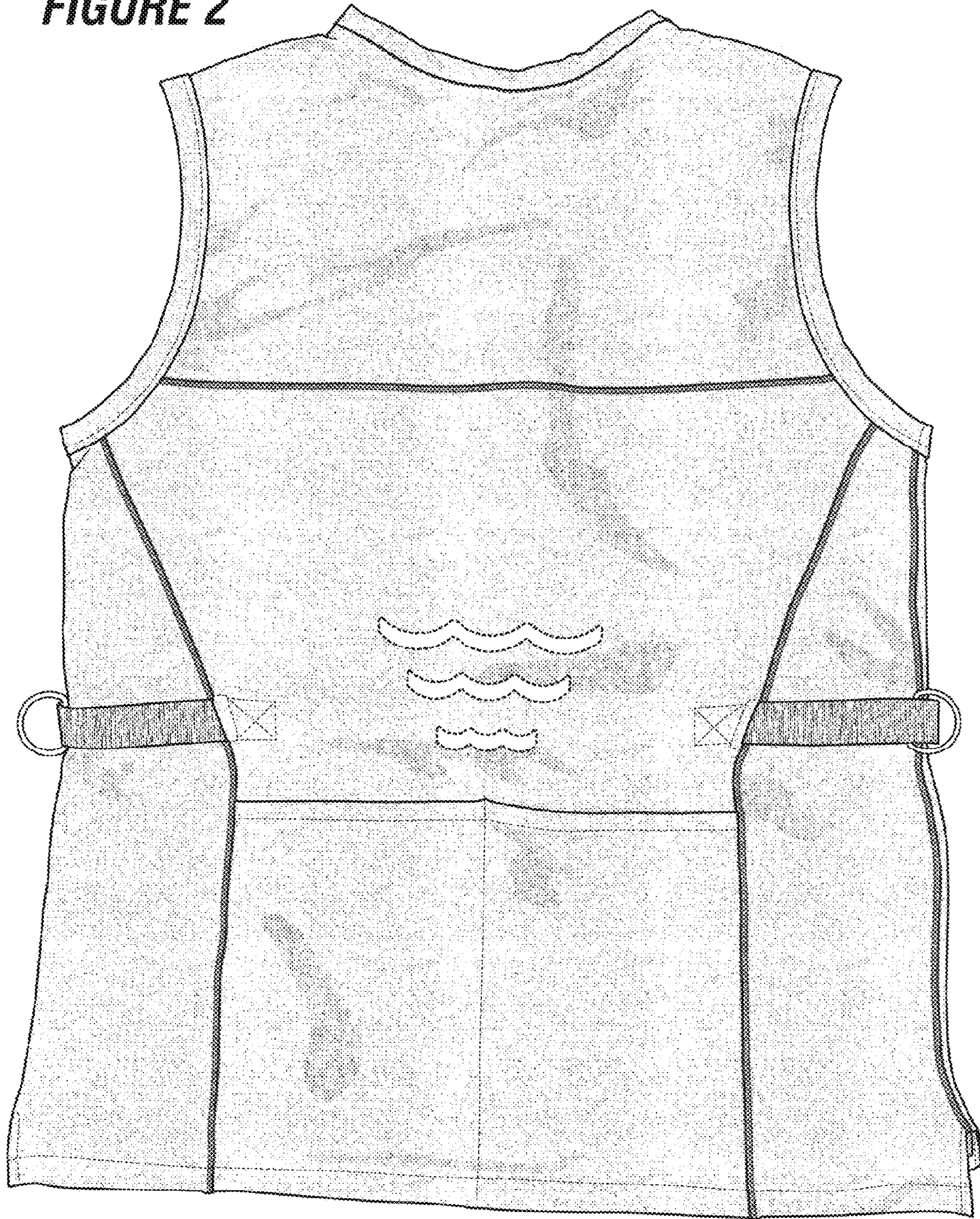

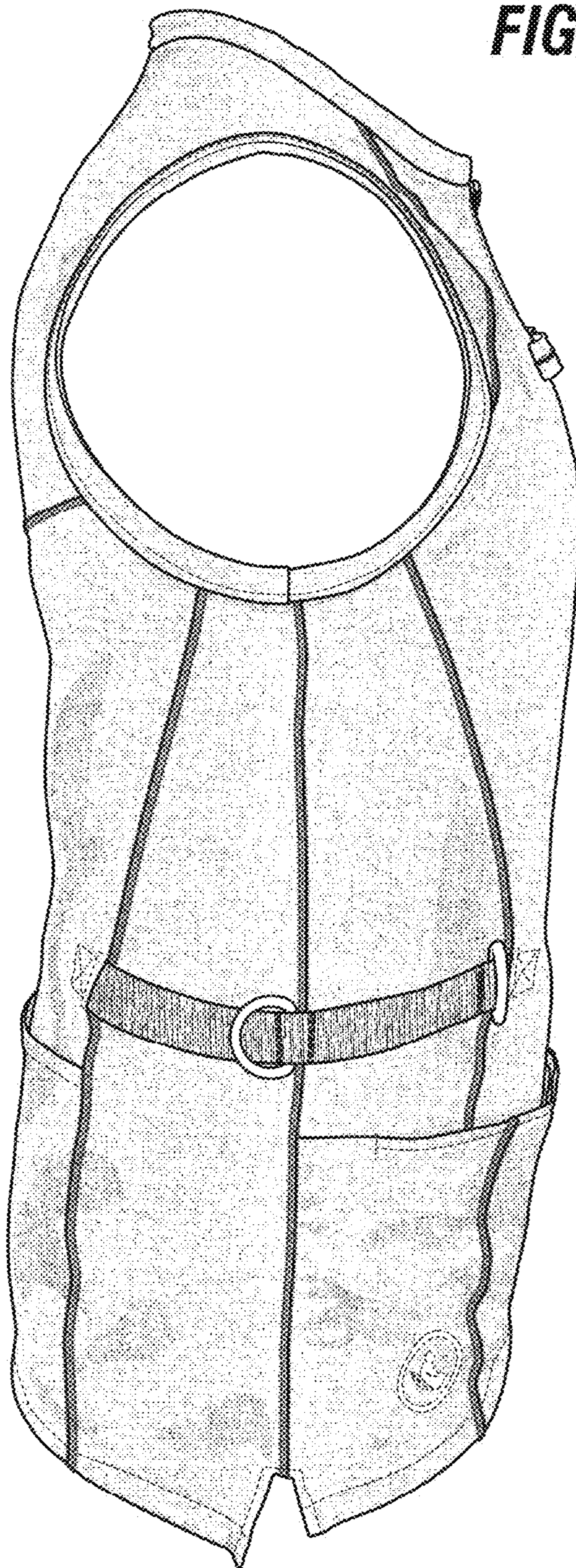
