The ornamental design for a shoe sole, as shown and described.

**DESCRIPTION**

FIG. 1 is a lateral view of a shoe sole showing my new design;

FIG. 2 is a medial view thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a rear view thereof;

FIG. 5 is a top view thereof;

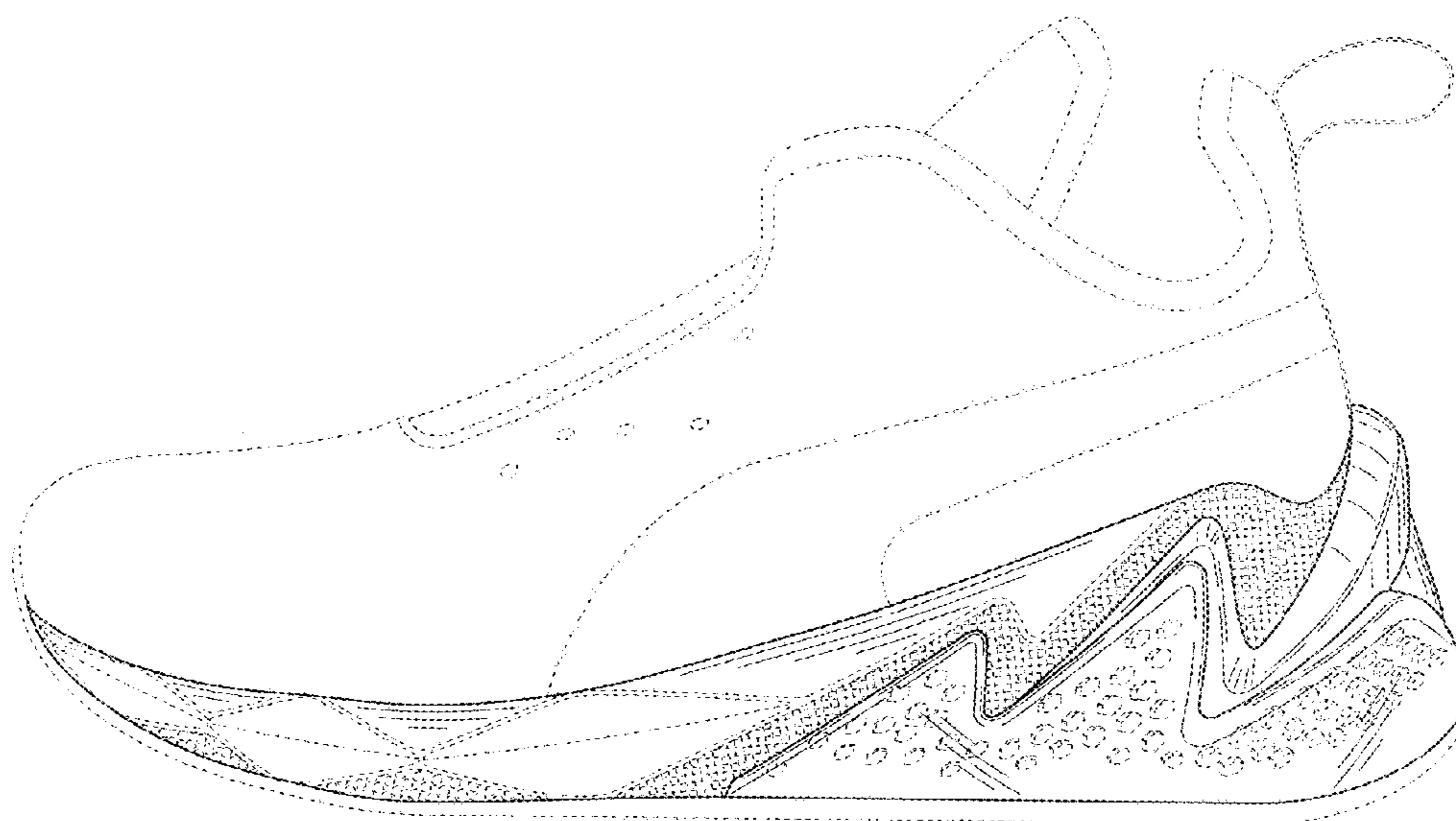
FIG. 6 is a bottom view thereof; and,

The oblique line shading in the heel section of the mid-sole of the shoe sole indicate a transparent surface and broken line features in the heel section are behind the transparent surface.

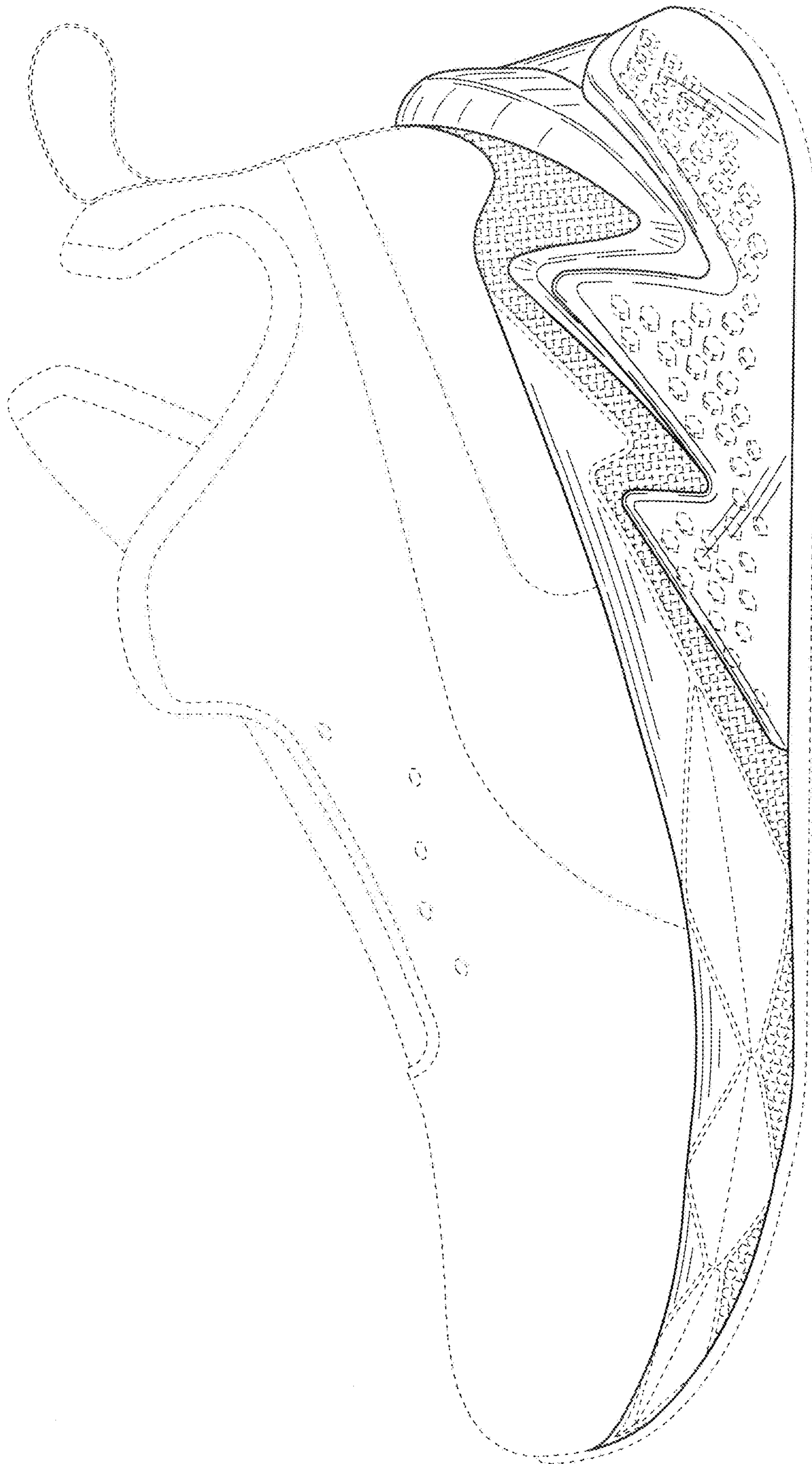

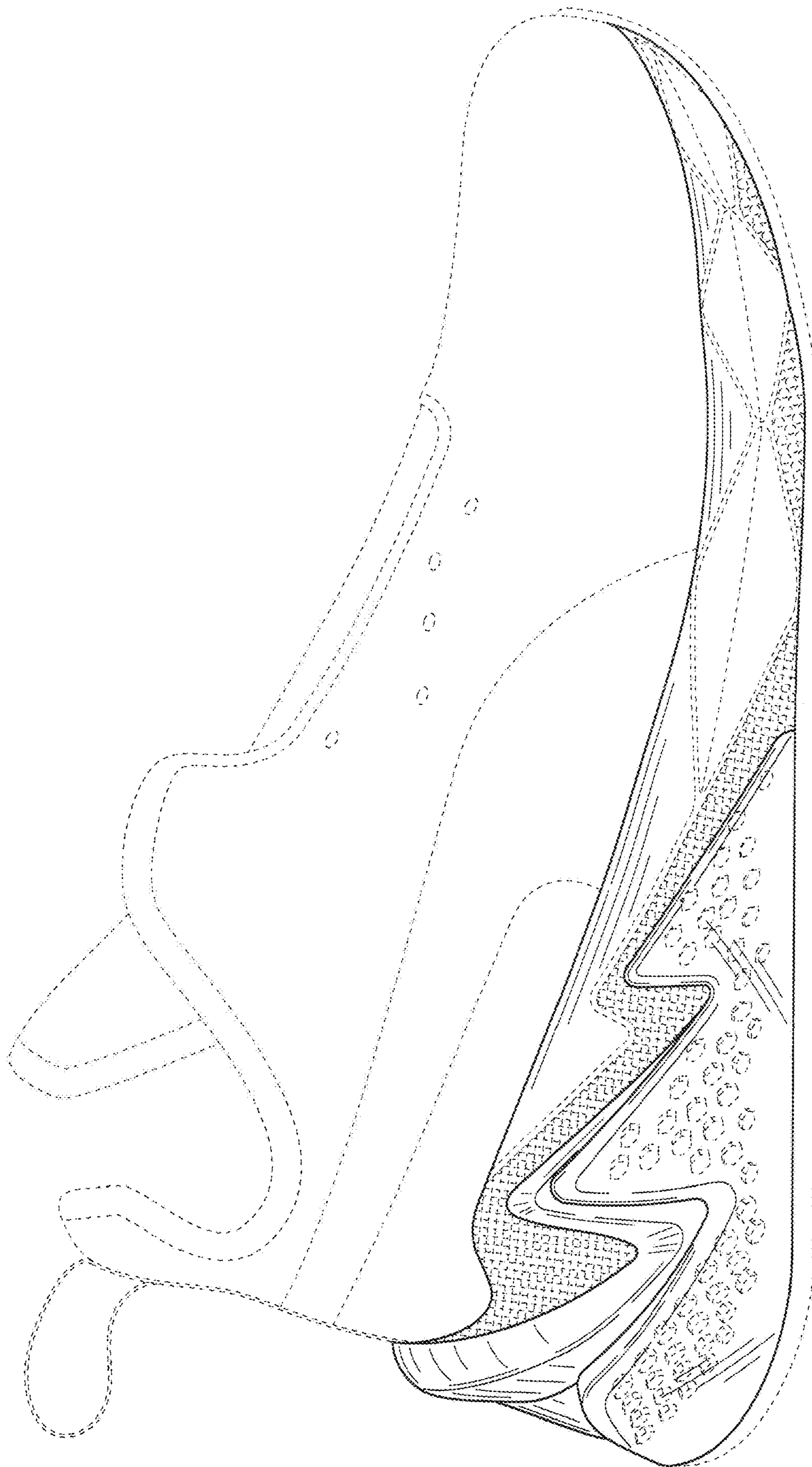

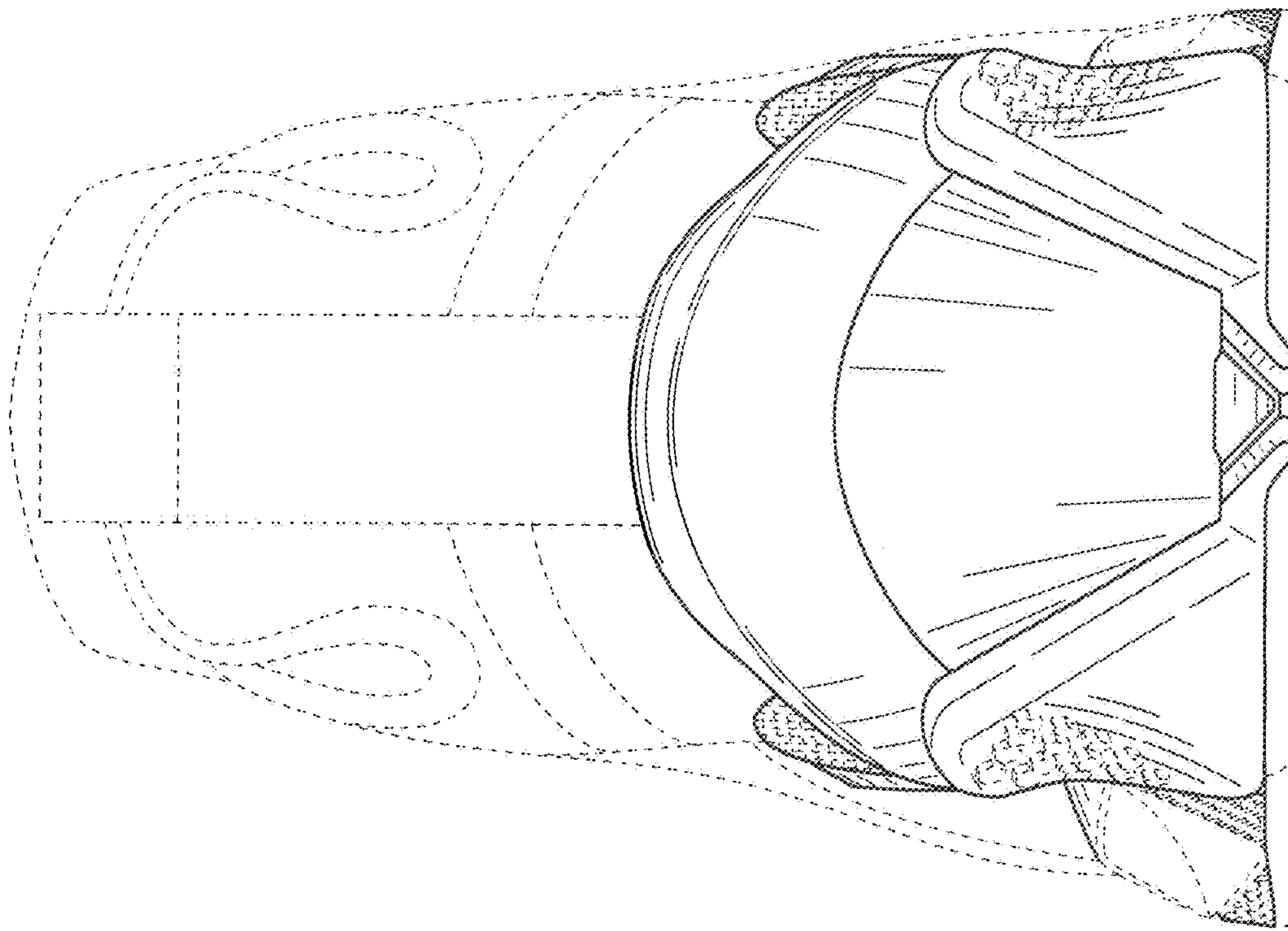

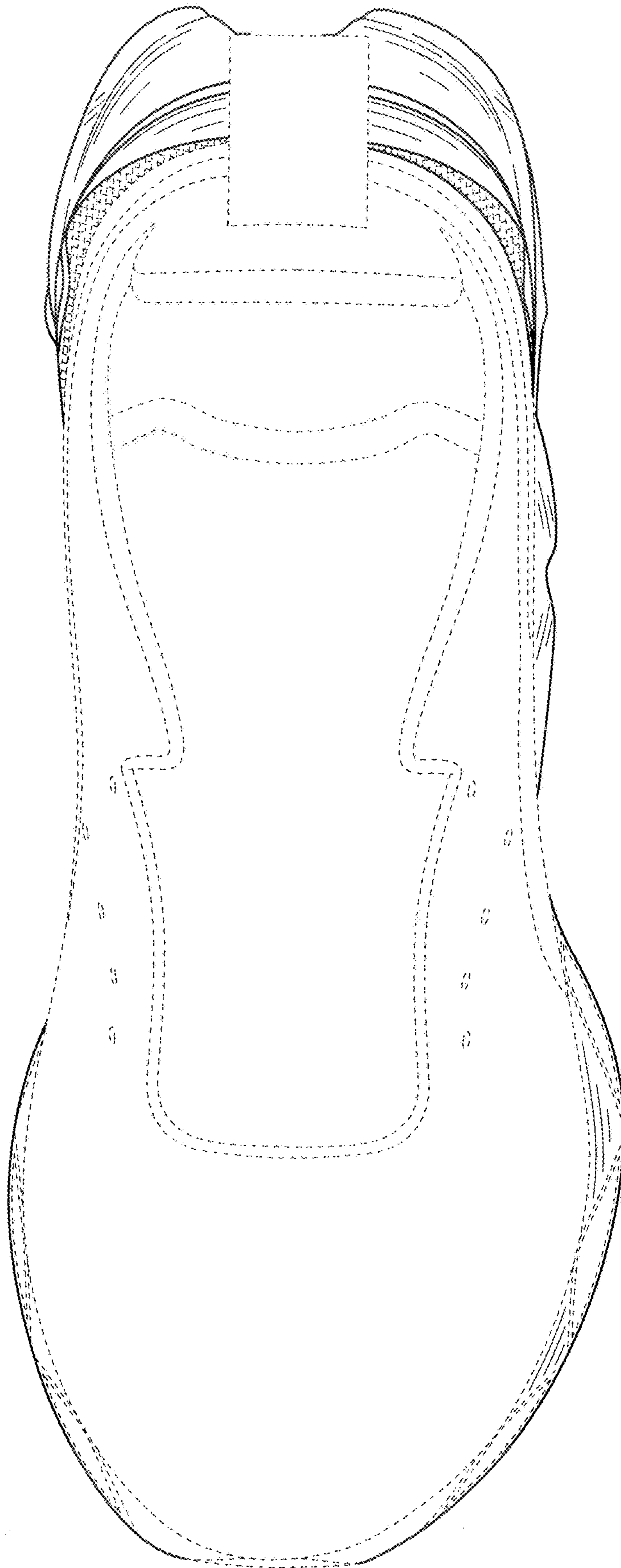

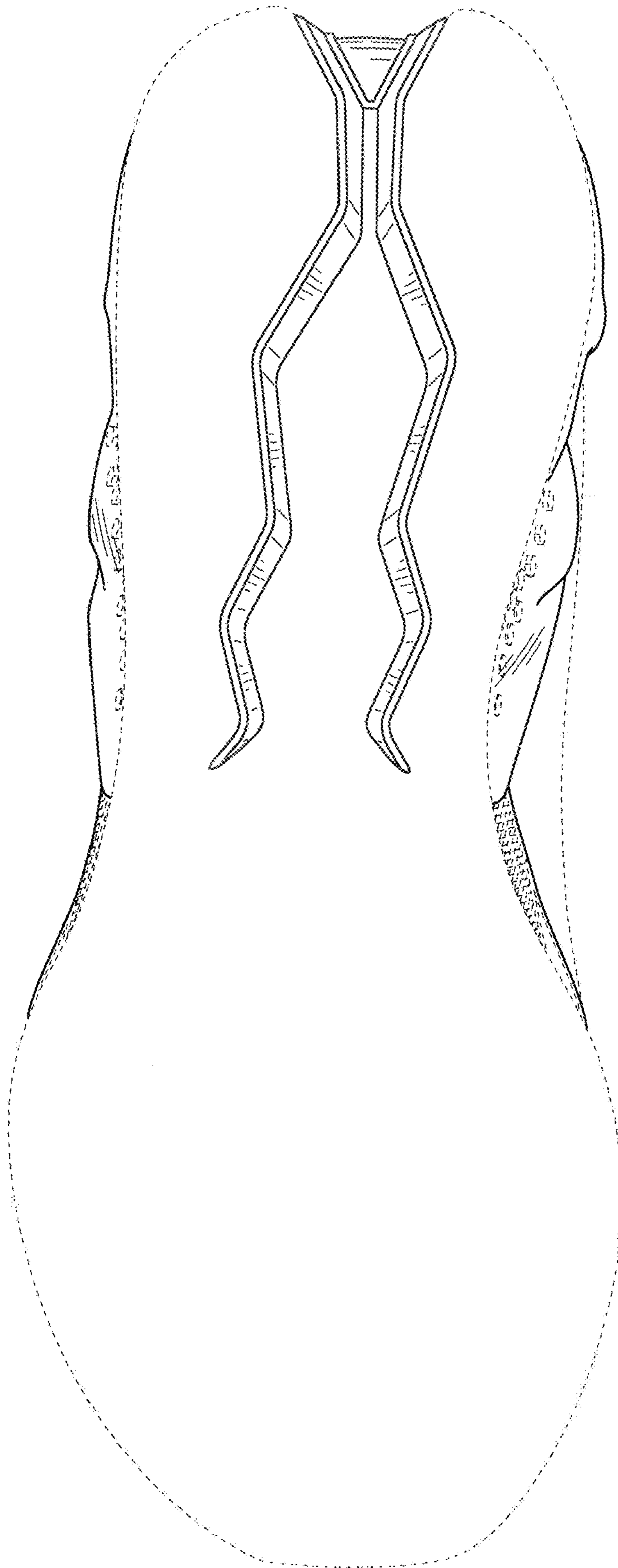

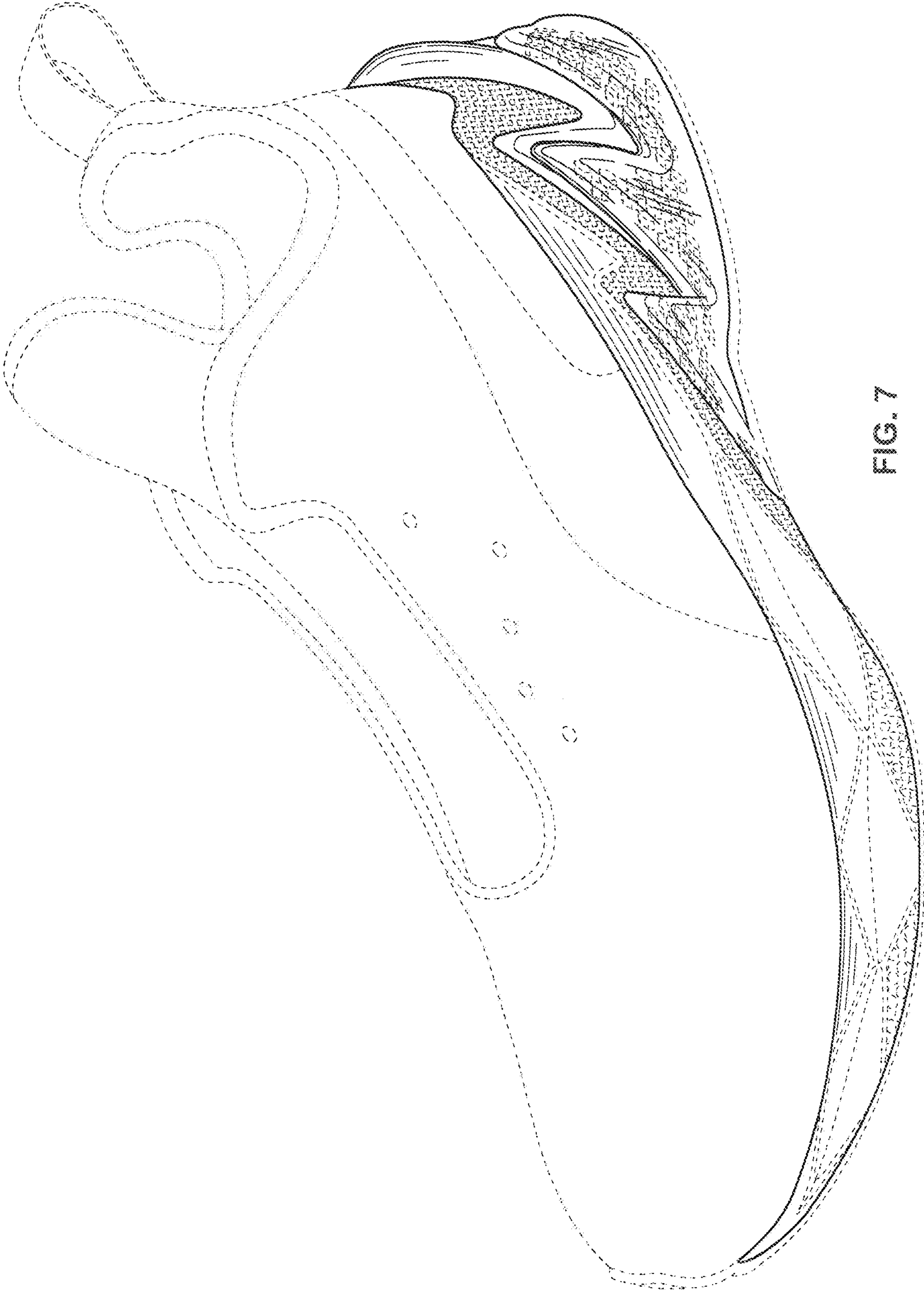
