FIG. 3 is a front view thereof;

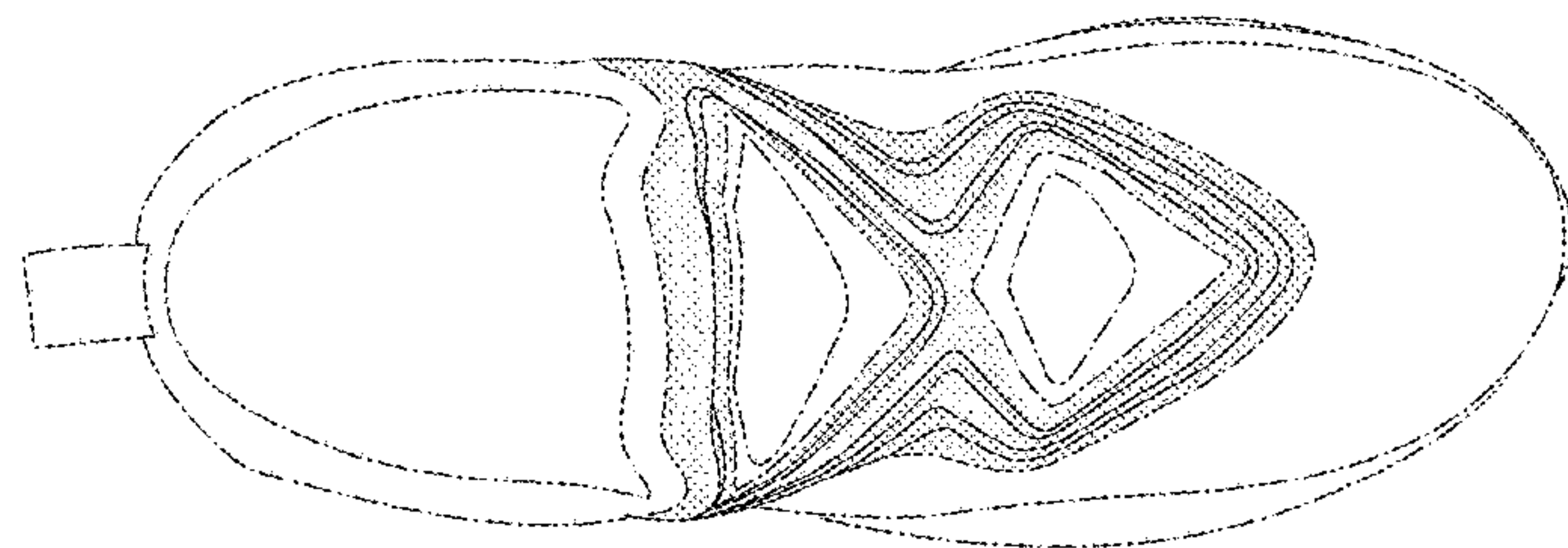
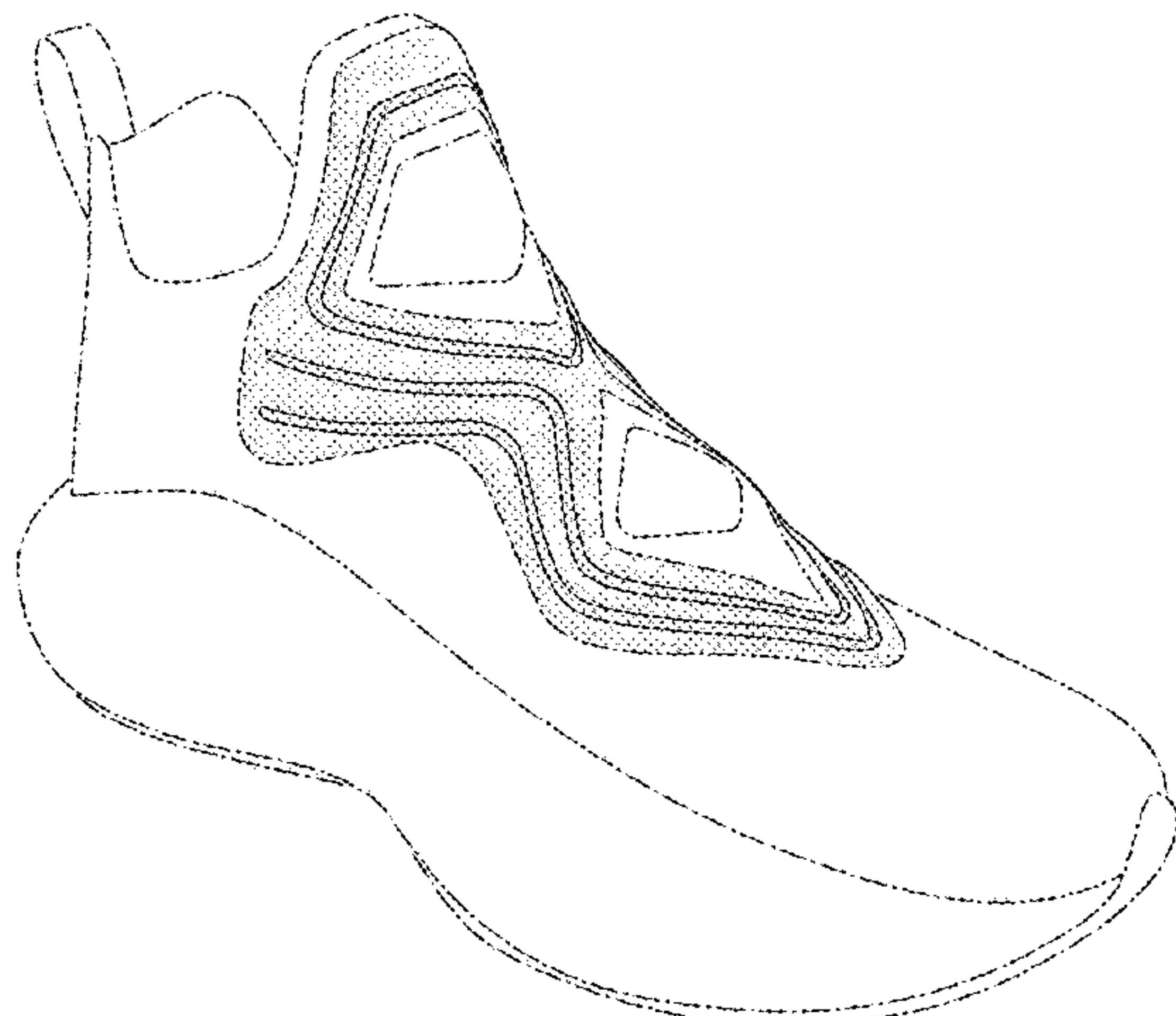
FIG. 4 is an opposite side front perspective view thereof;

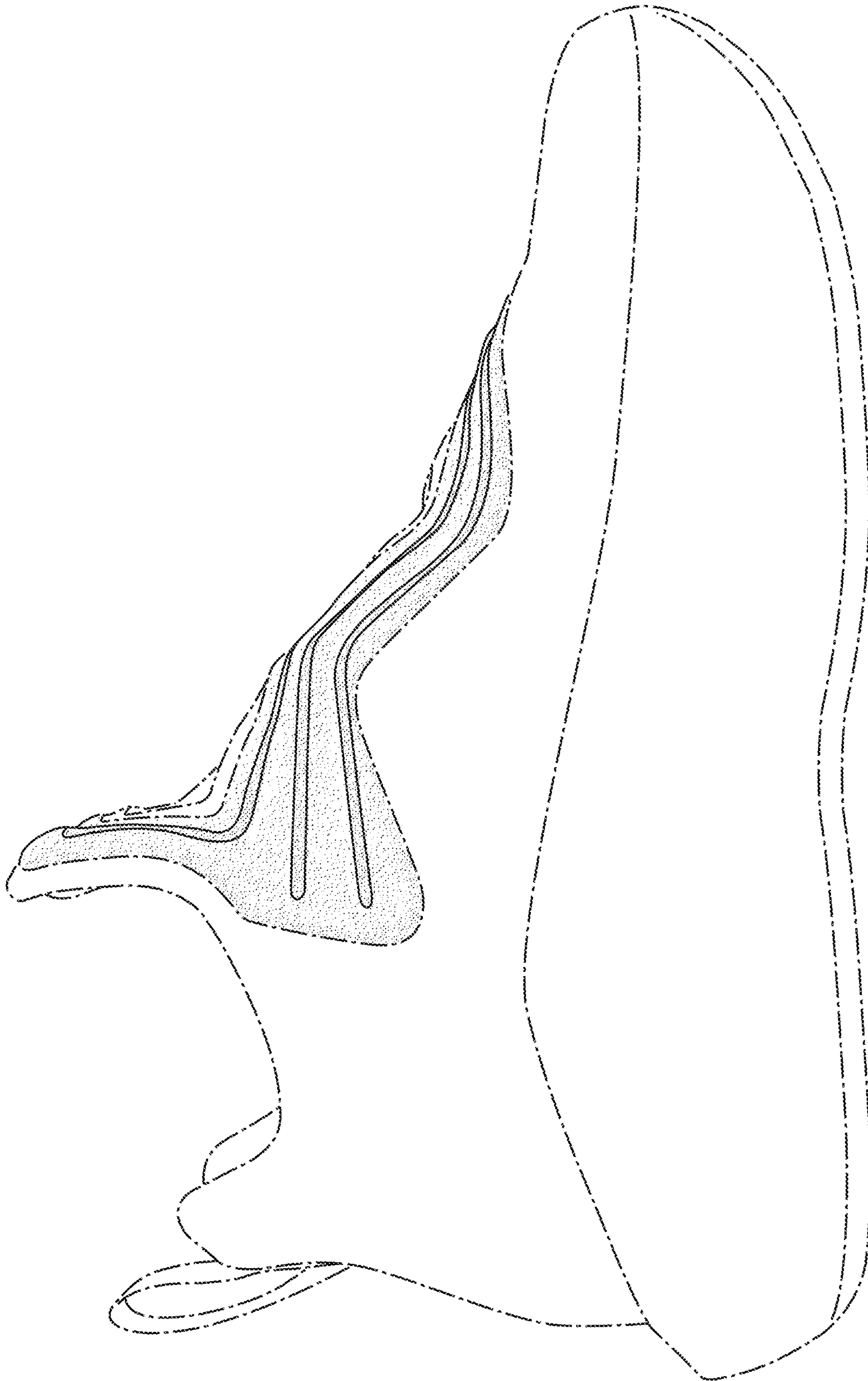

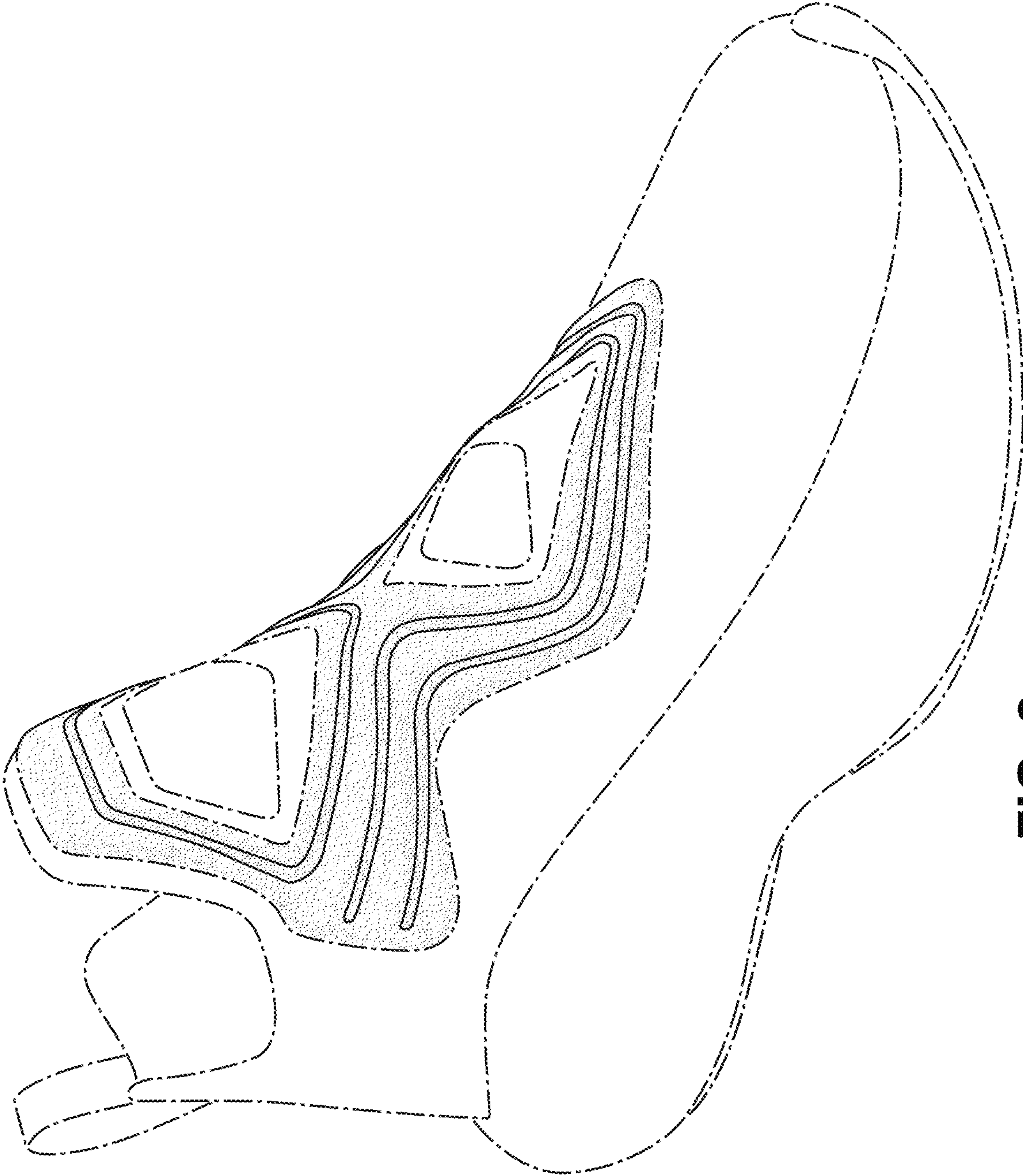

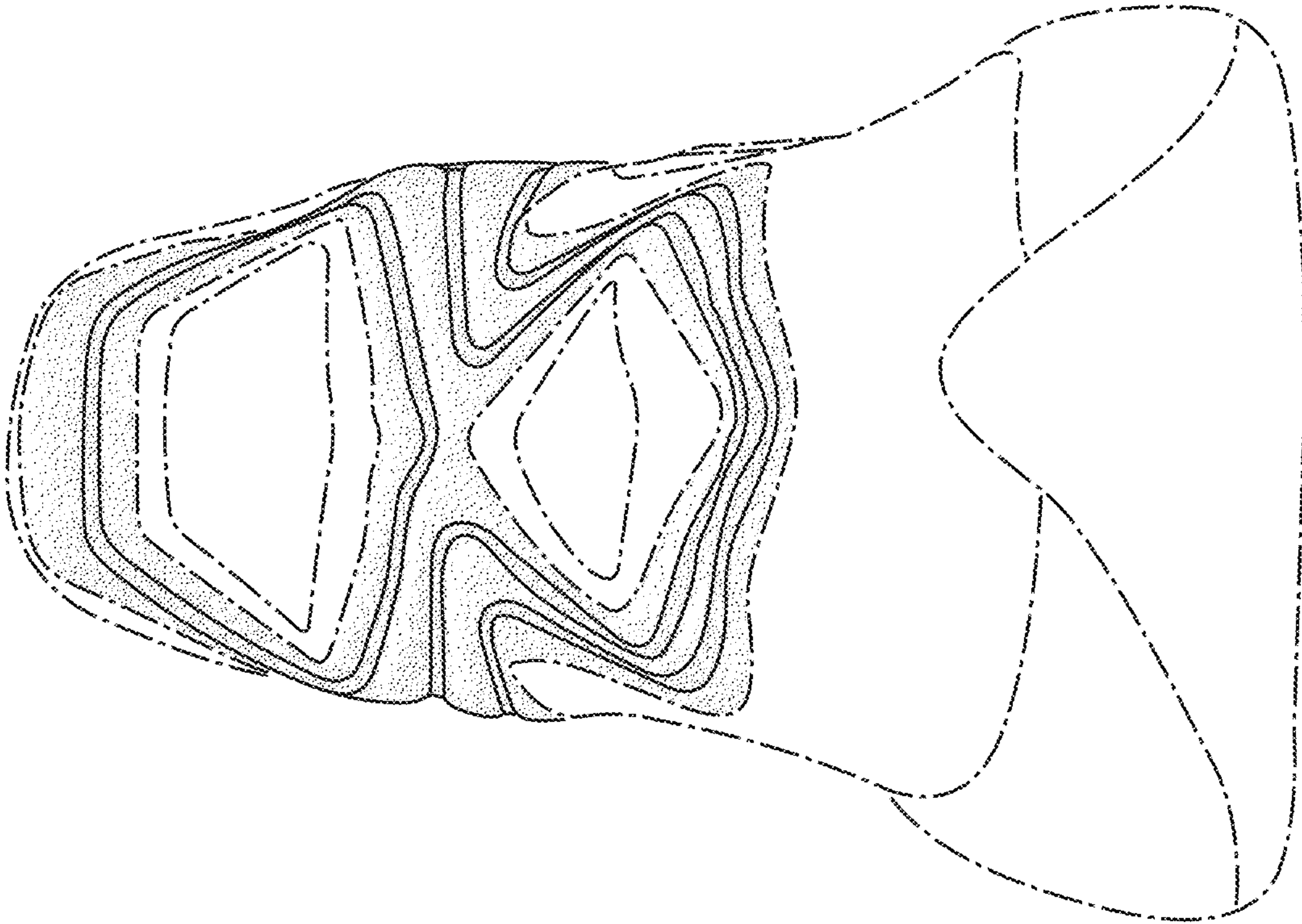

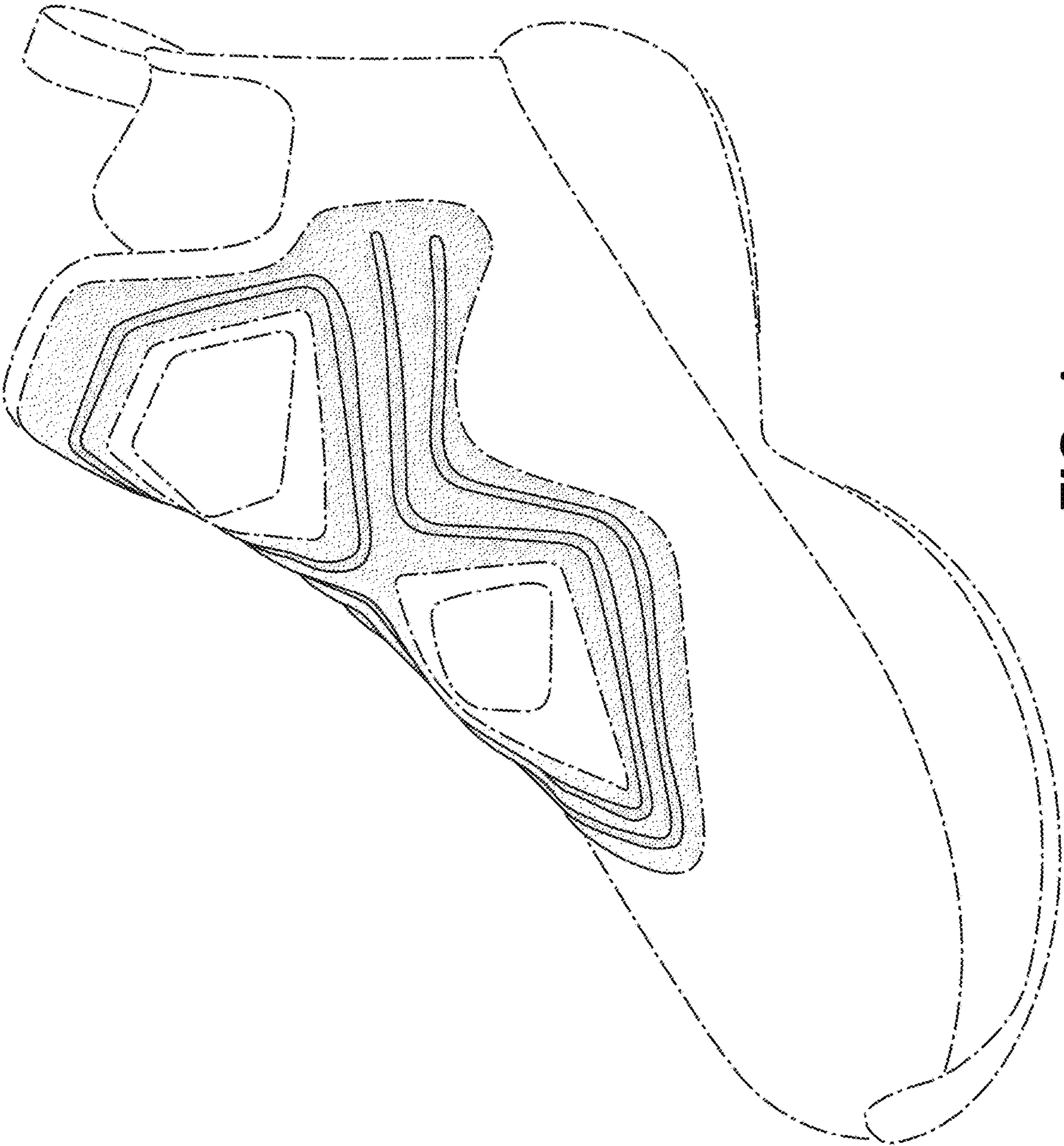

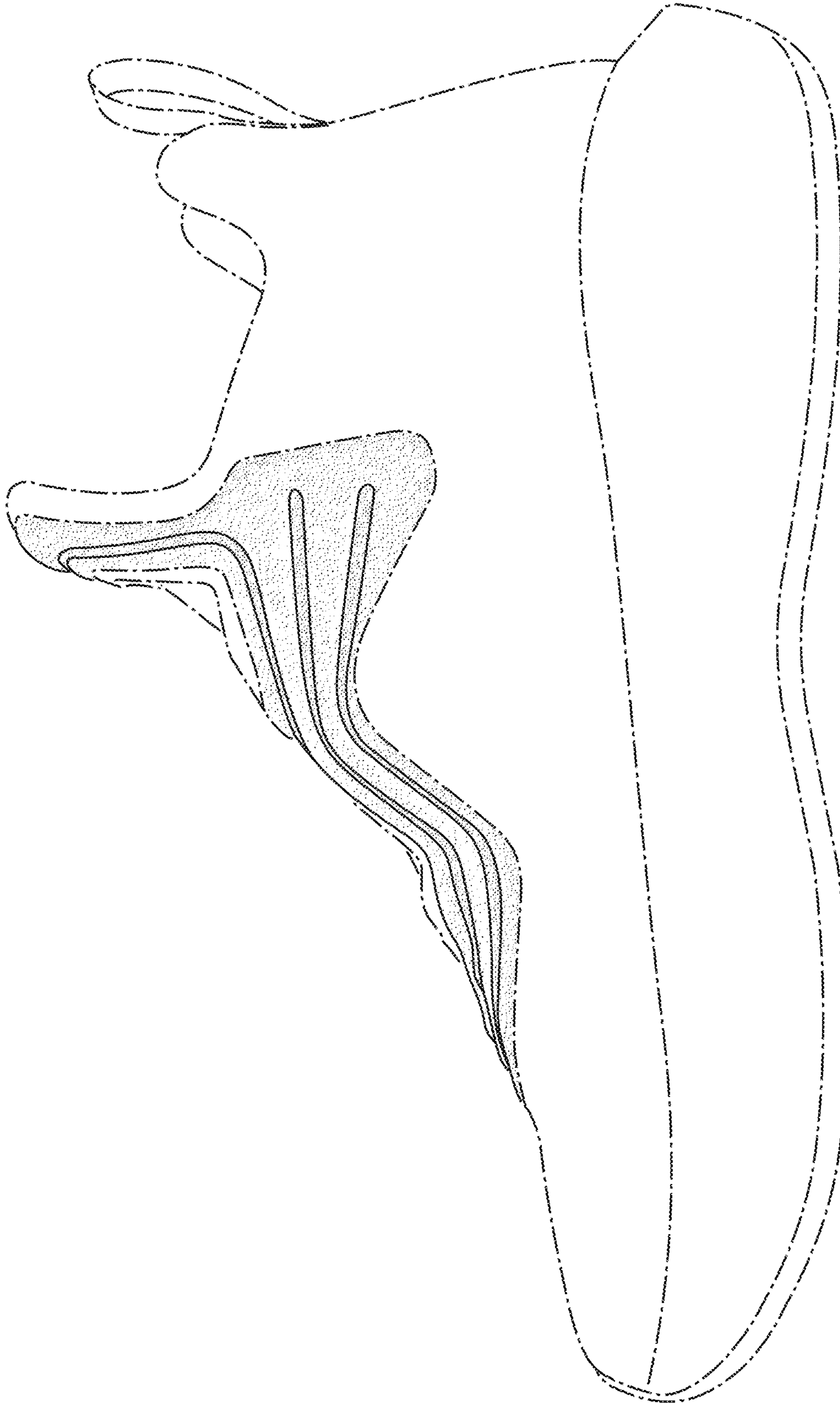

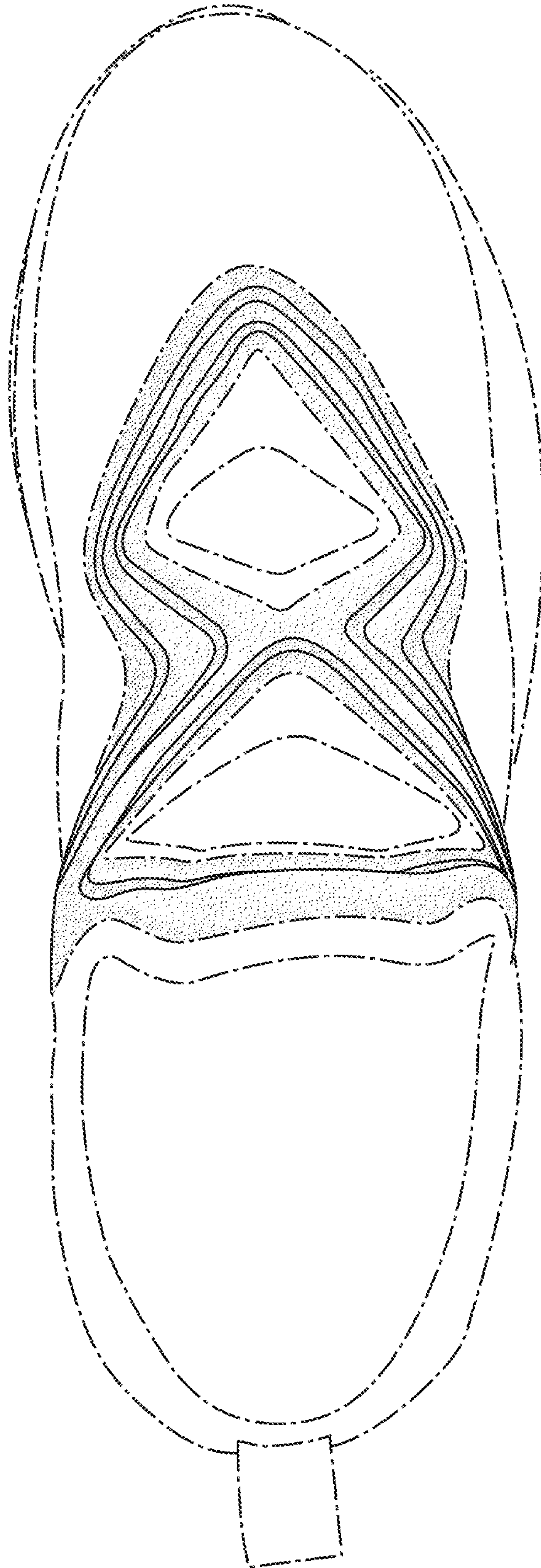
