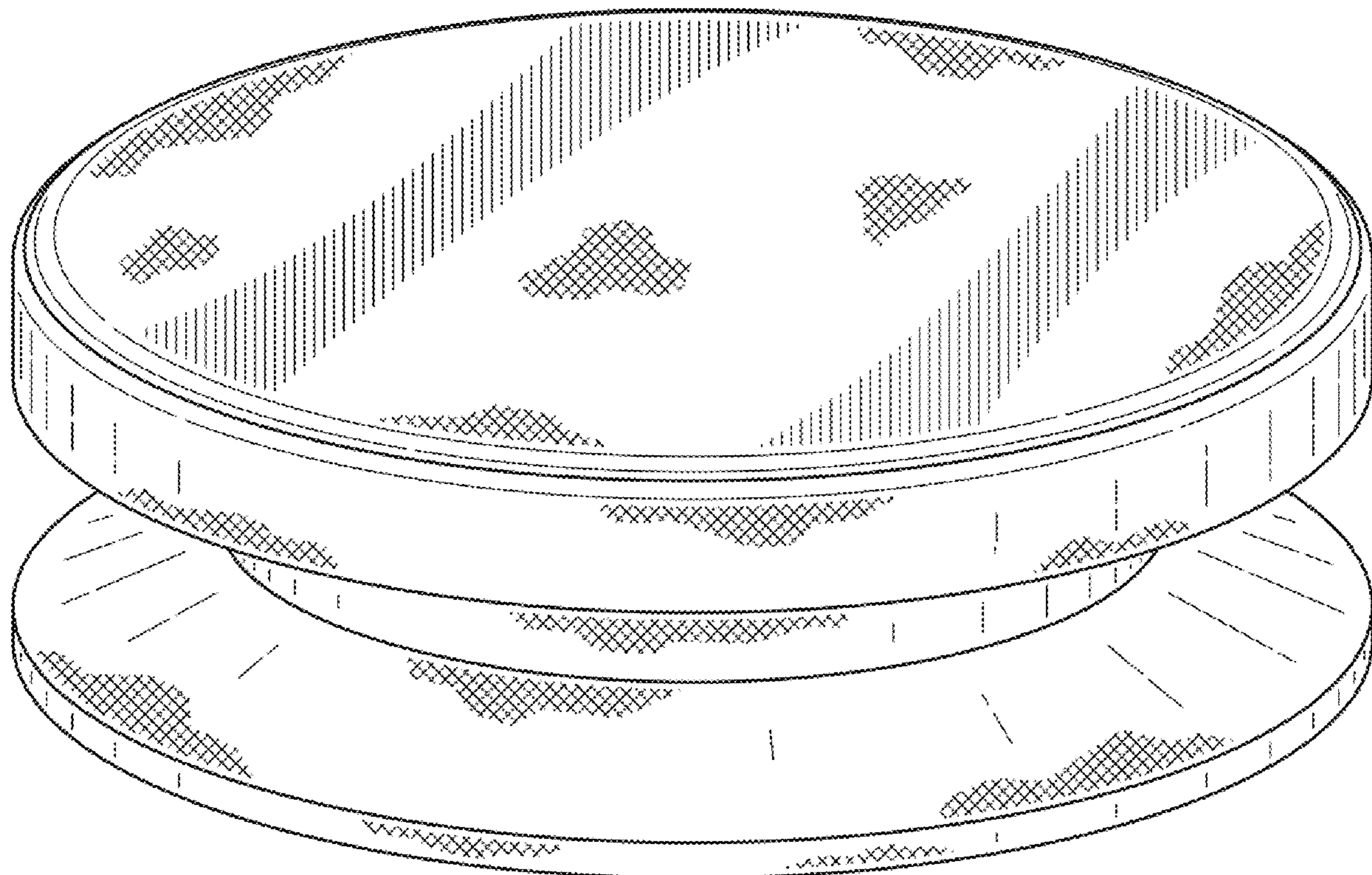

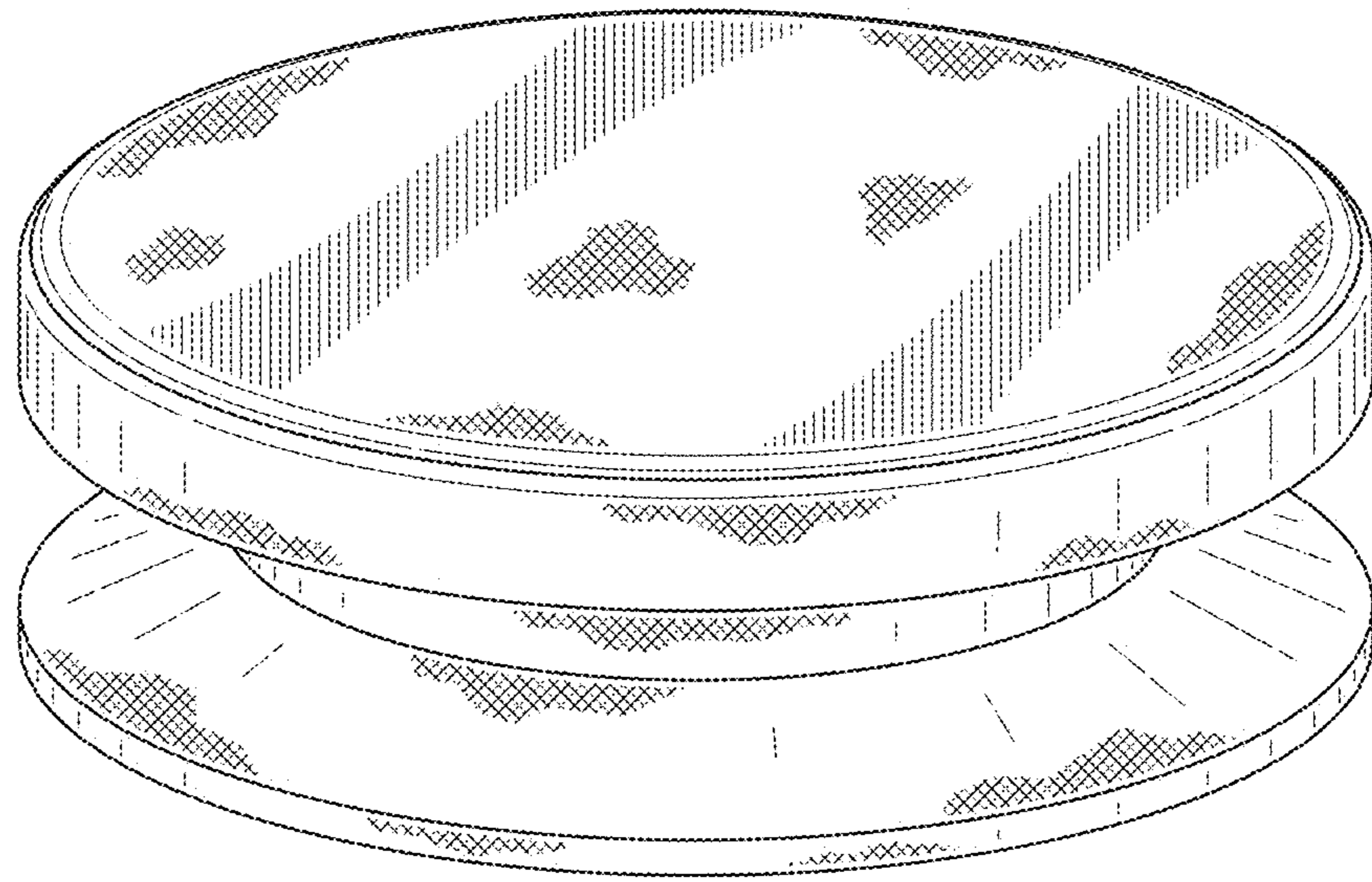
The ornamental design for posture seat cushion, as shown and described.

**DESCRIPTION**

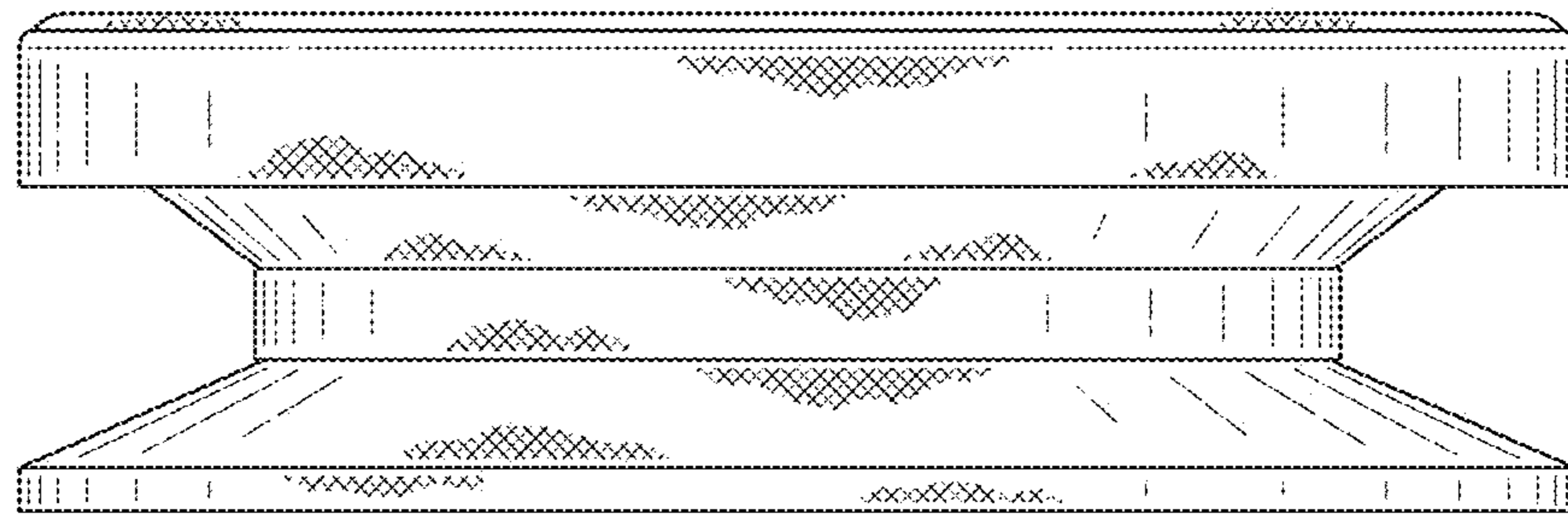
FIG. 1 is a front top perspective view of the posture seat cushion of the invention.

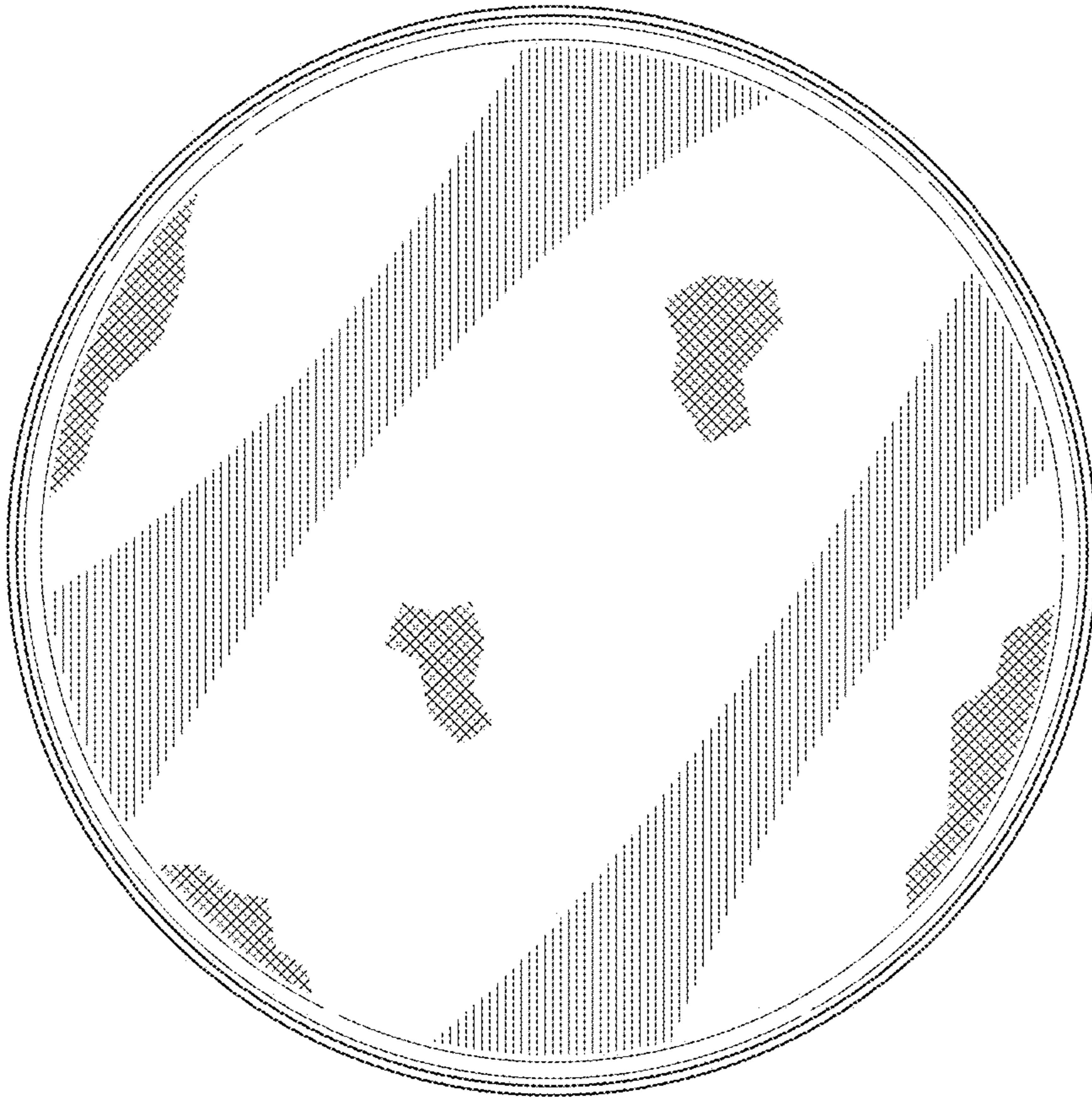




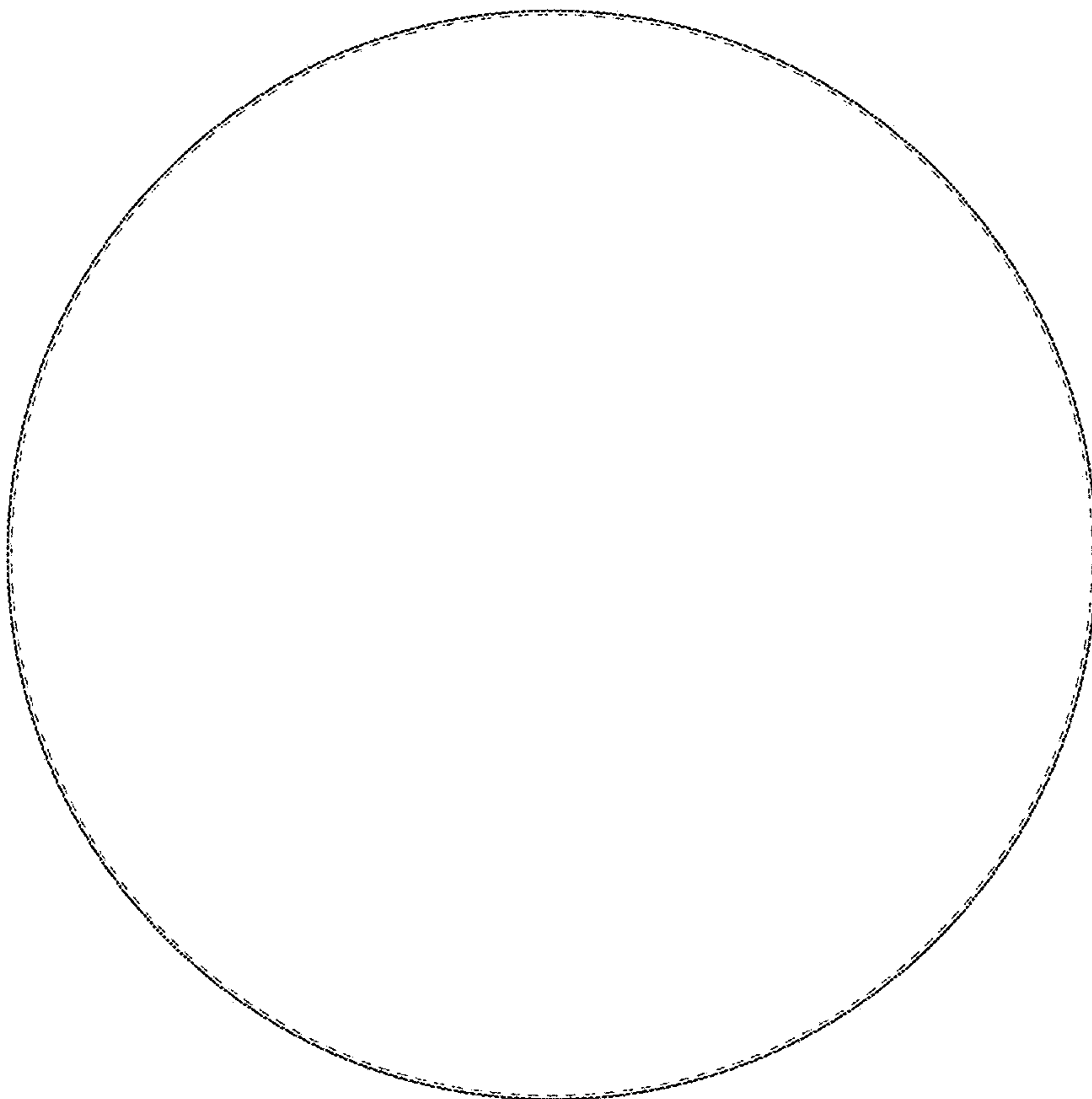
