We claim the ornamental design for a spice container, as shown and described.

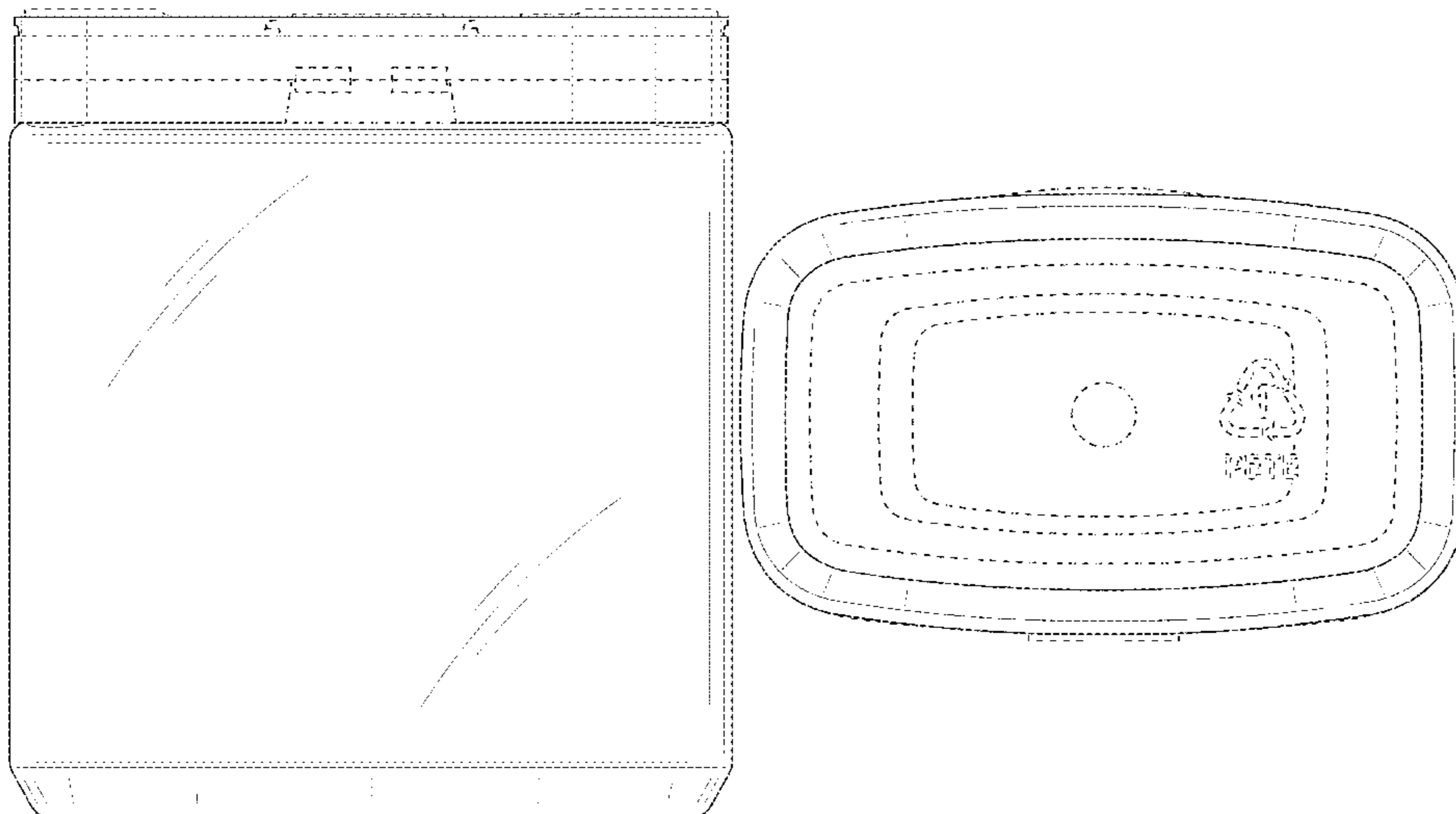

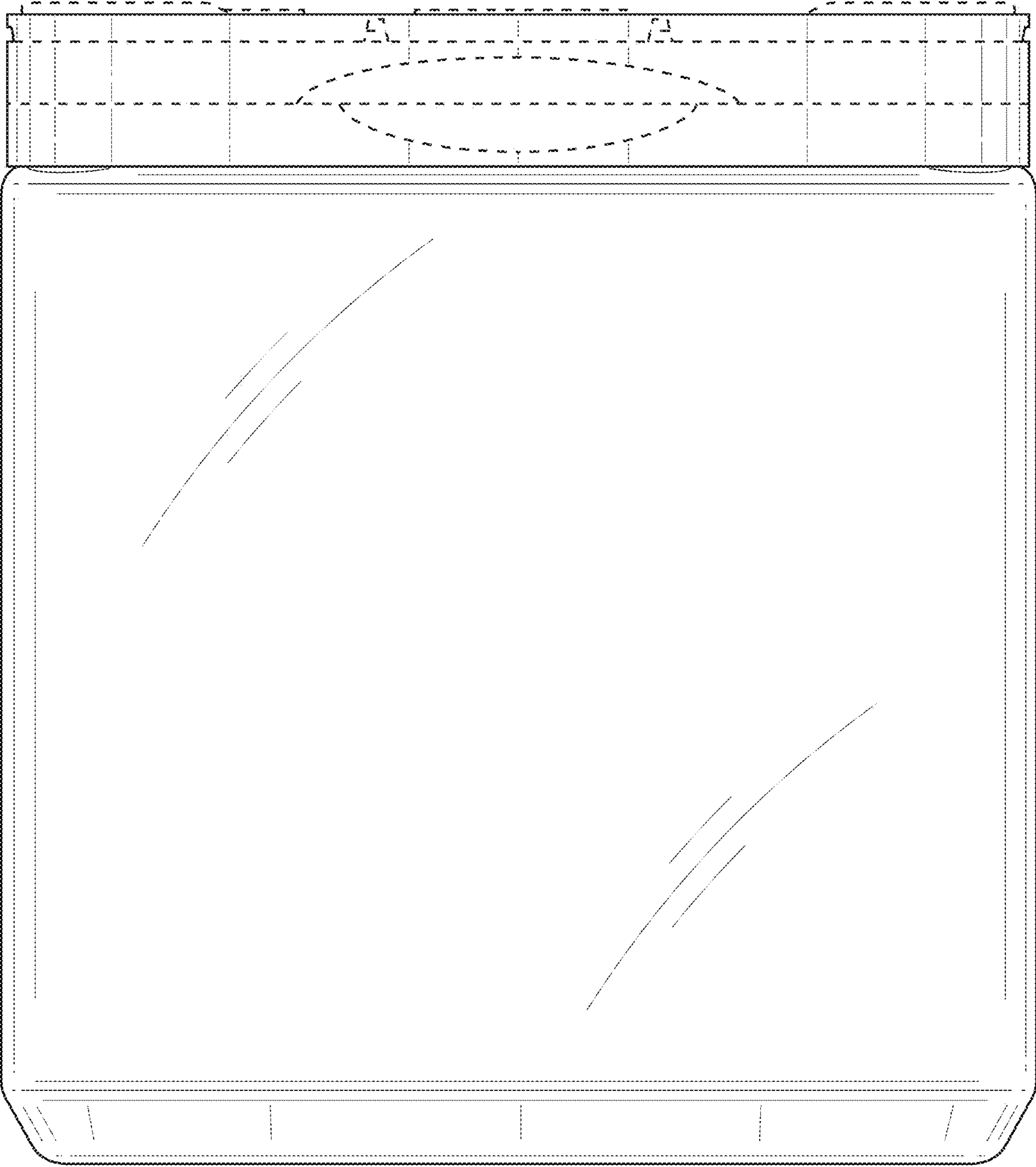

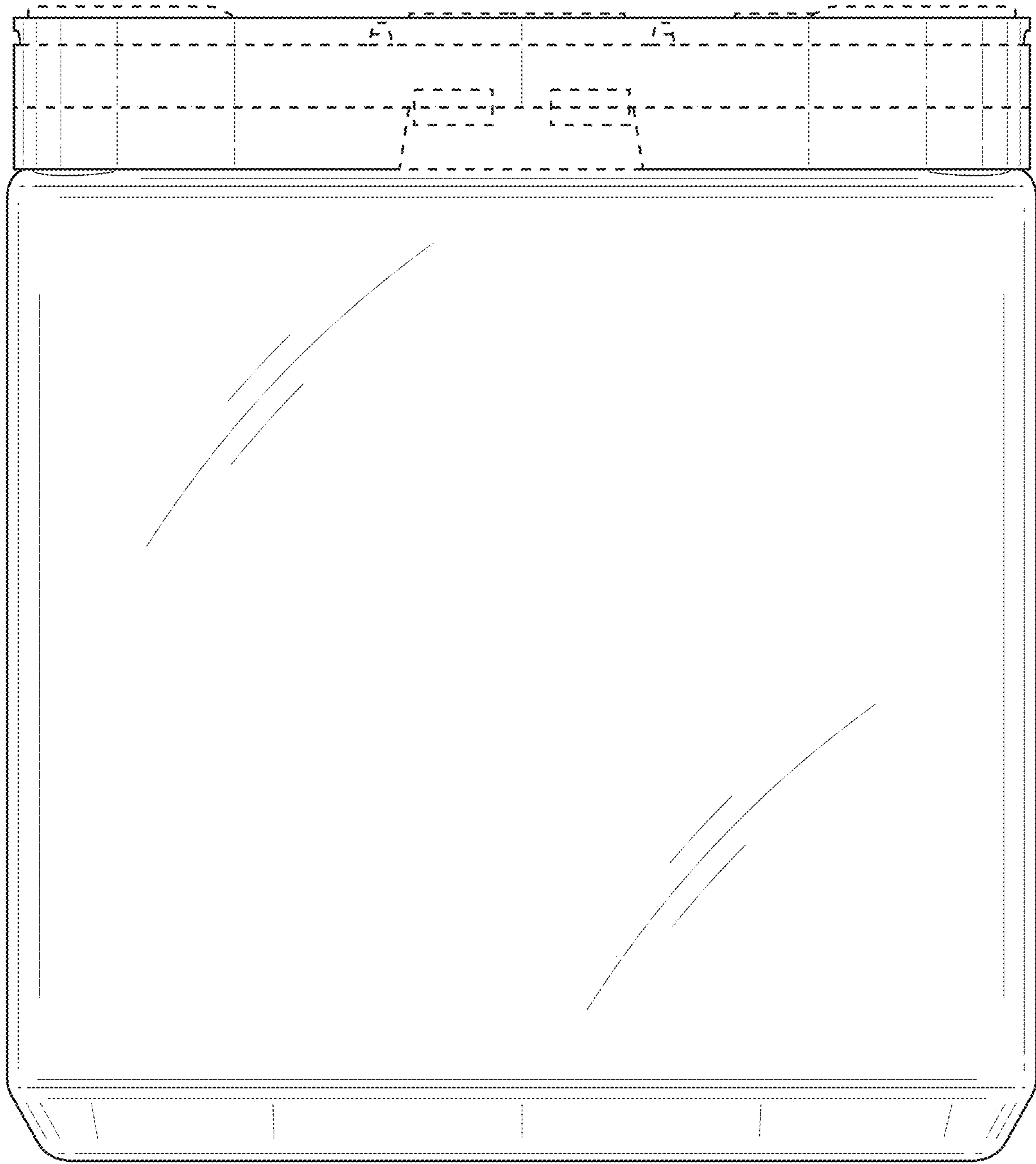

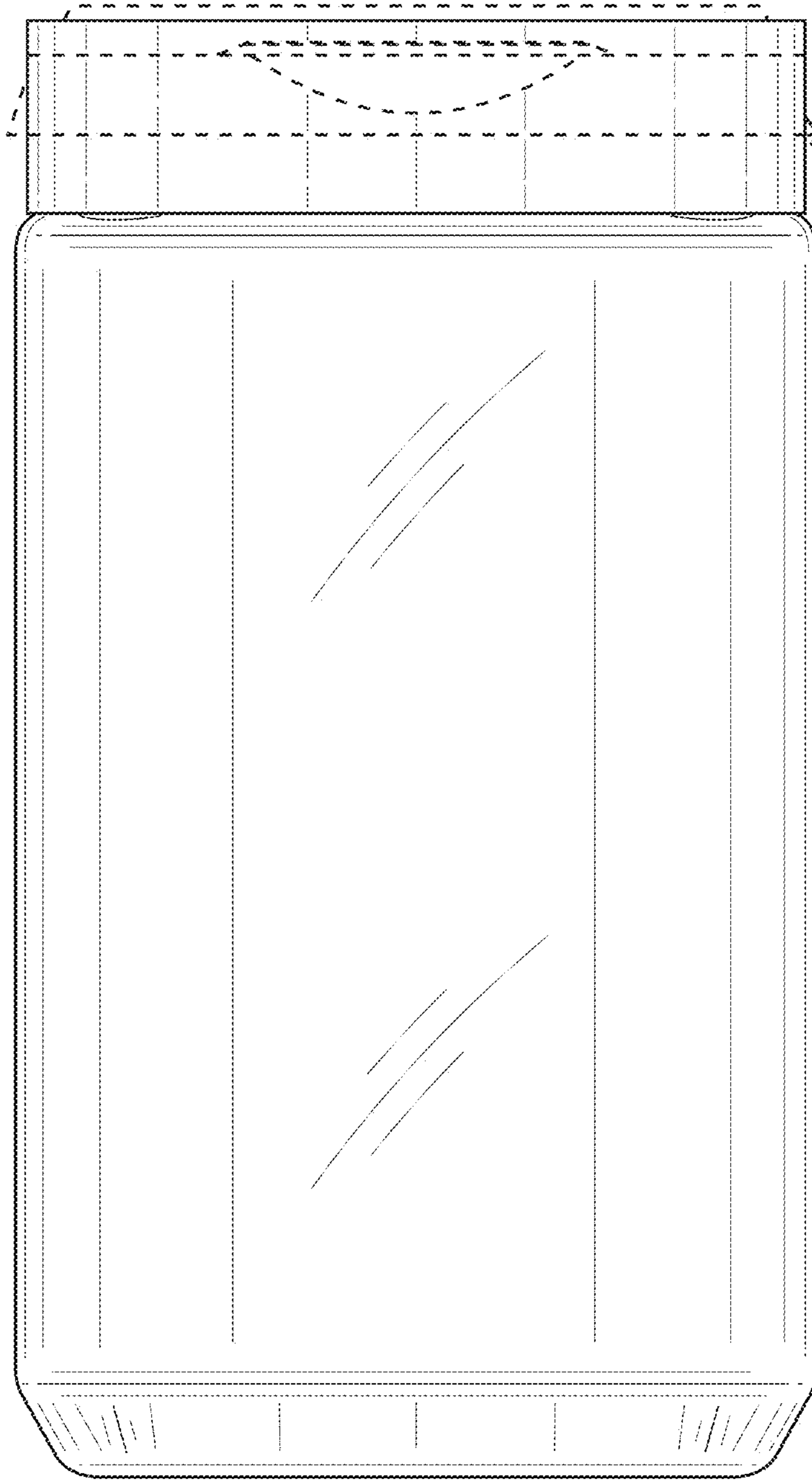

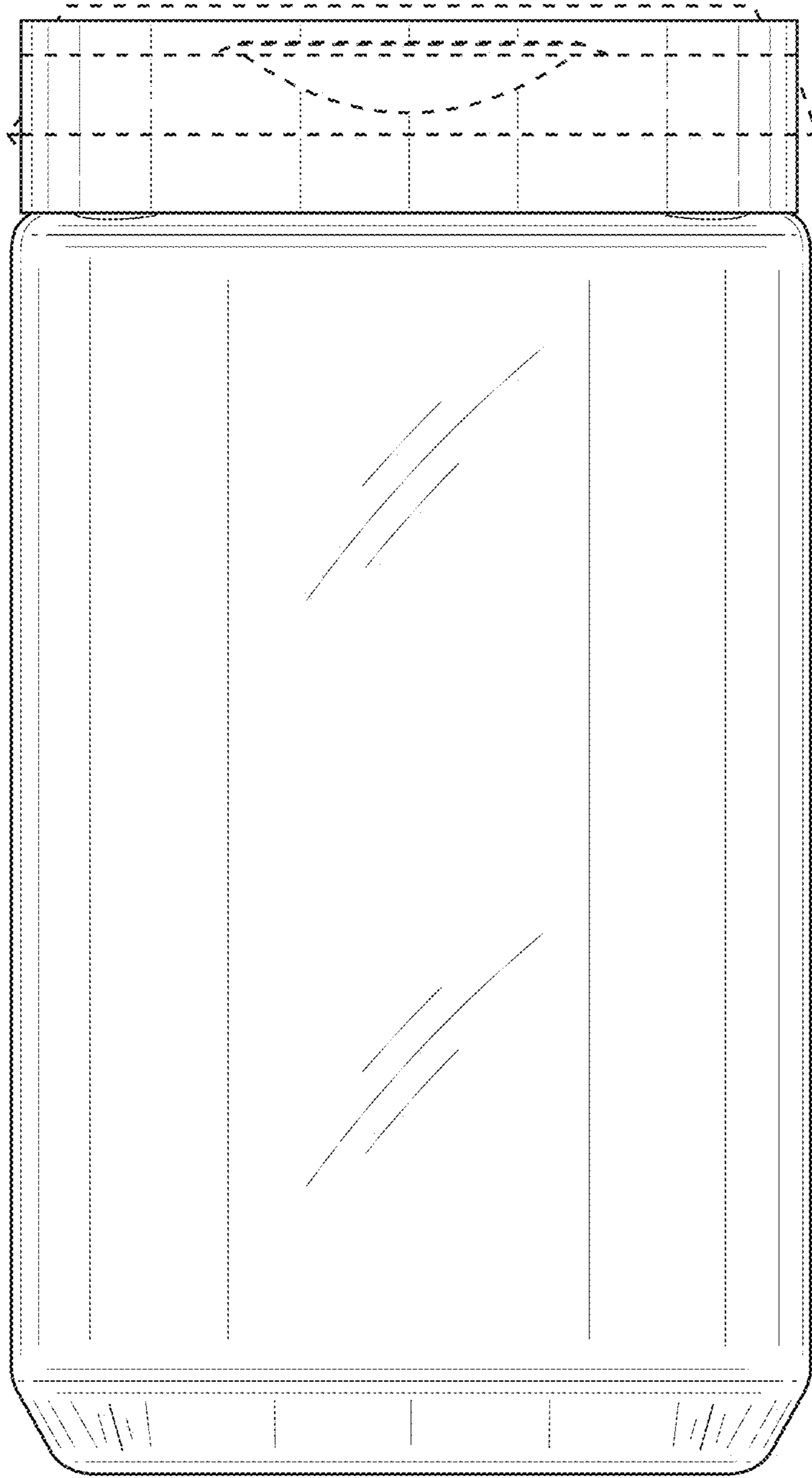

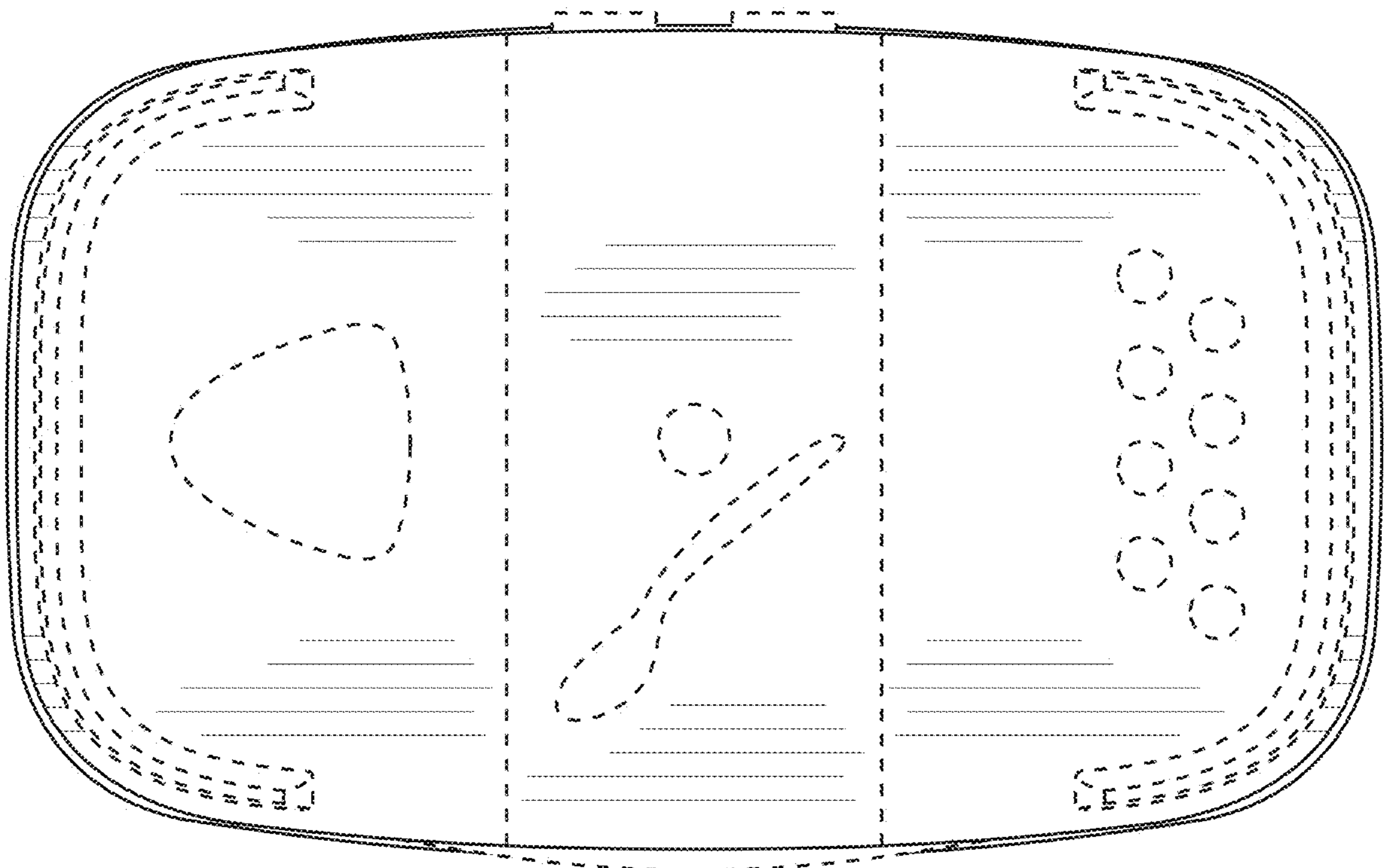
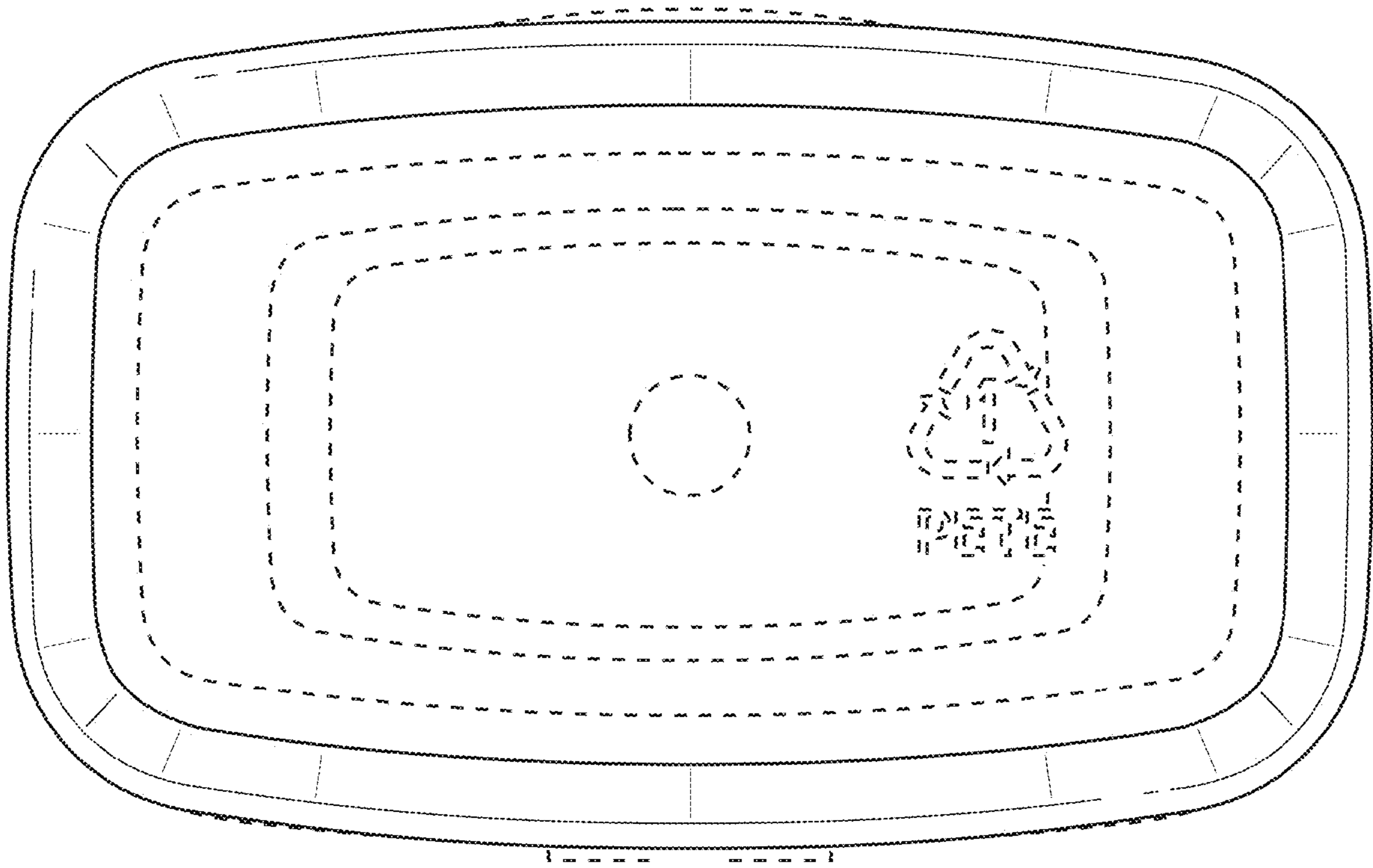
