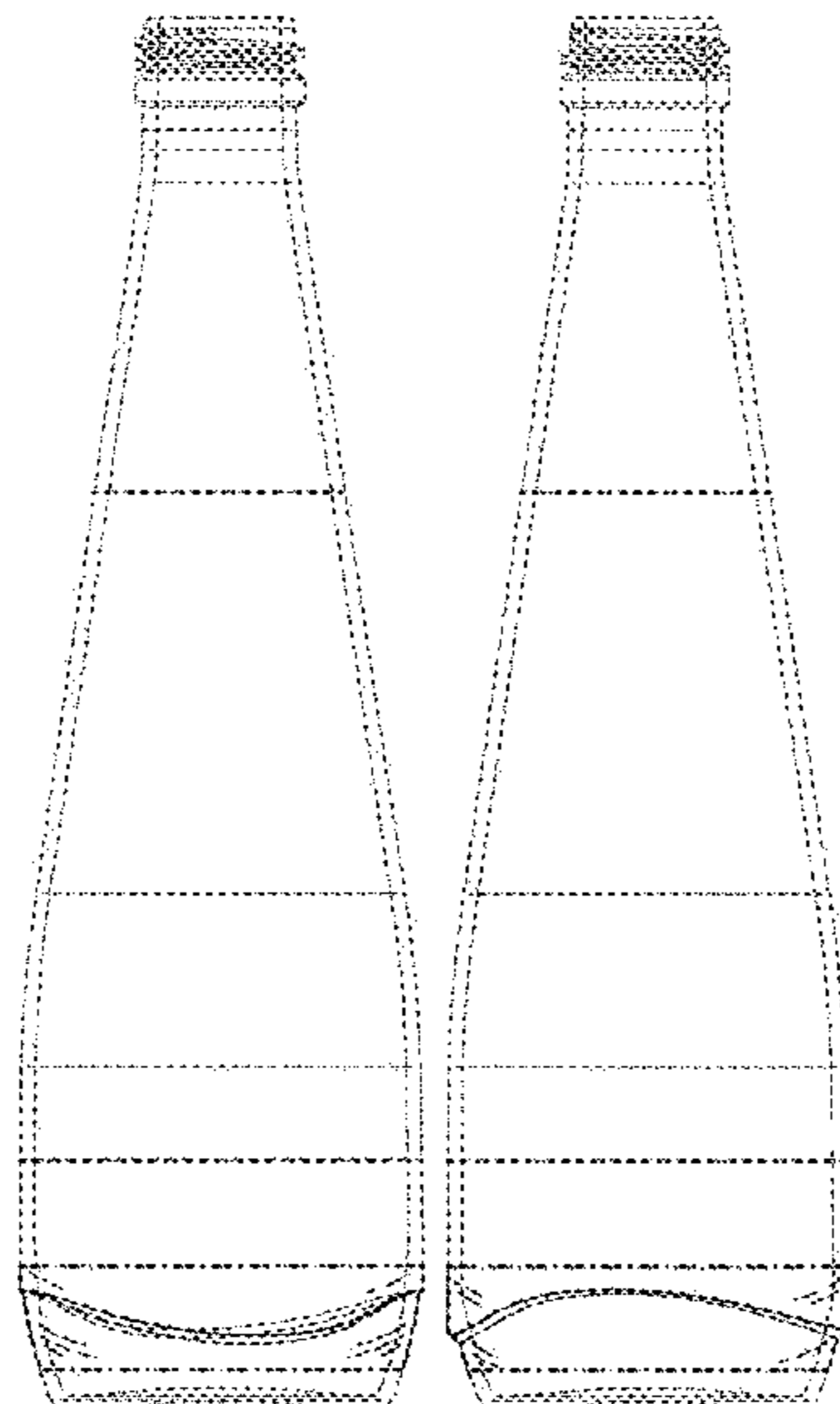
(57) **CLAIM**

We claim an ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is an upper perspective view of a container in accordance with our new claimed design.
 FIG. 2 is a front view of the container in FIG. 1.
 FIG. 3 is a right side view of the container in FIG. 1.
 FIG. 4 is a rear view of the container in FIG. 1.
 FIG. 5 is a left side view of the container in FIG. 1.
 FIG. 6 is a top view of the container in FIG. 1; and,
 FIG. 7 is a bottom view of the container in FIG. 1.
 Dash-dash broken lines shown in the drawings illustrate portions of the container that form no part of the claimed design.
 Dash-dot broken lines shown in the drawings represent boundaries of the claimed design and form no part of the claimed design.

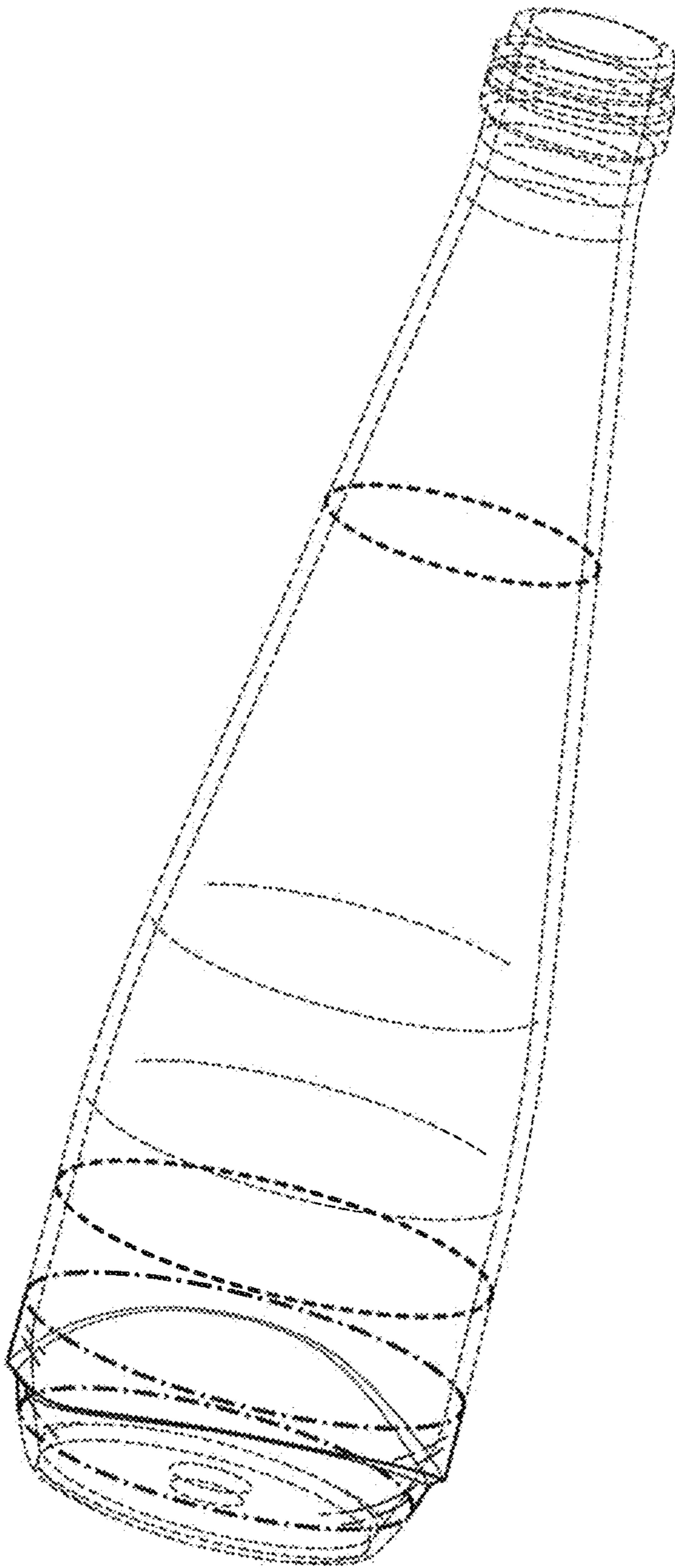

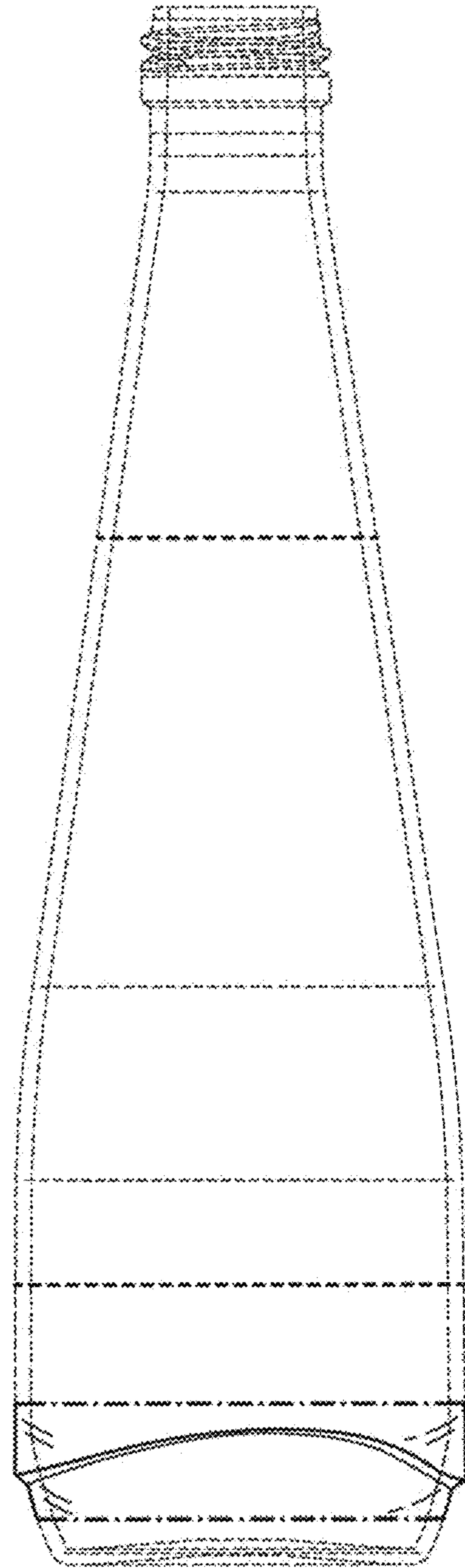

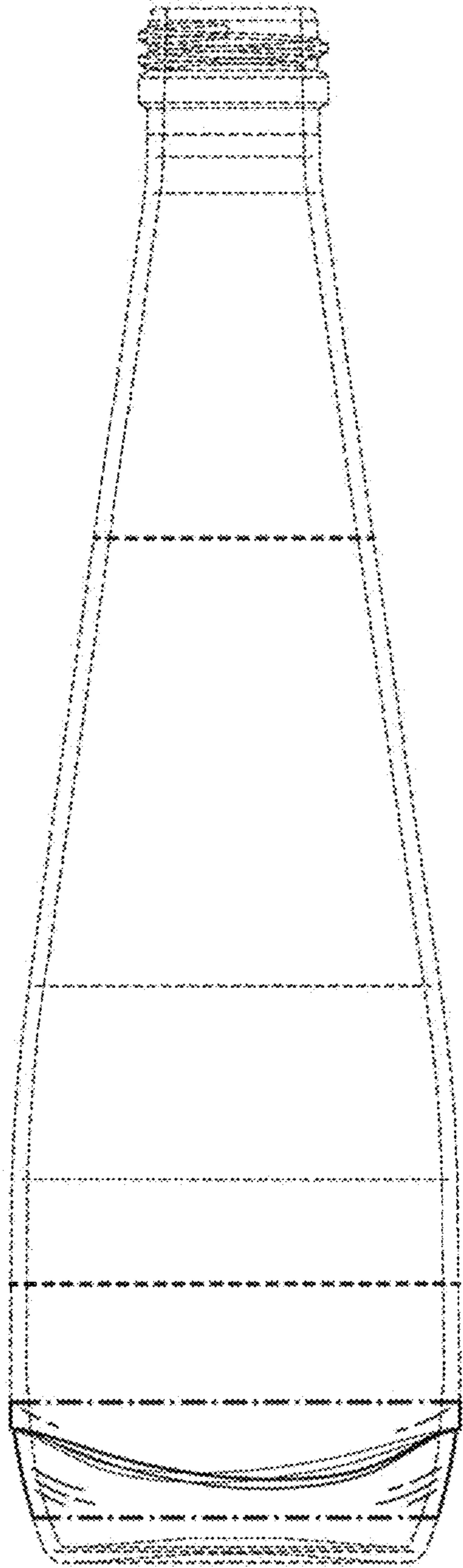

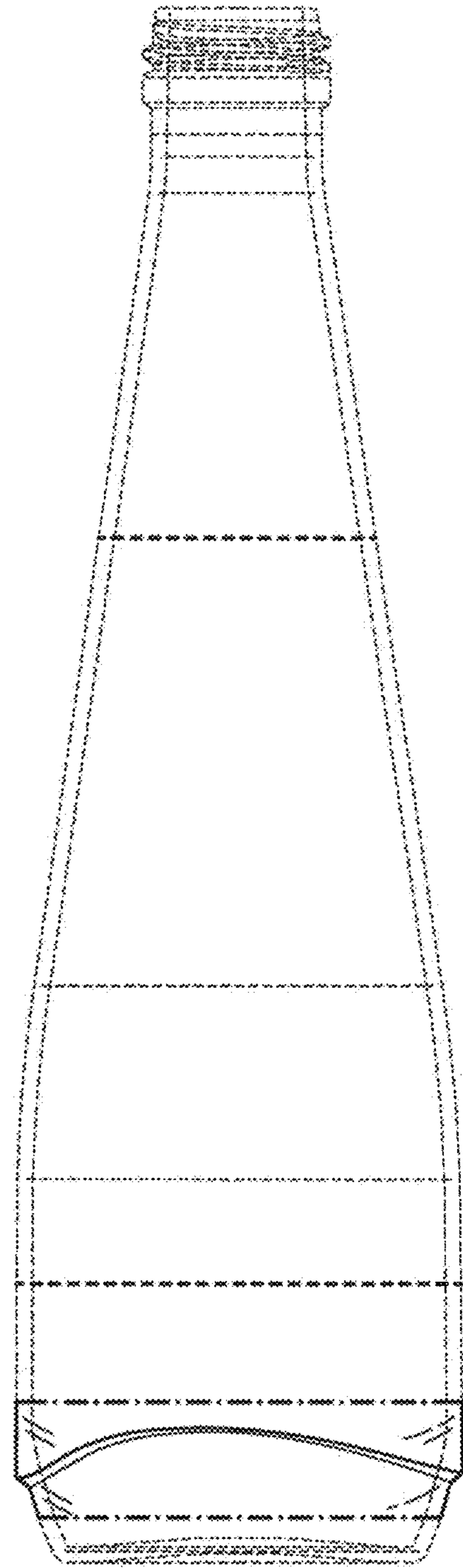

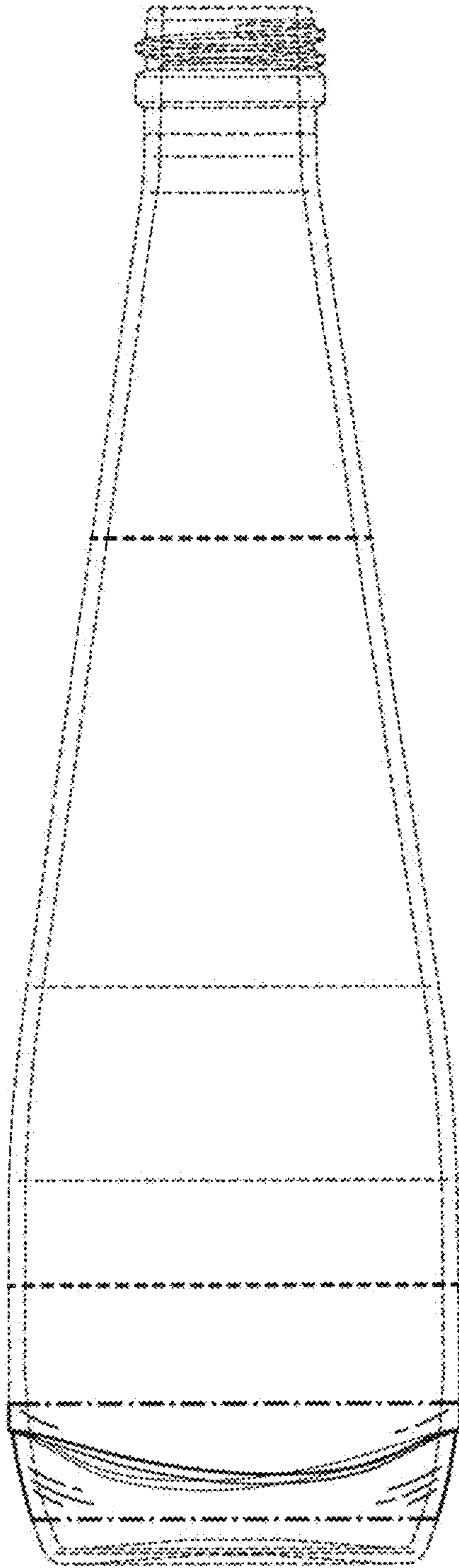

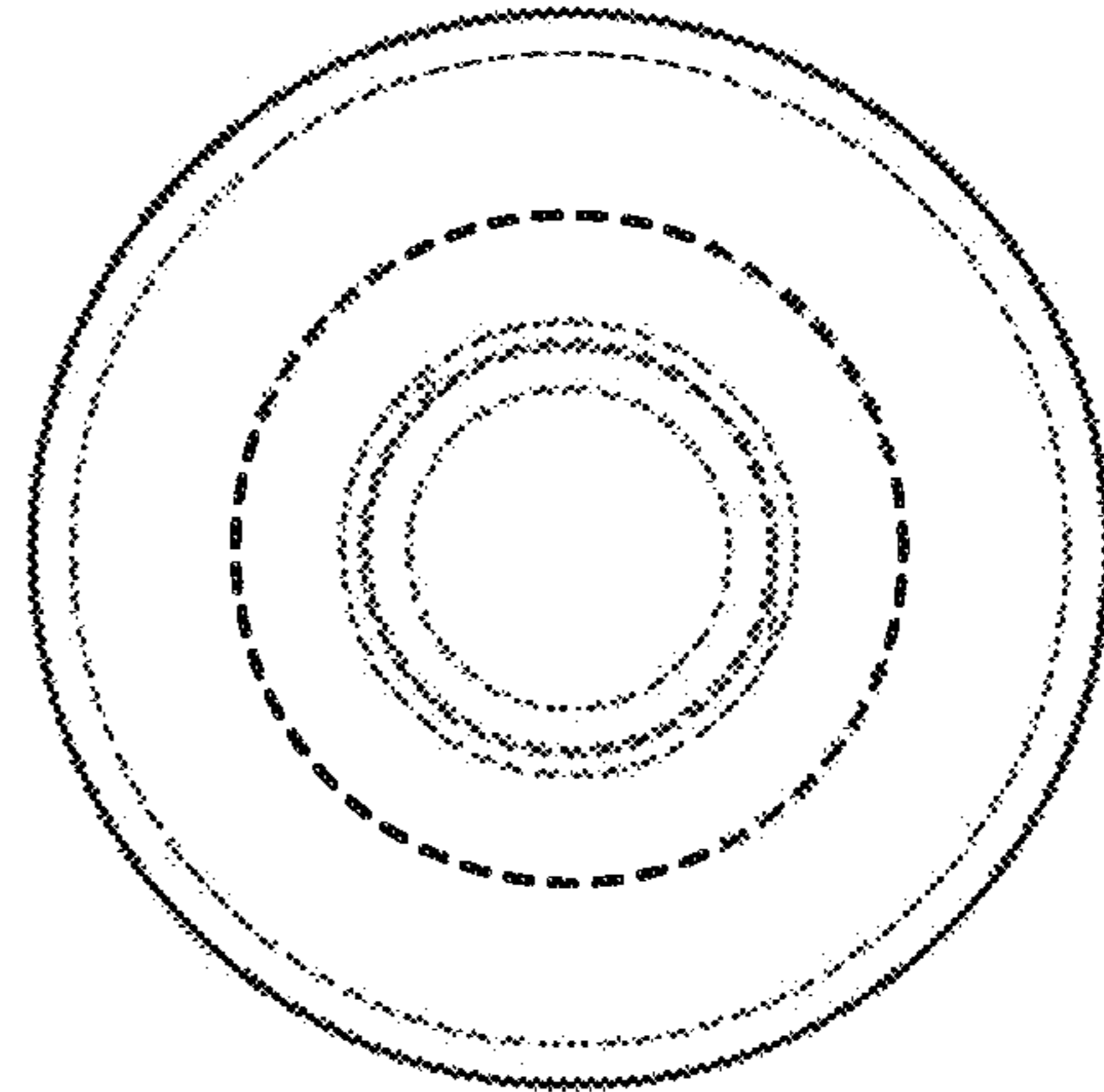

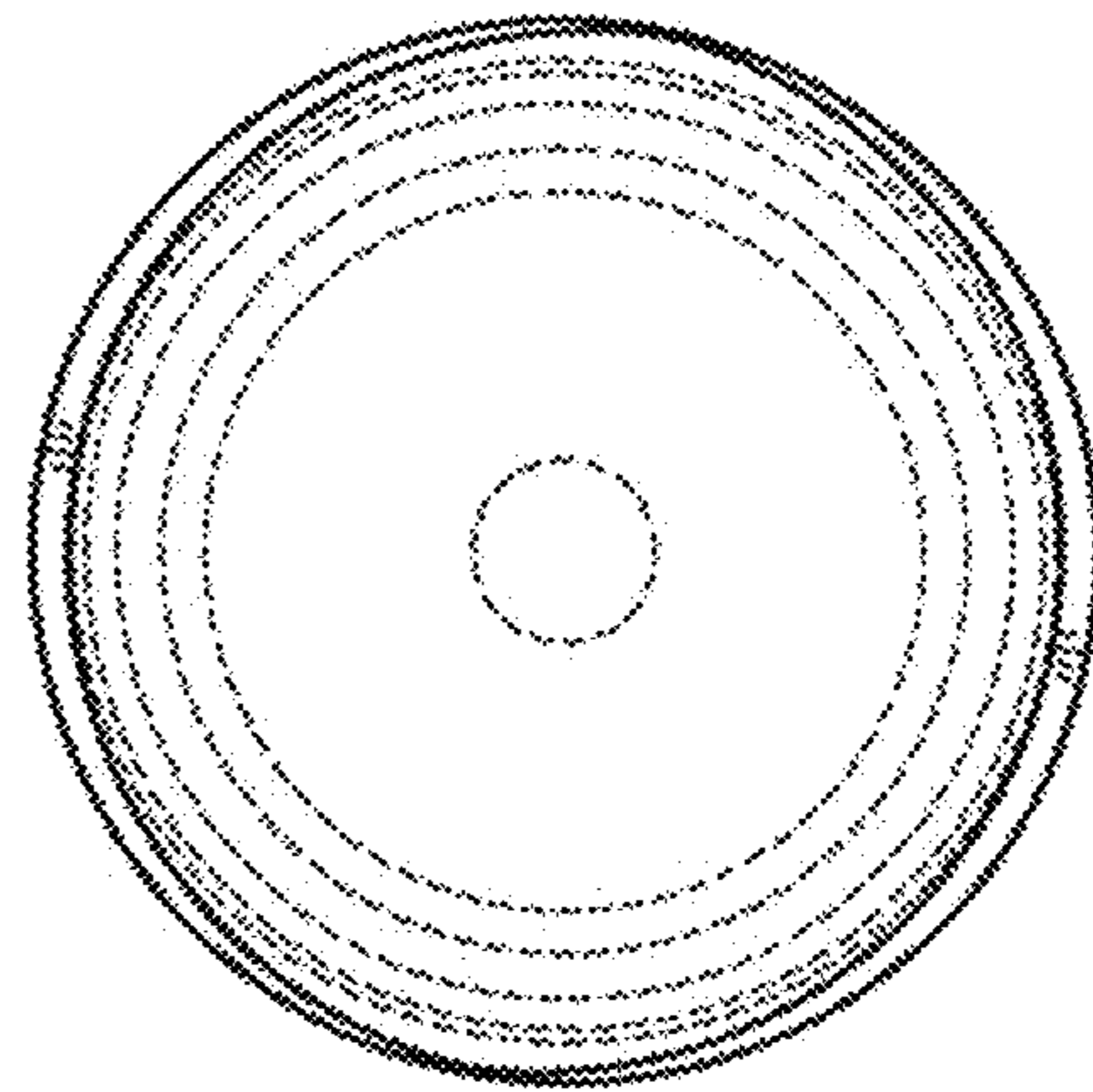
