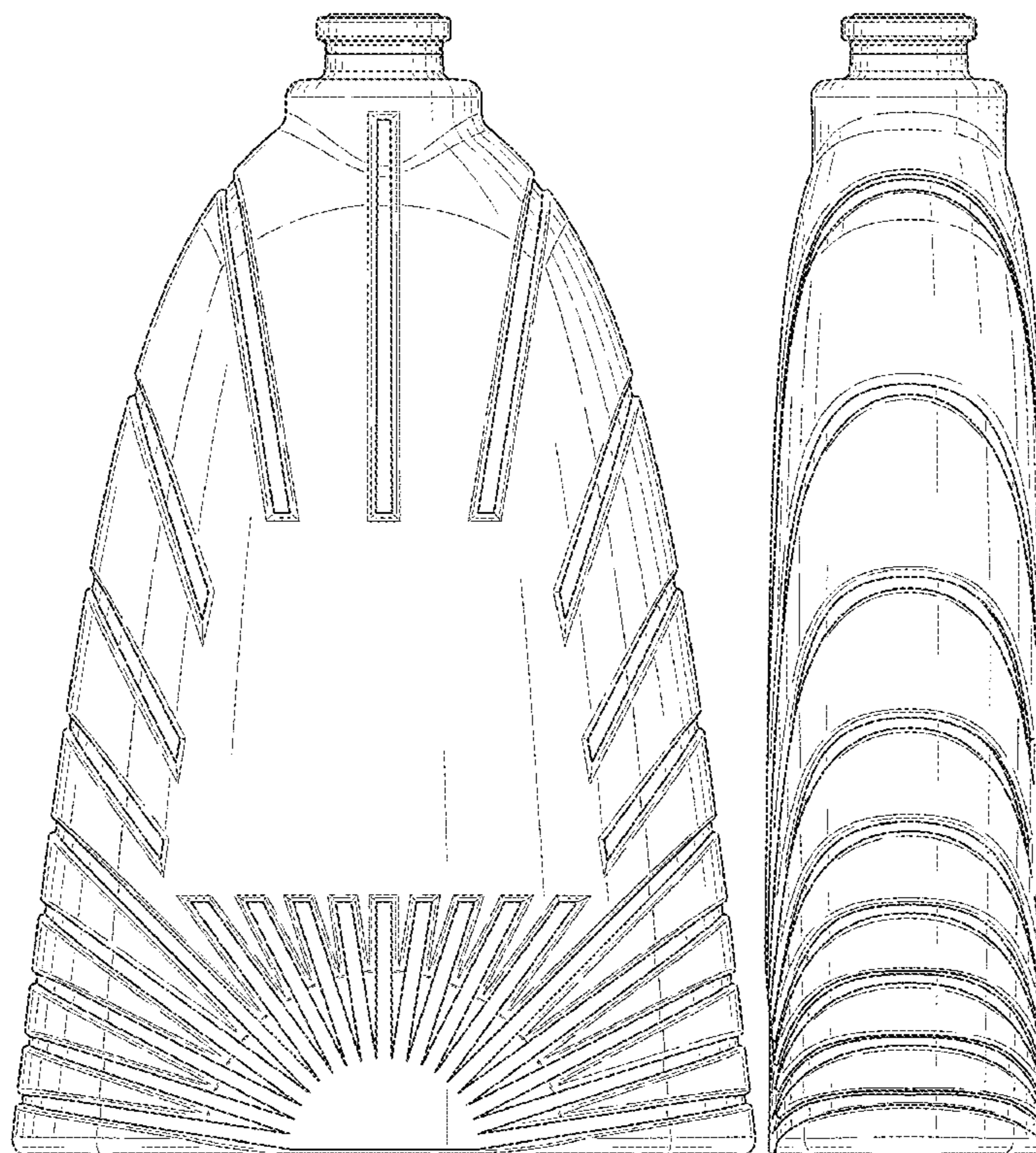
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the bottle;
FIG. 2 is a front elevational view of the bottle;
FIG. 3 is a rear elevational view of the bottle;
FIG. 4 is a right side elevational view of the bottle the
opposite side of which is a mirror image;
FIG. 5 is a top plan view of the bottle; and,

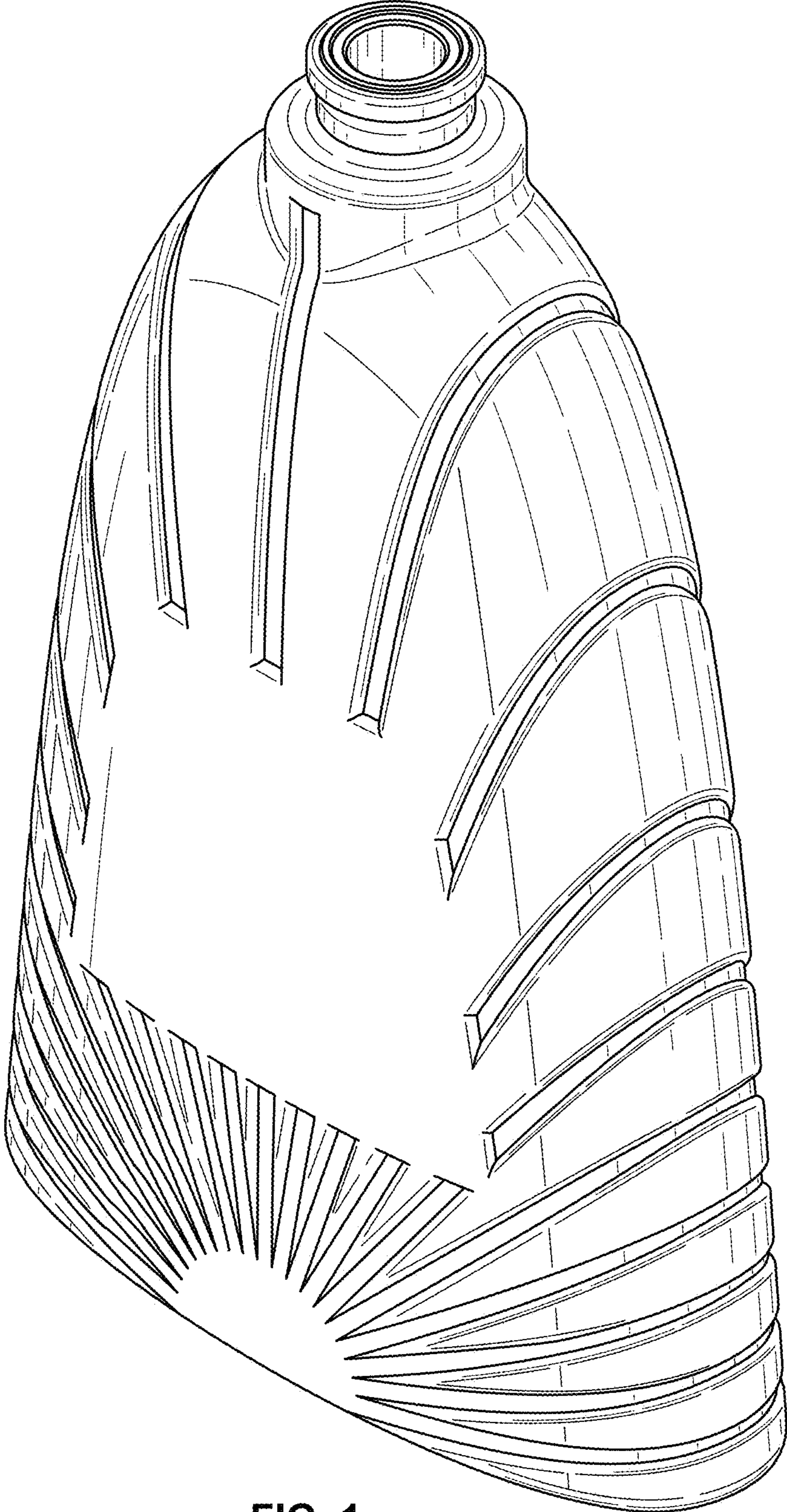

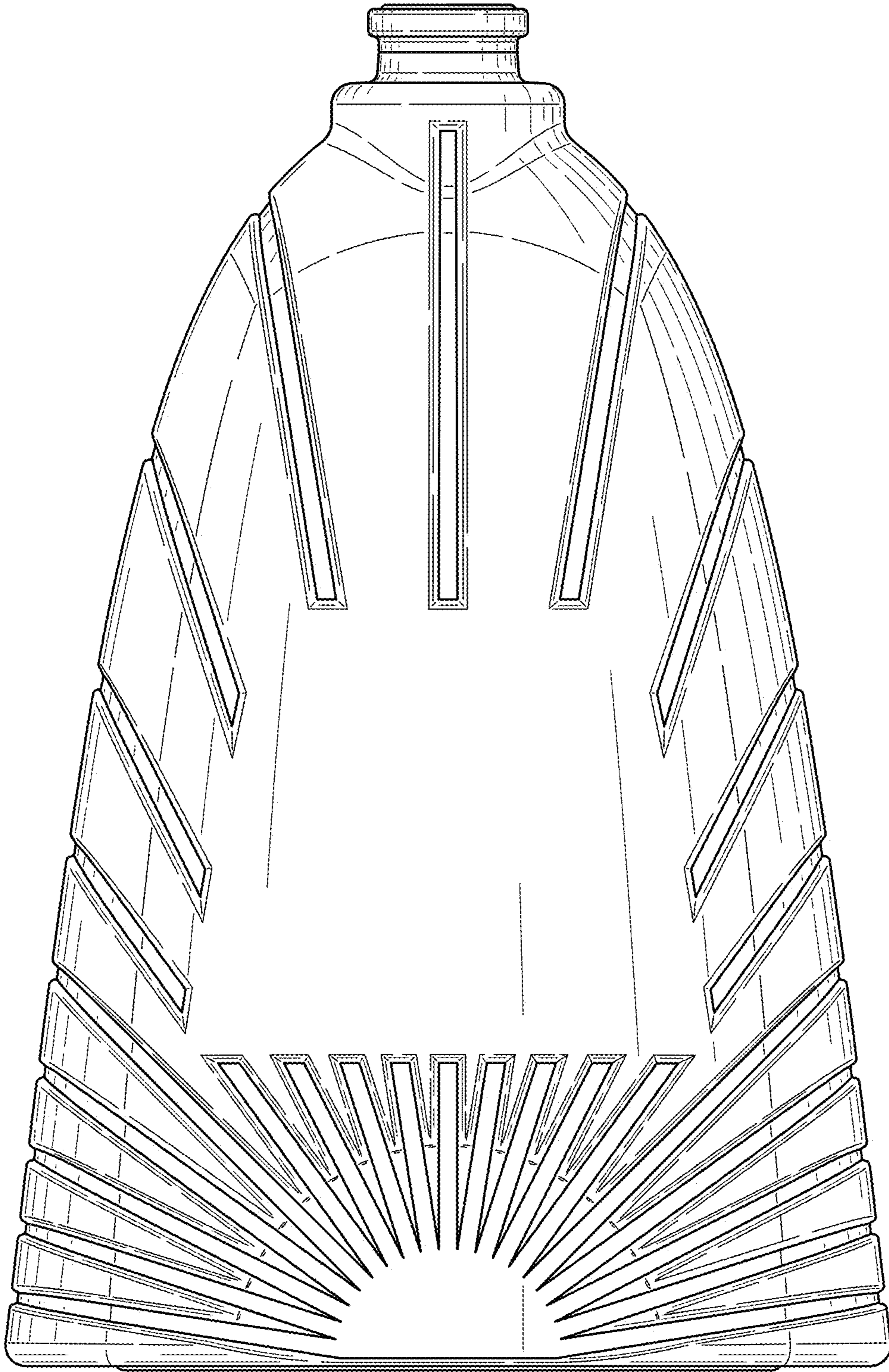

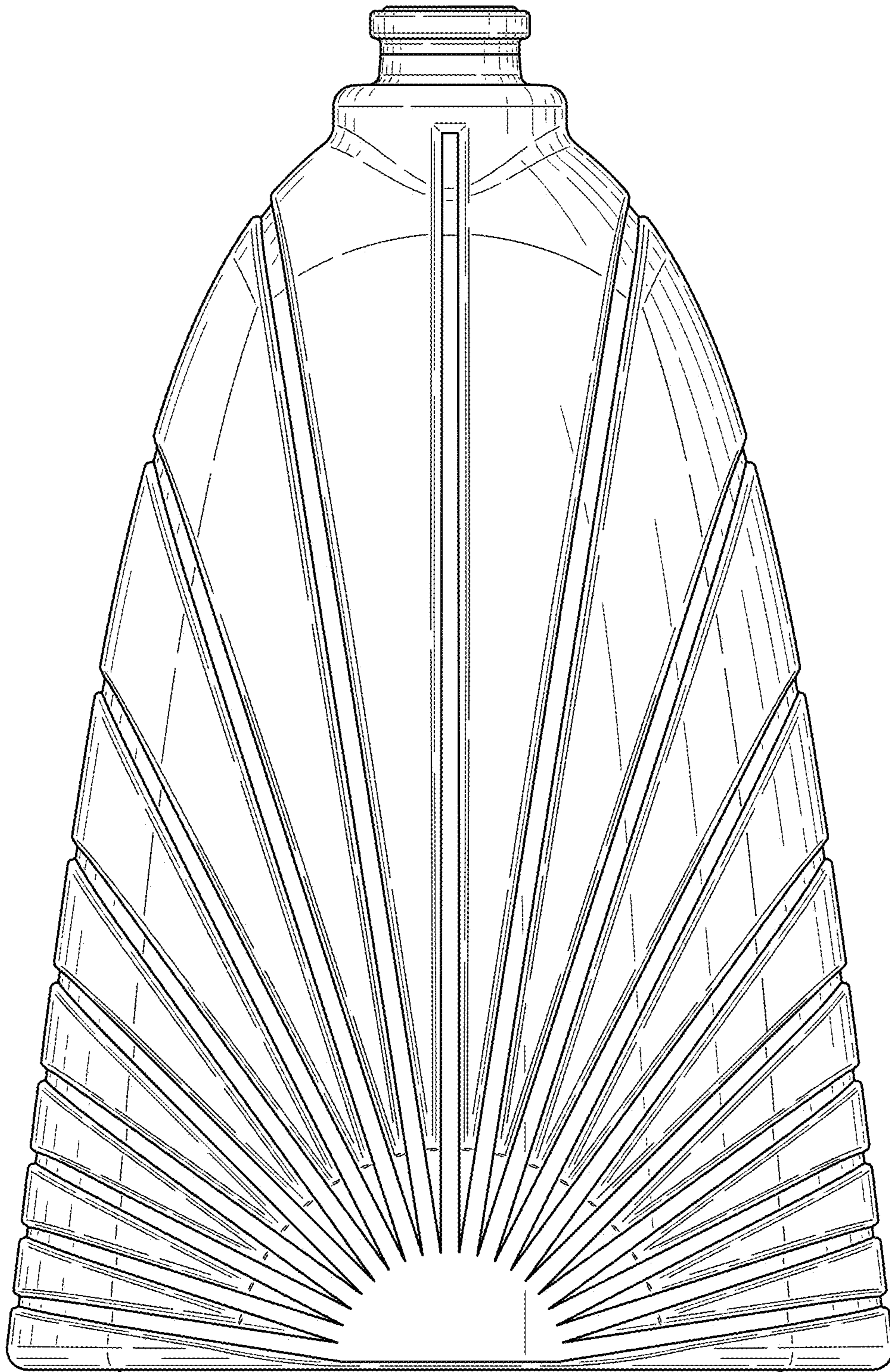

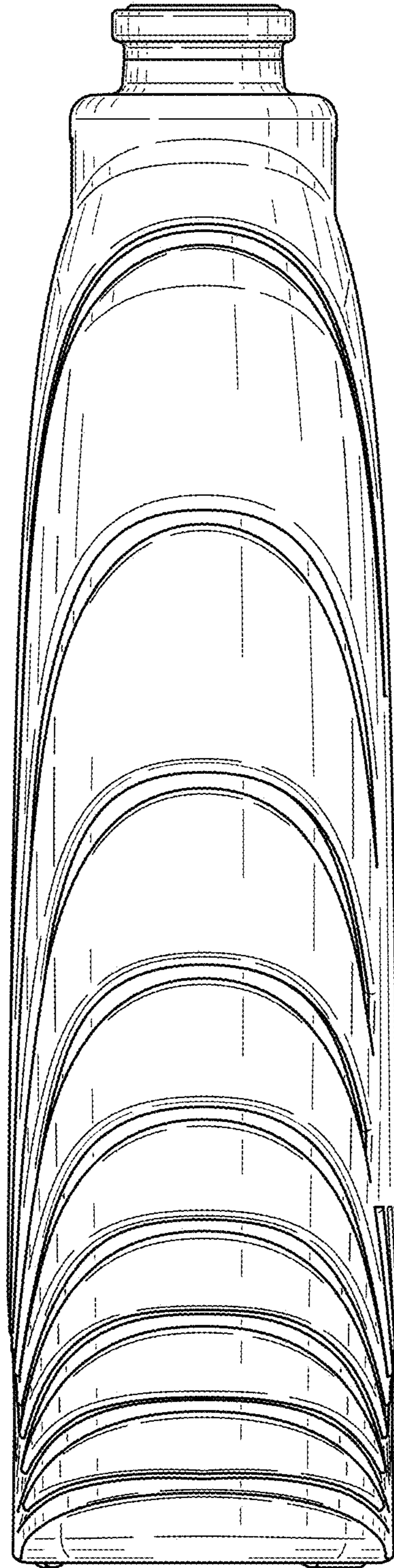

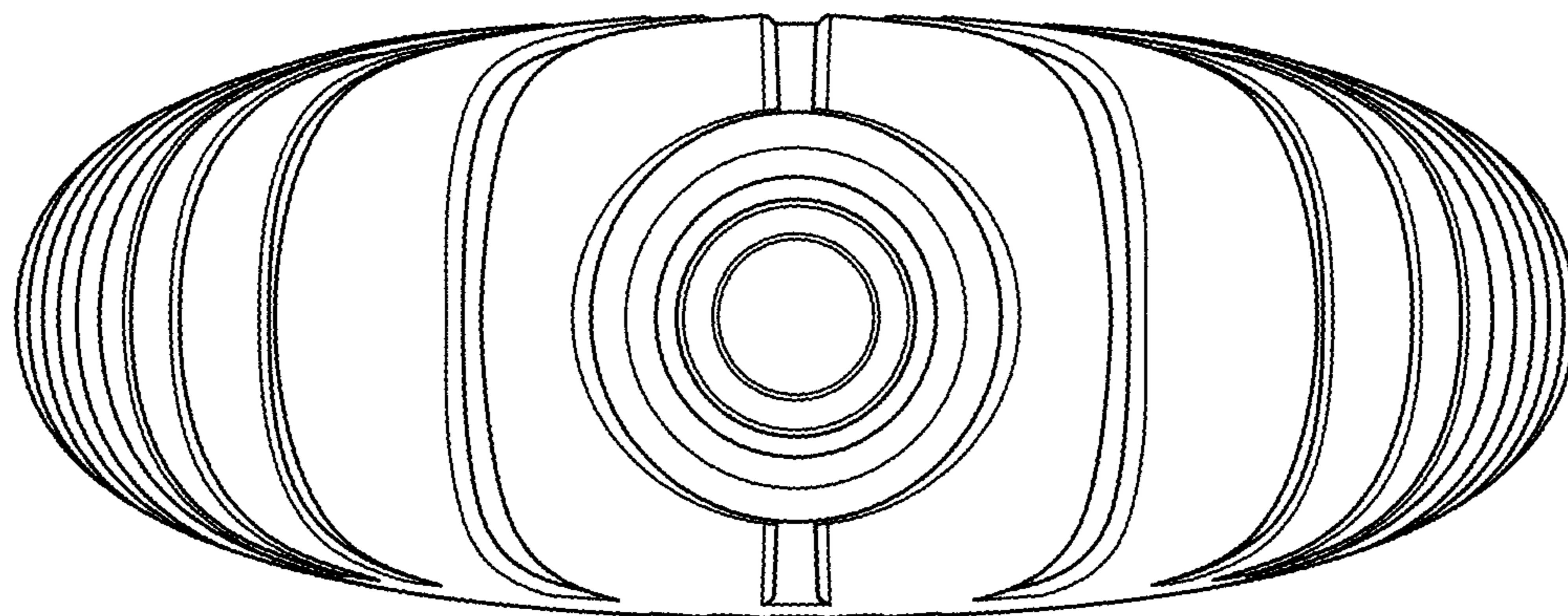

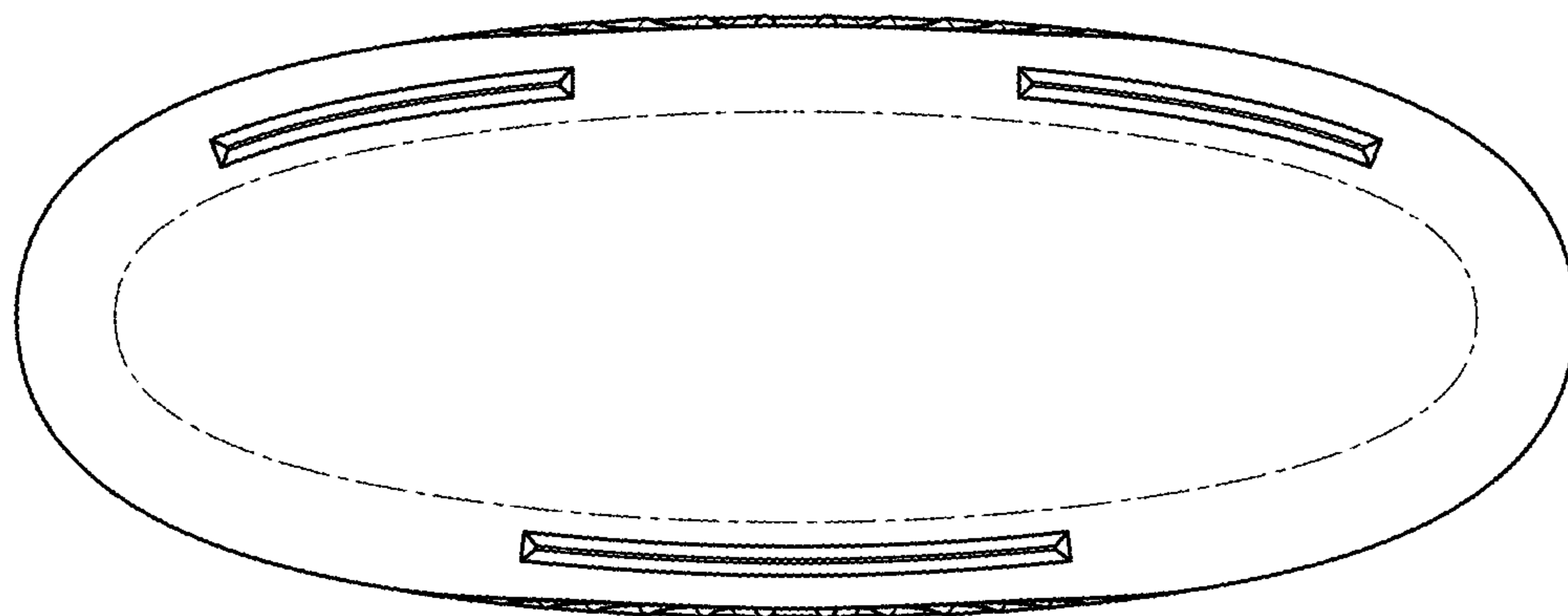
