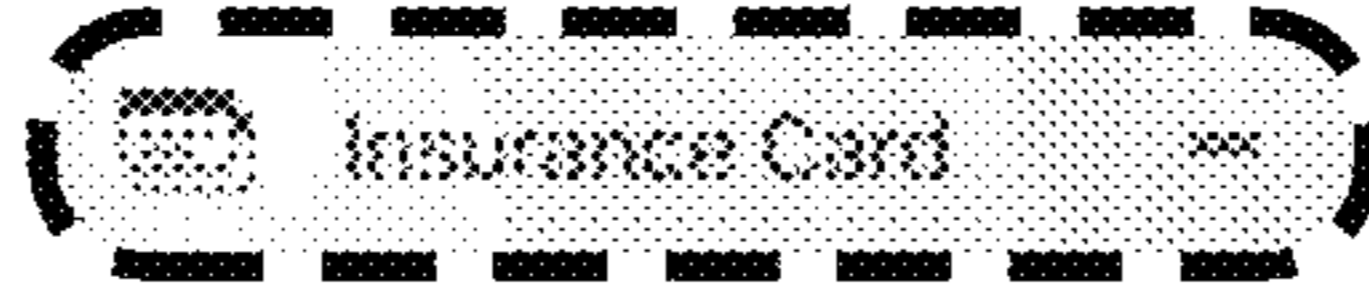
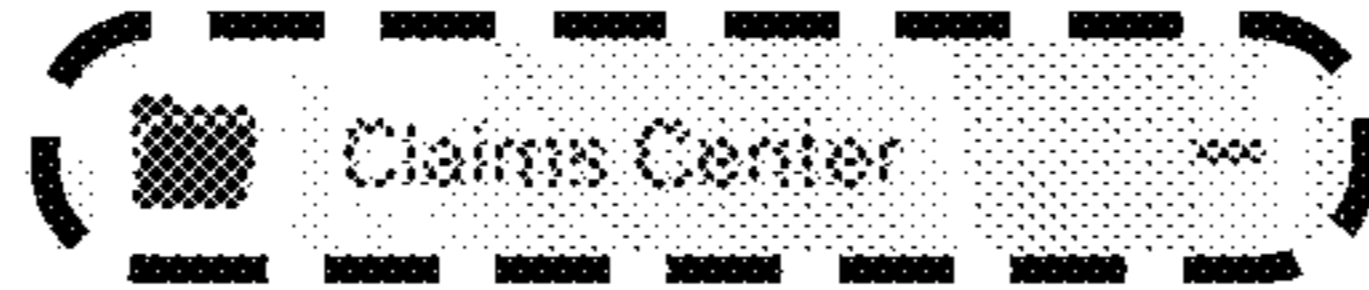
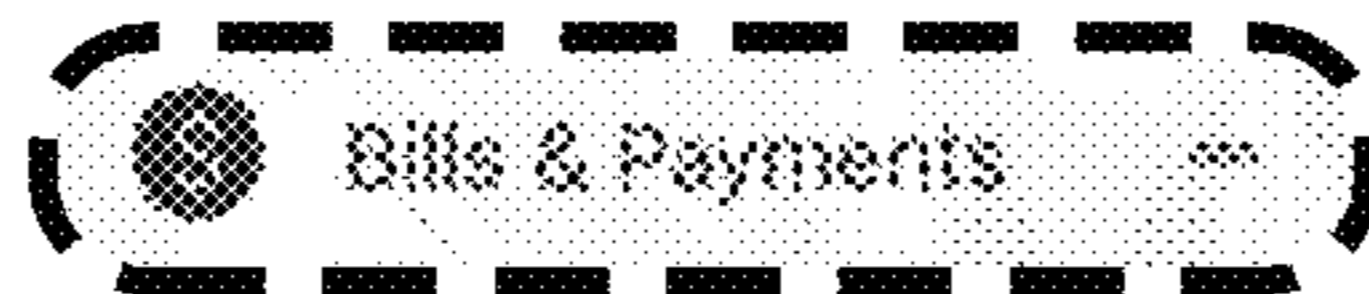
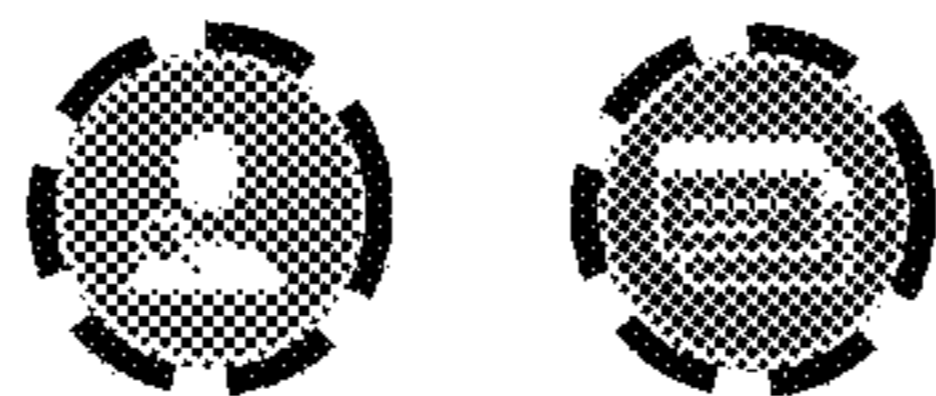
The claim is directed to the collective appearance of the set of graphical user interfaces shown.
