FIG. 8 is a rear, top left side perspective view thereof.

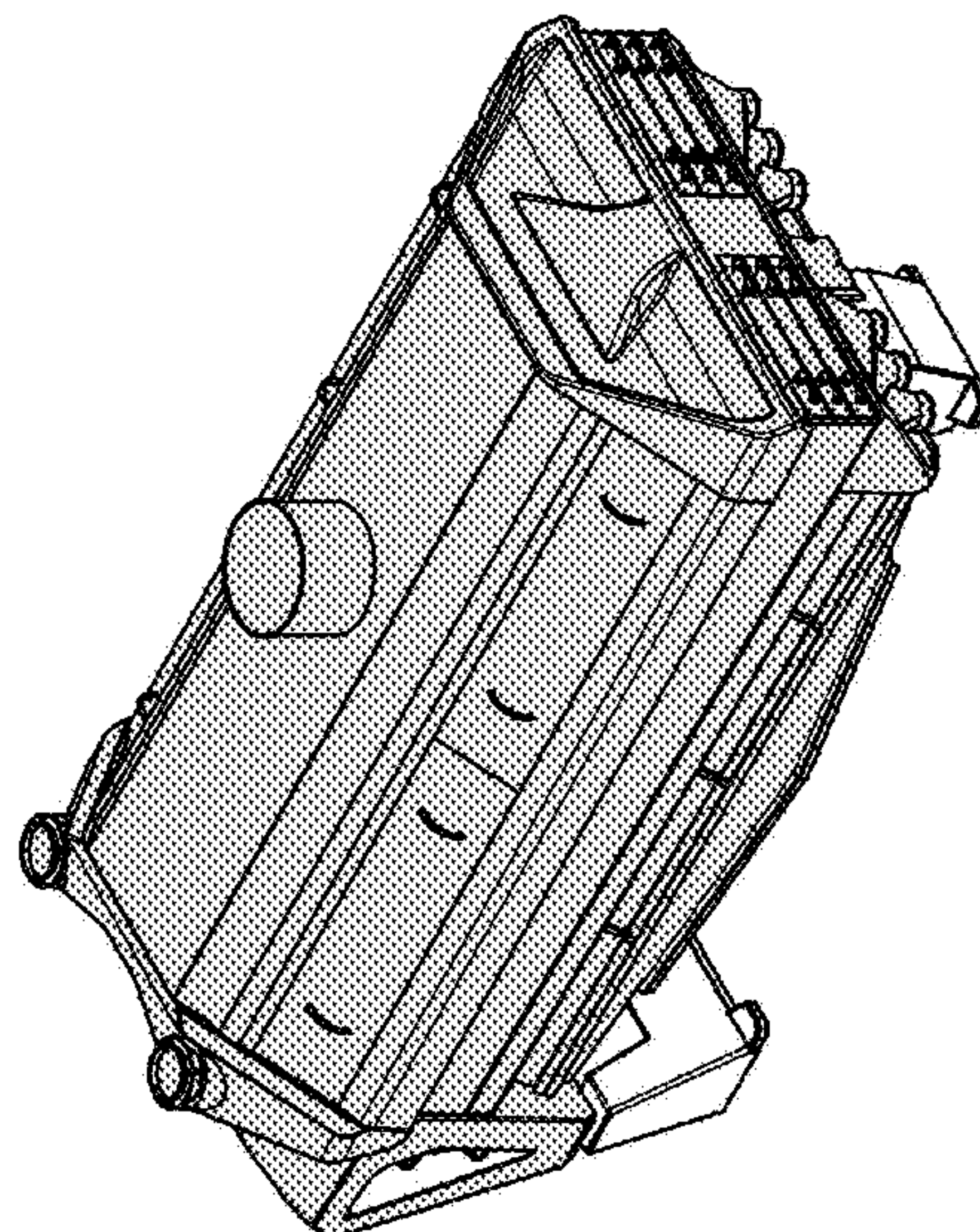

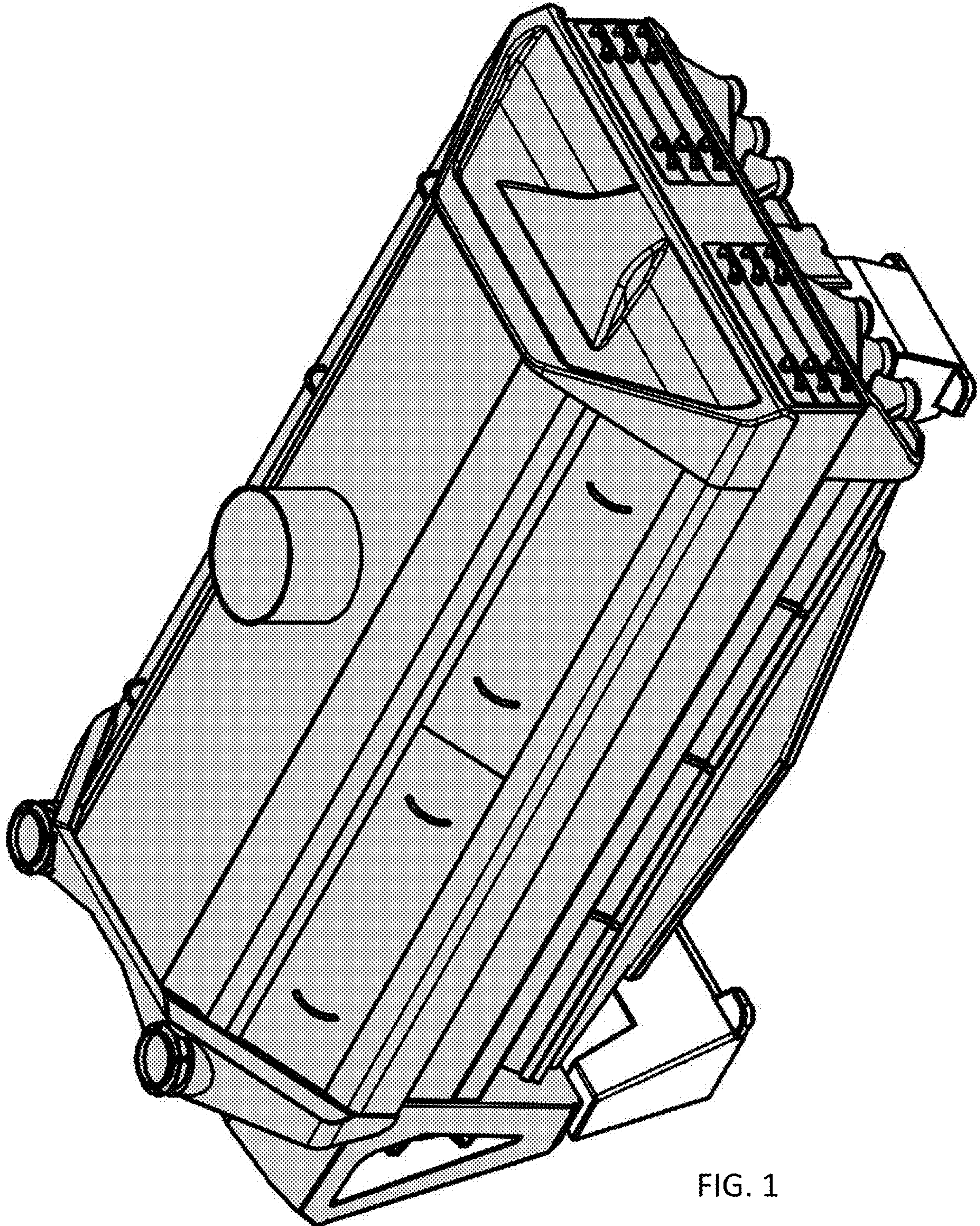

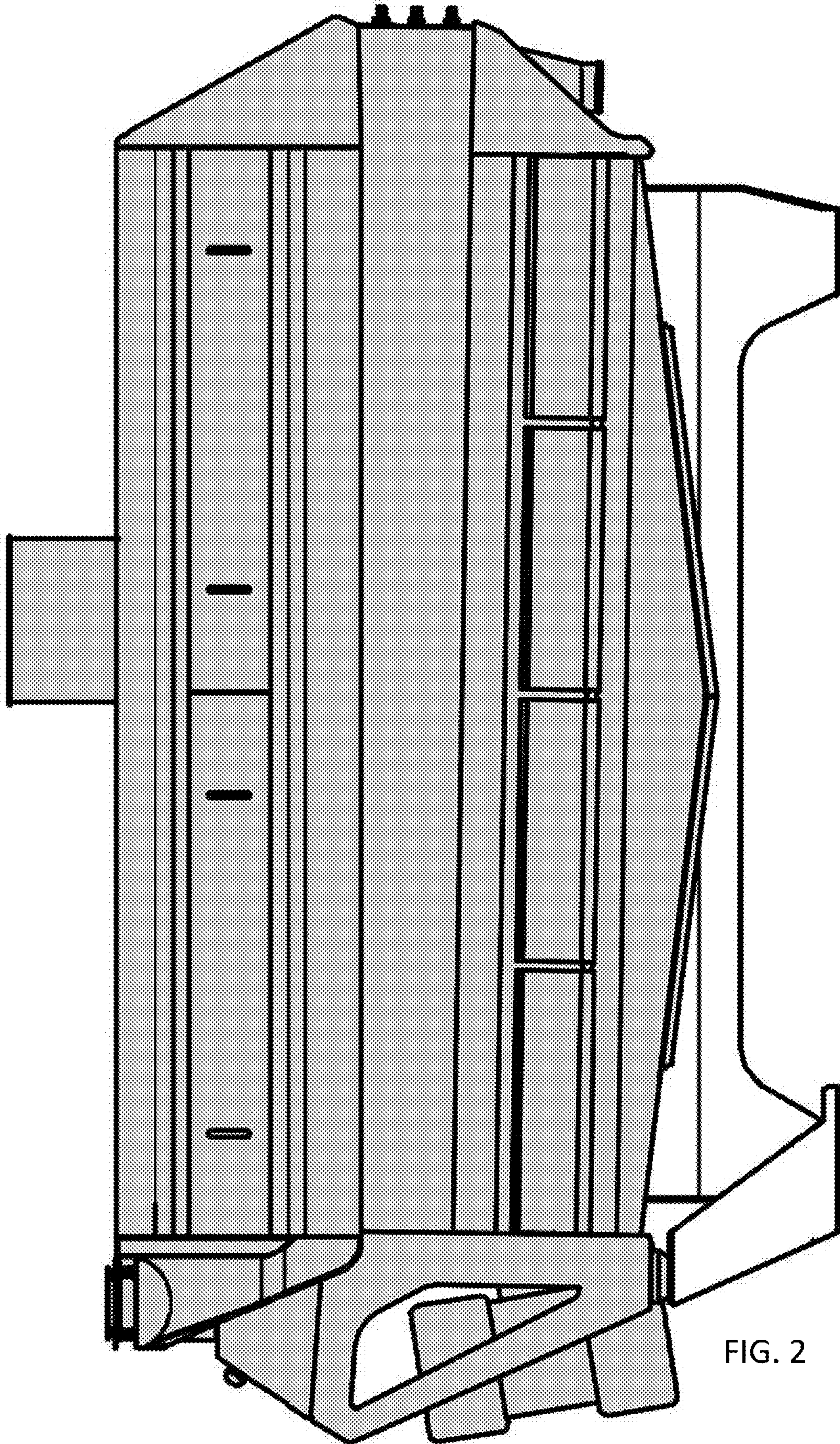

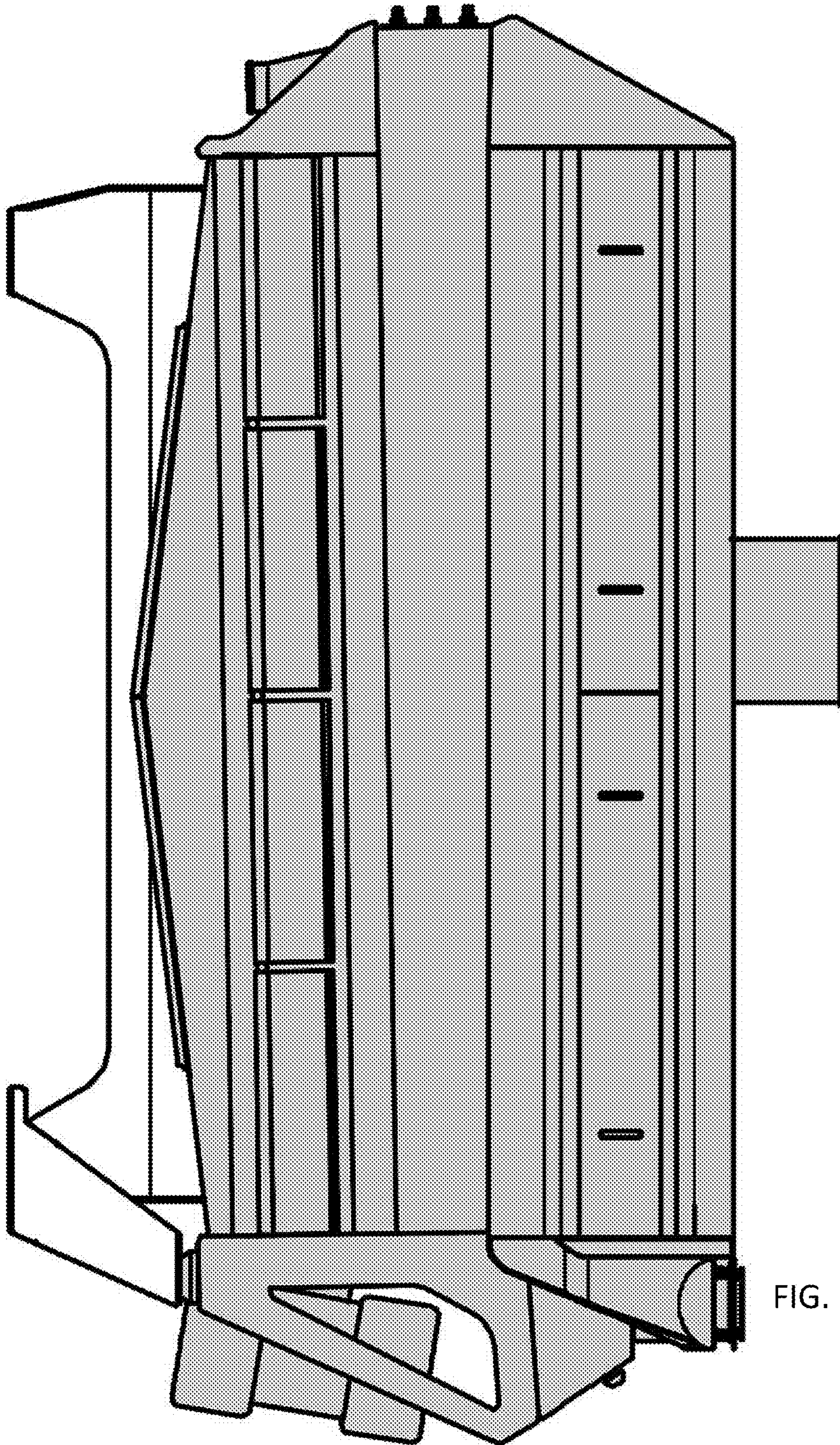

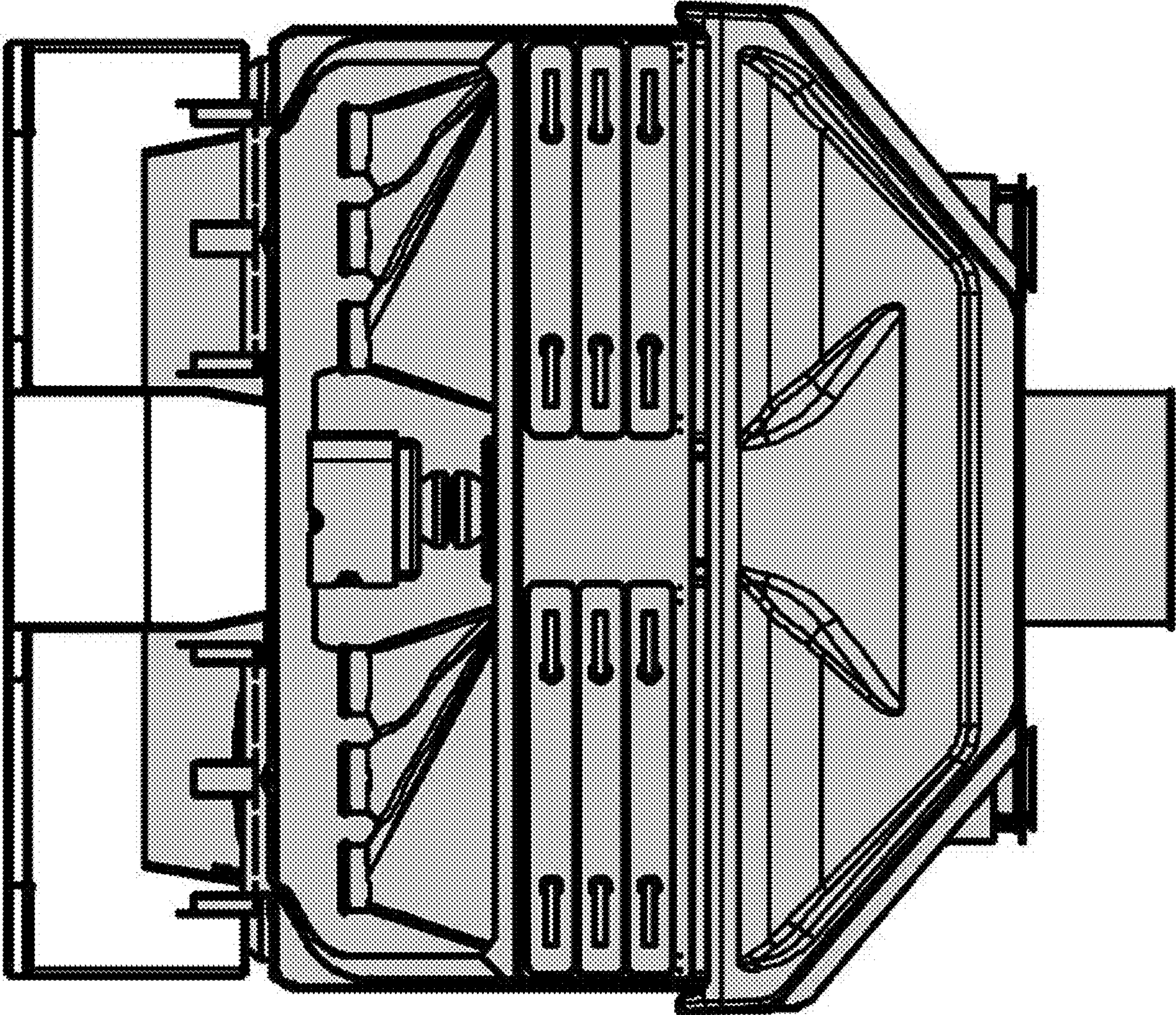

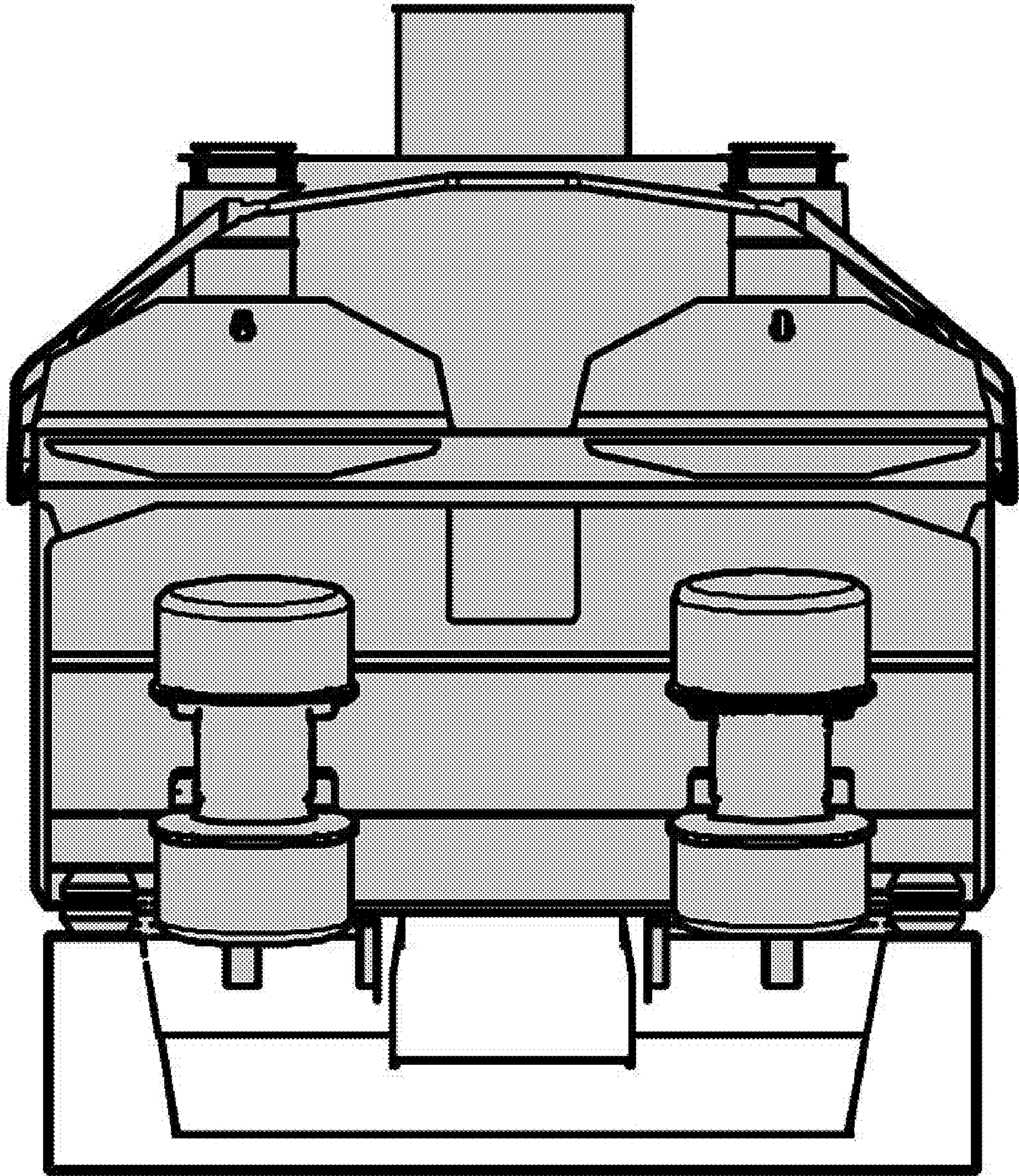

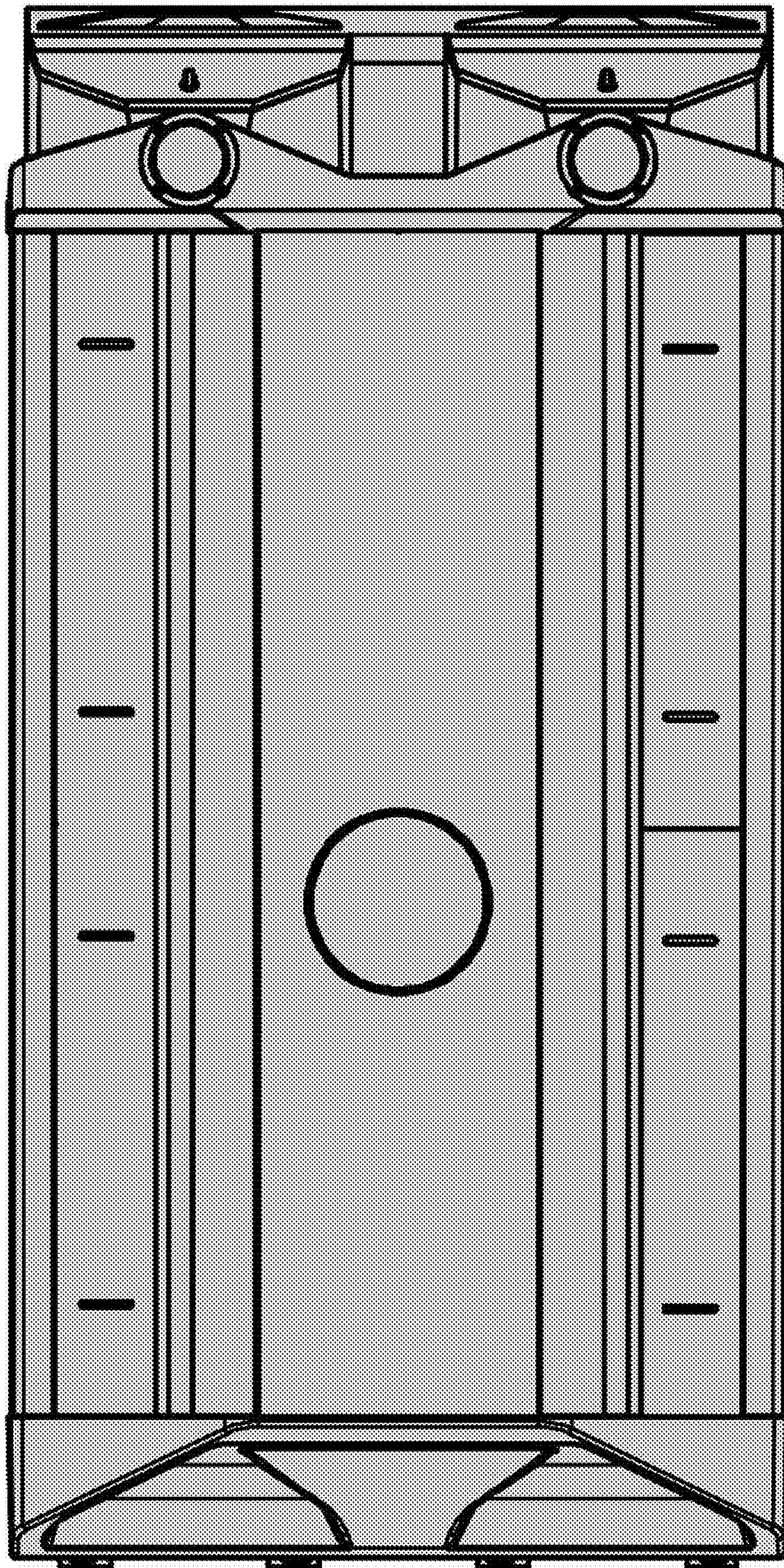

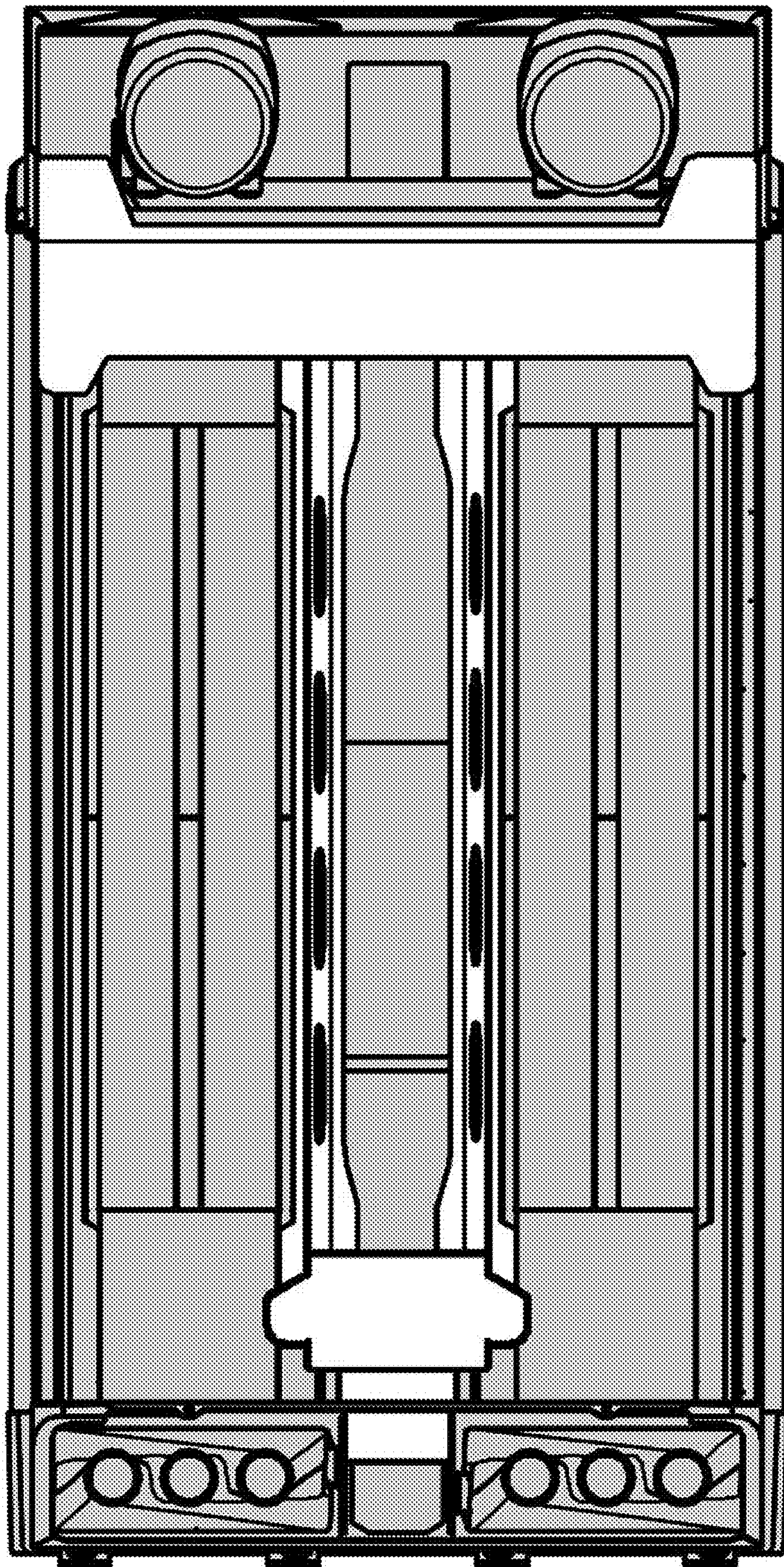

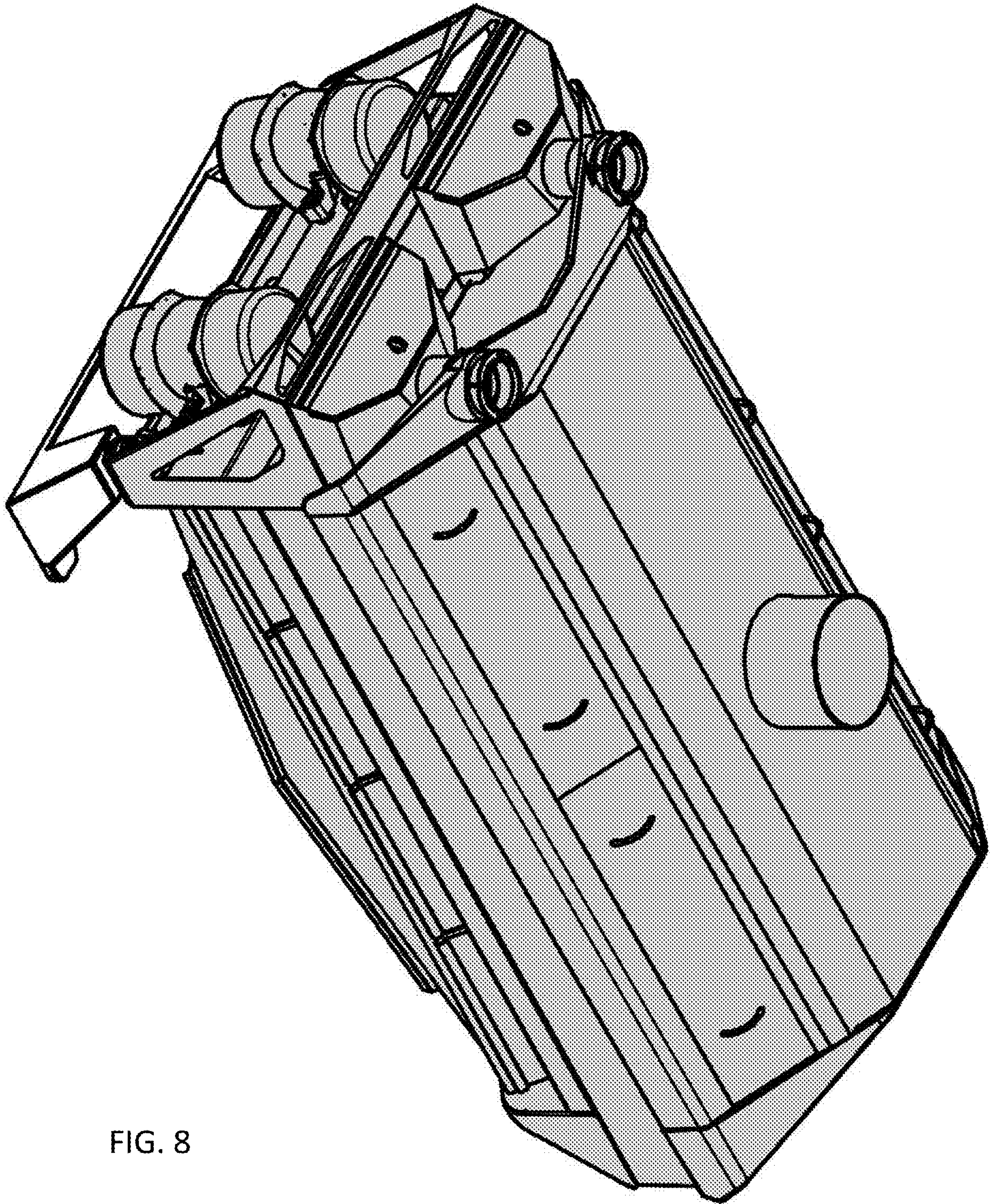
