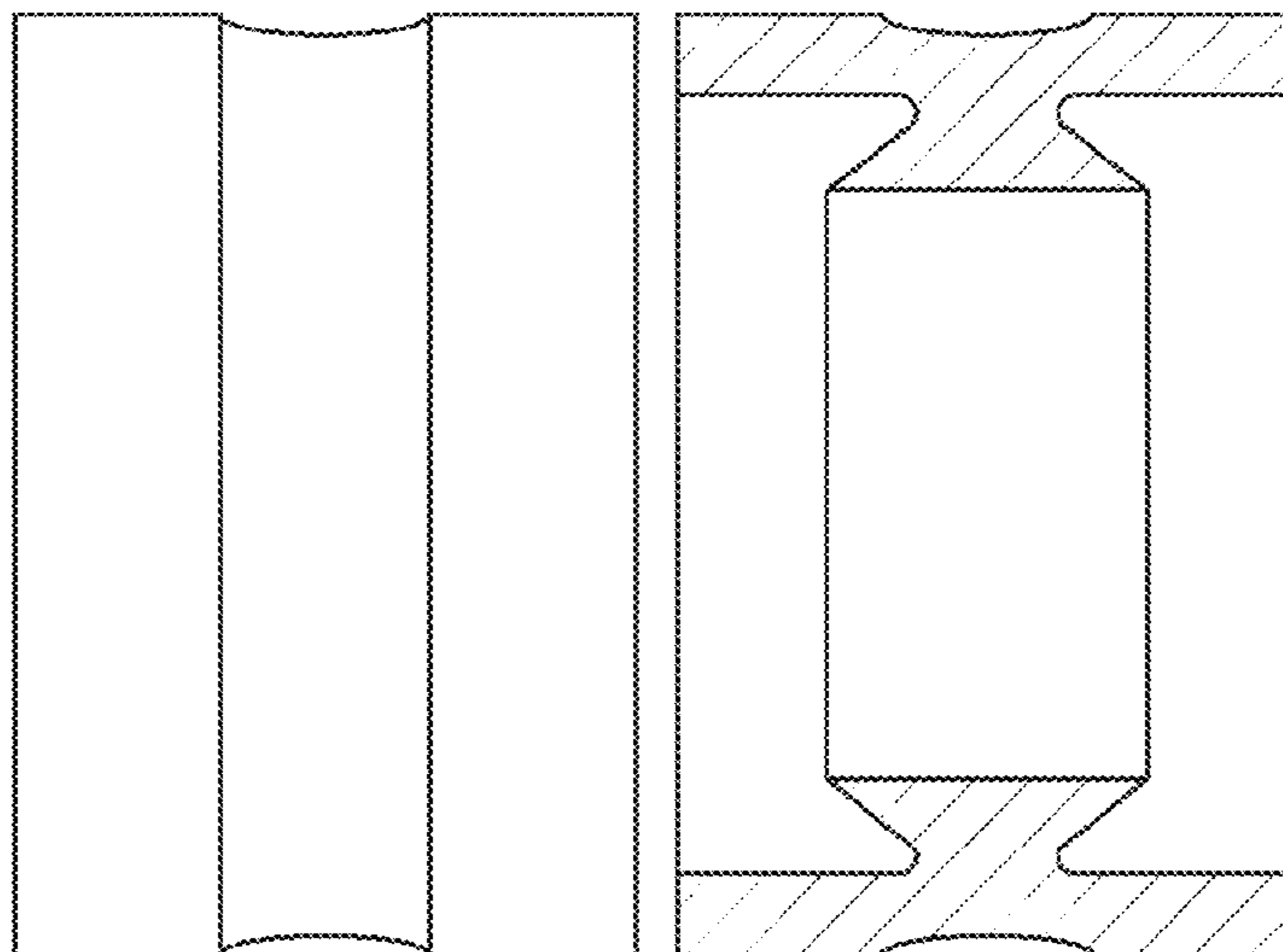
(57) **CLAIM**

The ornamental design for a gasket, as shown and described.

DESCRIPTION

FIG. 1 illustrates a front elevational view of a gasket showing our new design;
FIG. 2 illustrates a top plan view thereof;
FIG. 3 illustrates a side elevational view thereof;
FIG. 4 illustrates a cross-sectional view of the gasket taken along line 4-4 in FIG. 1;
FIG. 5 illustrates a front perspective view thereof; and,
FIG. 6 illustrates the FIG. 4 cross-sectional view of the gasket shown in an environmental position of use.
The broken lines in the drawings illustrate environment that forms no part of the claimed design.

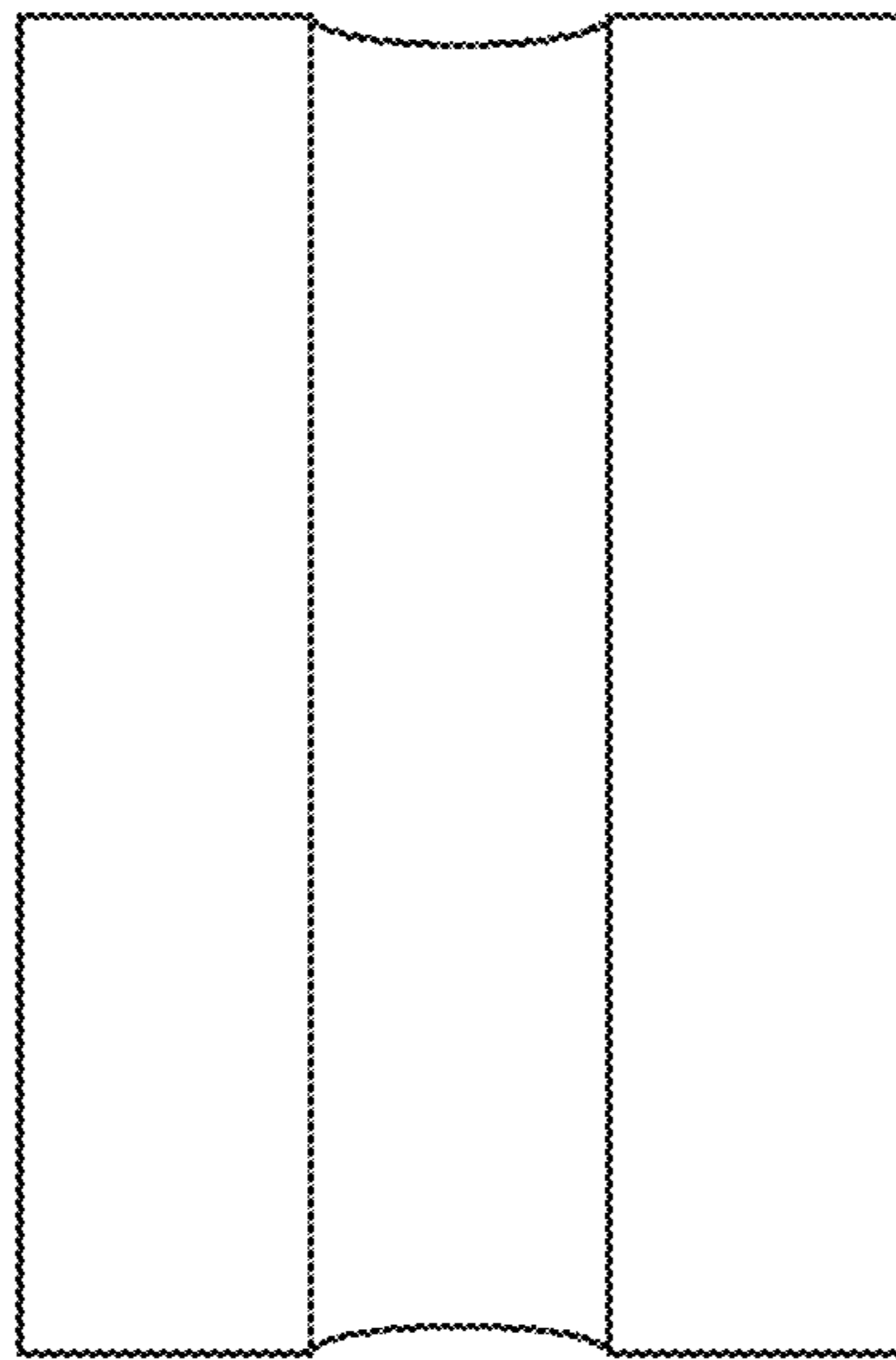

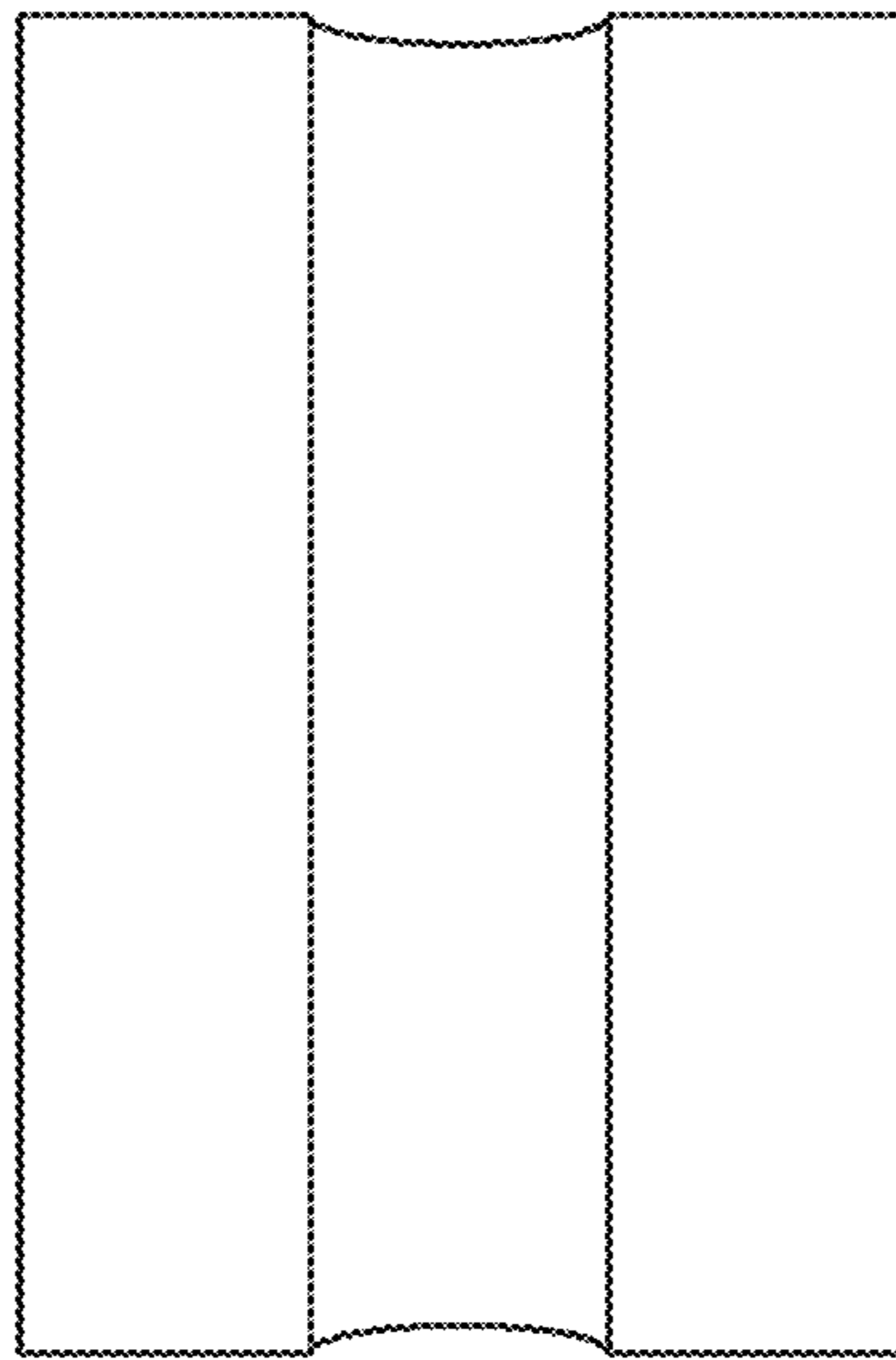

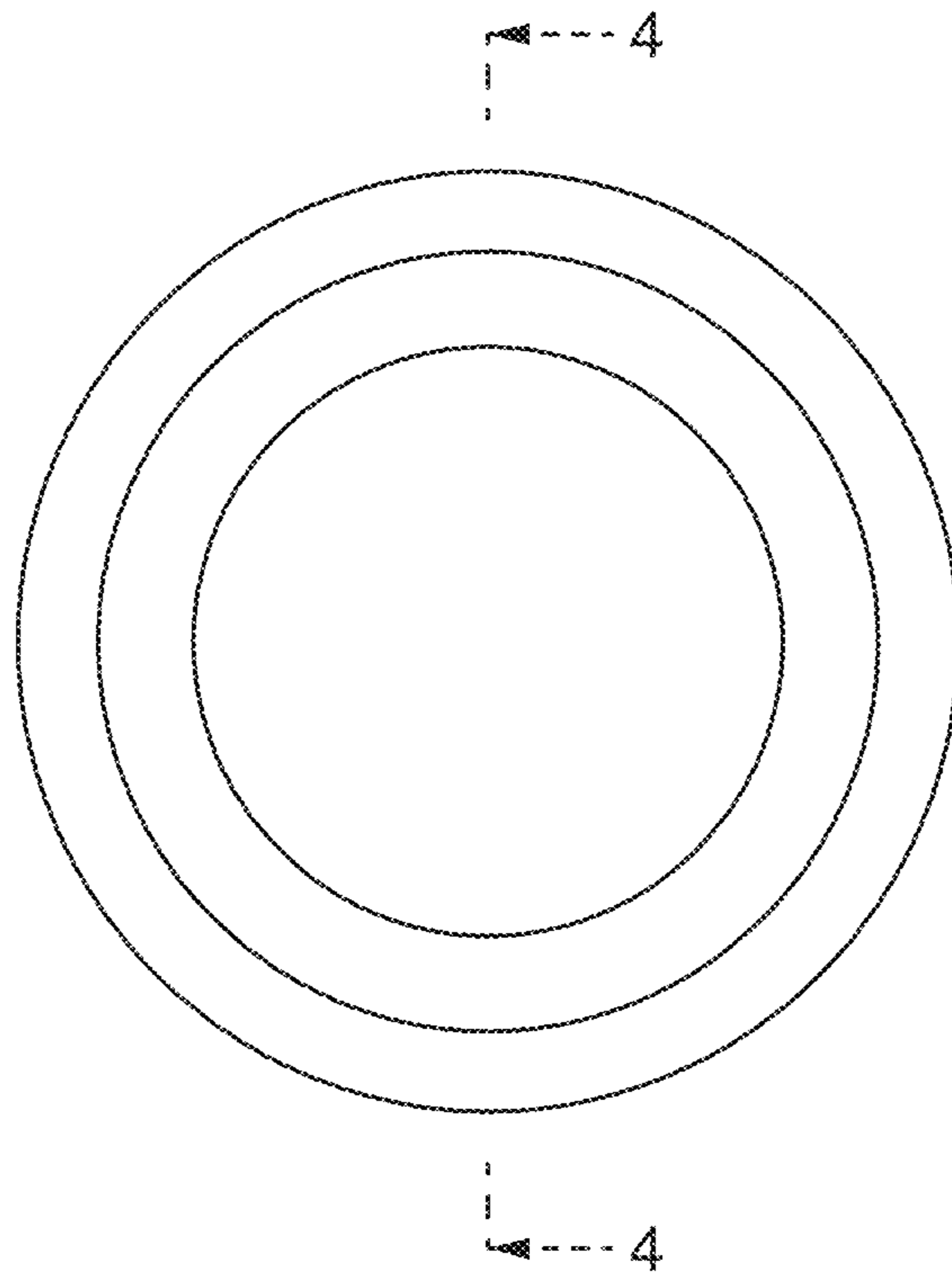

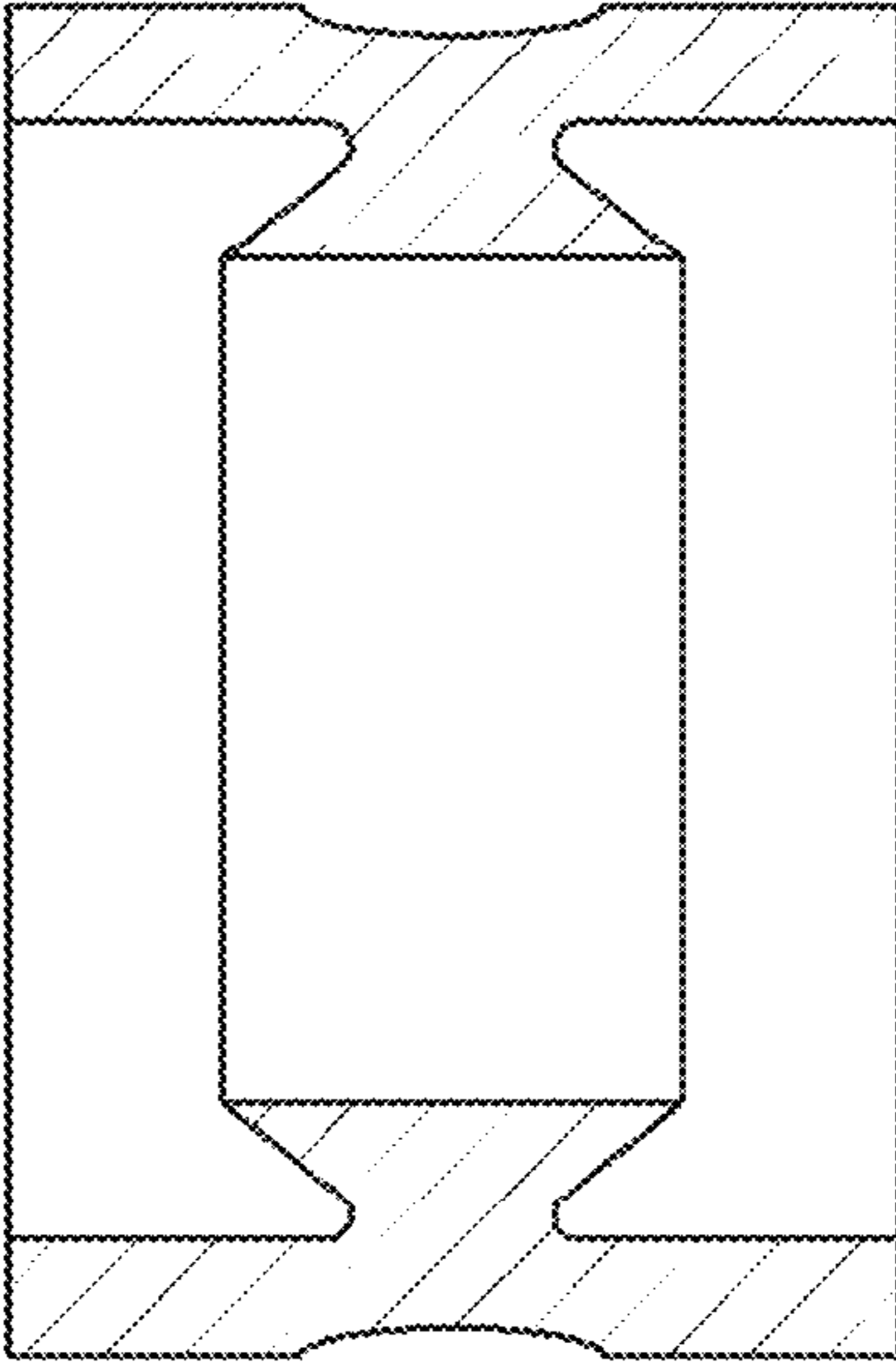

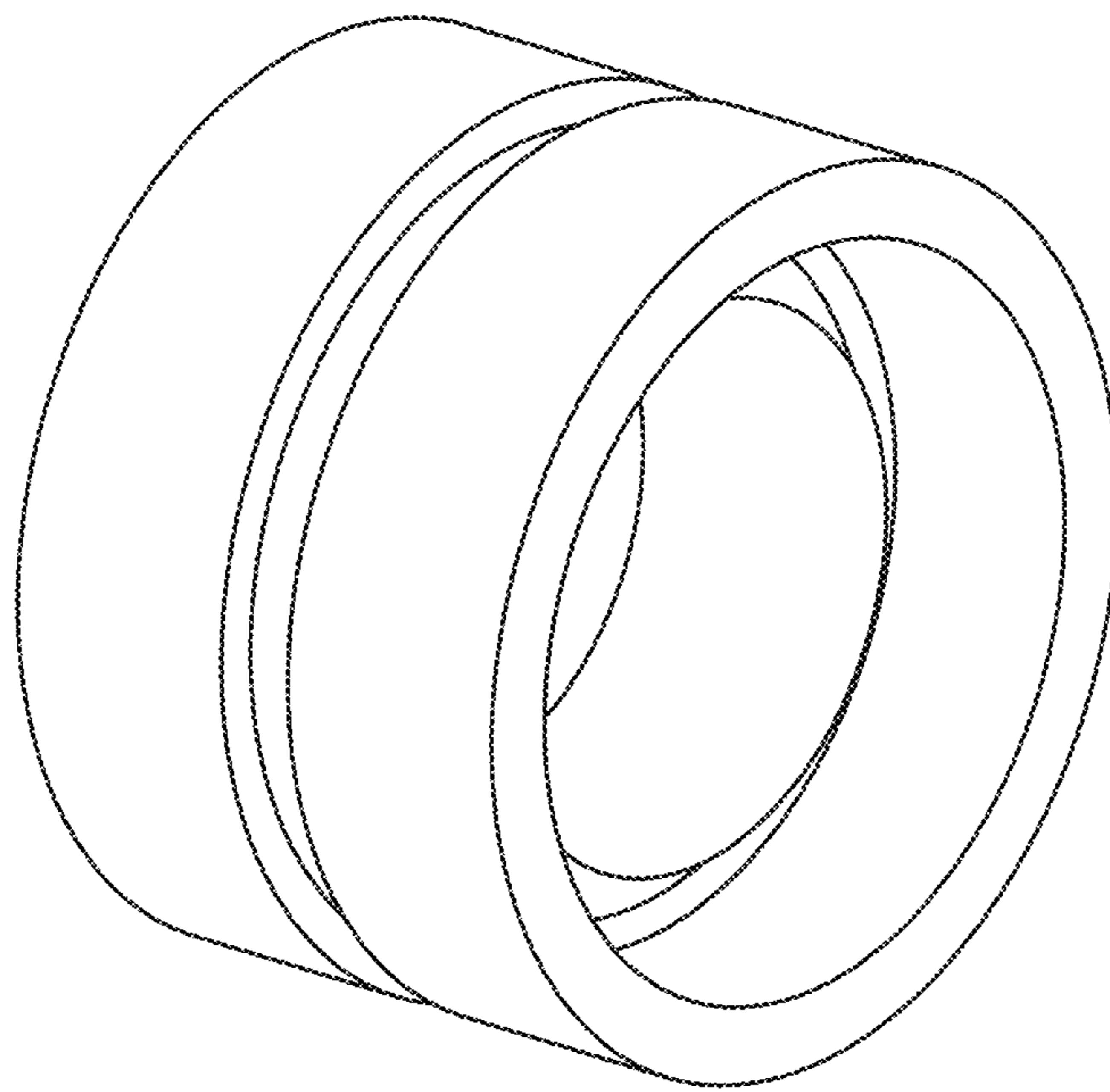
