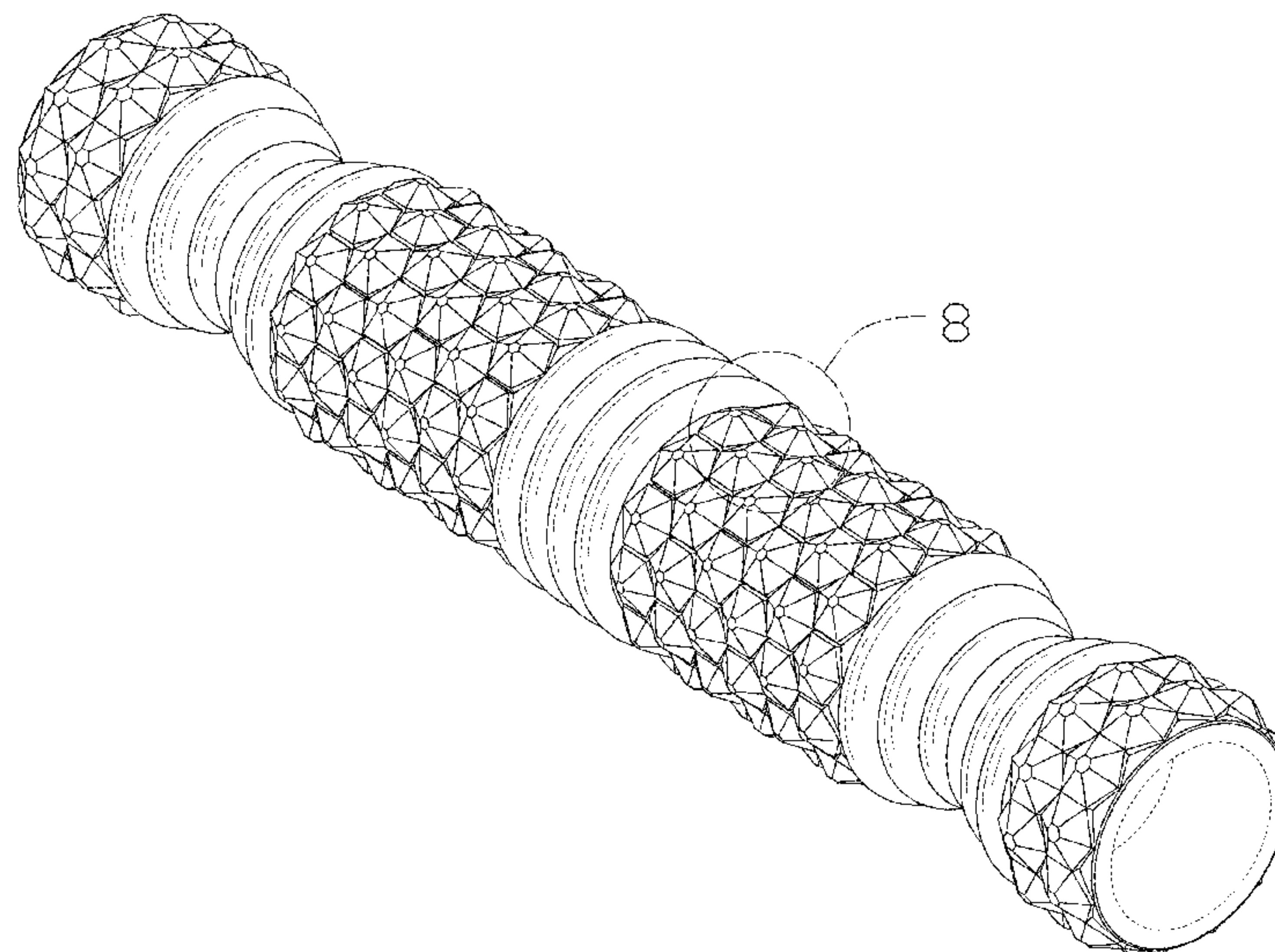
(57) **CLAIM**

The ornamental design for a foam roller, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a foam roller showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a right side elevational view thereof;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a bottom plan view thereof; and,  
FIG. 8 is an enlarged view of portion 8 shown in FIG. 1. The dash-dash broken lines in the drawings depict portions of the foam roller that form no part of the claimed design. The long dash-short dash broken line circle in FIGS. 1 and 8 defines the bounds of the enlargement and forms no part of the claimed design.

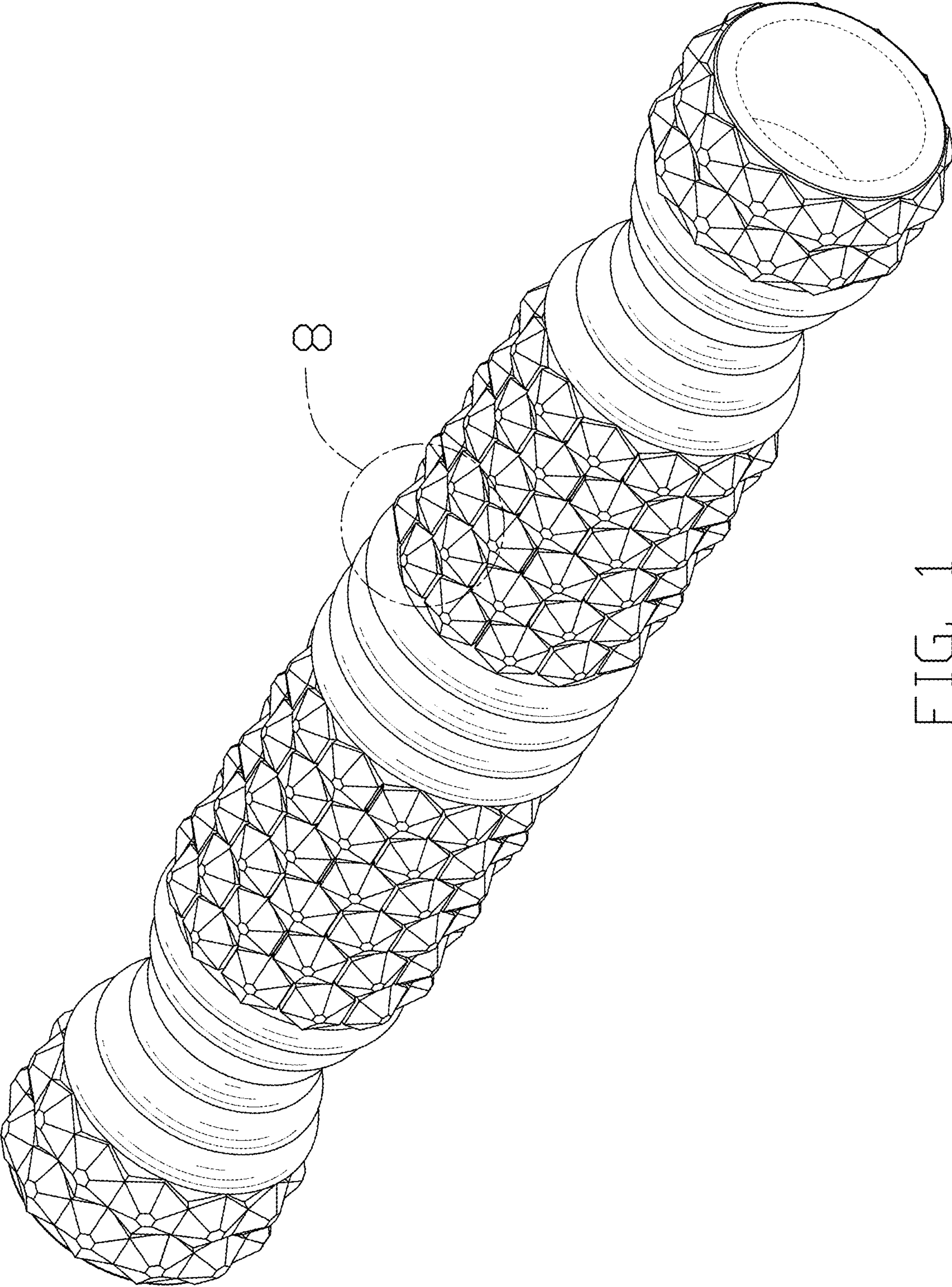

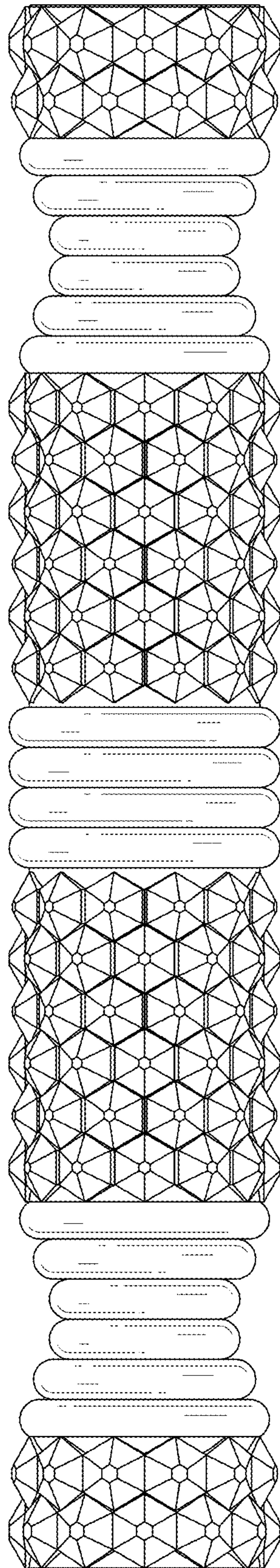

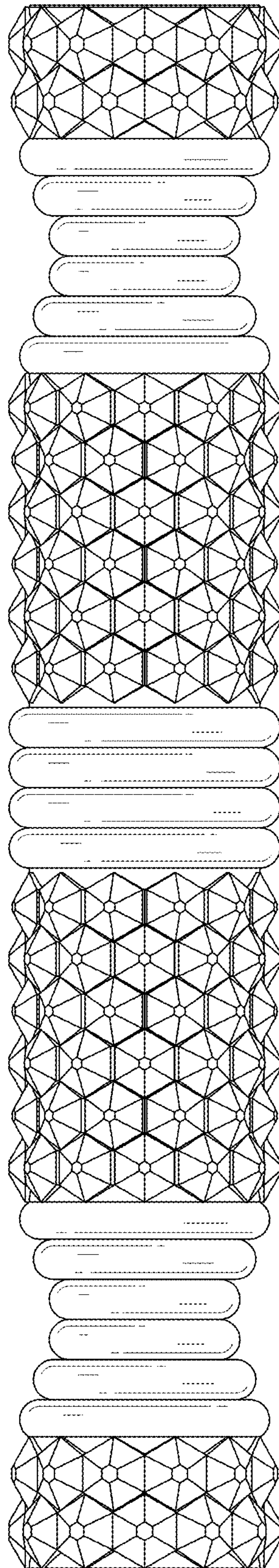

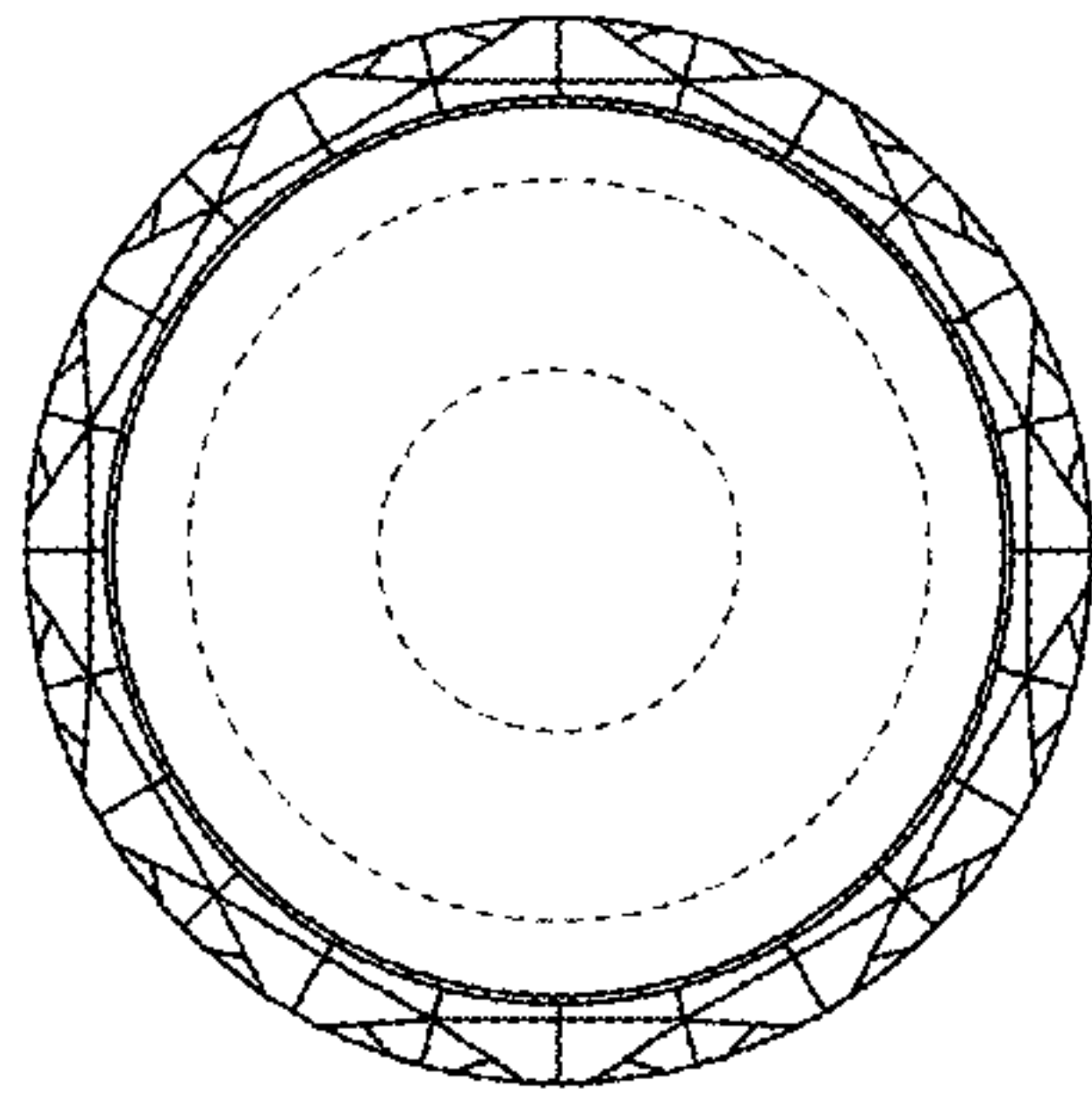

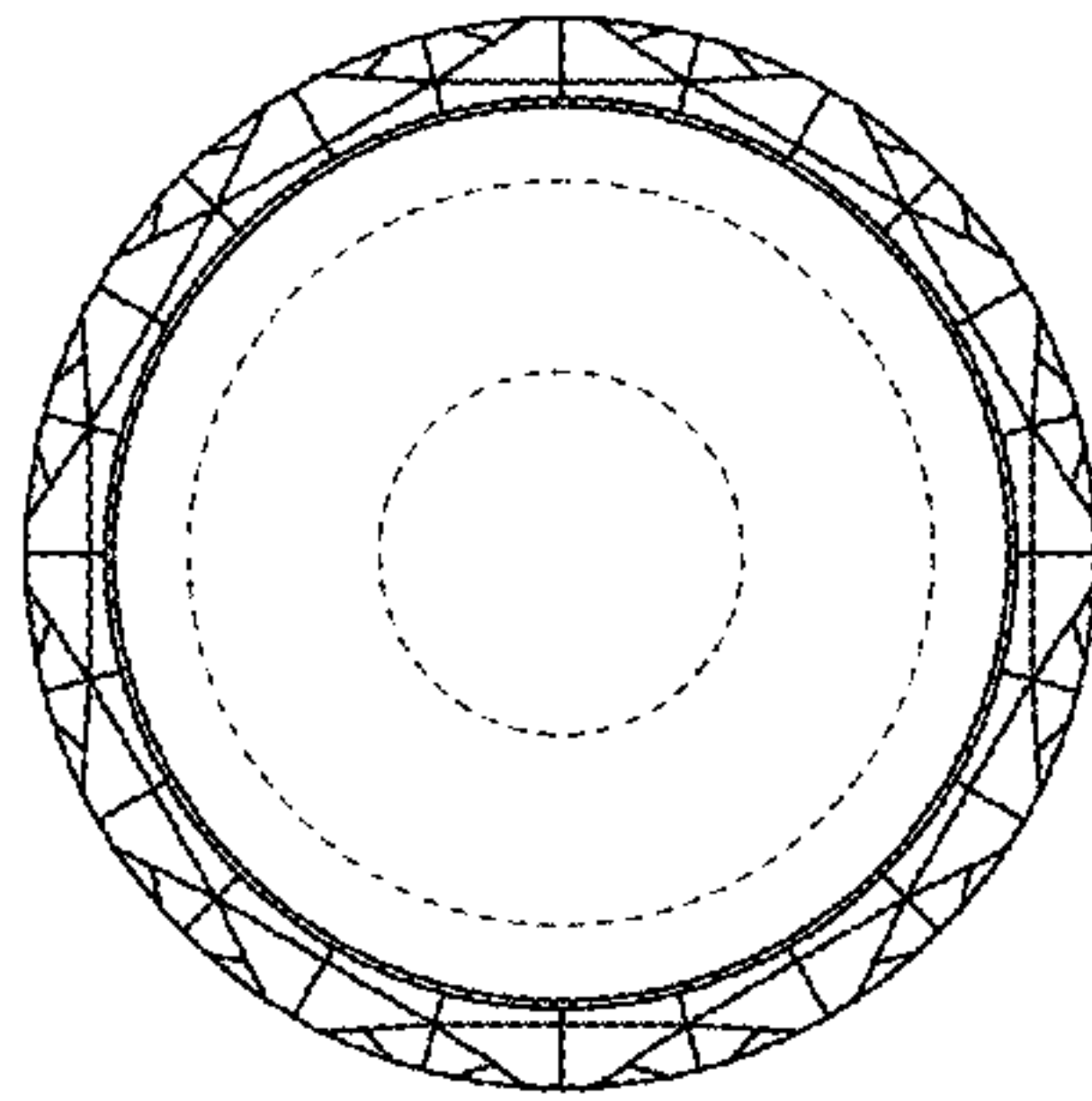

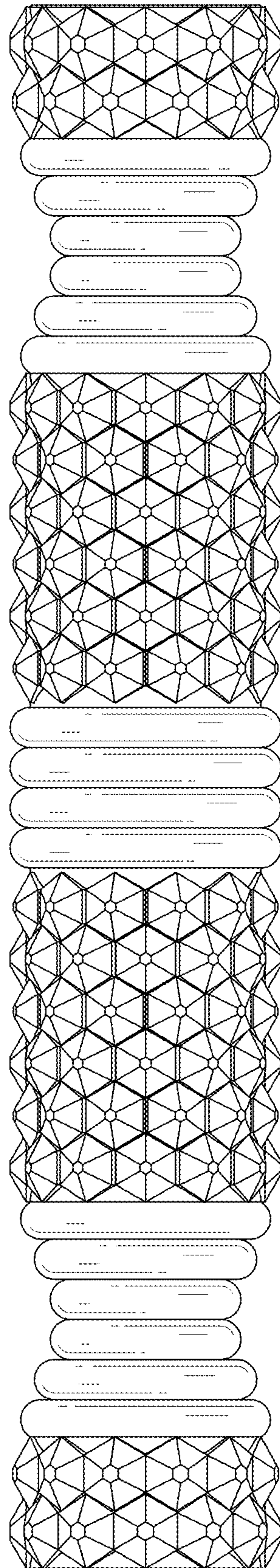

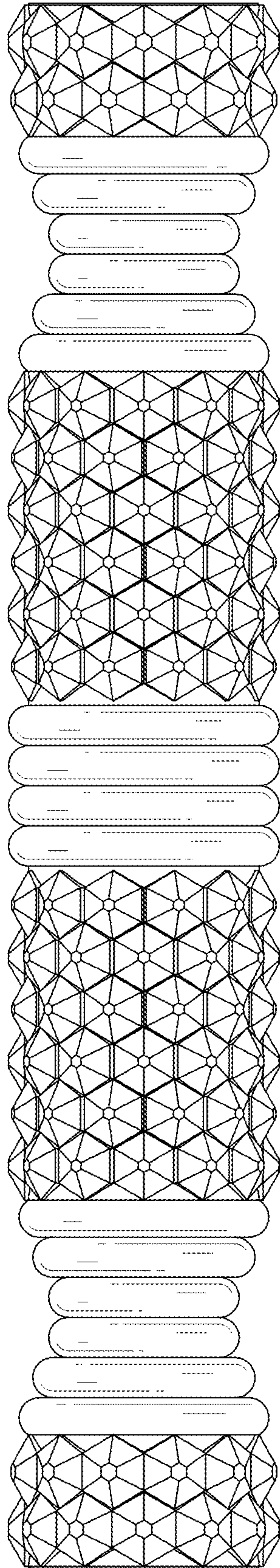

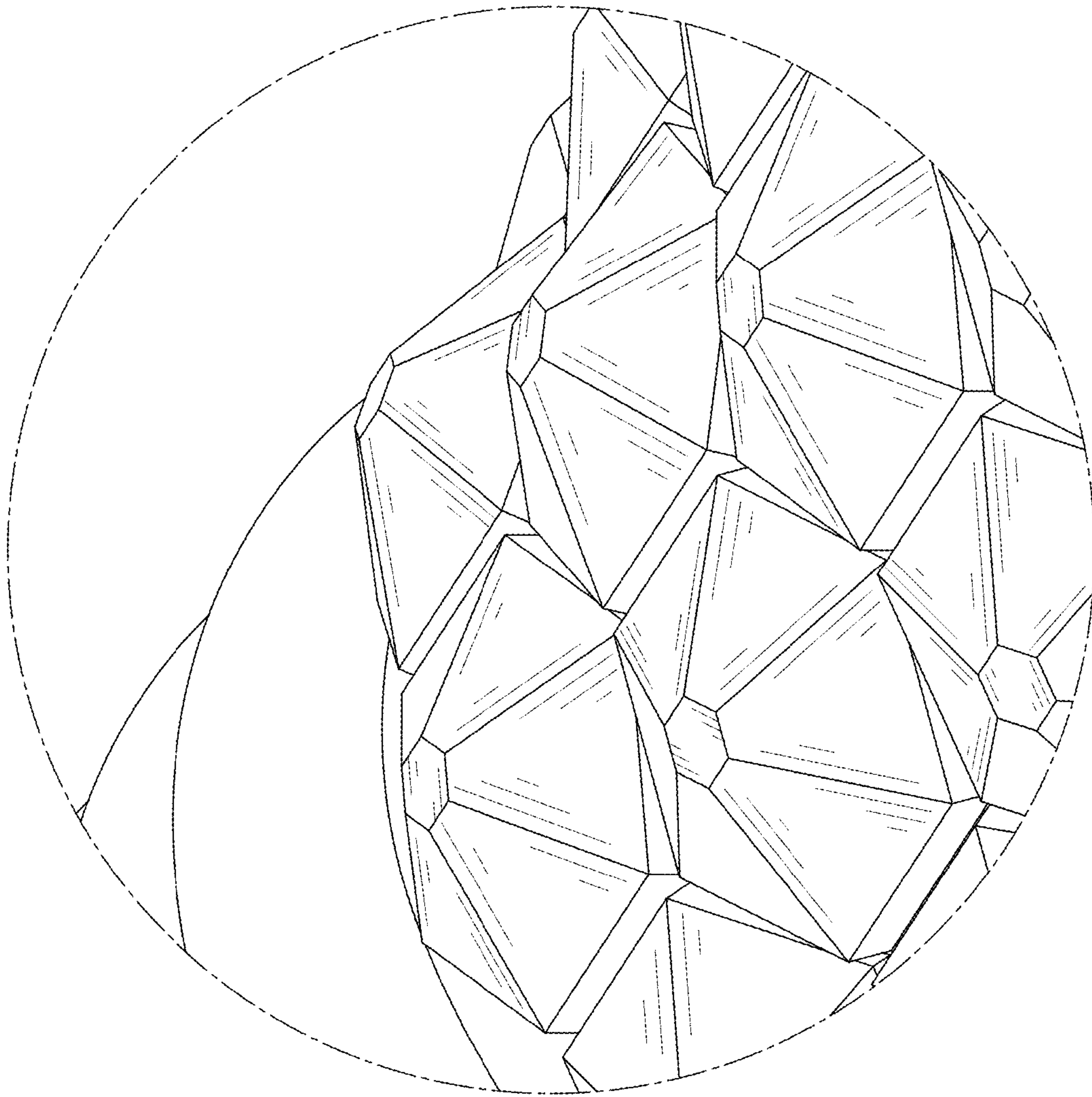
