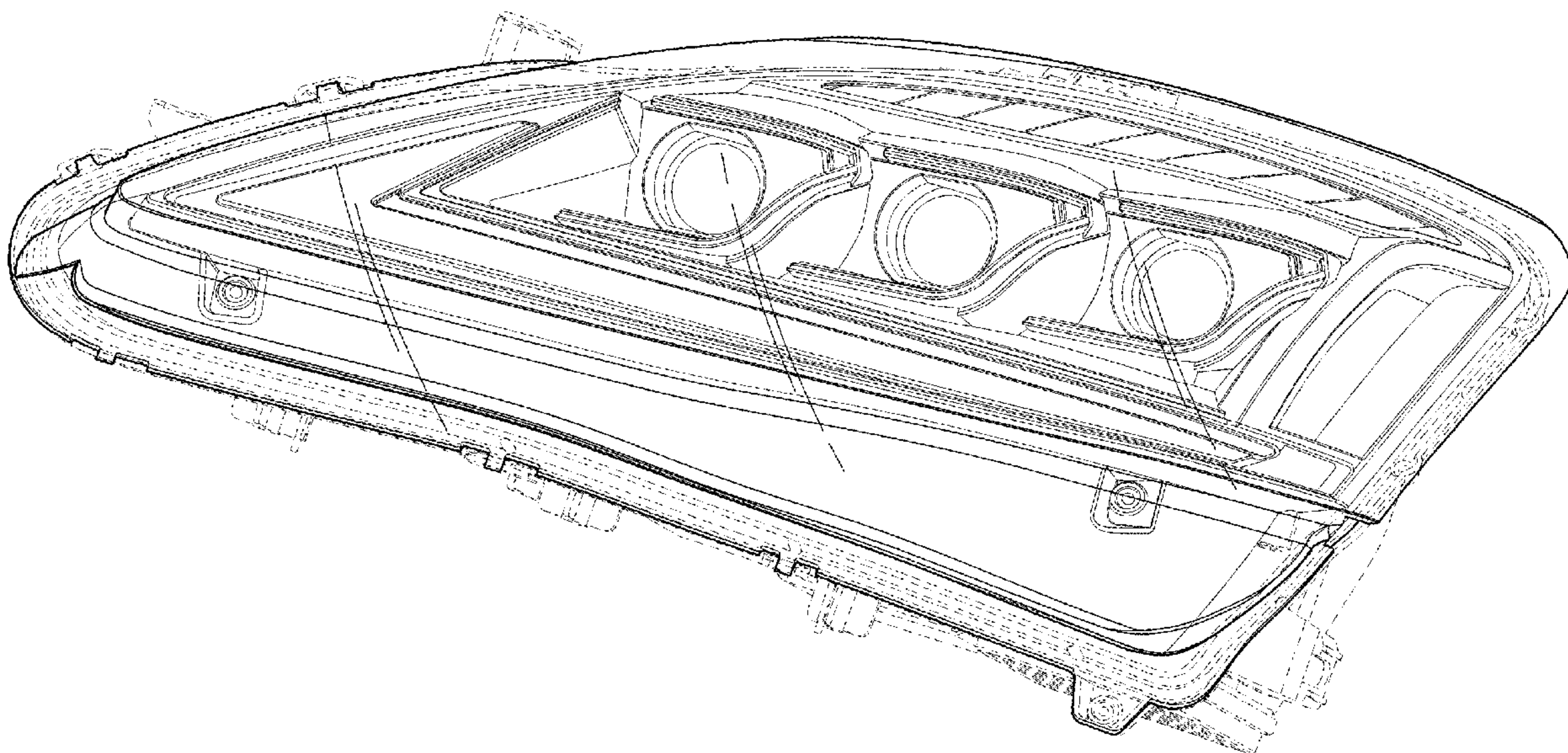
The ornamental design for a vehicle headlight, as shown and

### DESCRIPTION

FIG. 1 is a front, right side and bottom perspective view of  
a vehicle headlight showing my new design;

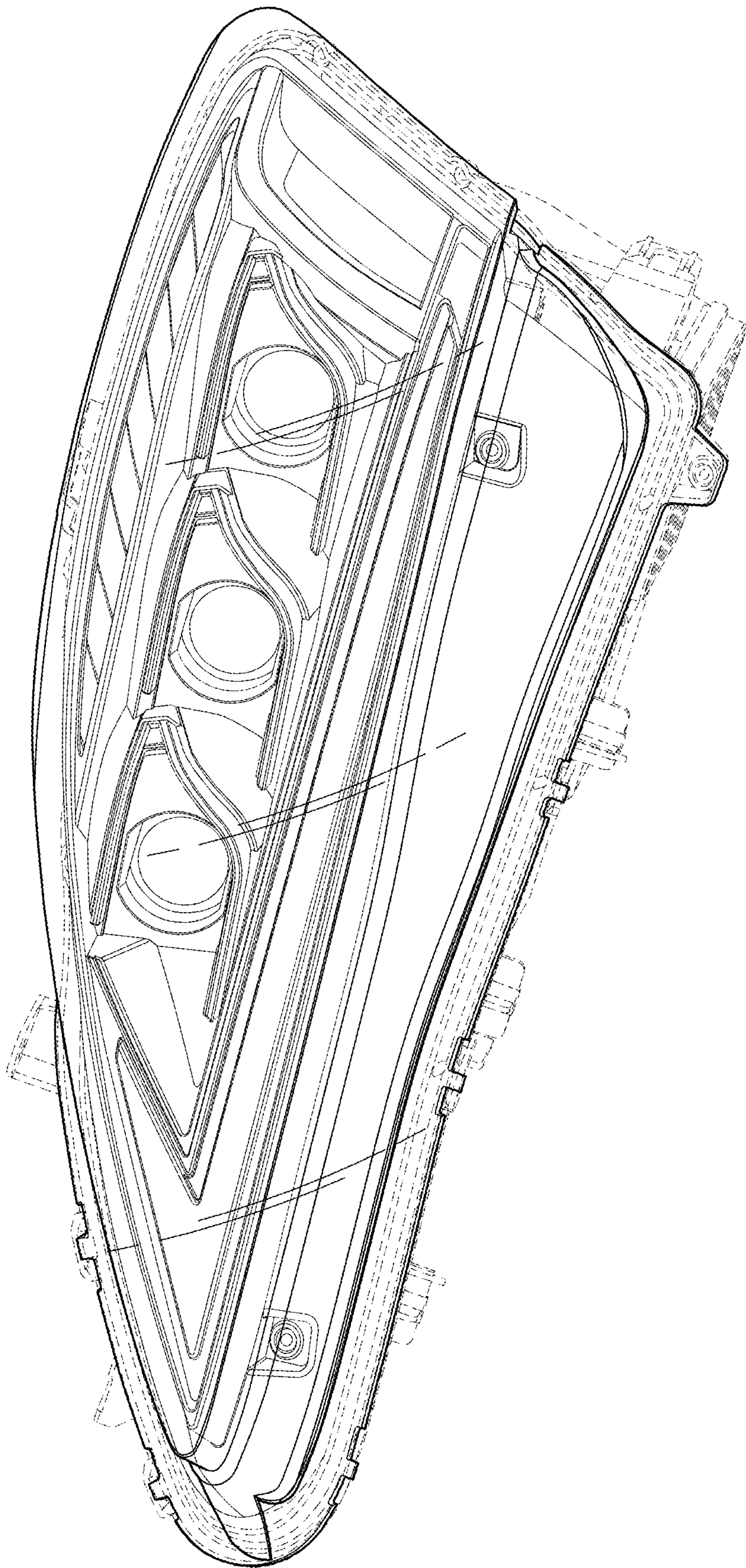

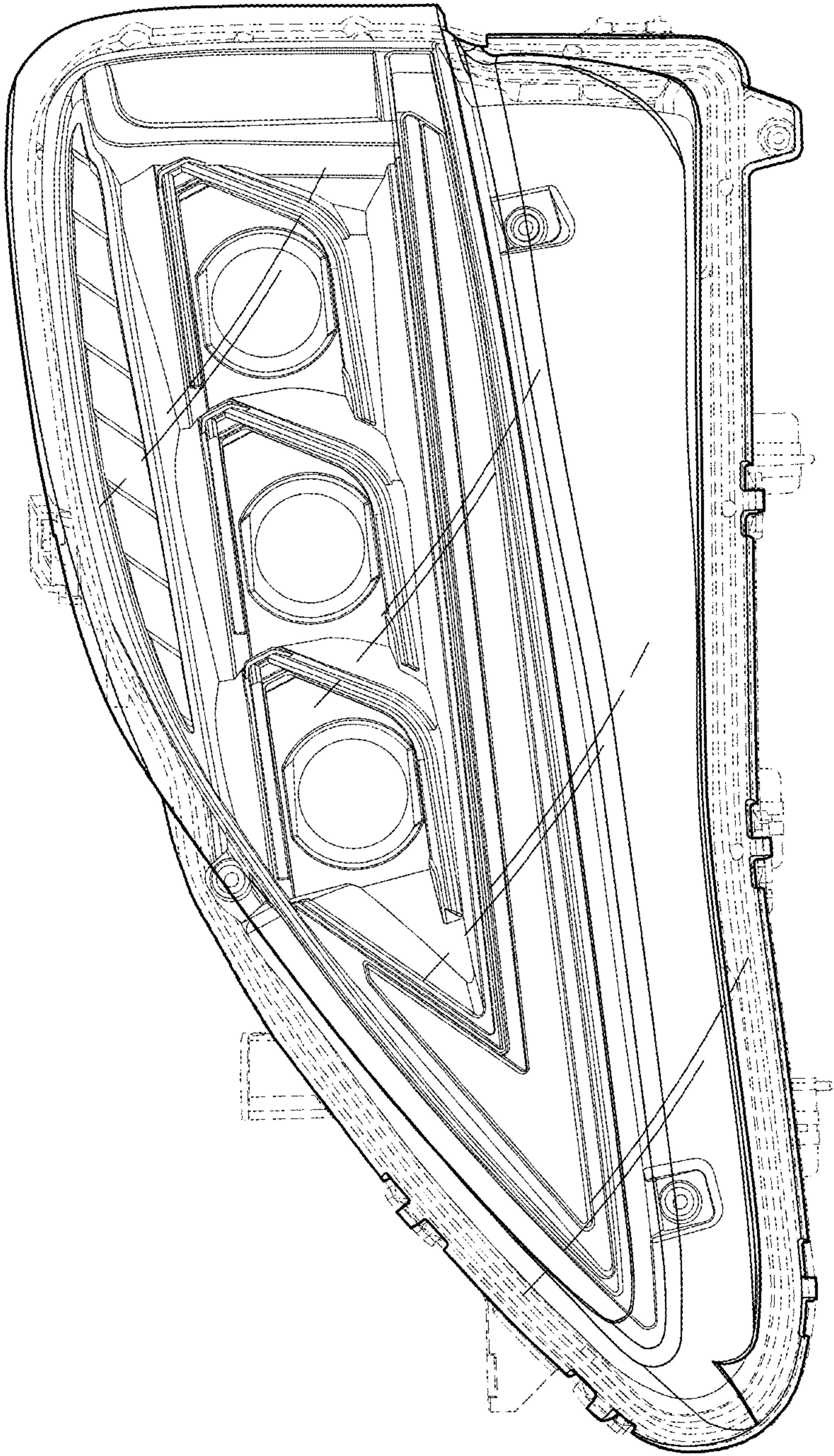

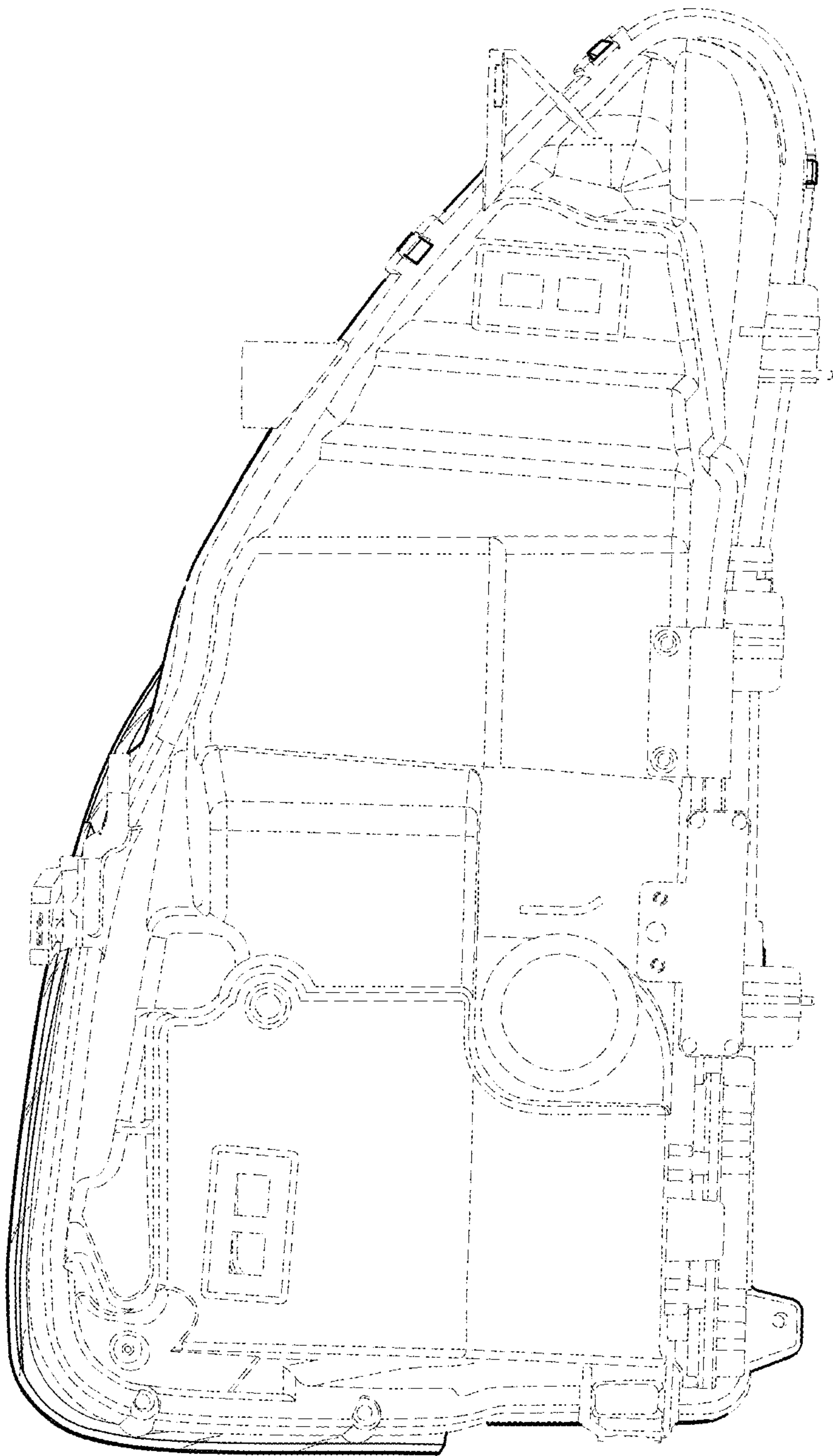

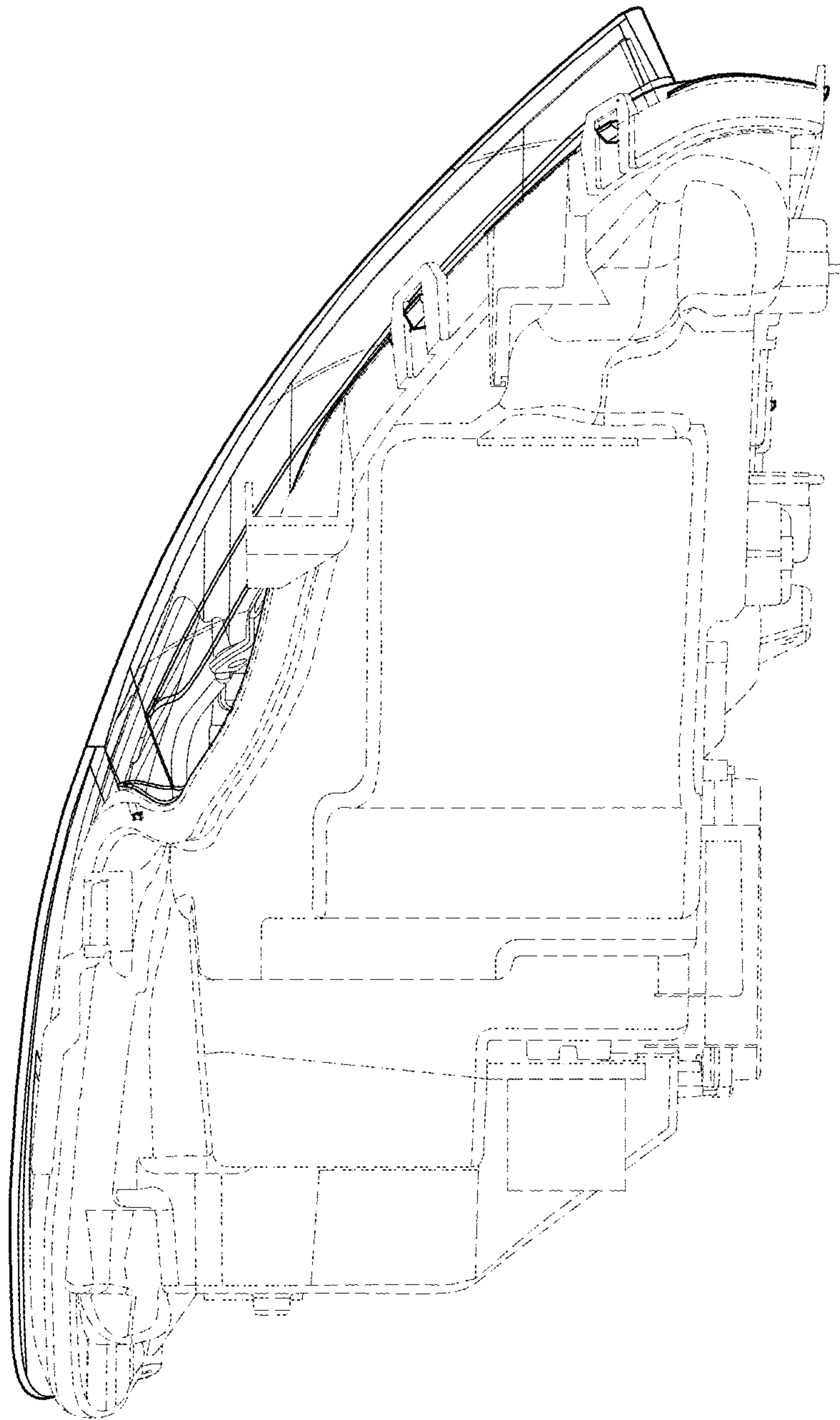

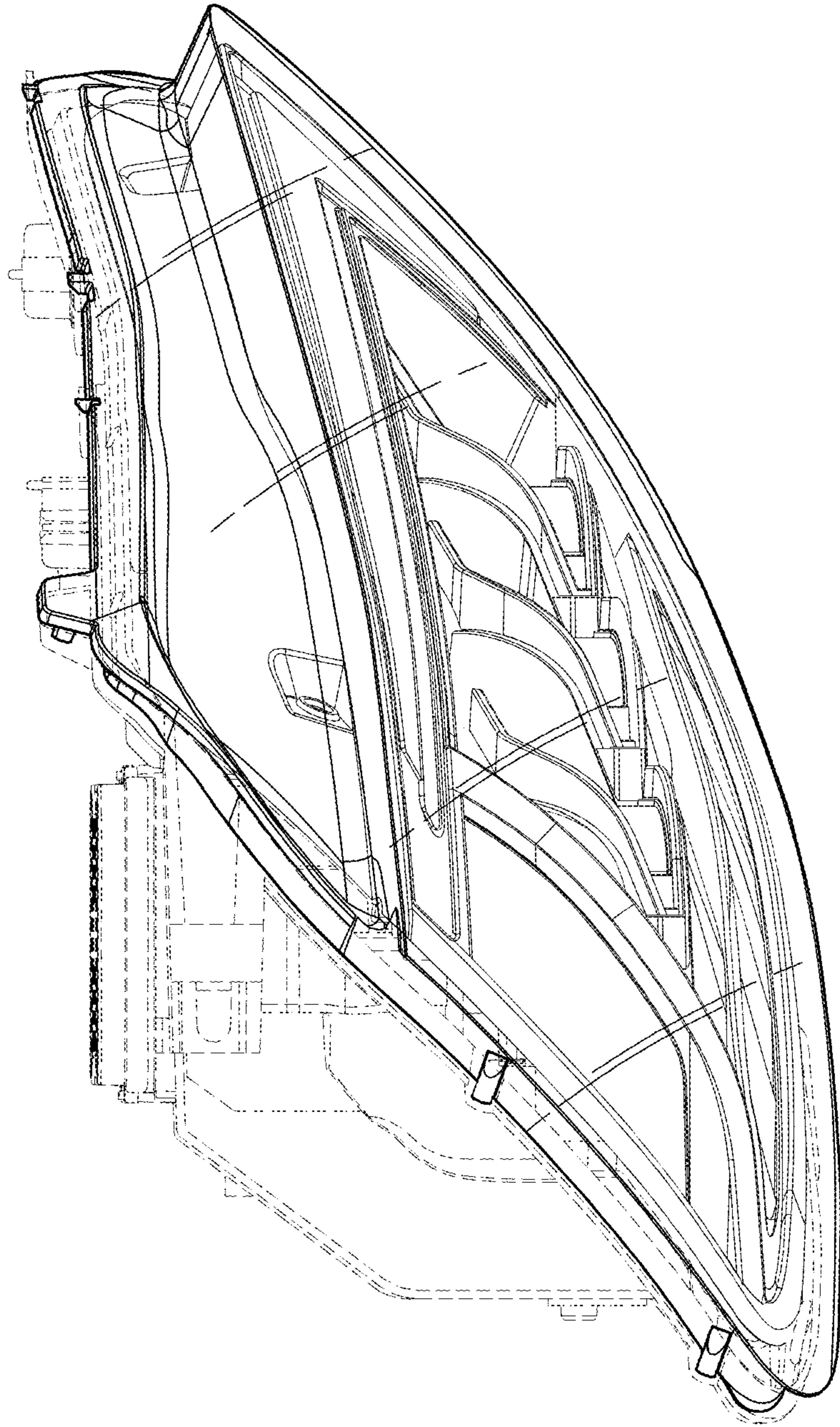

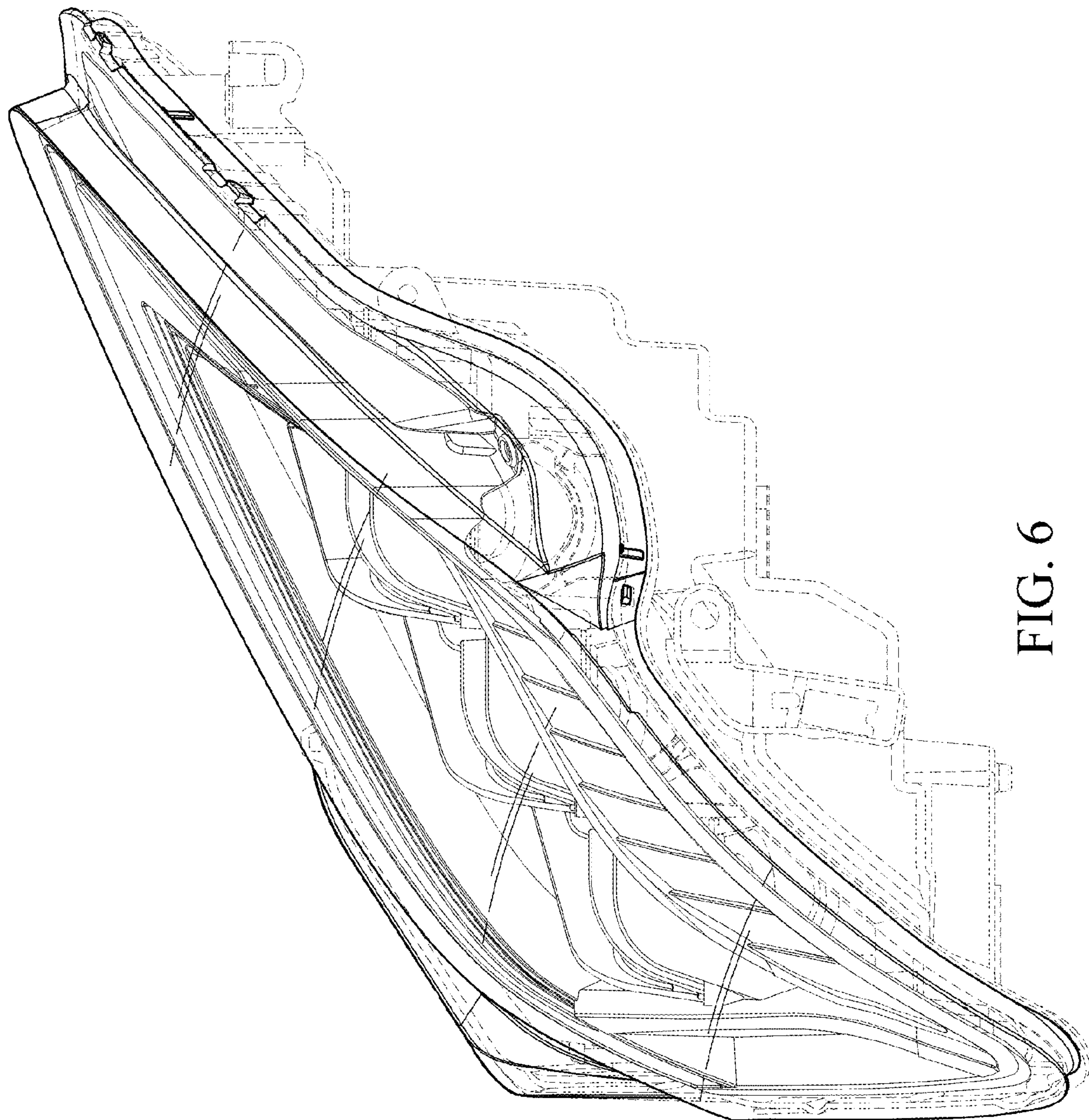

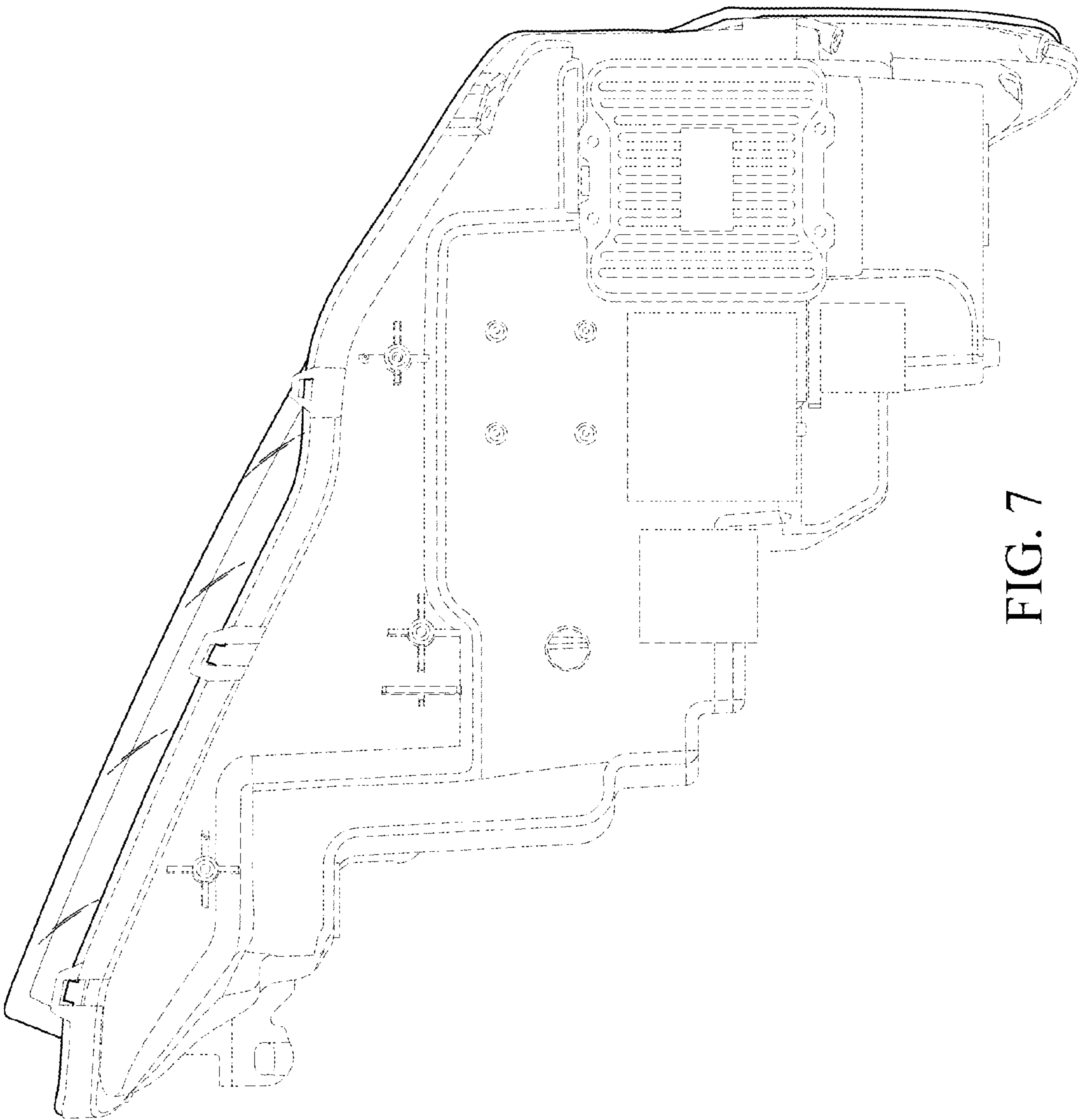
