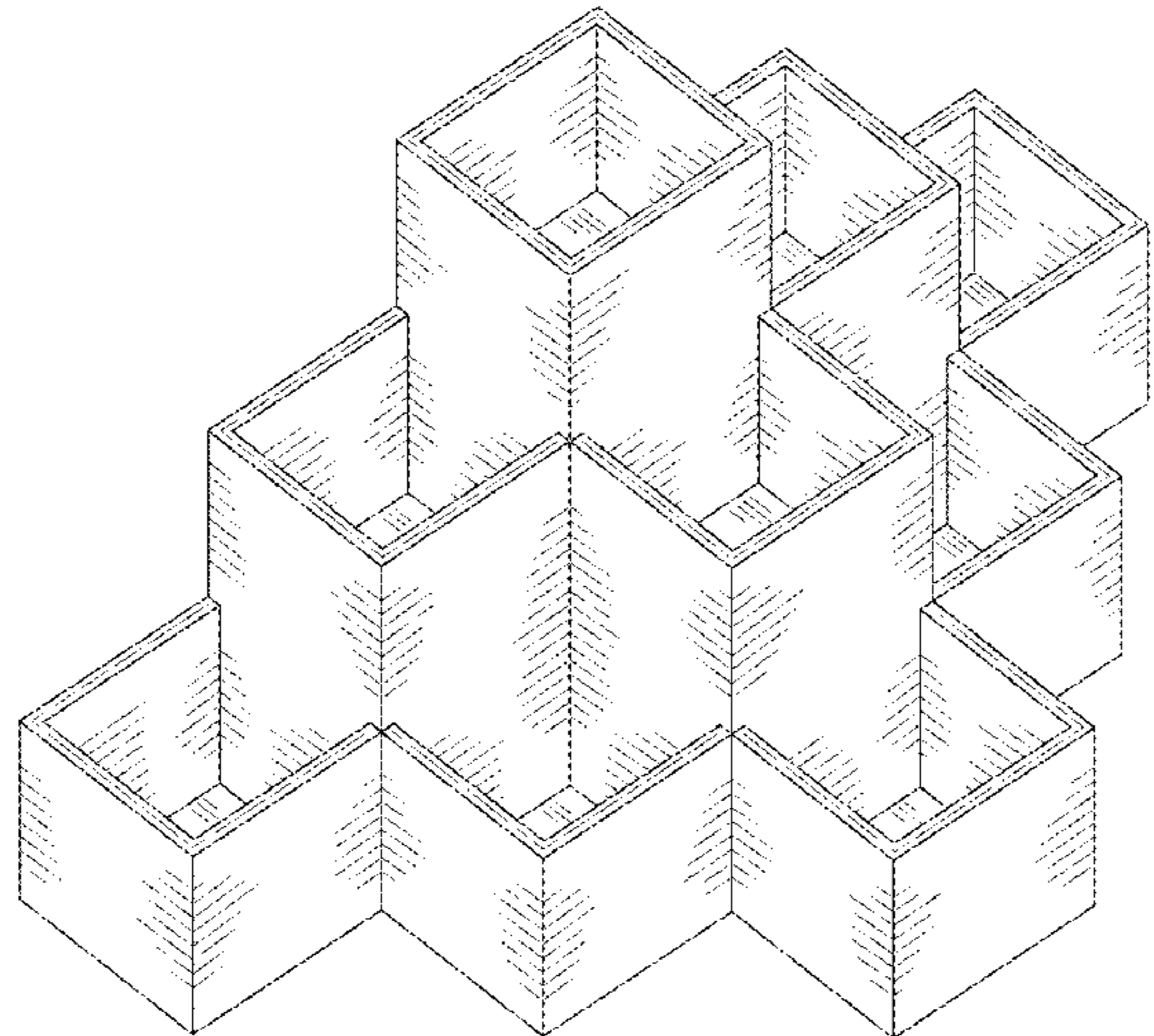

DESCRIPTION
FIG. 1 is a front/left/top perspective view of a lipstick organizer showing my new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a left side elevation view thereof;
FIG. 5 is a right side elevation view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a rear/left/top perspective view thereof; and,
FIG. 9 is a cross-section view along line 9 in FIG. 2 of the lipstick organizer.

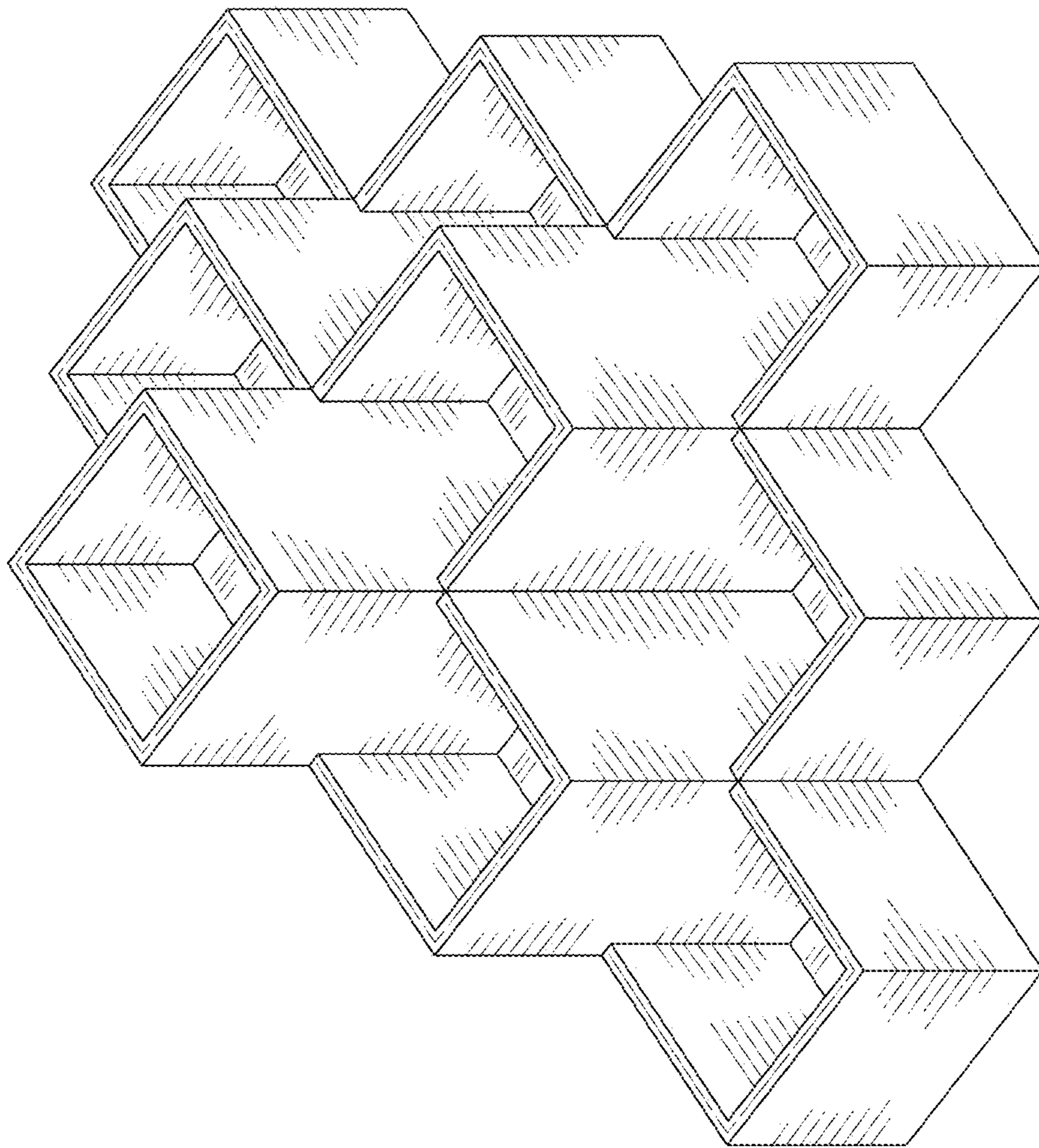

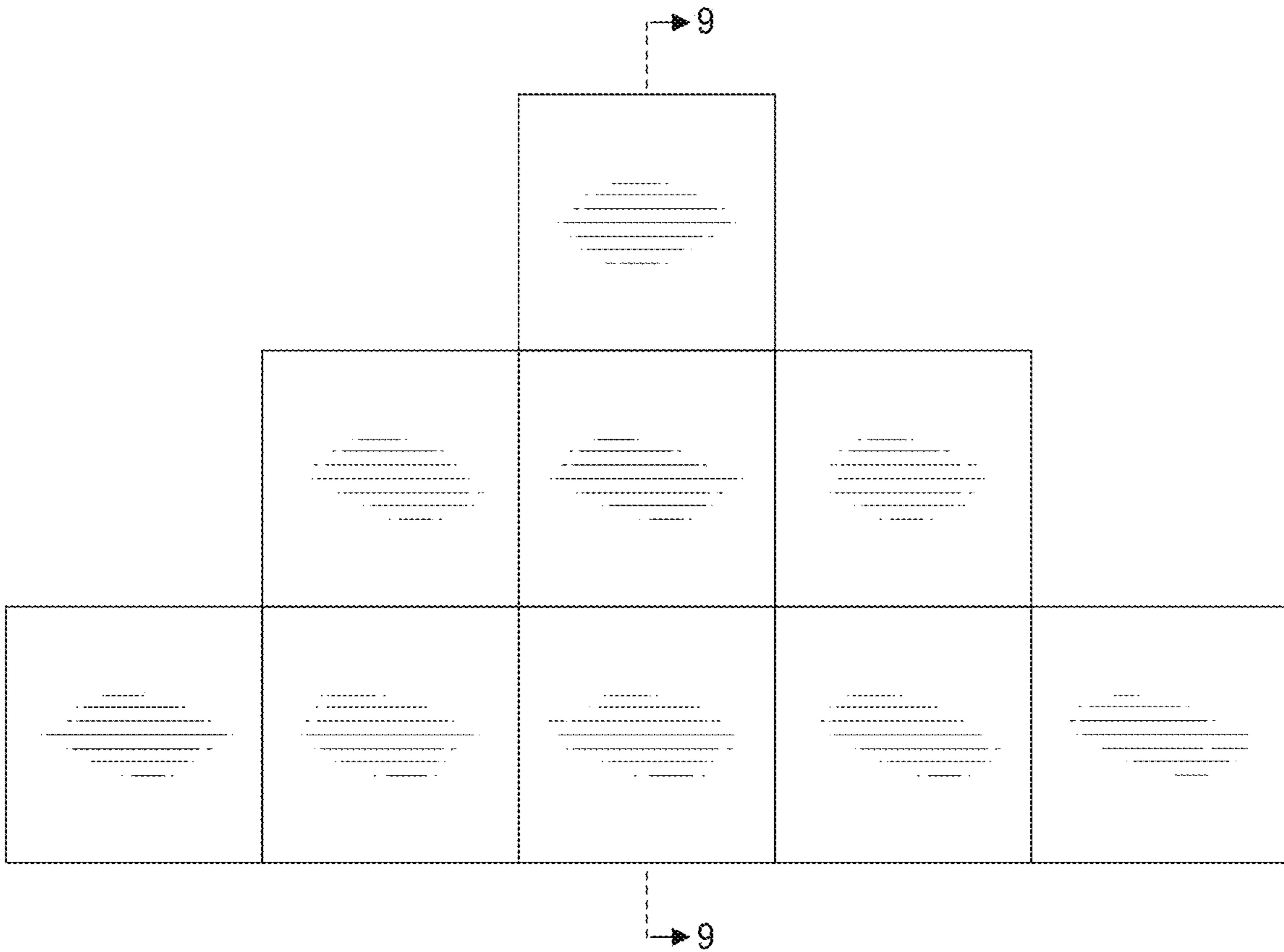

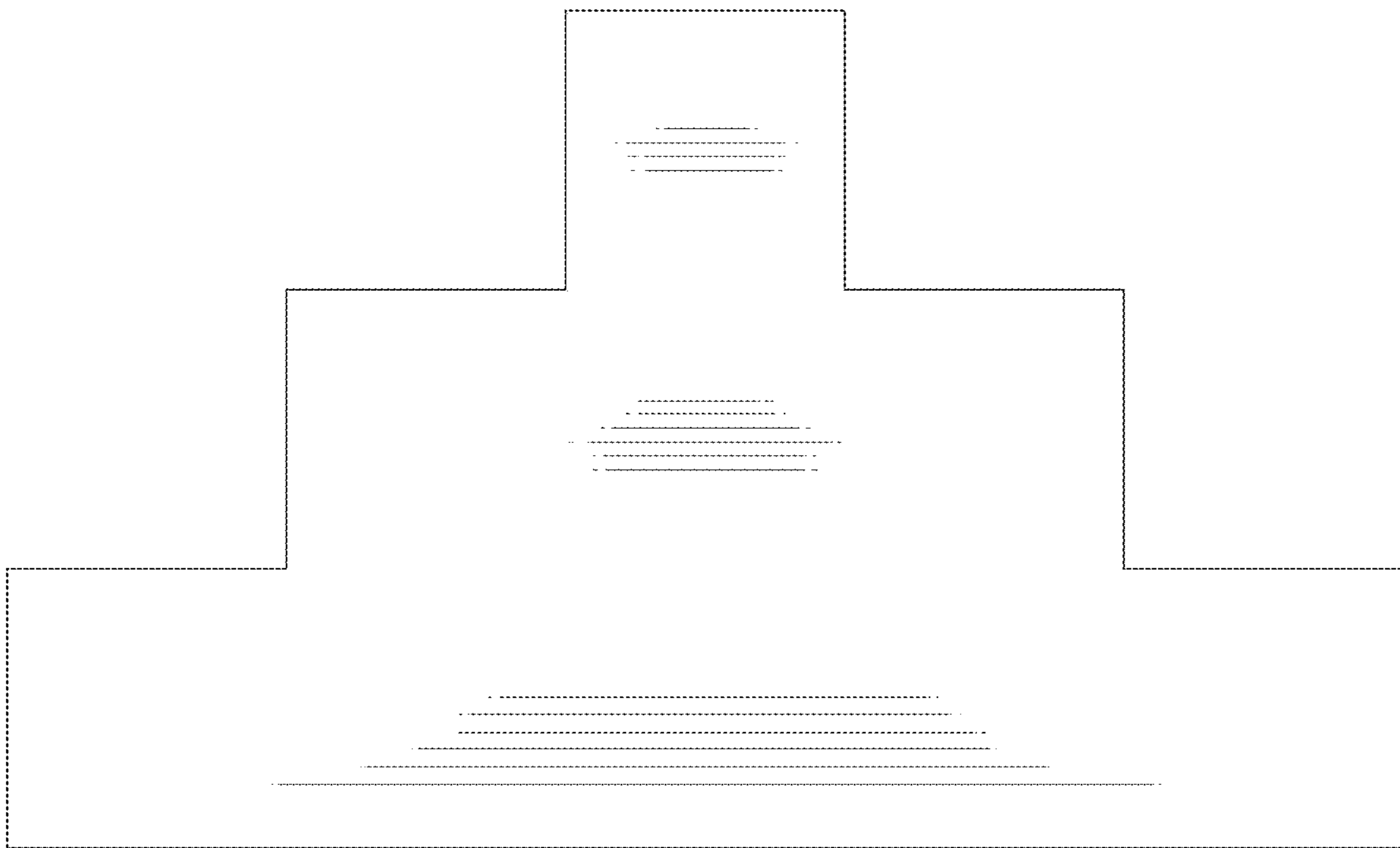

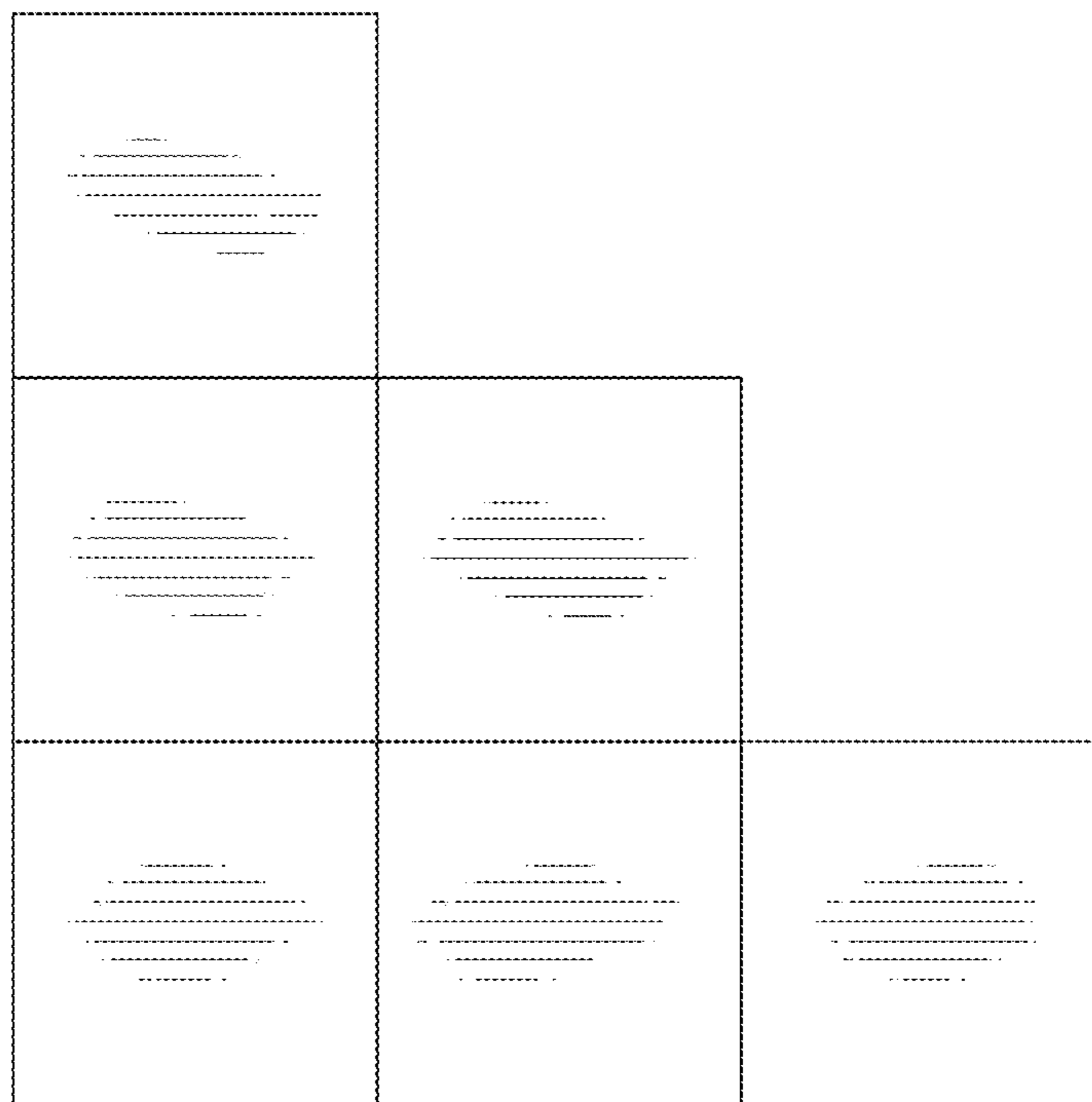

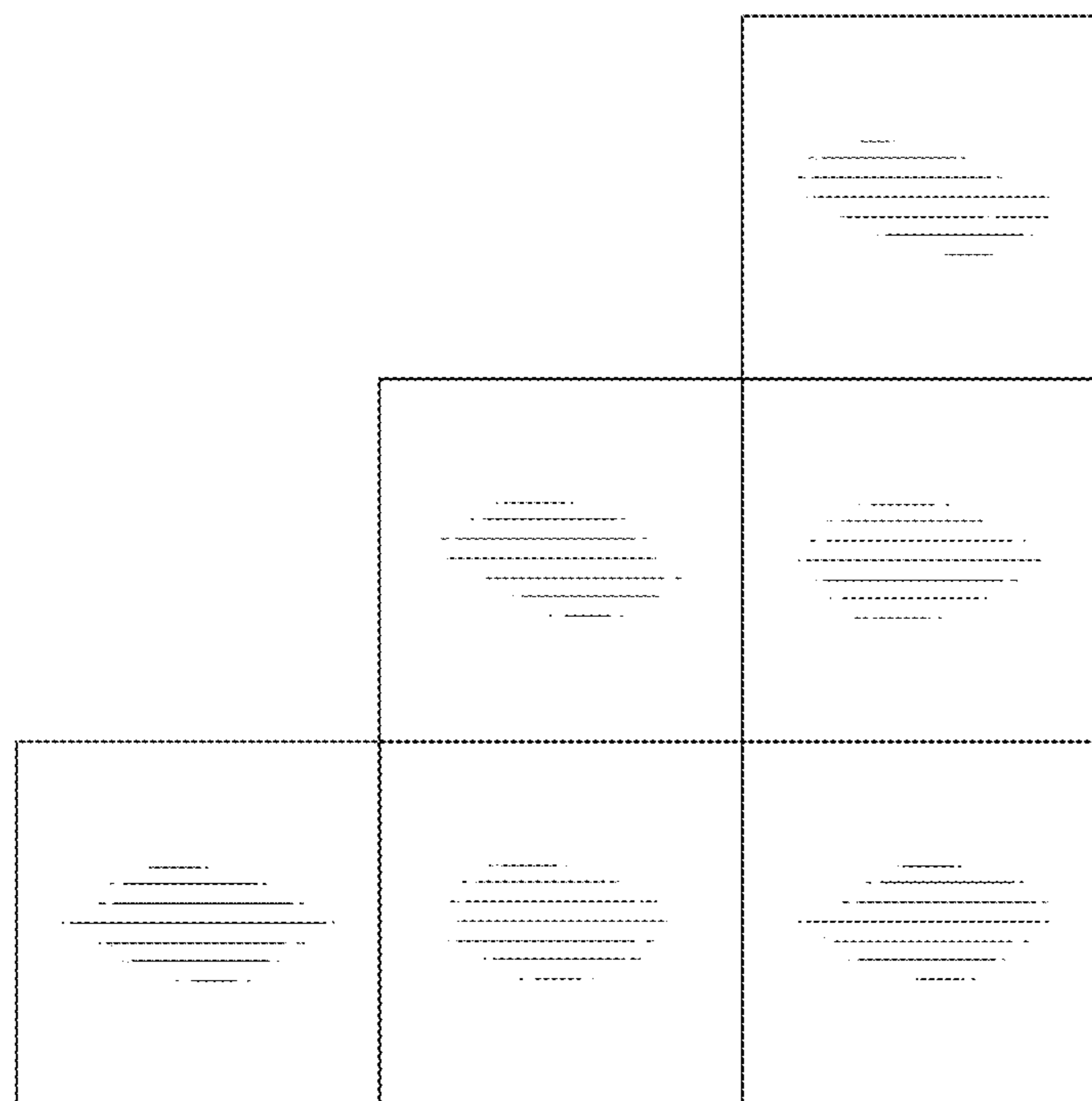

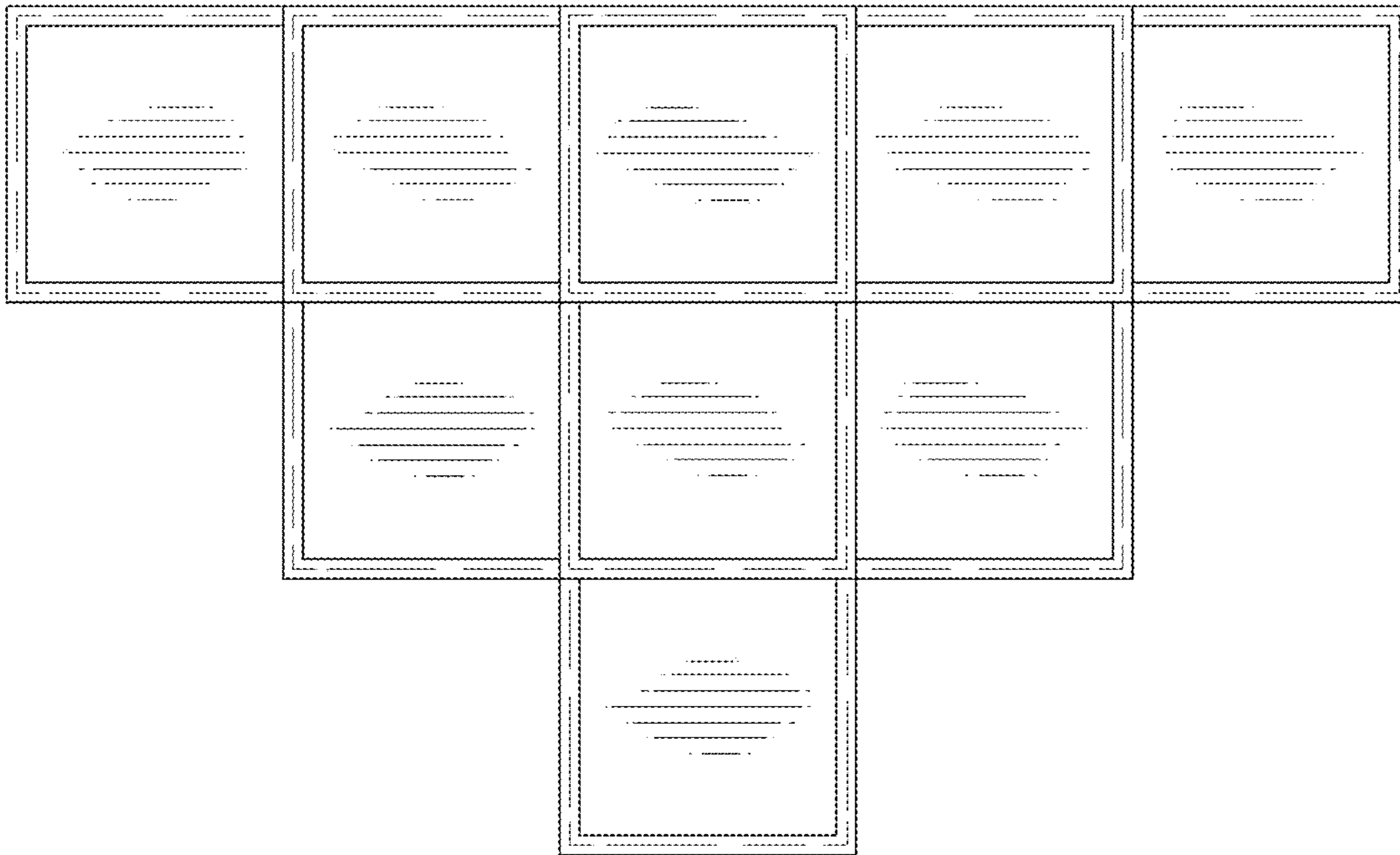

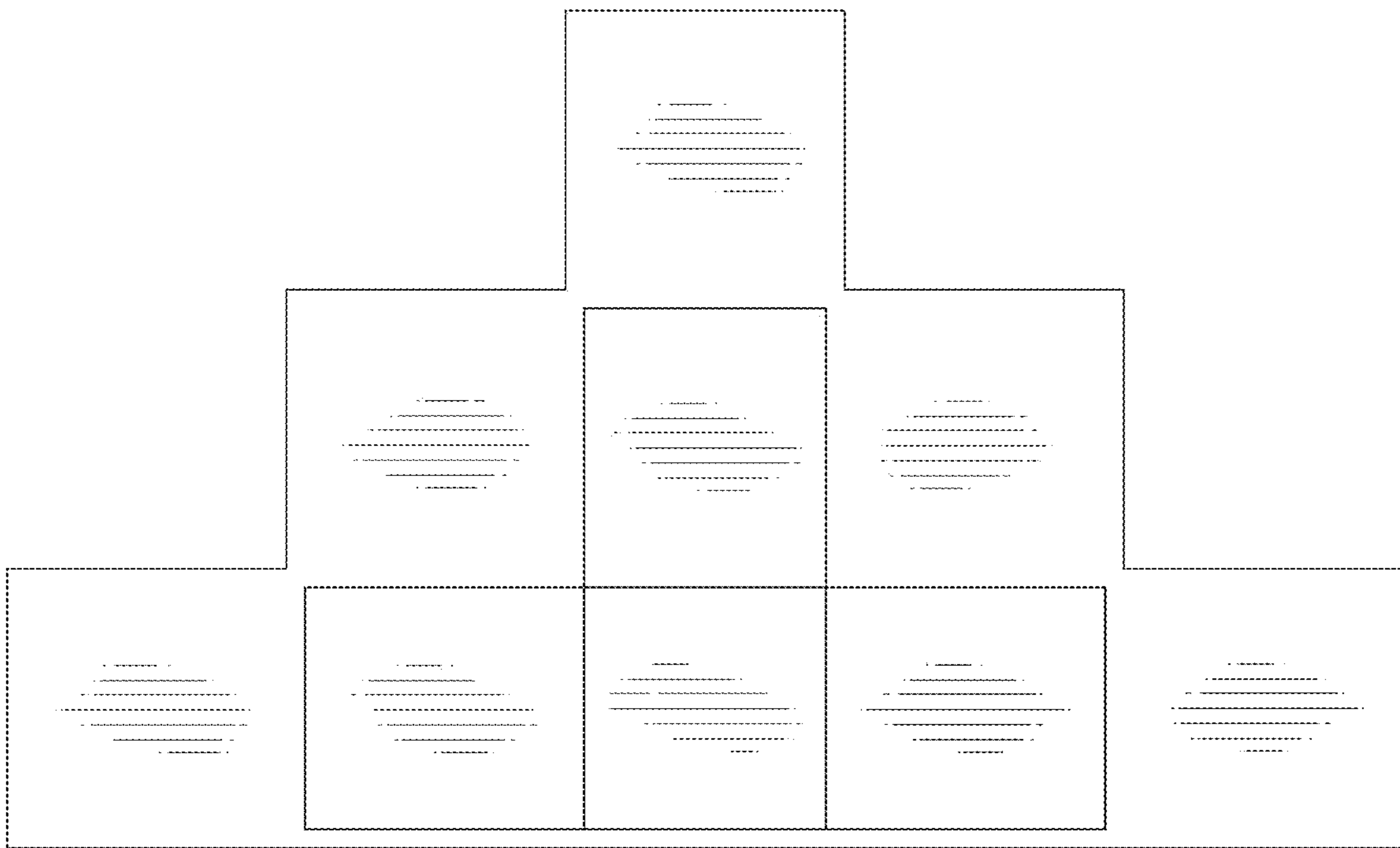

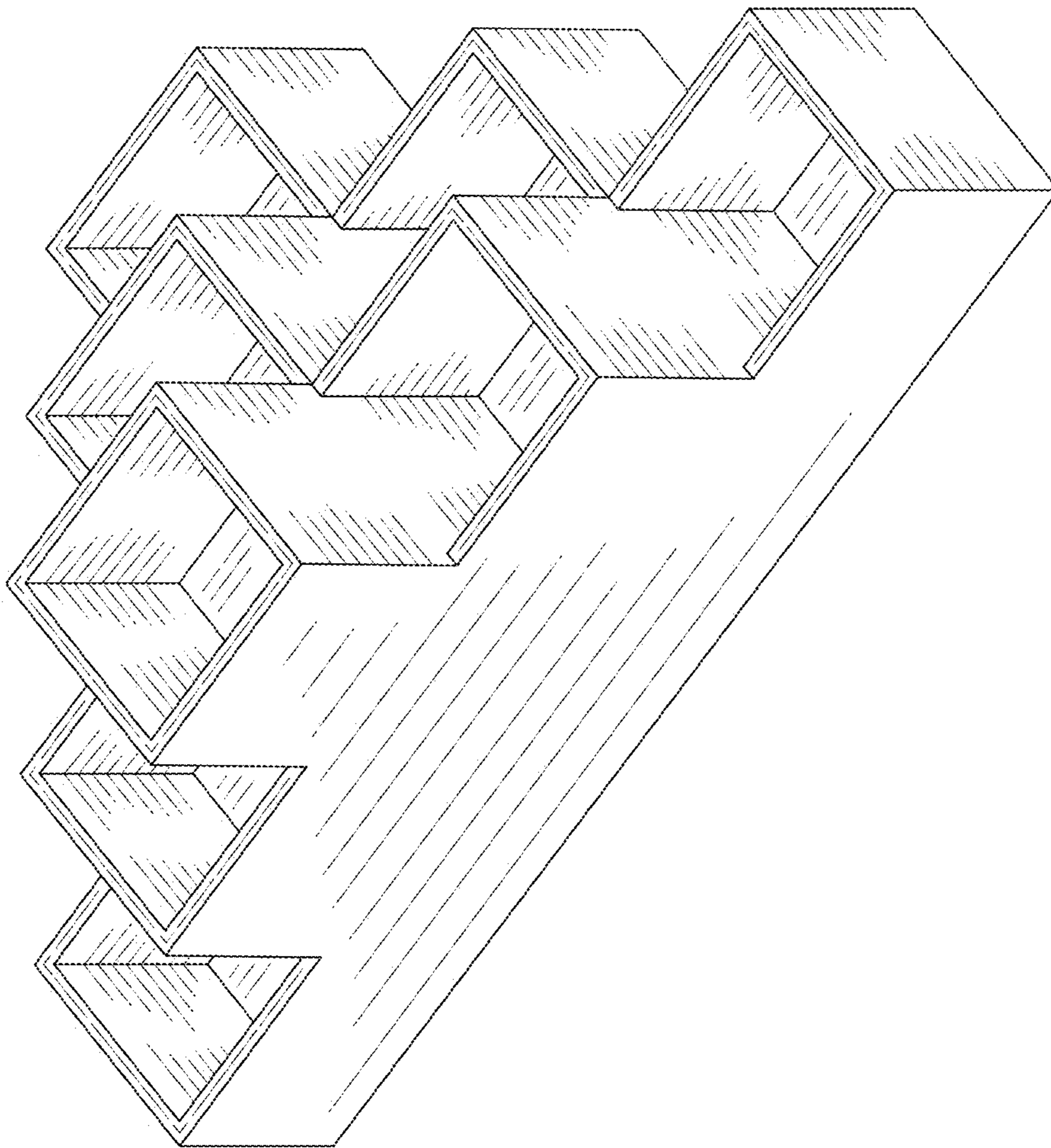

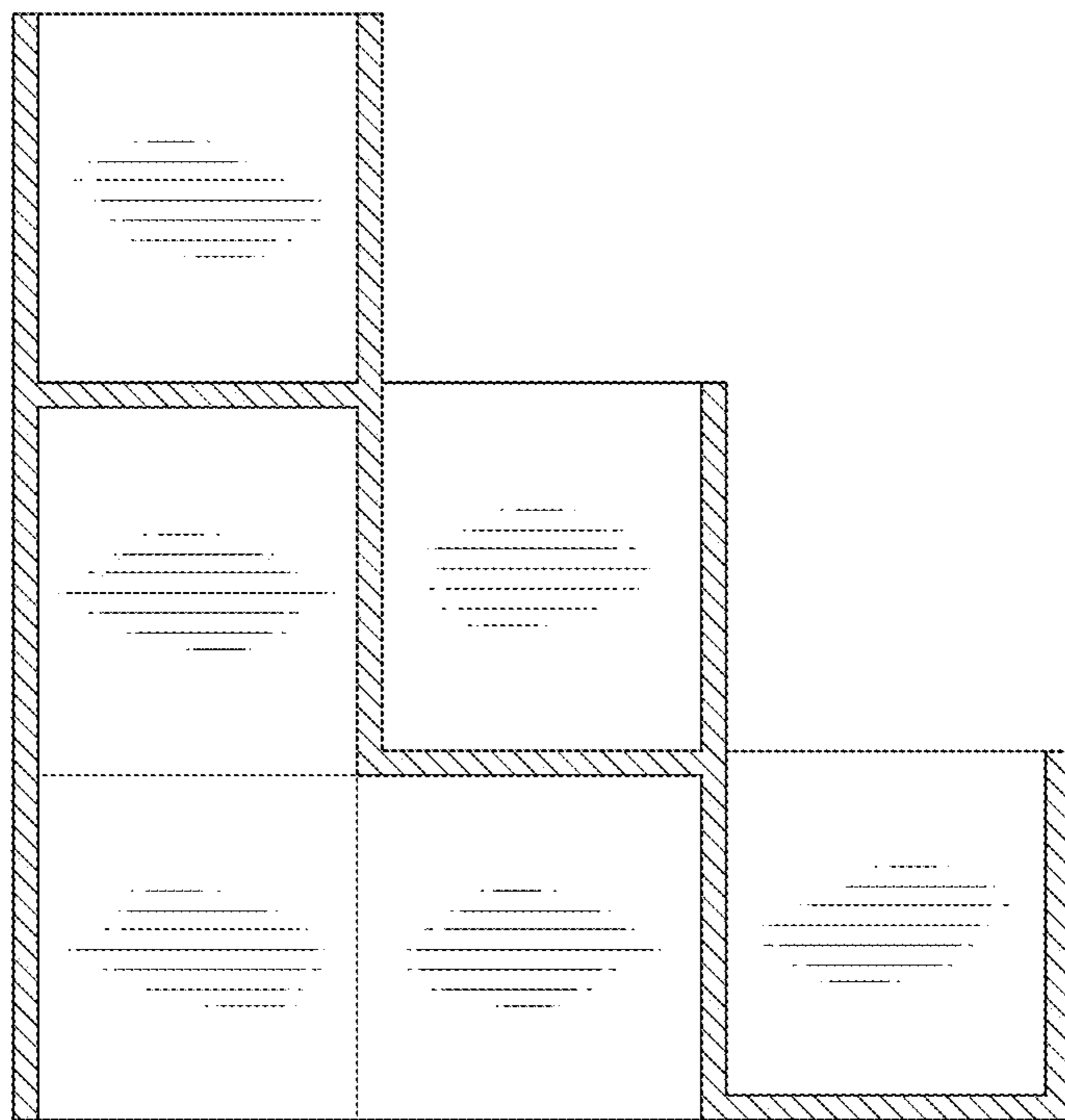
