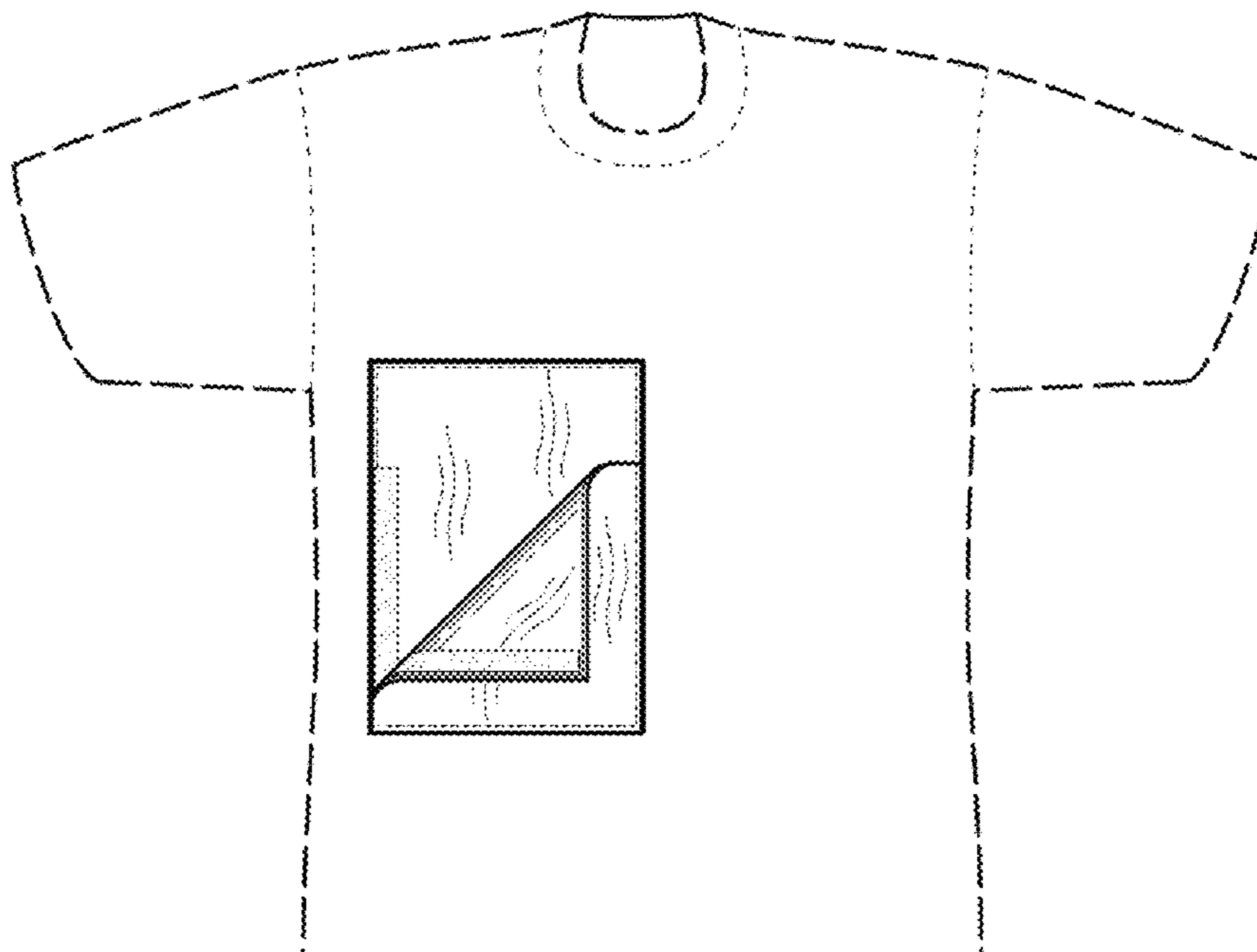
(57) **CLAIM**

I claim the ornamental design for a urostomy shirt, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a urostomy shirt in an inside out orientation embodying my new design;  
 FIG. 2 is a top plan view of the shirt in an inside out orientation;  
 FIG. 3 is a bottom plan view of the shirt in an inside out orientation;  
 FIG. 4 is a rear elevational view of the shirt in an inside out orientation;  
 FIG. 5 is a right side elevational view of the shirt in an inside out orientation;  
 FIG. 6 is a left side elevational view of the shirt in an inside out orientation; and,  
 FIG. 7 is a front elevational view of the shirt in an right side out orientation.  
 The large bold outer broken lines and the medium vertical lines at the top of the sleeves depict environmental structure that form no part of the claimed design. The small broken lines depict stitching in the urostomy shirt that form no part of the claimed design.  
 The broken lines illustrate environmental structure that form no part of the claimed designed.

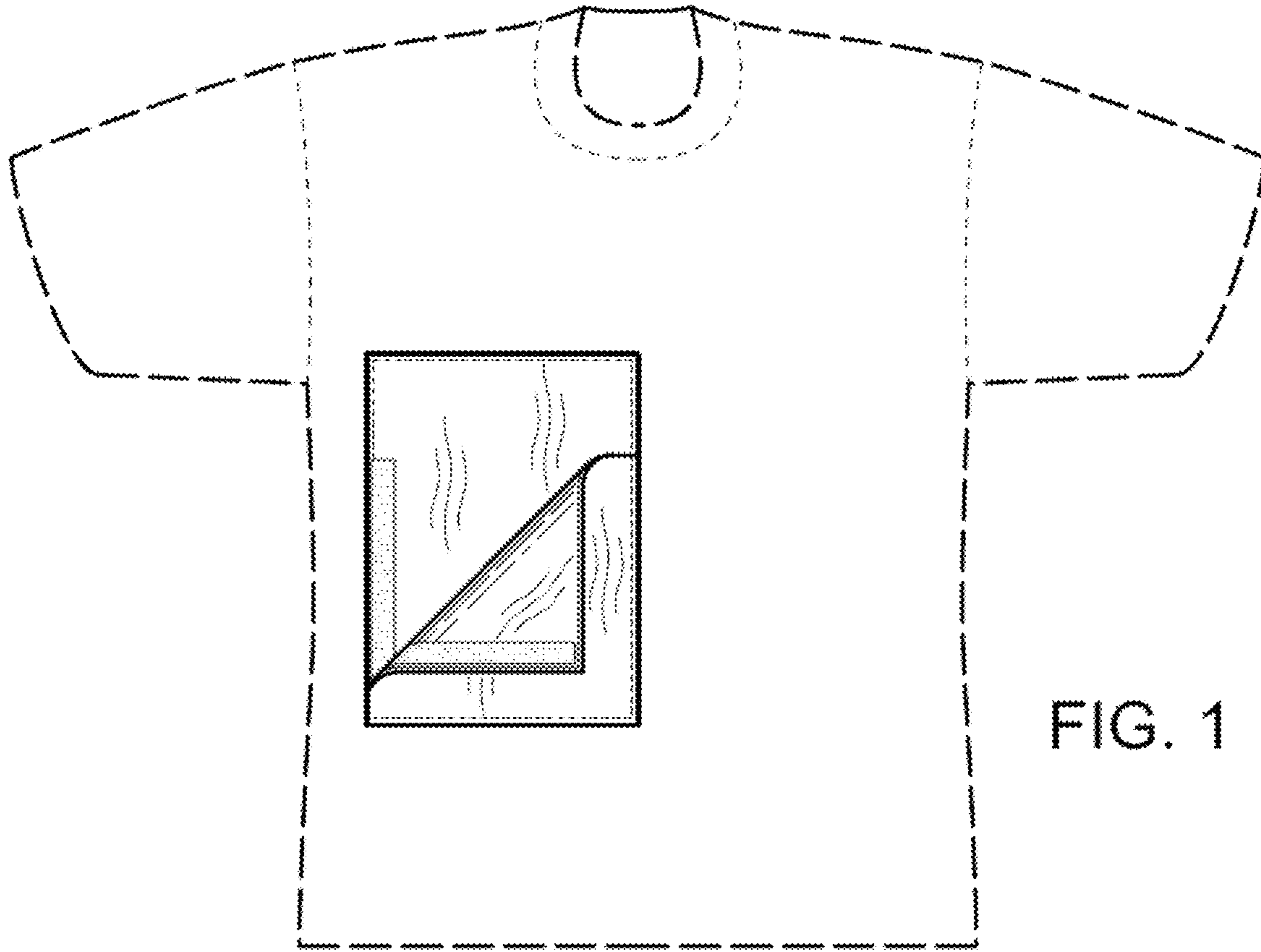

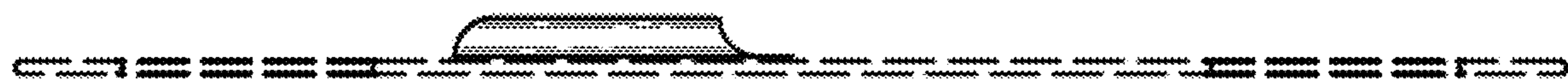

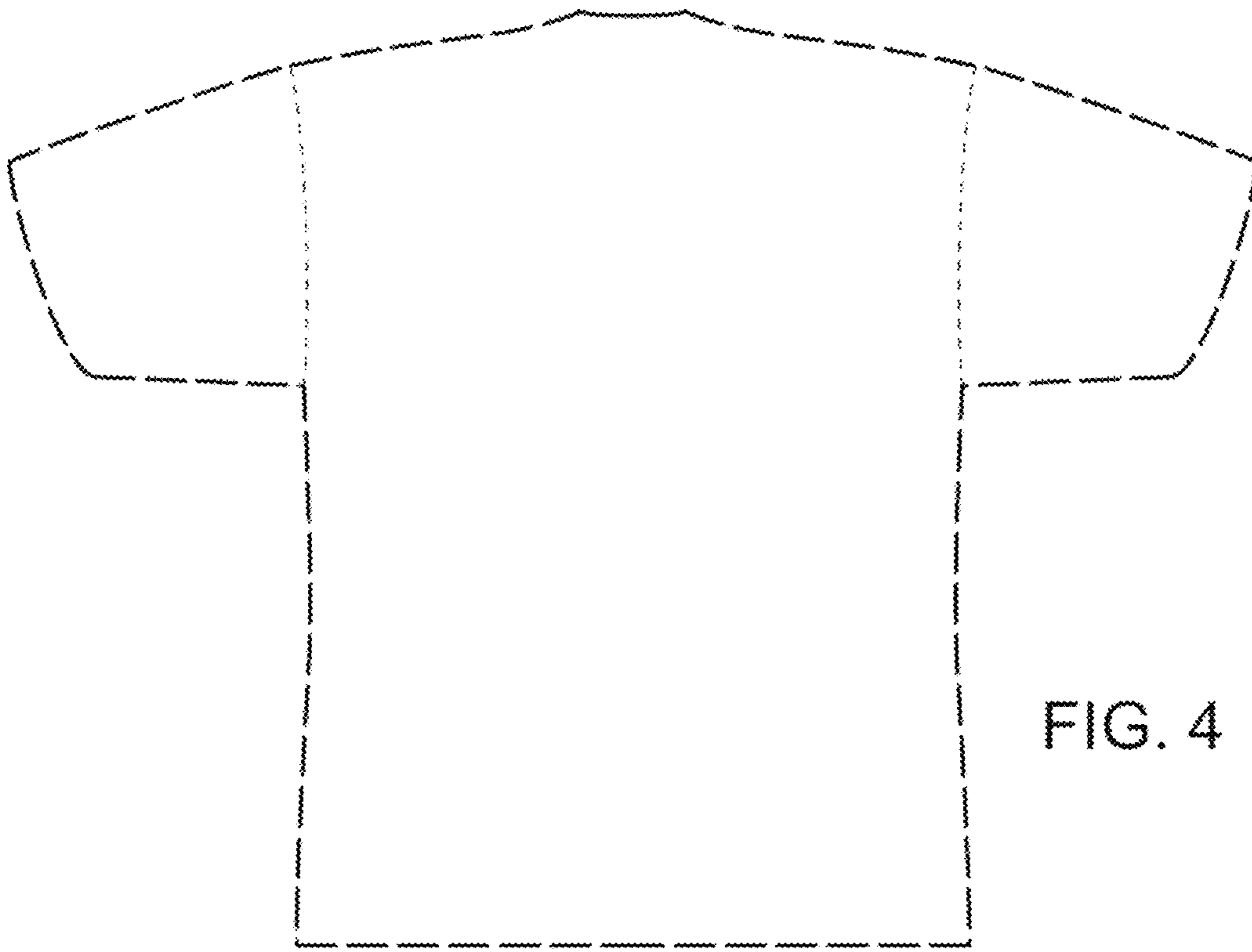

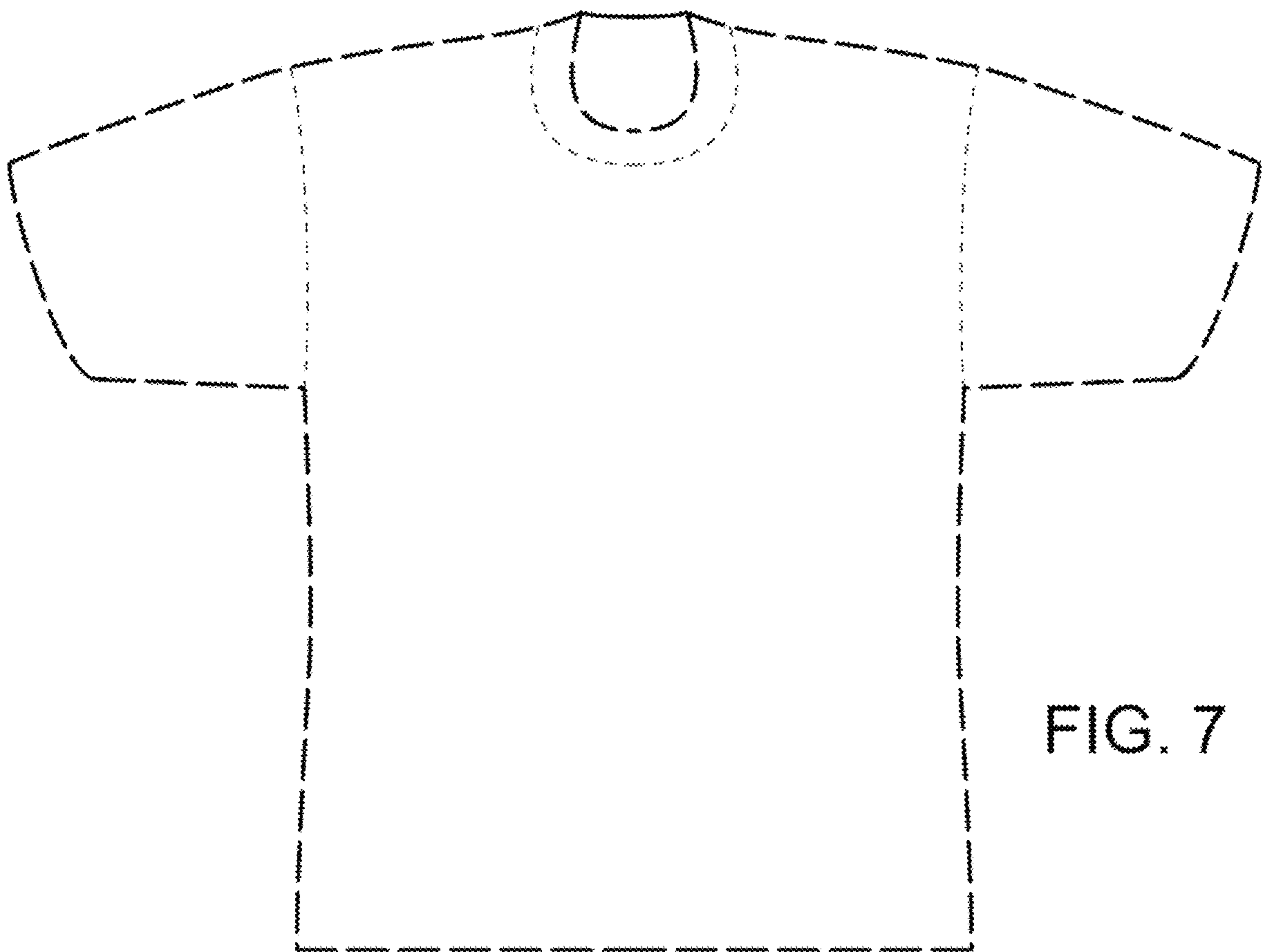
