The ornamental design for a bib scarf, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a first embodiment of a bib scarf in an open position.

FIG. 2 is a front elevation view of the first embodiment of the bib scarf the open position.

FIG. 3 is a back elevation view of the first embodiment of the bib scarf in the open position.

FIG. 4 is a left side elevation view of the first embodiment of the bib scarf in the open position.

FIG. 5 is a right side elevation view of the first embodiment of the bib scarf in the open position.

FIG. 6 is a top plan view of the first embodiment of the bib scarf in the open position.

FIG. 7 is a bottom plan view of the first embodiment of the bib scarf in the open position.

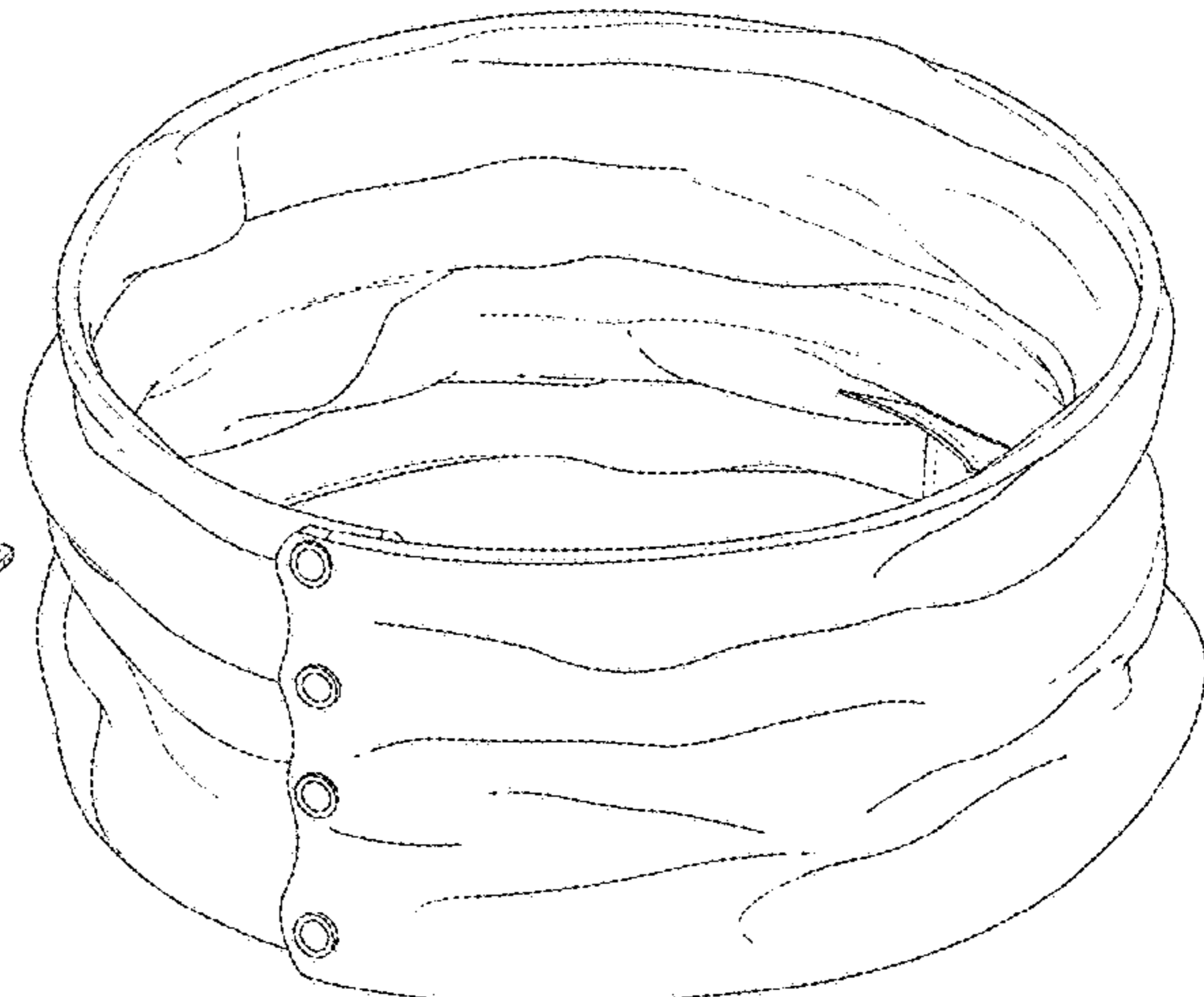
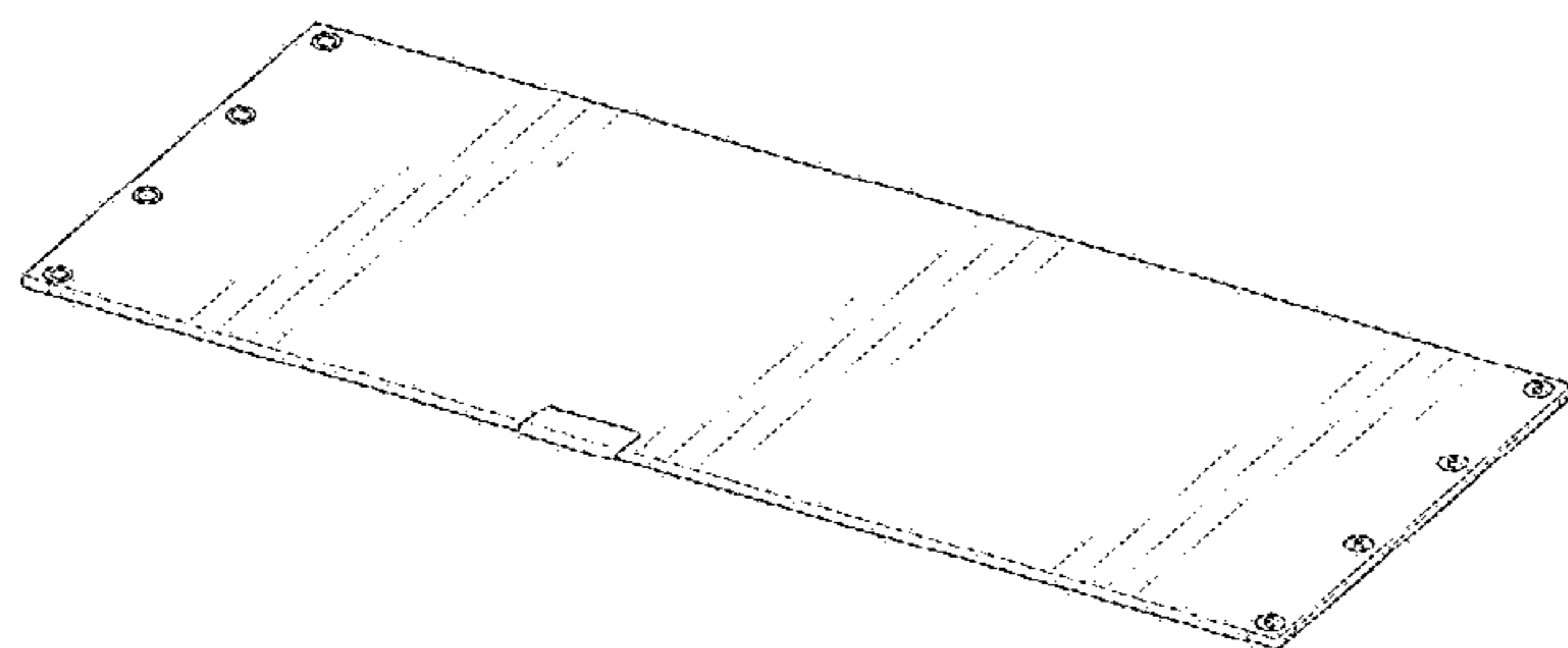

FIG. 27 is a top plan view of the second embodiment of the bib scarf in the closed position.

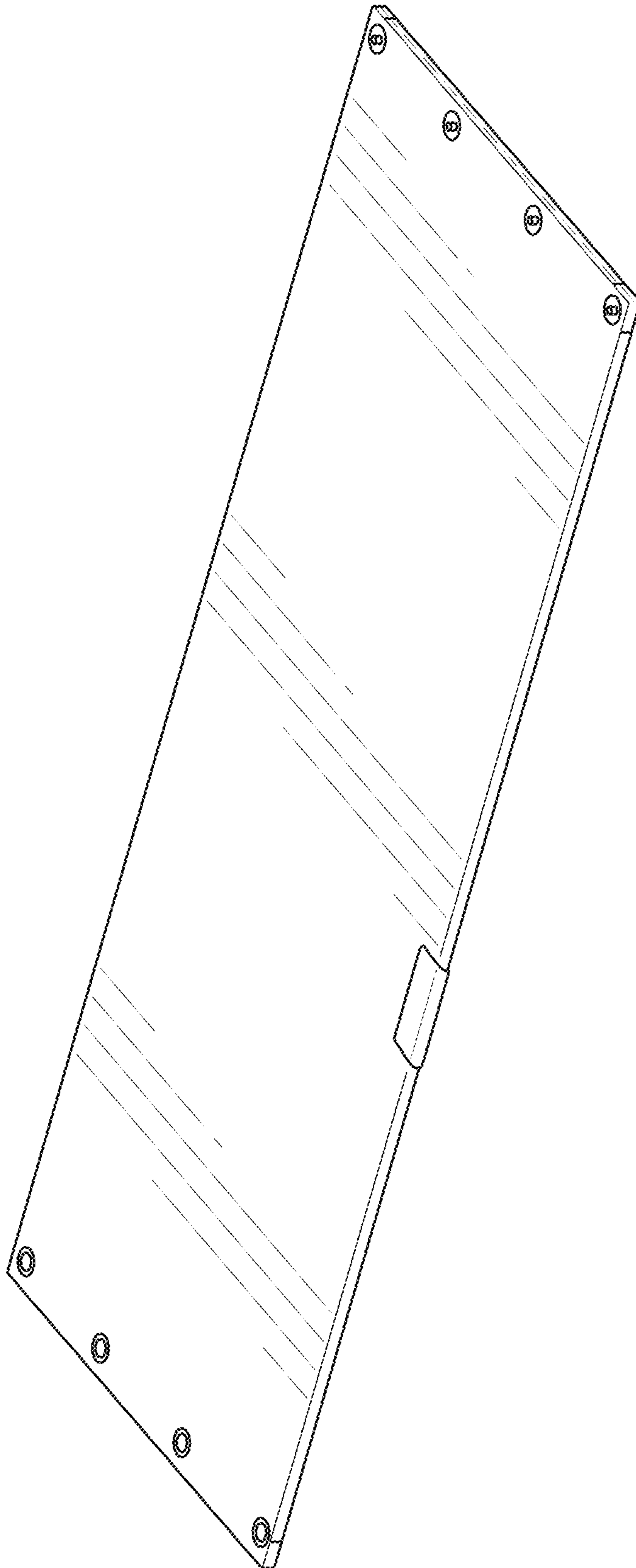
FIG. 28 is a bottom plan view of the second embodiment of the bib scarf in the closed position; and,

The broken lines shown as small dashed lines represent portions of the bib scarf that form no part of the claimed design.

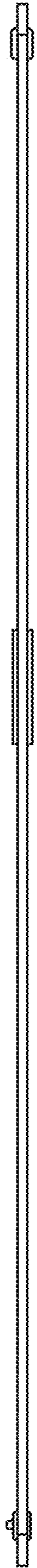

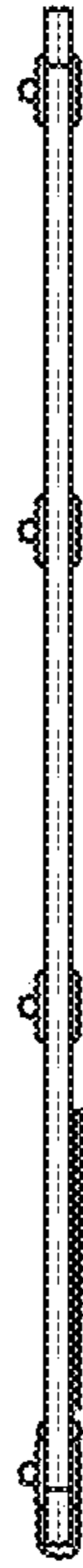

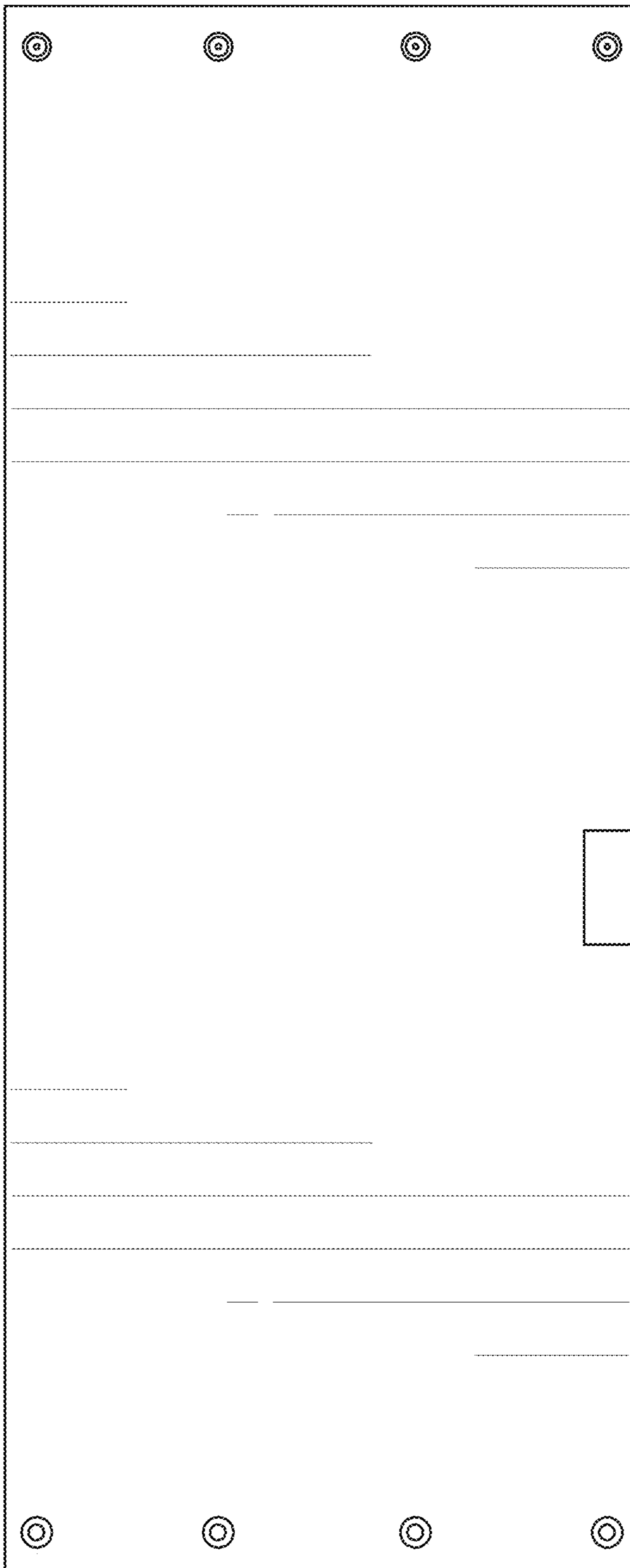




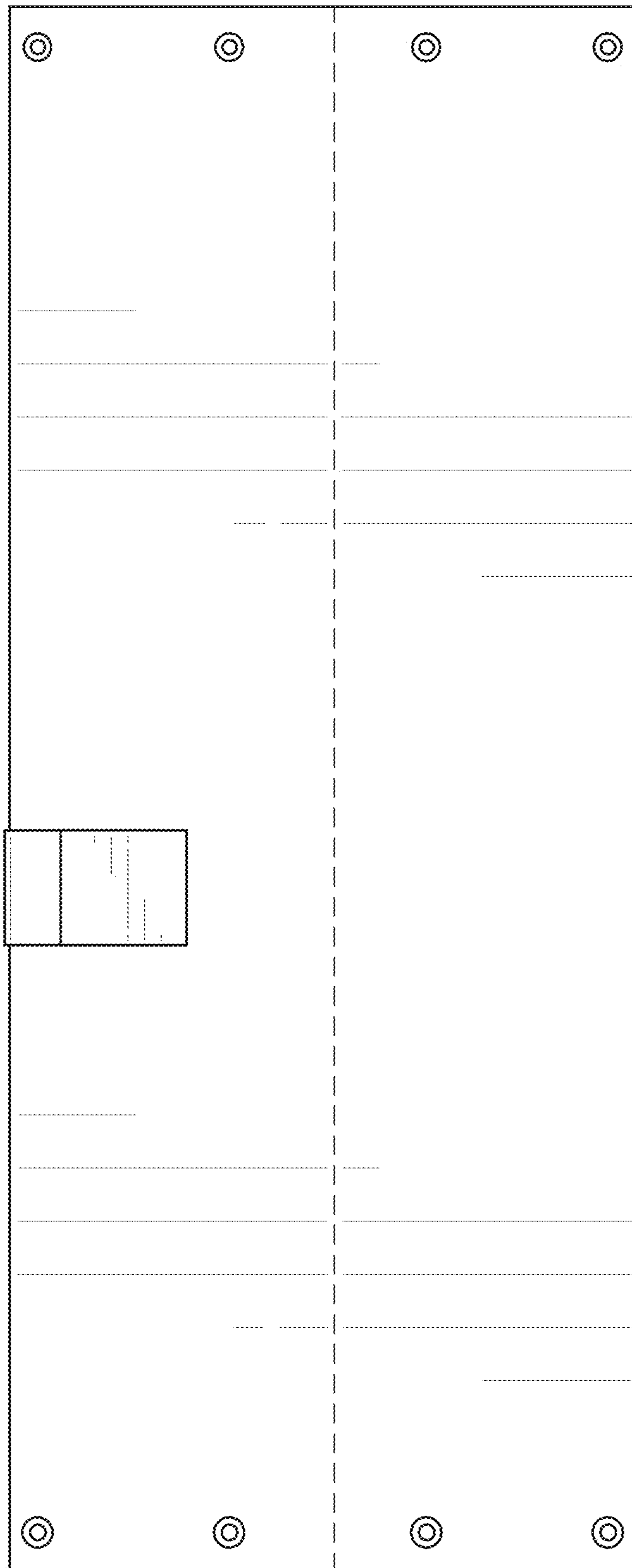

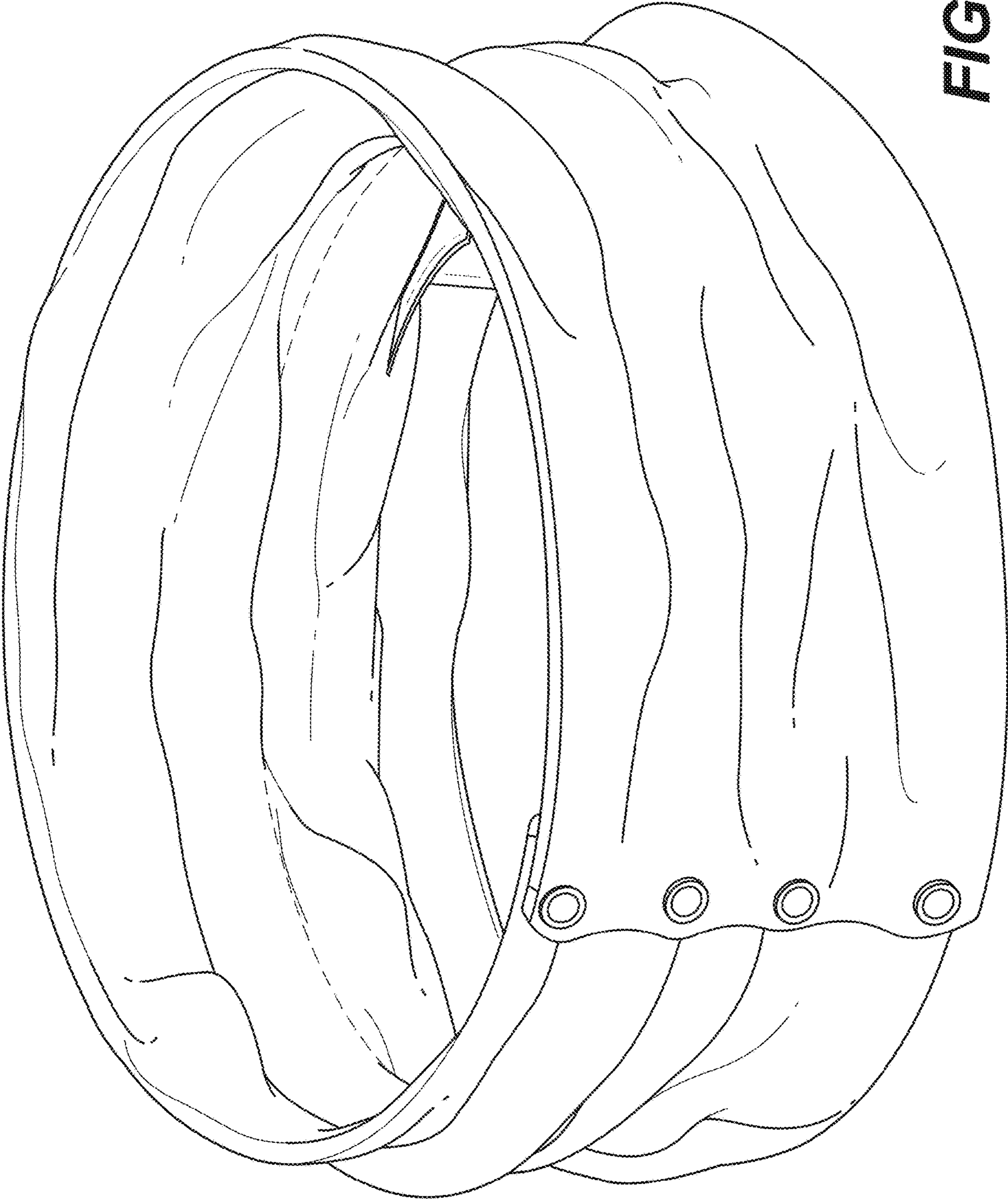
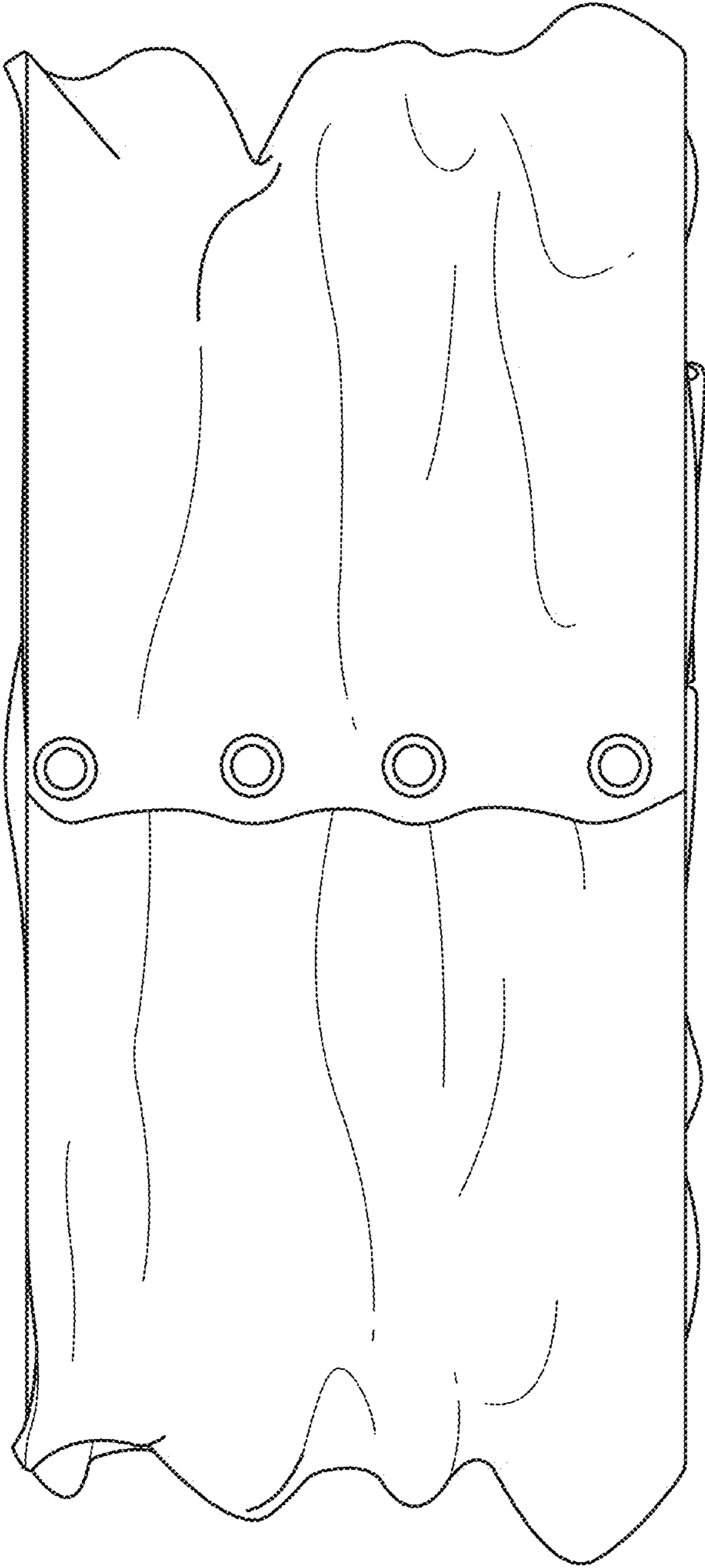
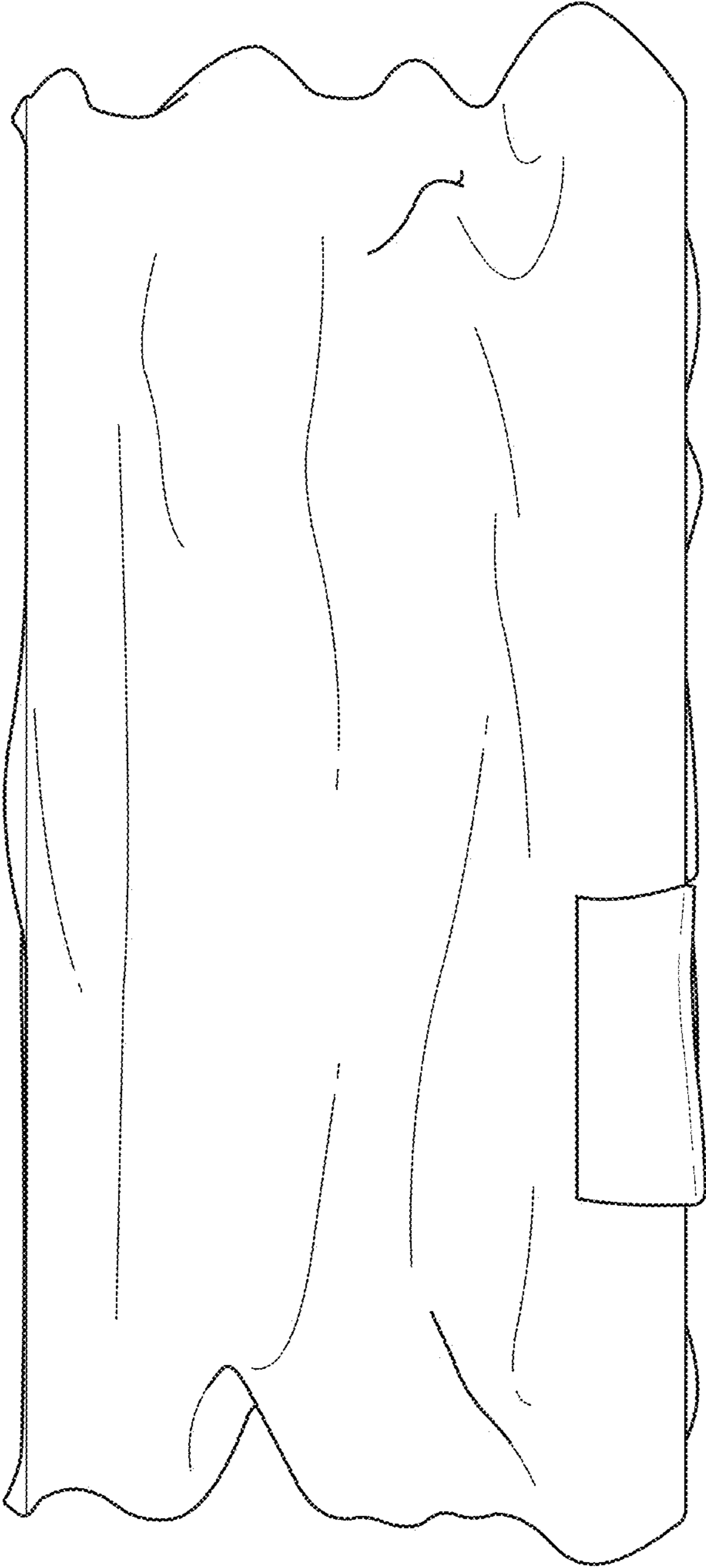

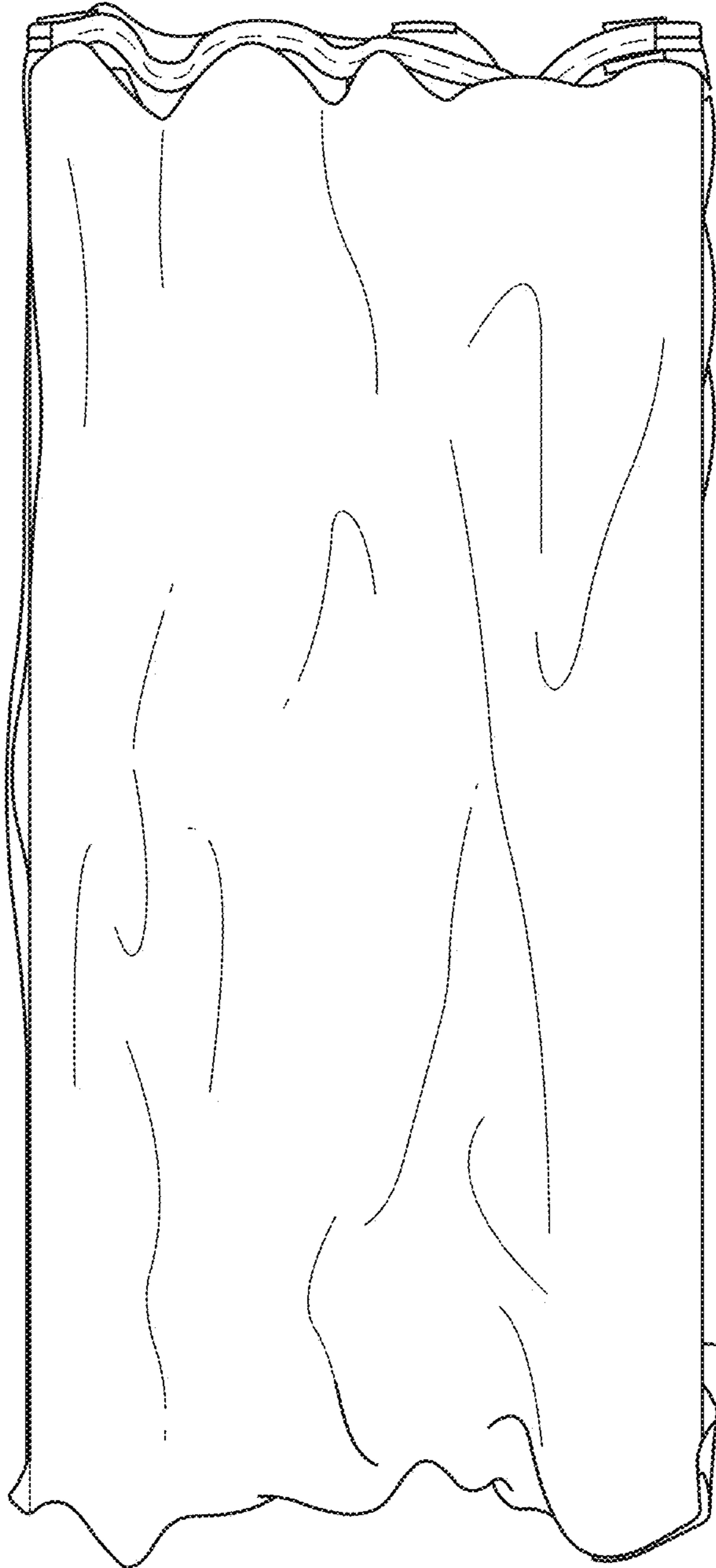




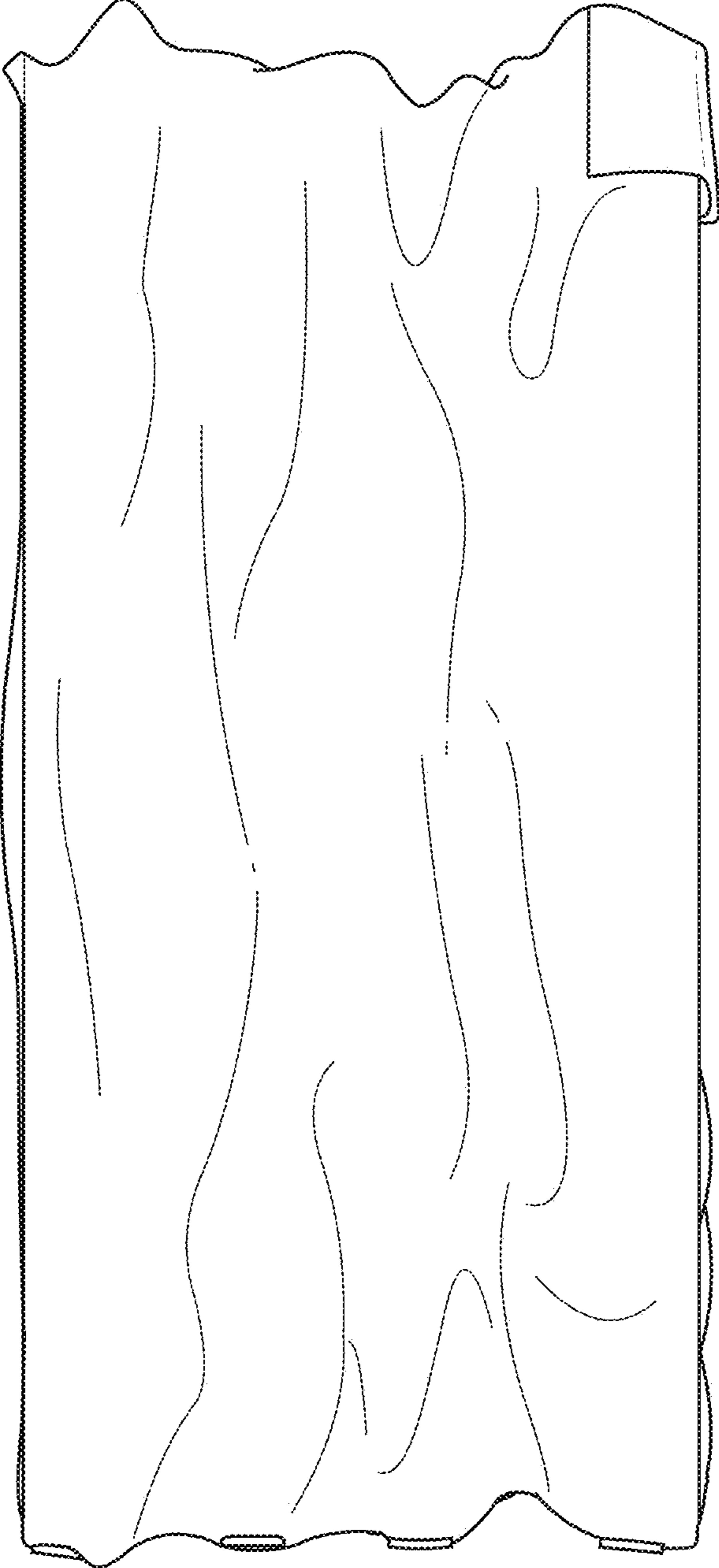

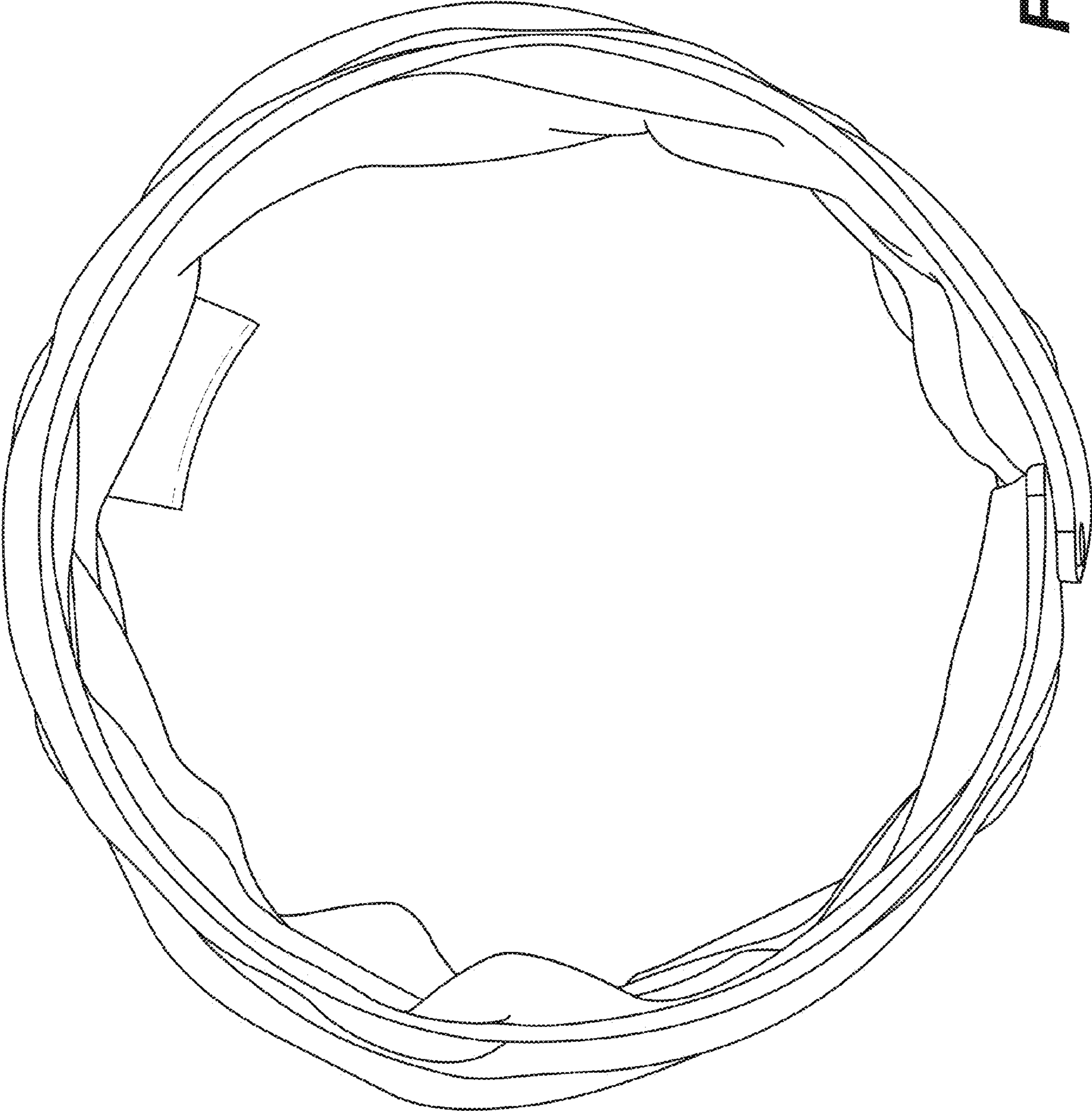
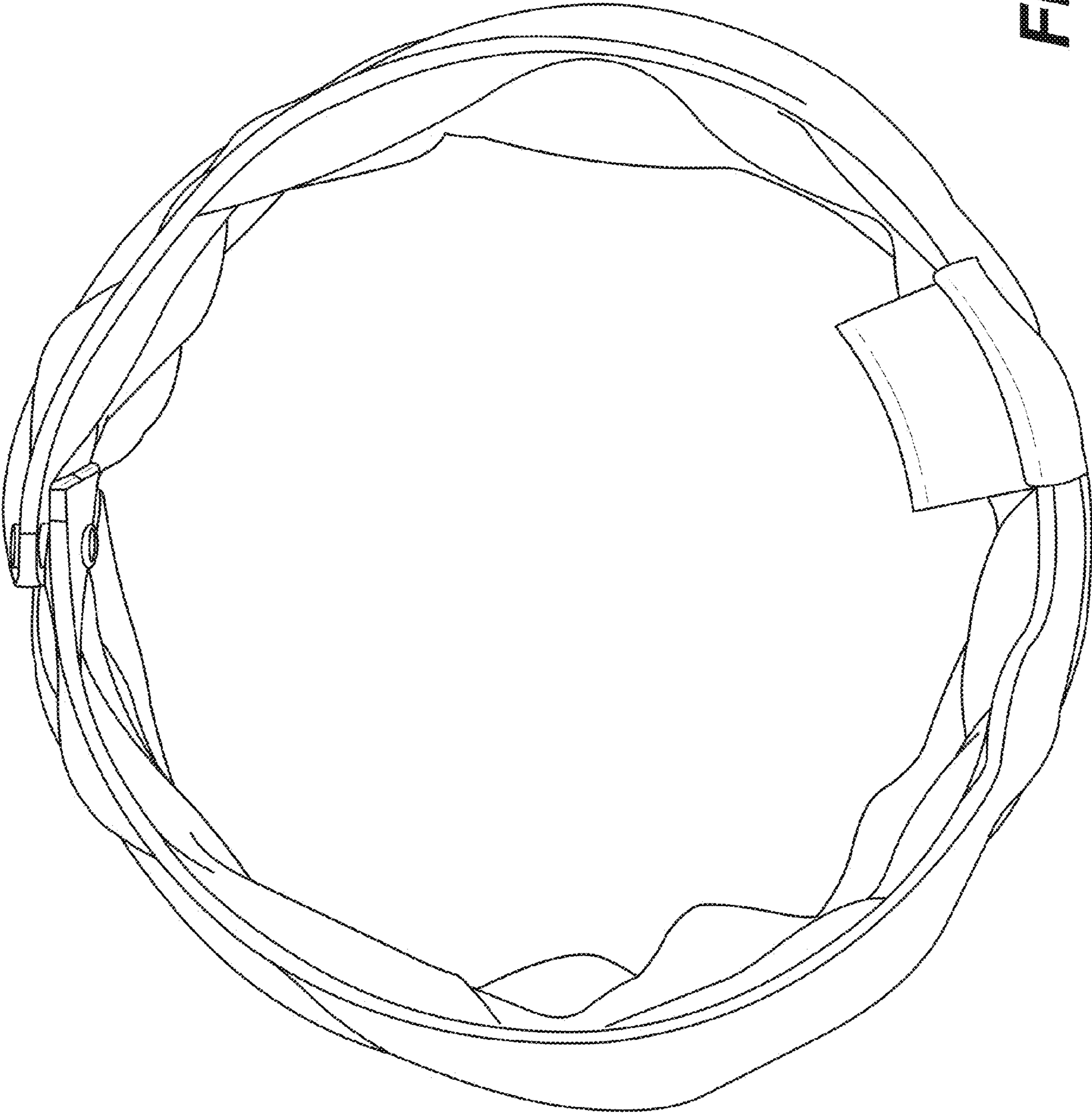
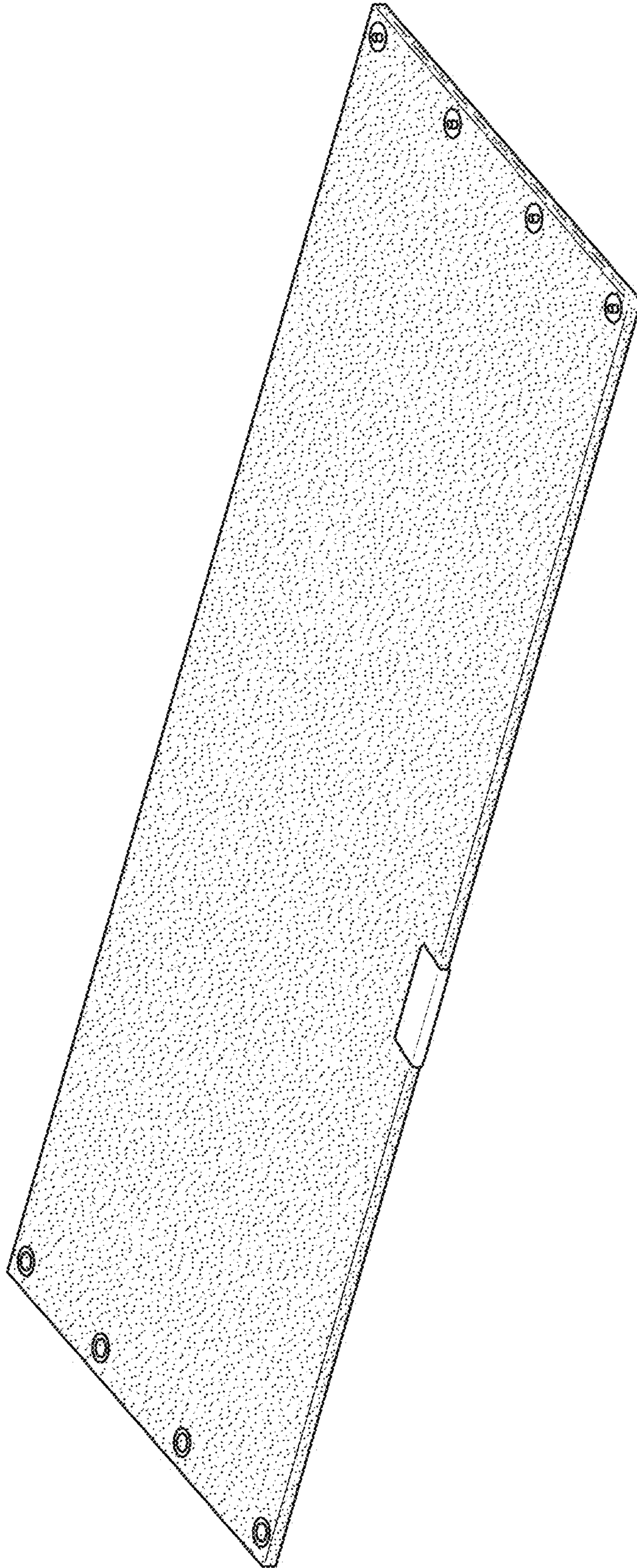

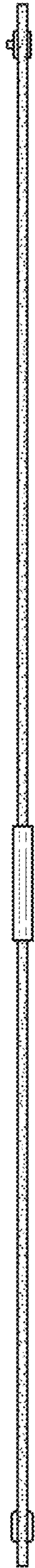

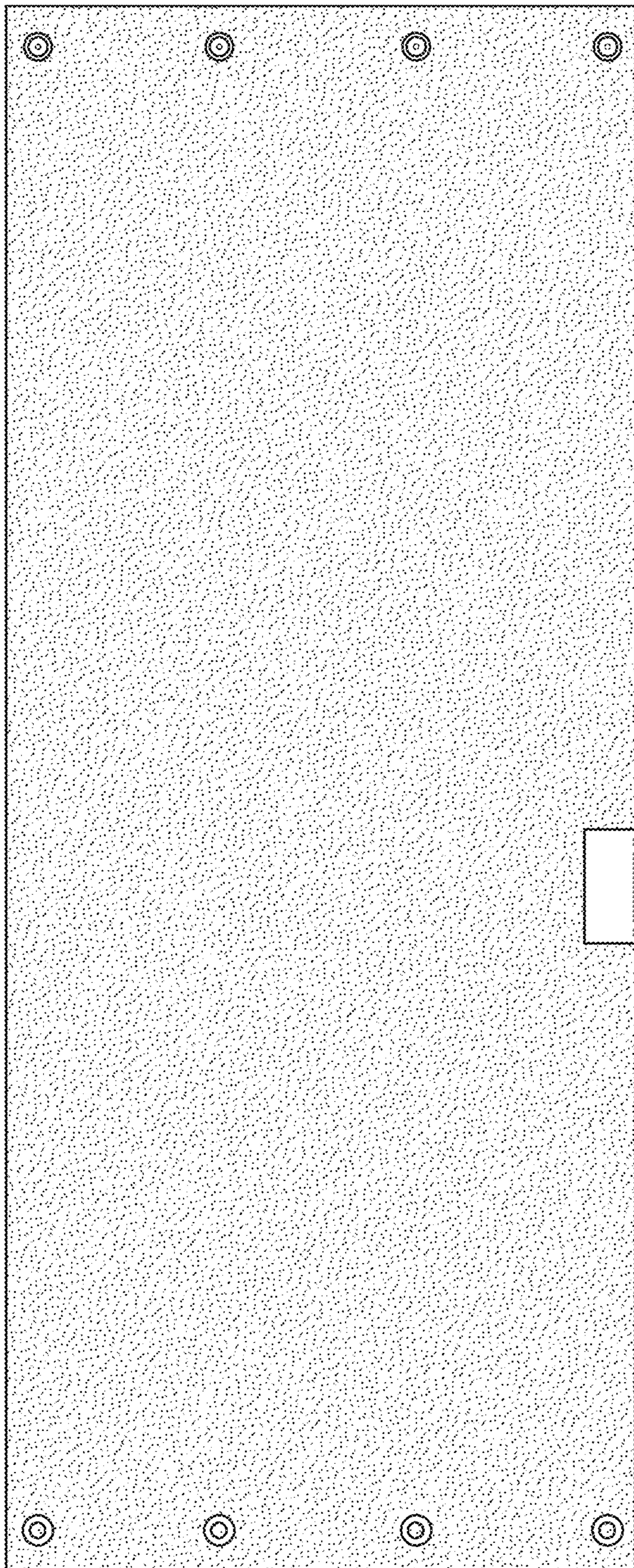

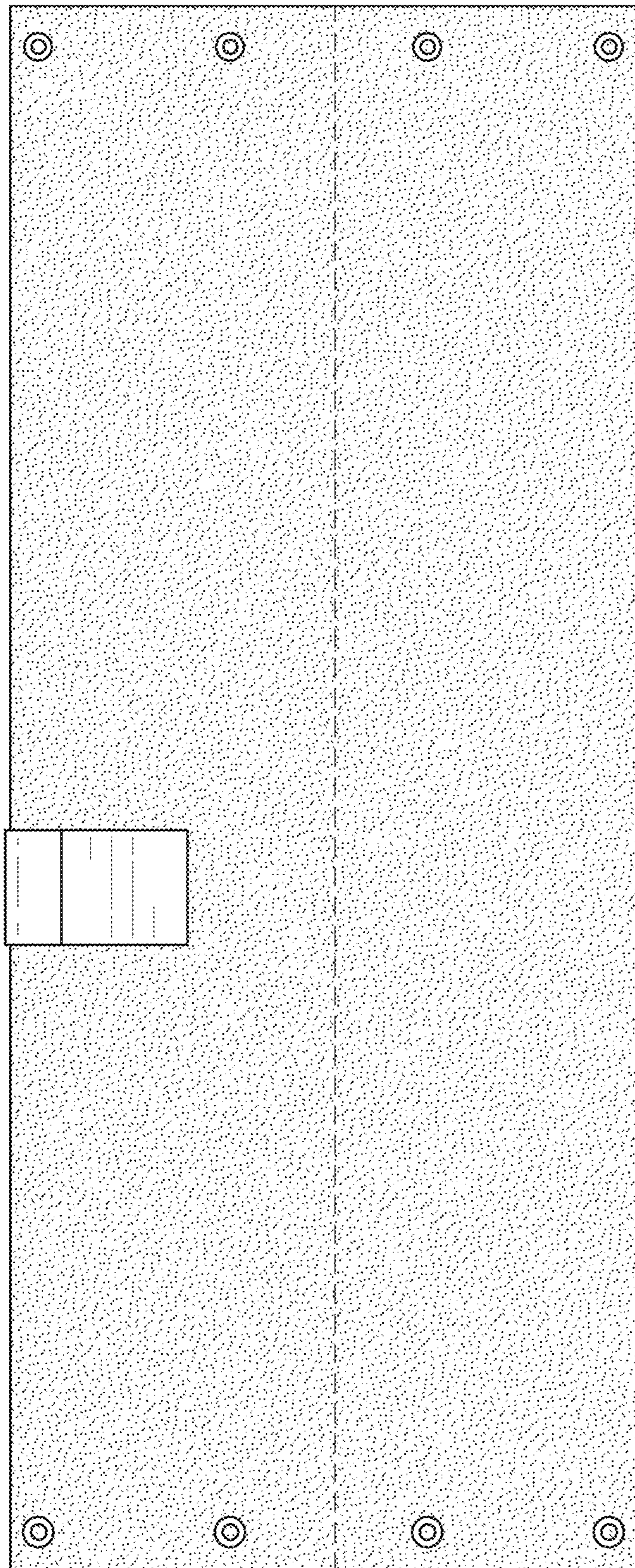

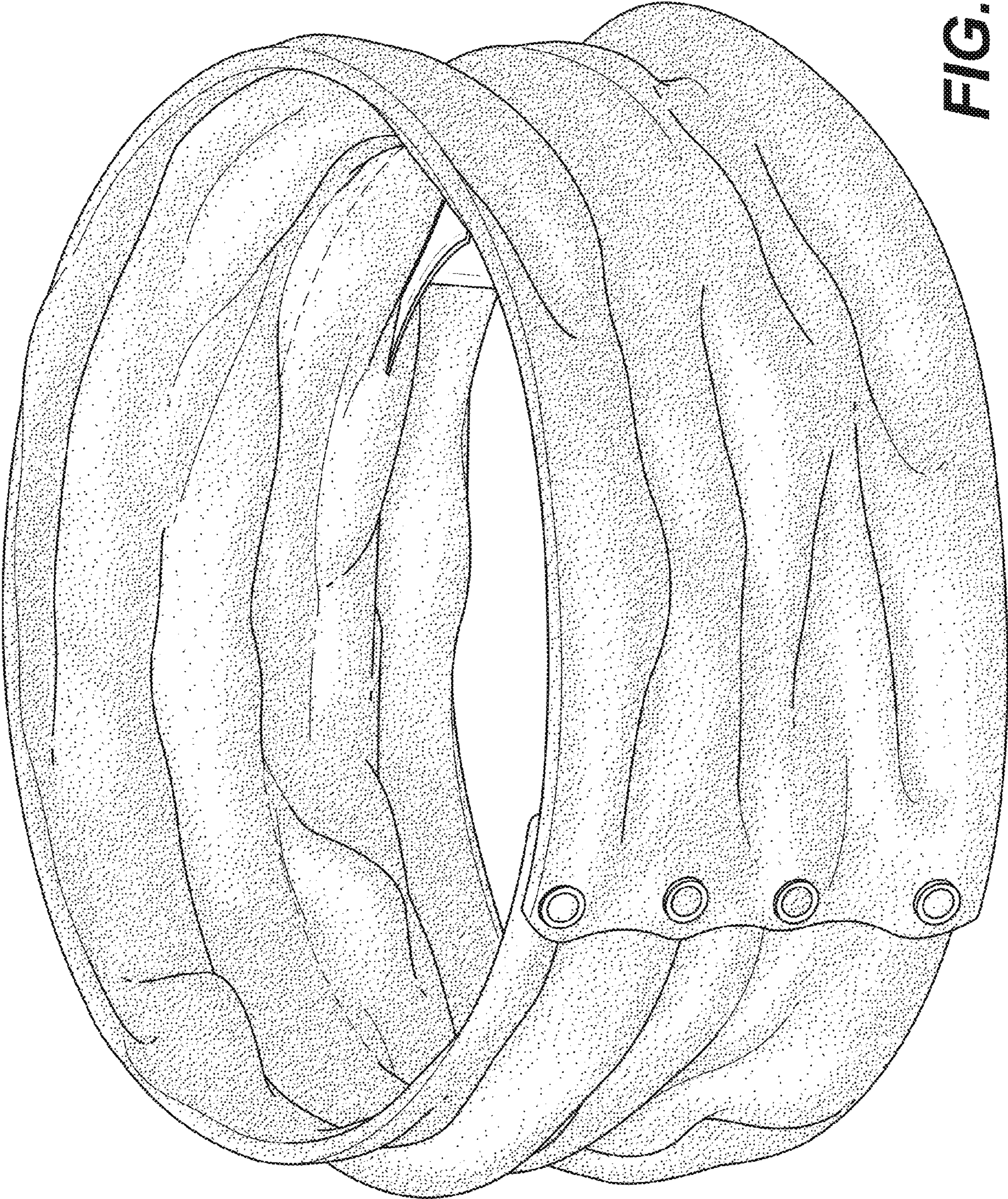
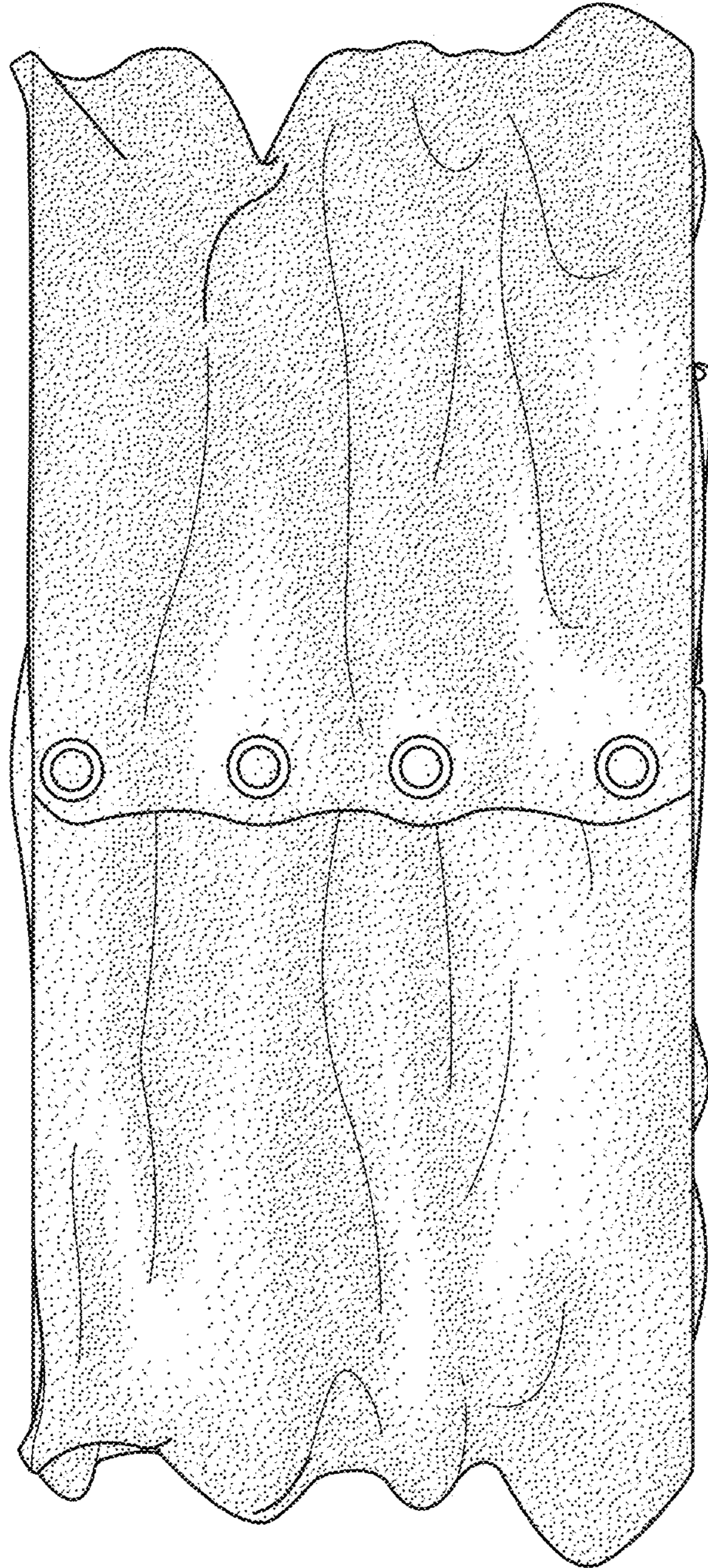
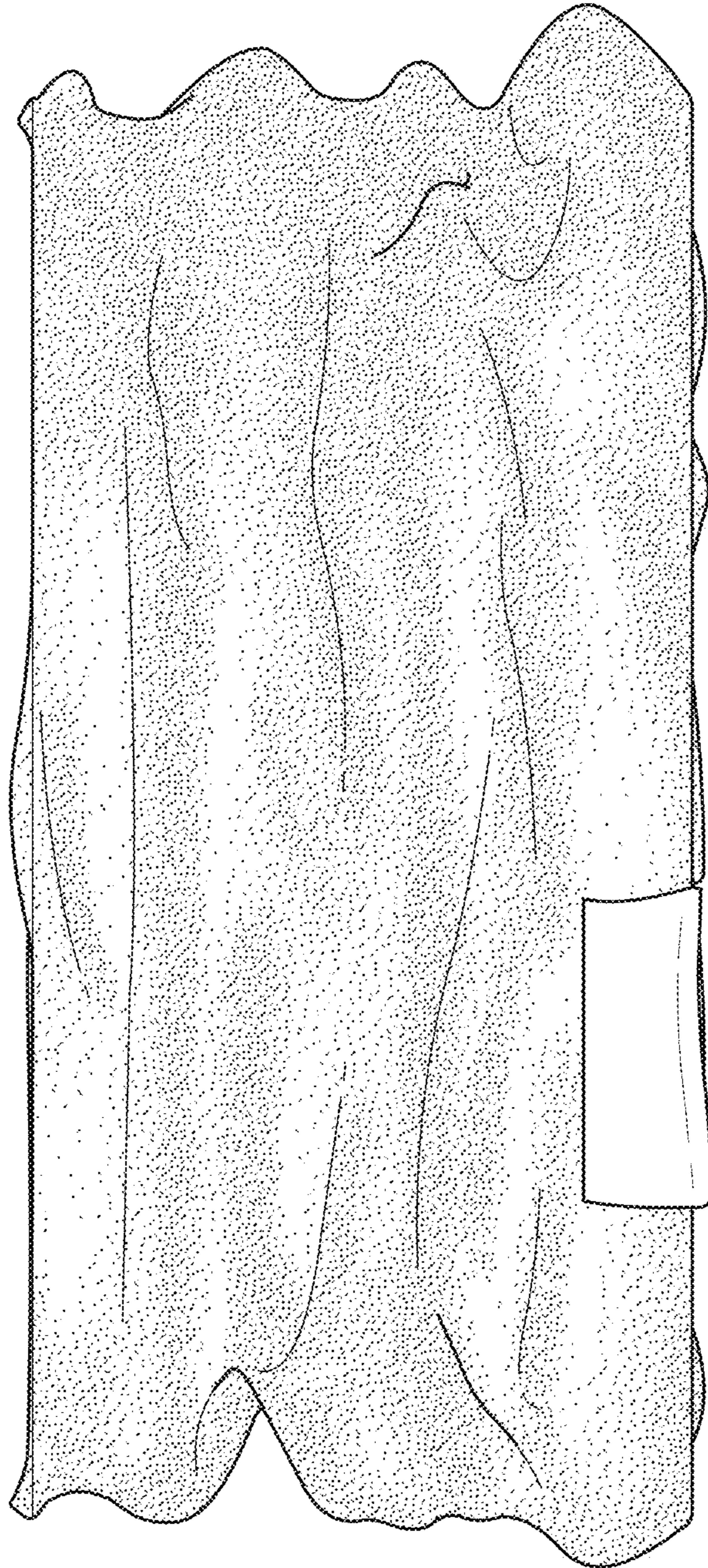

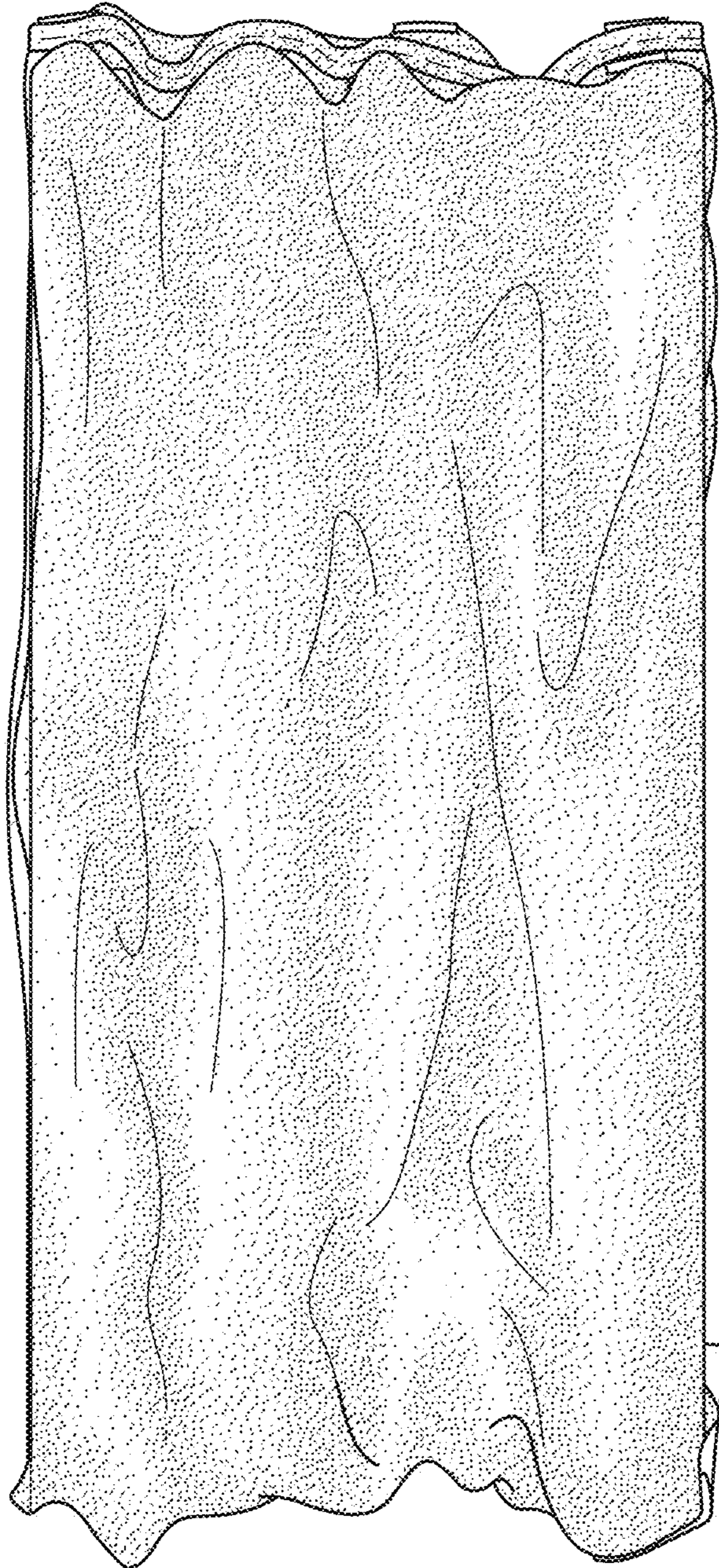

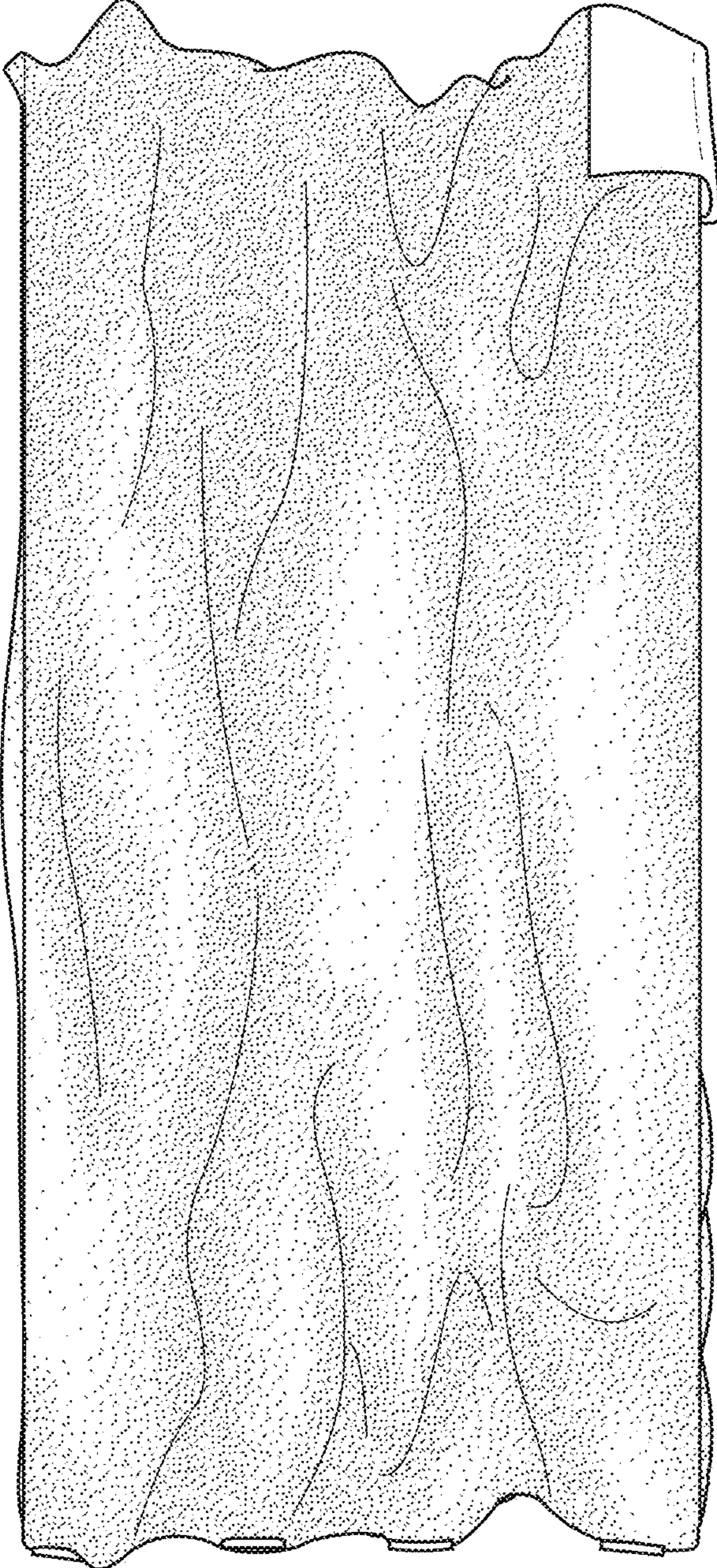

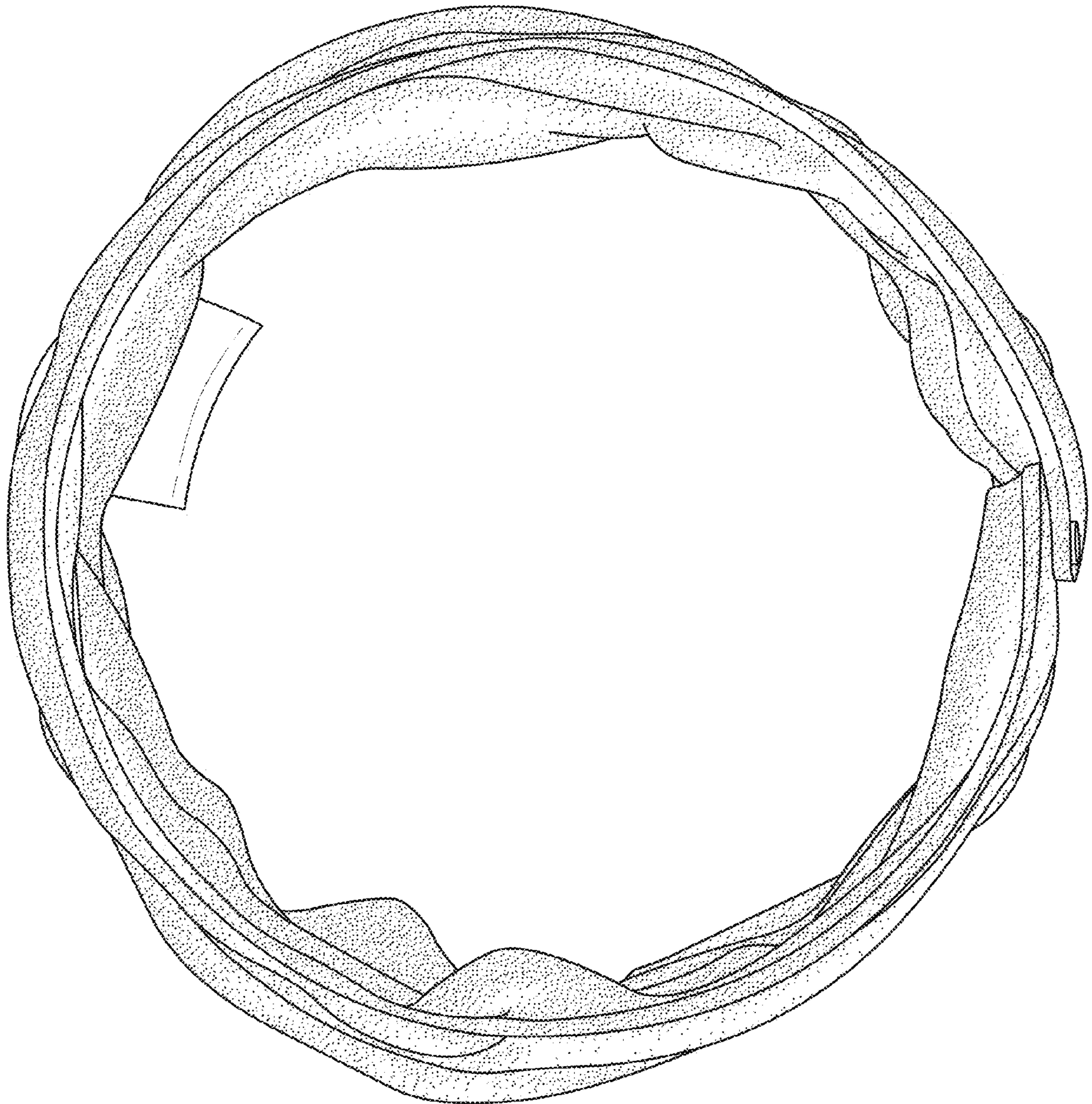

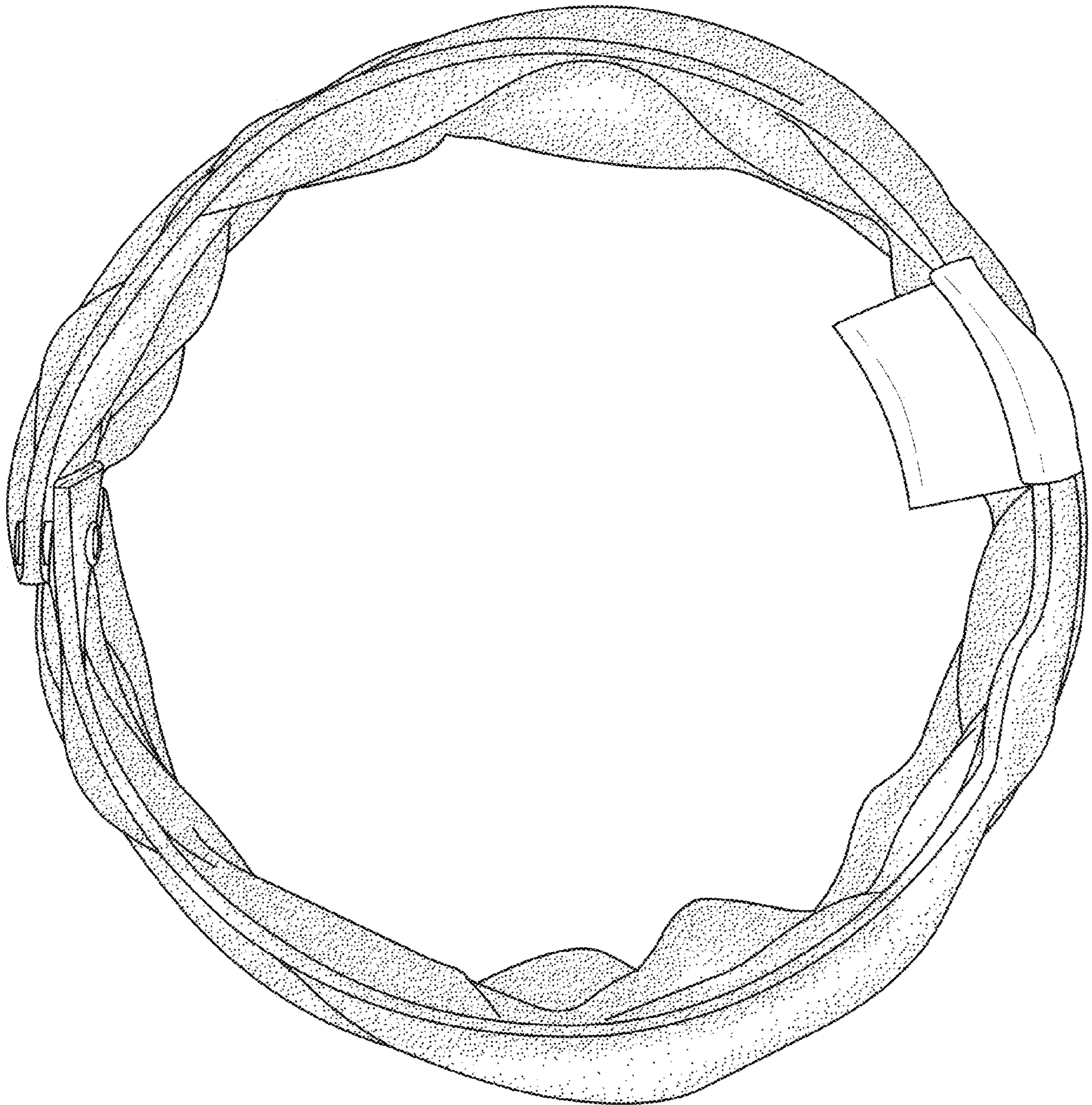
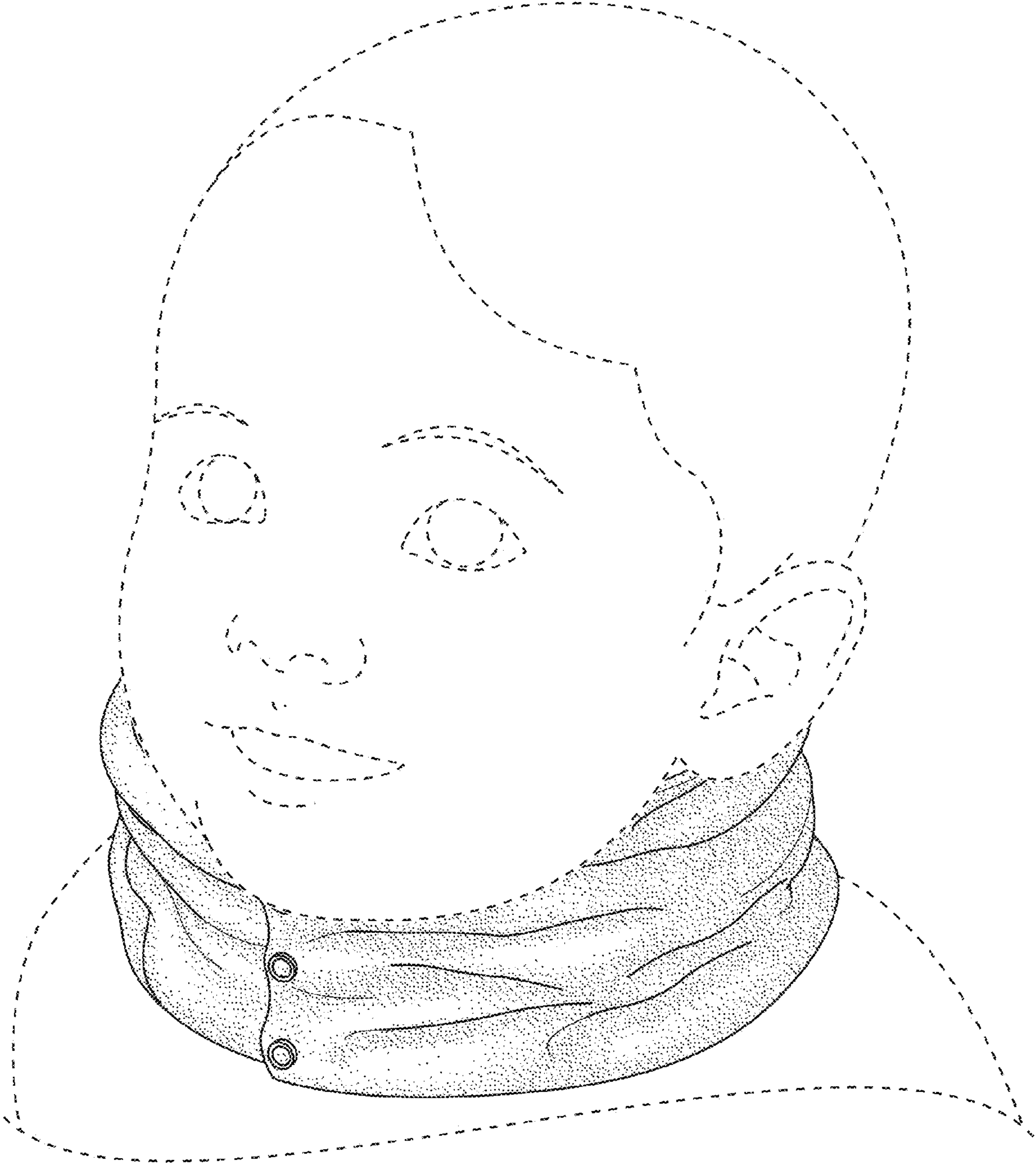
