(57) **CLAIM**

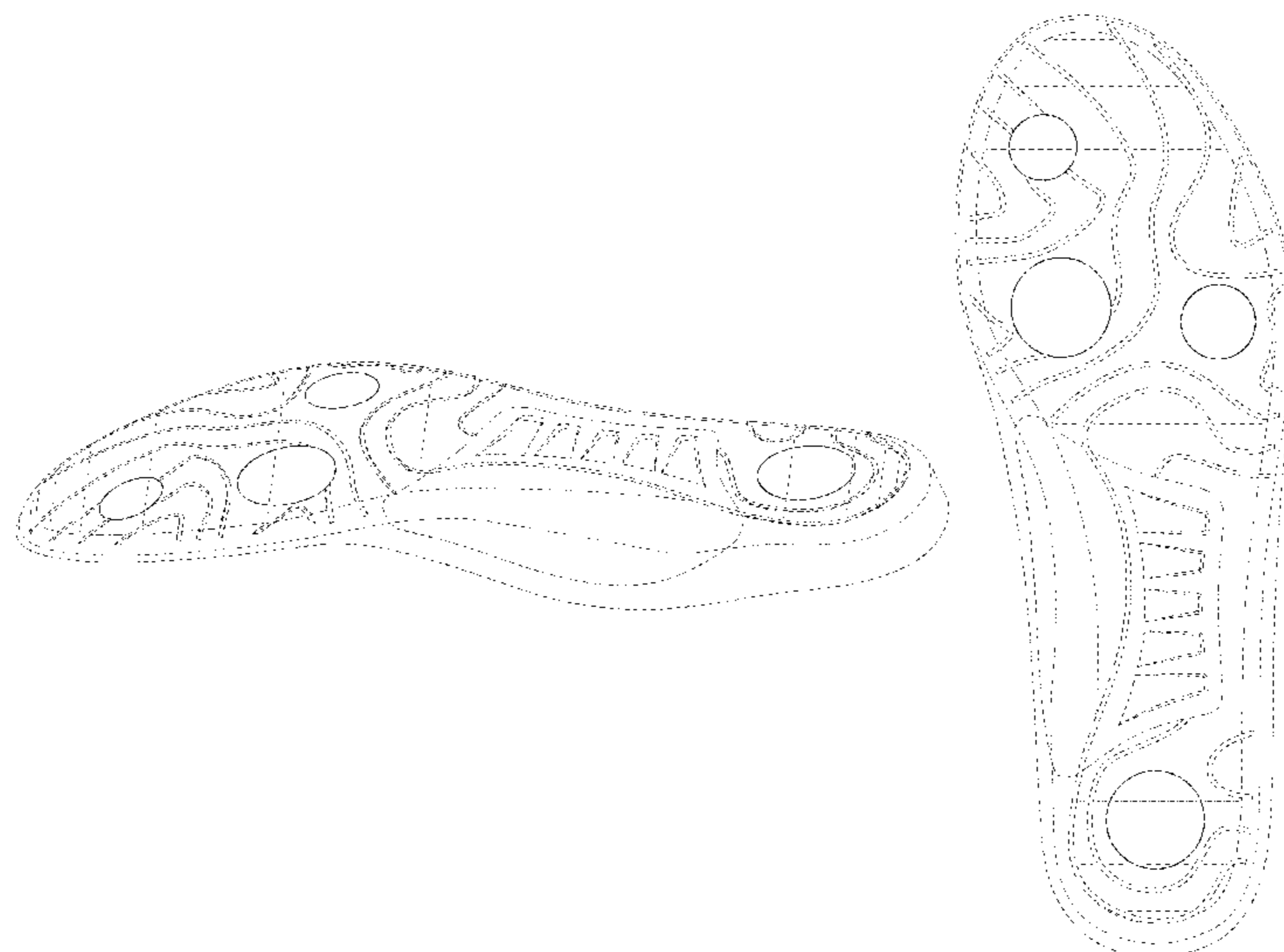
The ornamental design for a footbed, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom, front, left-side perspective view of a footbed according to our new design;

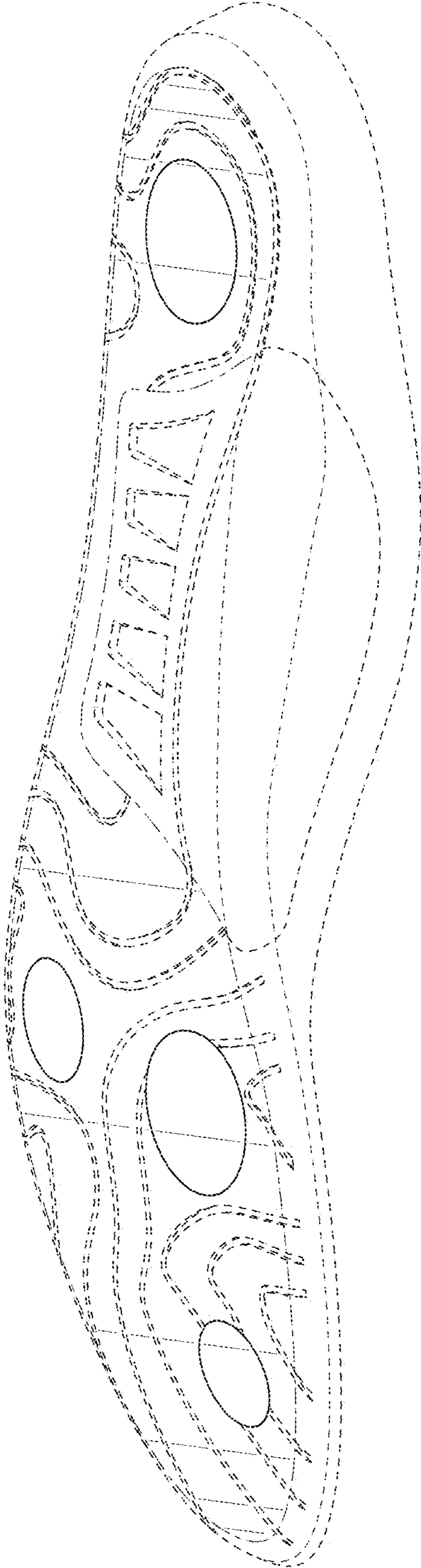

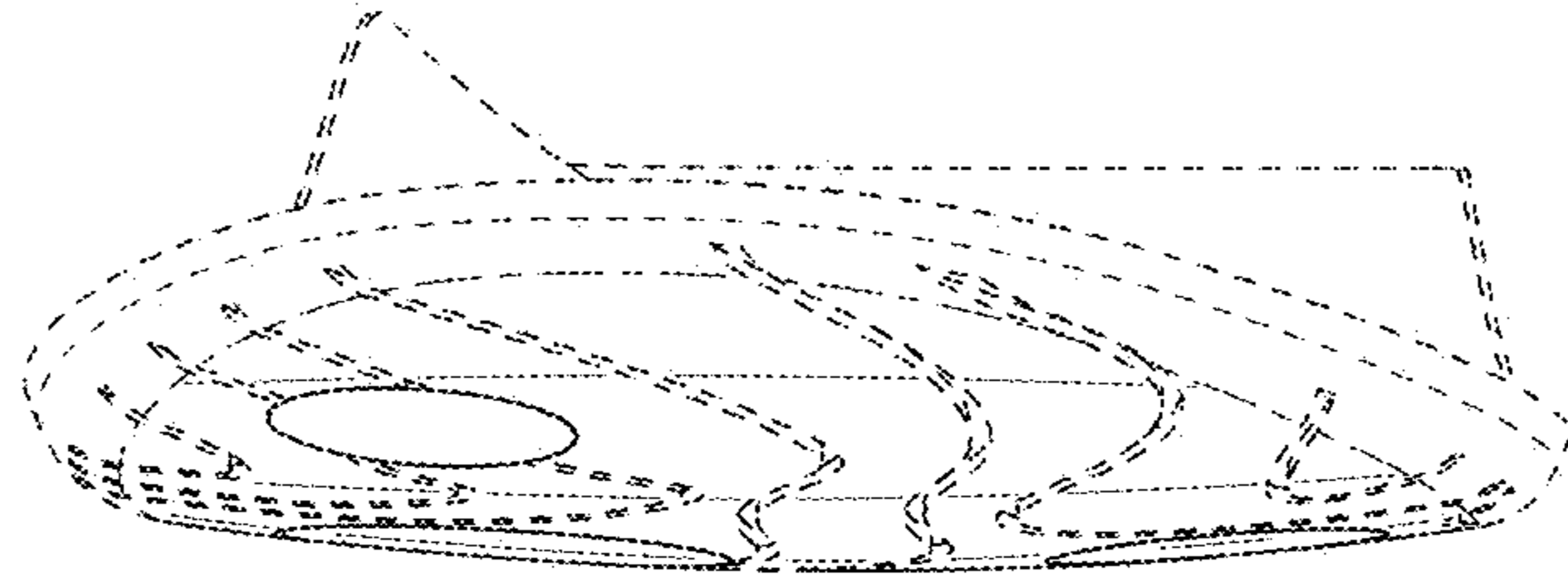

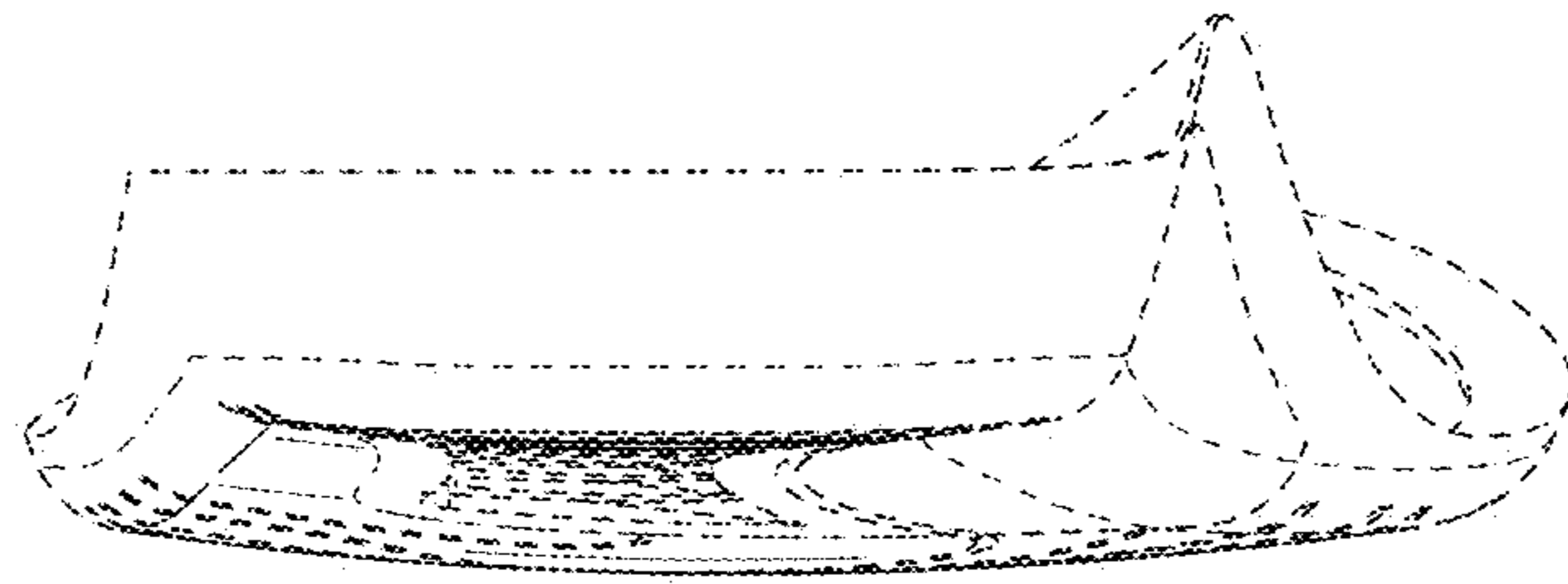

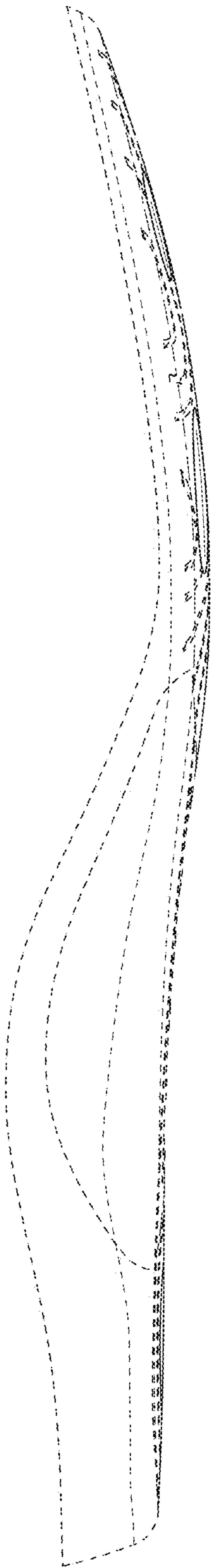

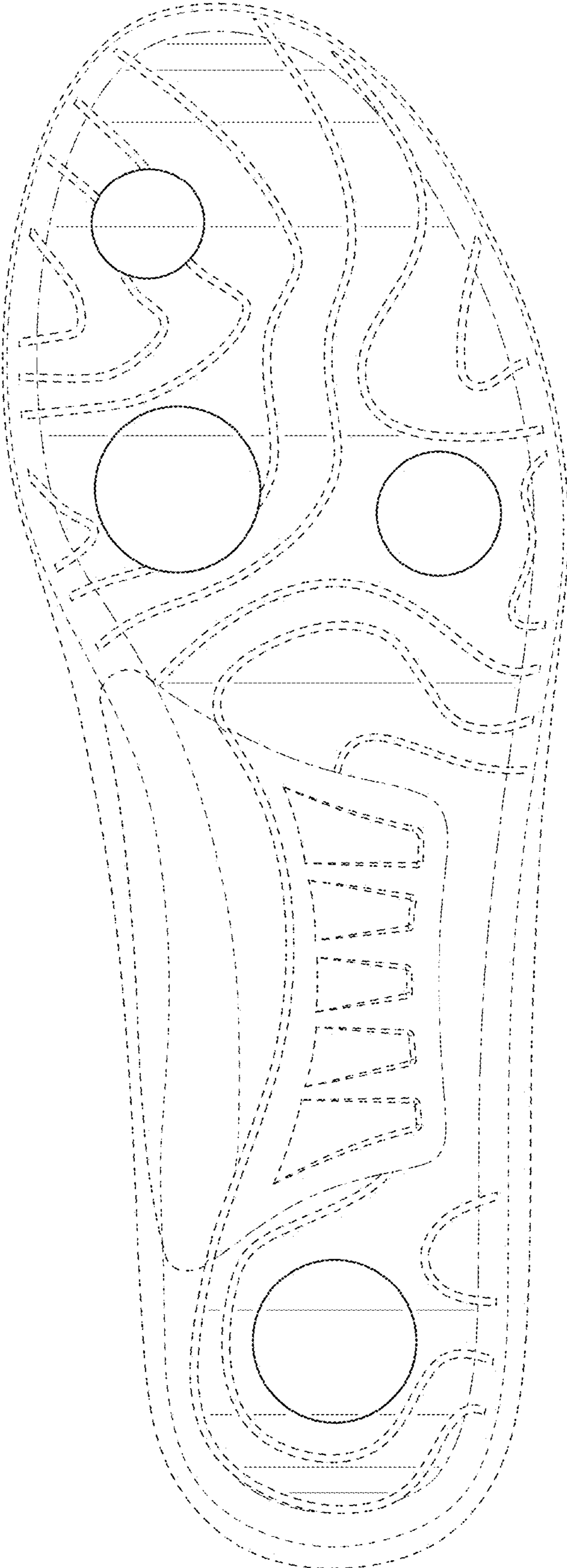

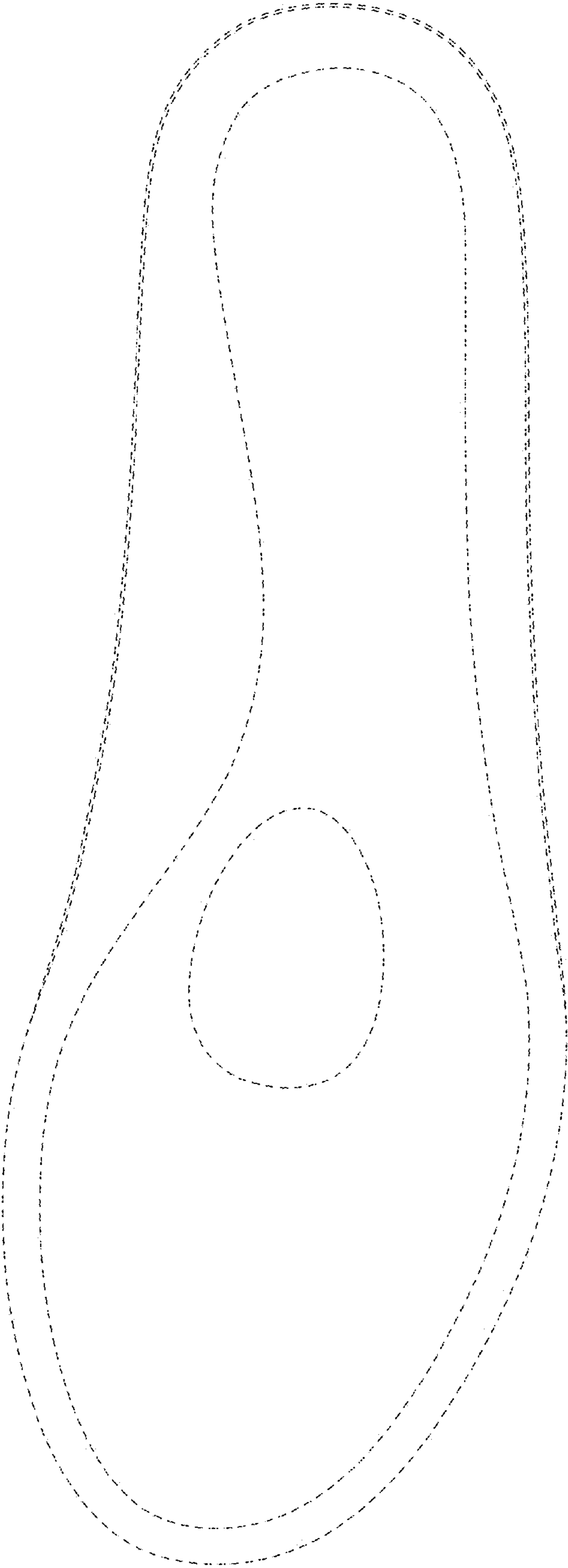

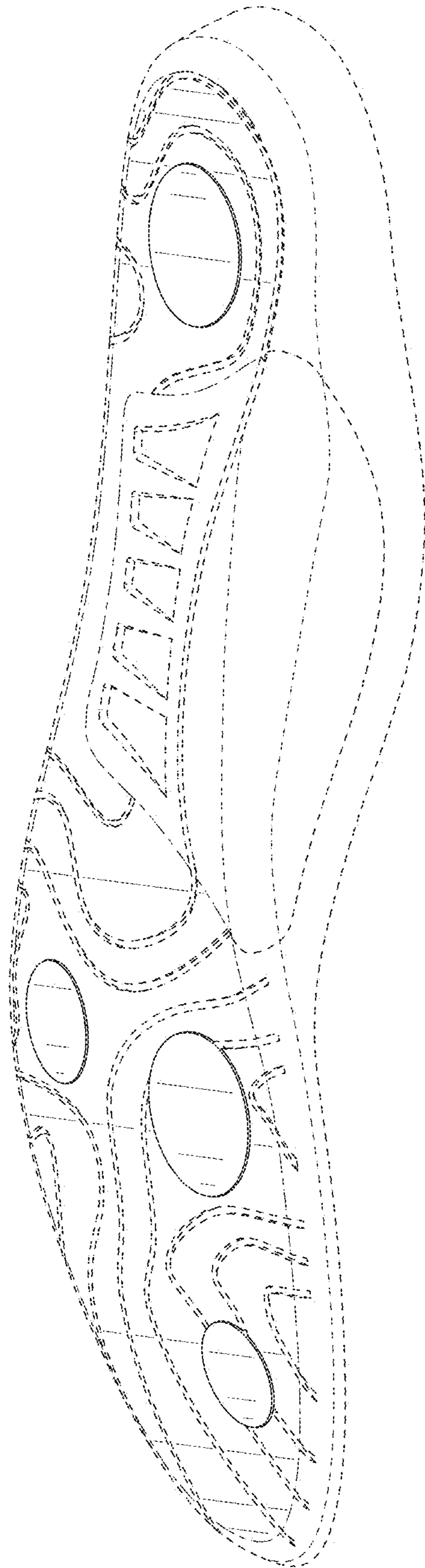

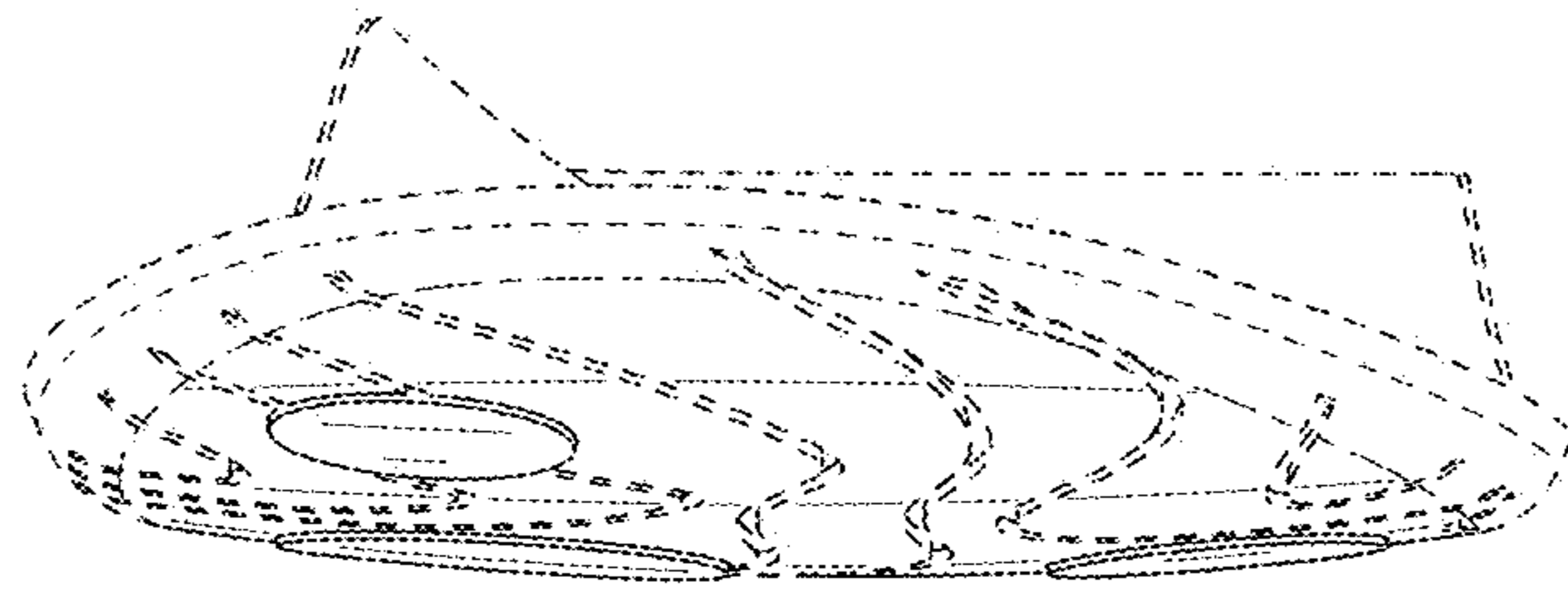

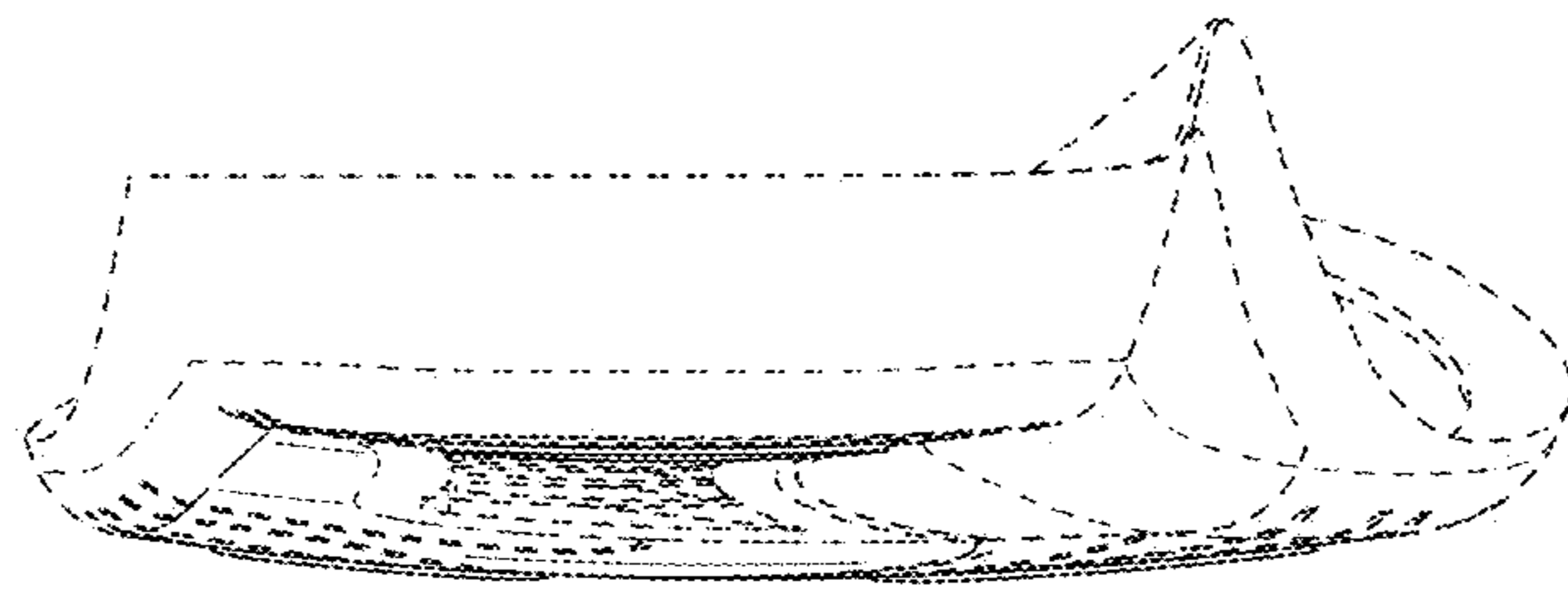

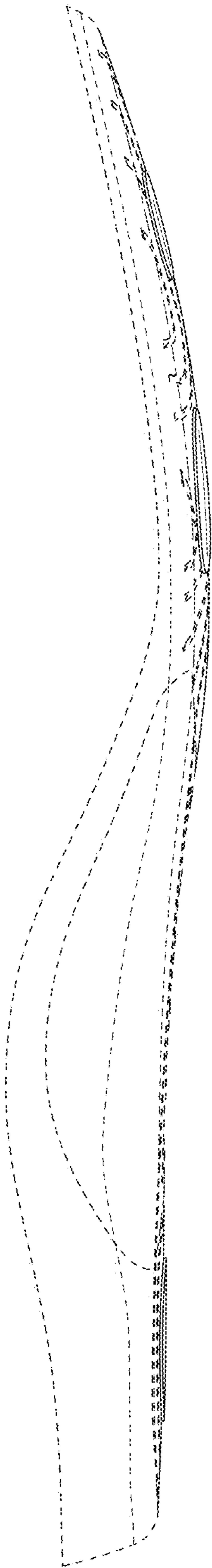

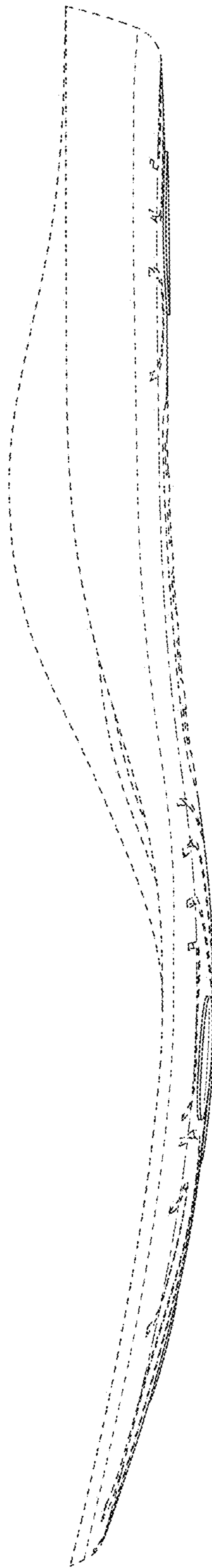

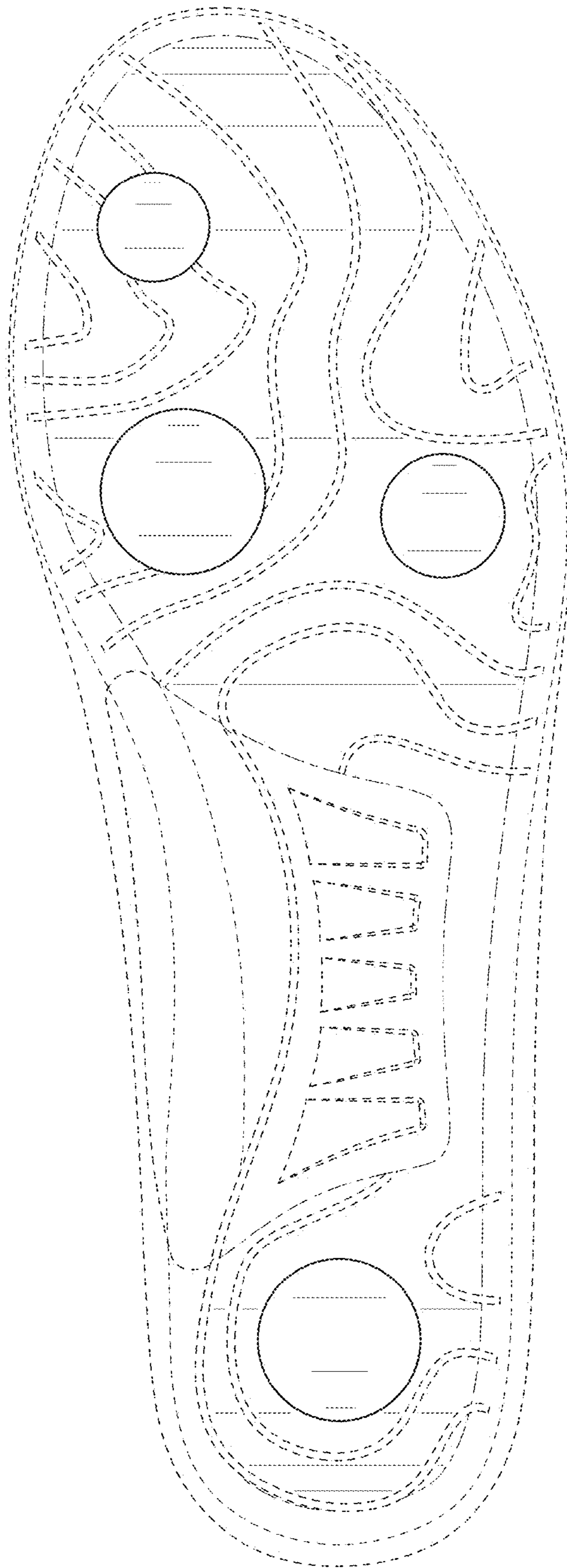

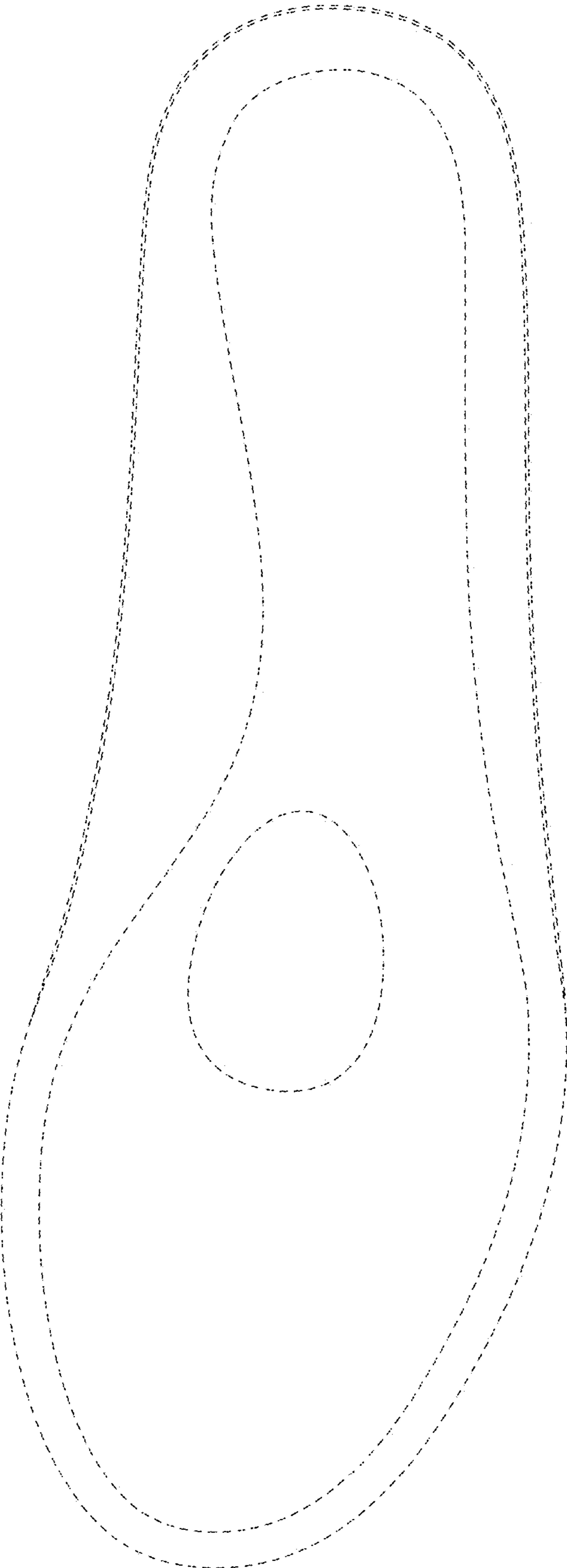
