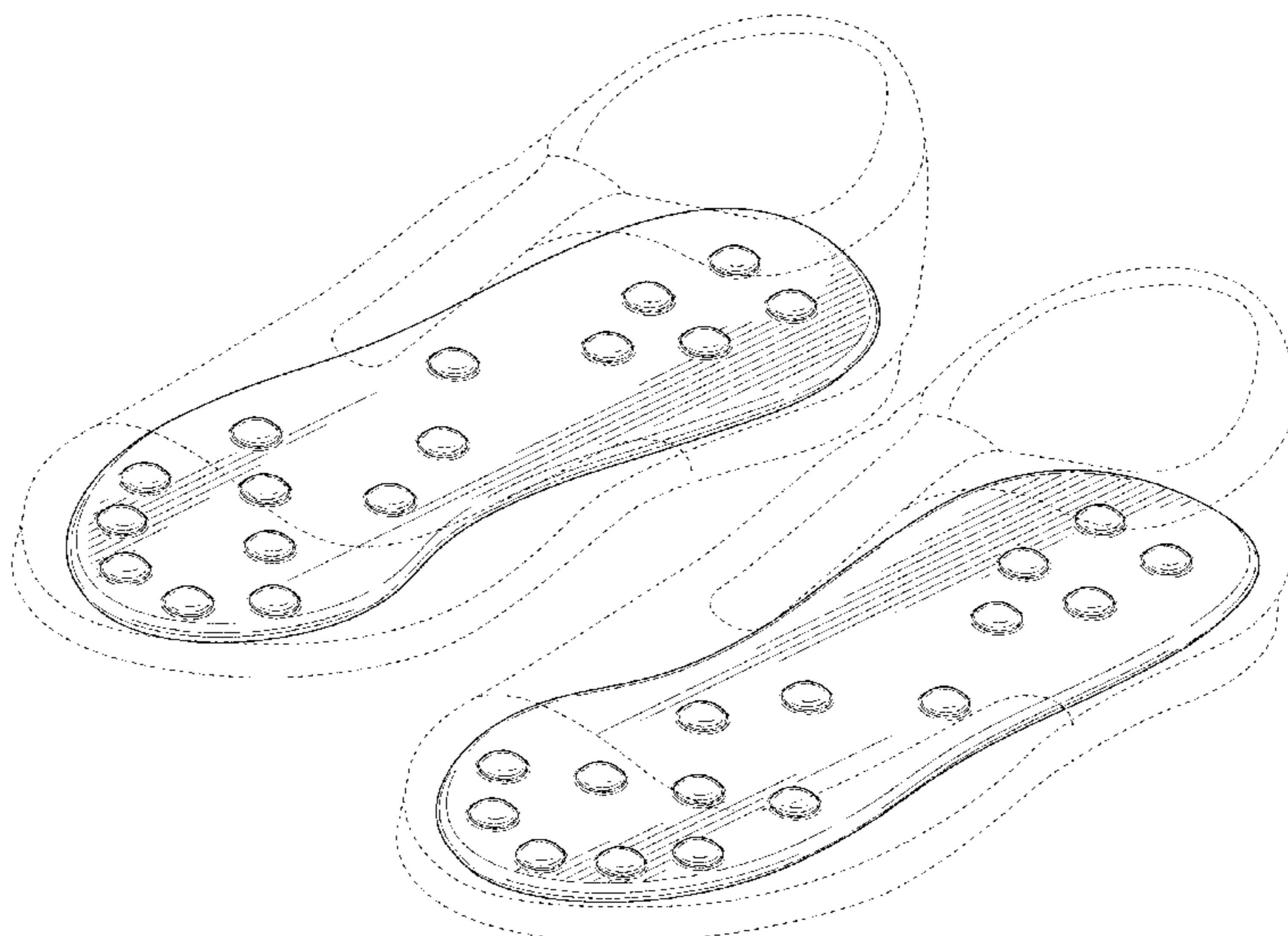
(57) **CLAIM**

The ornamental design for pair of insoles, substantially as shown and described.

DESCRIPTION

FIG. 1 is a top, perspective view of a left side of a pair of insoles showing our new design;
FIG. 2 is a top view thereof;
FIG. 3 is a bottom view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a front view thereof;
FIG. 7 is a rear view thereof;
FIG. 8 is a top, perspective view of a right side of the pair of insoles;
FIG. 9 is a top view thereof;
FIG. 10 is a bottom view thereof;
FIG. 11 is a right side view thereof;
FIG. 12 is a left side view thereof;
FIG. 13 is a front view thereof;
FIG. 14 is a rear view thereof; and,
FIG. 15 is a perspective view of the pair of insoles, with the right and the left sides shown together.
The broken lines in FIG. 15 illustrating a shoe show environment and form no part of the claimed design.

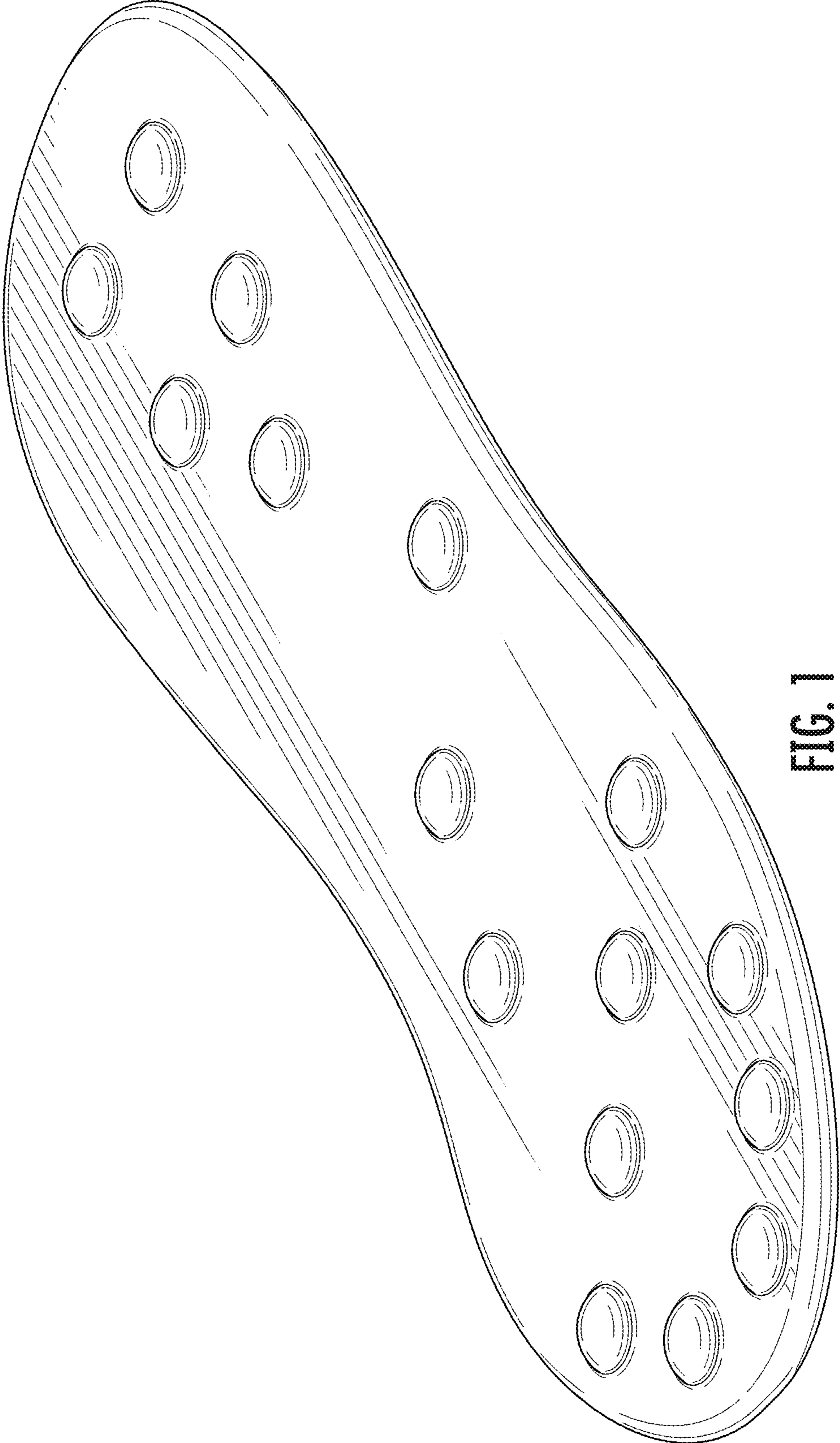

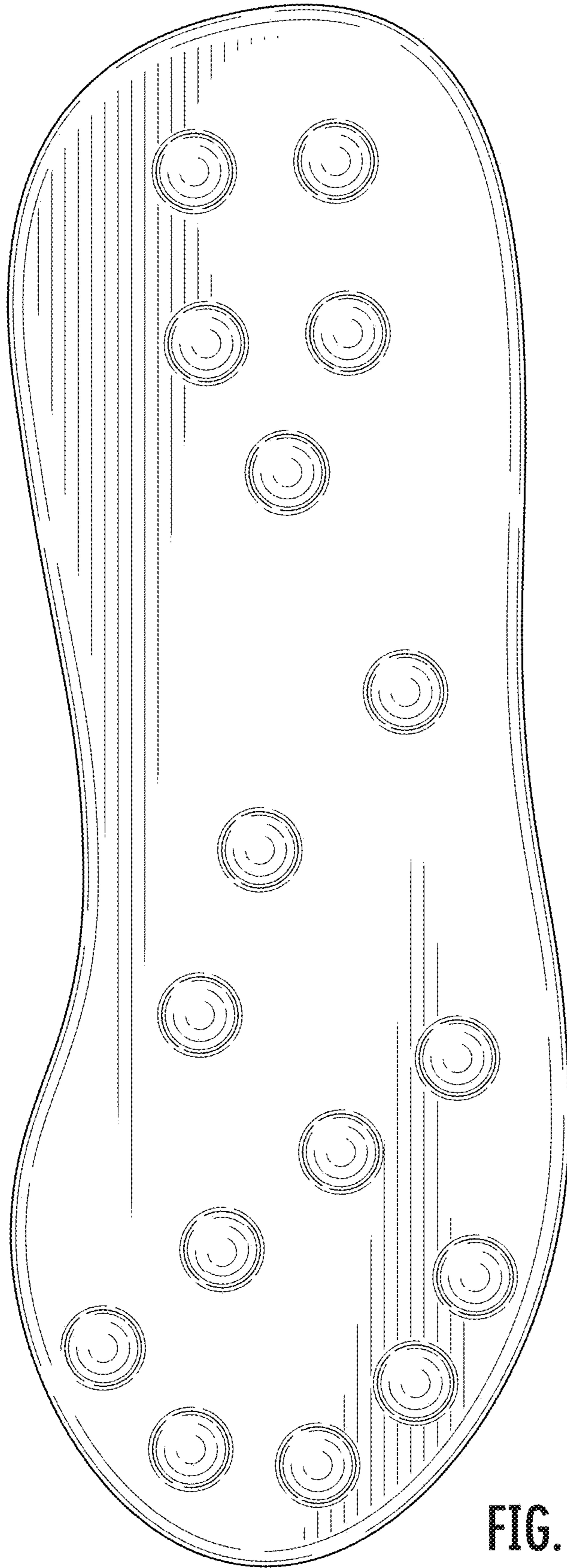

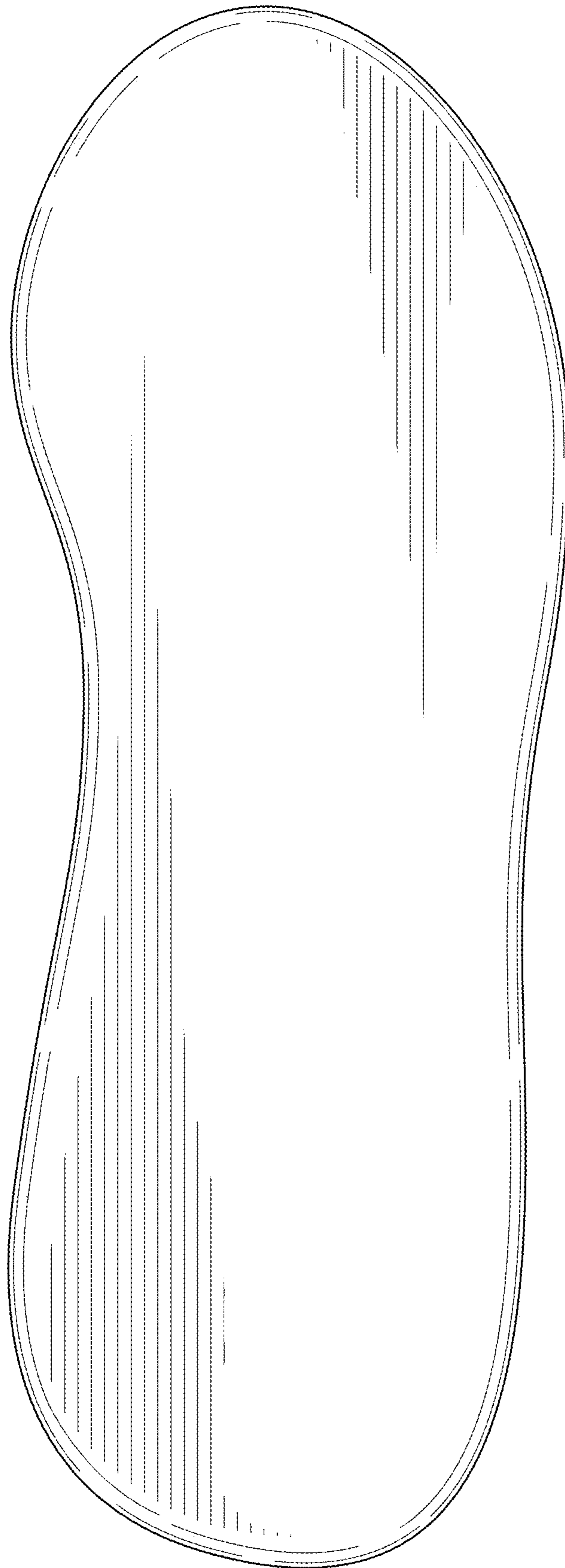

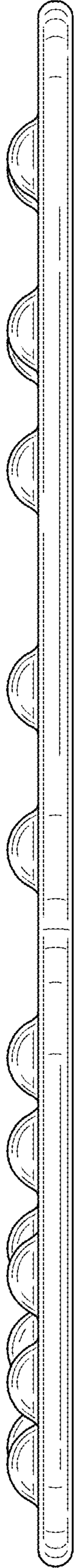

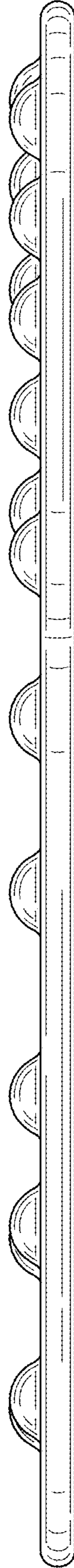

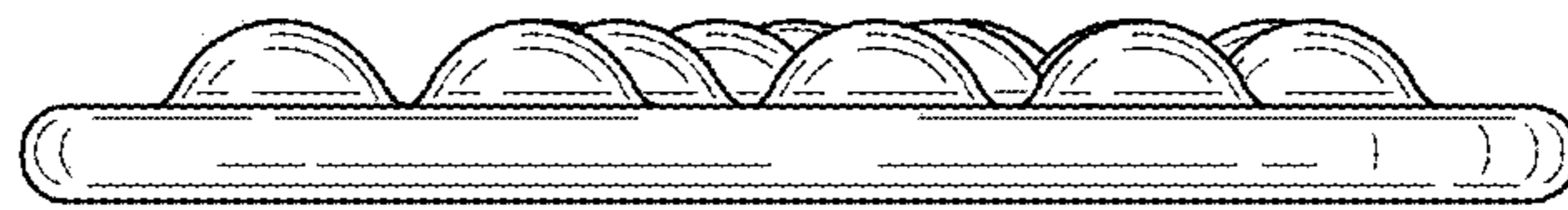

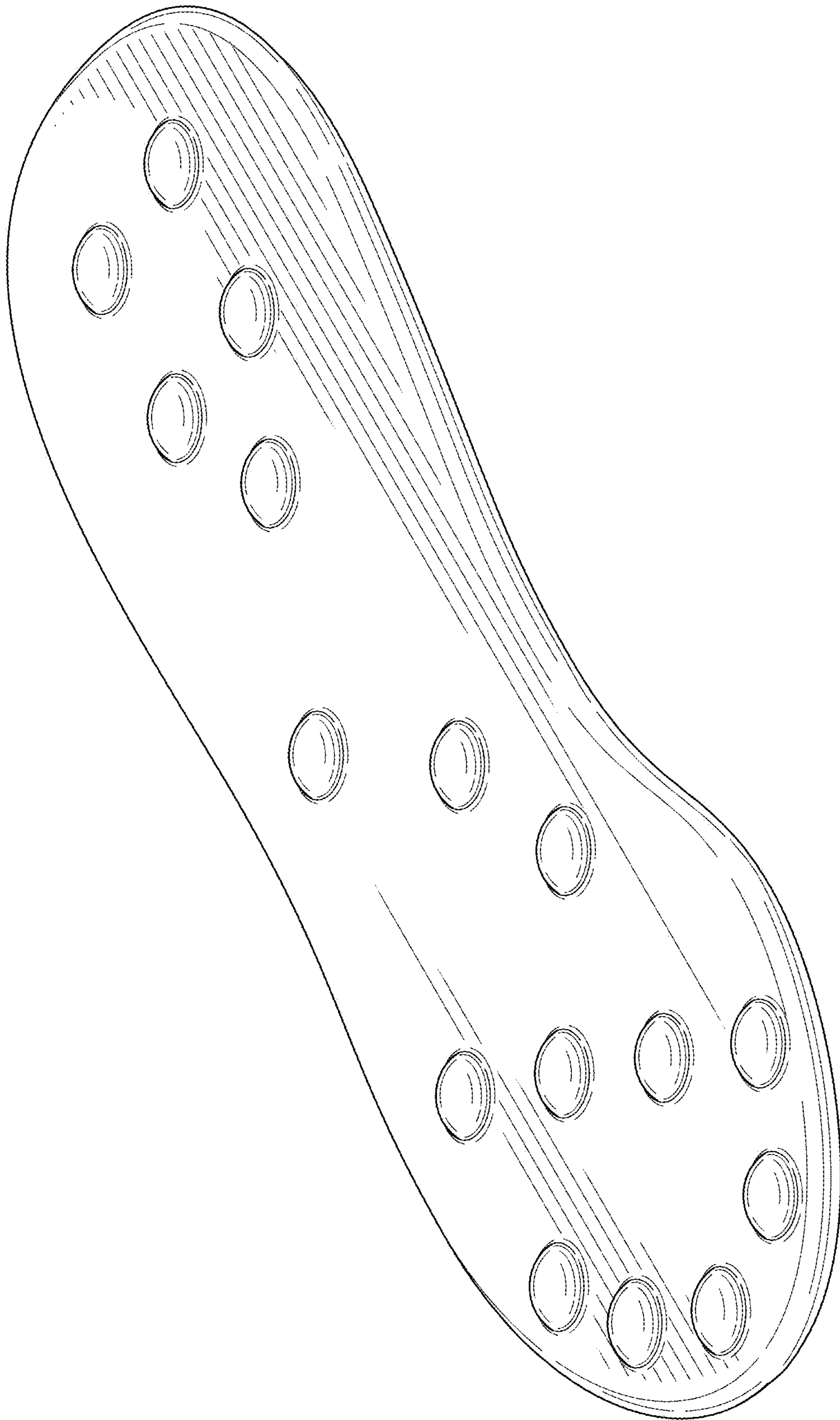

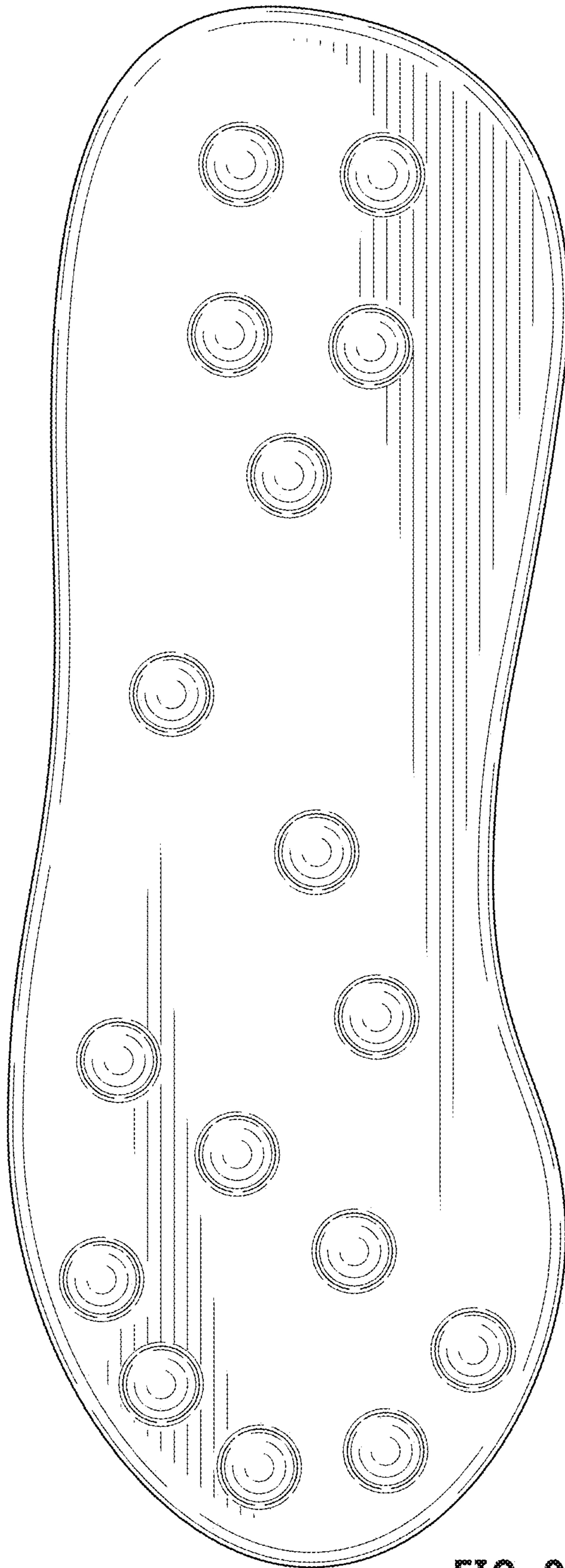

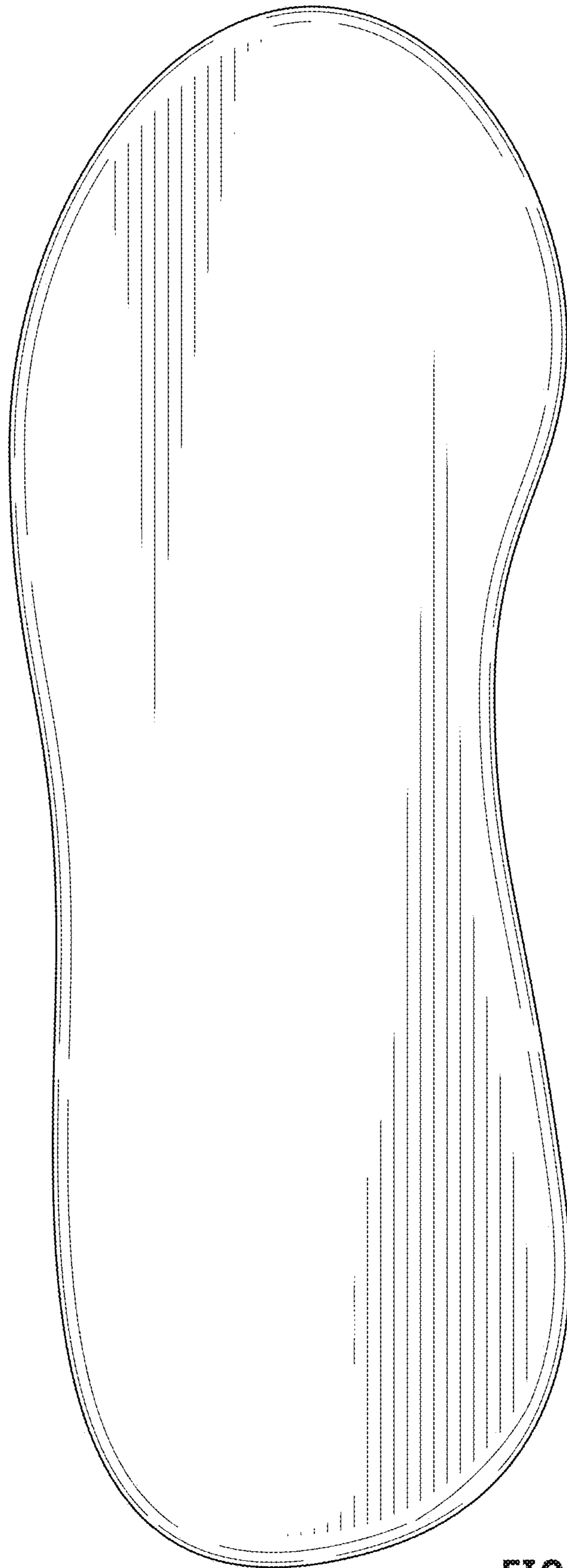

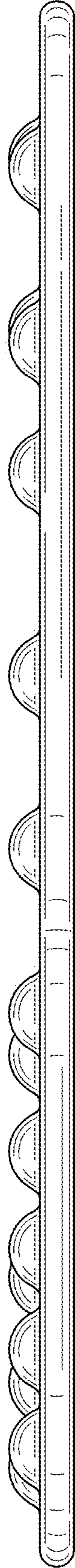

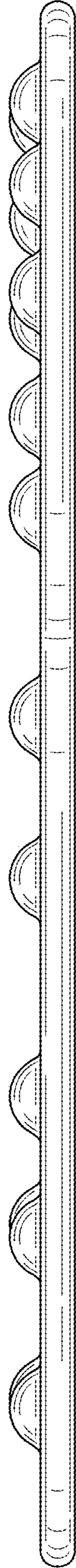

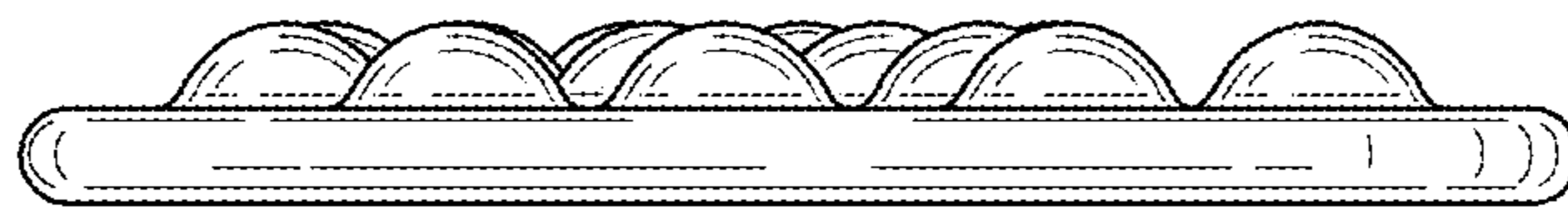

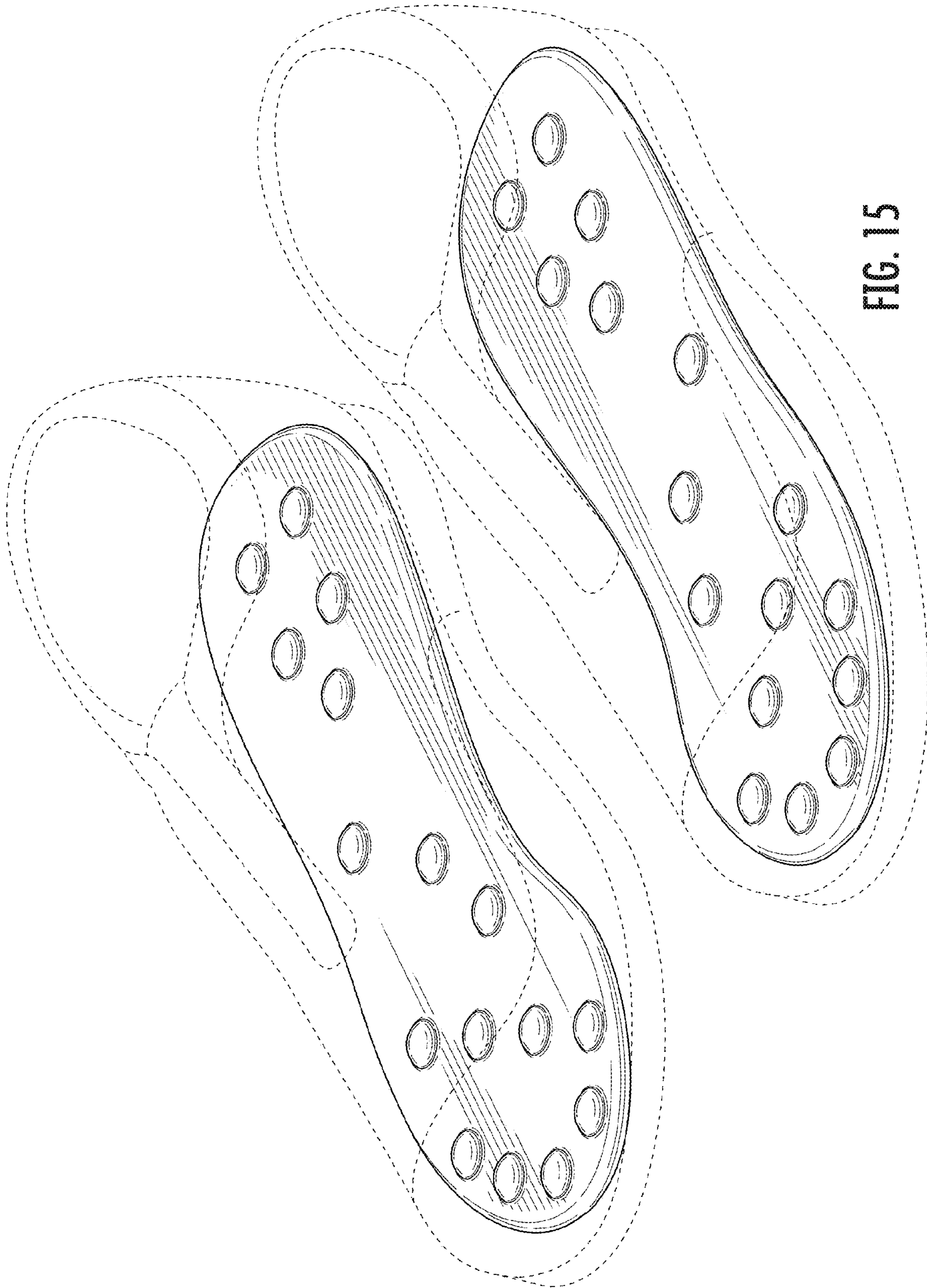
