The broken lines within the shaded areas depict unclaimed stitching. The remaining broken lines depict portions of the backpack that form no part of the claimed design.

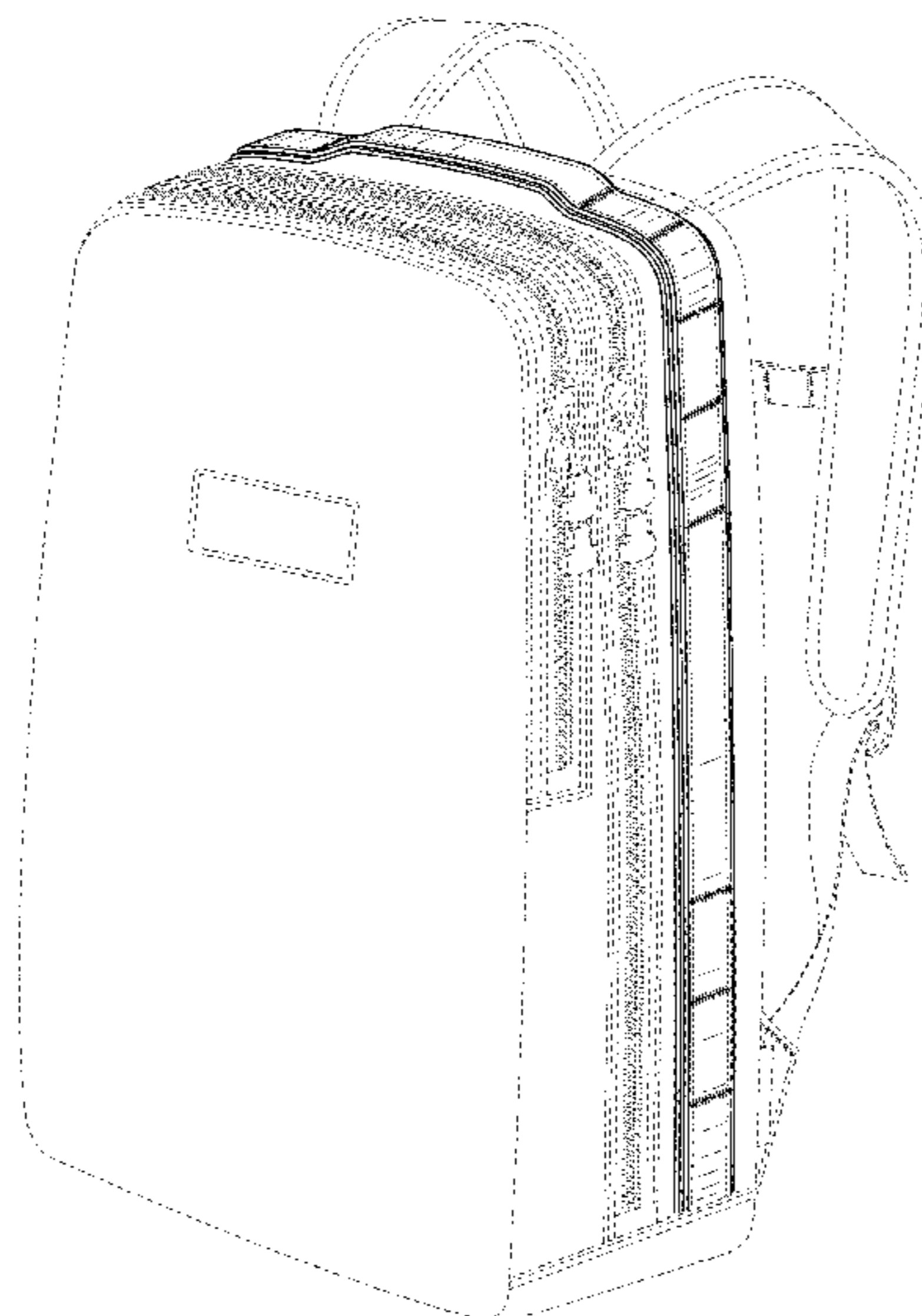

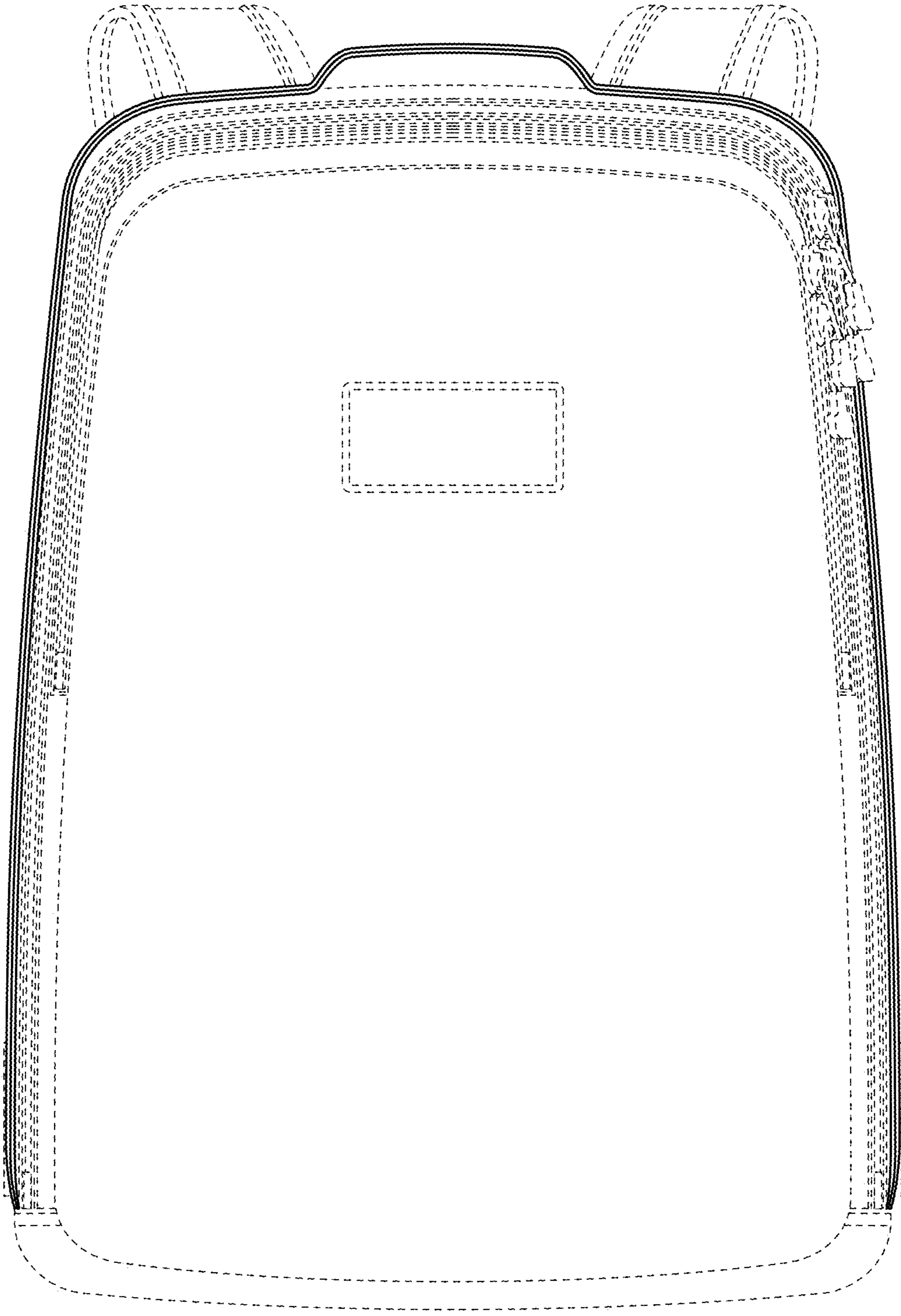

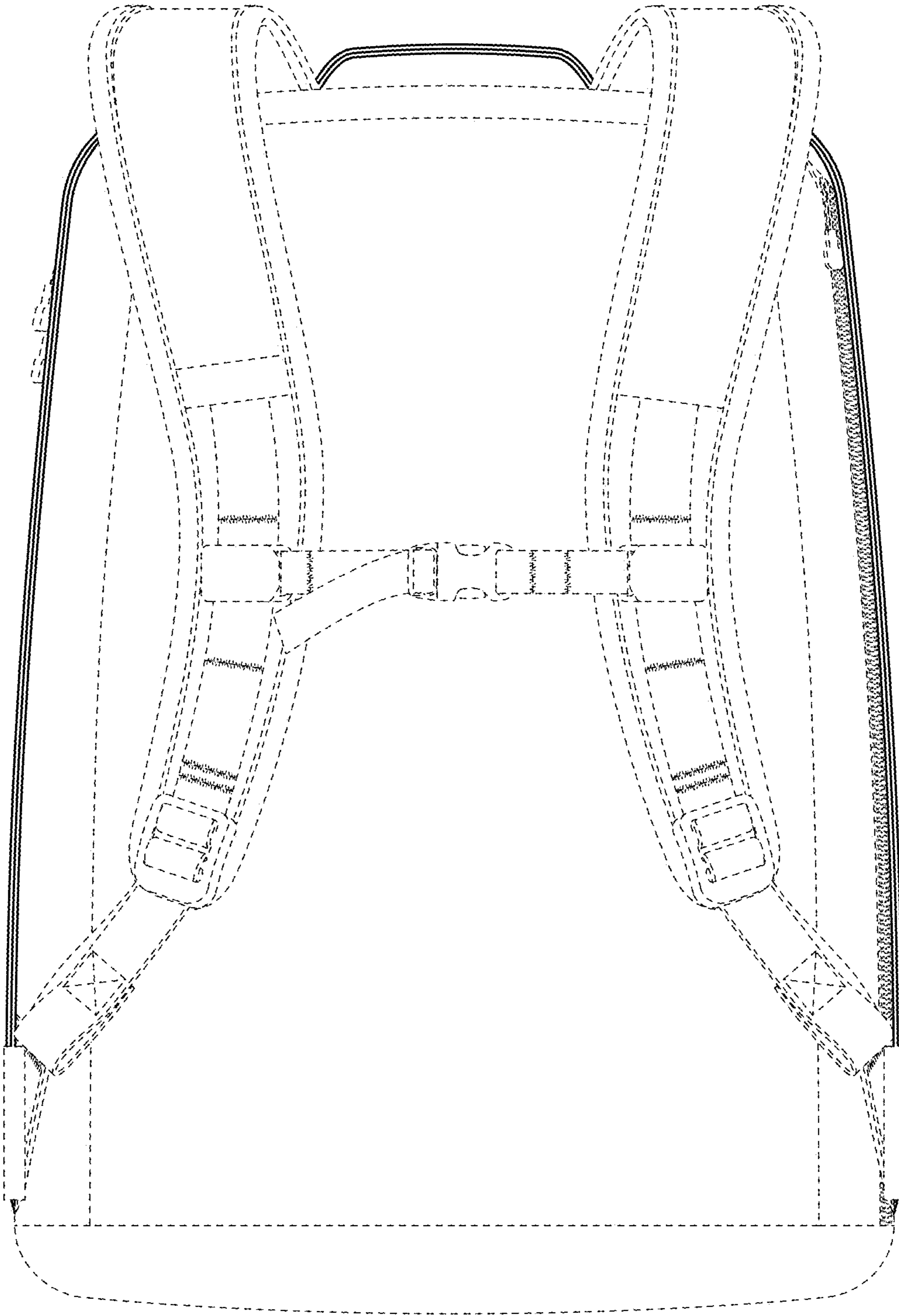

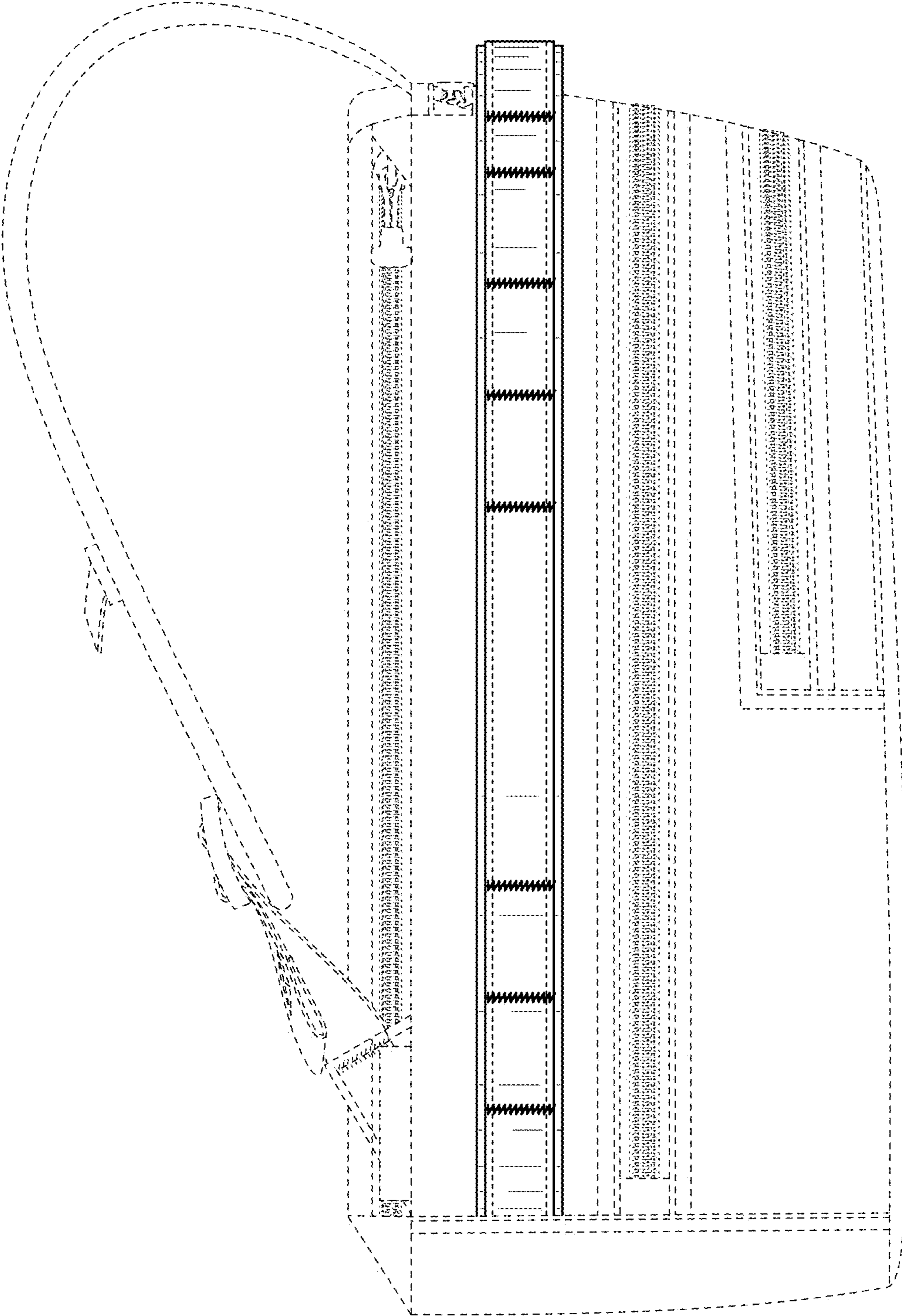

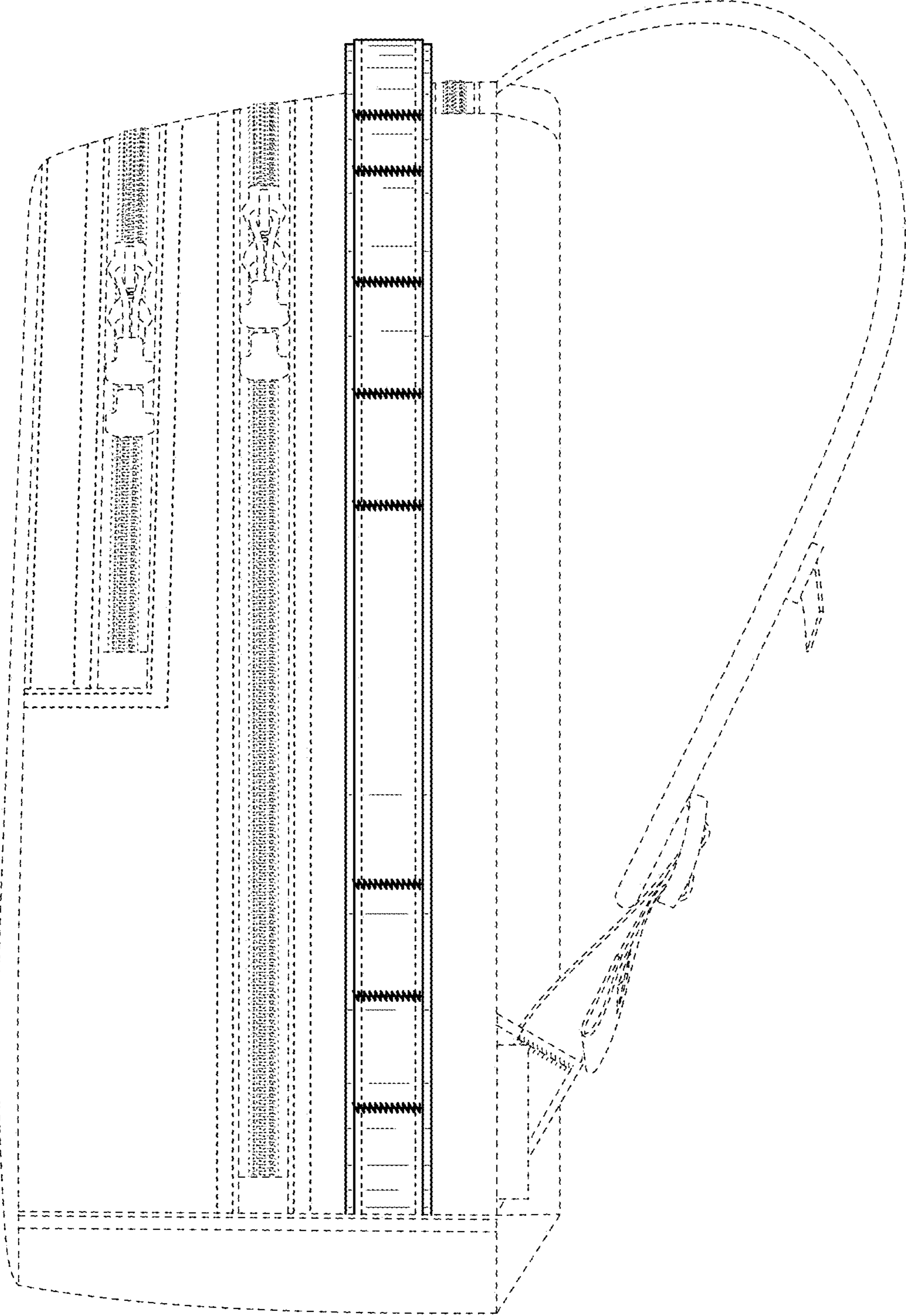

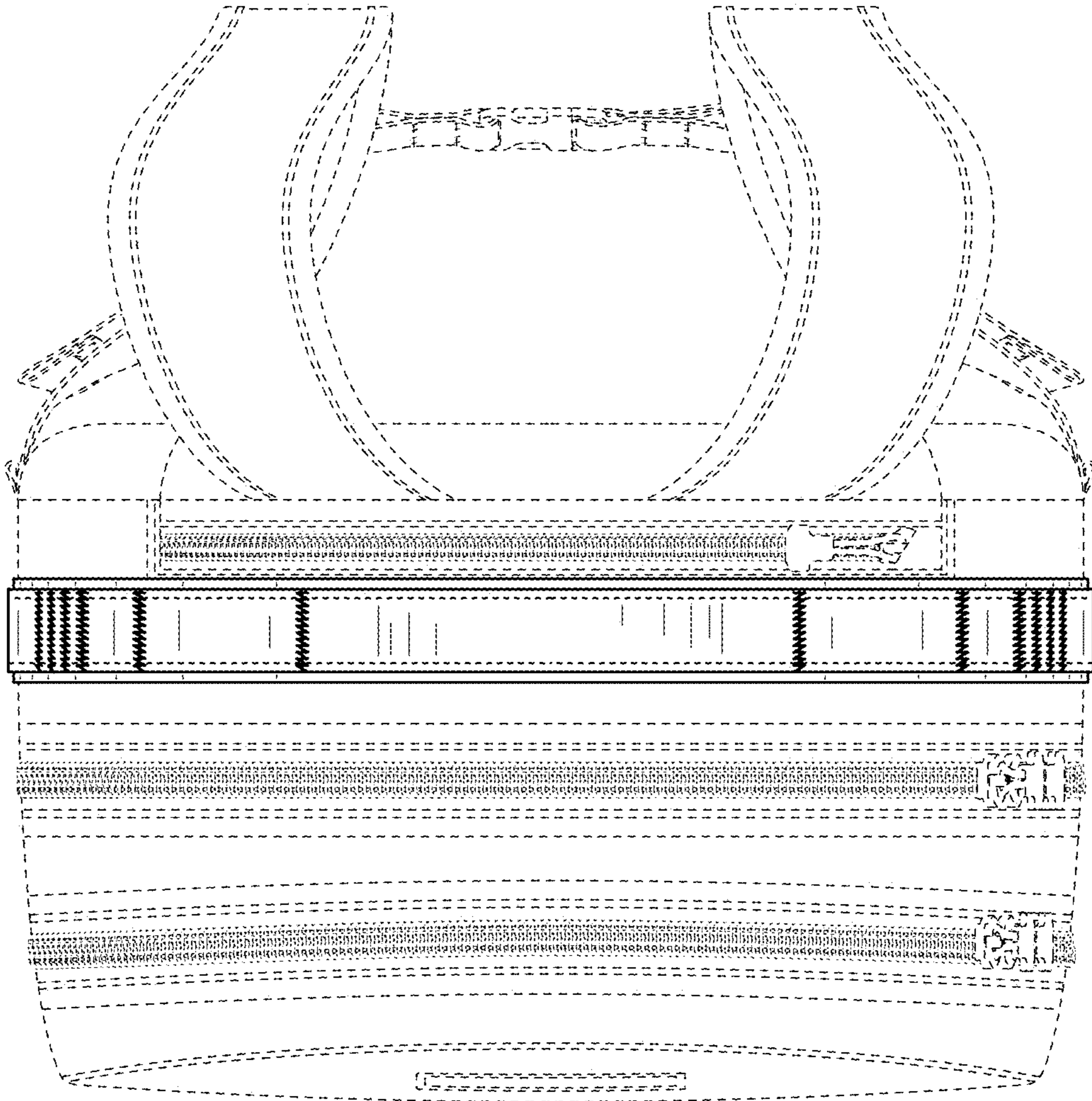

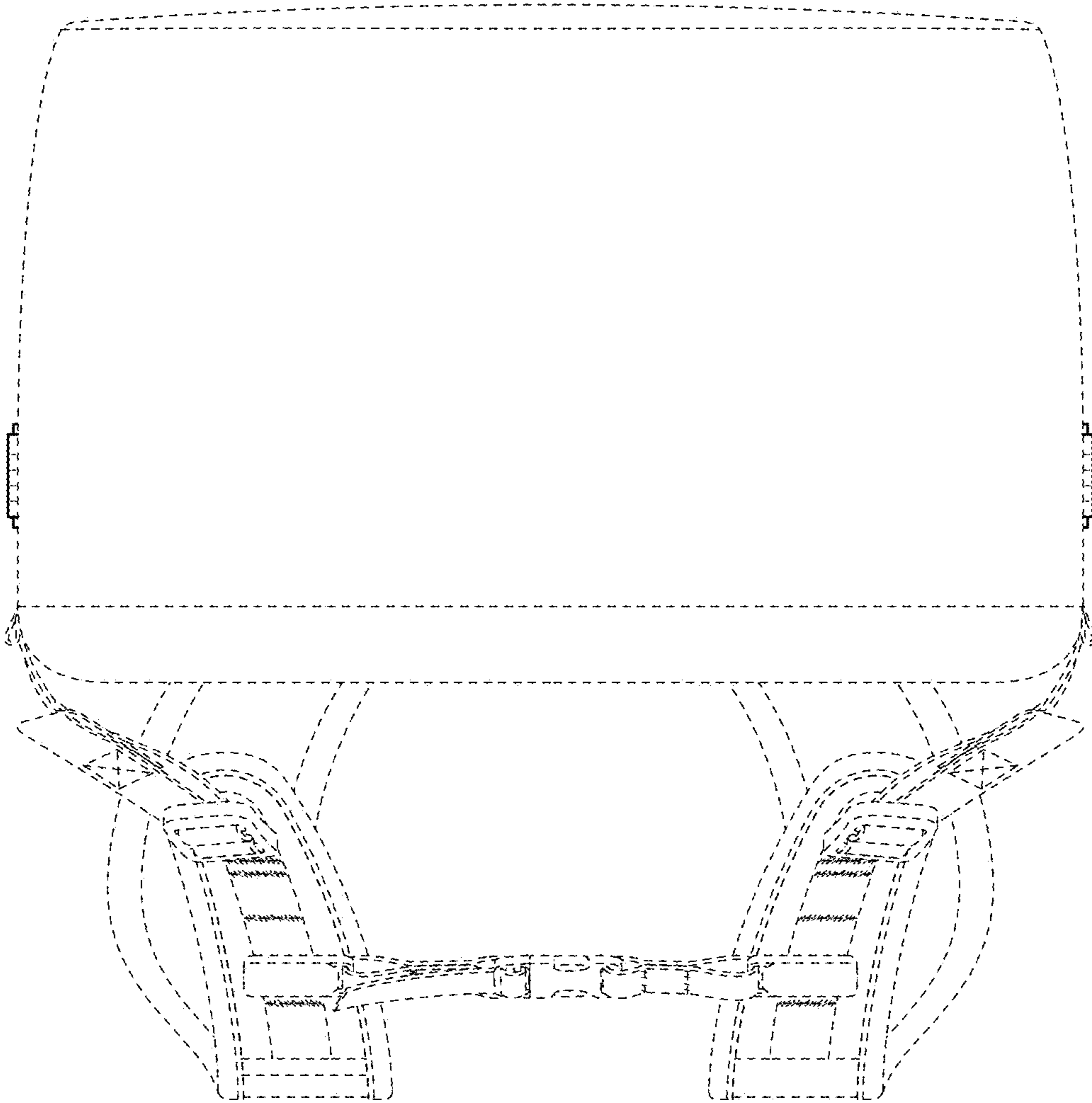
