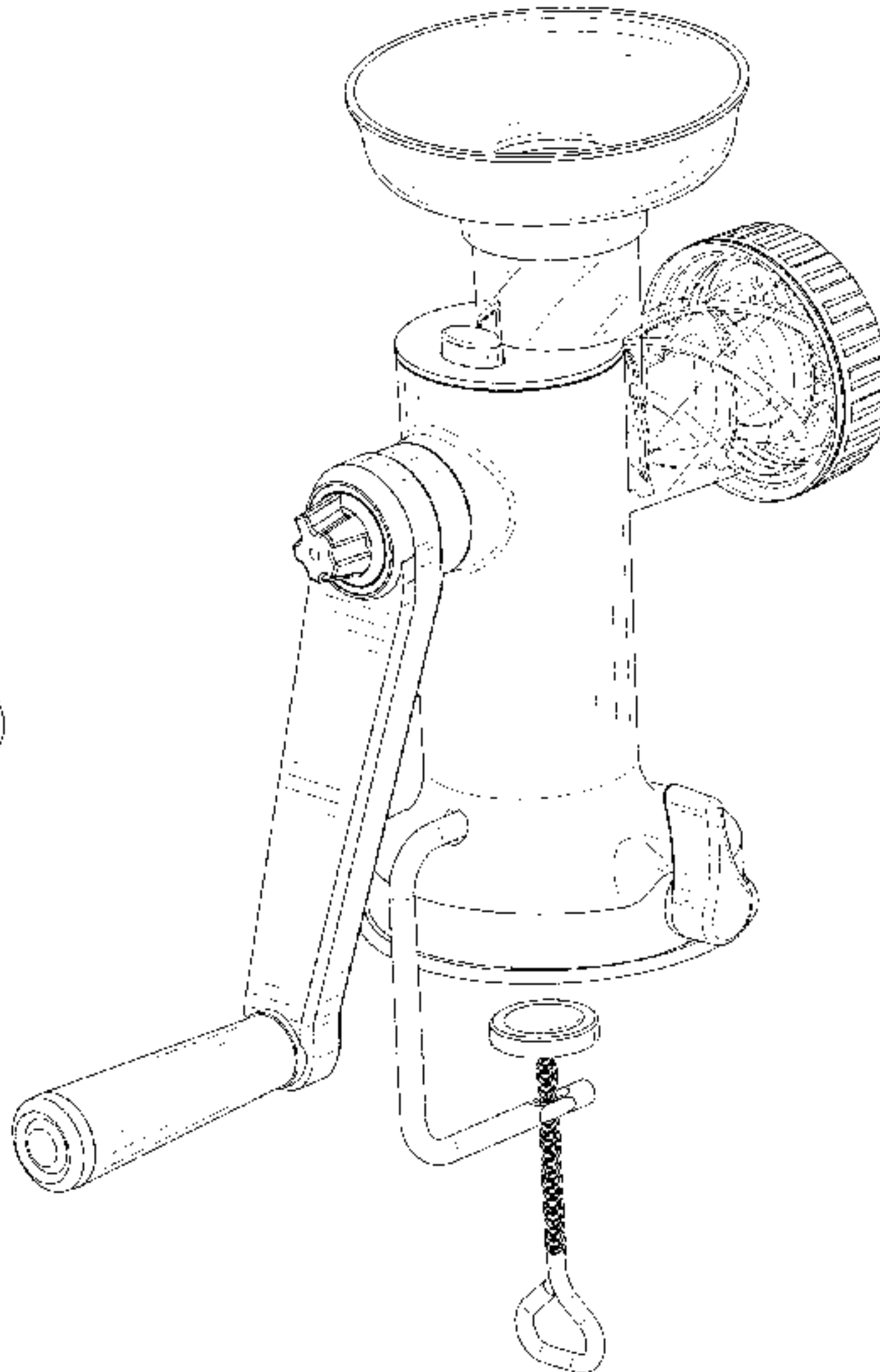
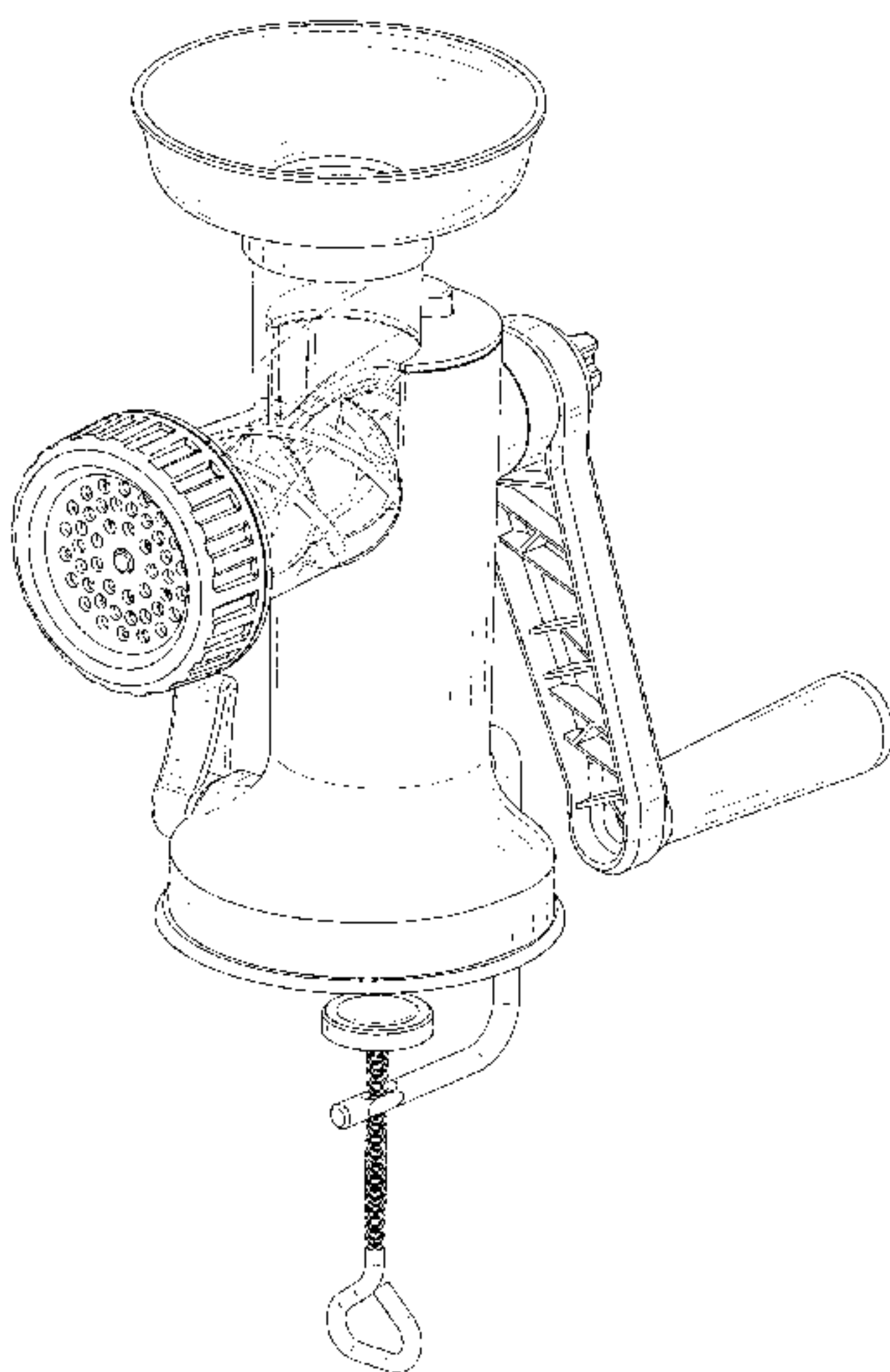
CLAIM

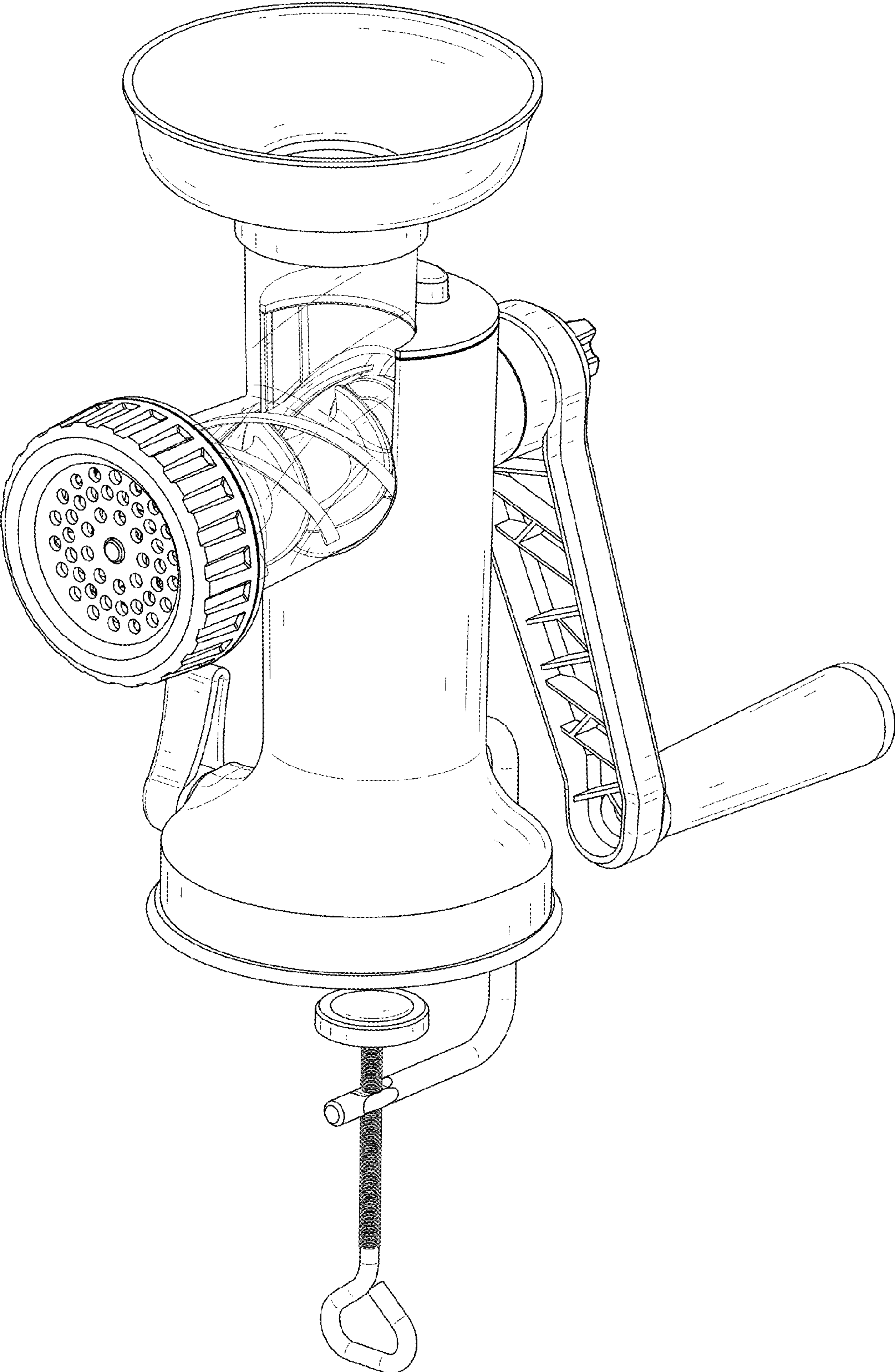

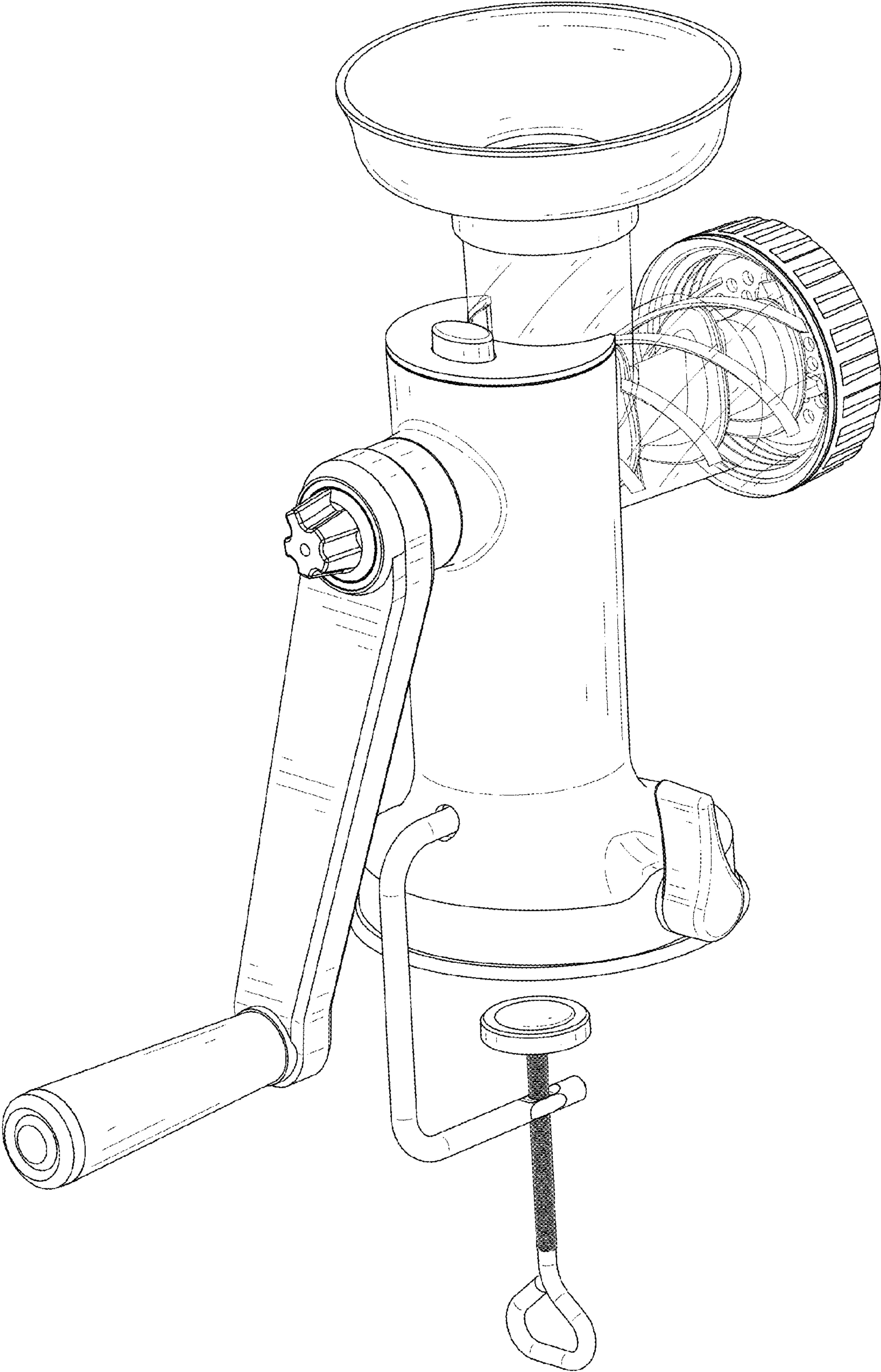

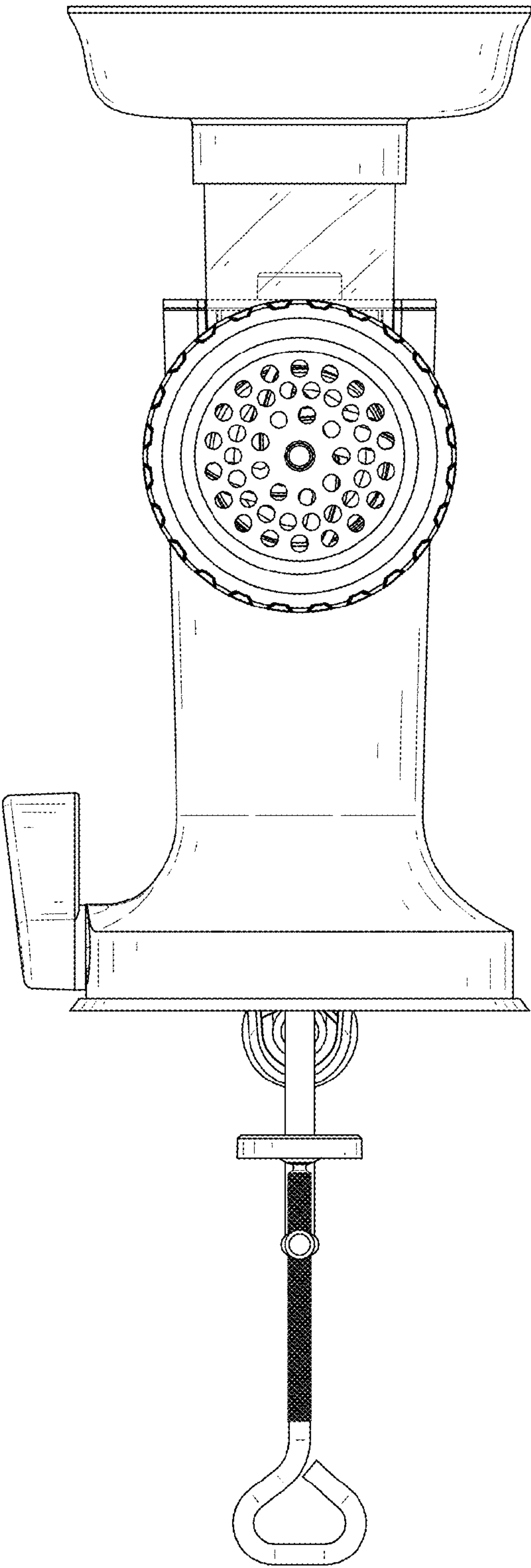

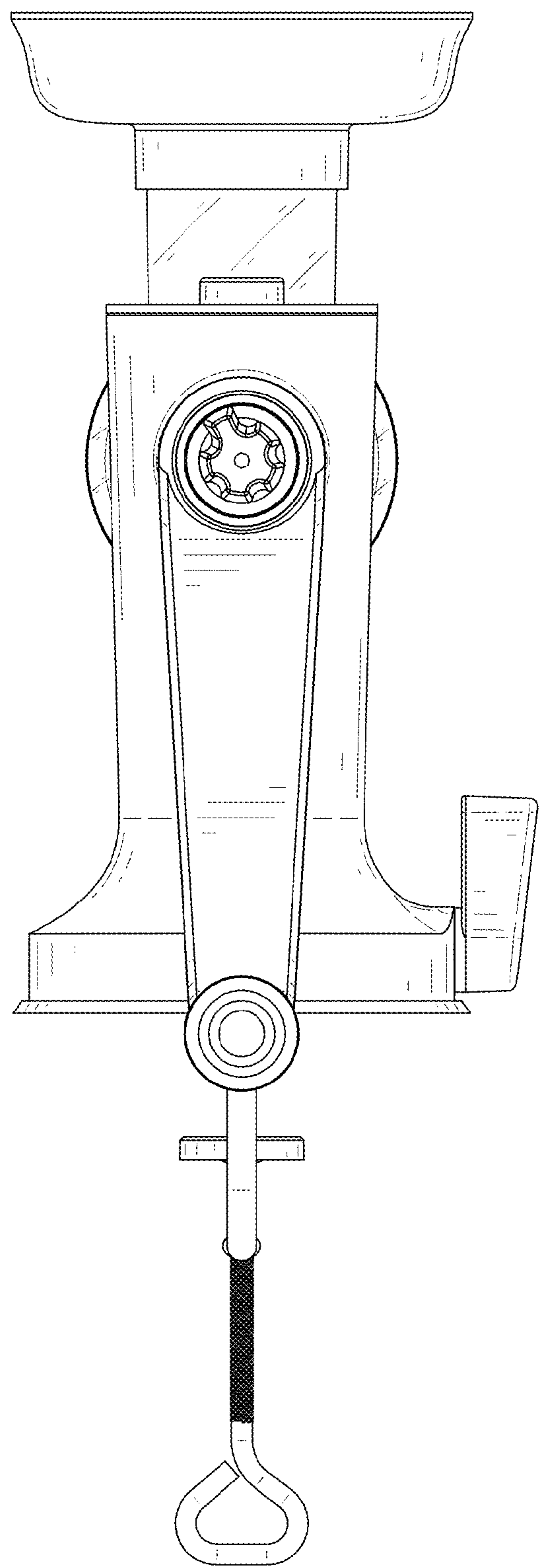

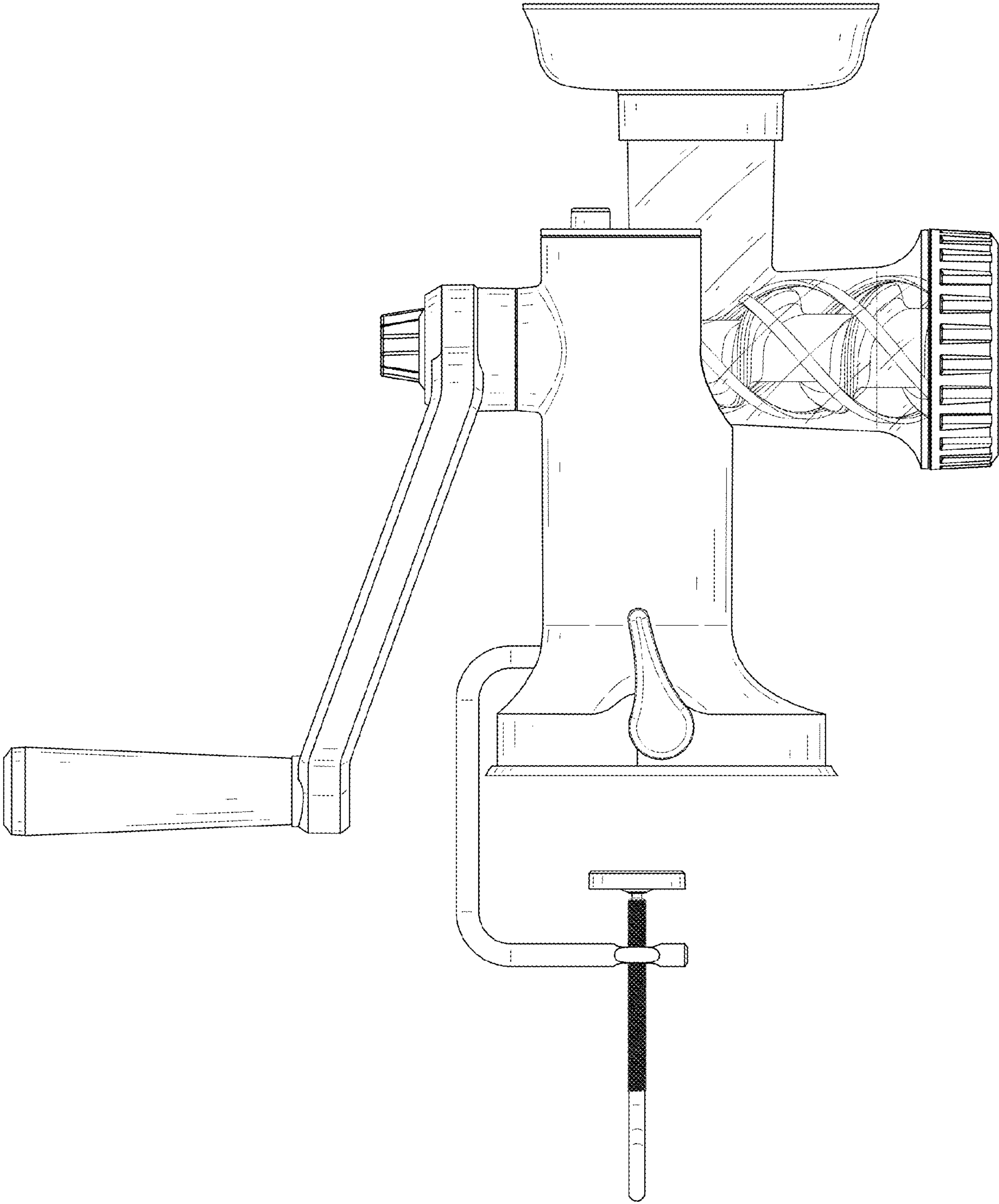

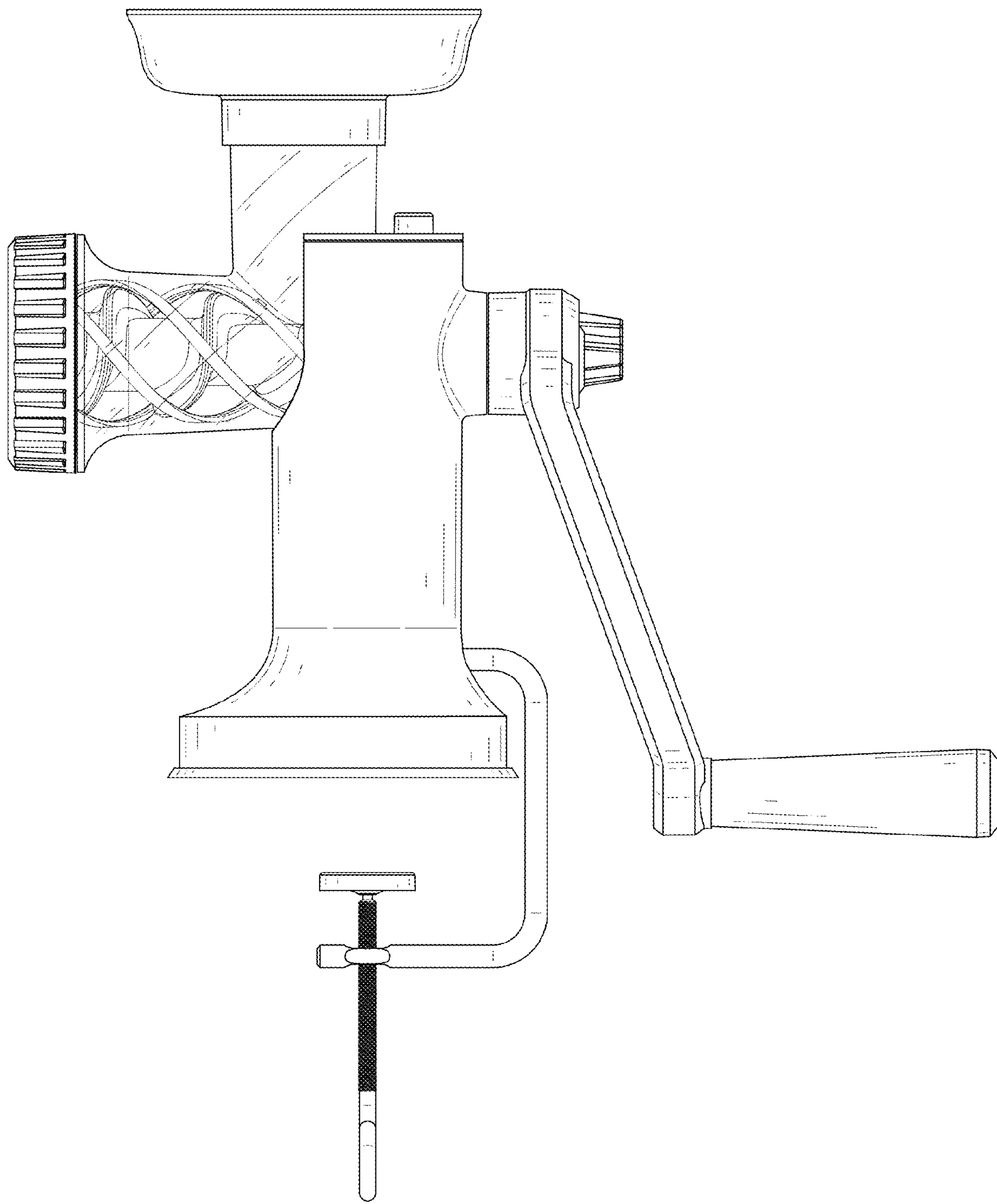

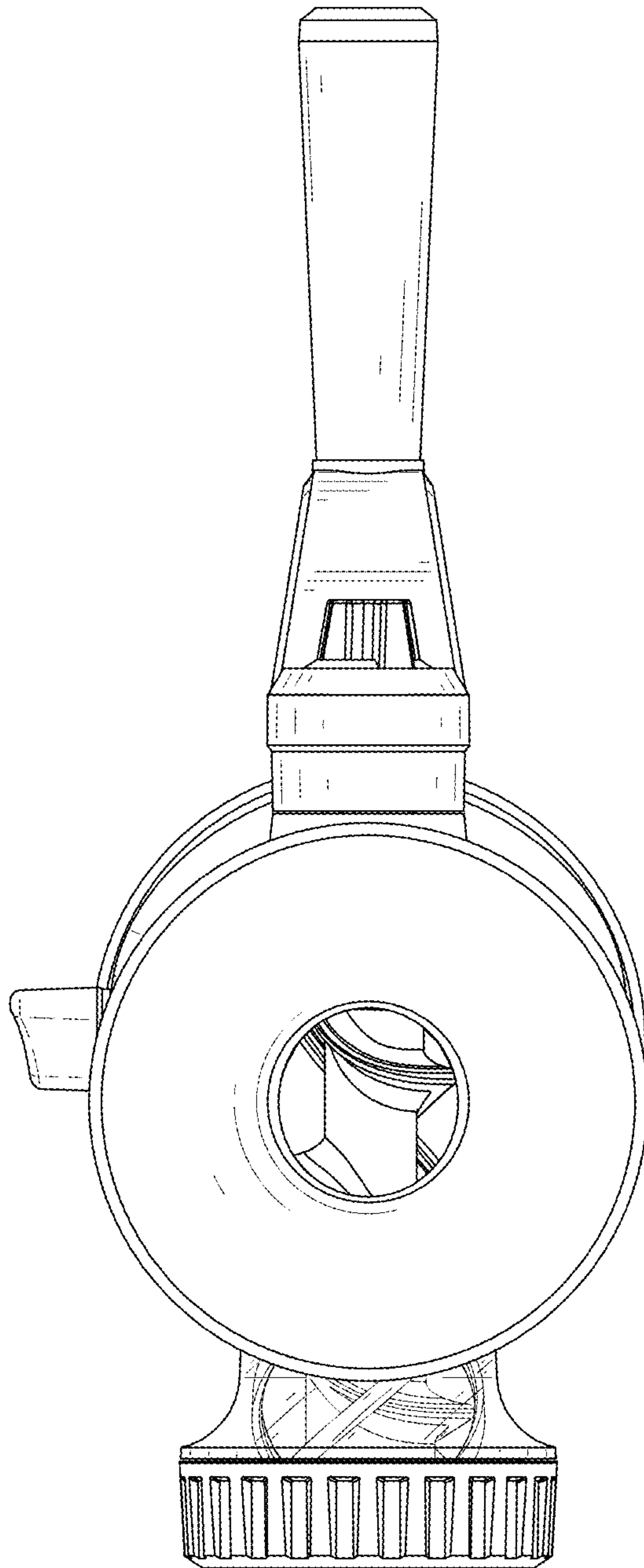

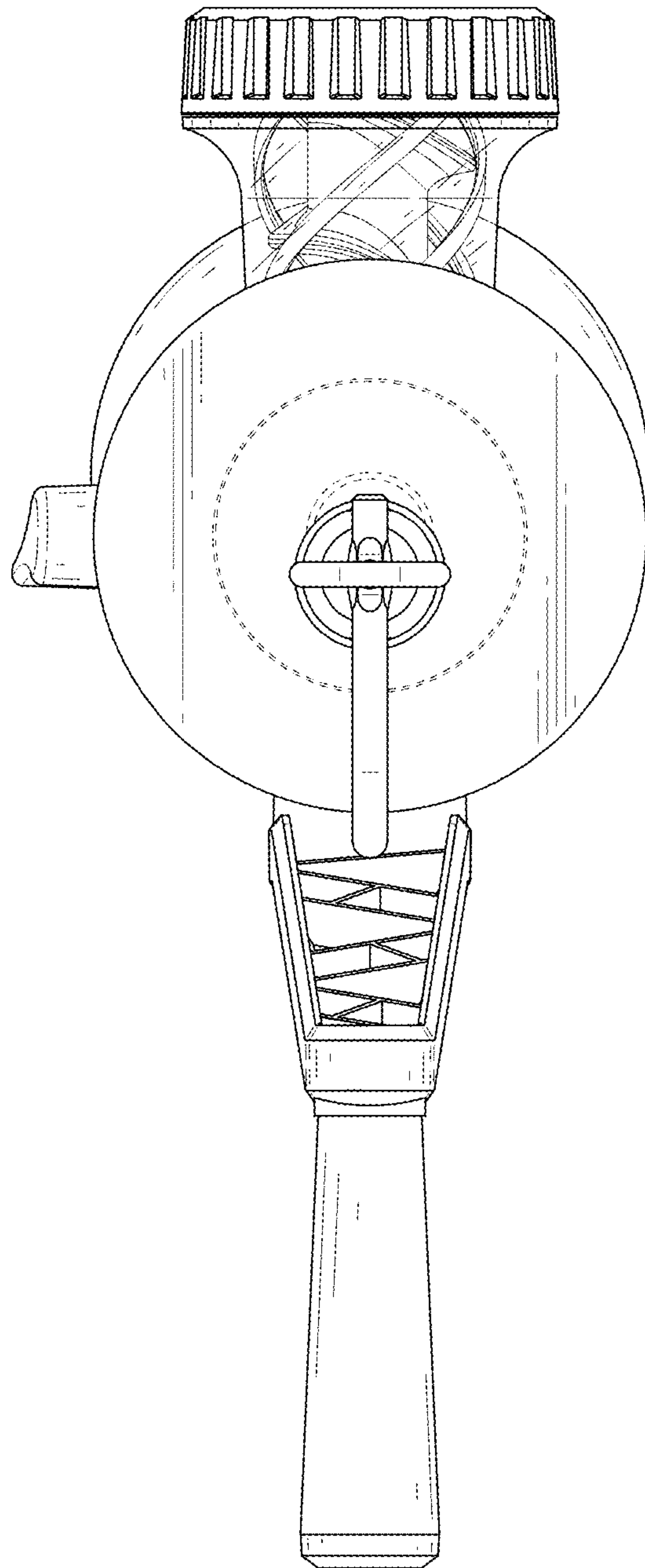
