FIG. 9 is a bottom view.

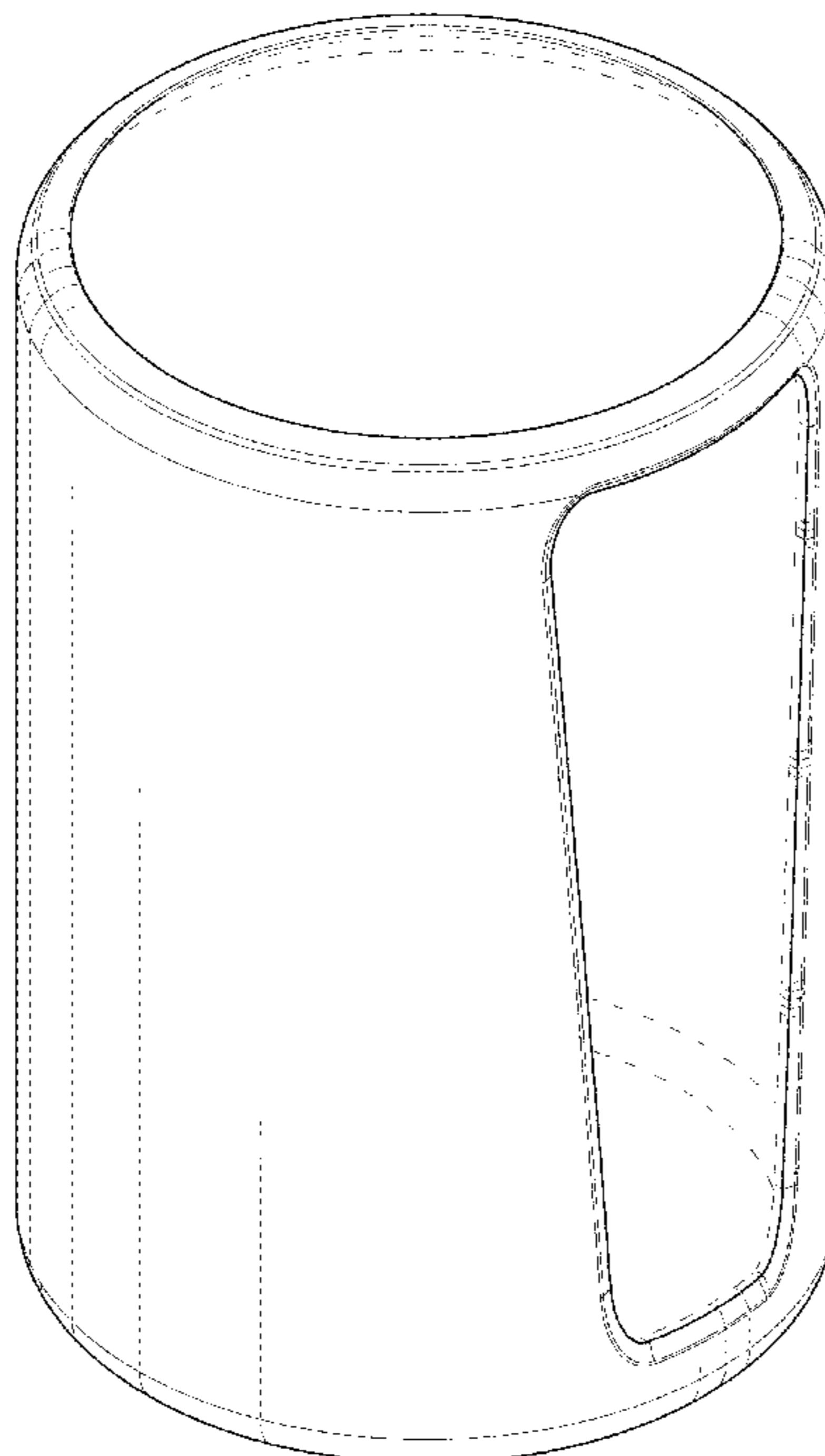
The dashed lines depict portions of the container lid that form no part of the claimed design.

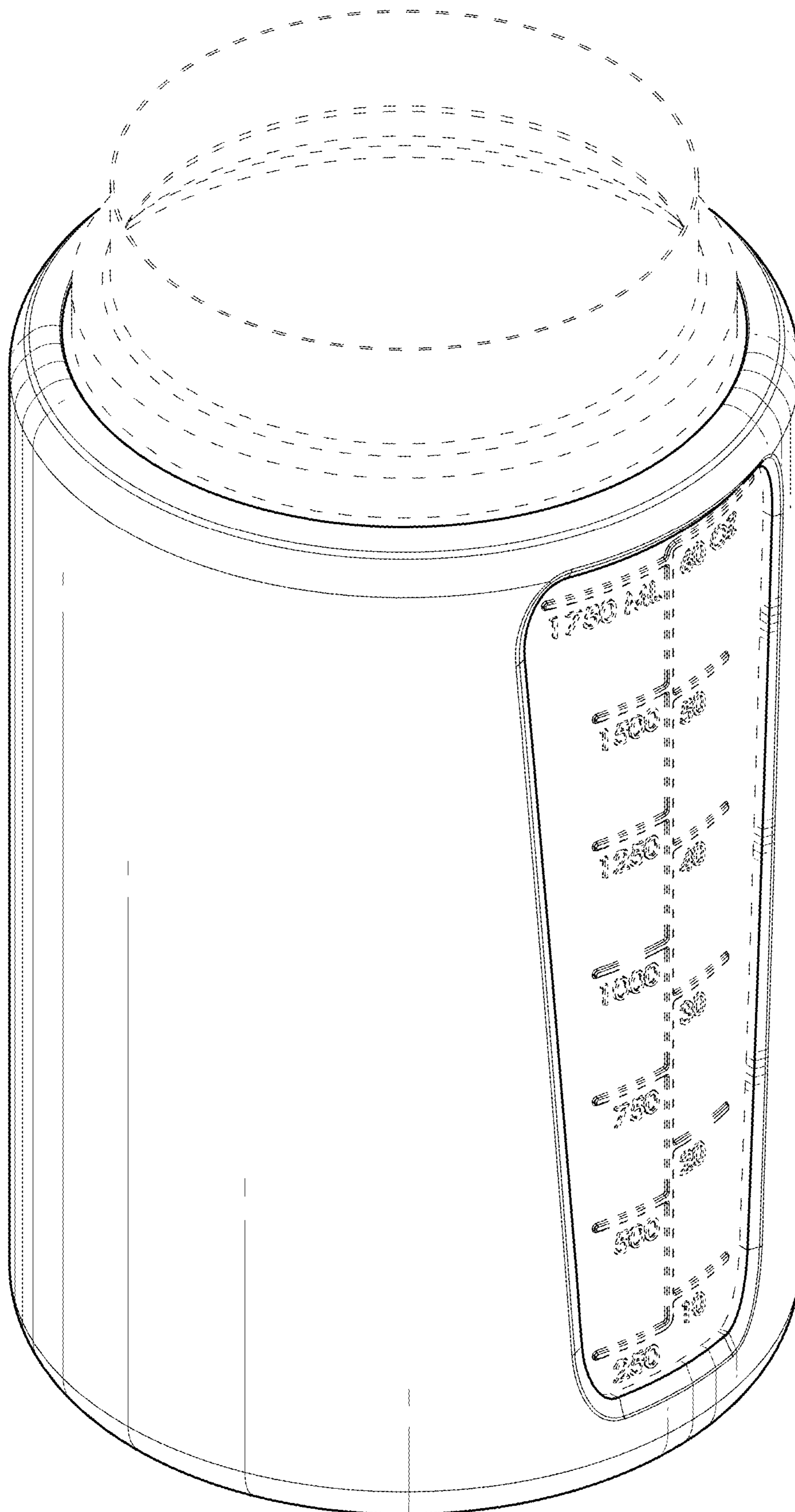

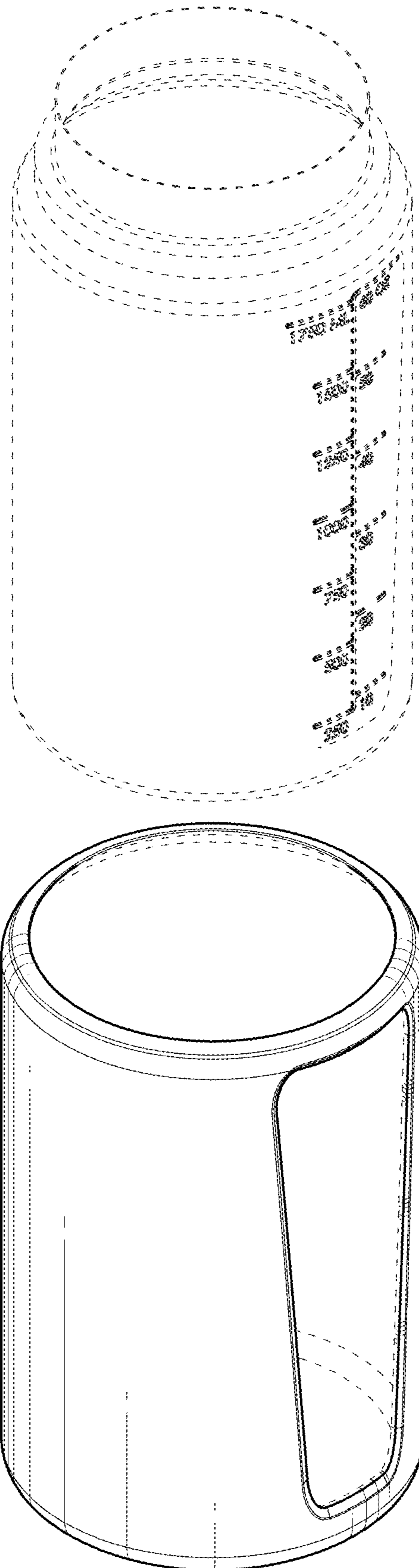

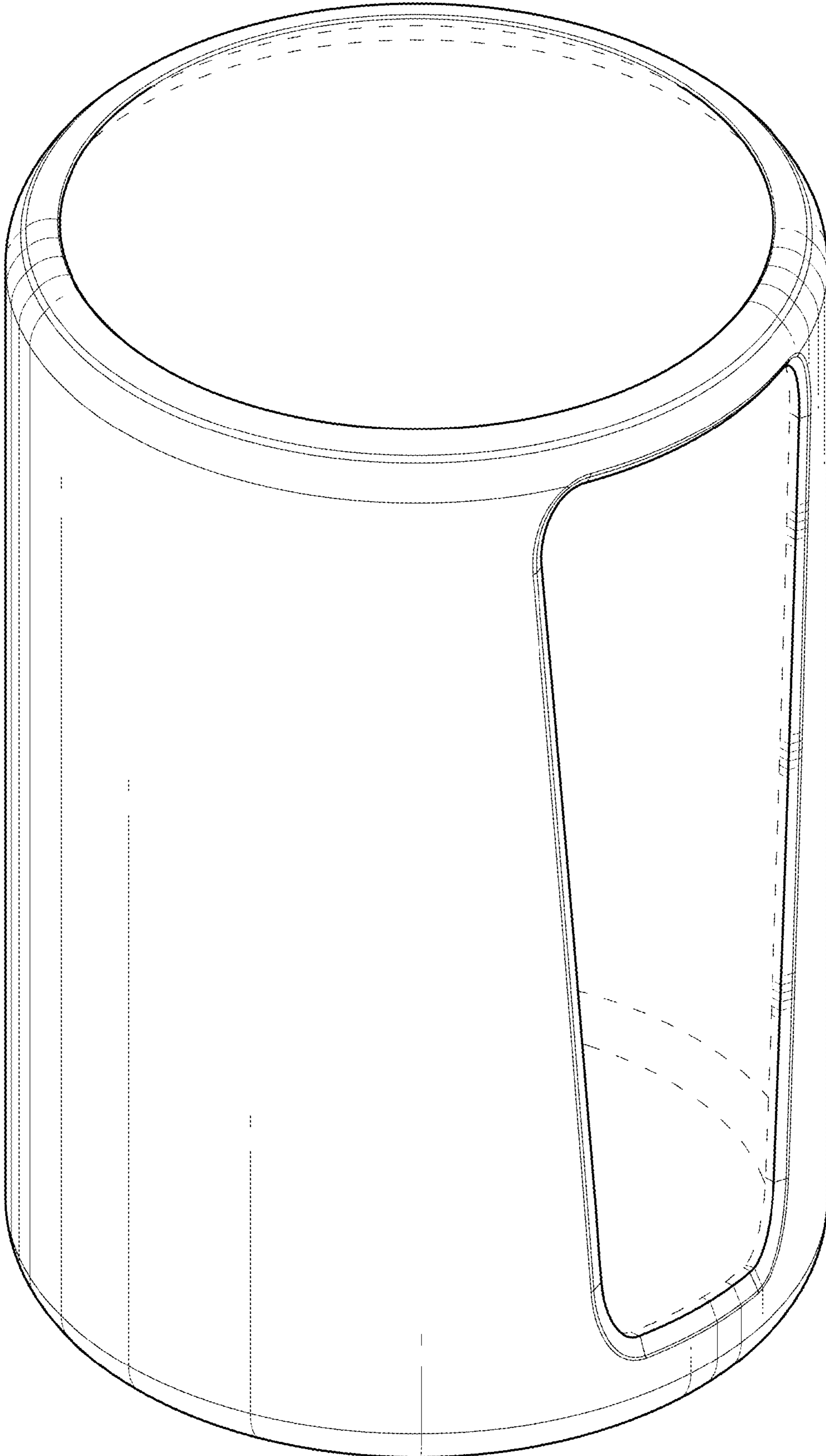

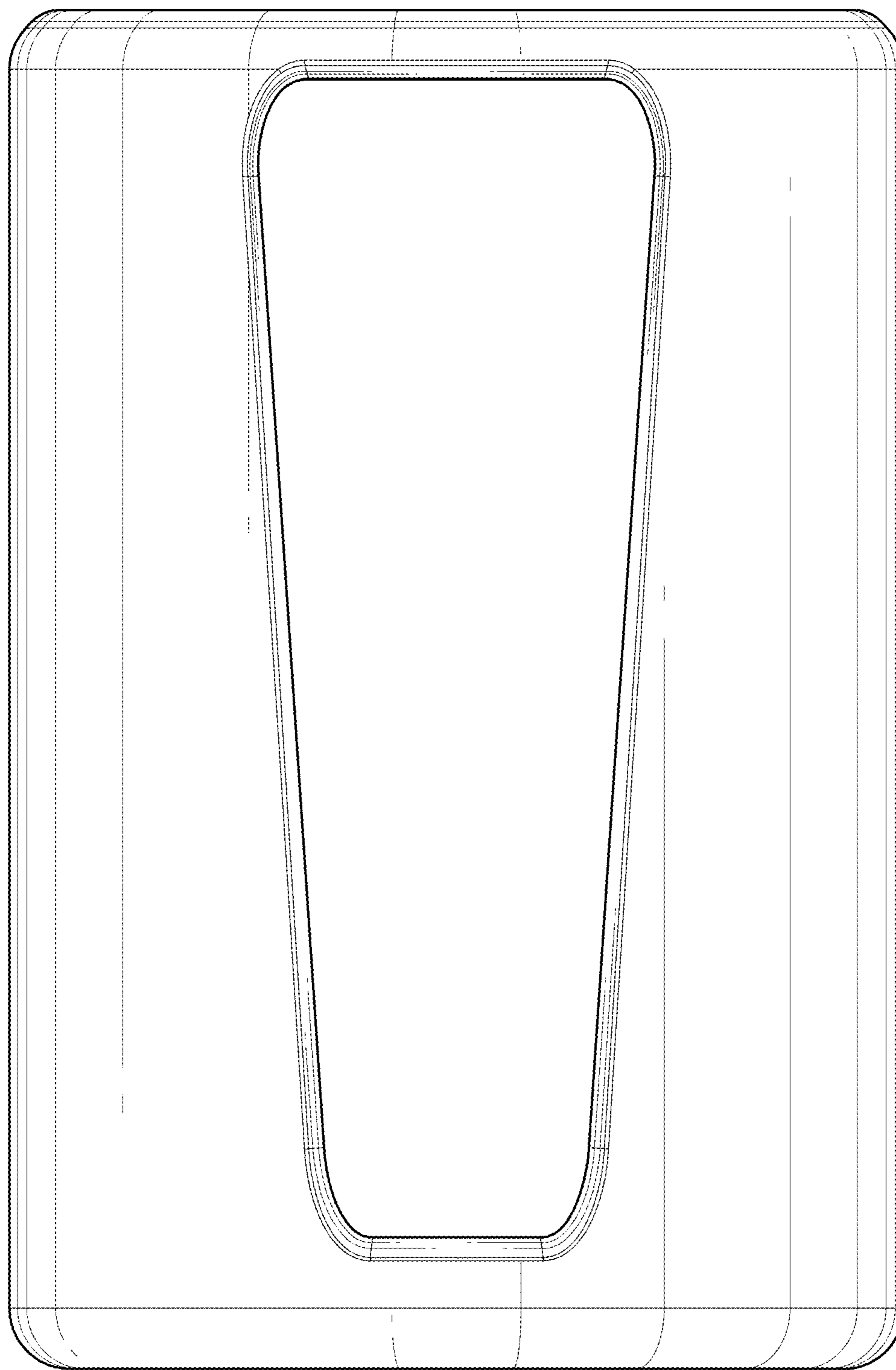

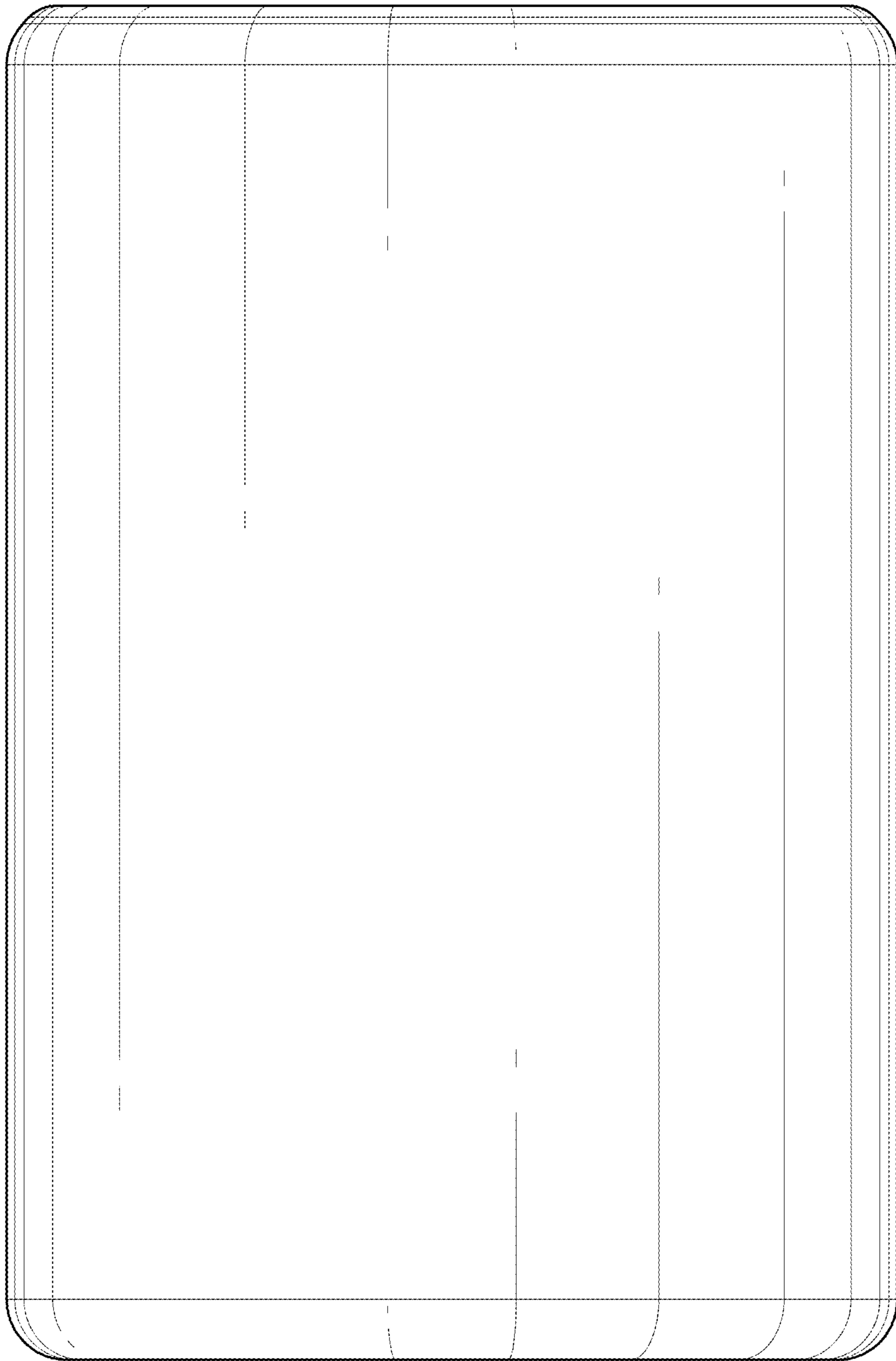

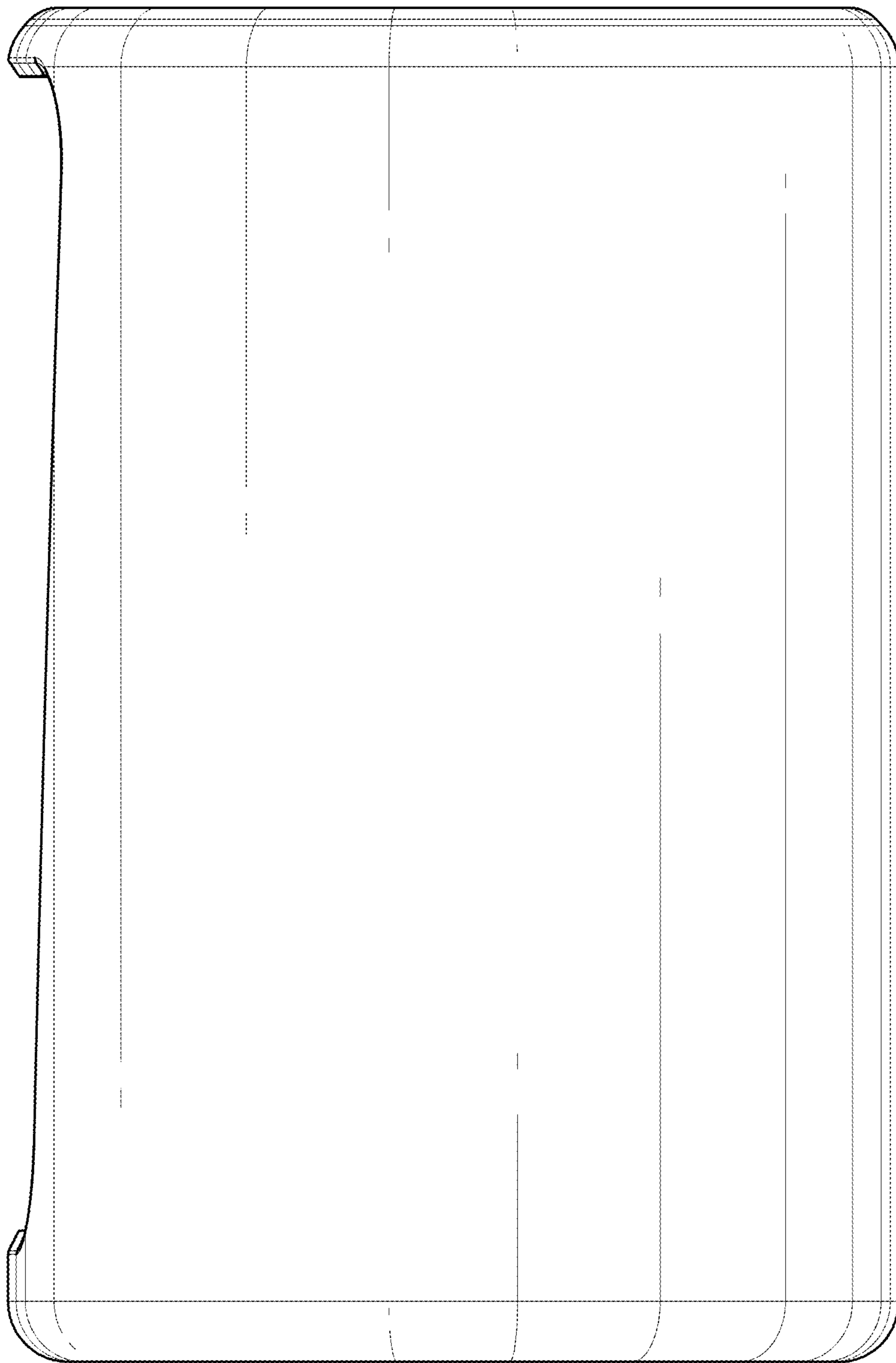

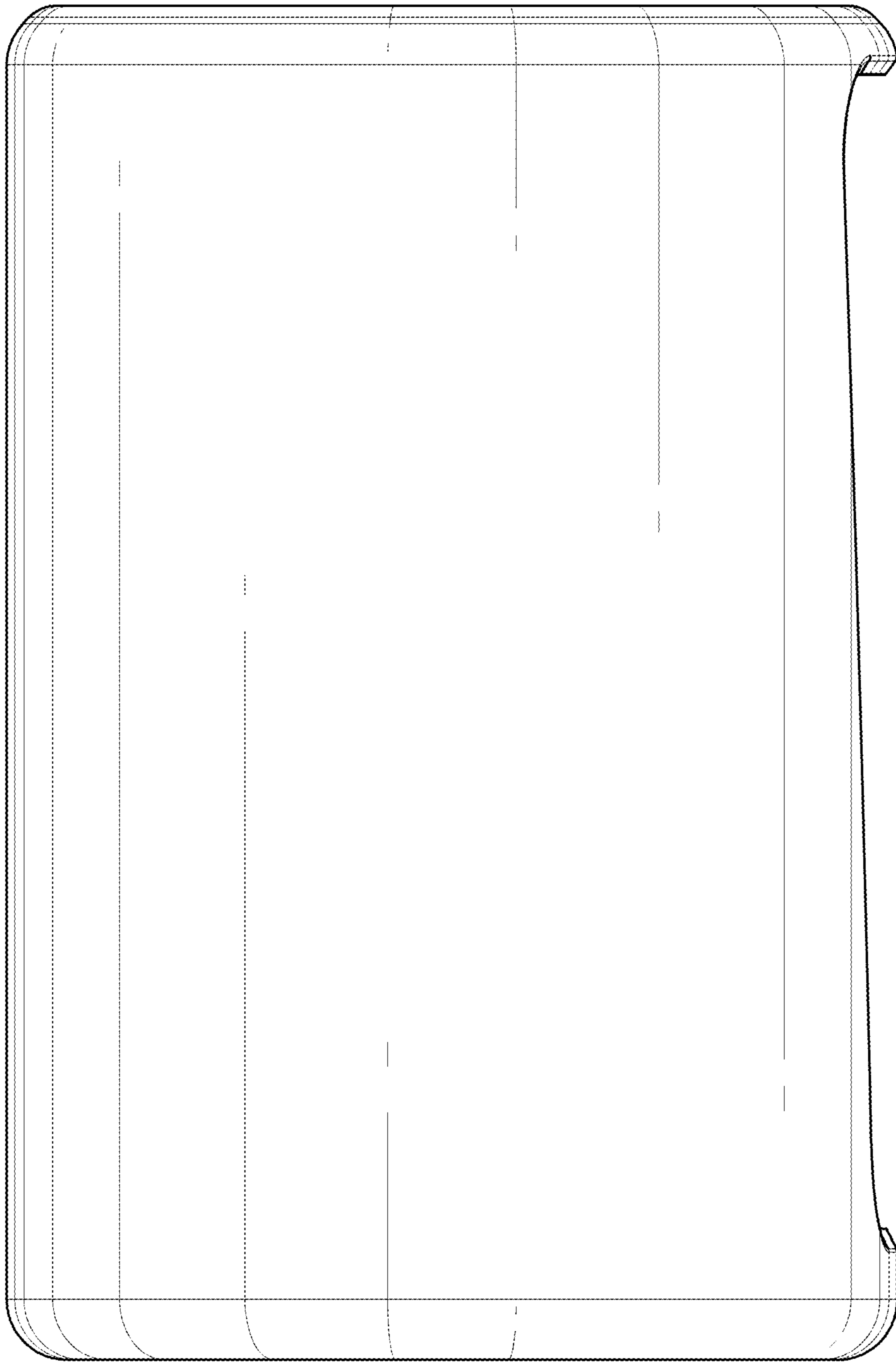

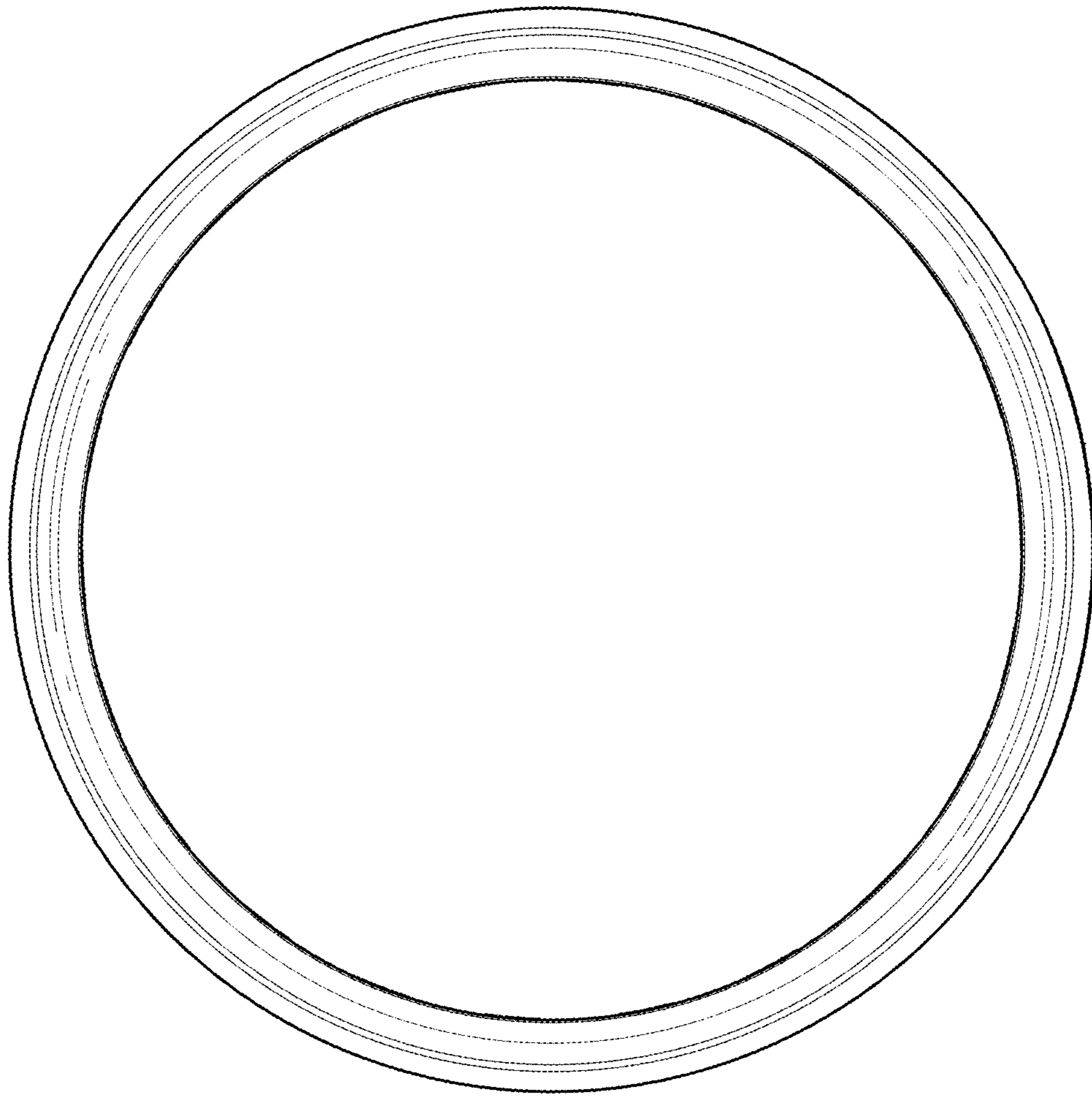

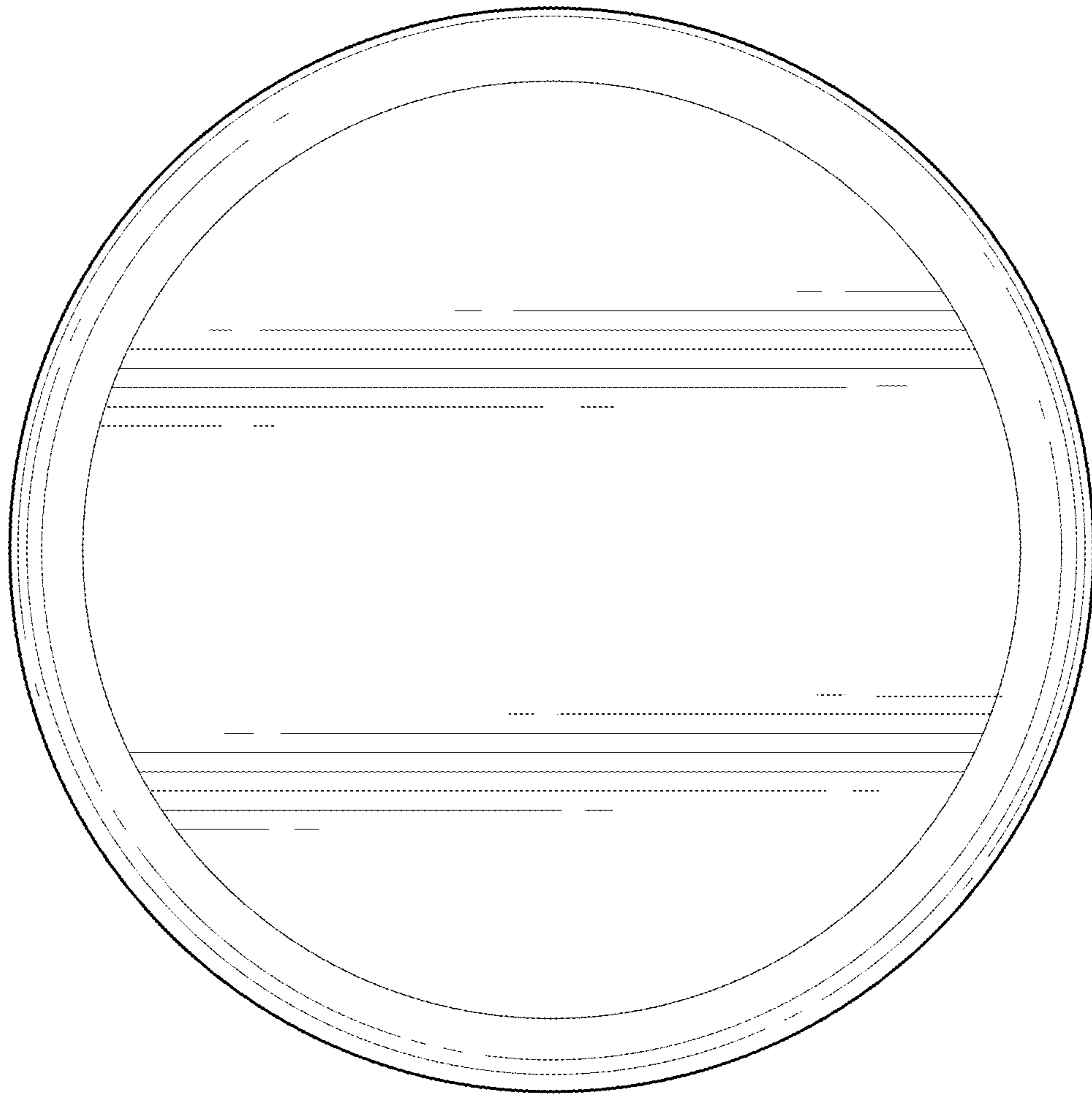
