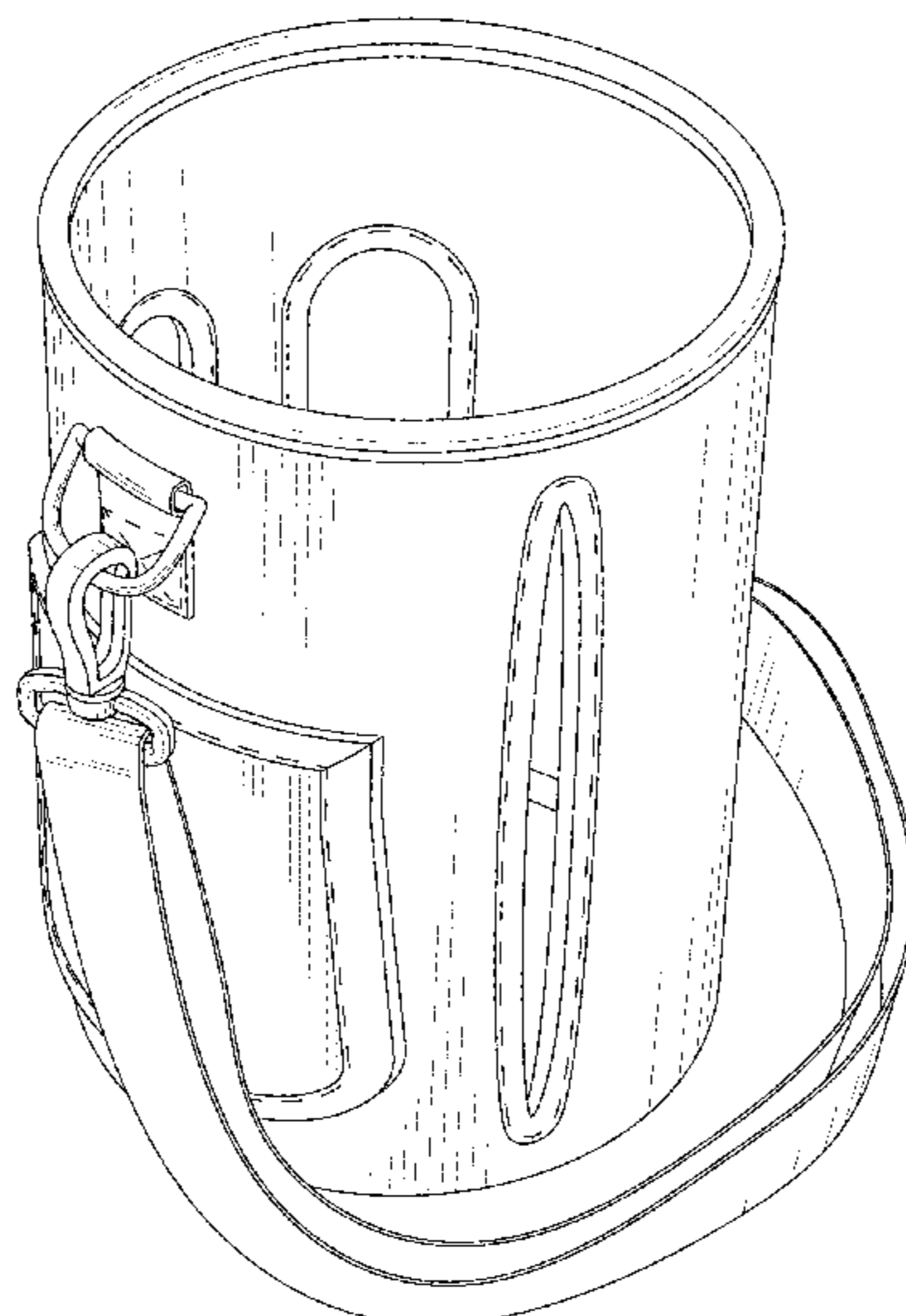
(57) **CLAIM**

The ornamental design for a bottle sleeve, as shown and described.

DESCRIPTION

FIG. 1 is the first perspective view of a bottle sleeve with a strap showing my new design;
FIG. 2 is the second perspective view thereof;
FIG. 3 is the third perspective view thereof;
FIG. 4 is a front view thereof;
FIG. 5 is a rear view thereof;
FIG. 6 is a left side view thereof;
FIG. 7 is a right side view thereof;
FIG. 8 is a top plan view thereof; and,
FIG. 9 is a bottom plan view thereof.
The broken lines are representing stitching of the bottle sleeve and the broken lines form no part of the claimed design.
The strap in FIG. 1 is removed in the other Figs. for ease of illustration.

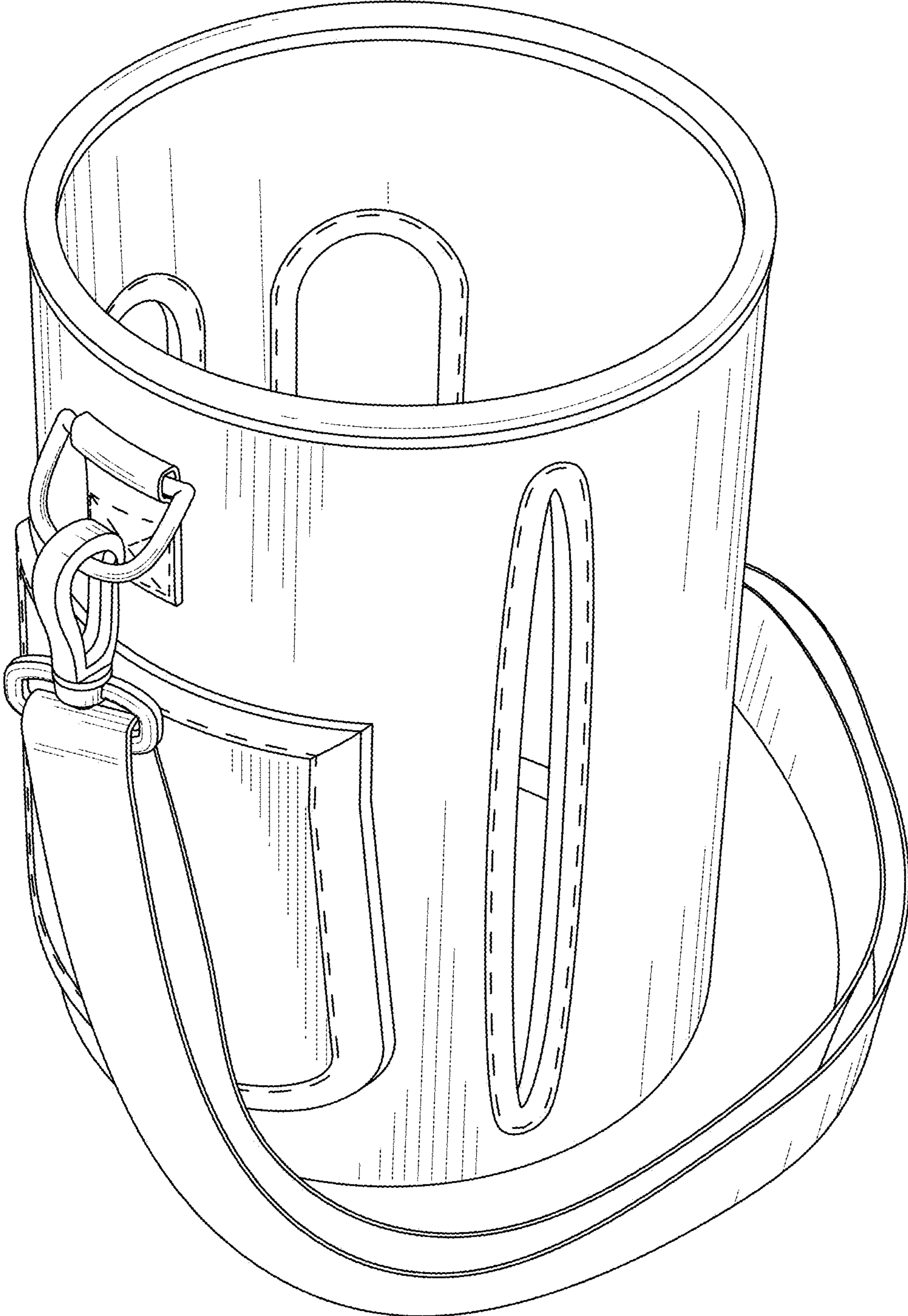

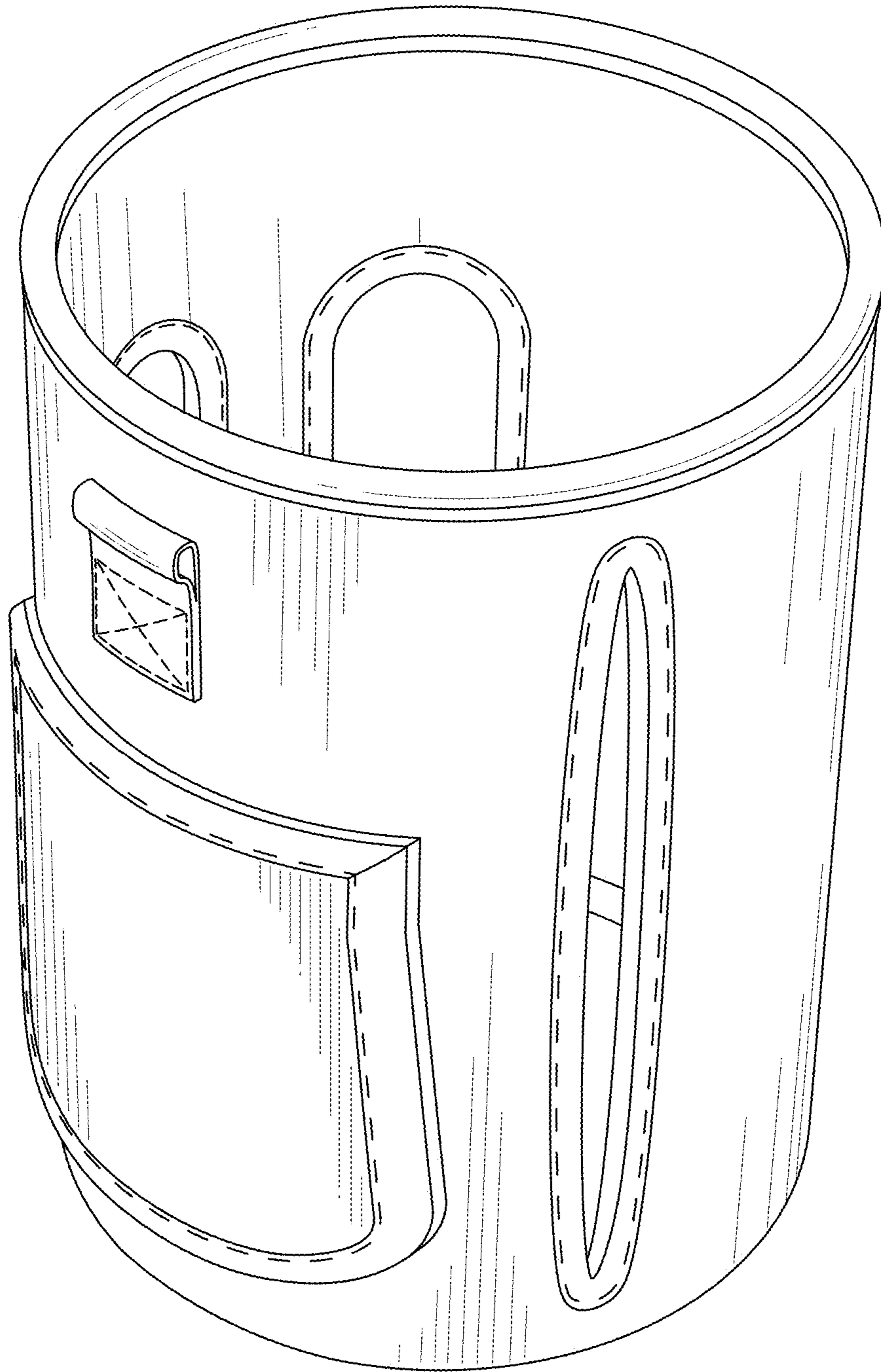

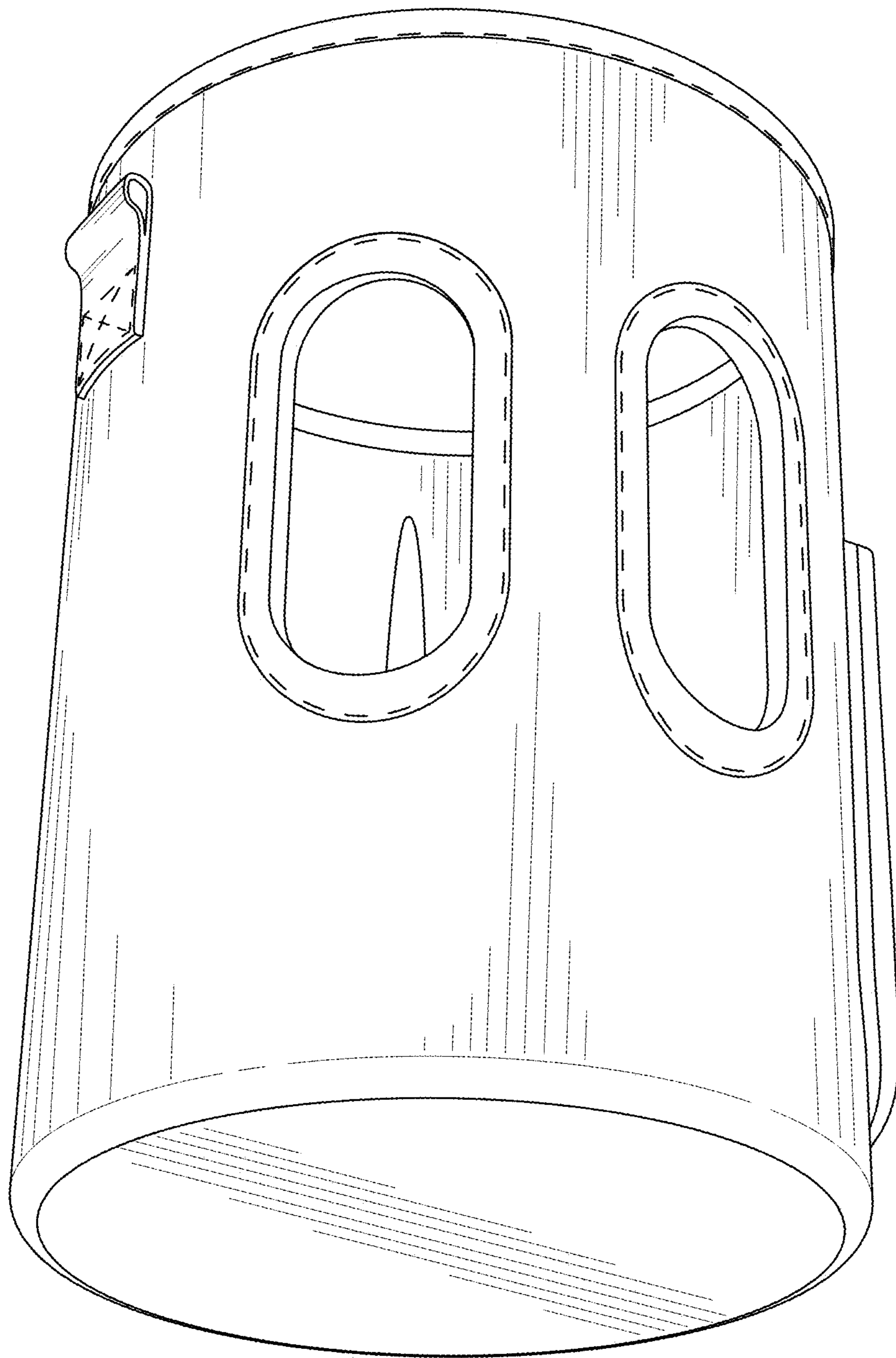

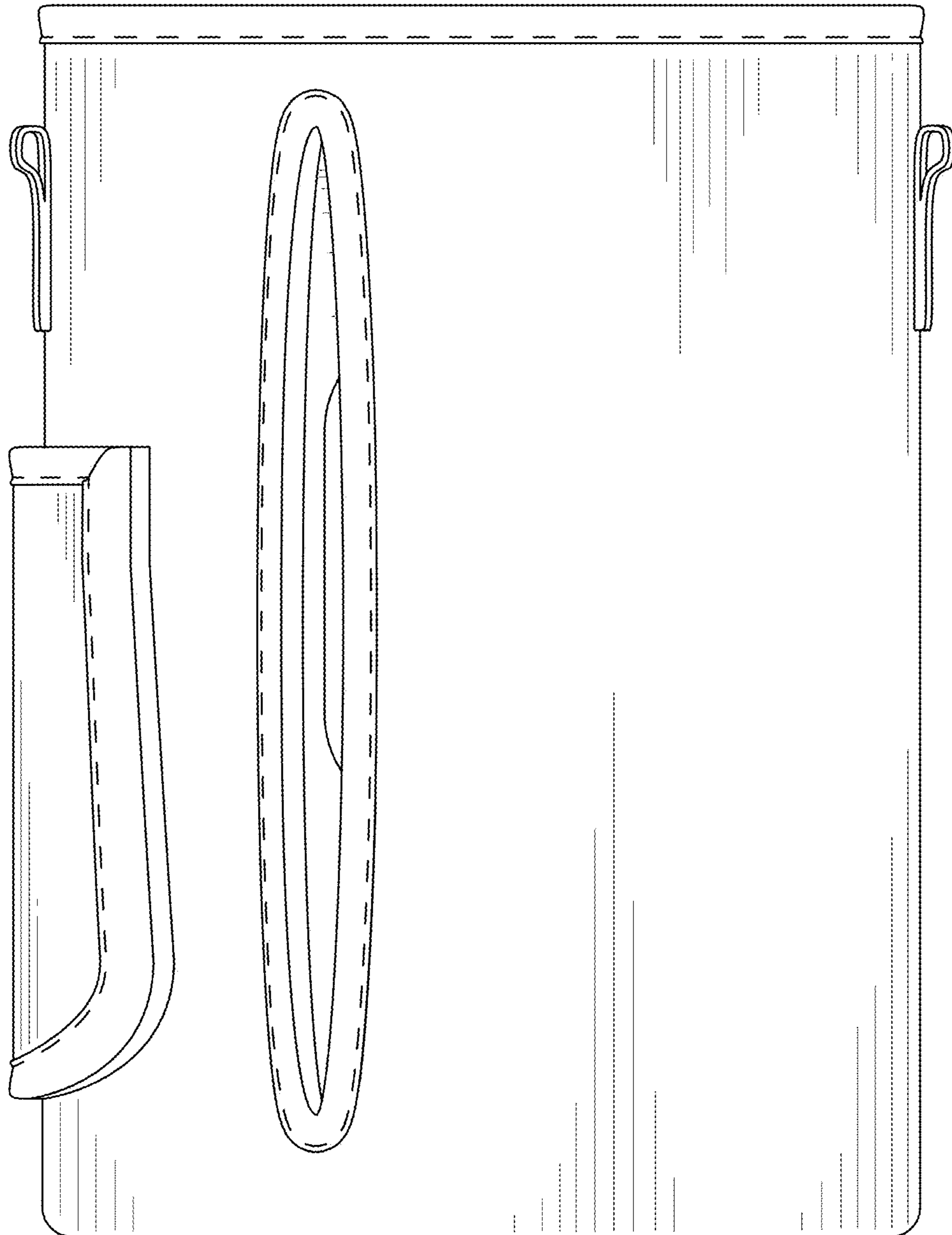

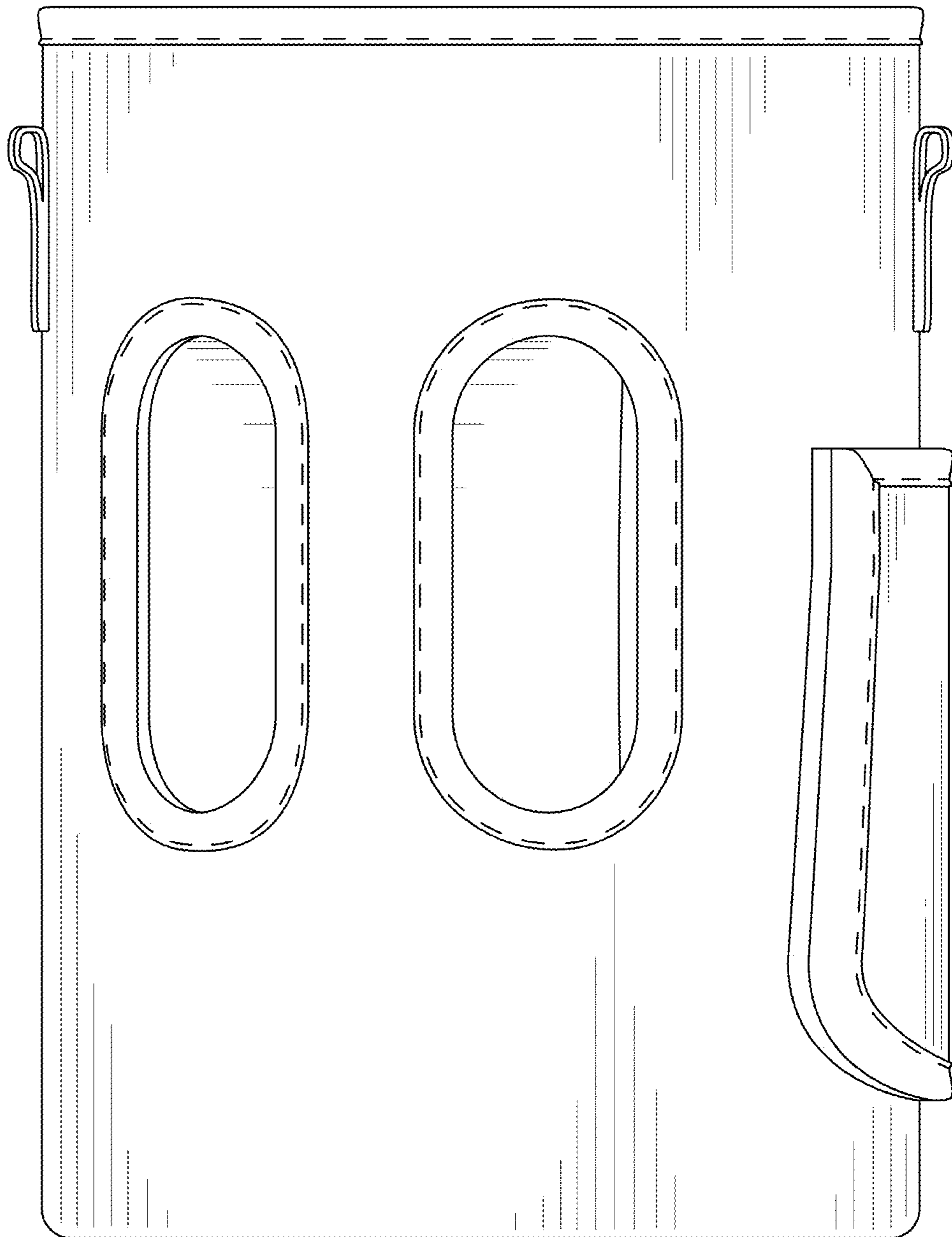

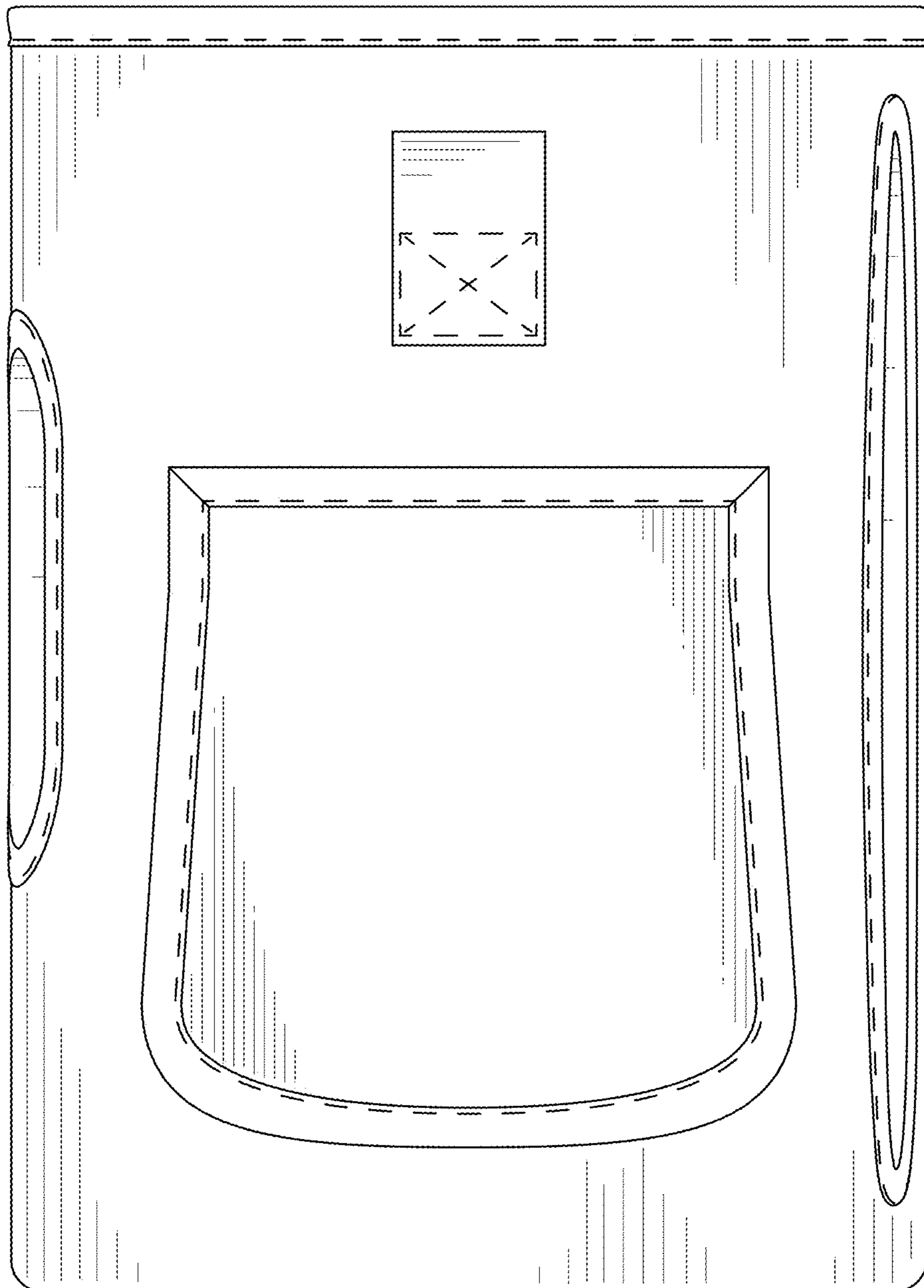

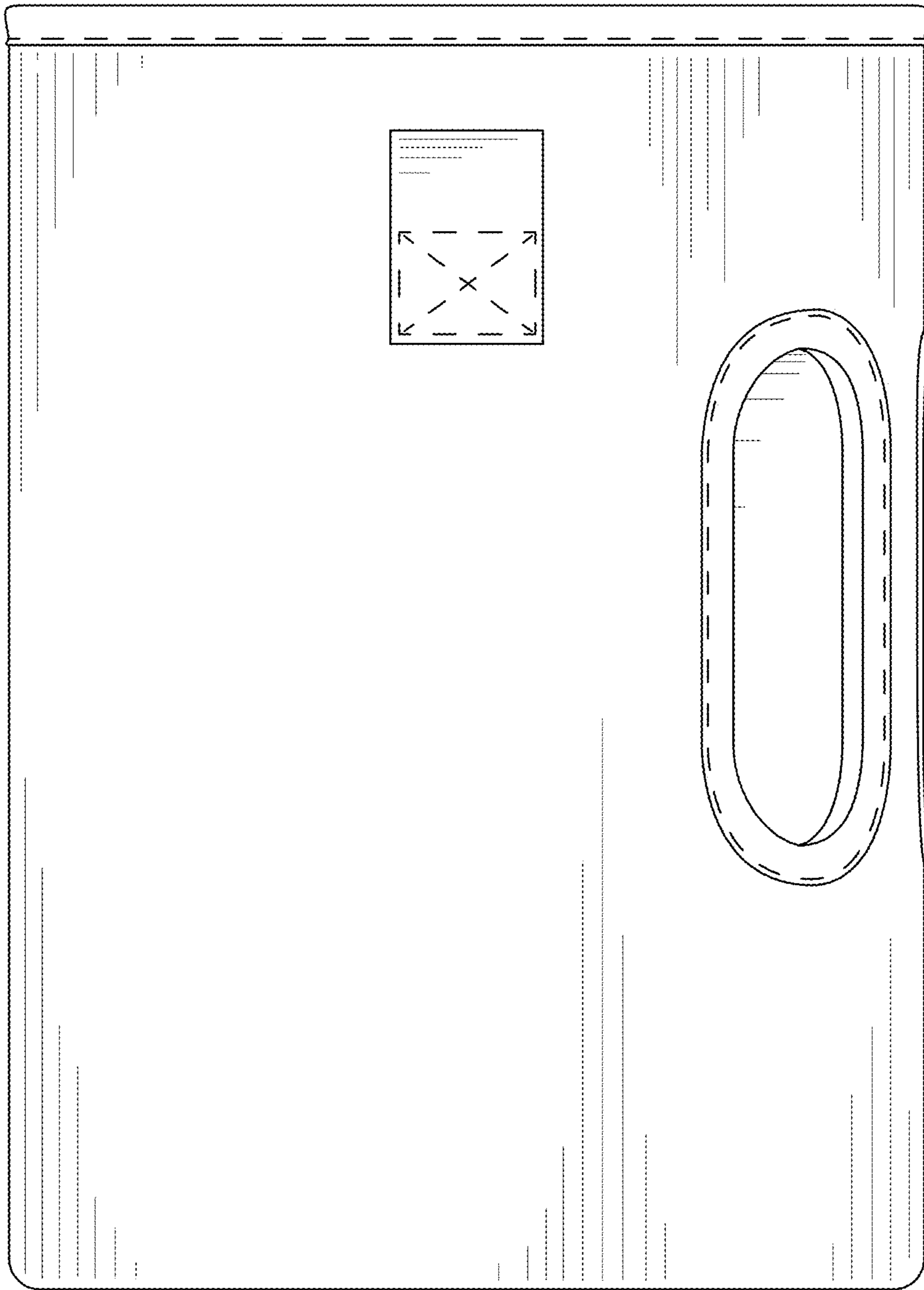

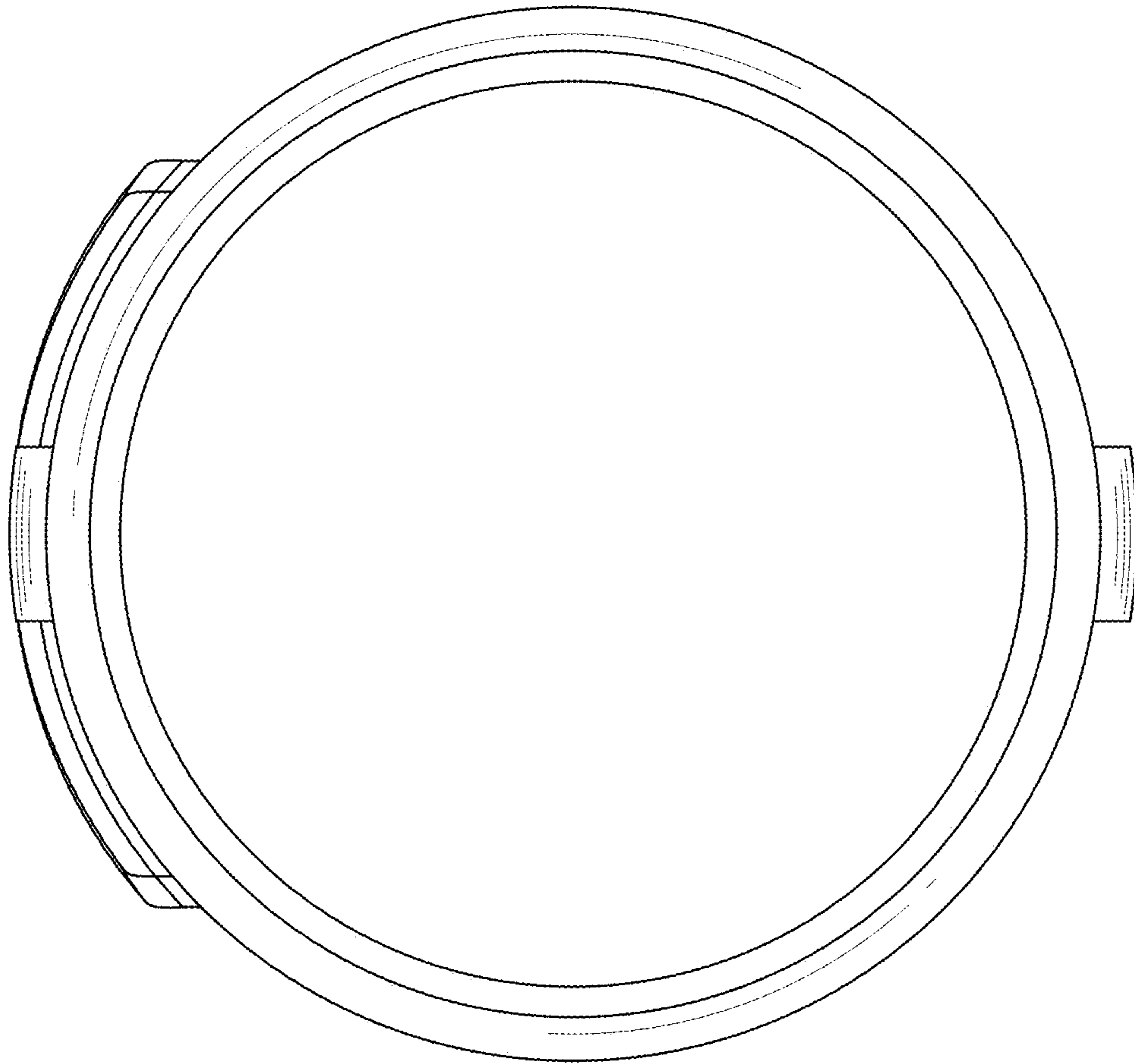

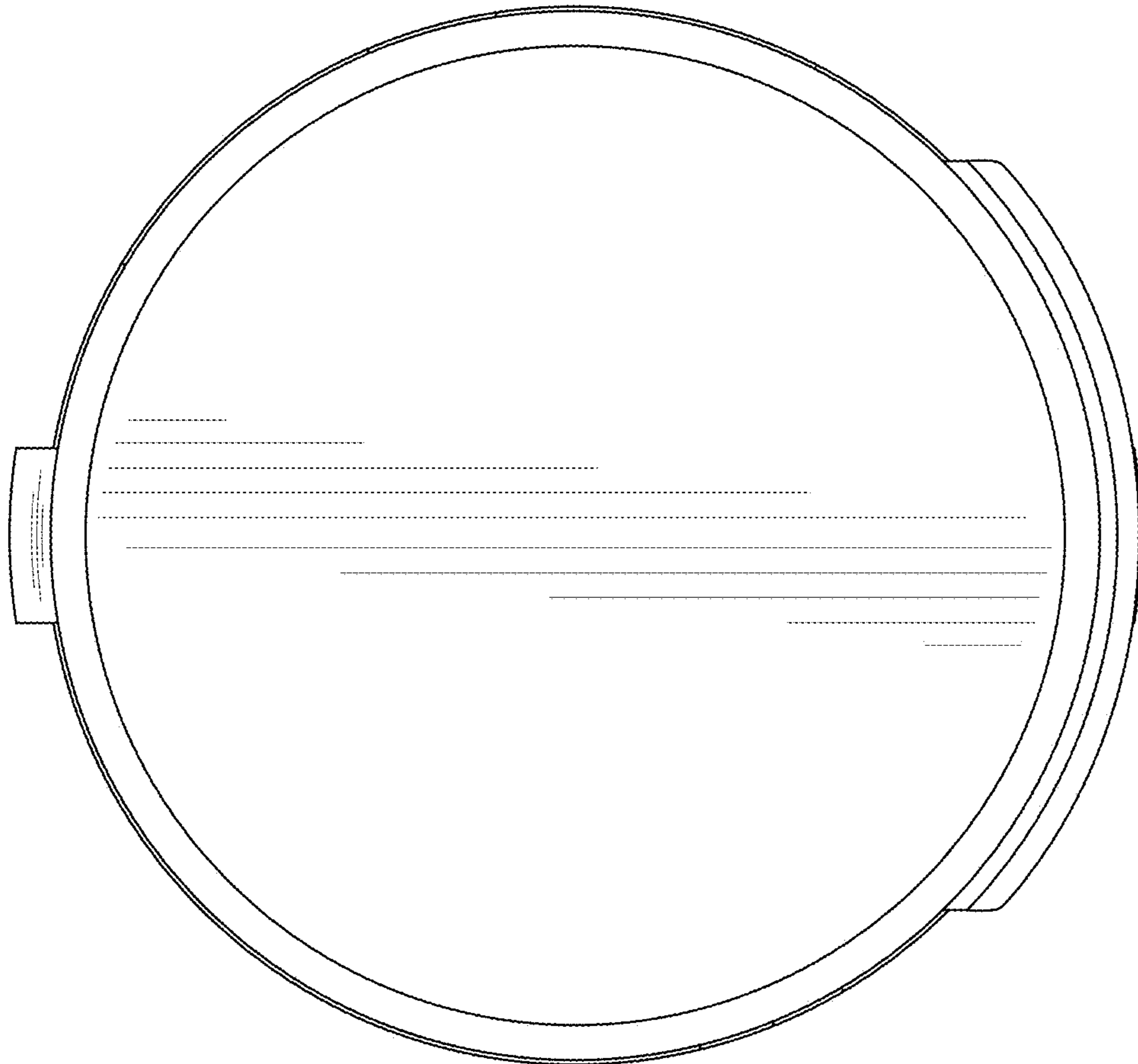
