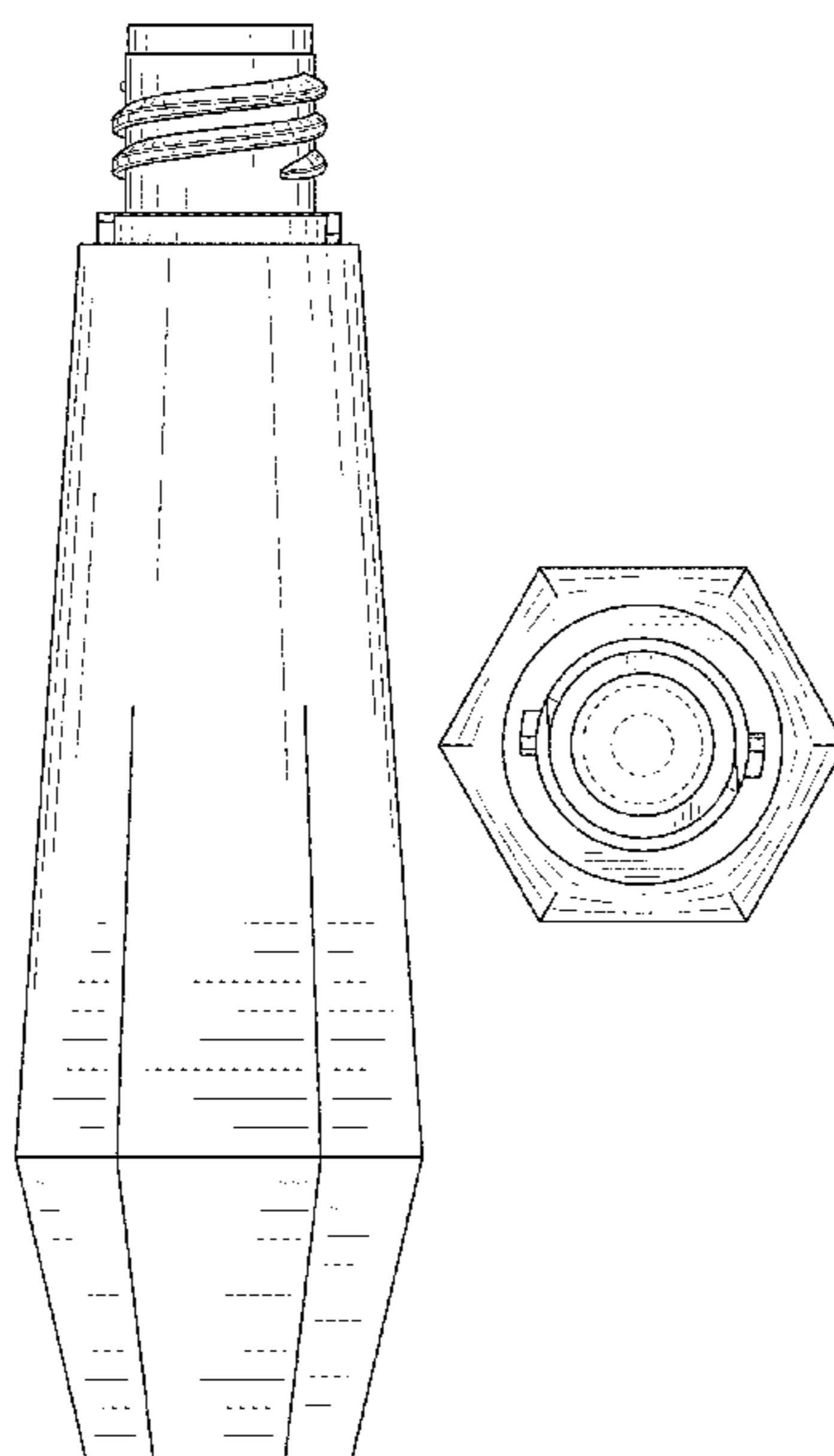
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a bottle for cosmetic applicator, showing our new design.
FIG. 2 is a front view thereof.

FIG. 4 is a right side view thereof.

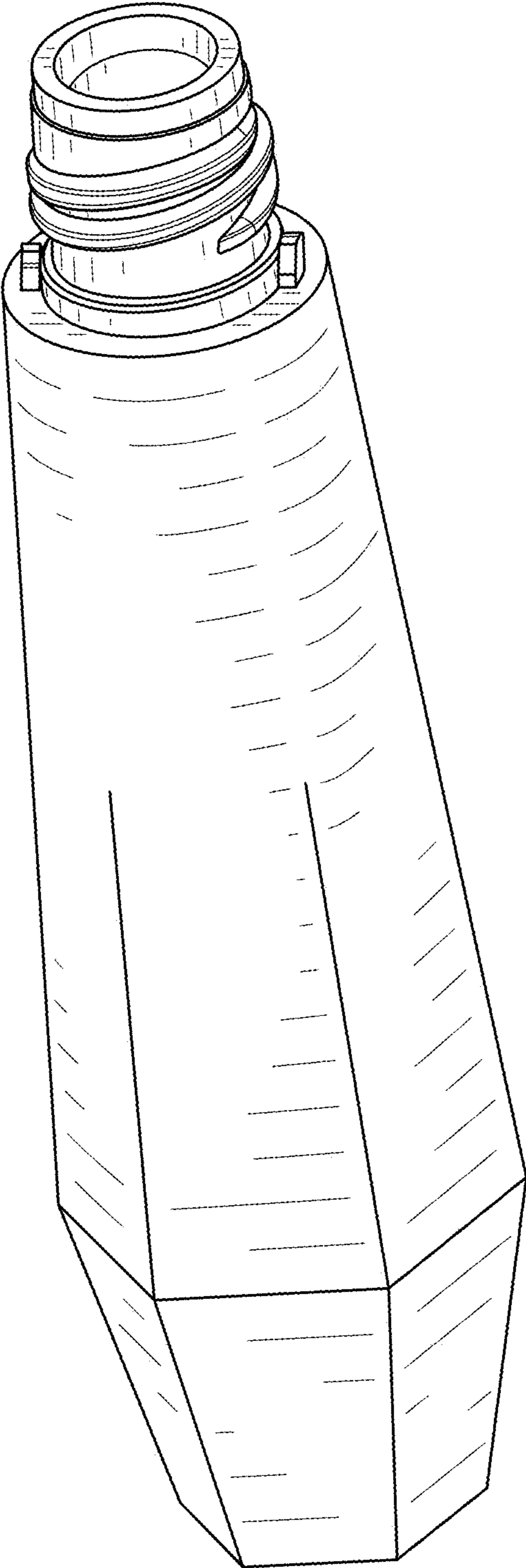

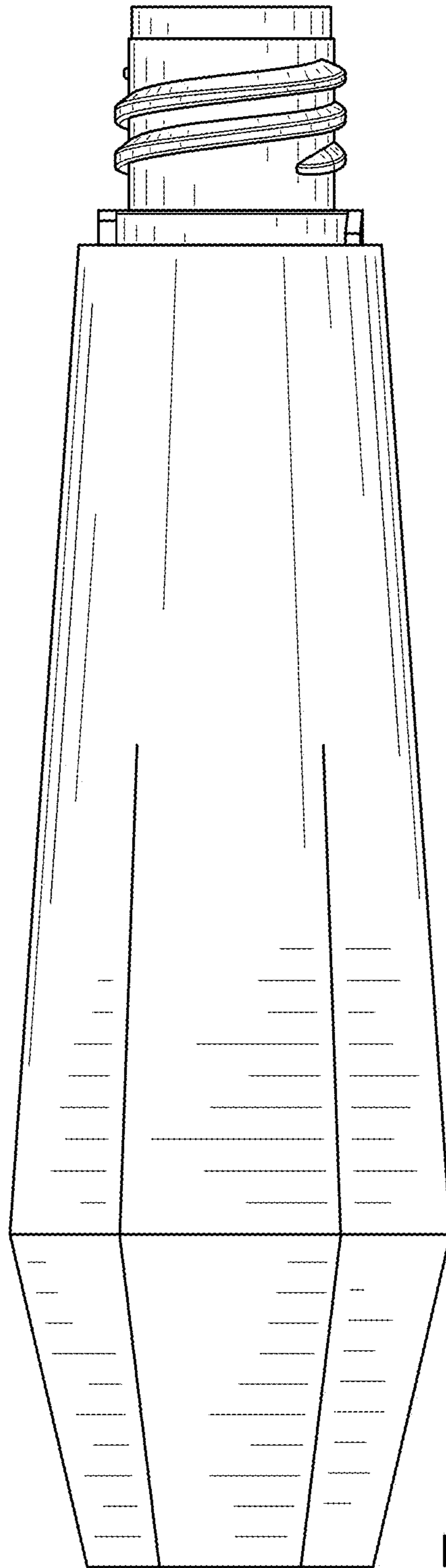

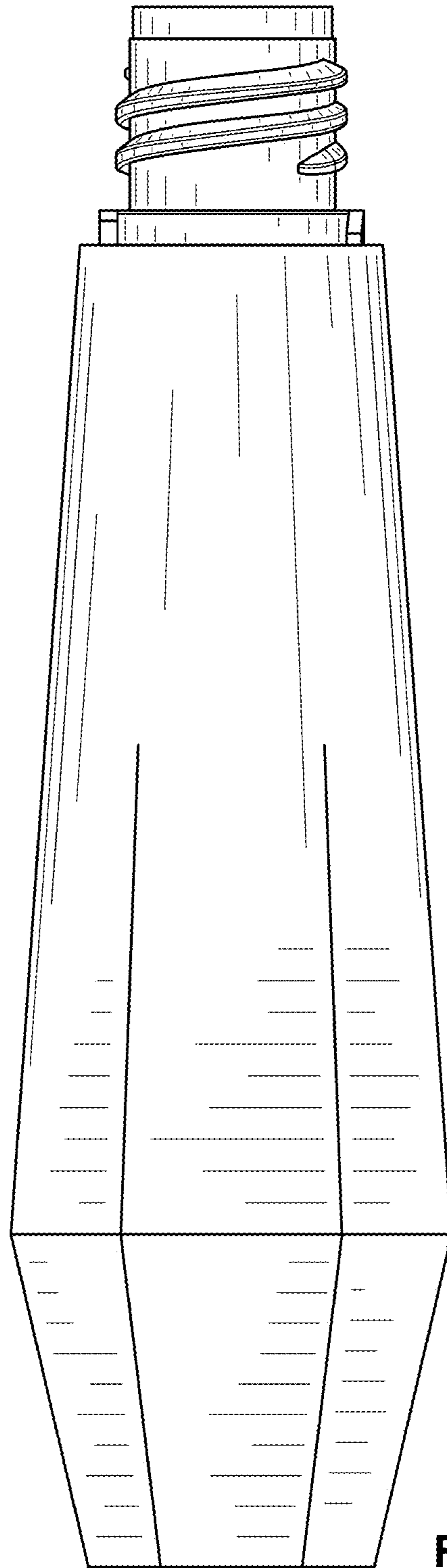

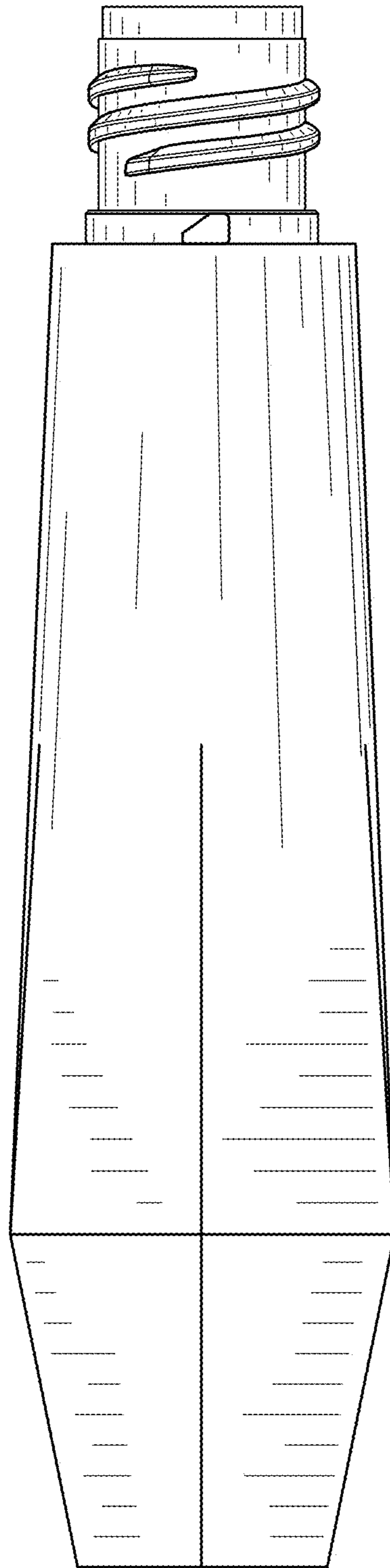

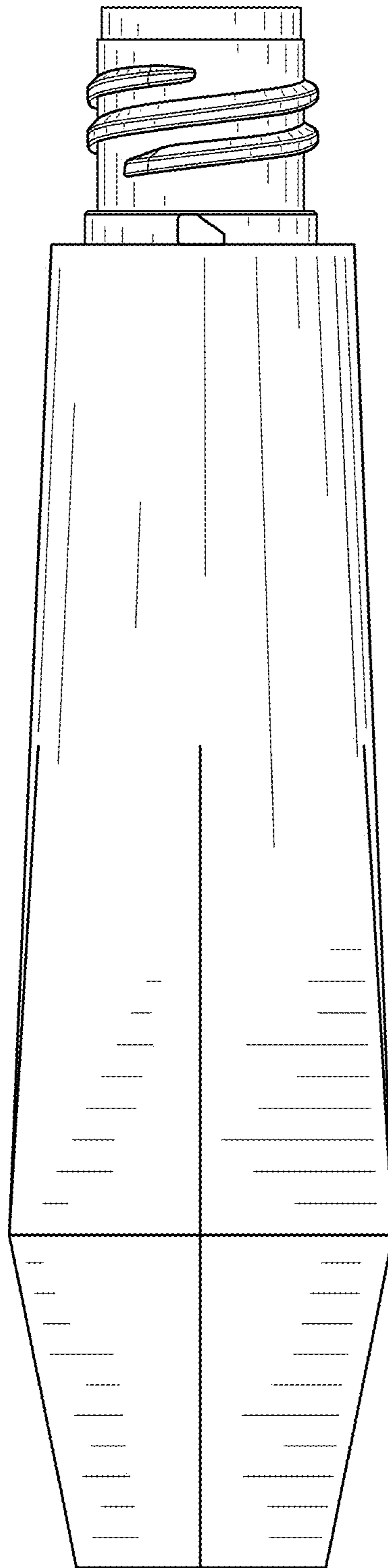

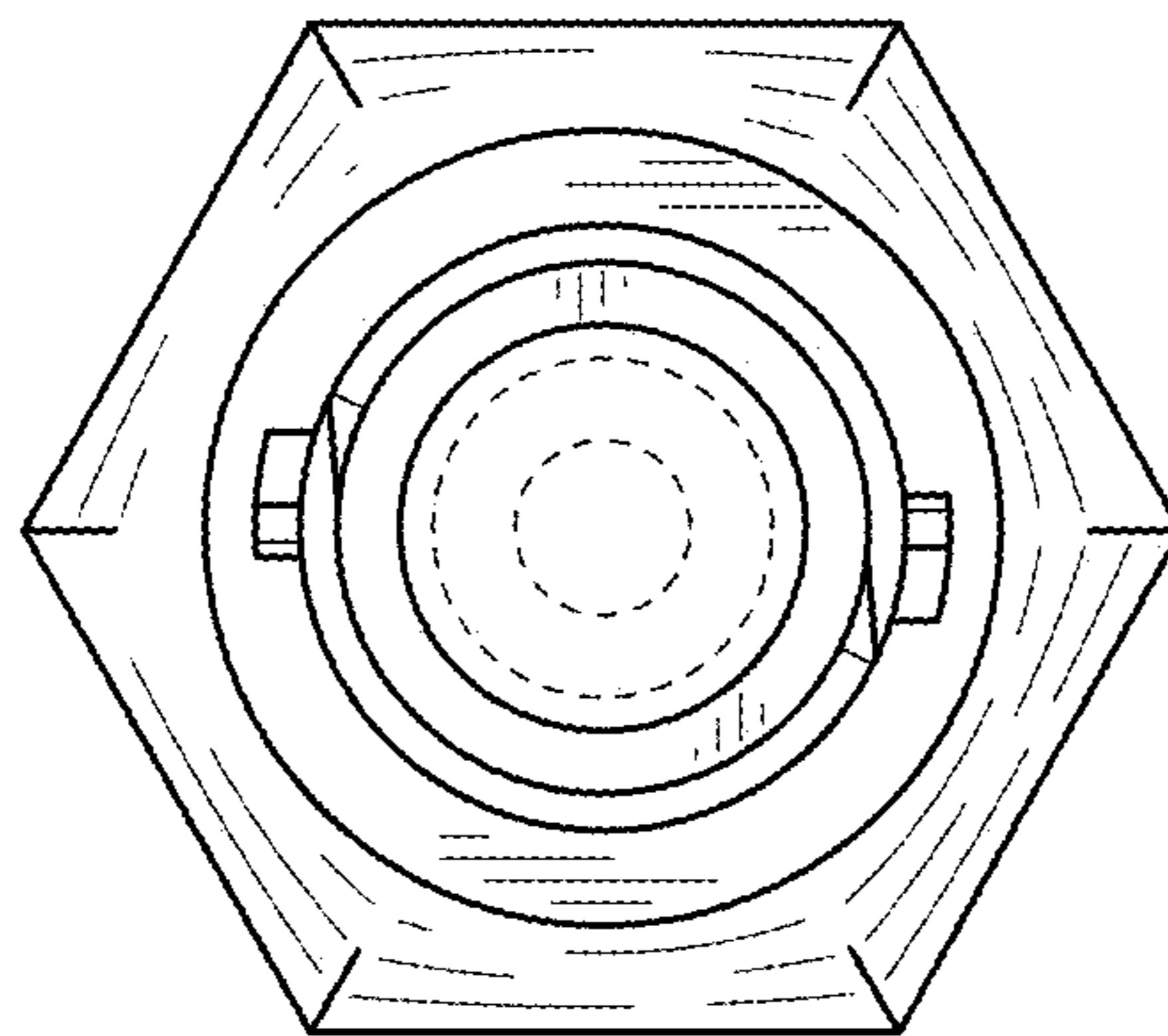

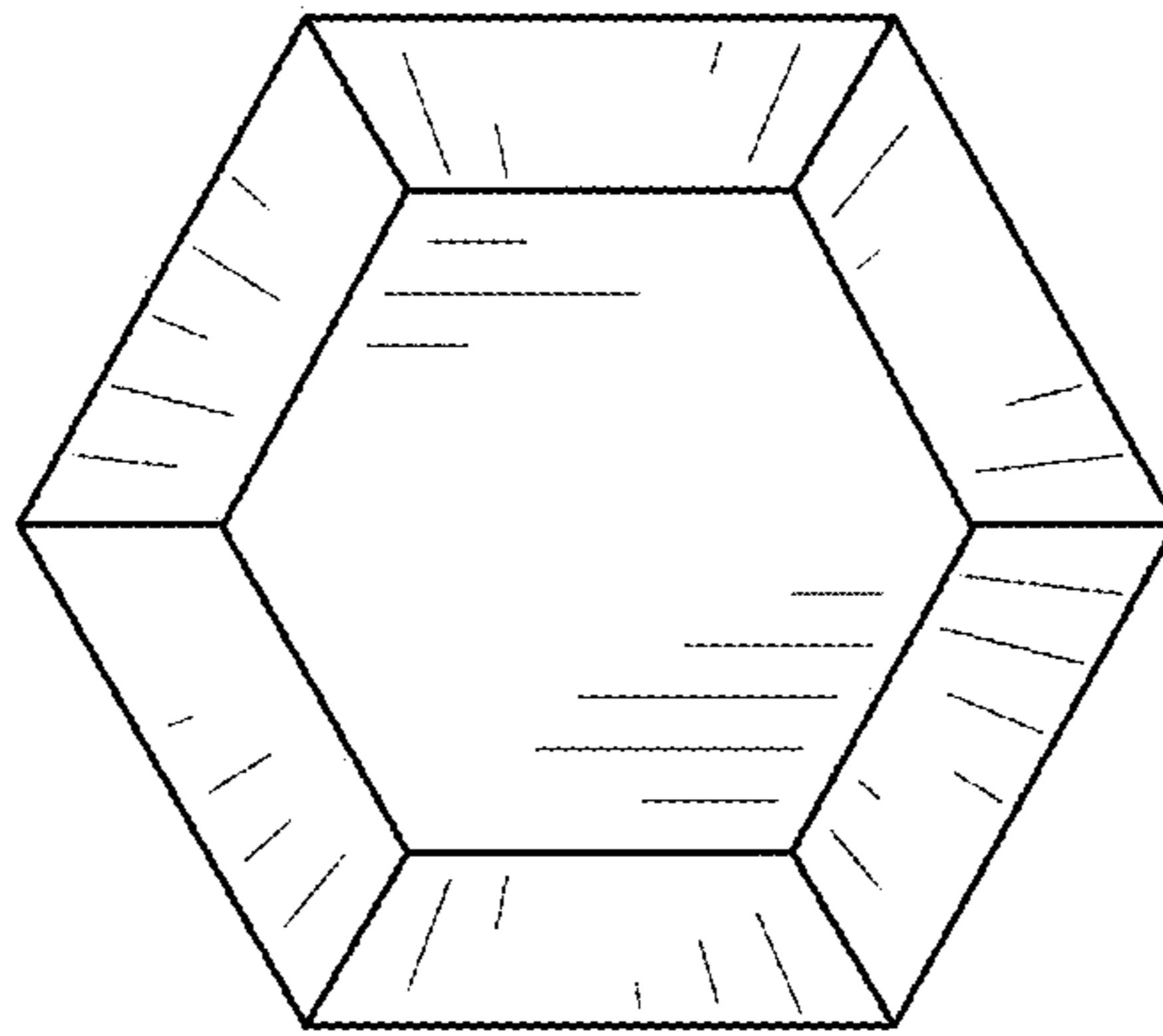
