(57) **CLAIM**

The ornamental design for a watch, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a watch showing my new design, shown with a front cover in a closed position; FIG. 2 is a back elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a left side elevational view thereof; FIG. 7 is a front, right side perspective view thereof; FIG. 8 is a back, right side perspective view thereof; and, FIG. 9 is a front, right side perspective view of the watch, shown with the front cover in an alternate, open position.

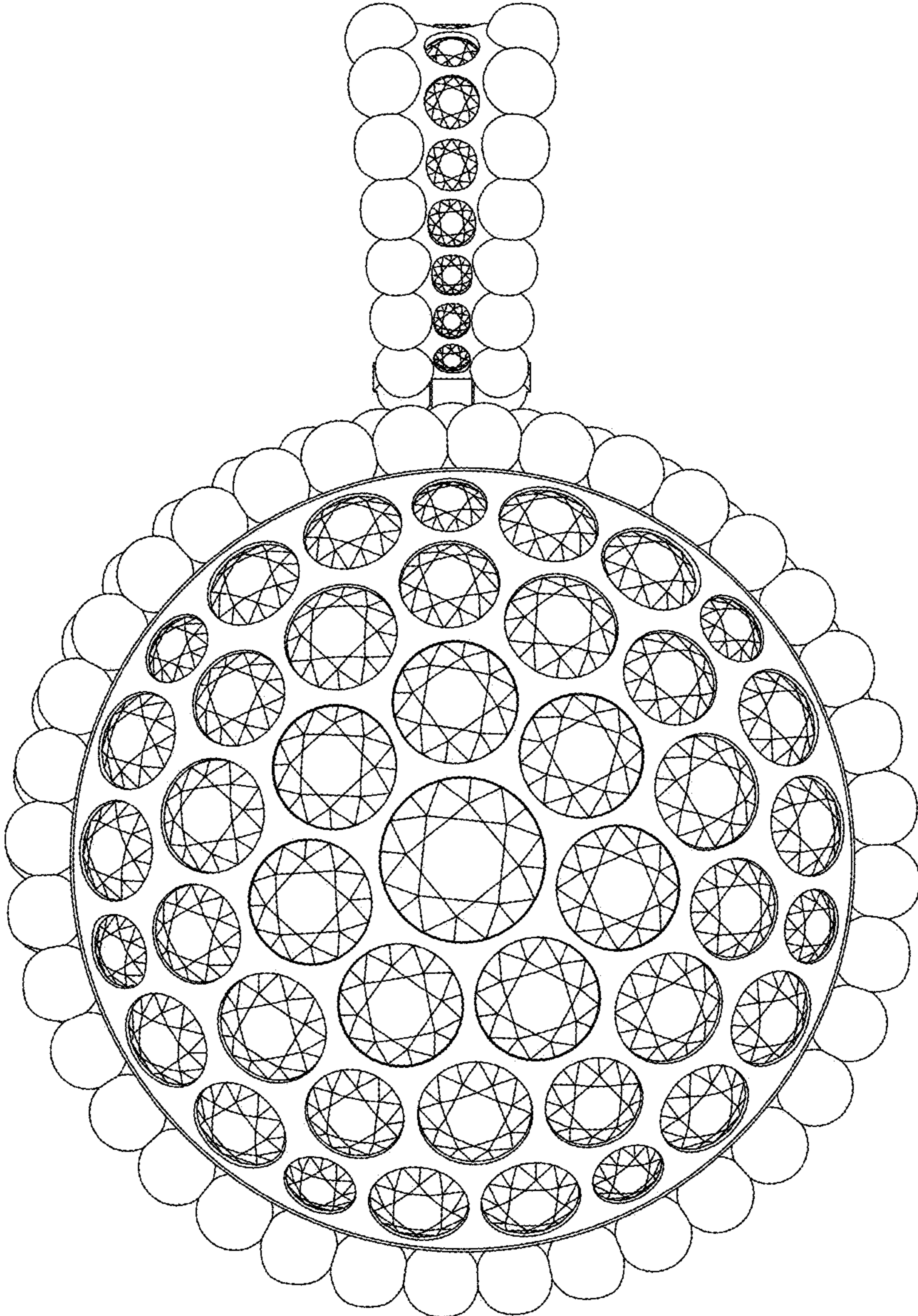

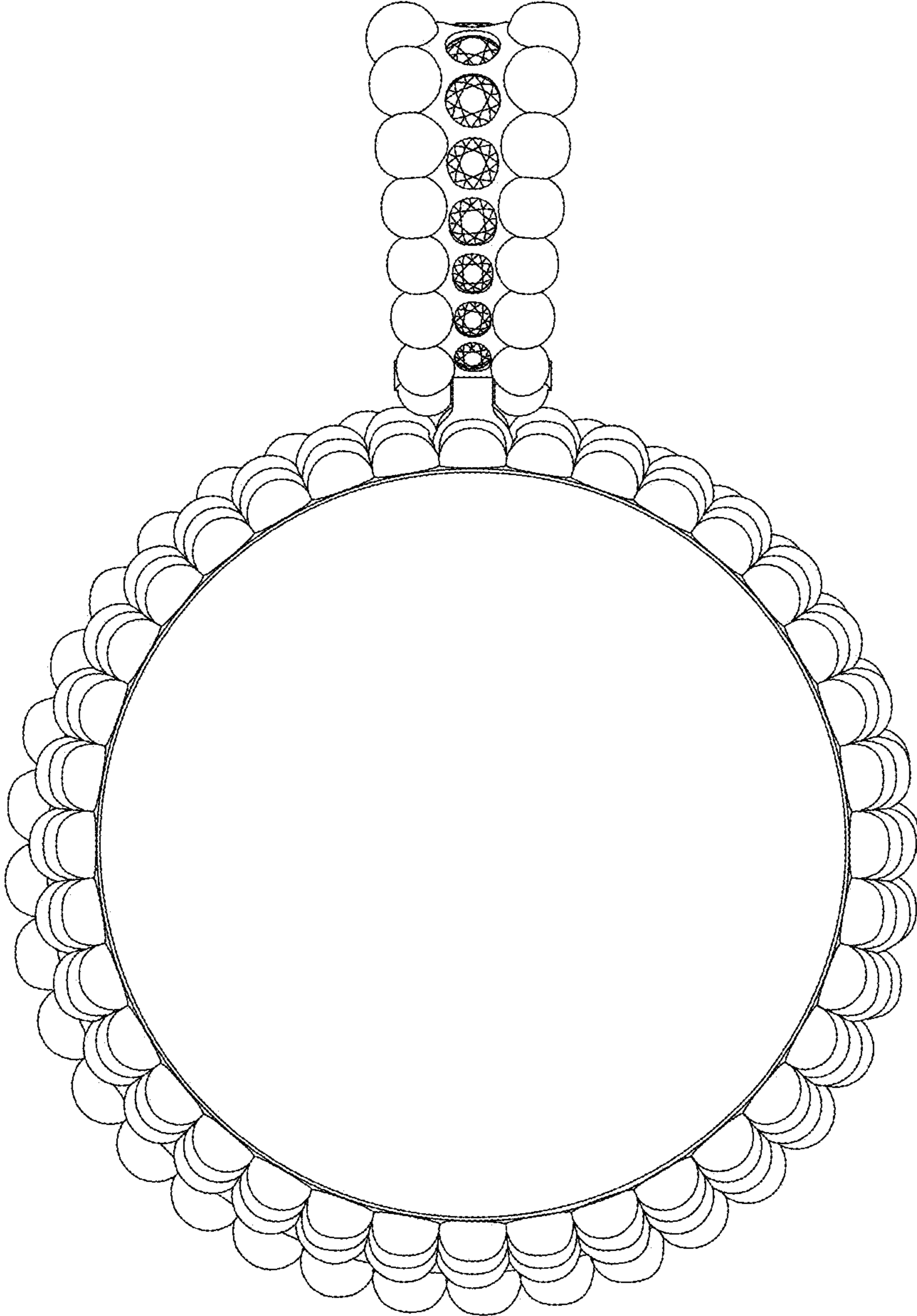

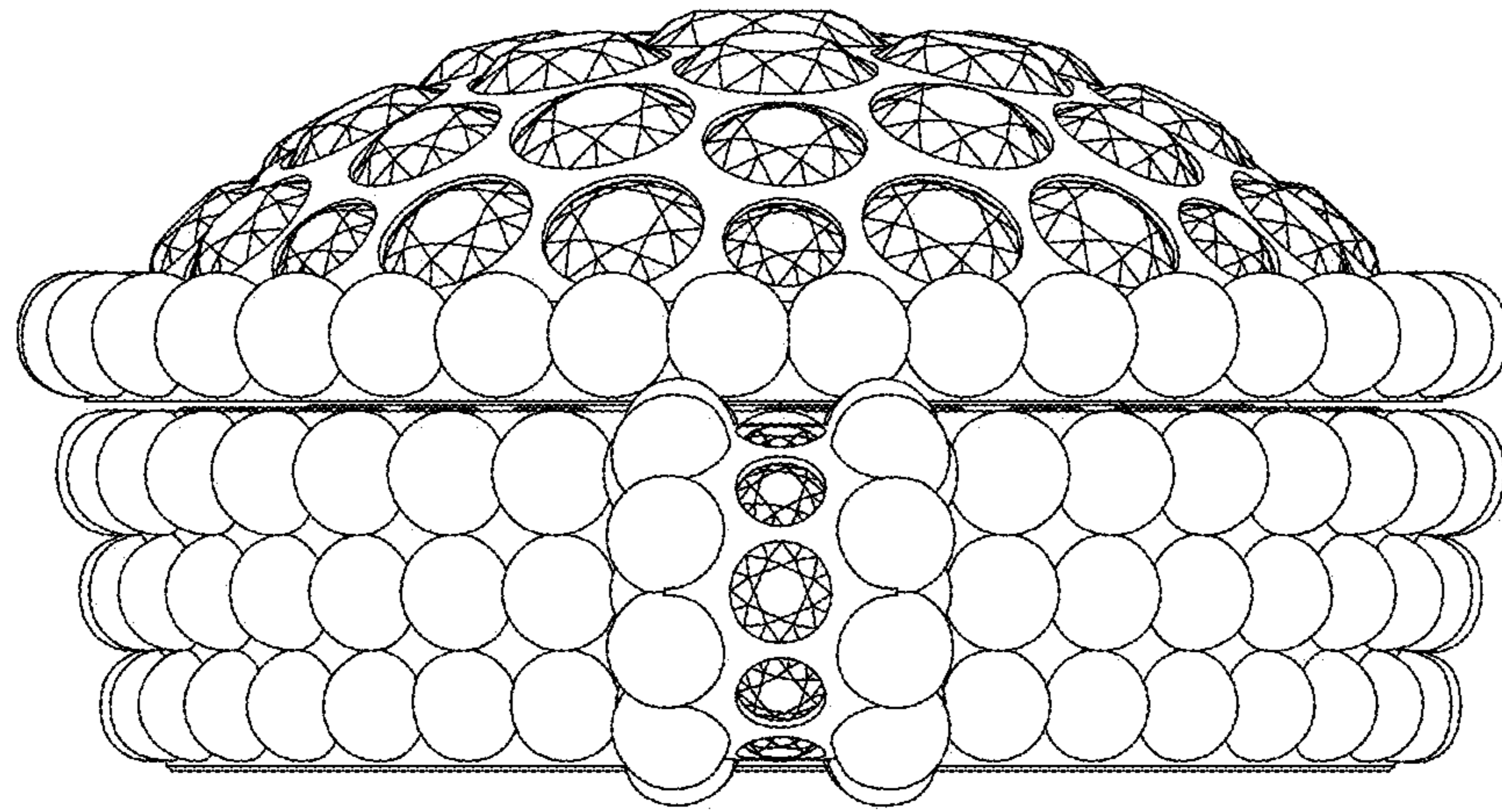

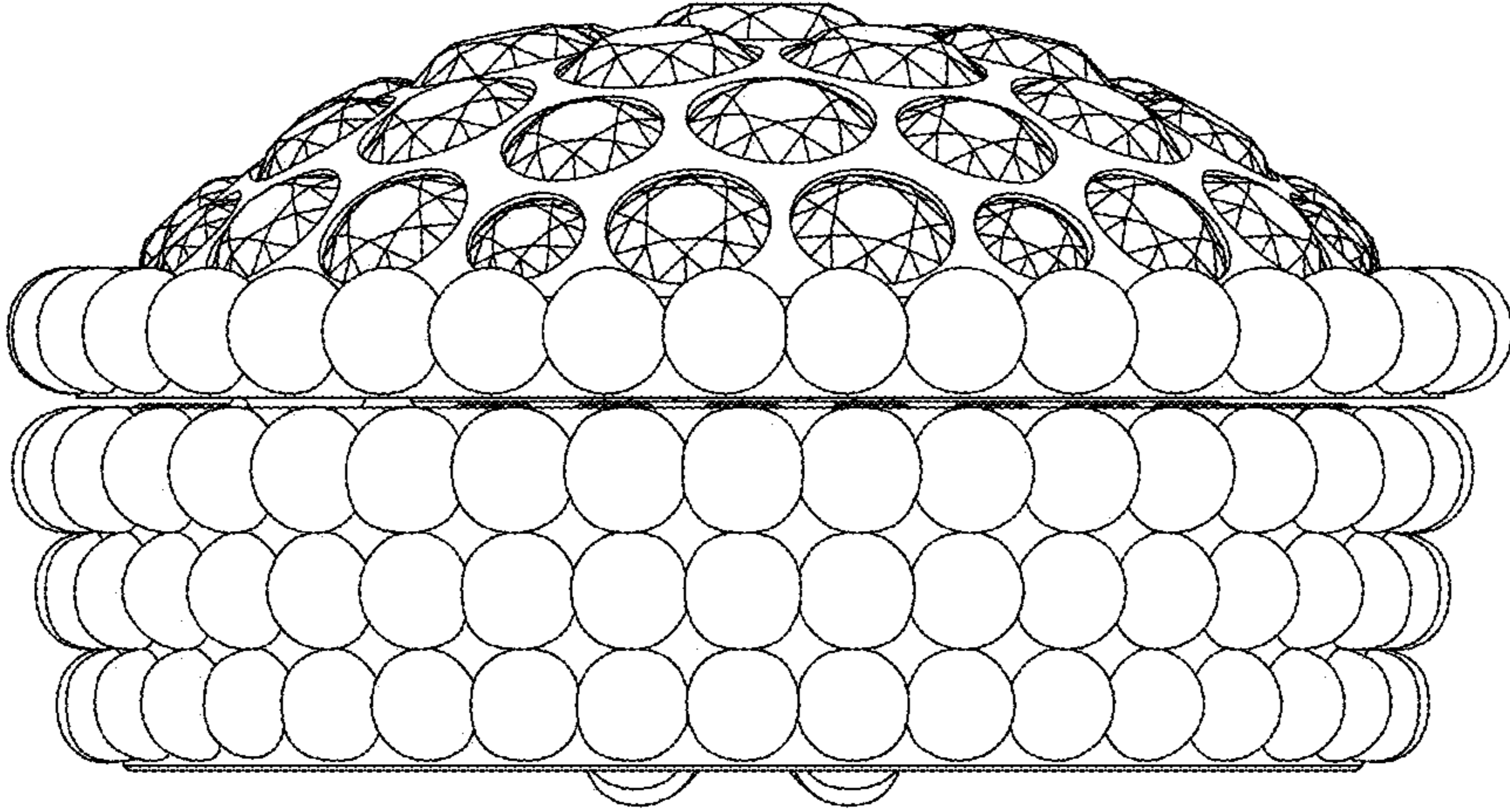

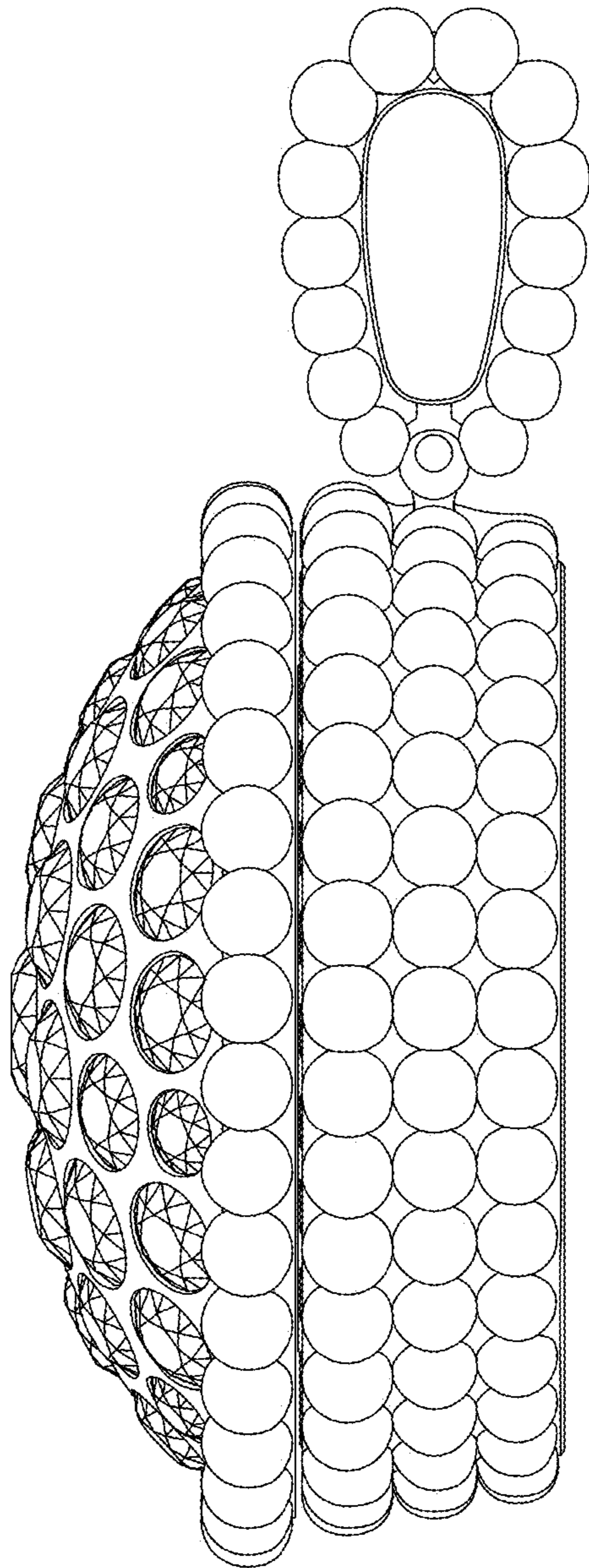

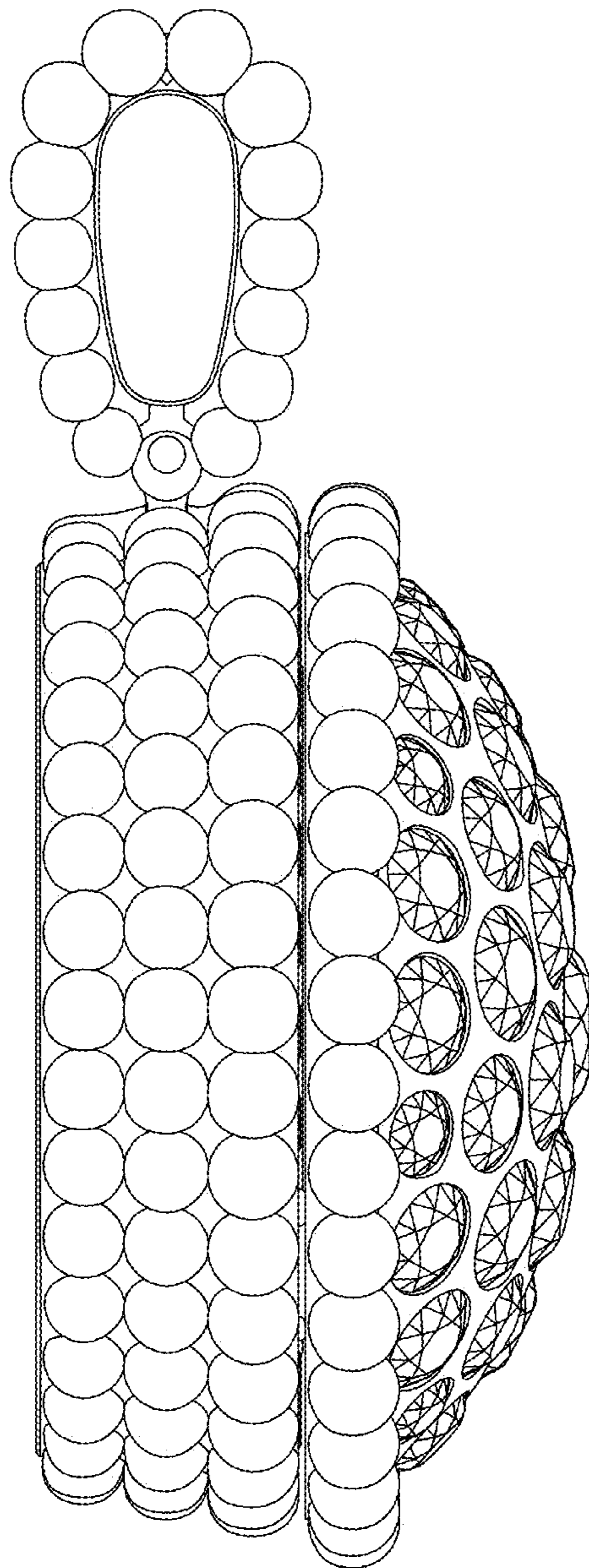

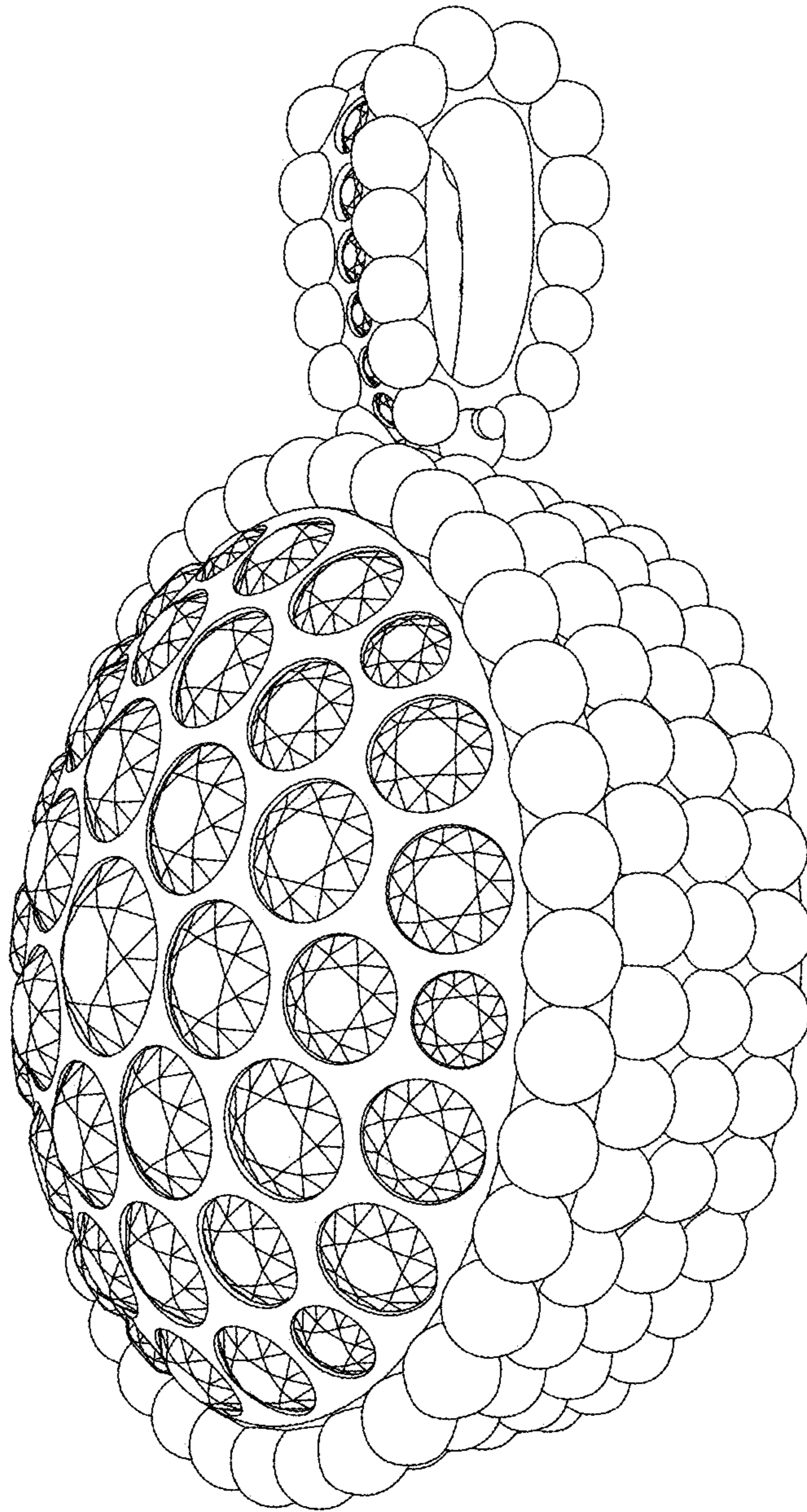

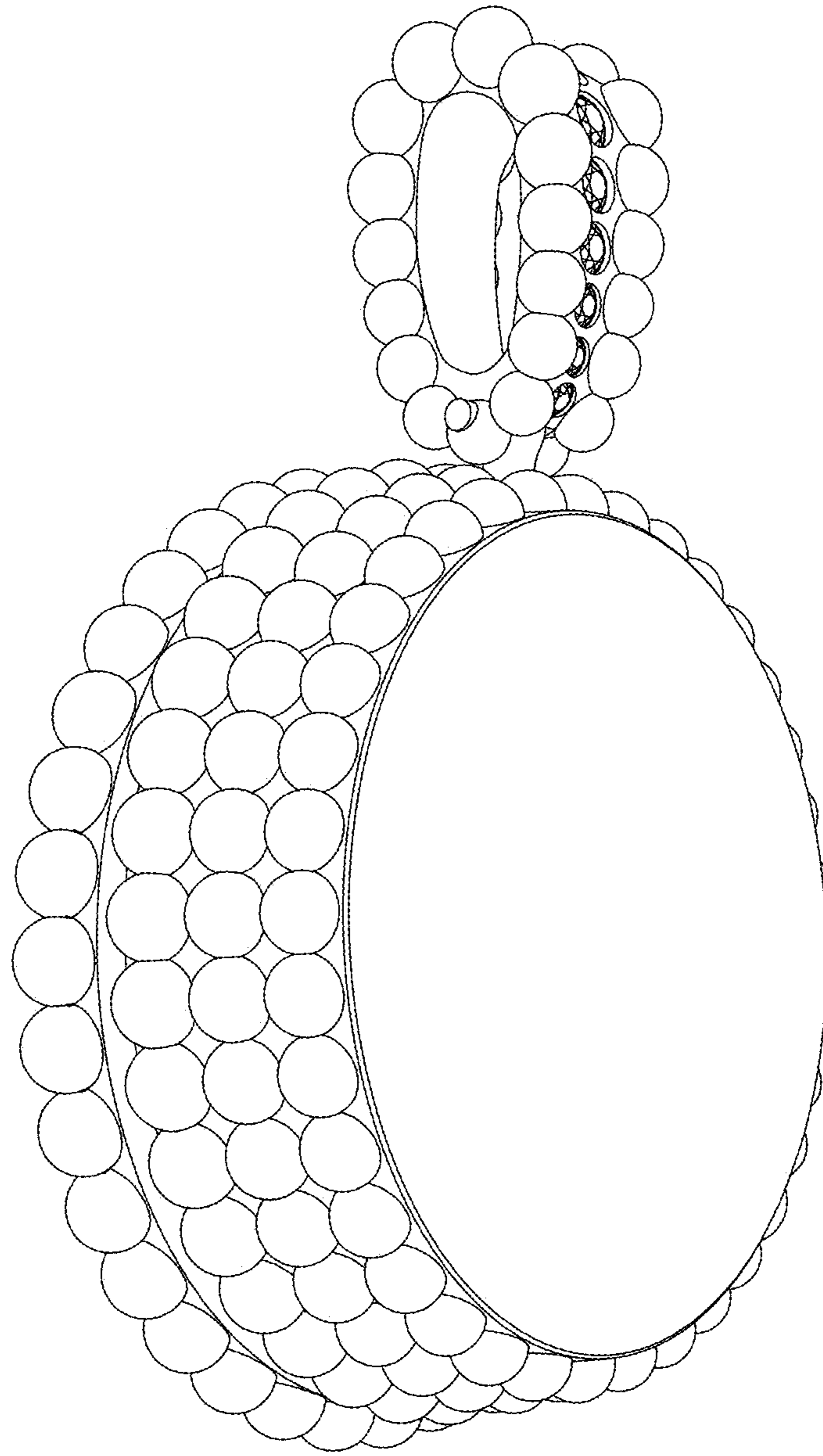

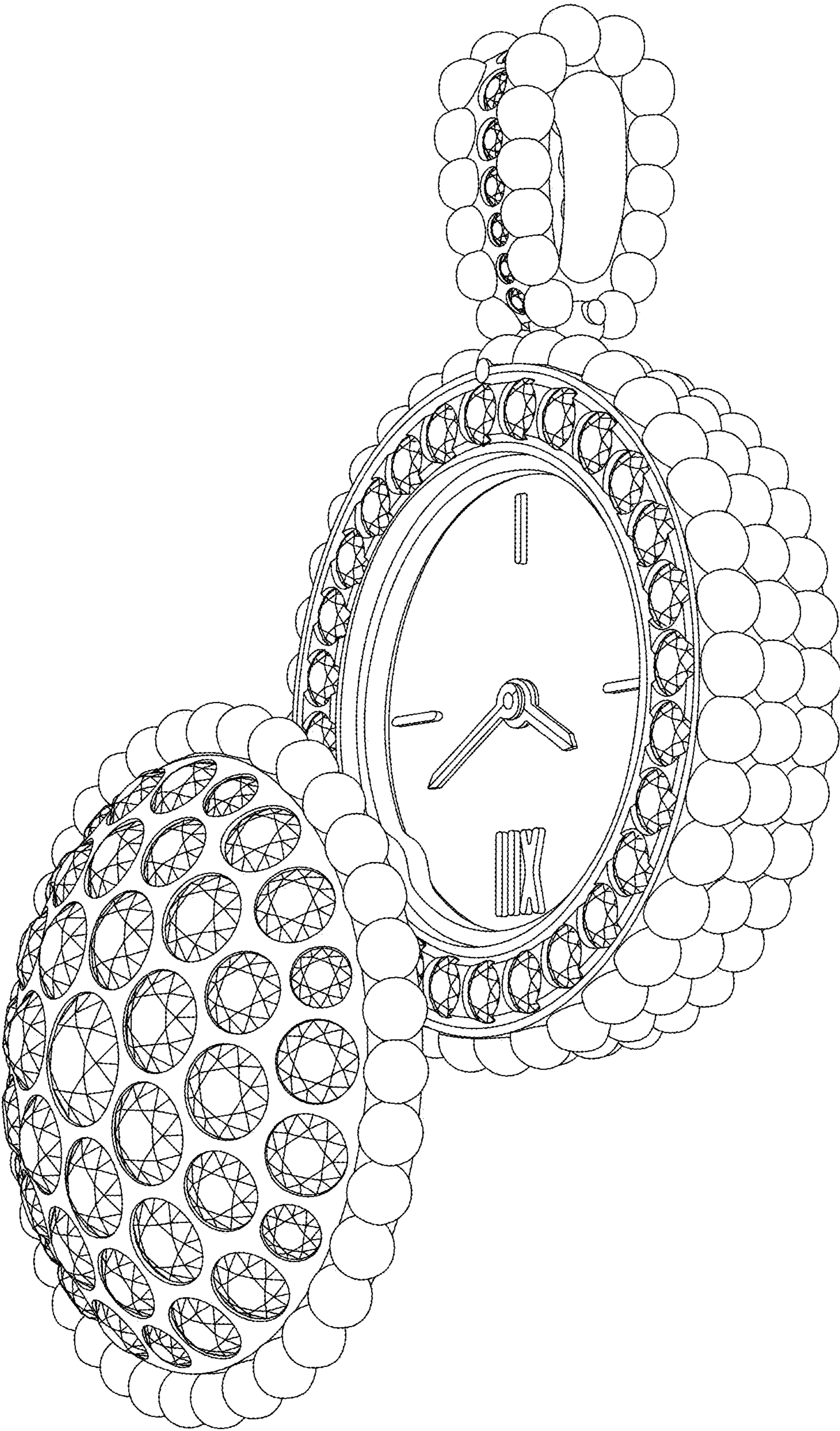
