(57) **CLAIM**

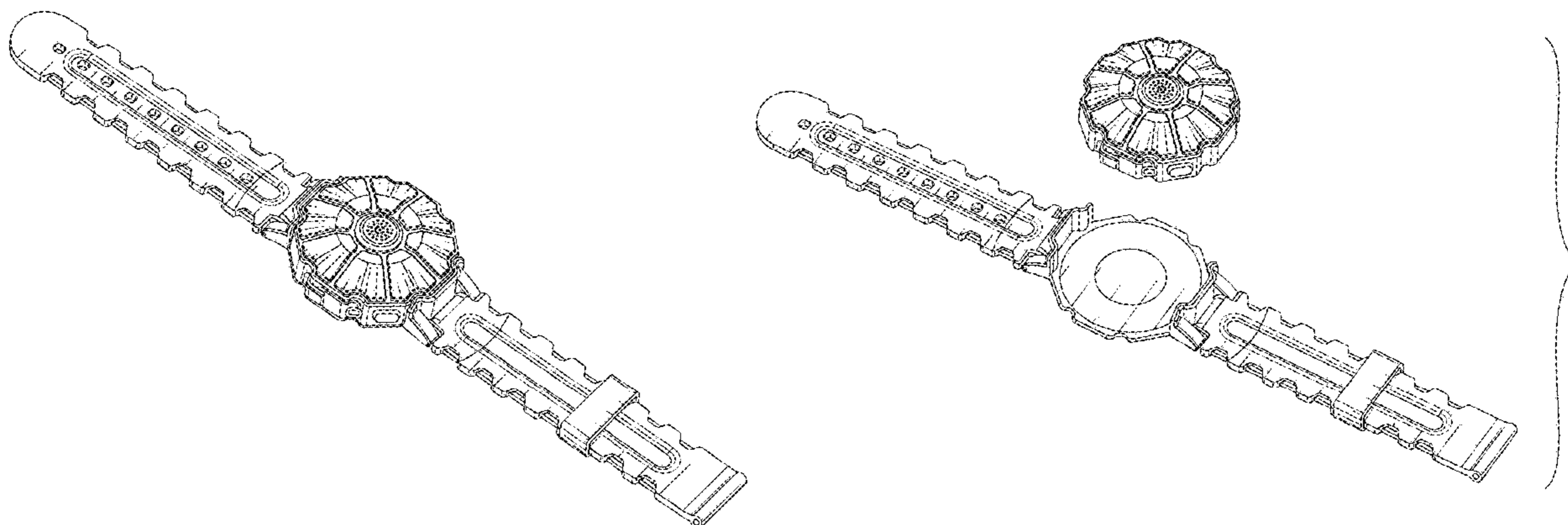
The ornamental design for a watch, as shown and described.

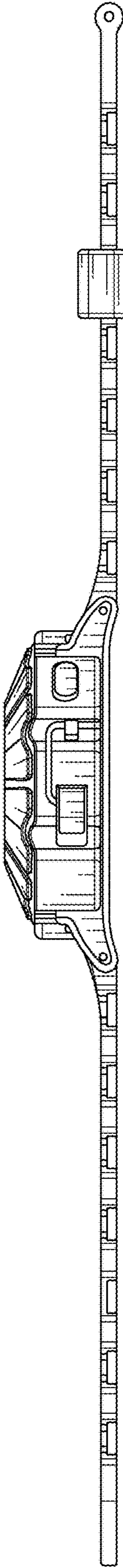

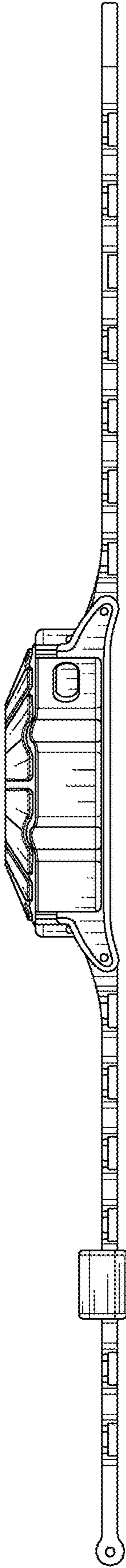

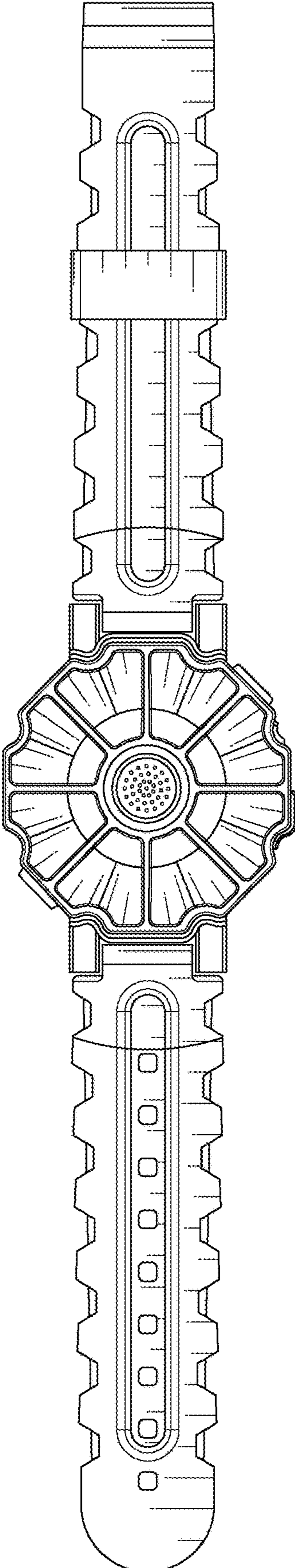

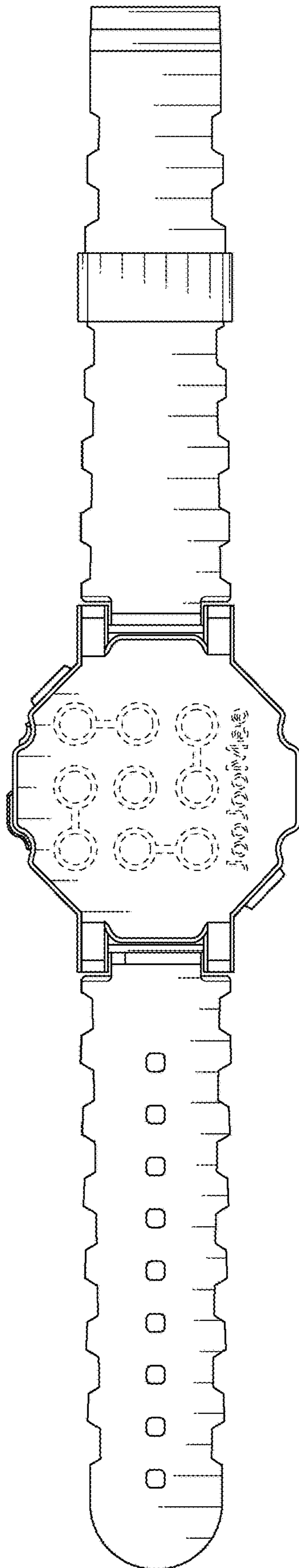

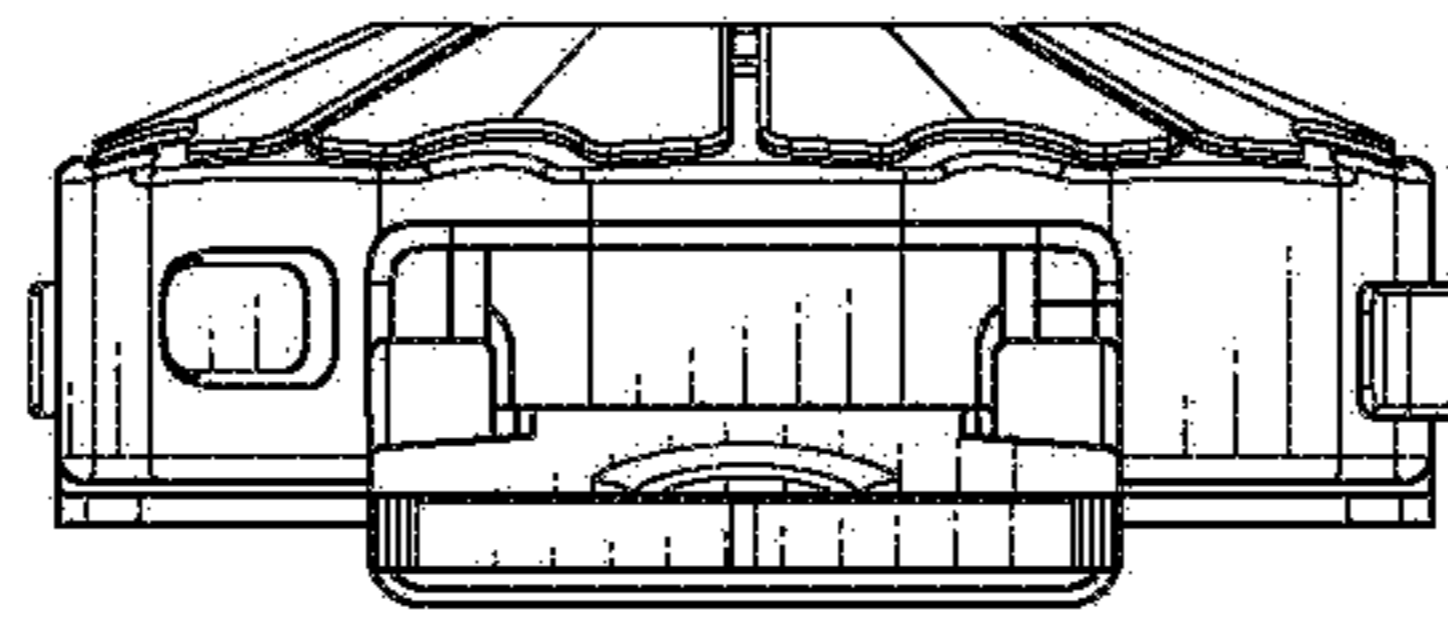

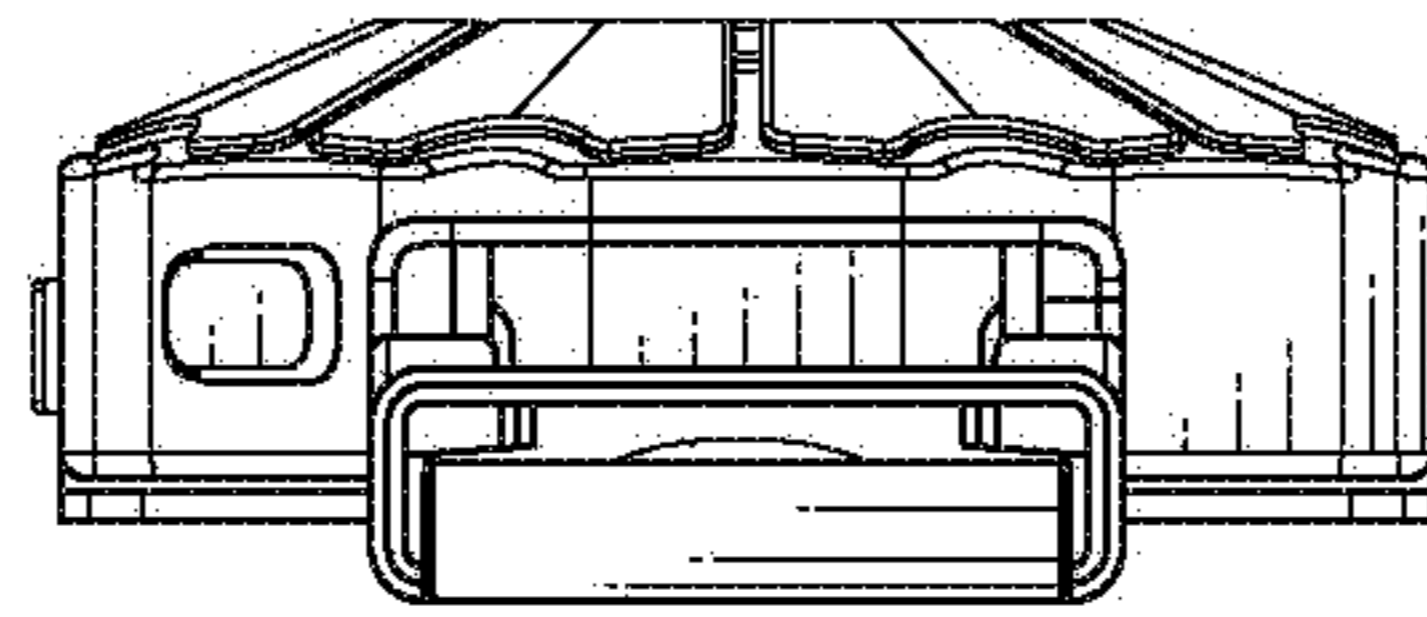

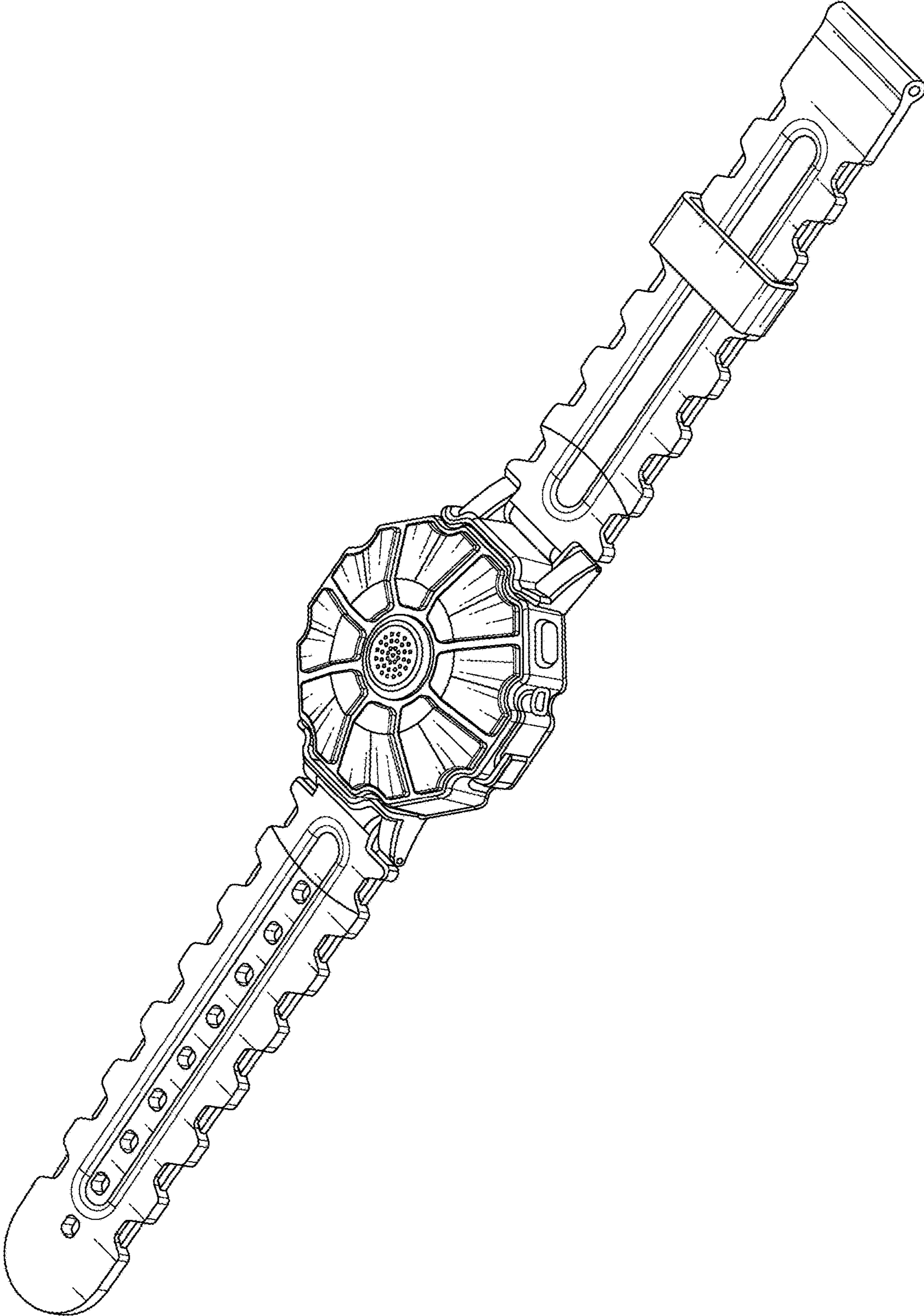

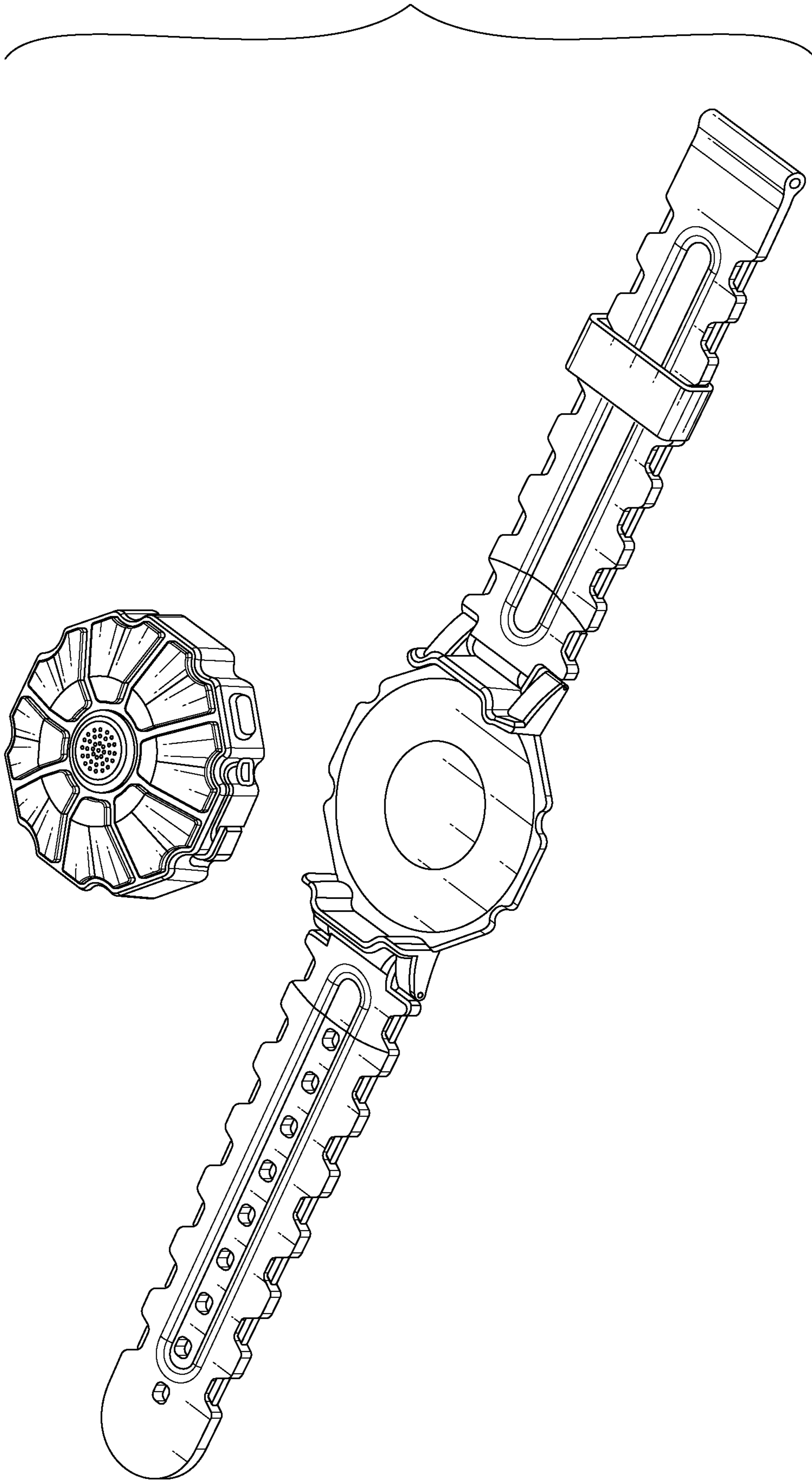

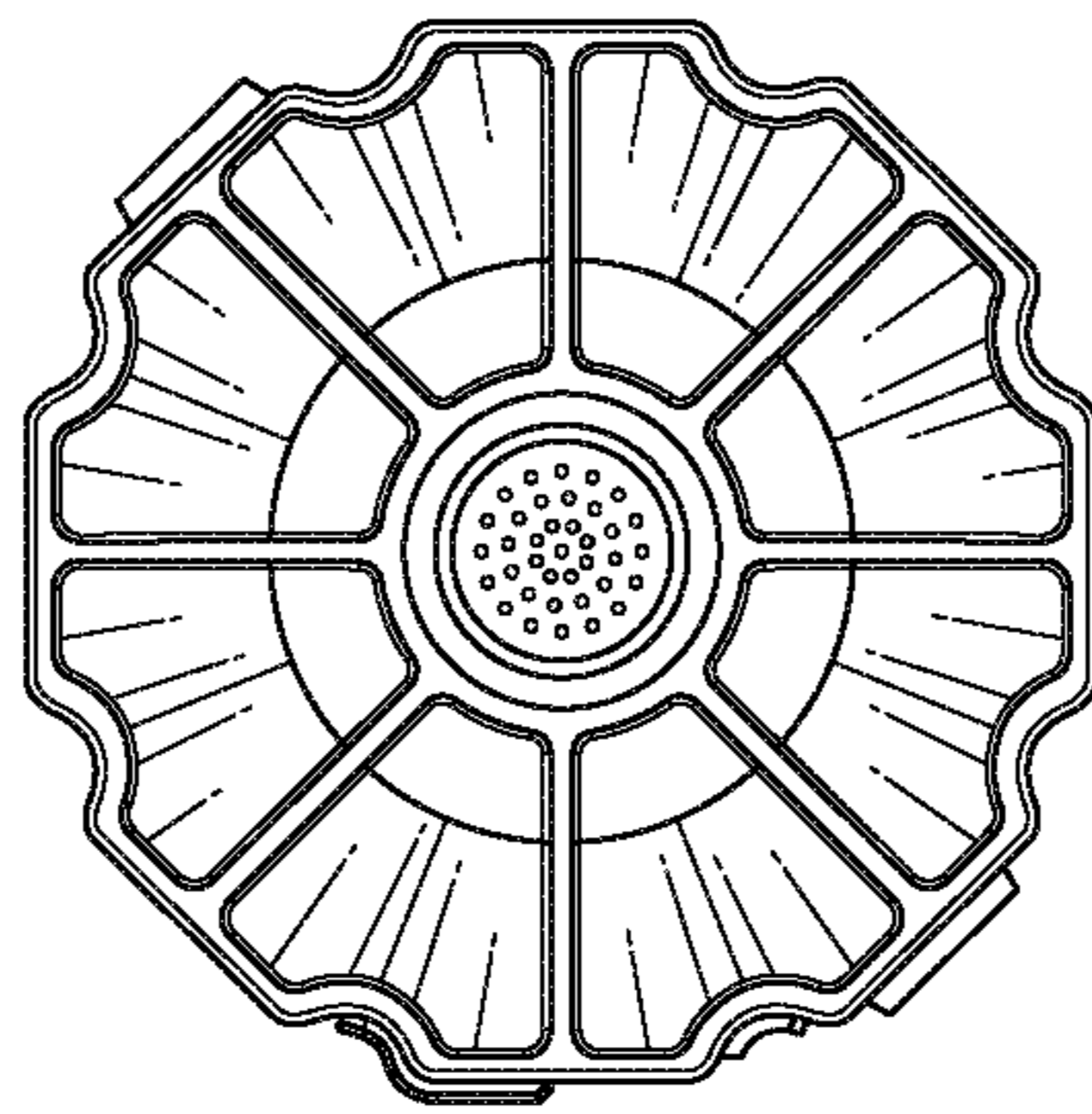

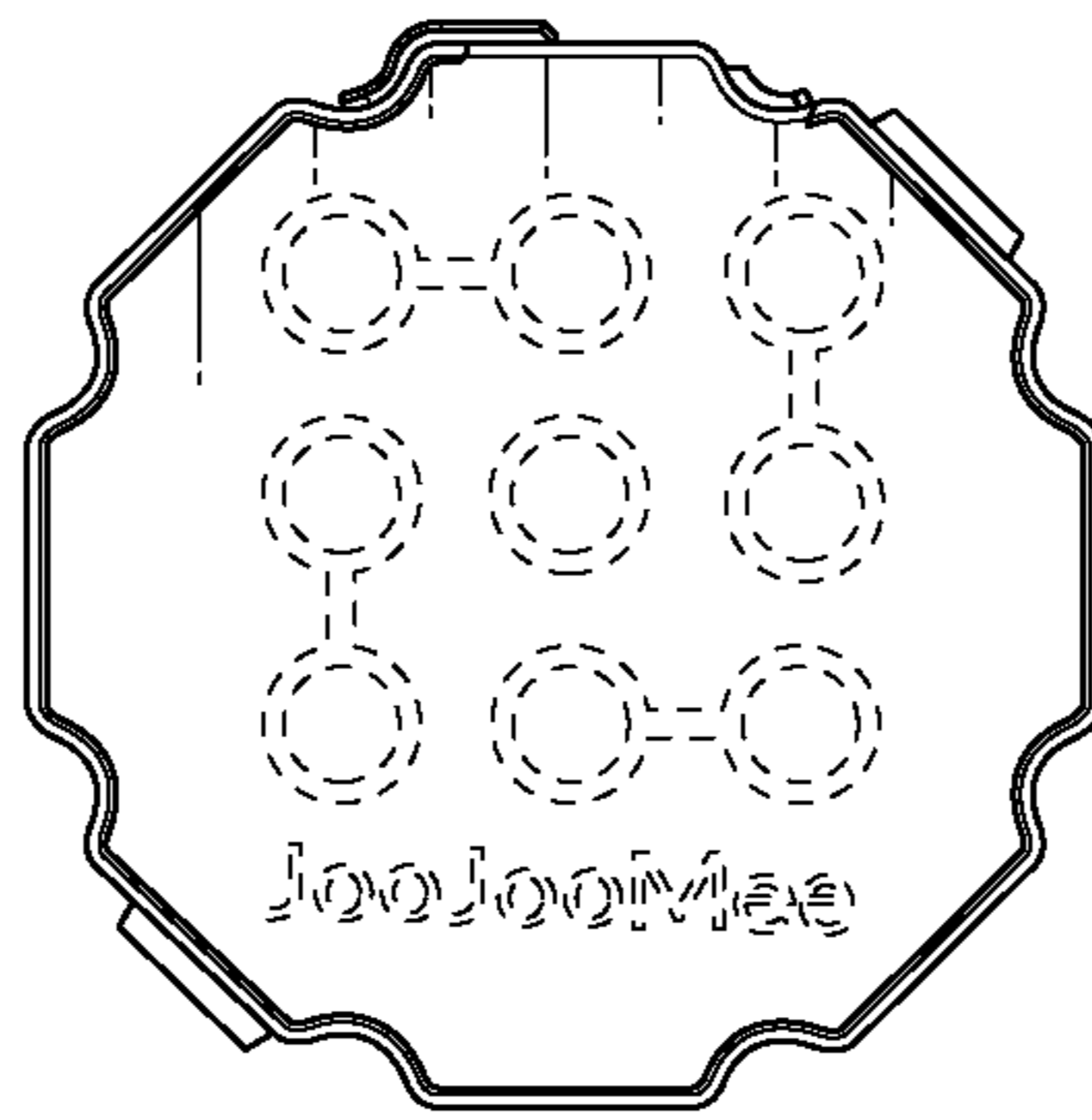
