DESCRIPTION

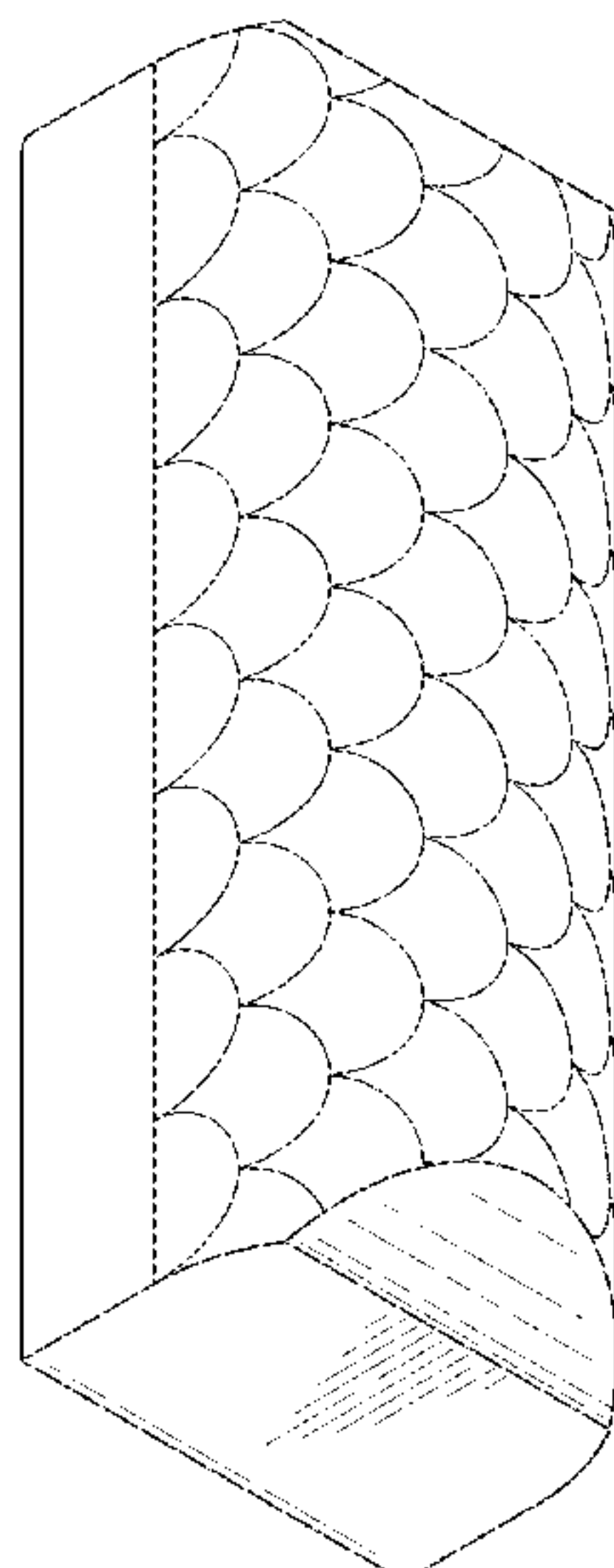
FIG. 1 is a top perspective view showing a curb guard according to the new design; and

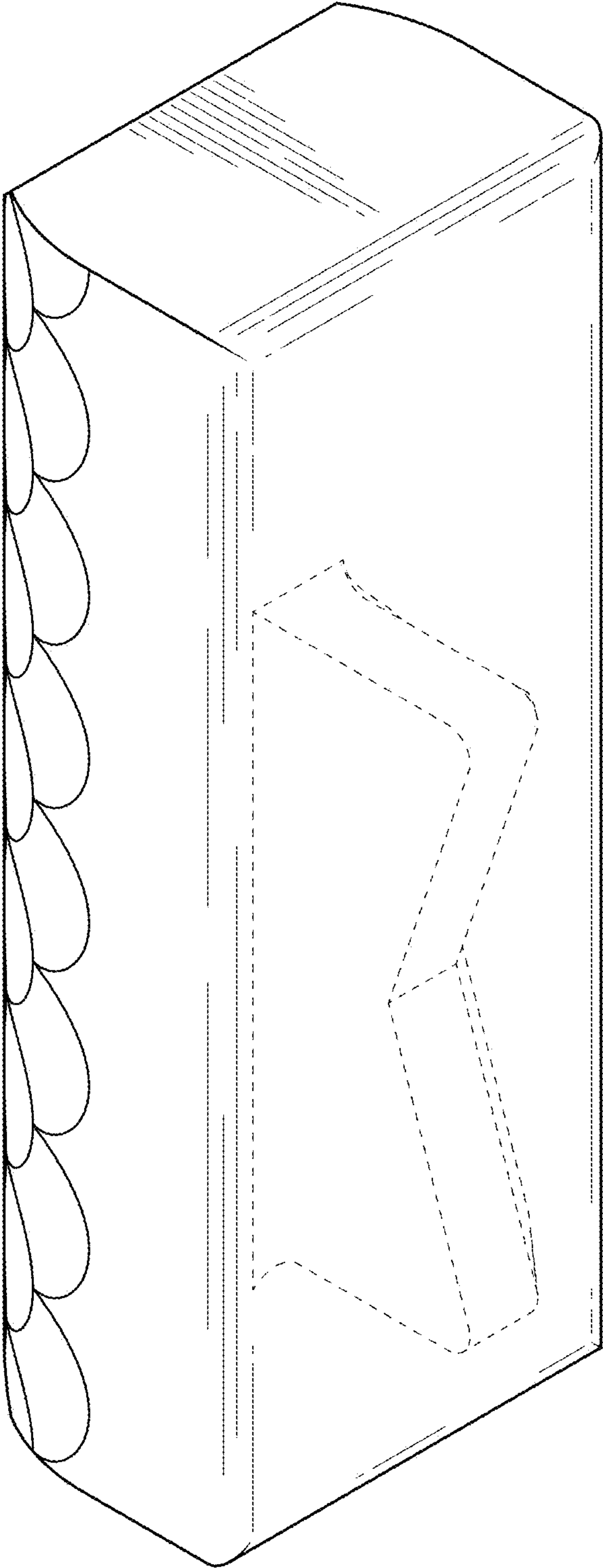

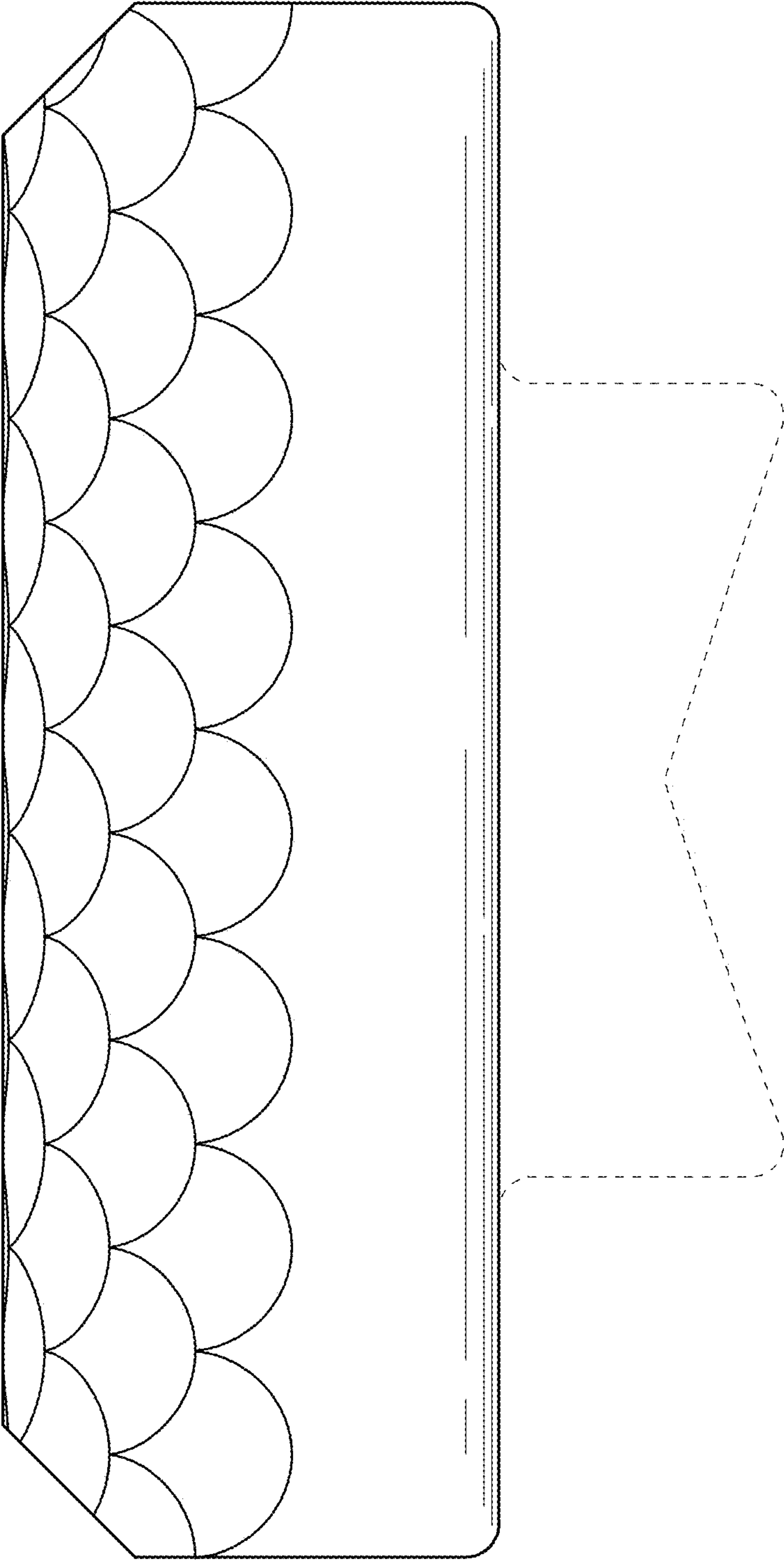

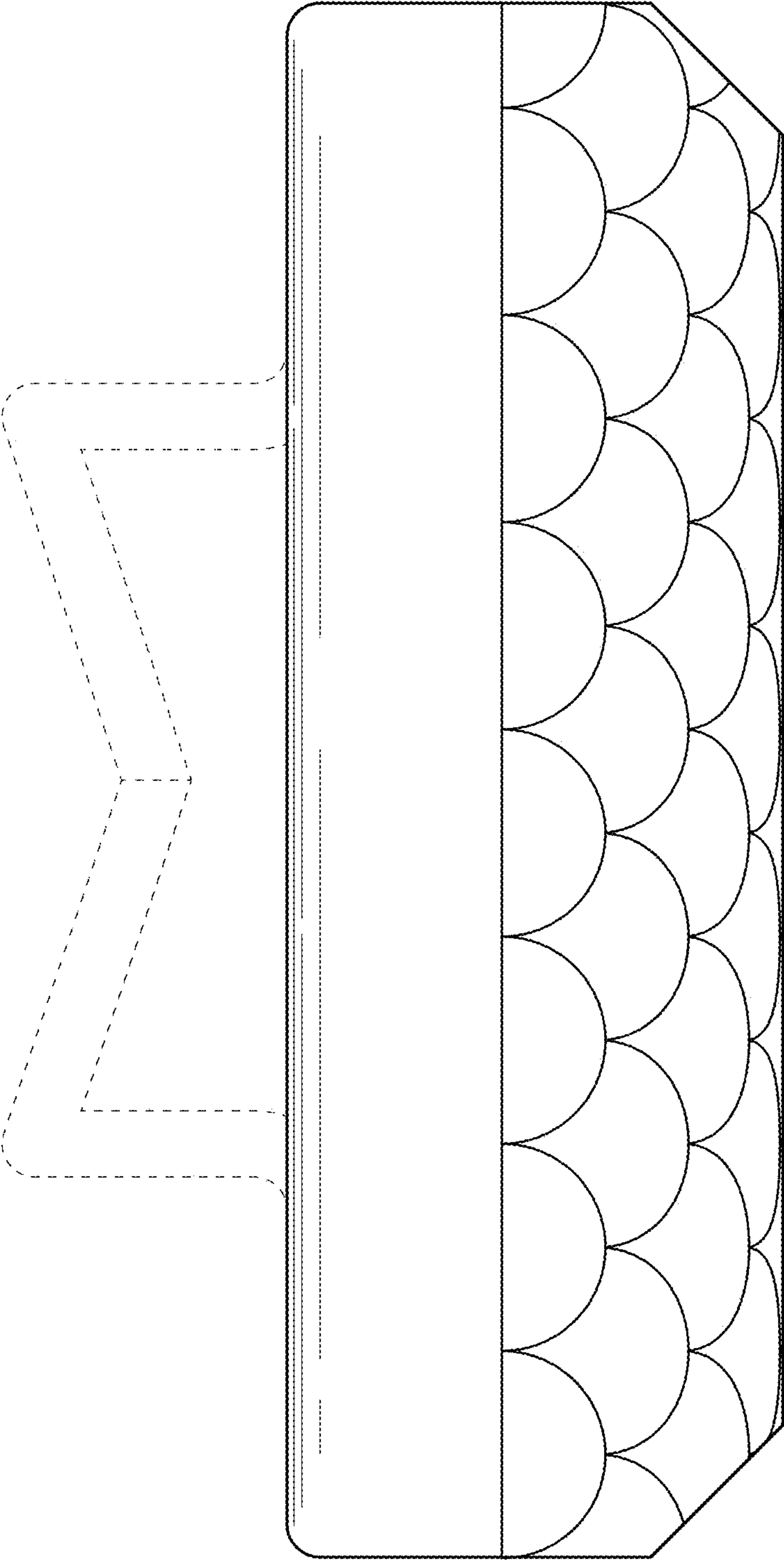

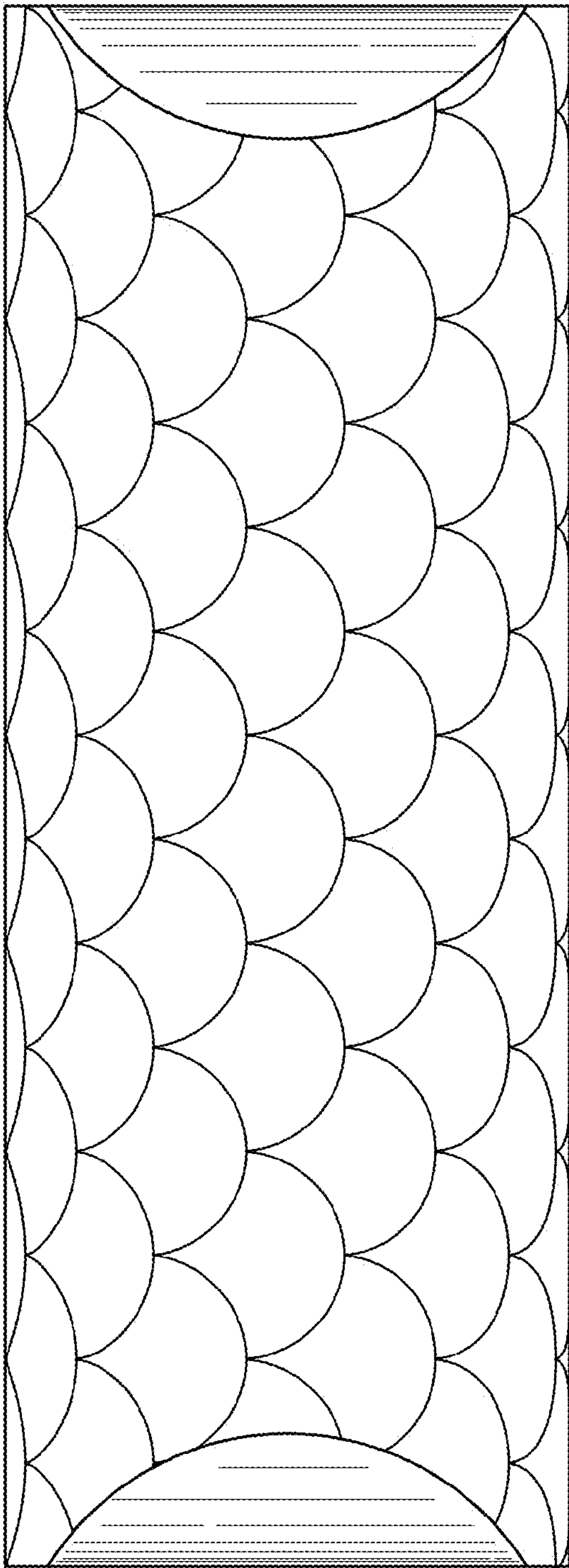

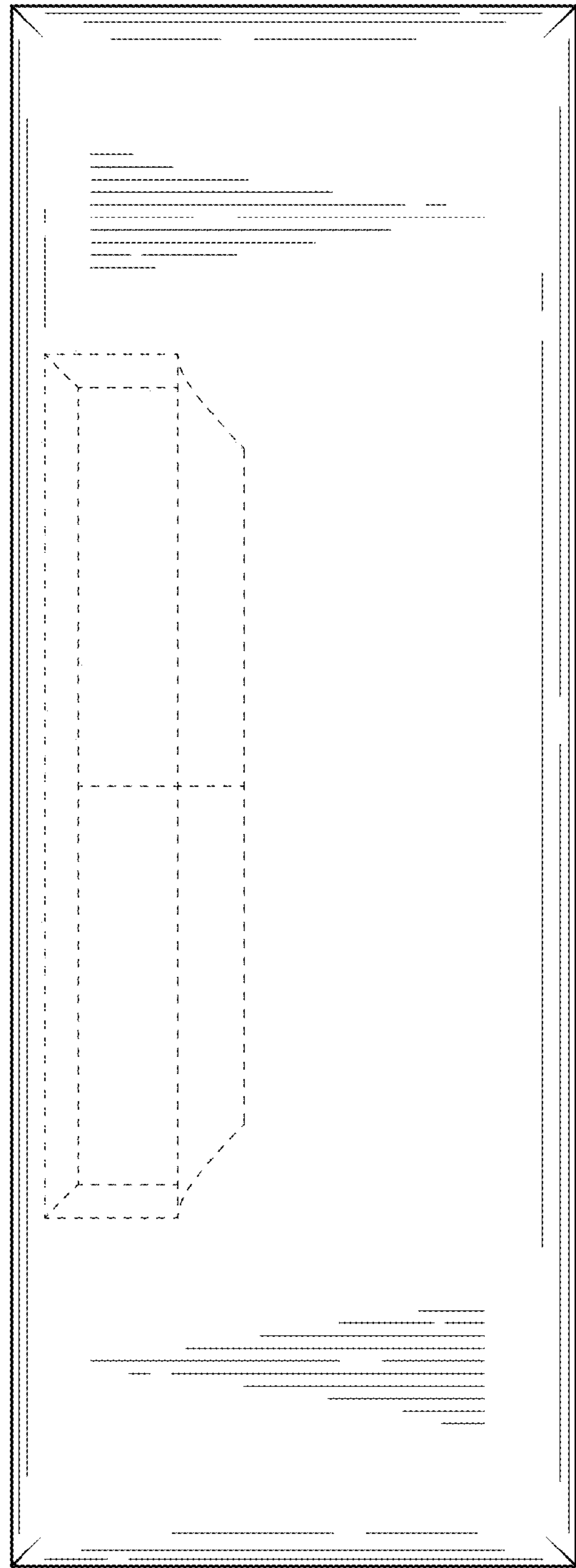

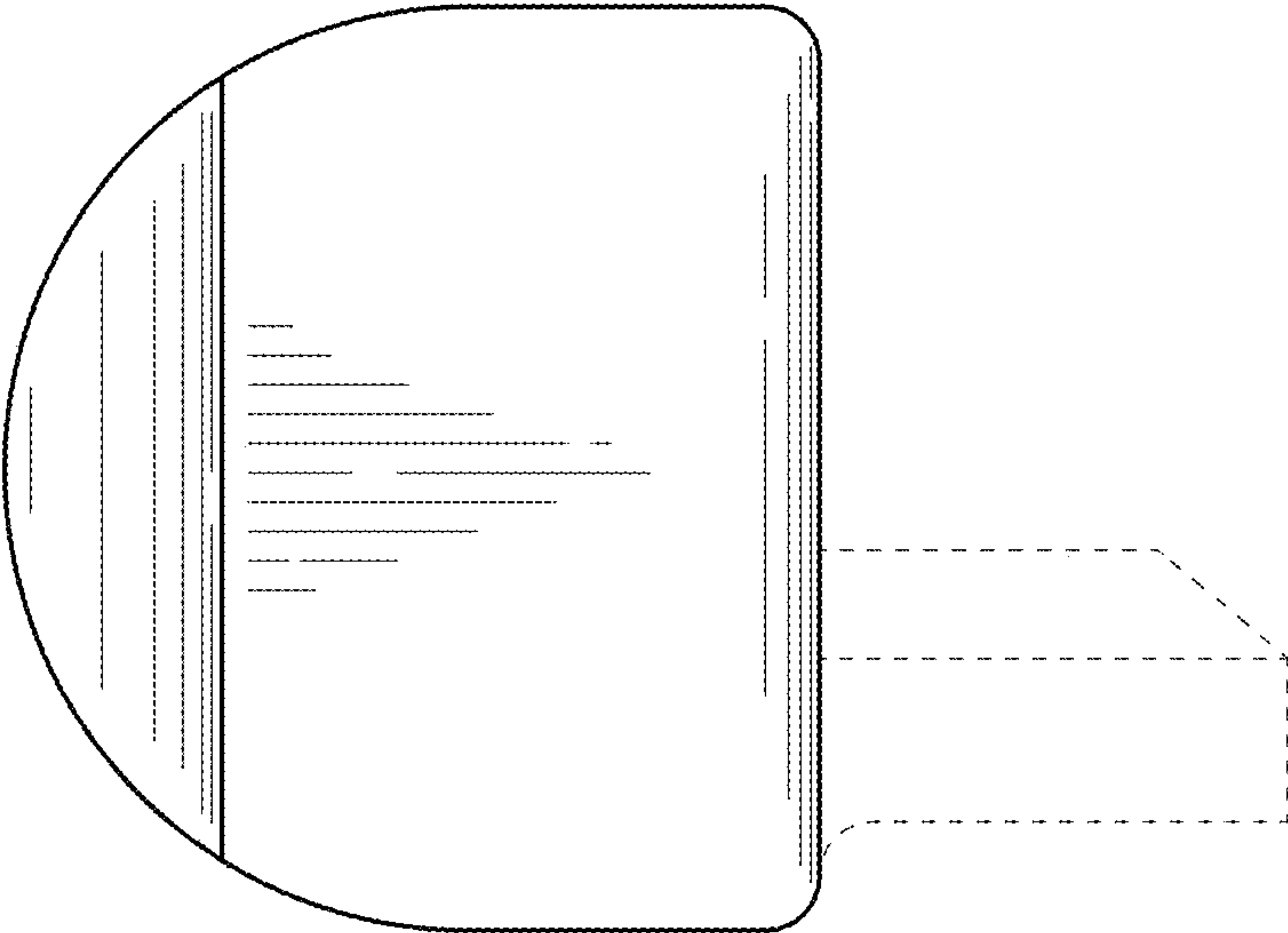

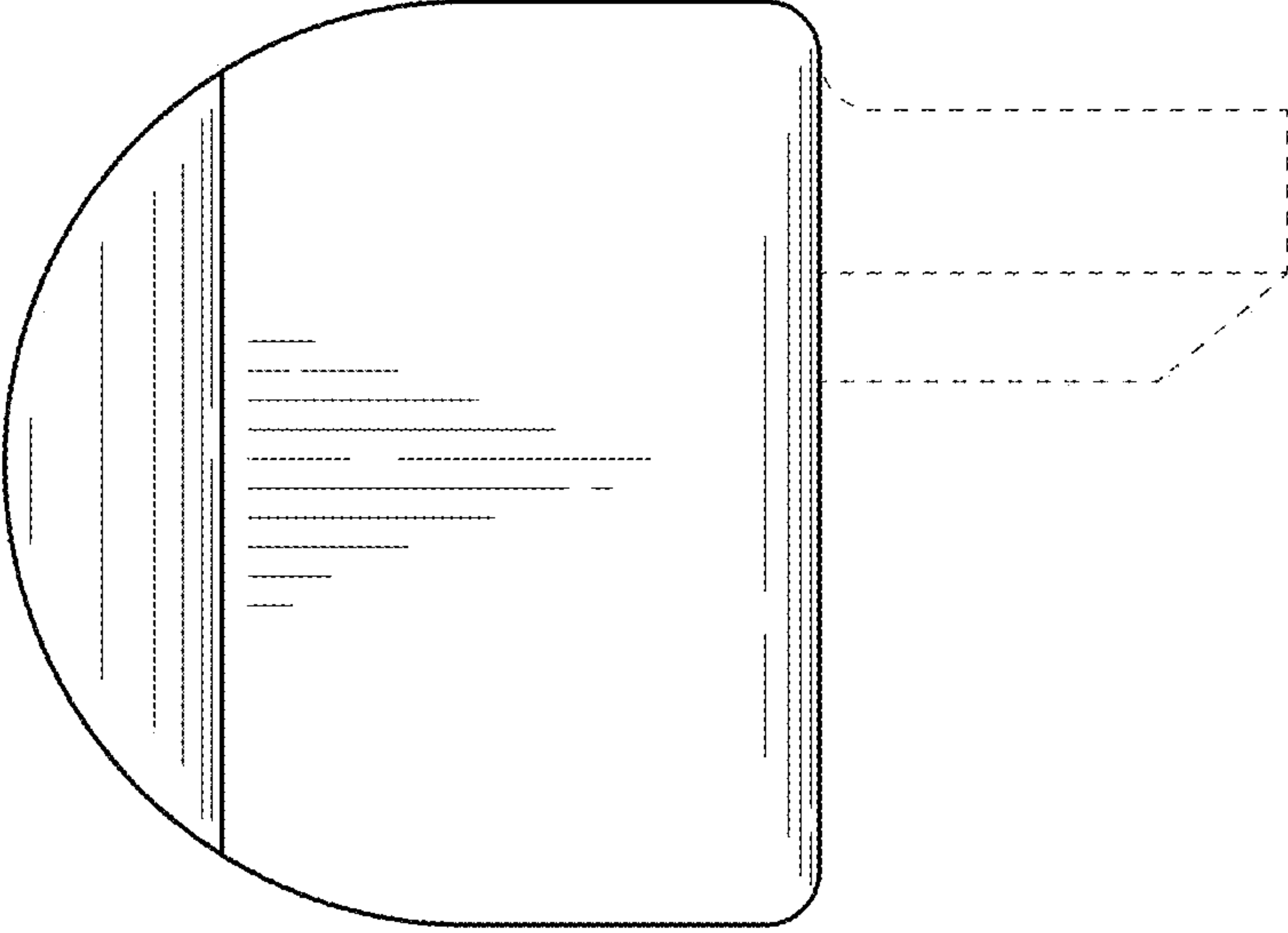

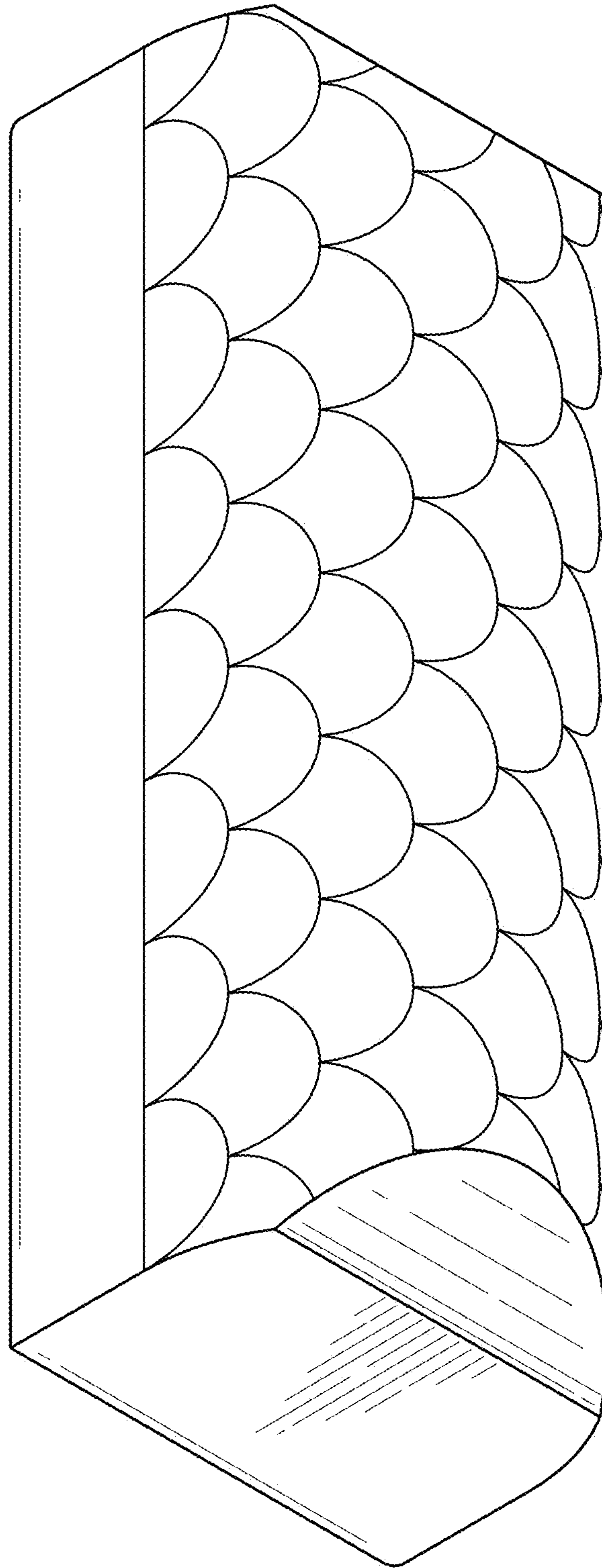
