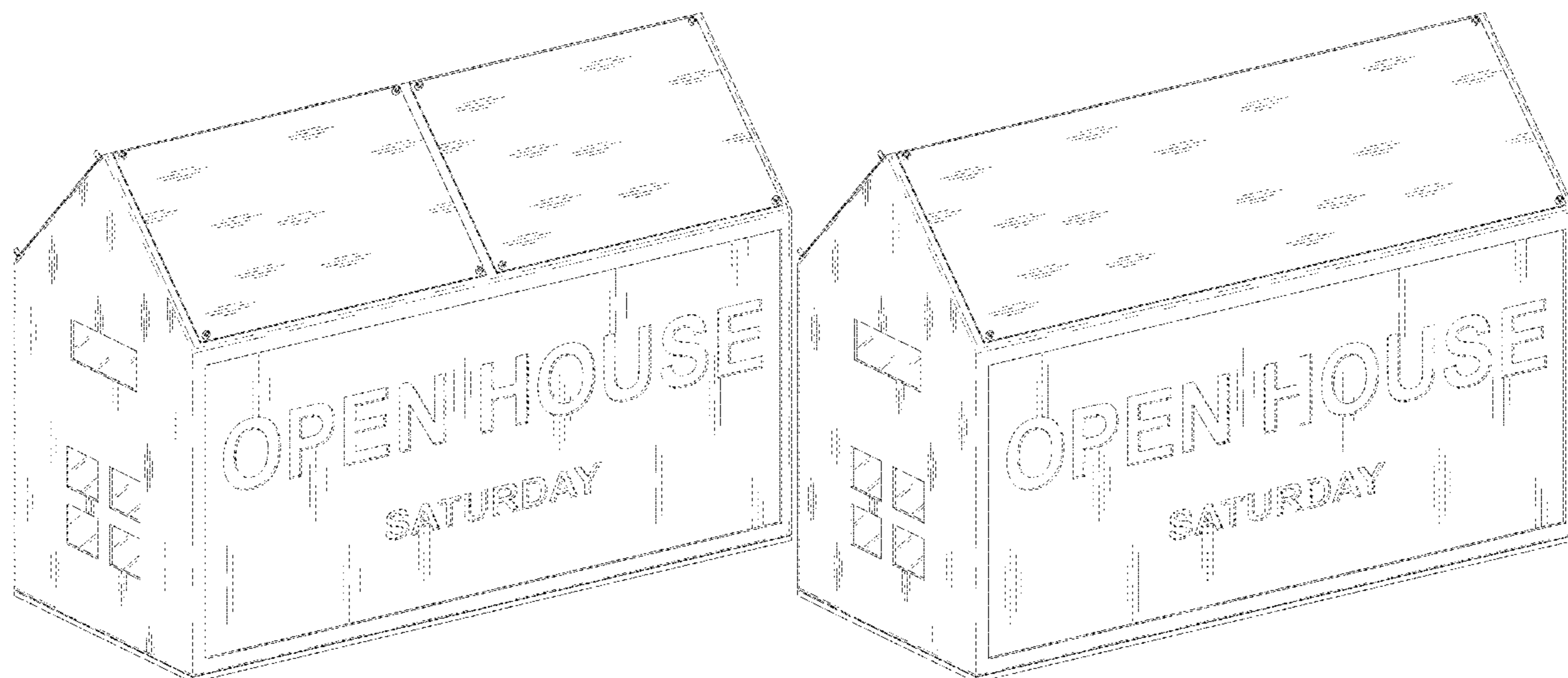
The ornamental design for a sign, as shown and described.

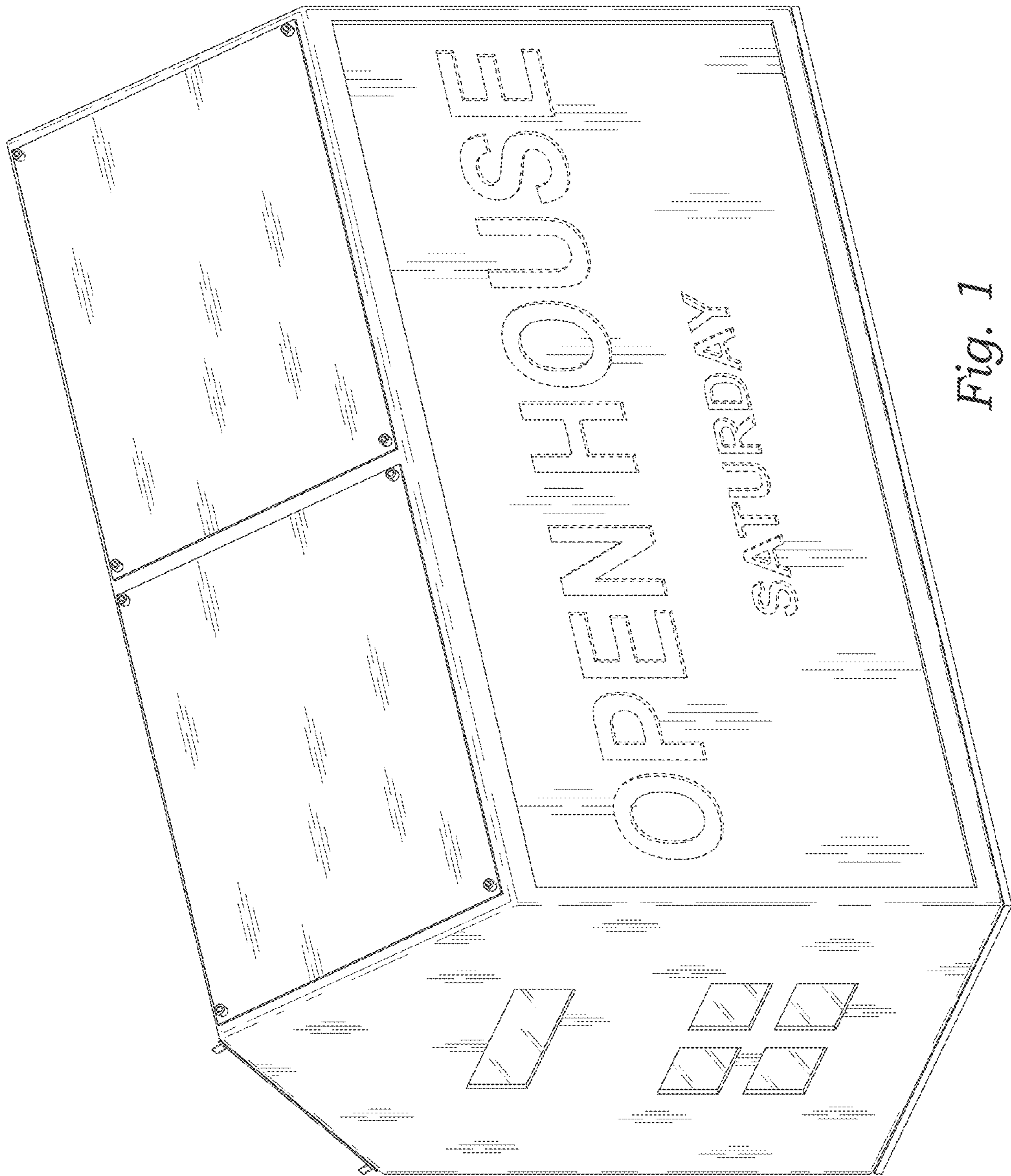

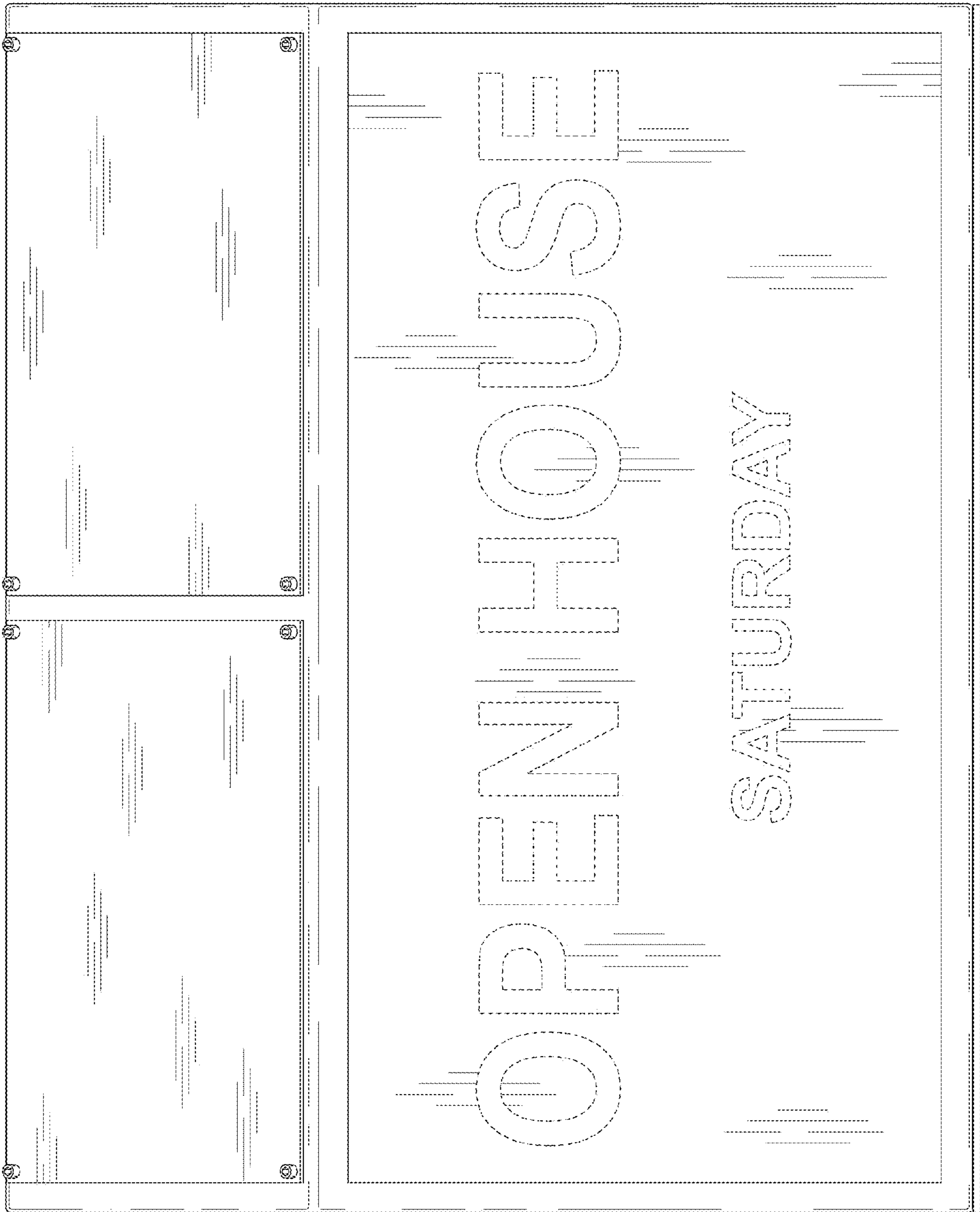

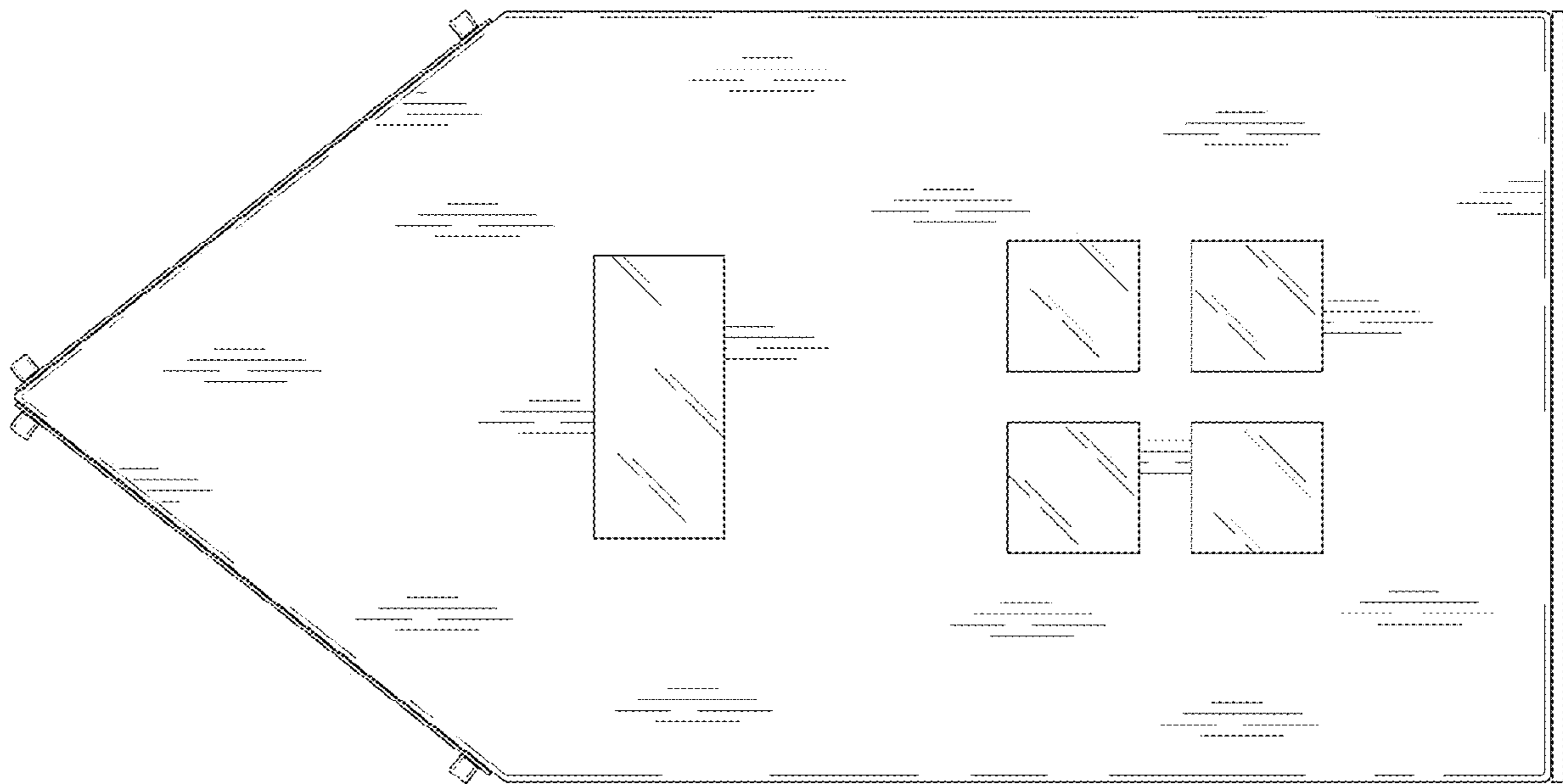

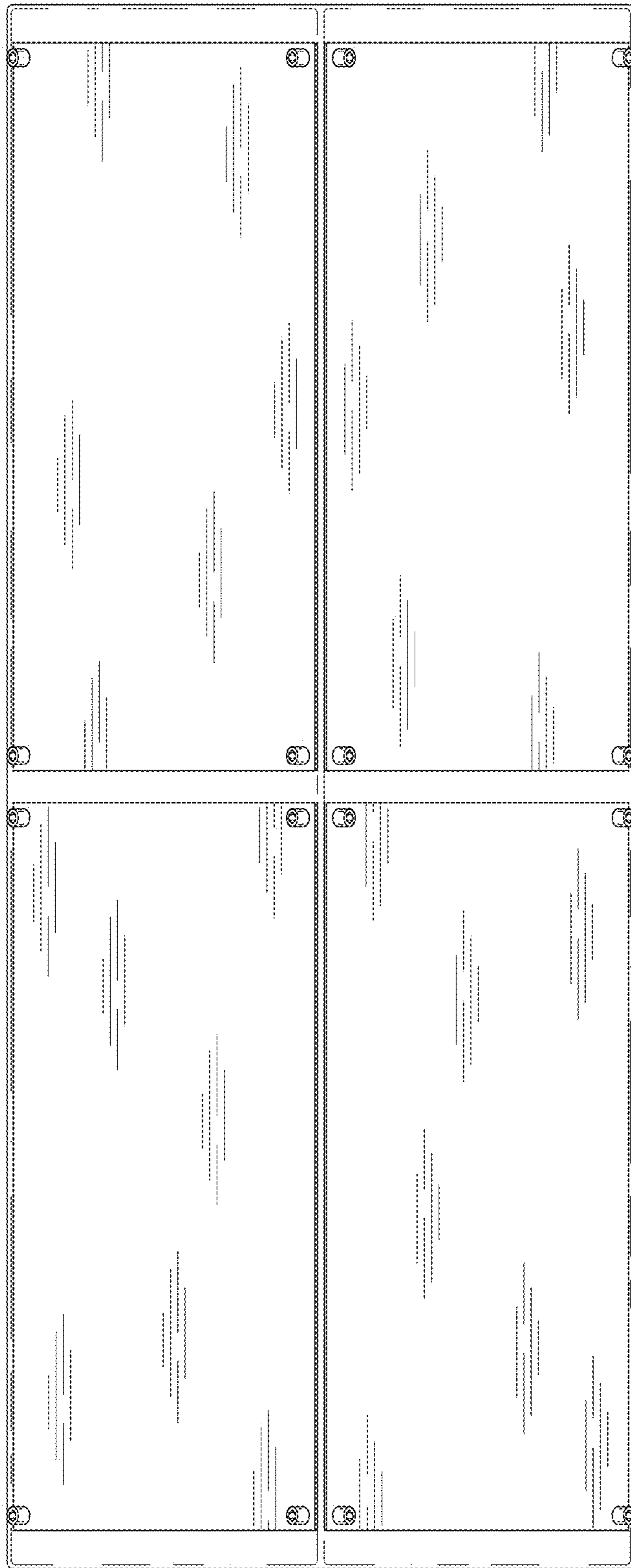

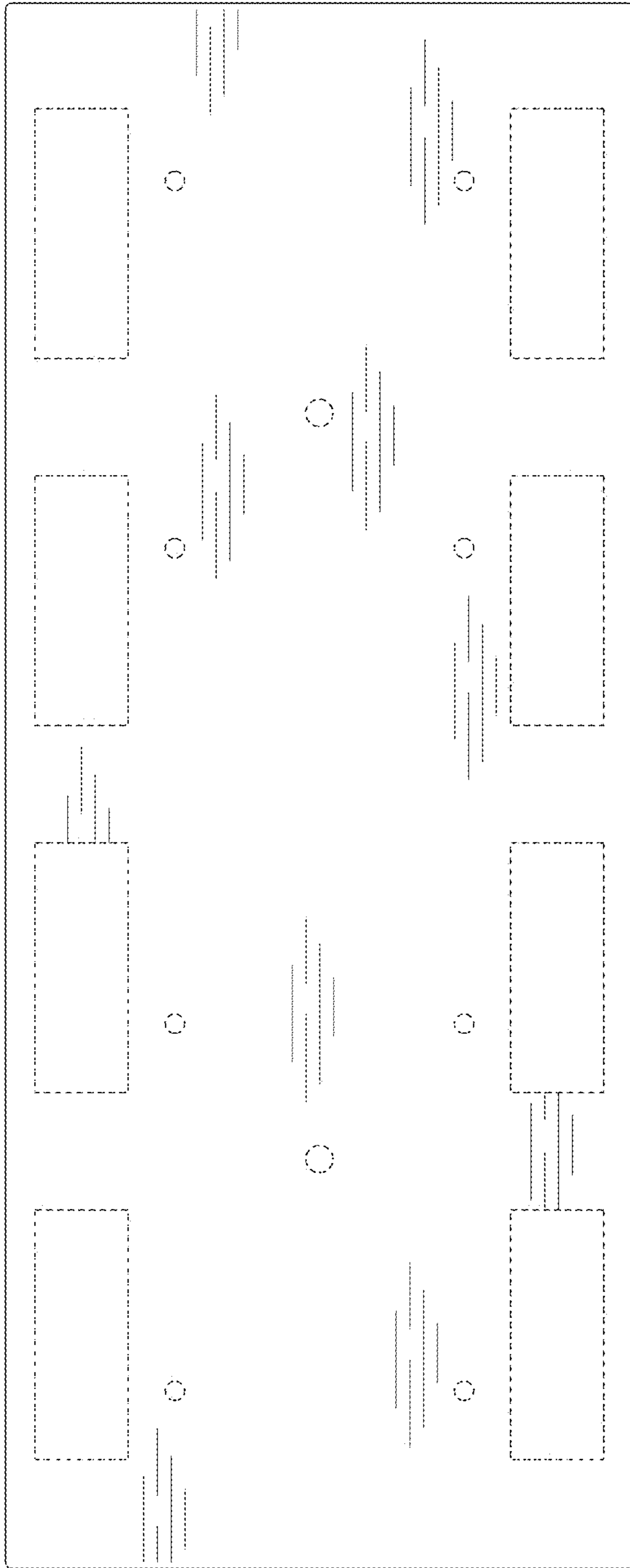
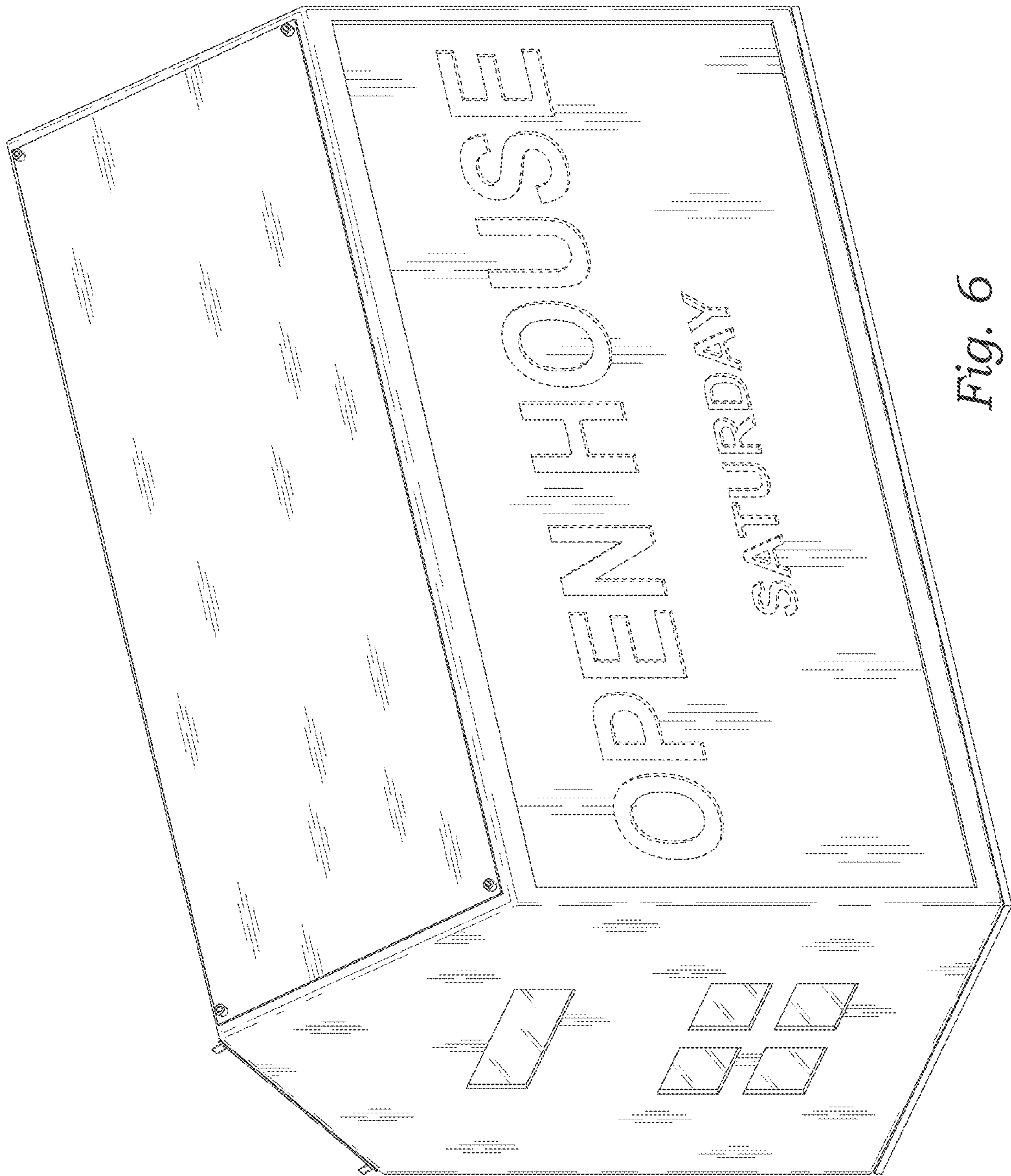

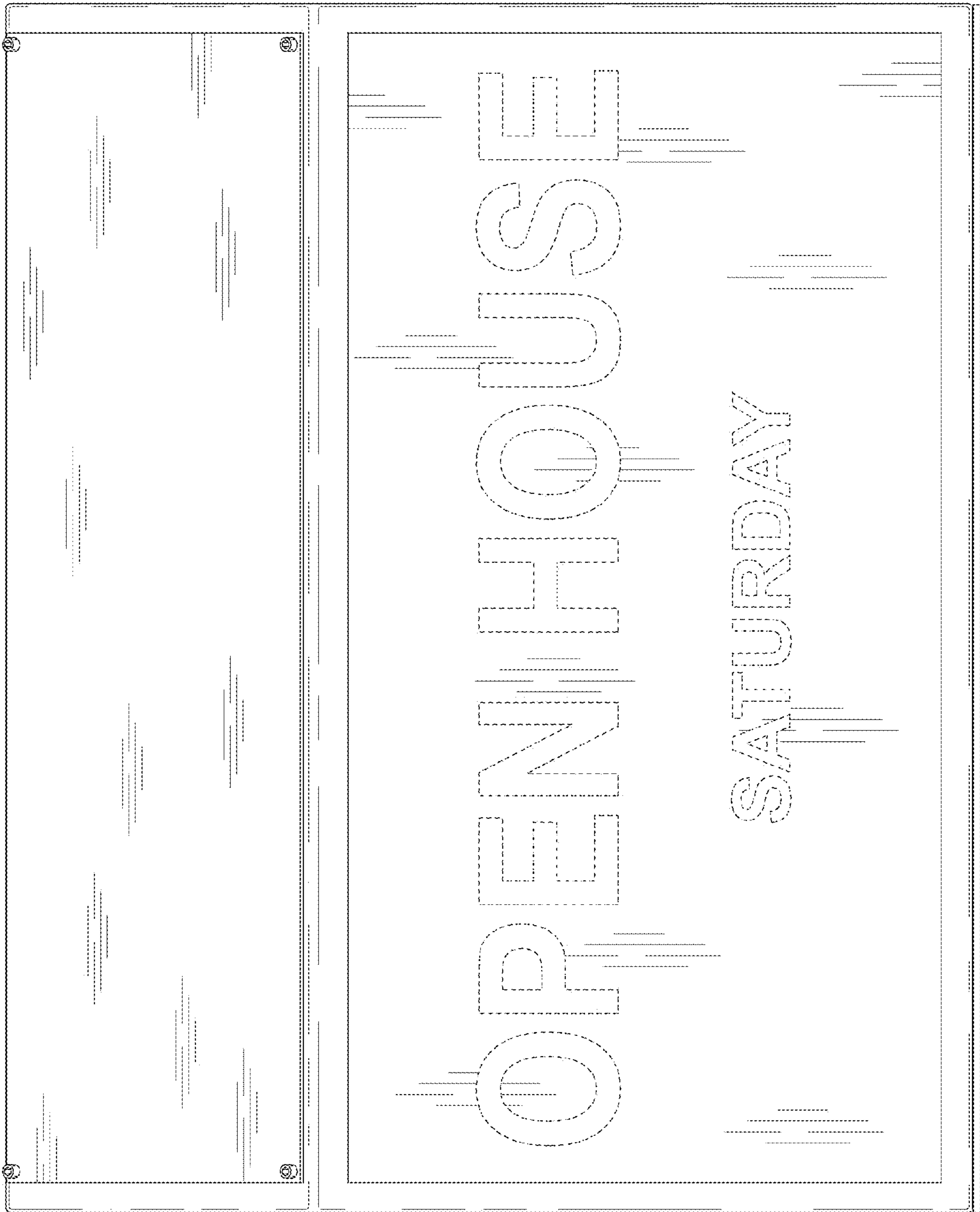

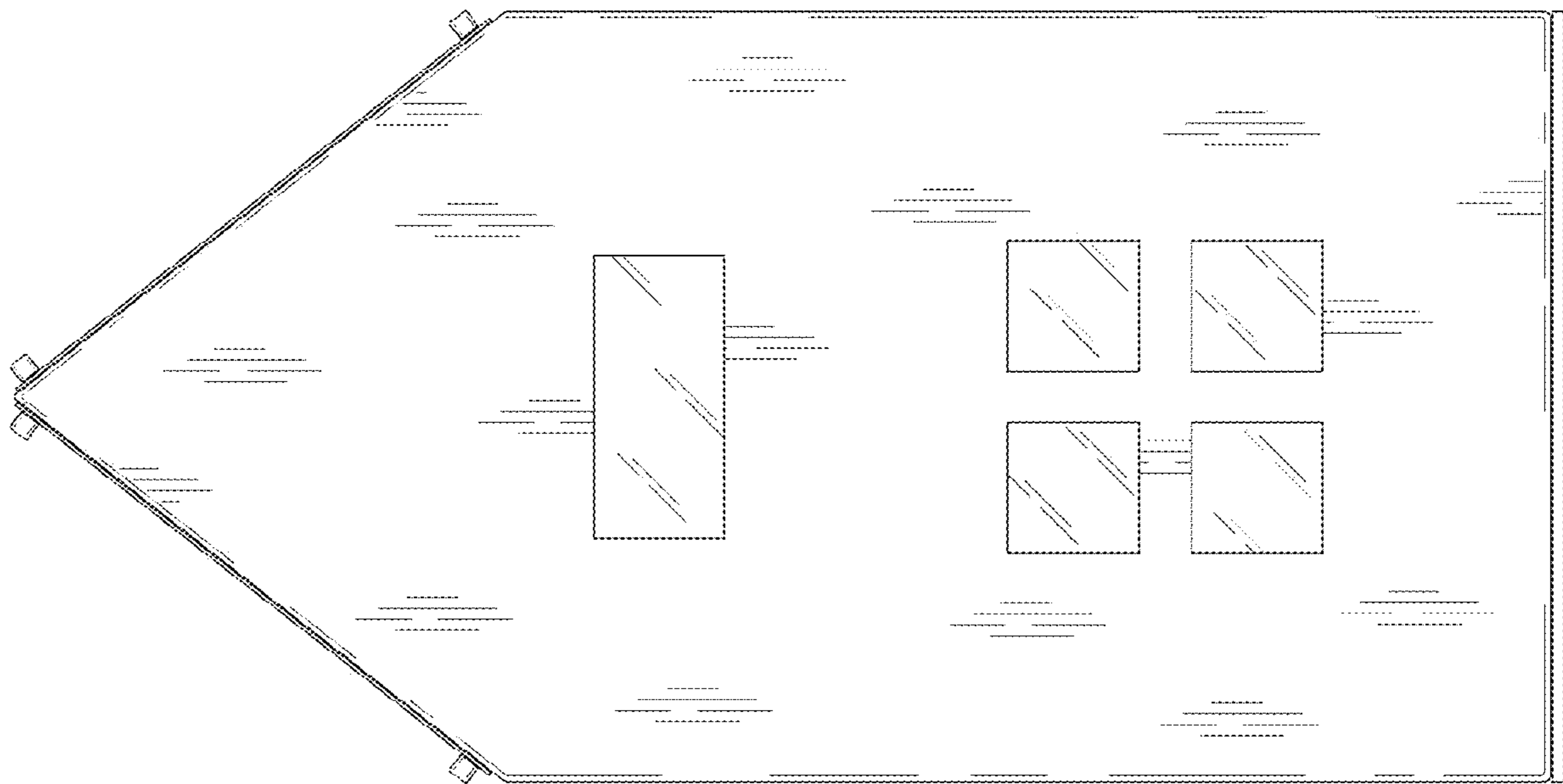
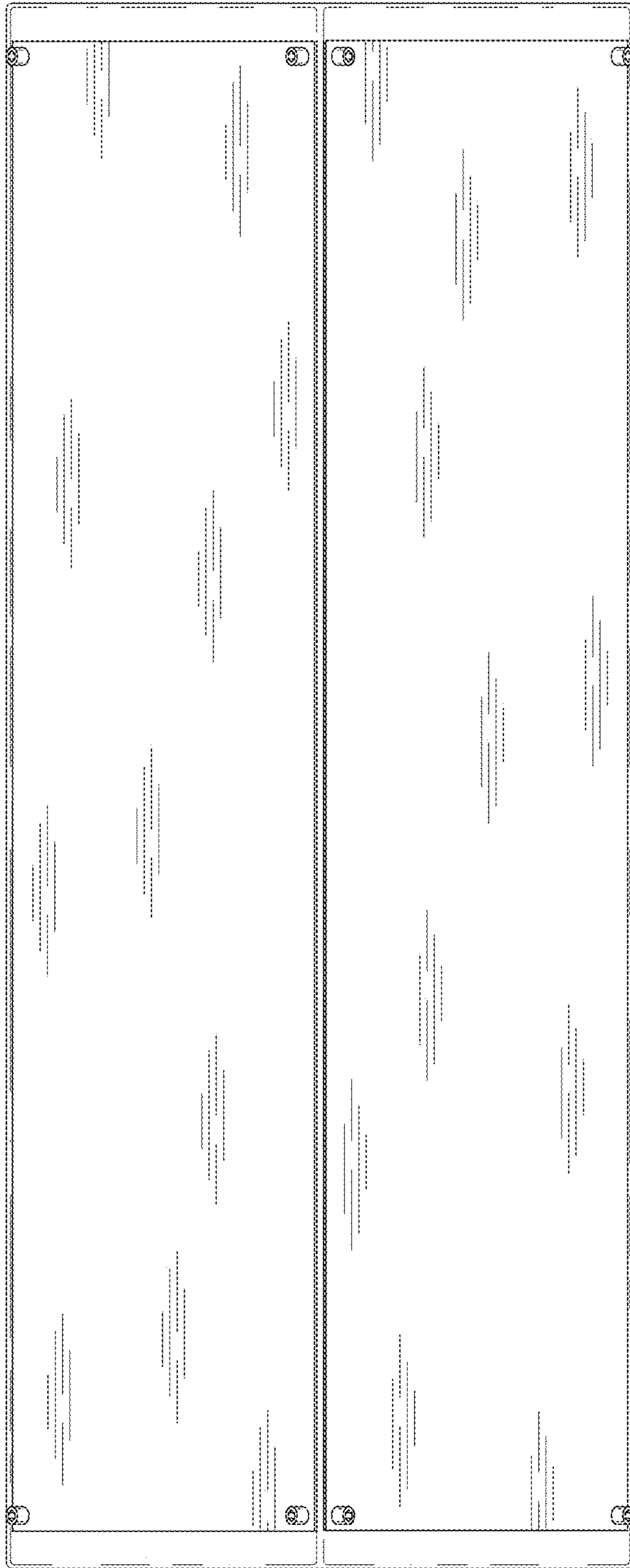
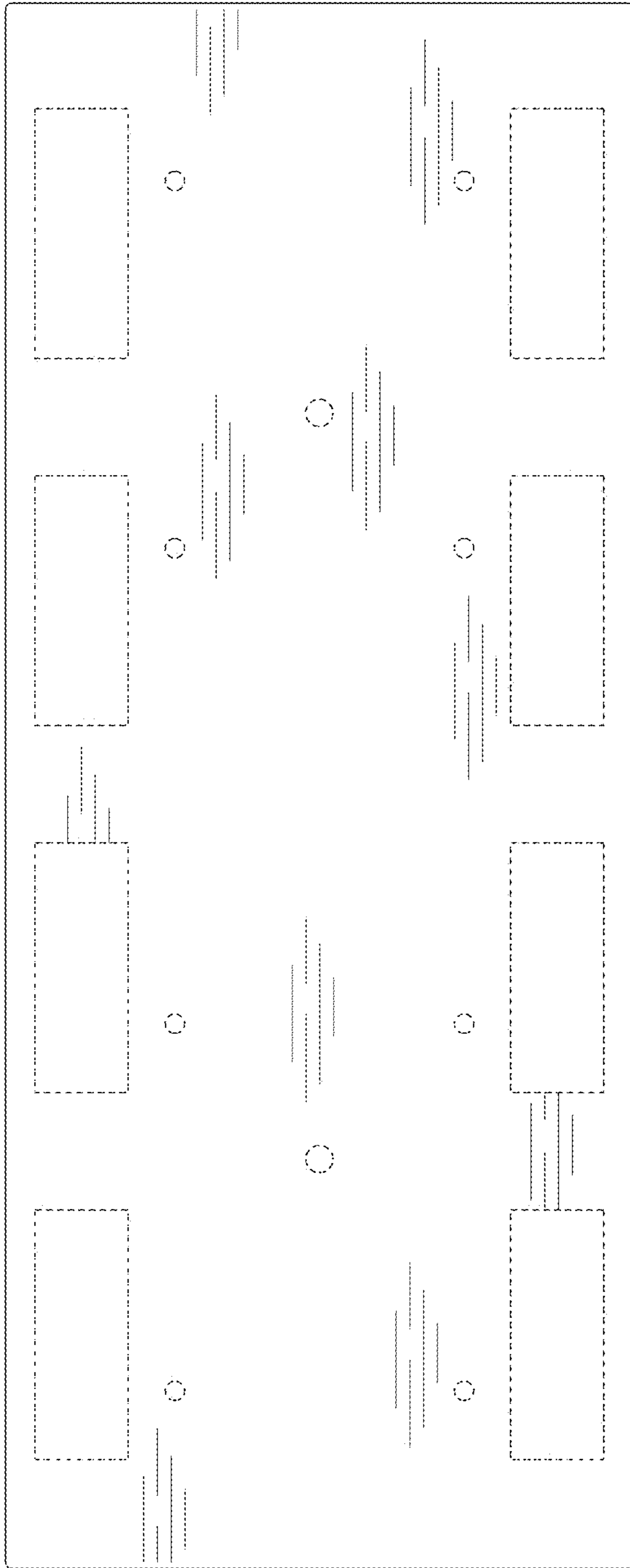
