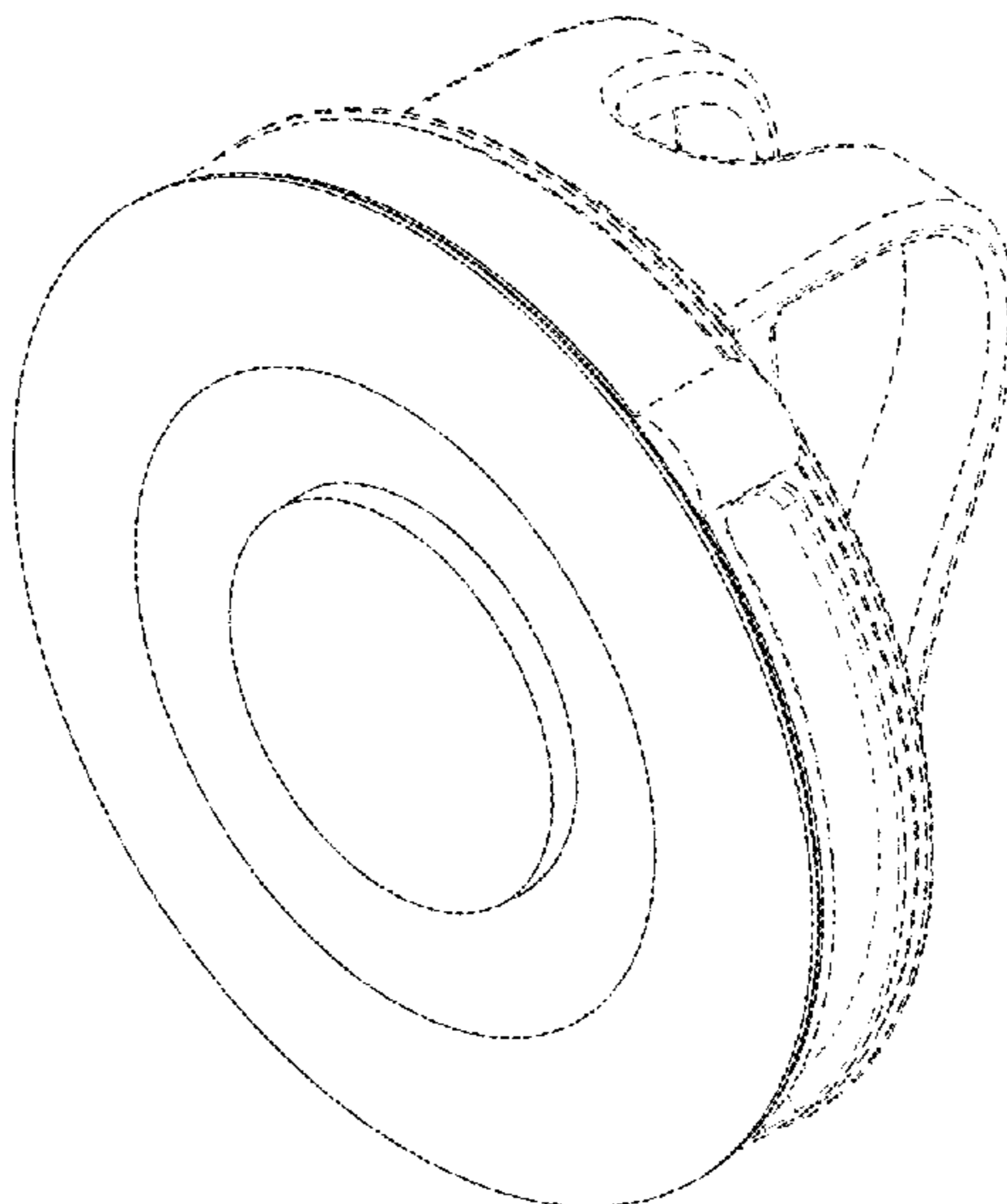
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of an air freshener device,  
embodying our new design;  
FIG. 2 is a rear perspective view thereof;

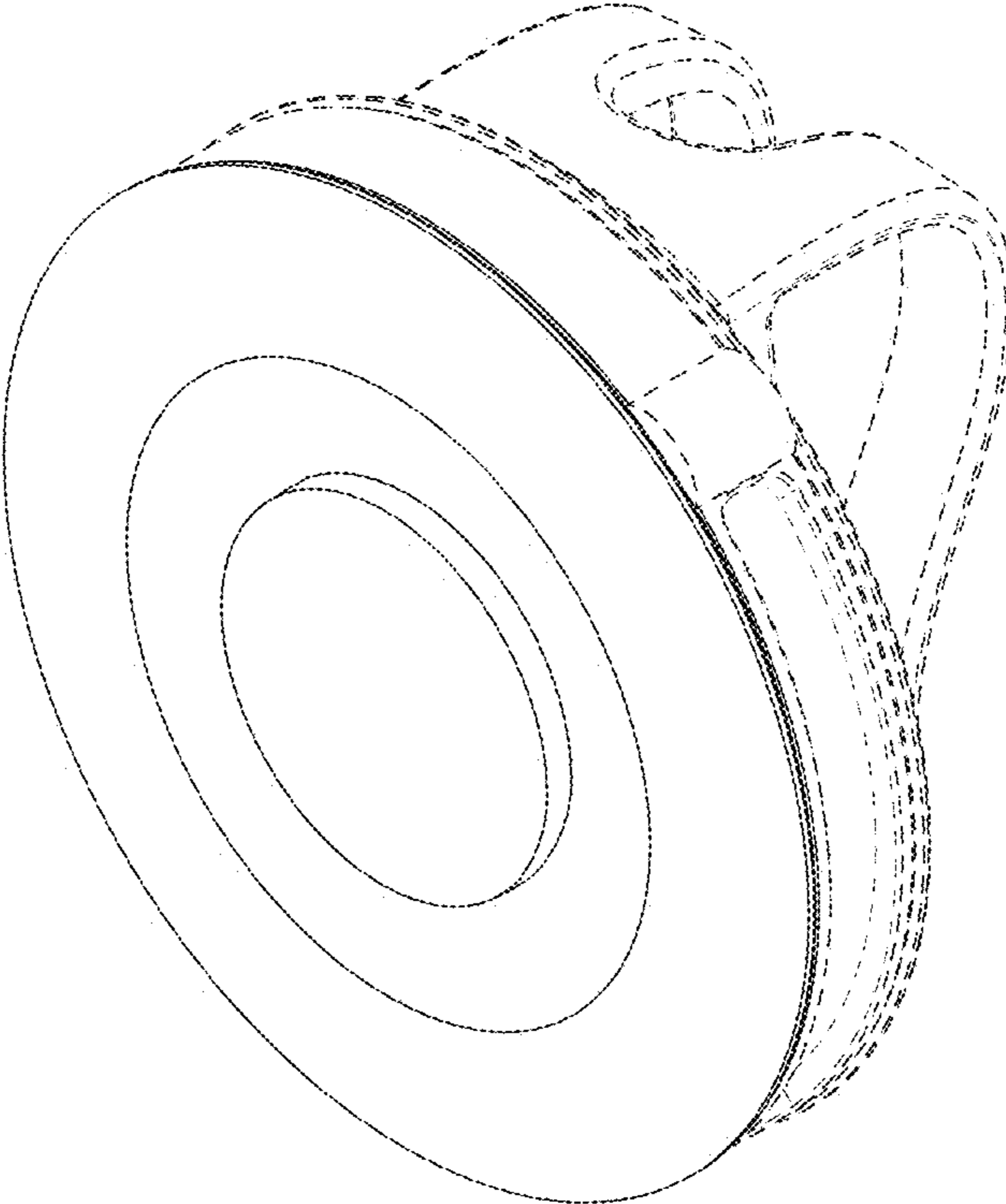

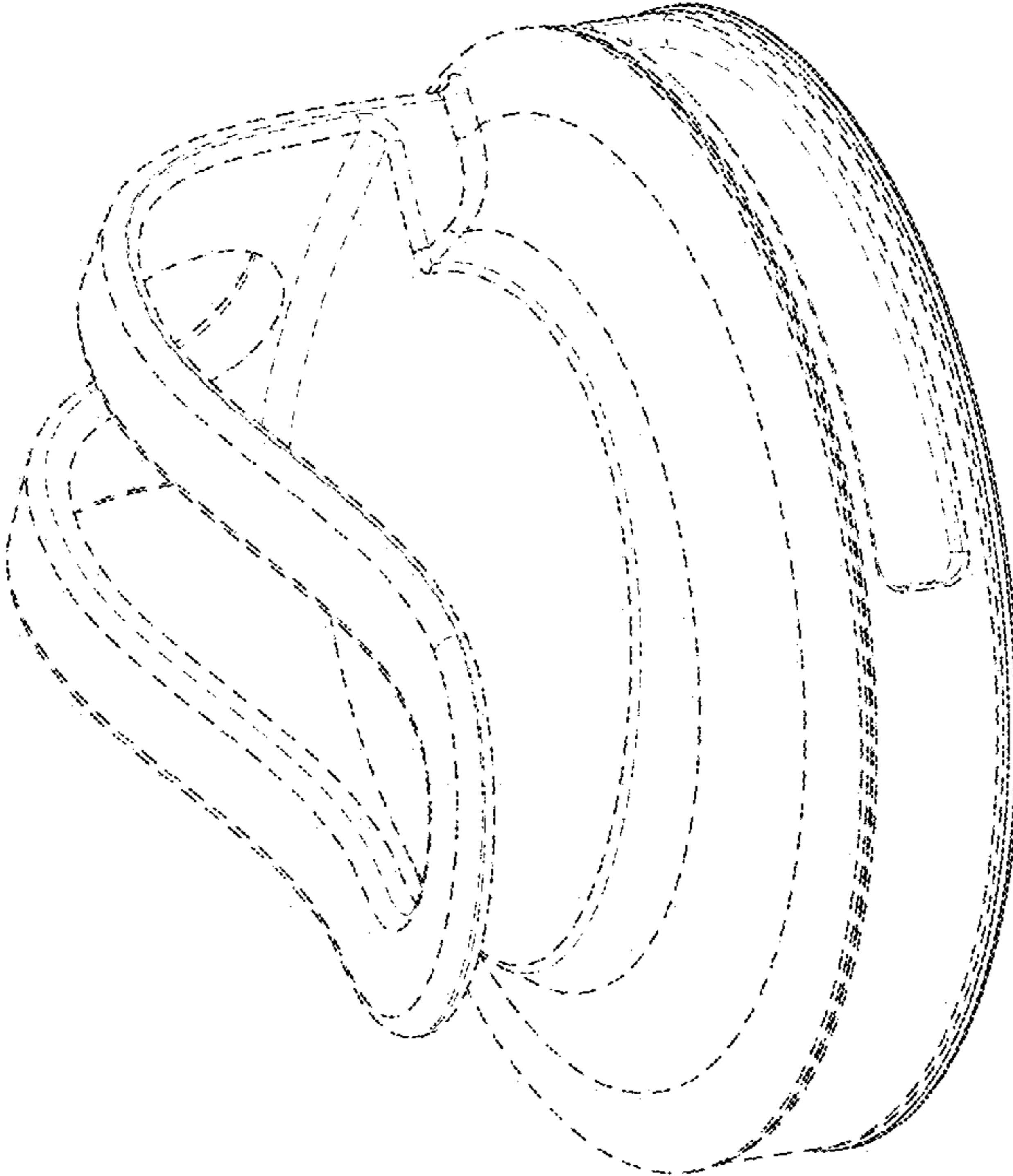

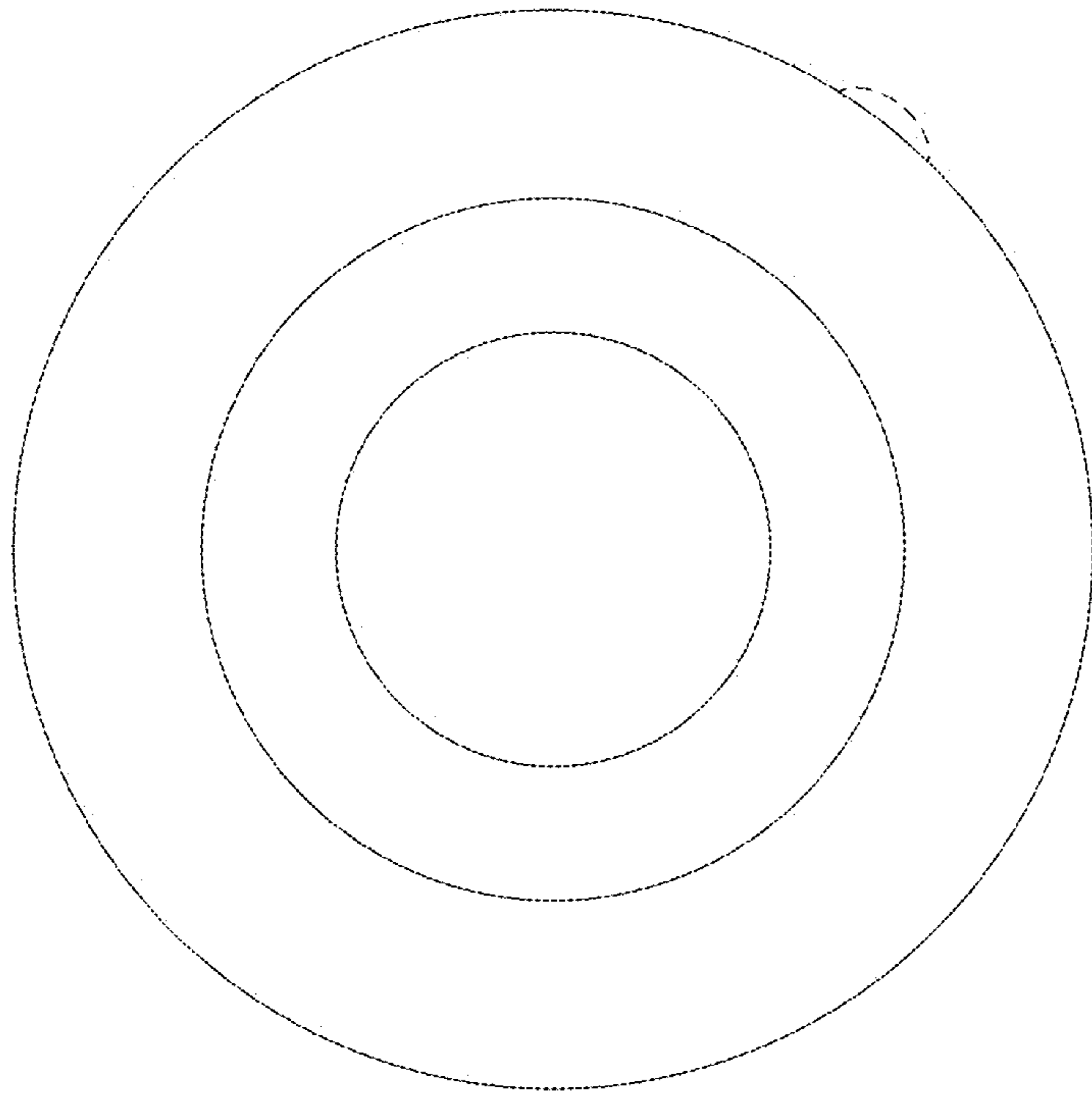

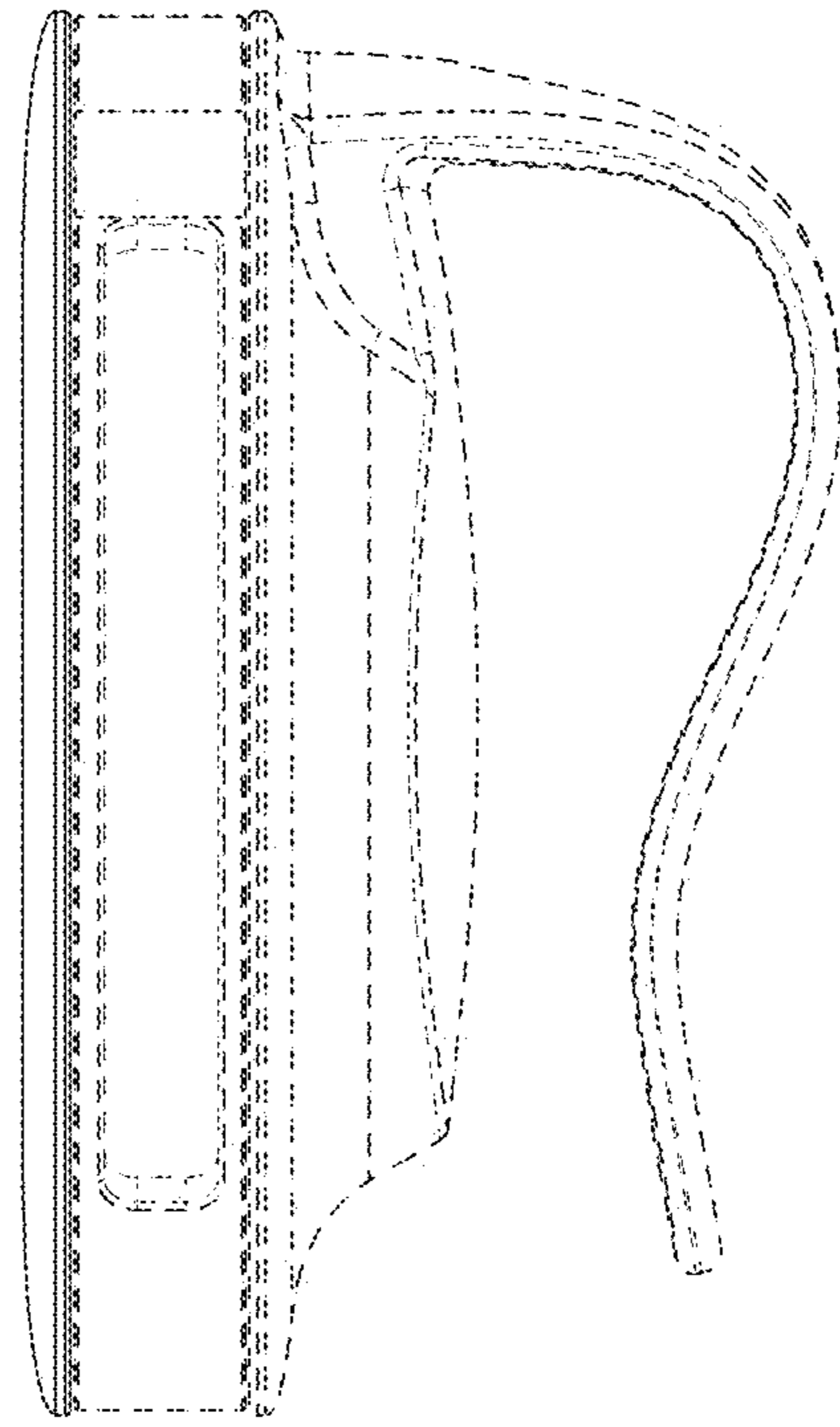

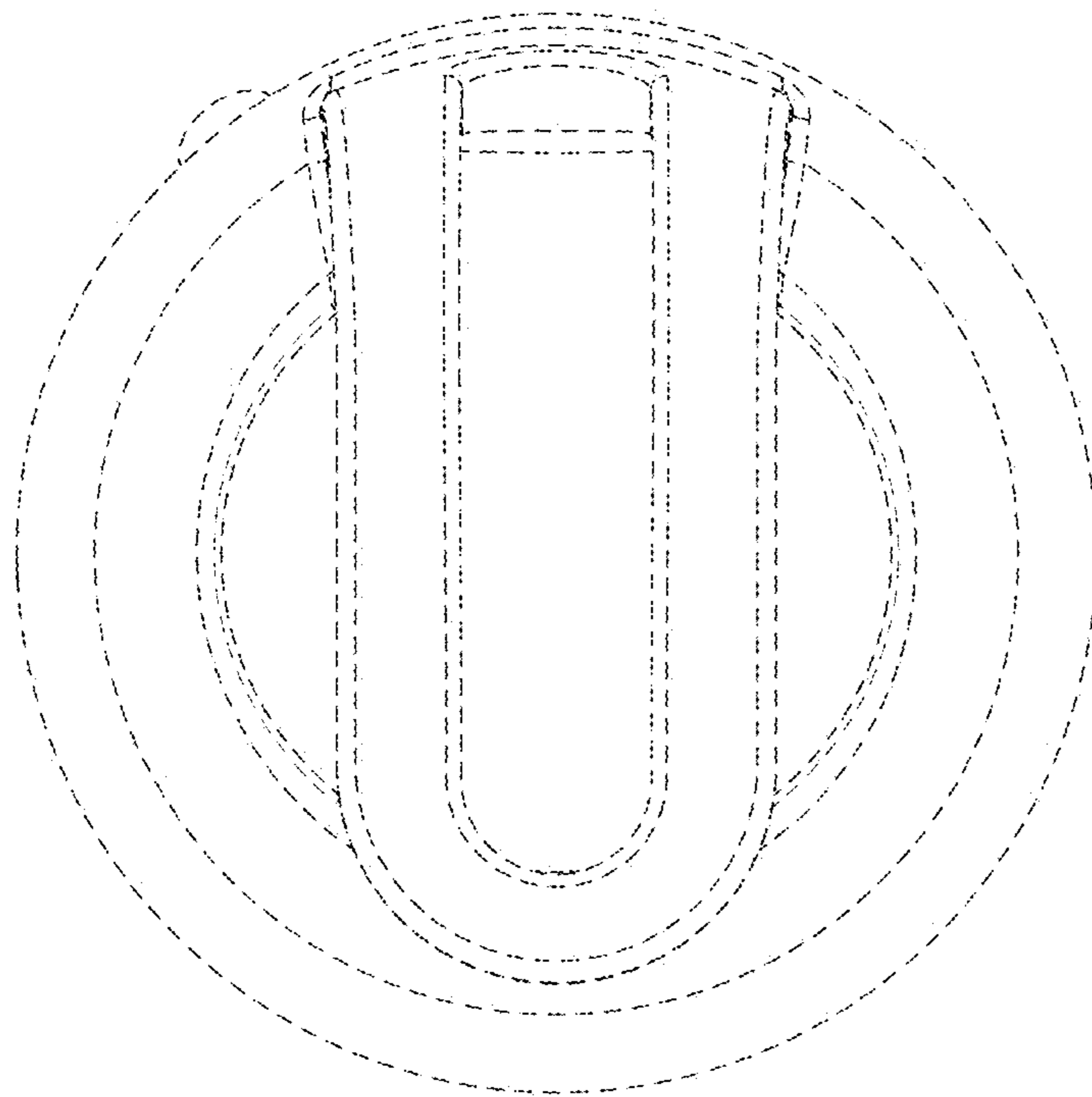

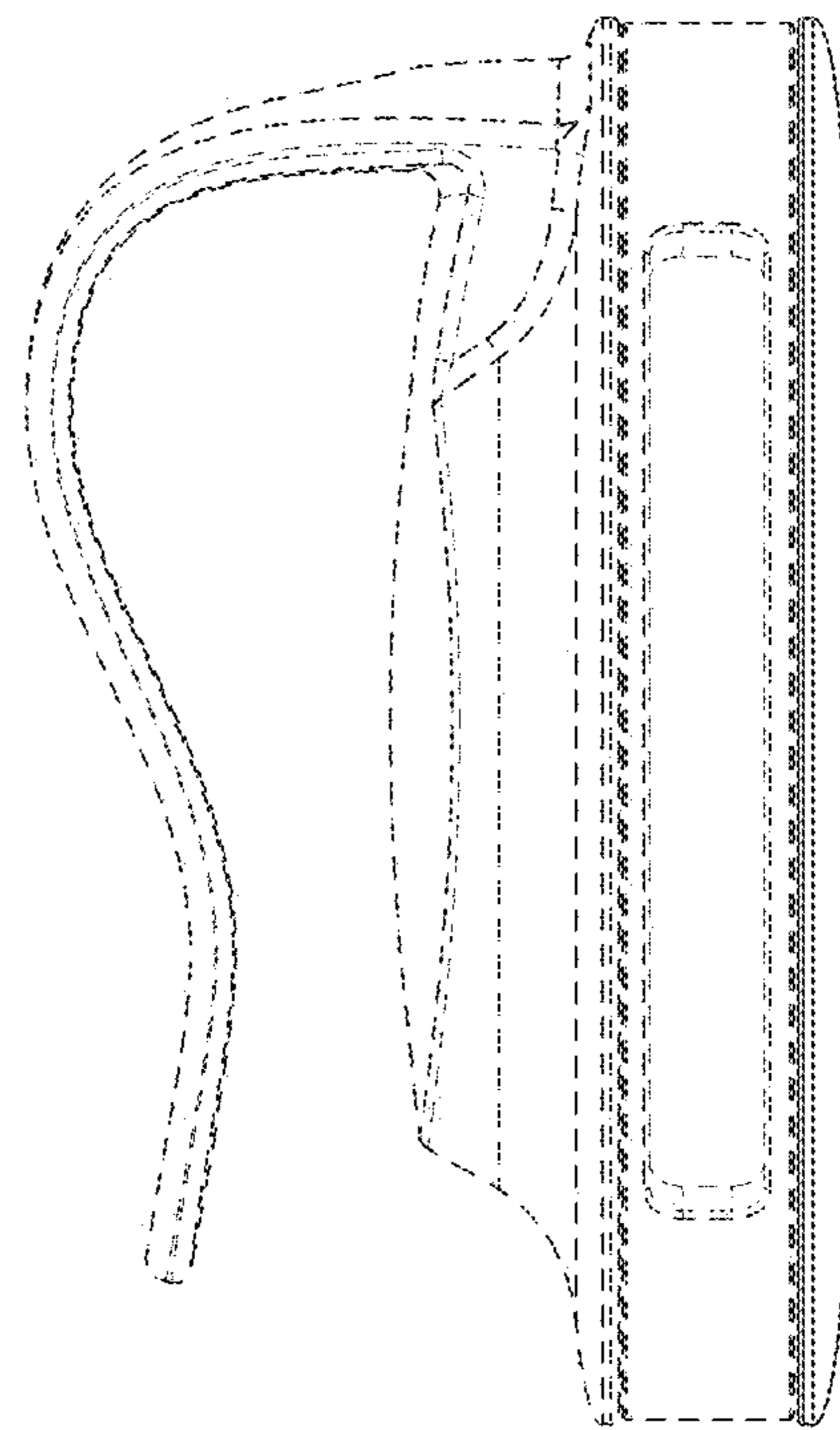

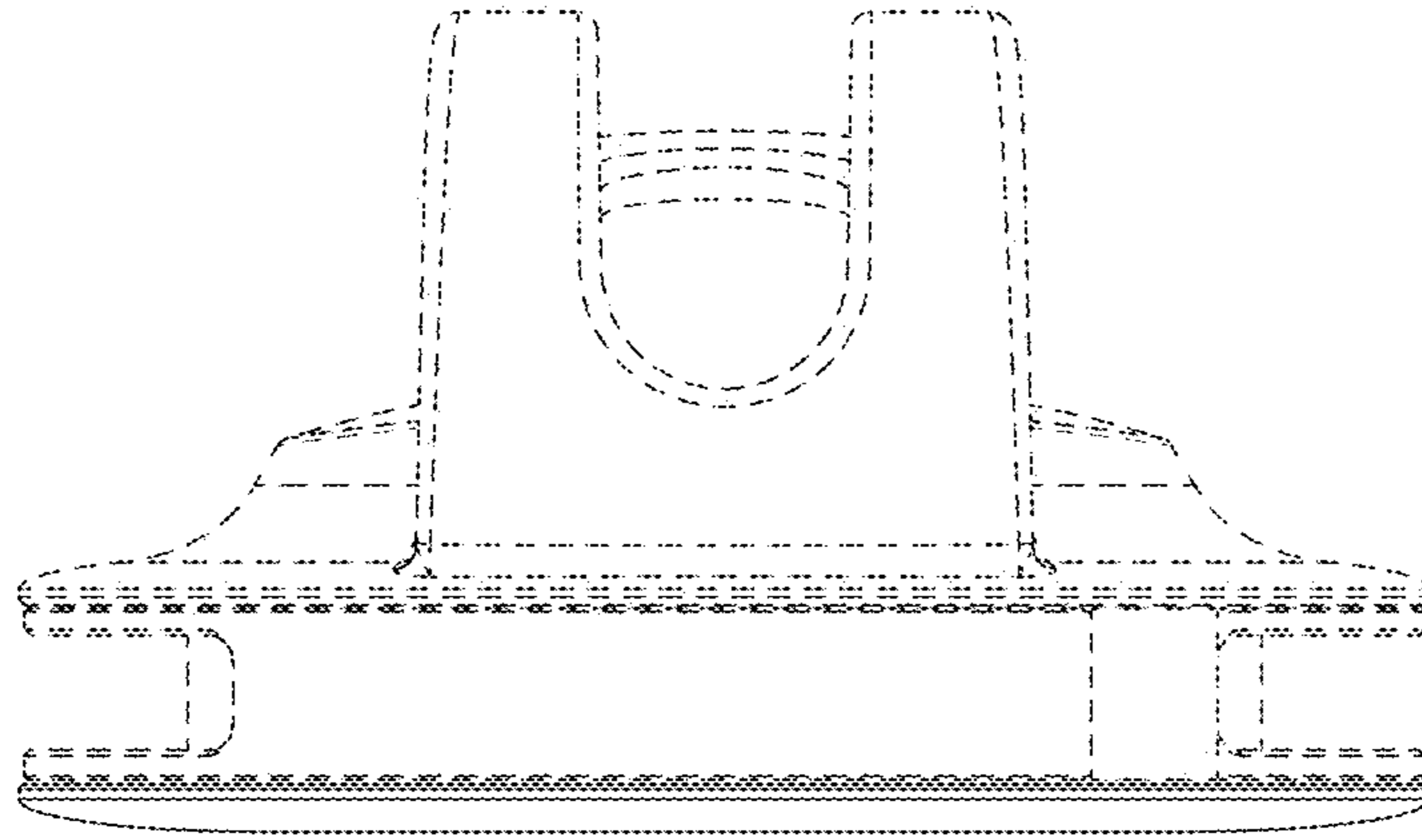

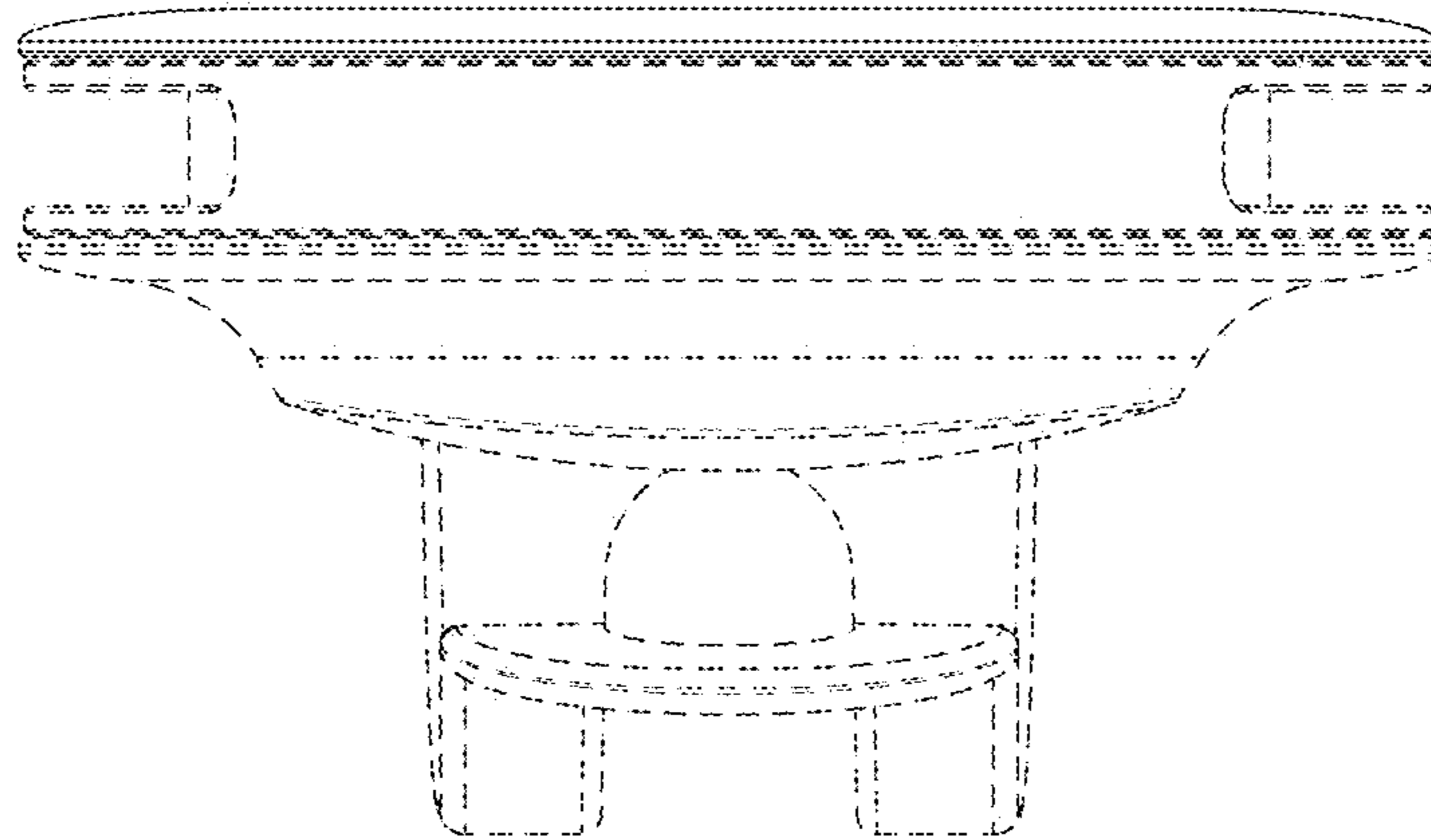
