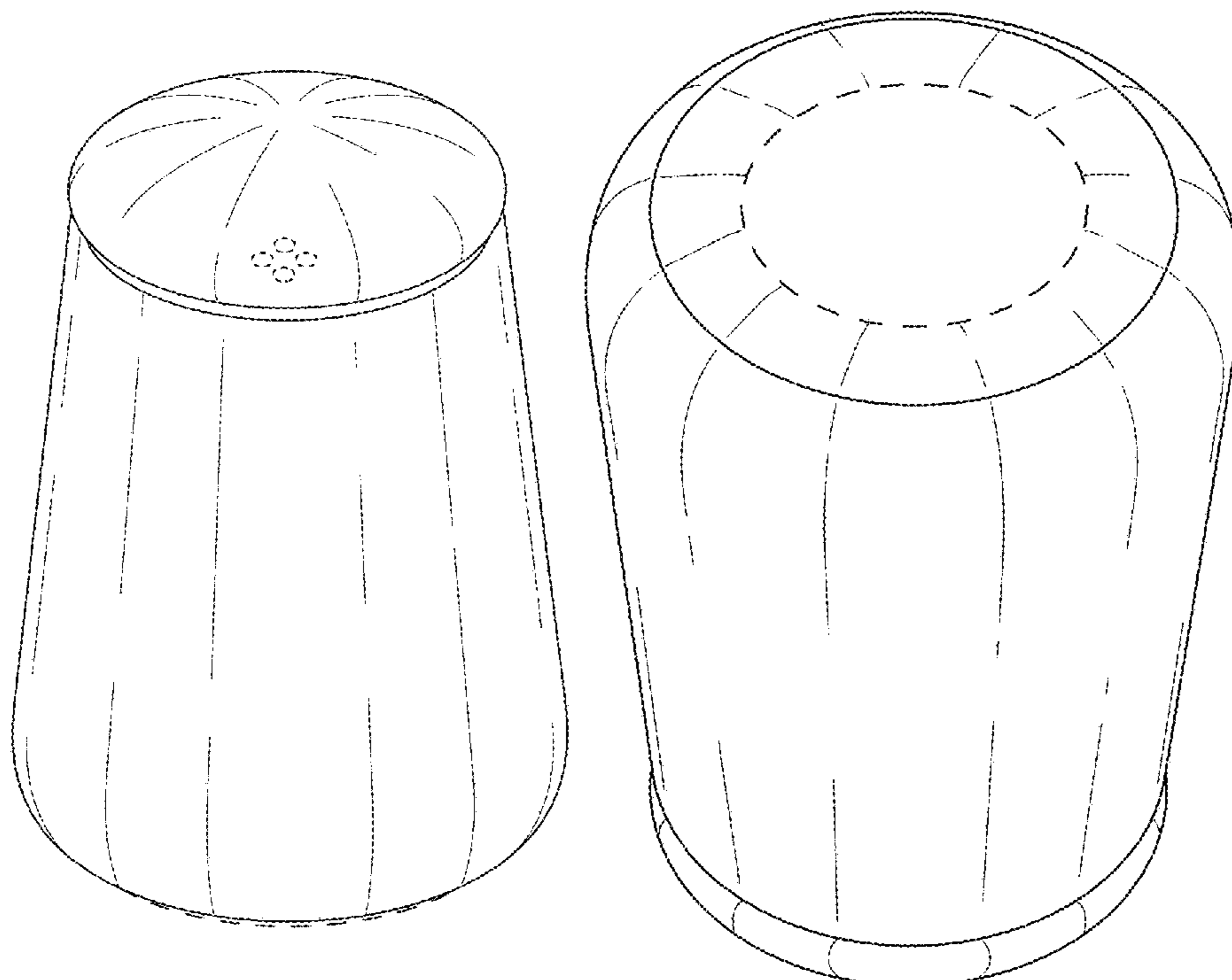
(57) **CLAIM**

The ornamental design for an aroma diffuser, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of an aroma diffuser showing my new design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a top and front perspective view thereof; and,

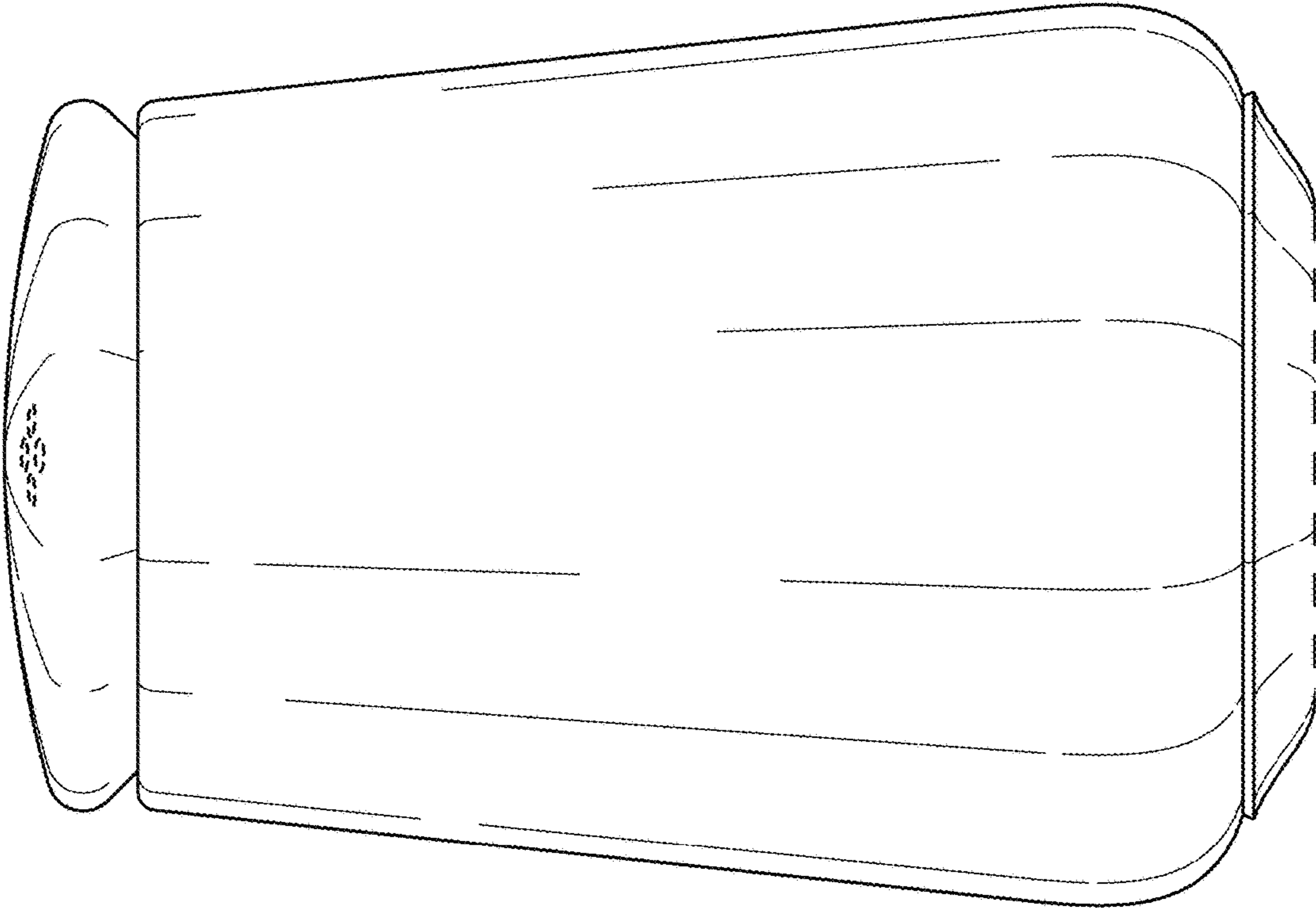

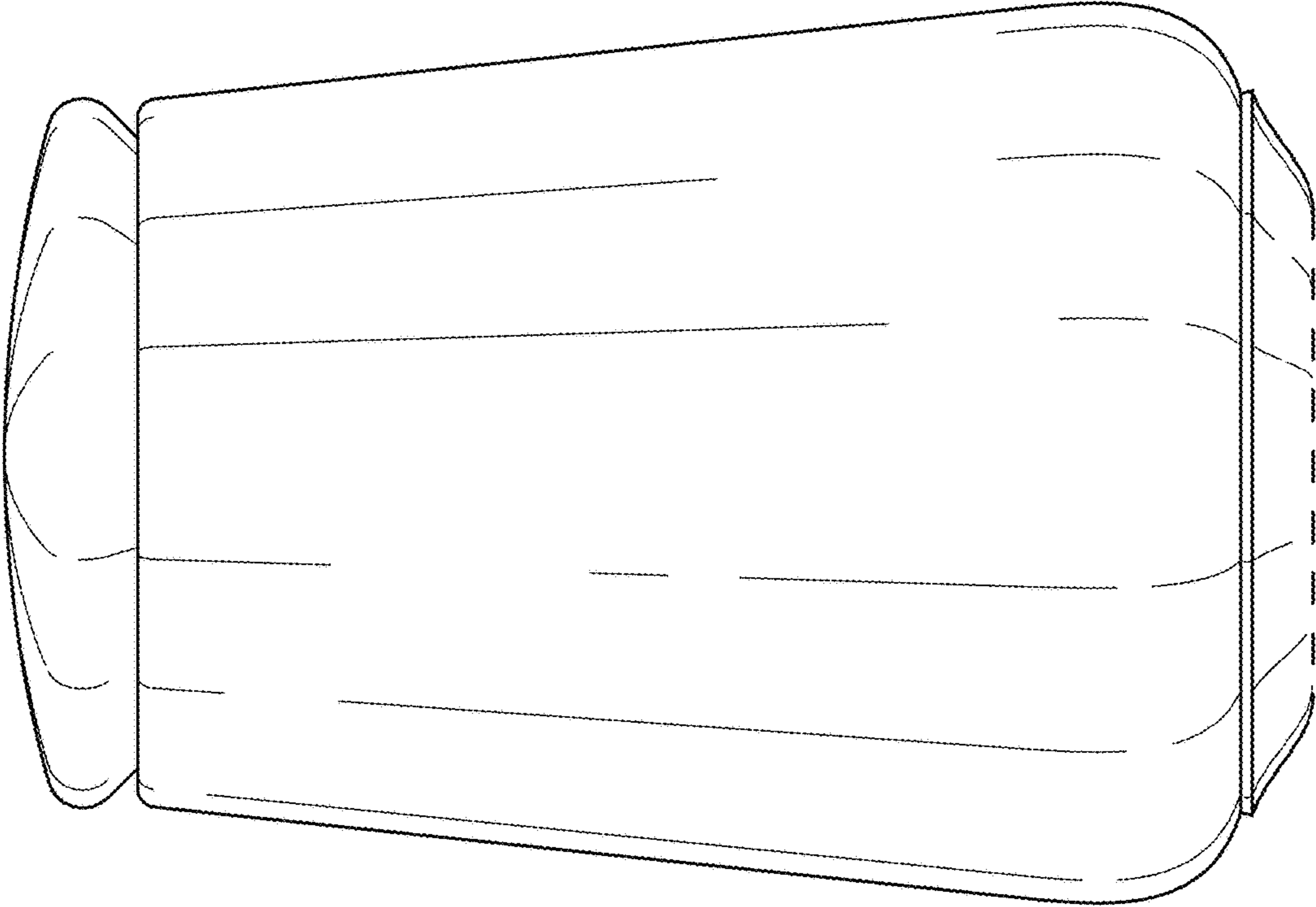

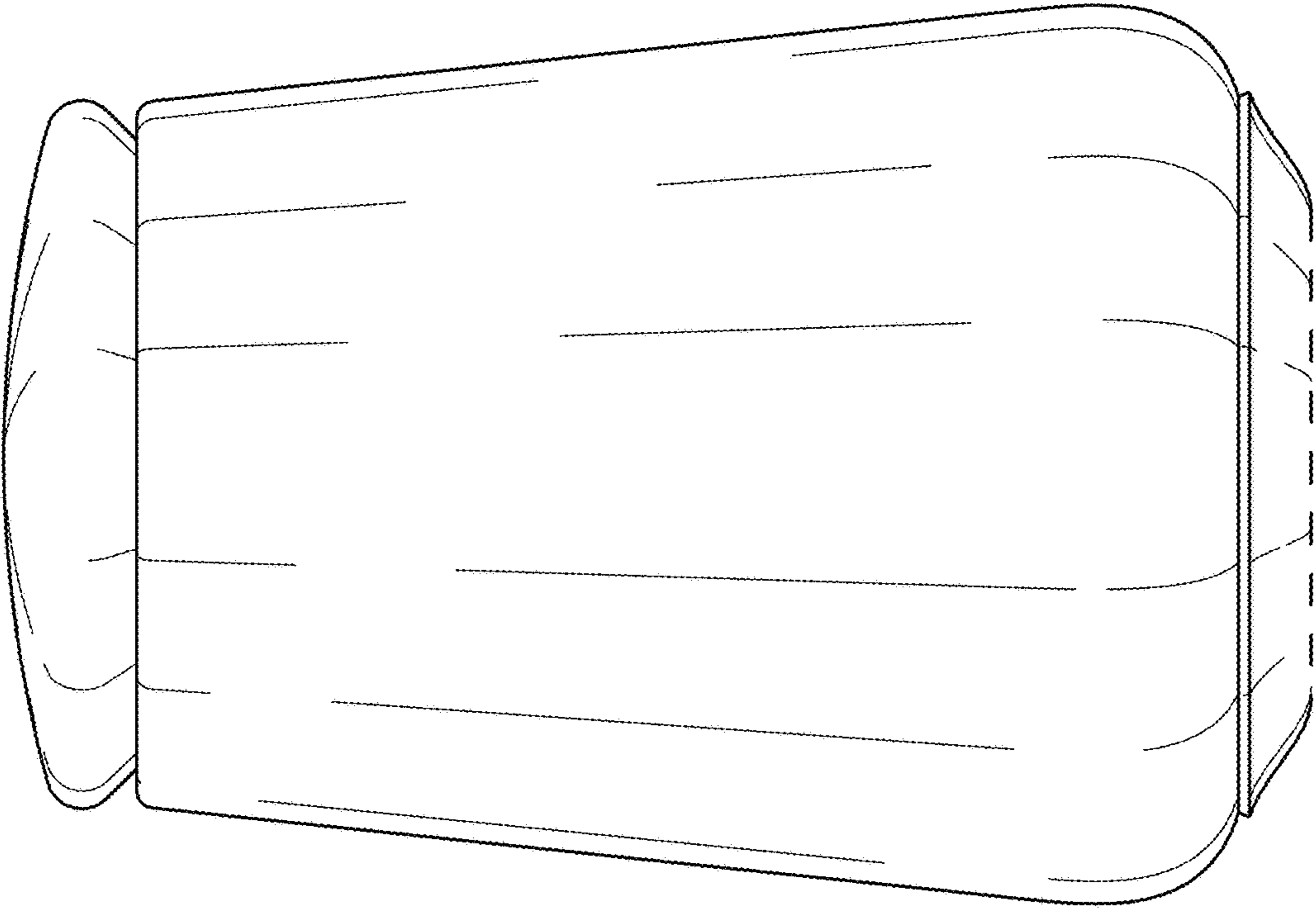

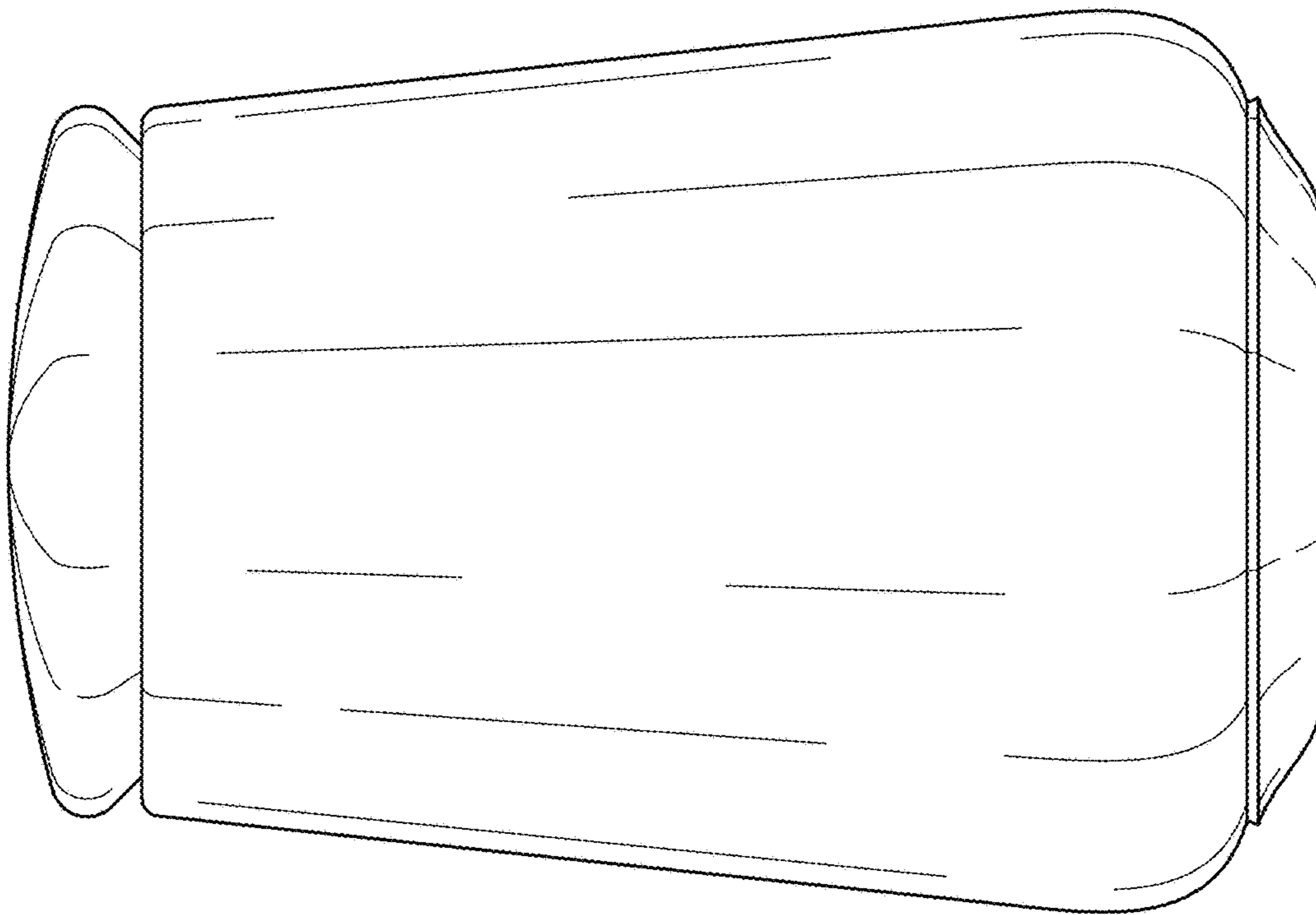

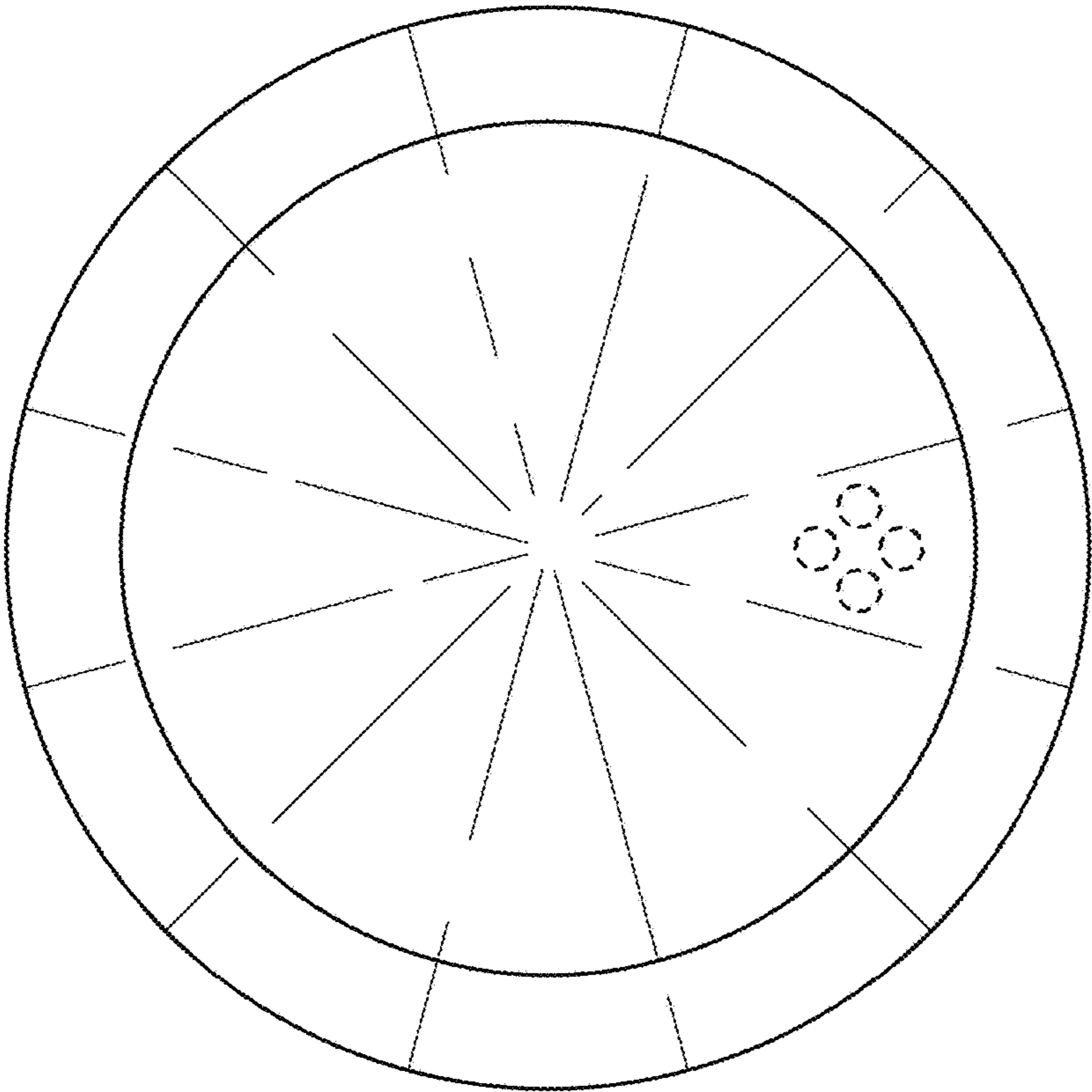

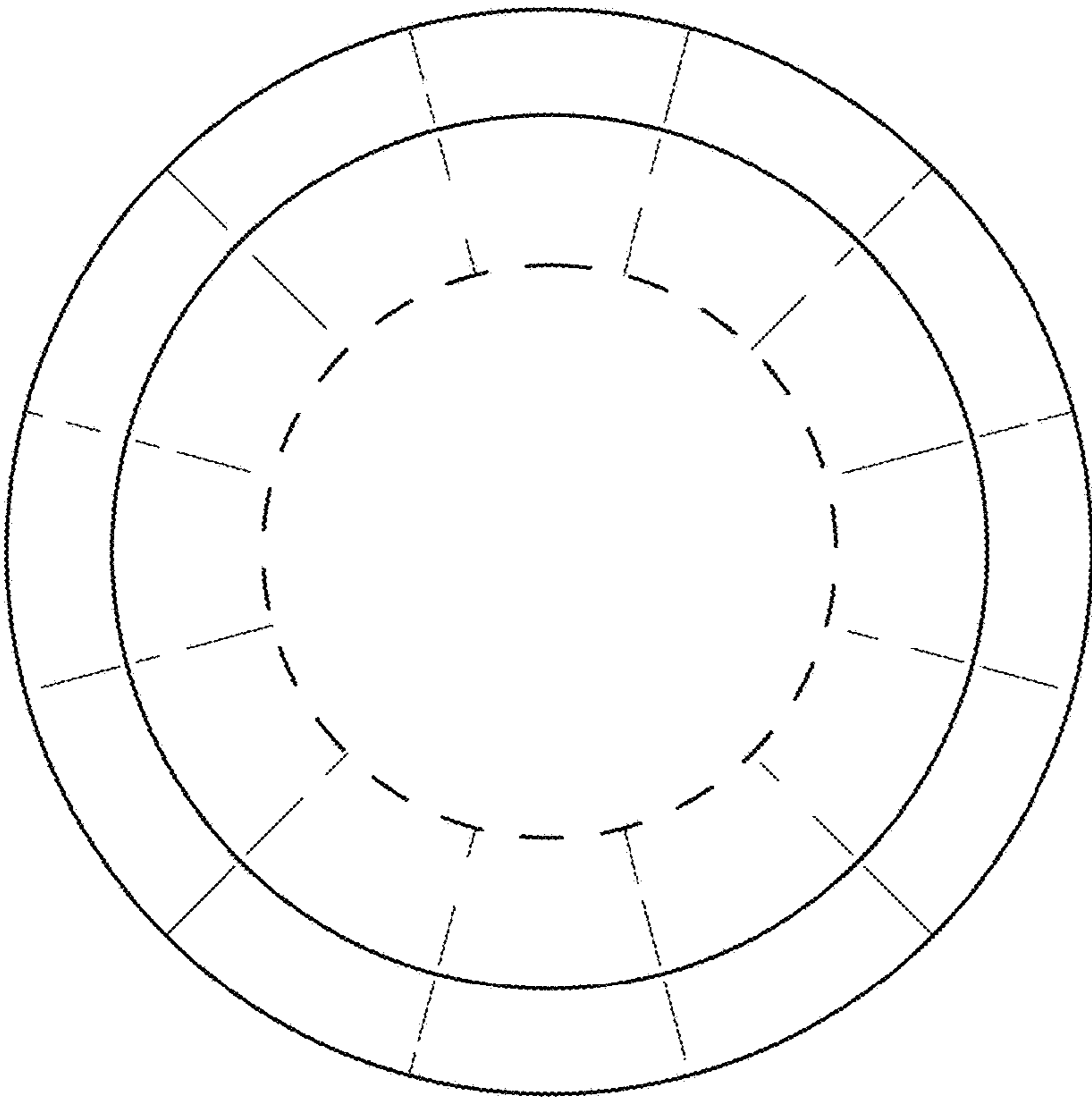

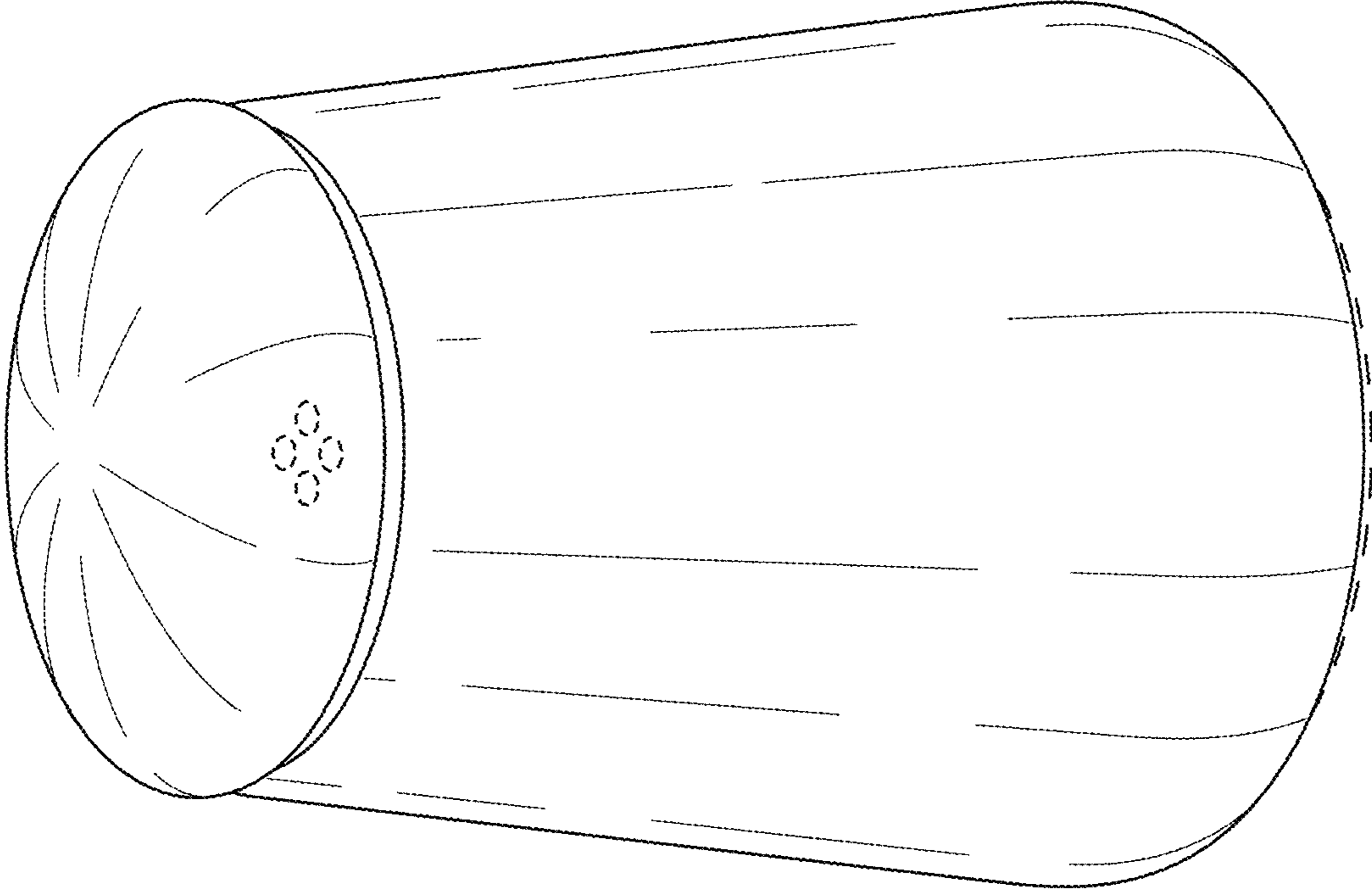

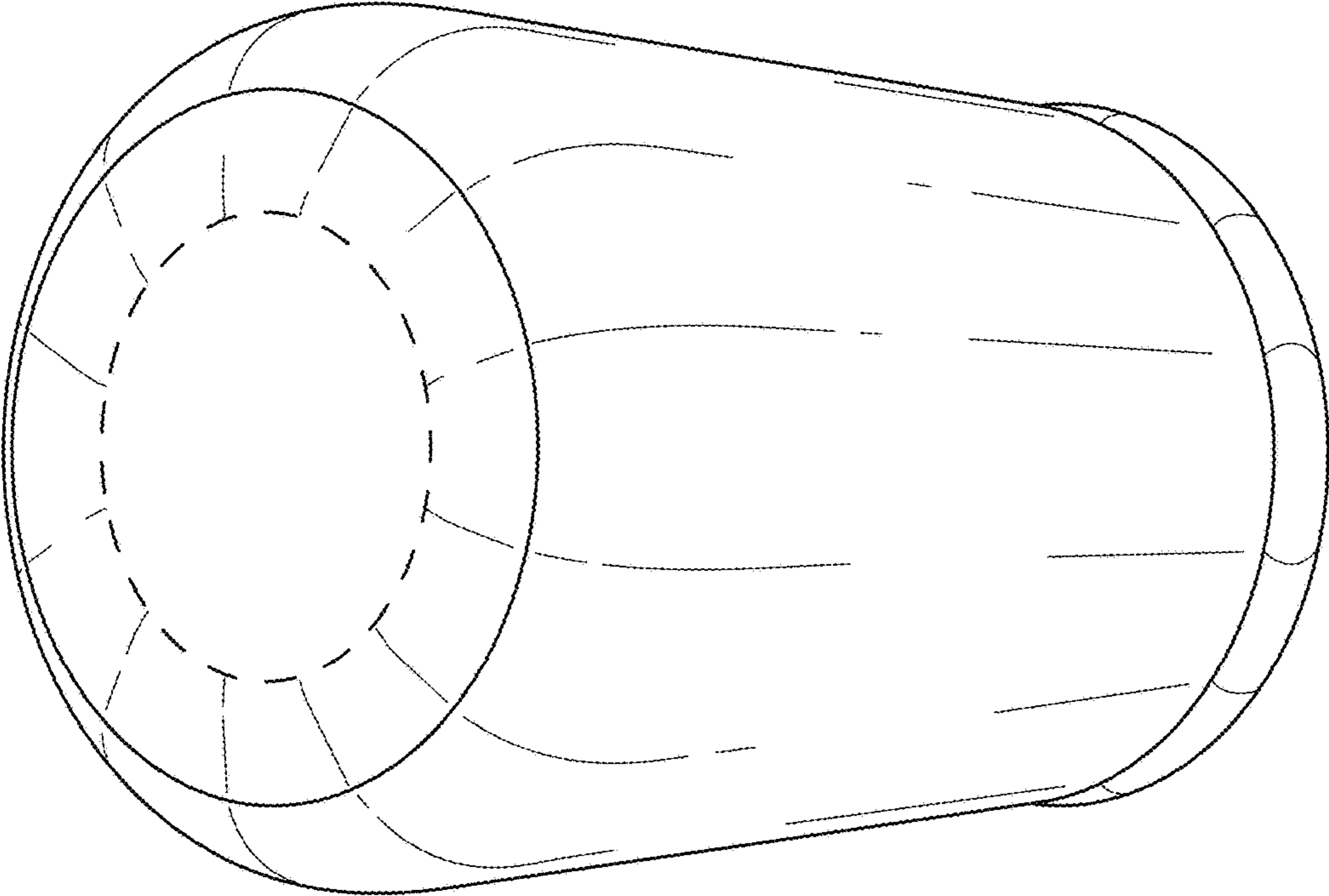
