(57) **CLAIM**

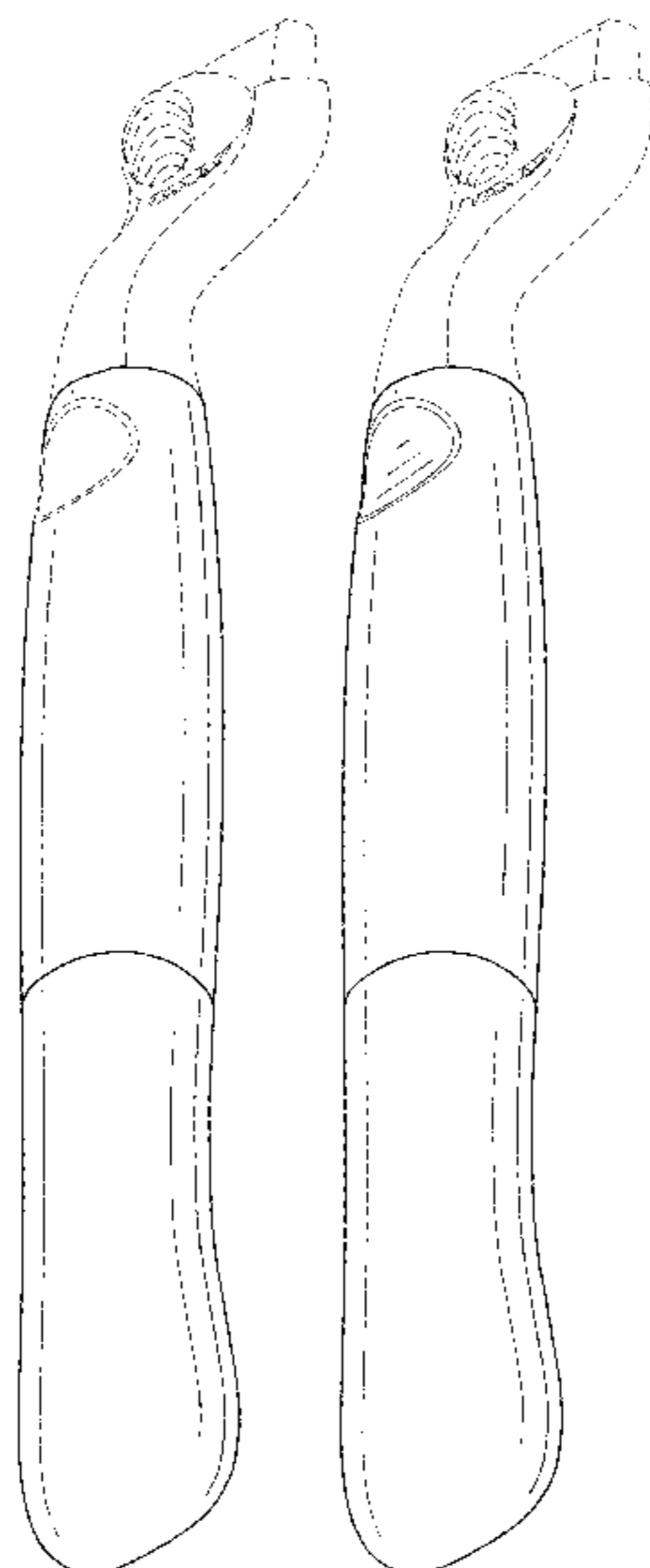
The ornamental design for a shaving razor handle, as shown and described.

**DESCRIPTION**

FIG. 1 is a first perspective view of a design of a shaving razor handle of the present invention;

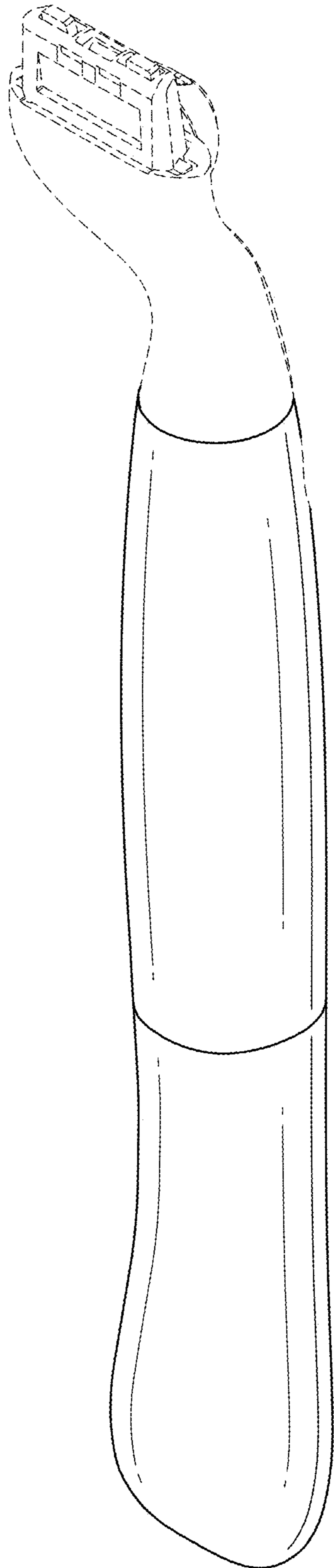

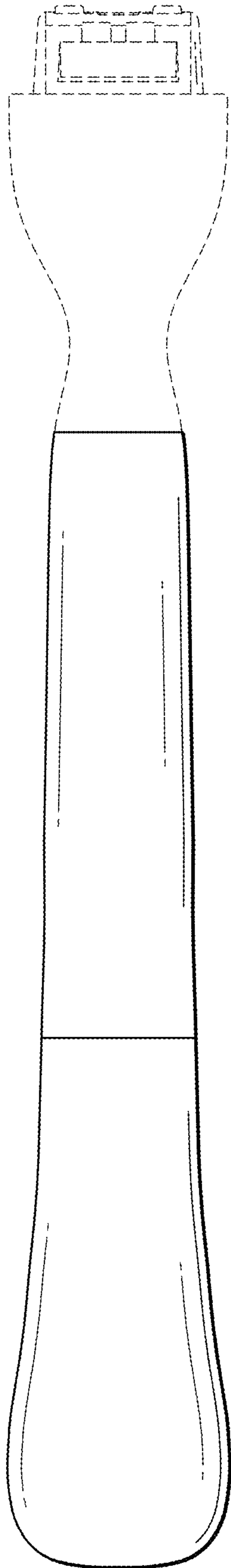

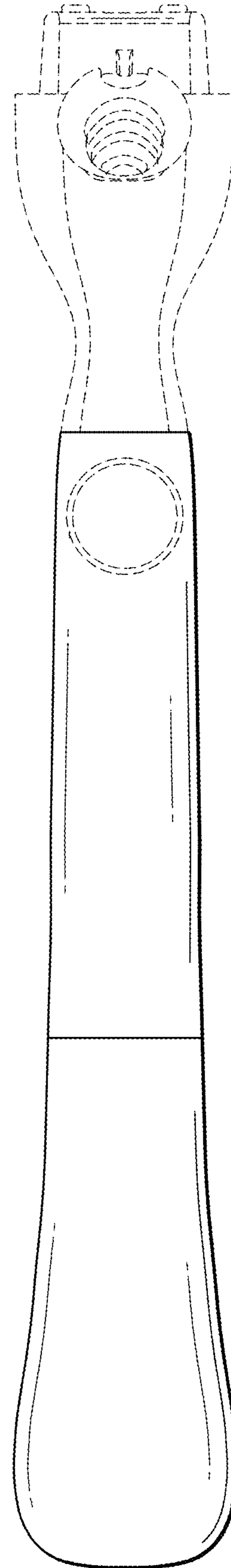

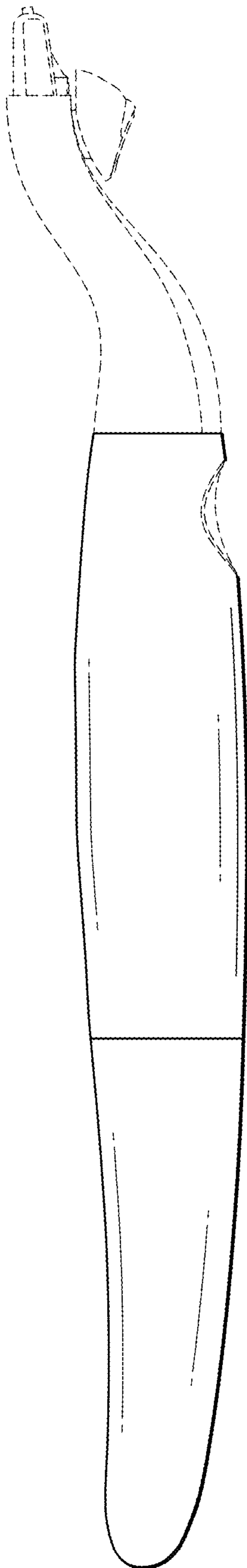

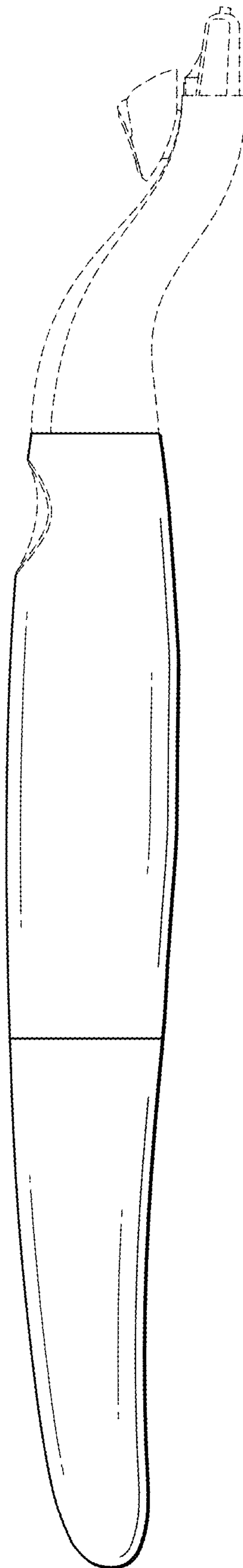

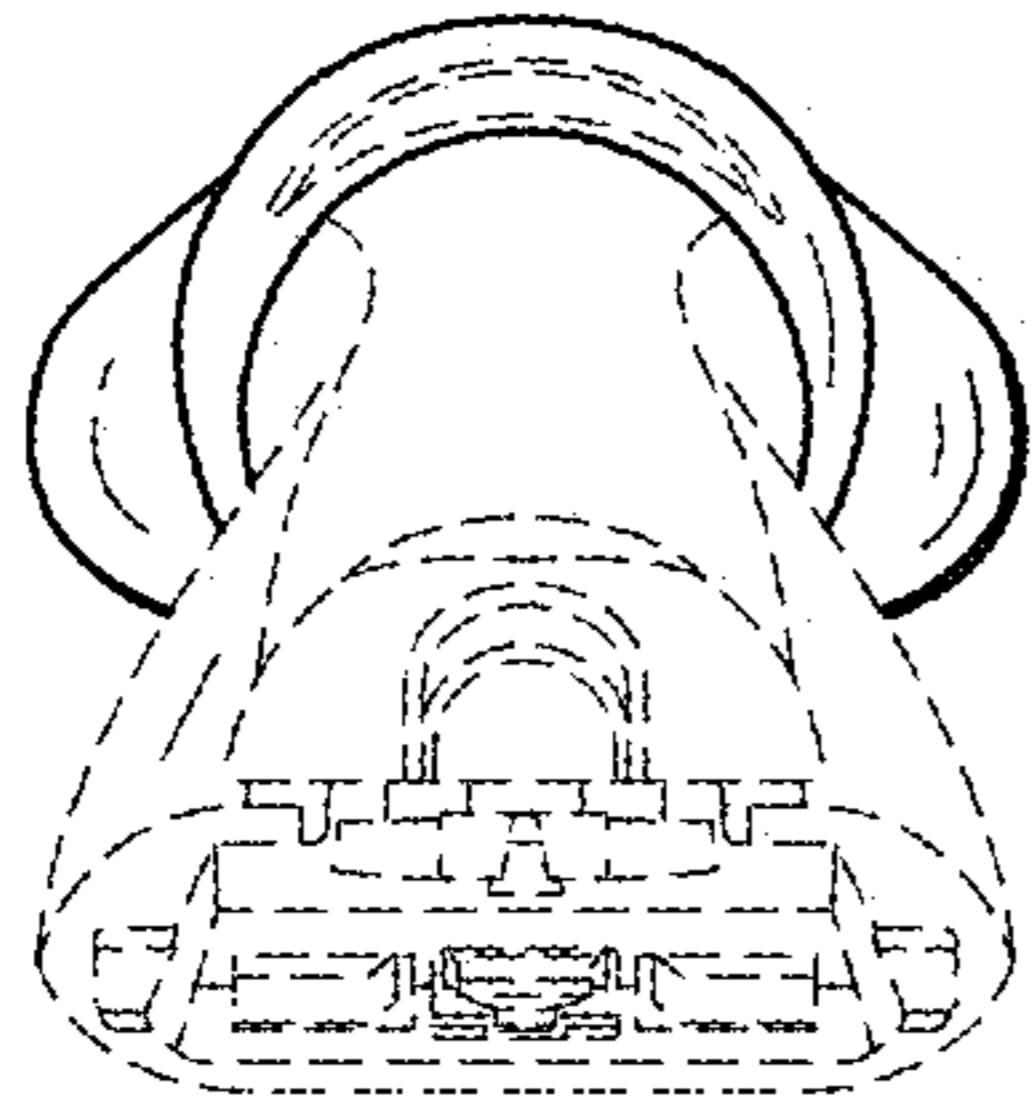

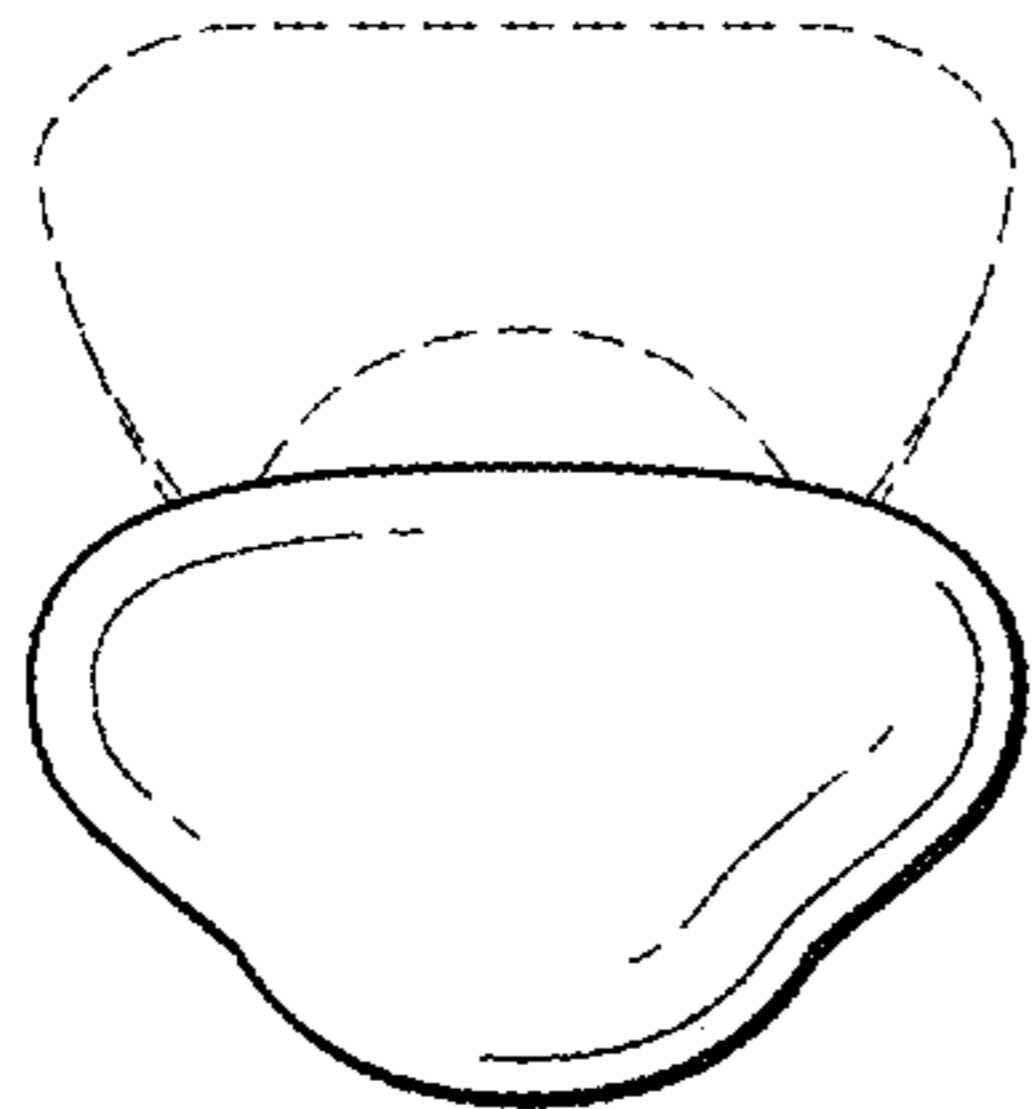

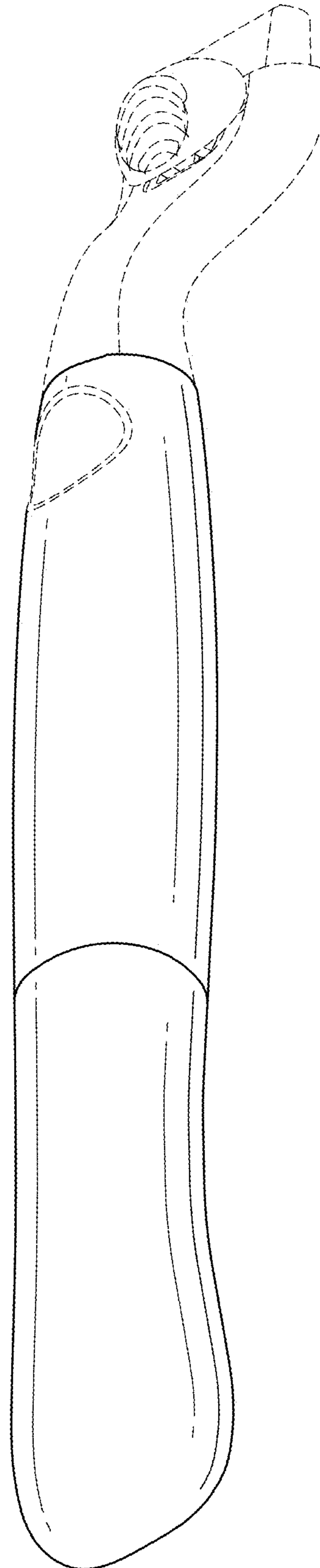

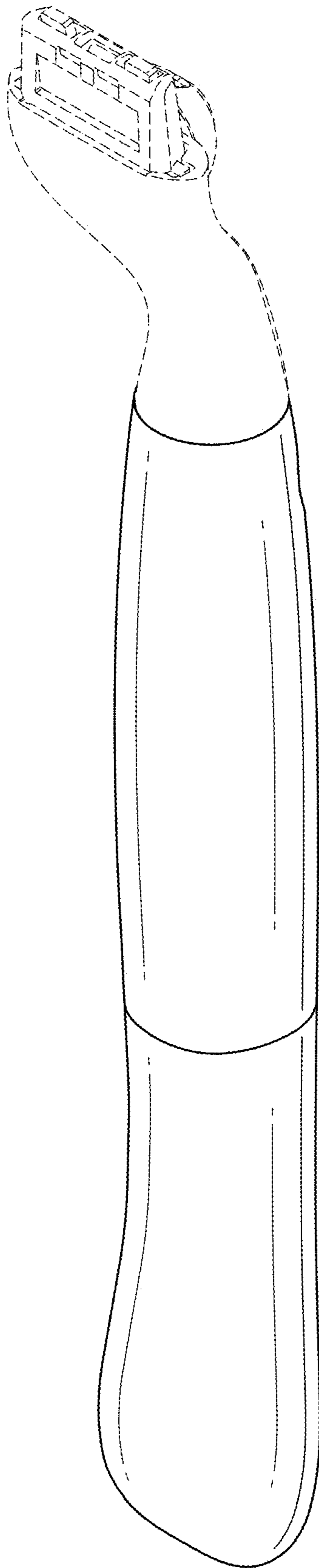

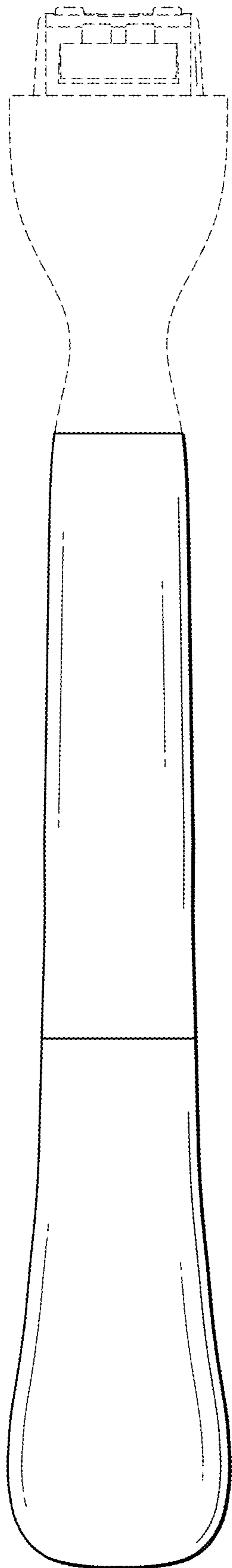

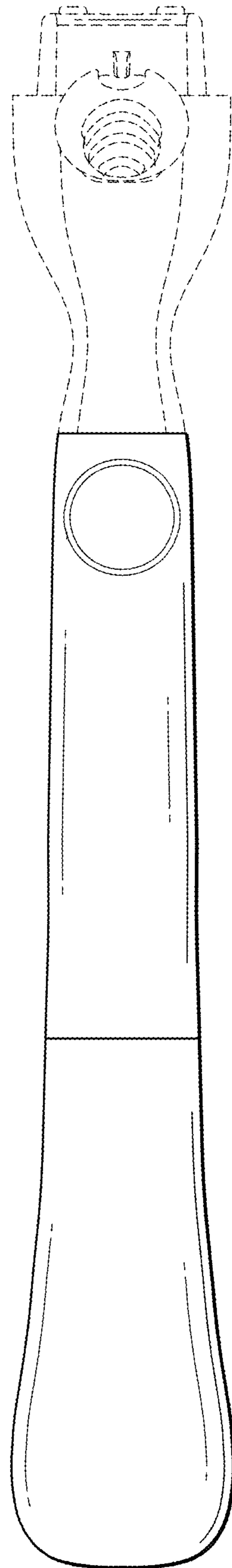

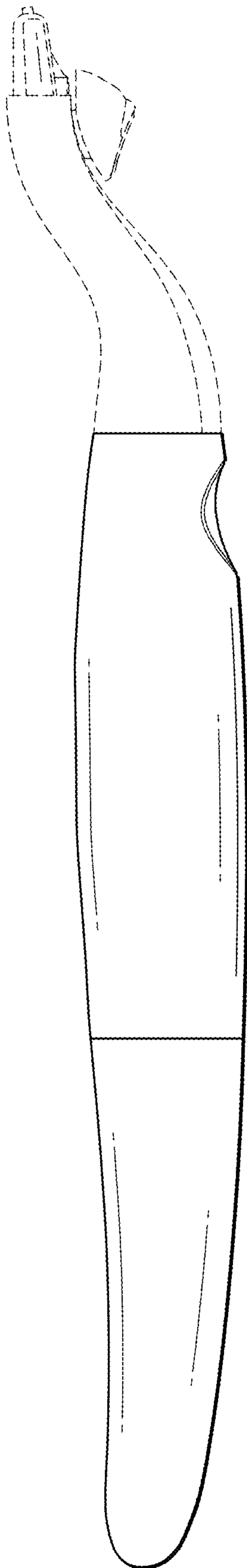

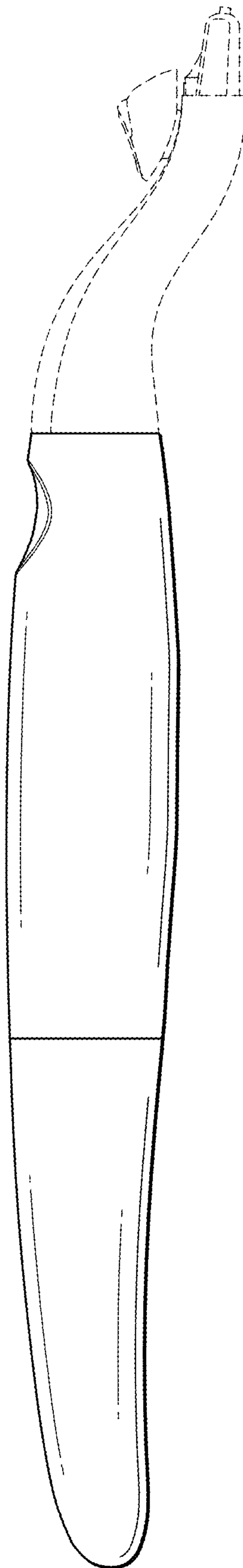

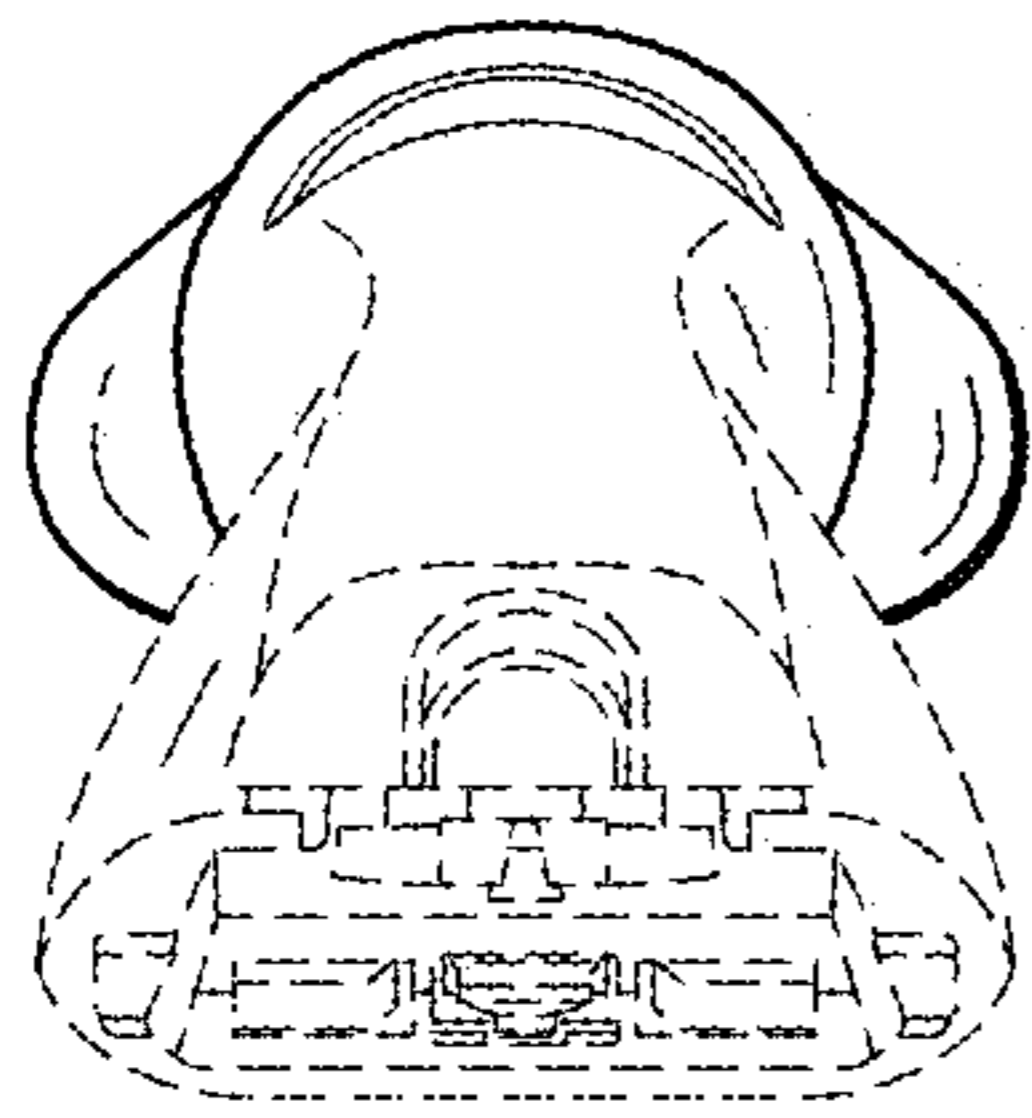

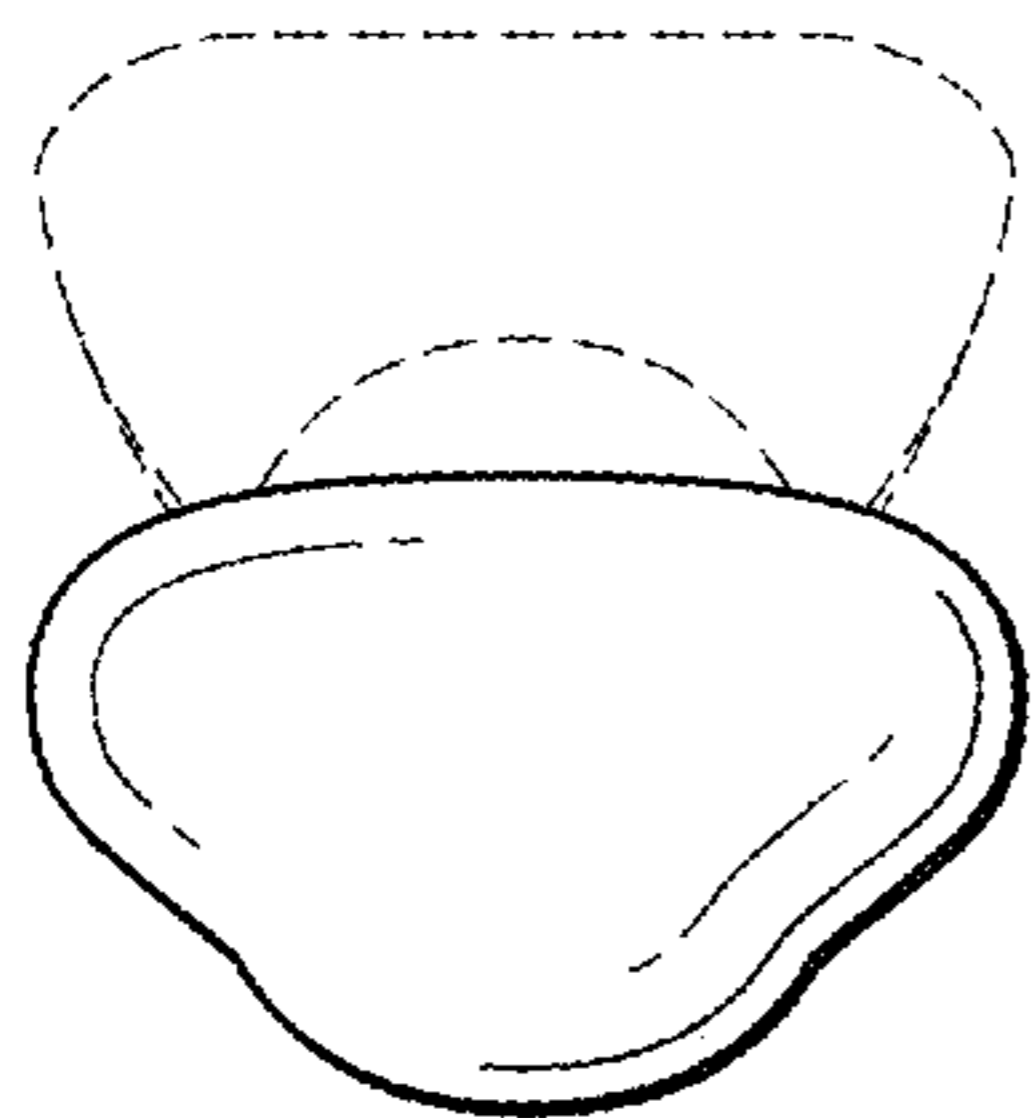

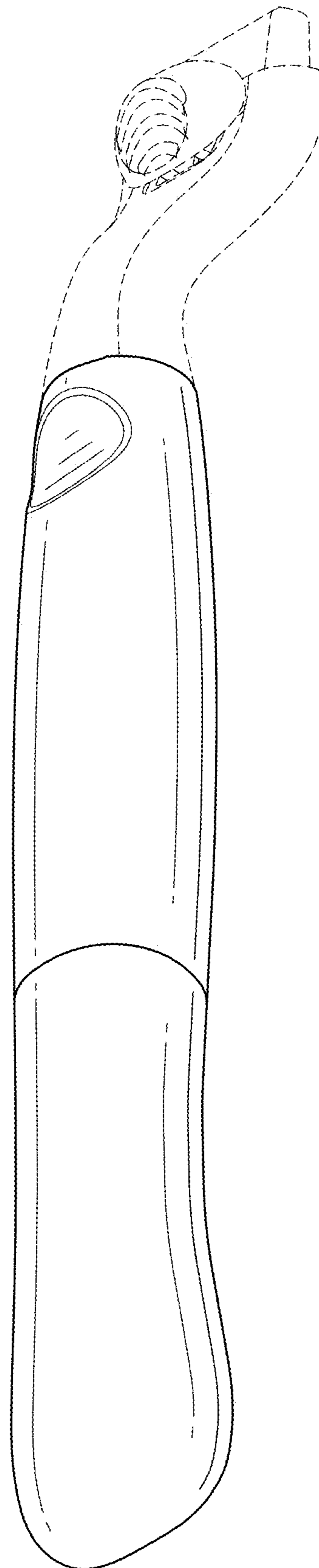
