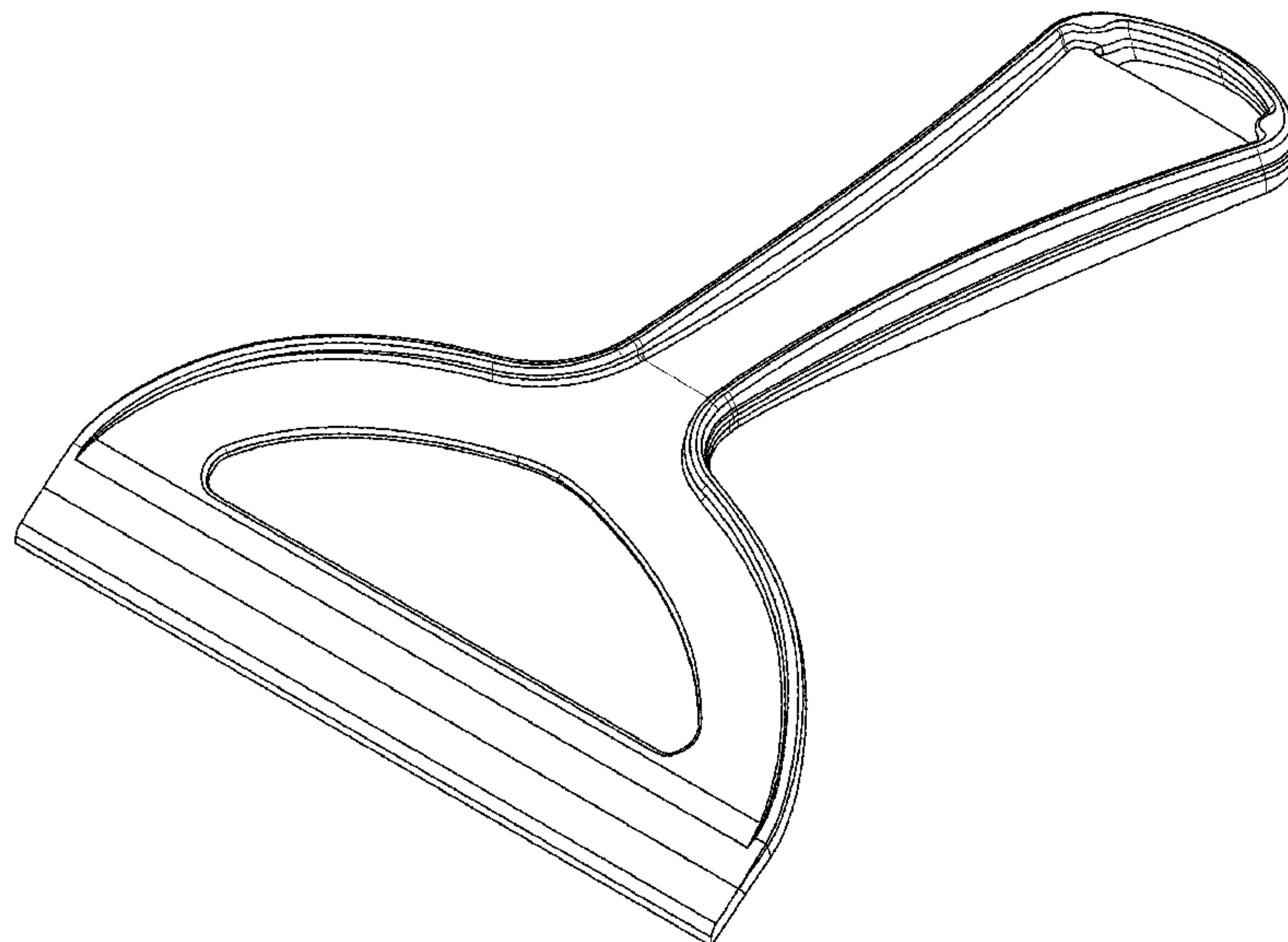
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view for a sink squeegee, showing my new design;

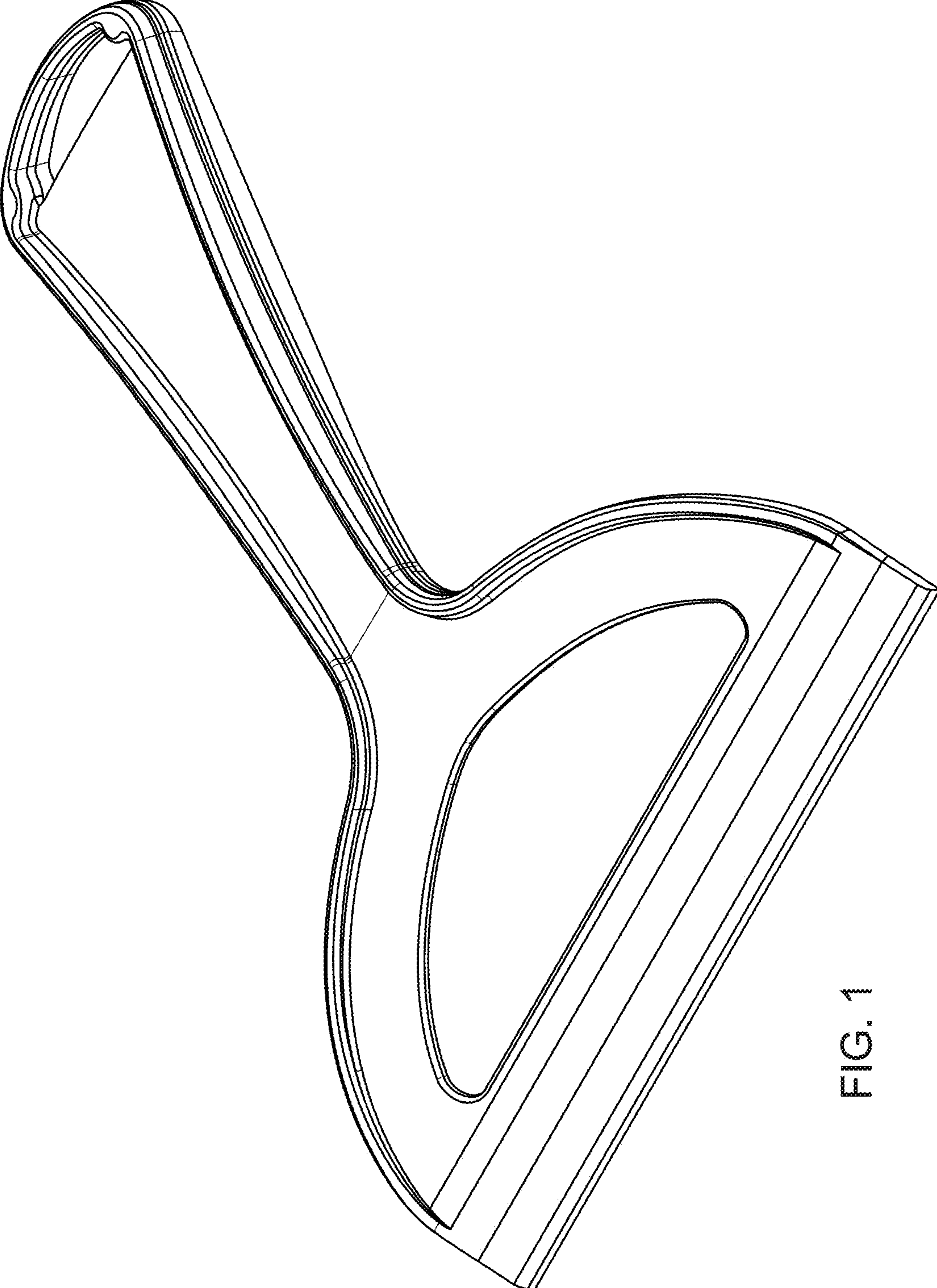

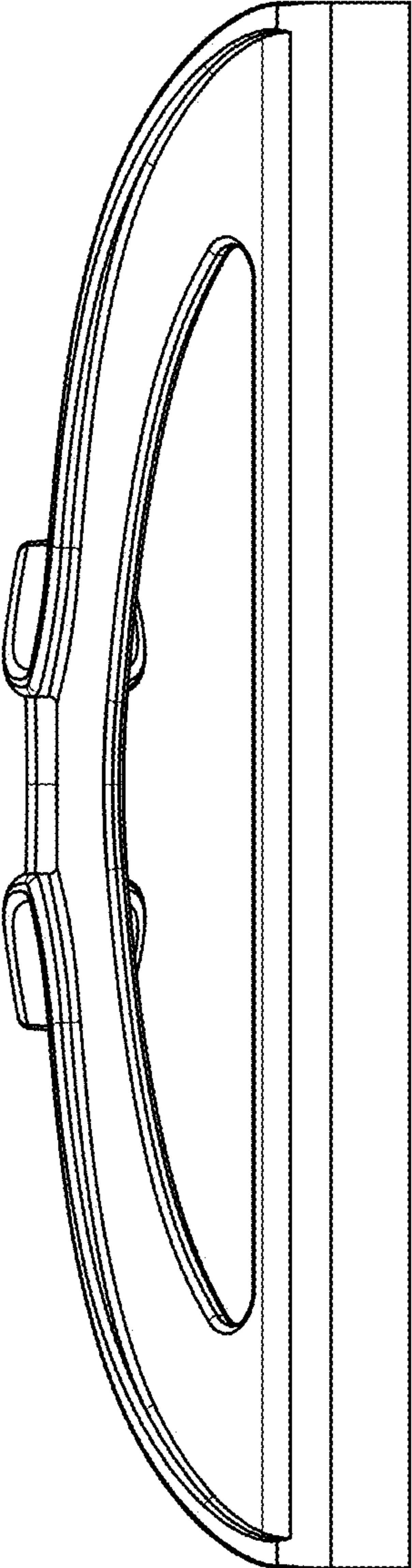

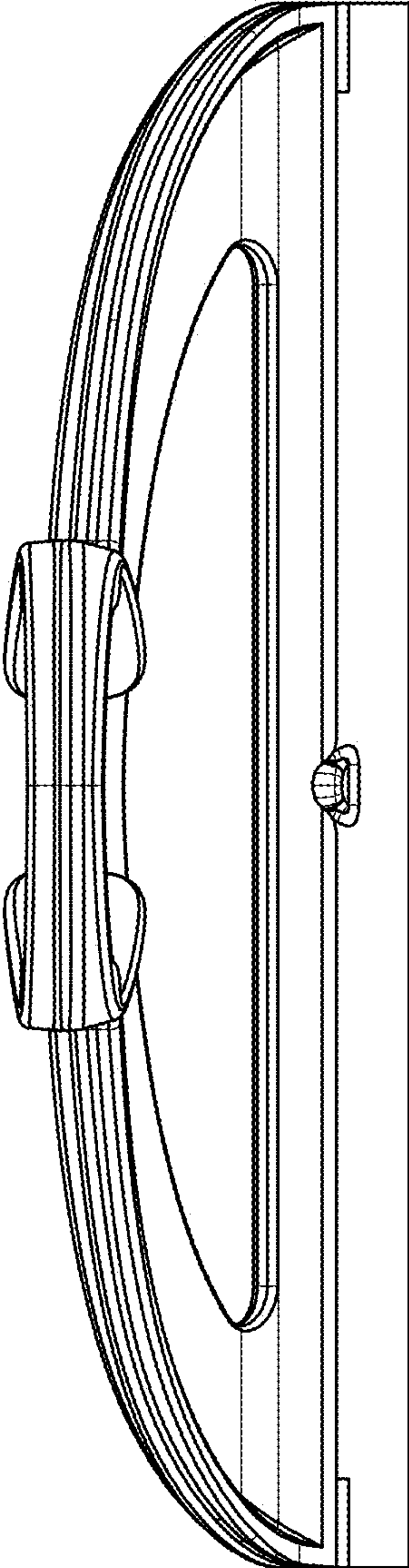

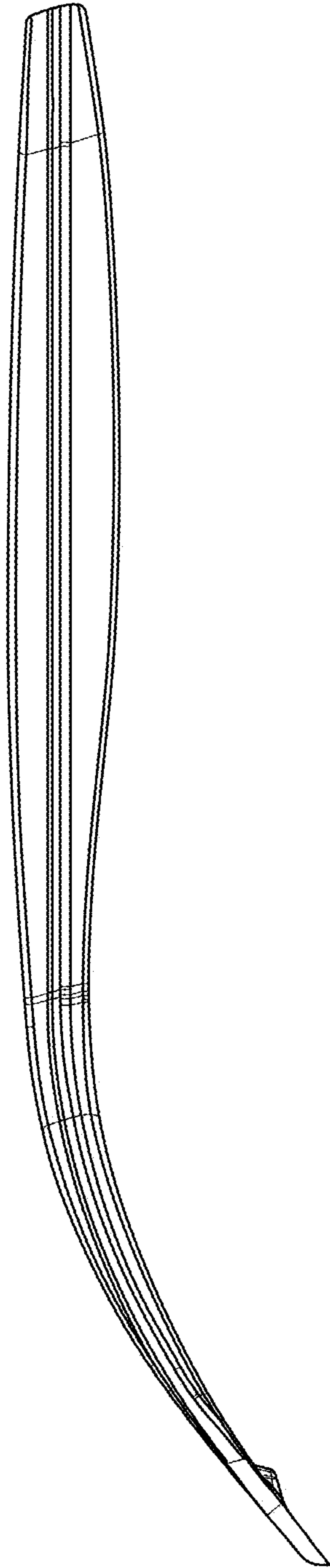

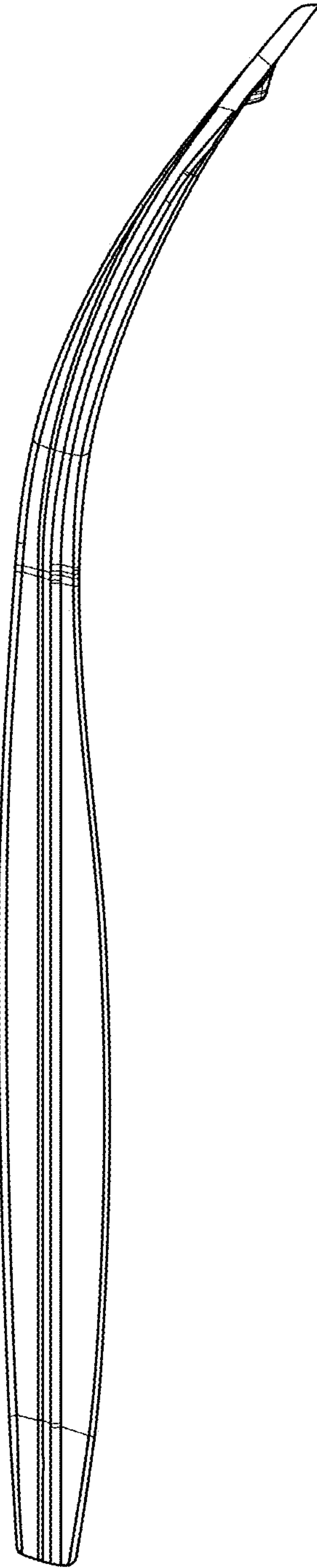

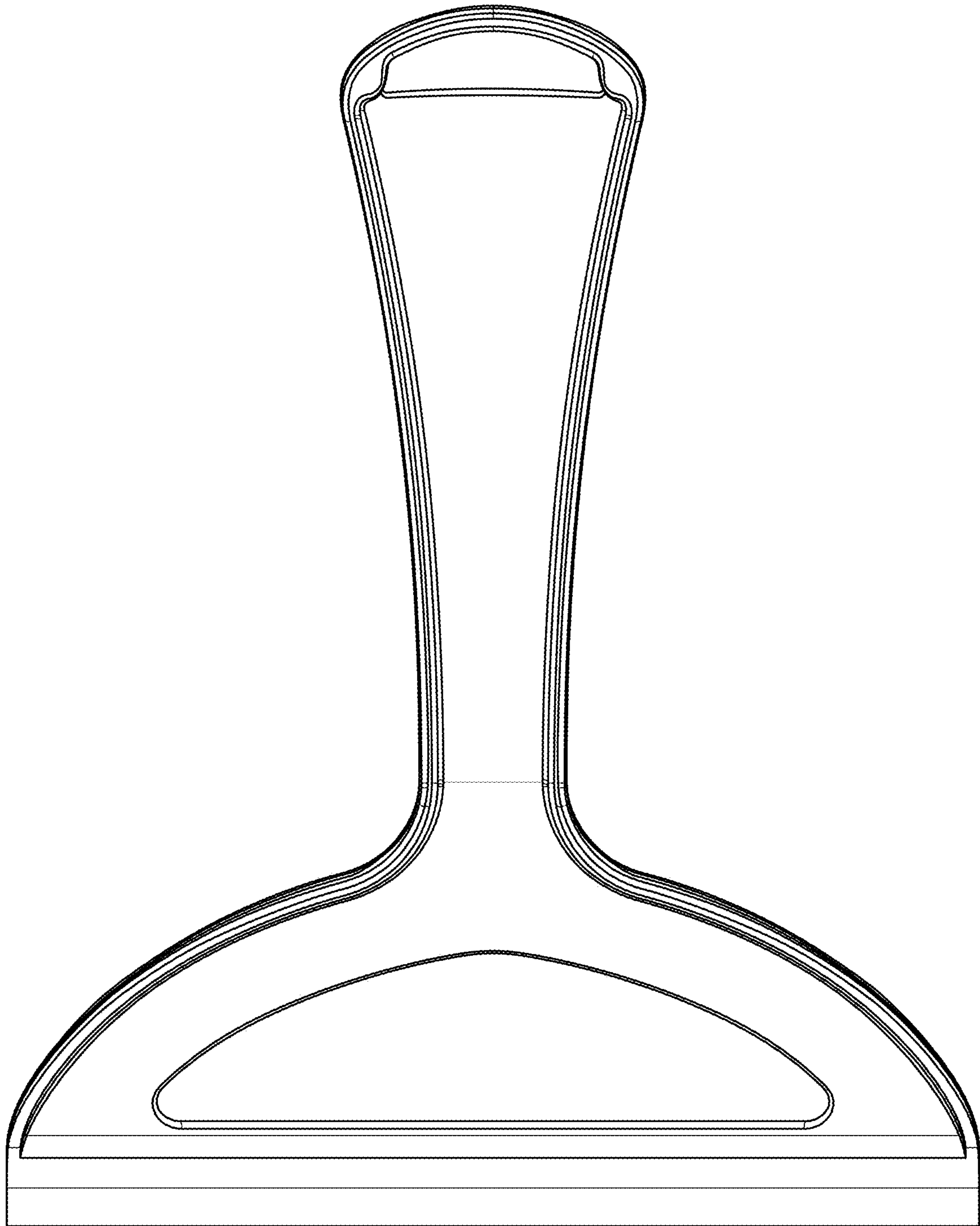

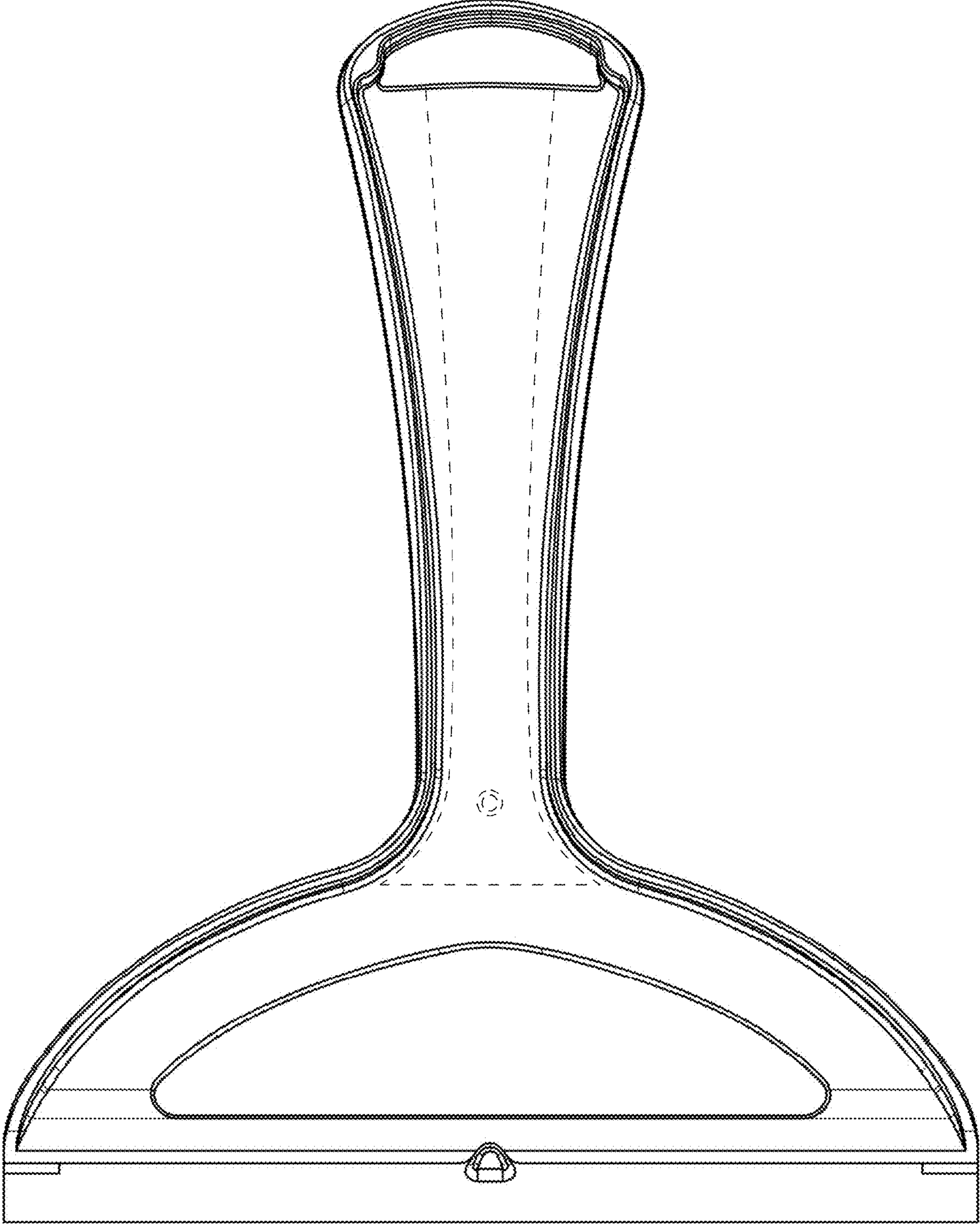
