(57) **CLAIM**

The ornamental design for an upper torso garment, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an upper torso garment showing our new design.

FIG. 2 is a rear perspective view of the upper torso garment.

FIG. 3 is a front elevation view of the upper torso garment.

FIG. 4 is a rear elevation view of the upper torso garment.

FIG. 5 is a right side elevation view of the upper torso garment.

FIG. 6 is a left side elevation view of the upper torso garment.

FIG. 7 is a top plan view of the upper torso garment.

FIG. 8 is a bottom plan view of the upper torso garment.

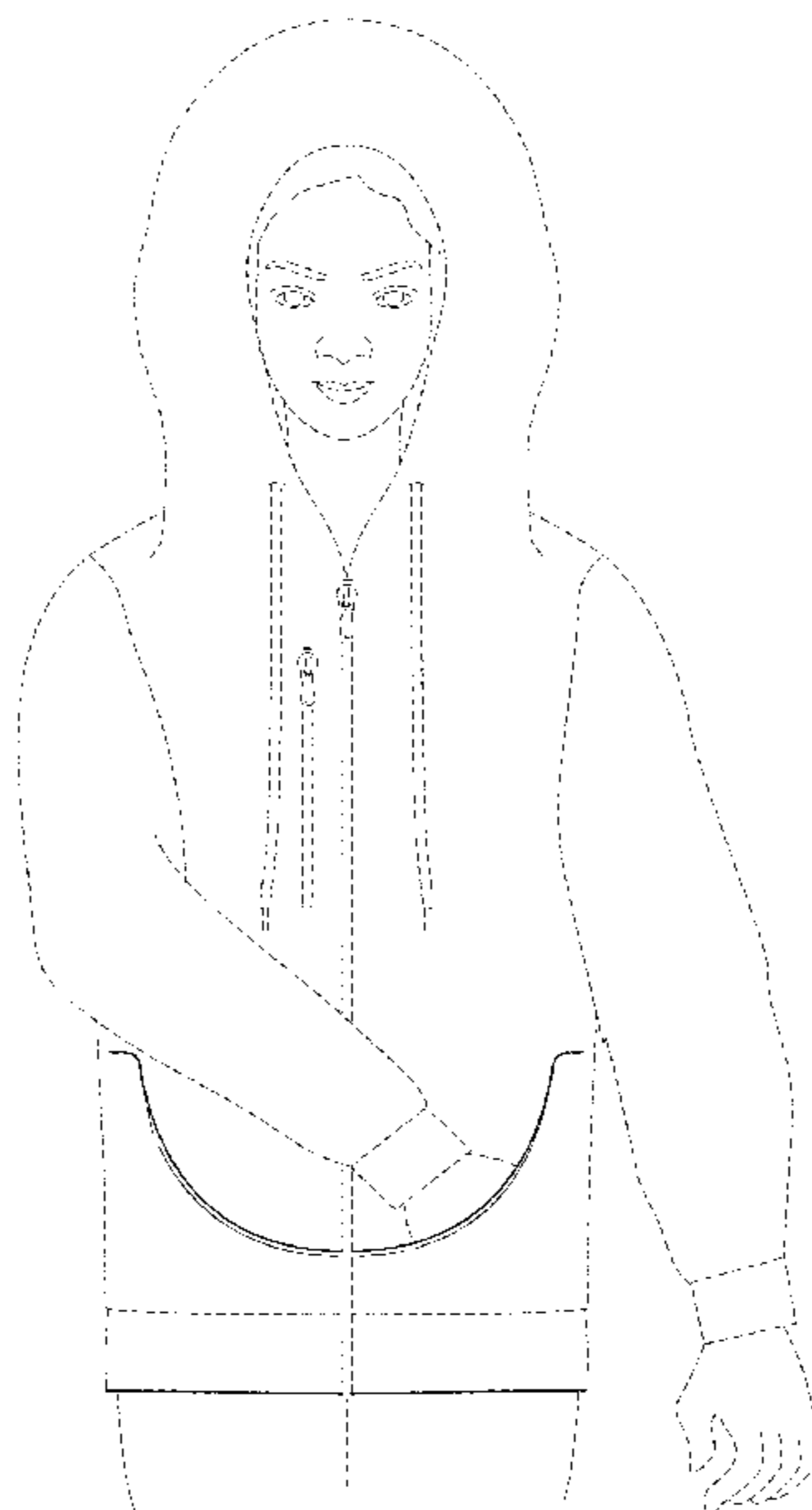
FIG. 9 is a front elevation view of the upper torso garment; and,

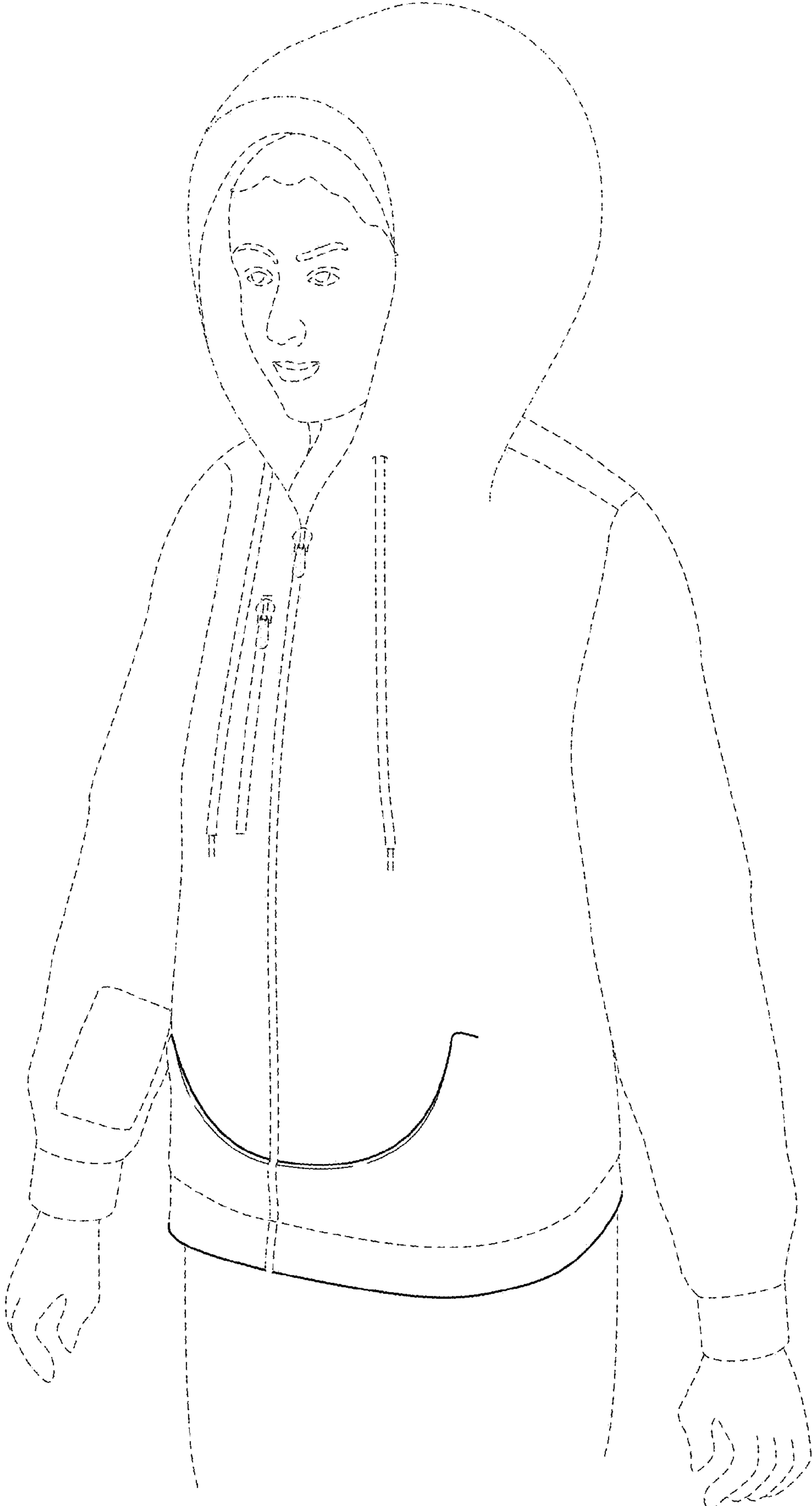

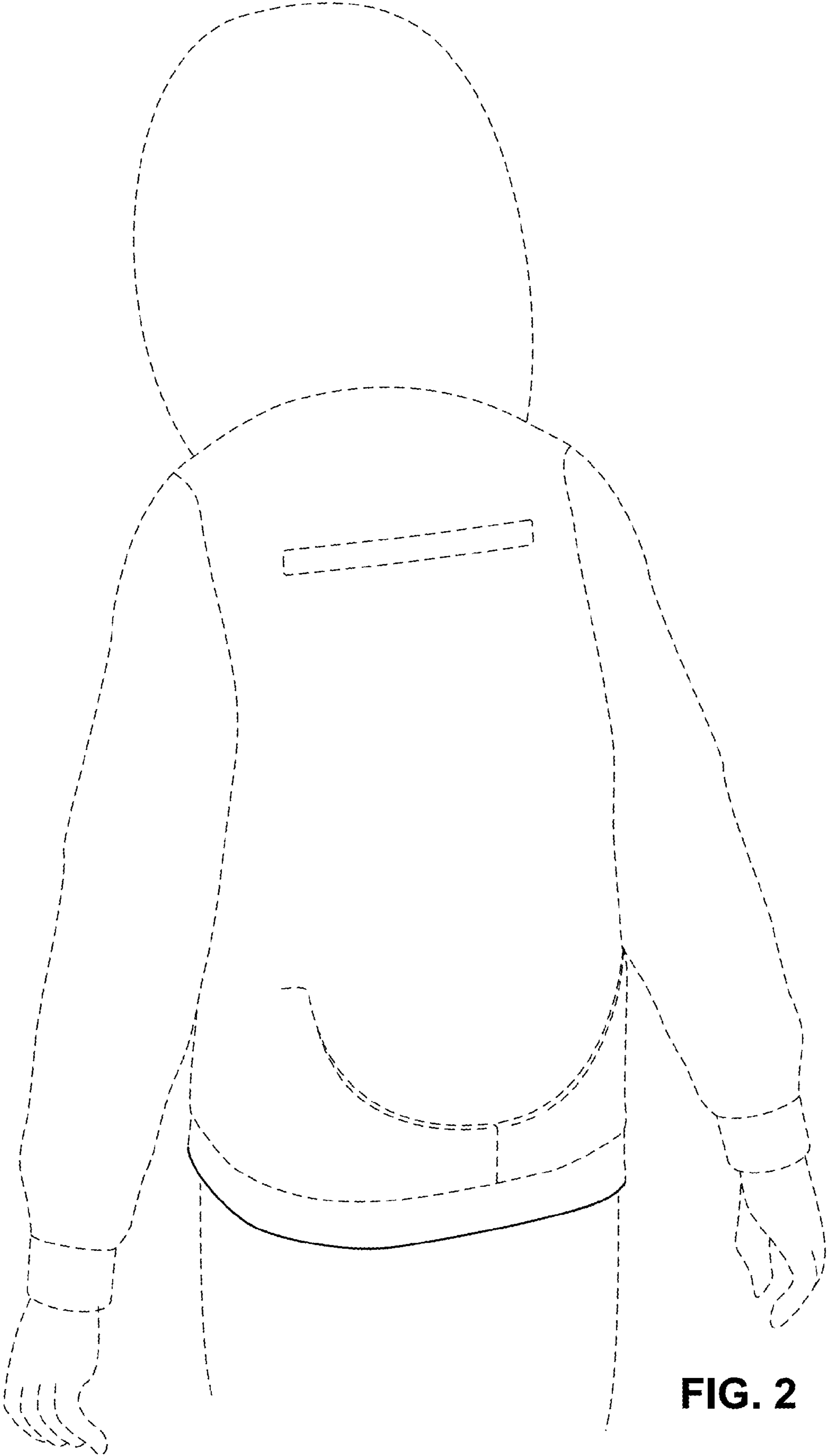

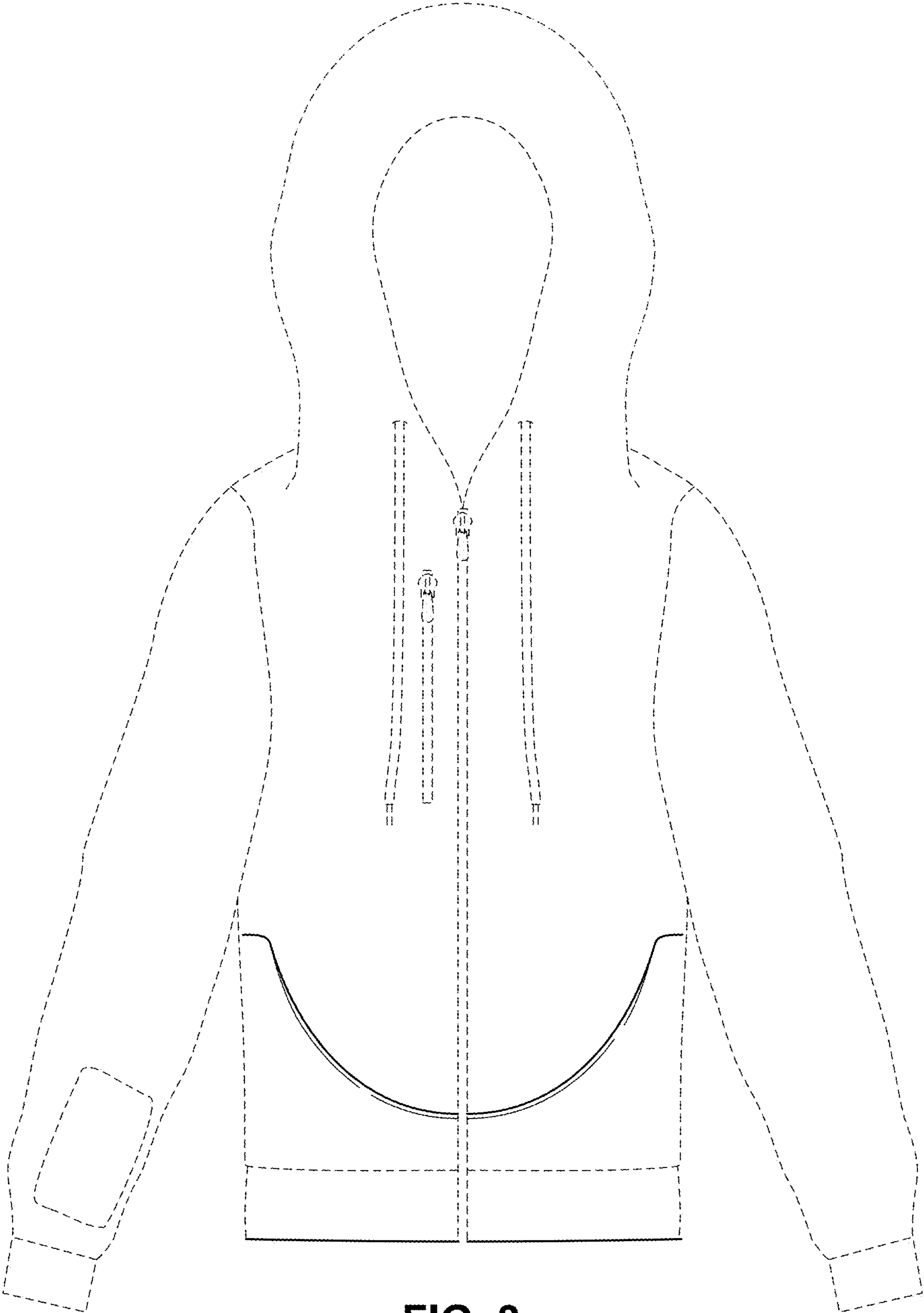

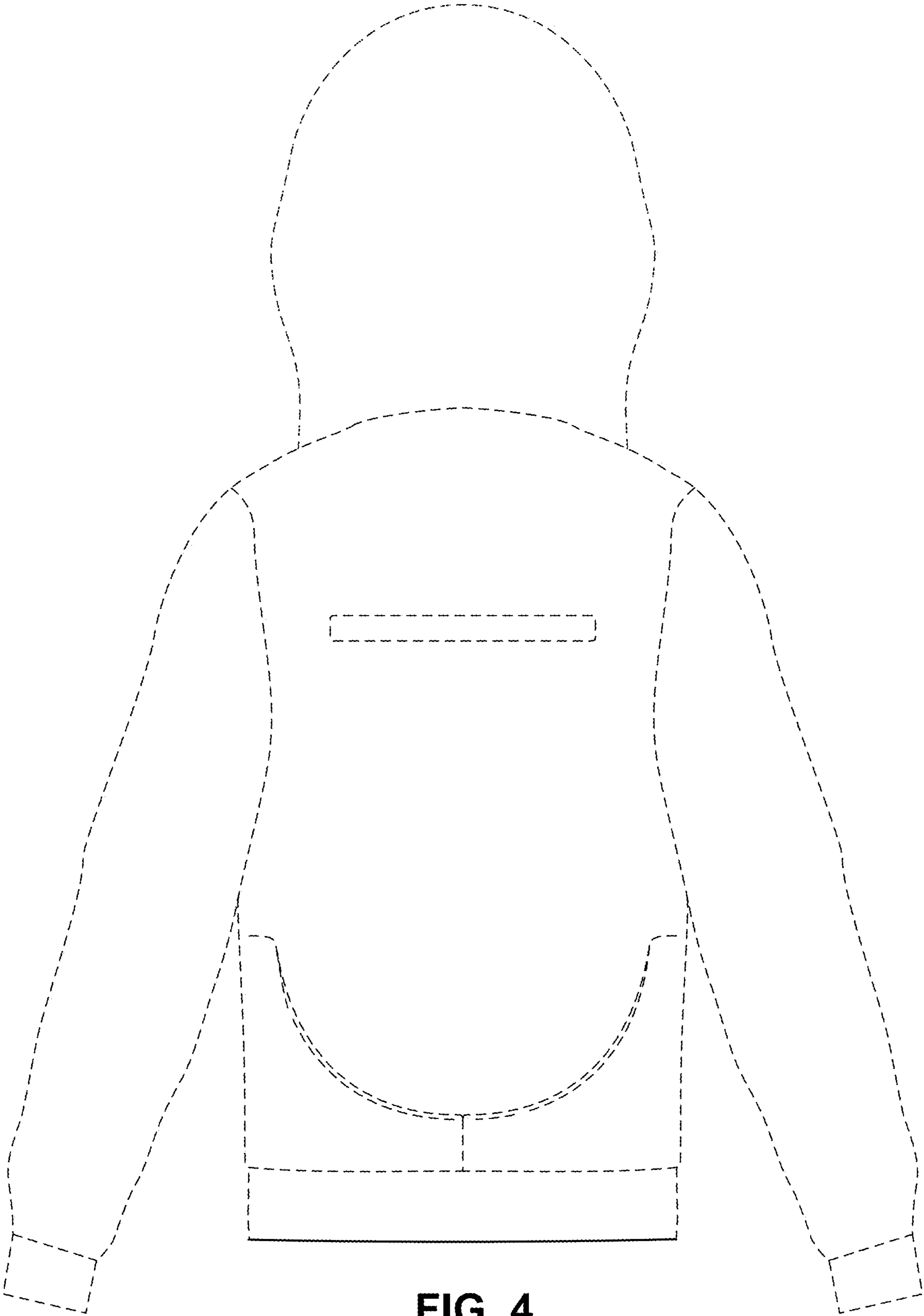

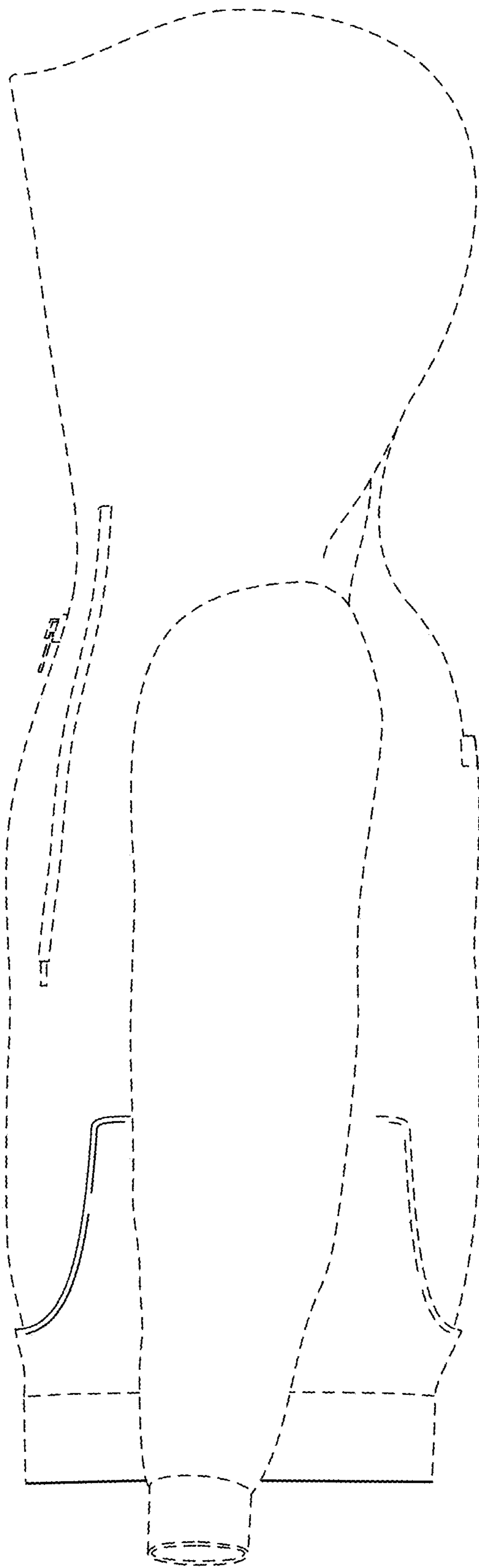

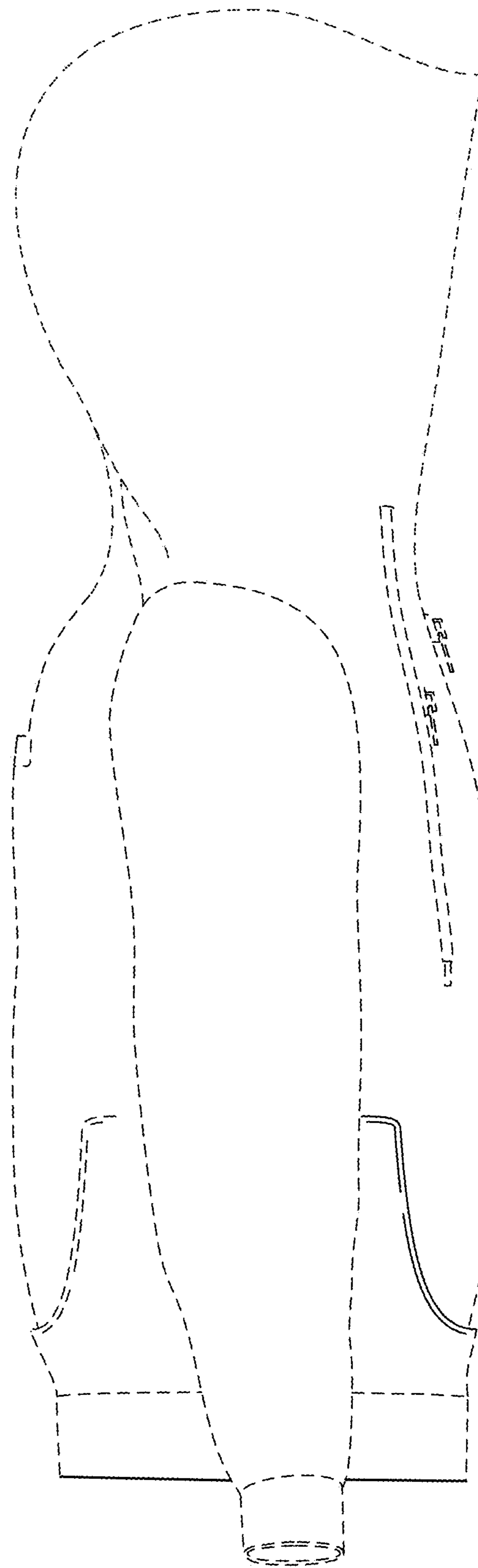

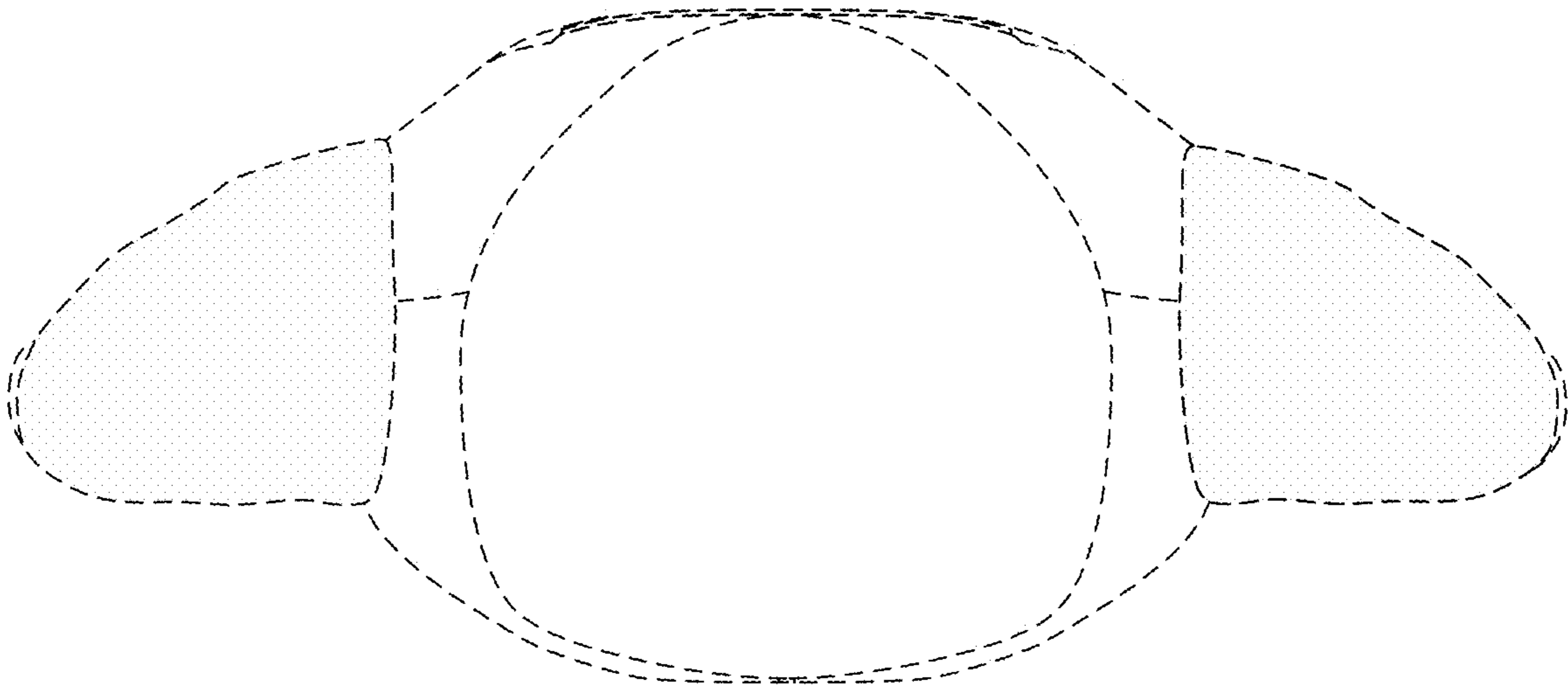

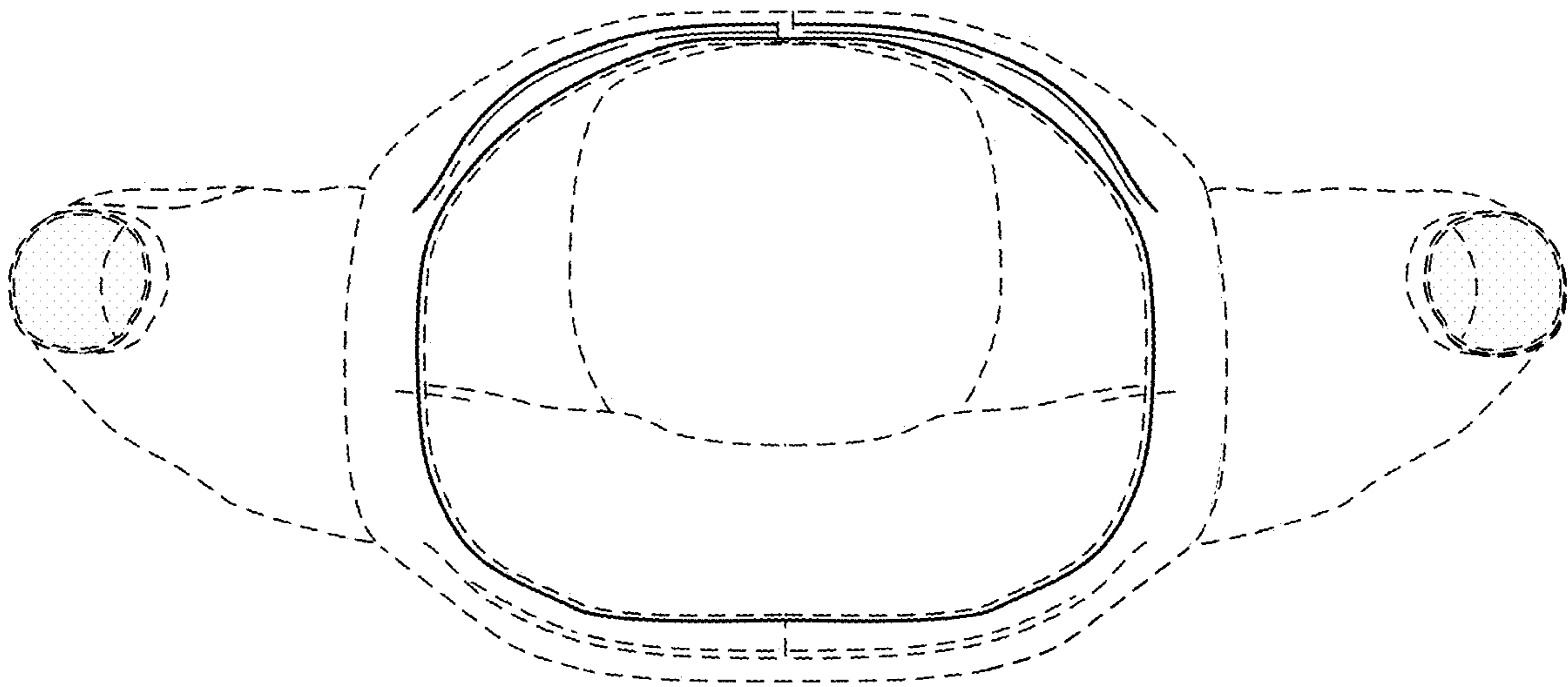

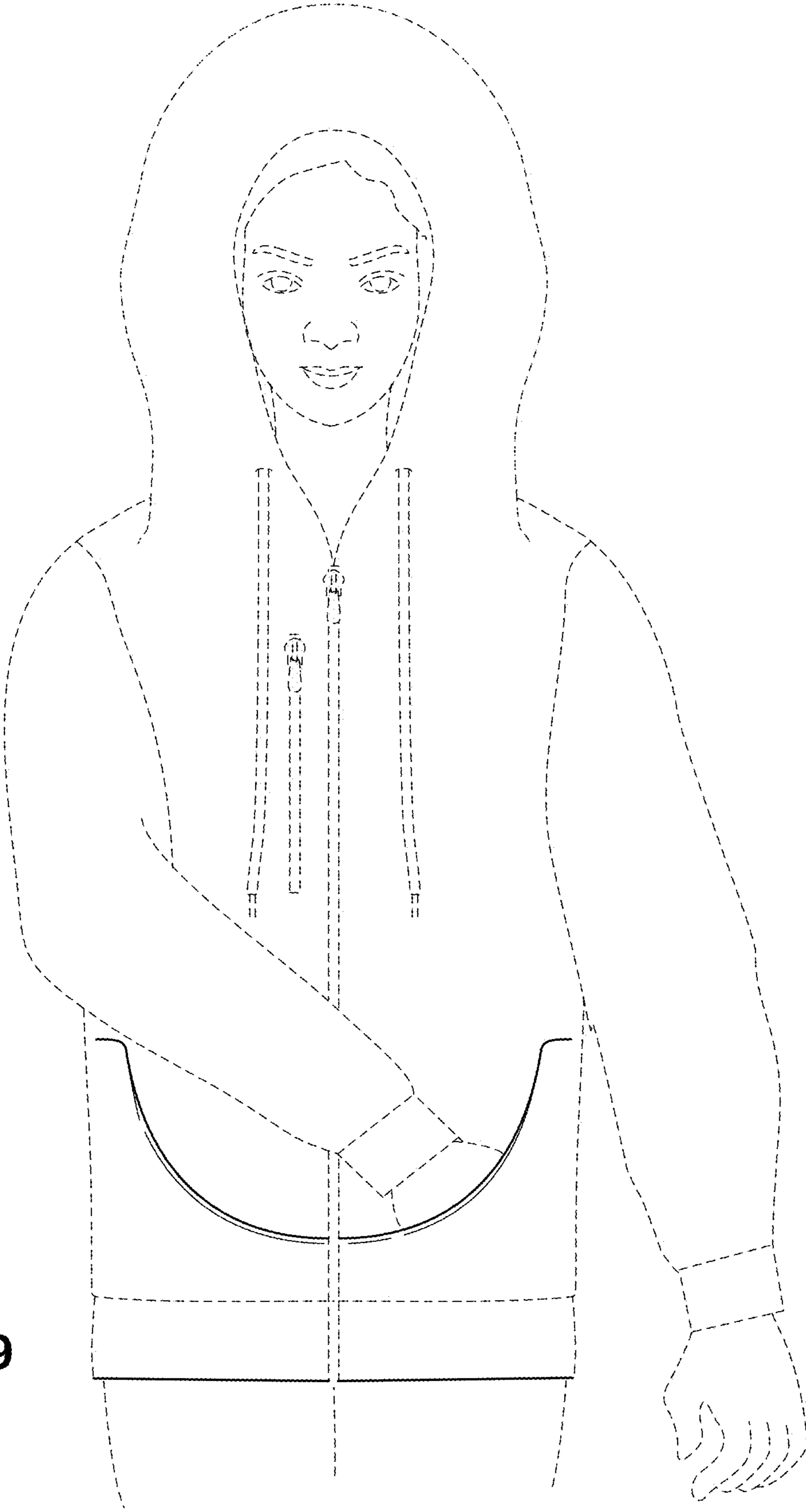

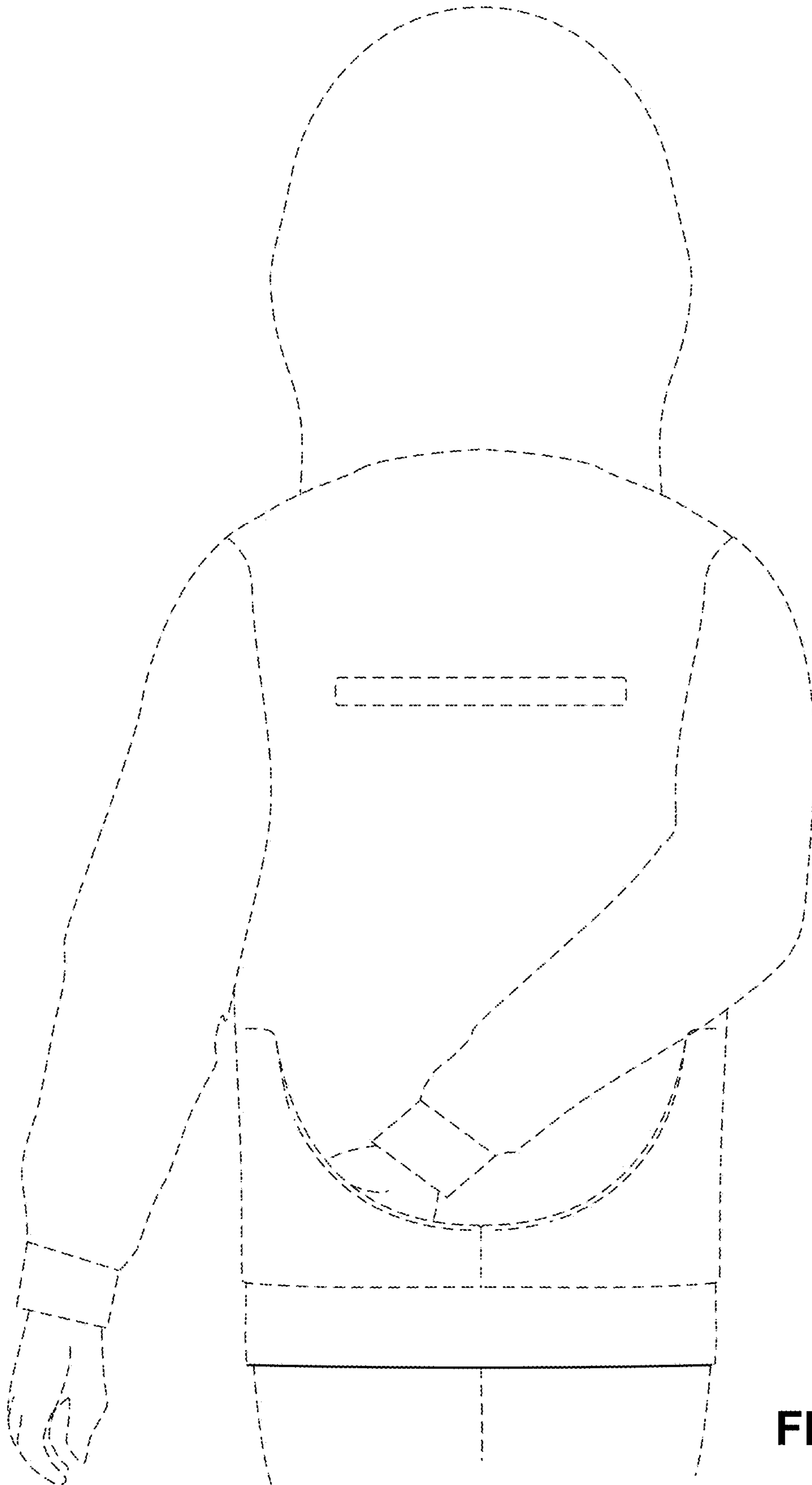
