**DESCRIPTION**

FIG. 1 is a perspective top front left view of a pair of pants, showing my new design;

FIG. 2 is a front elevation view thereof;

FIG. 4 is a right elevation view thereof;

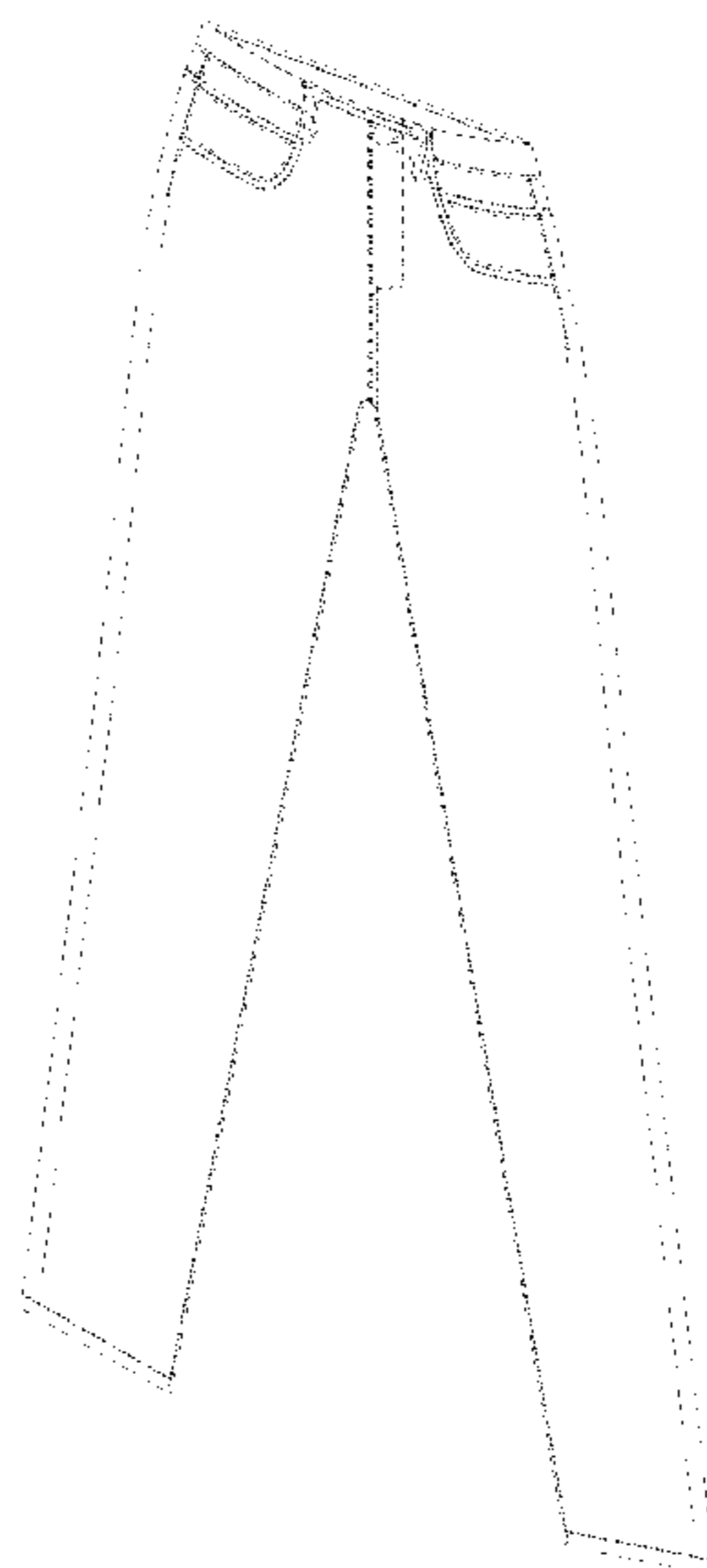
FIG. 5 is a left elevation view thereof;

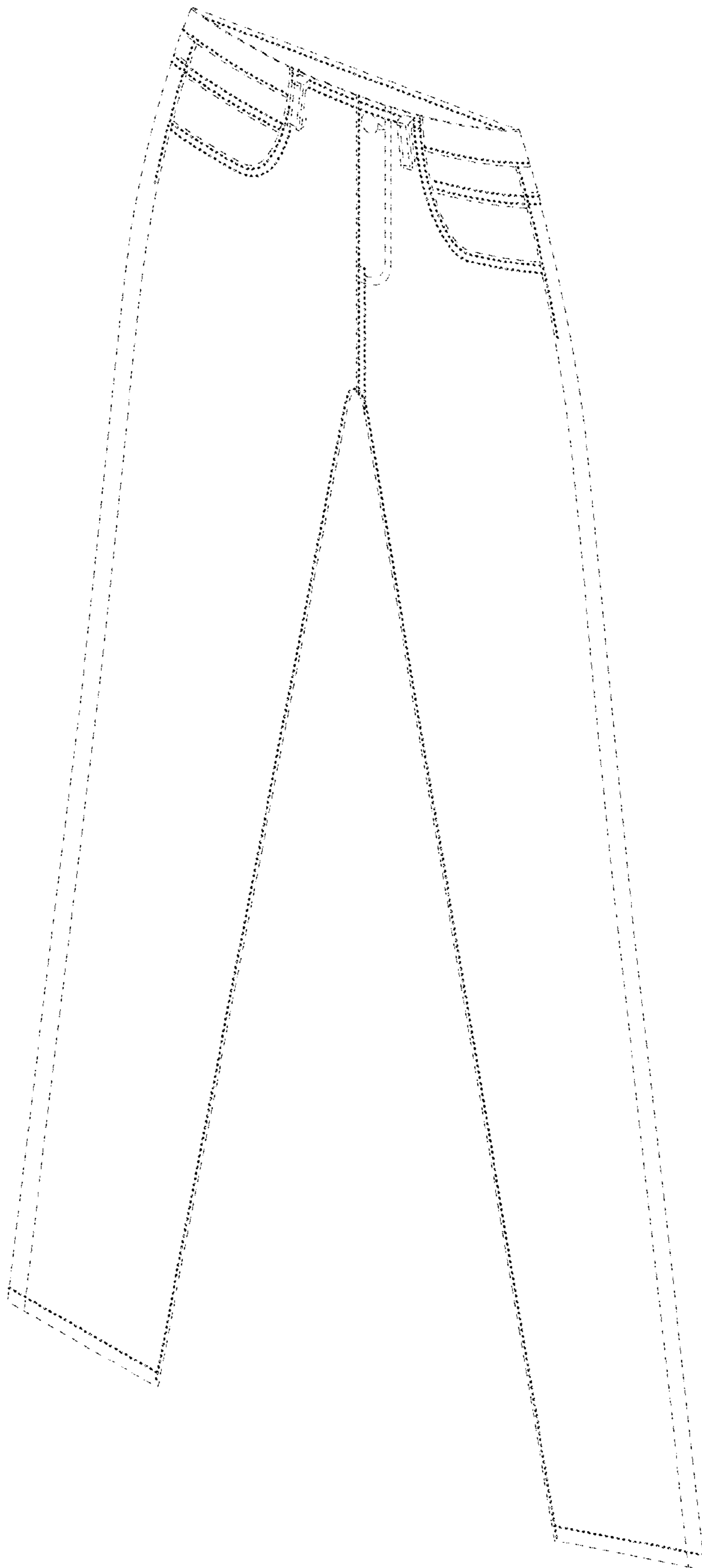

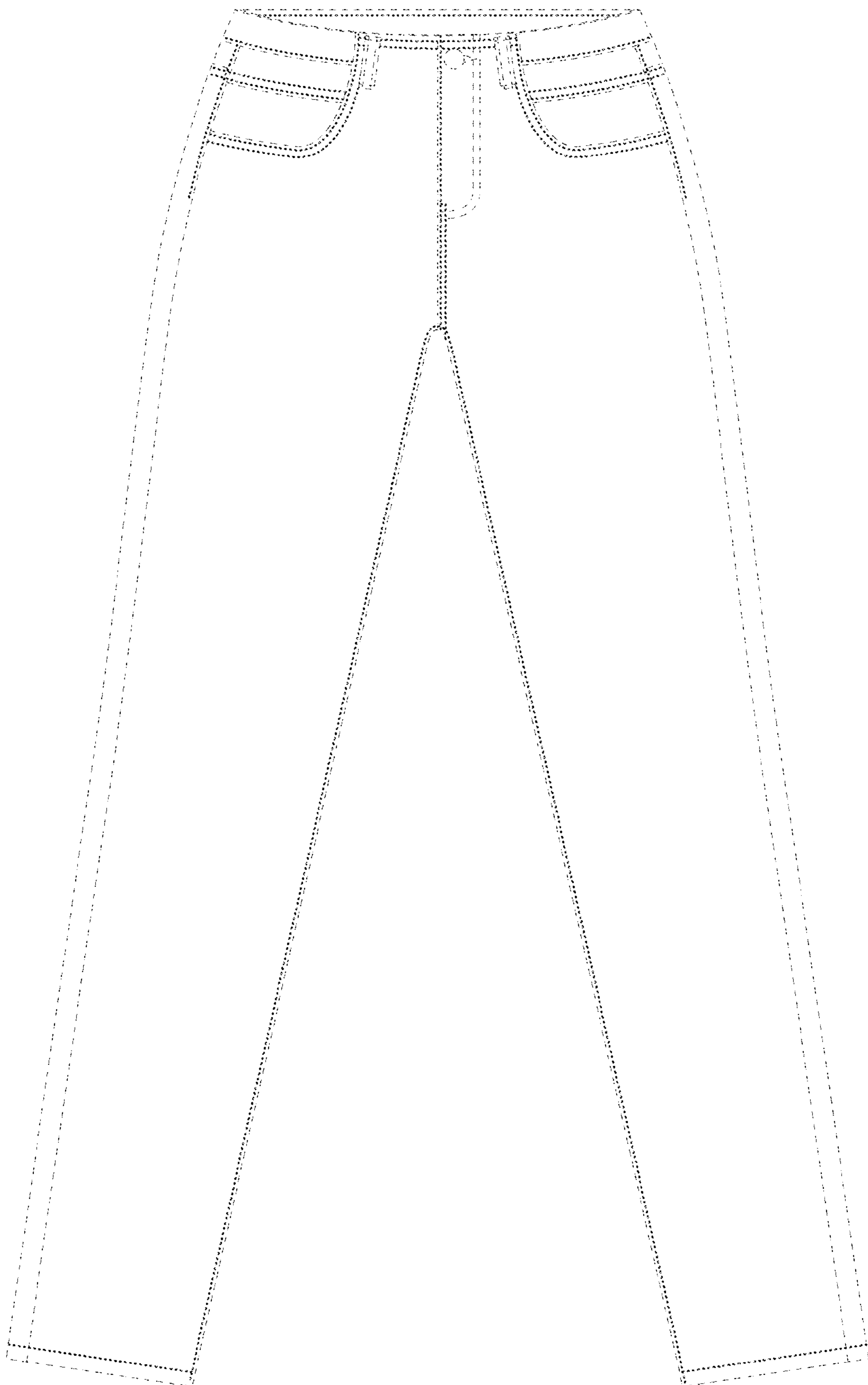

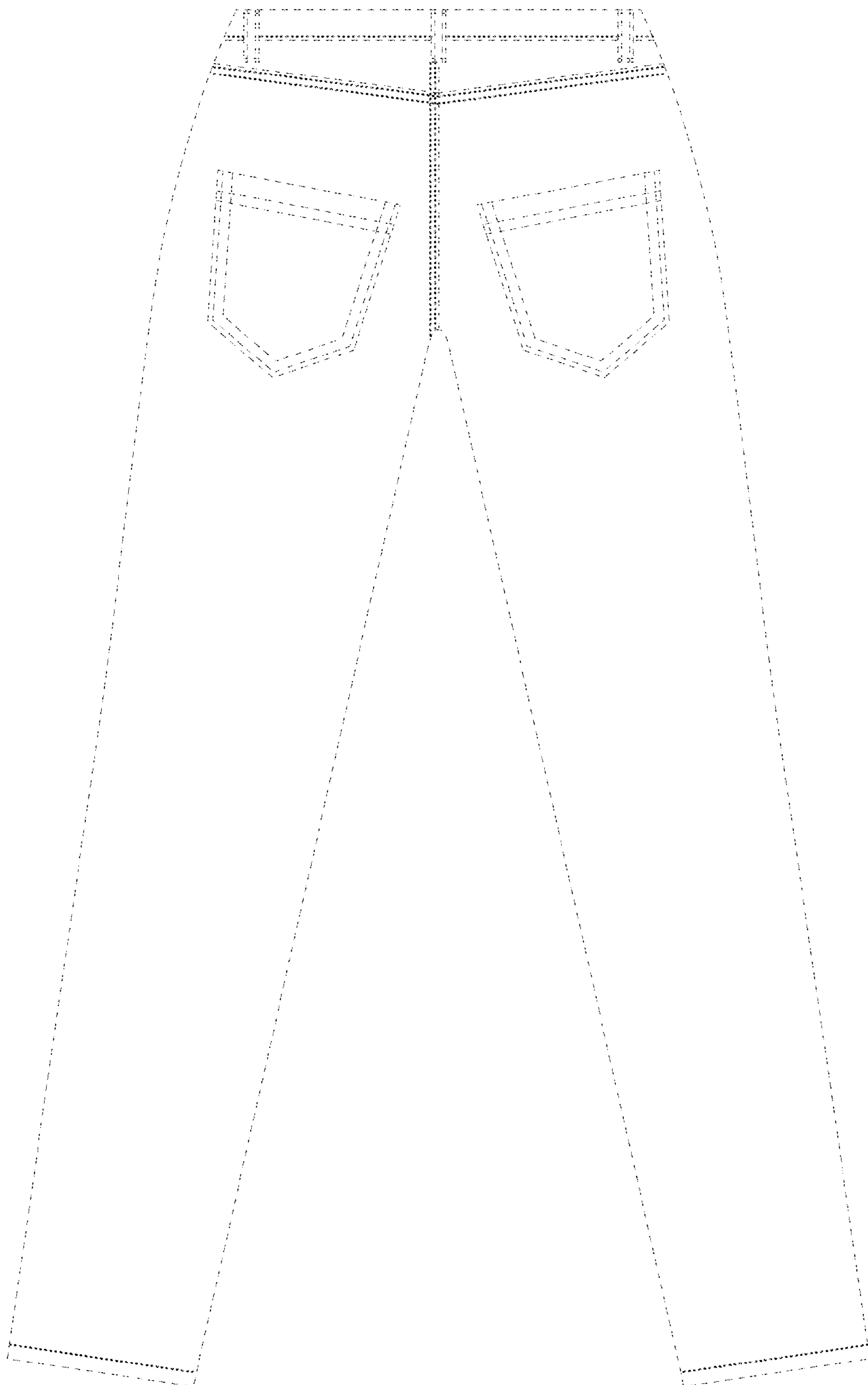

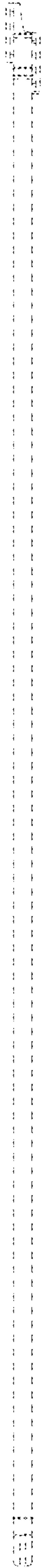

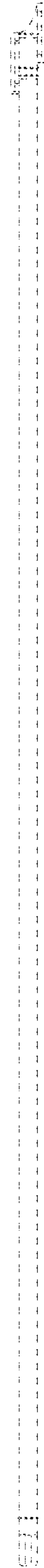

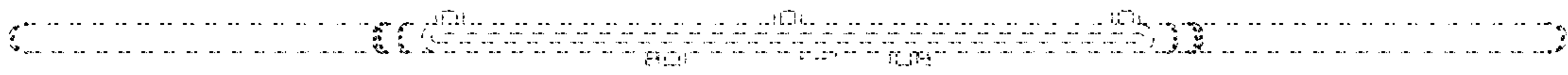

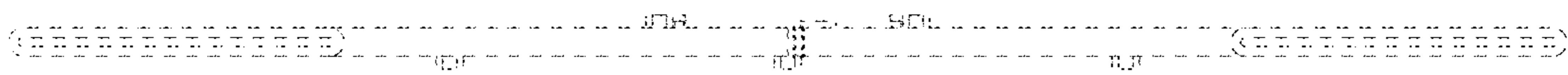
