(57) **CLAIM**

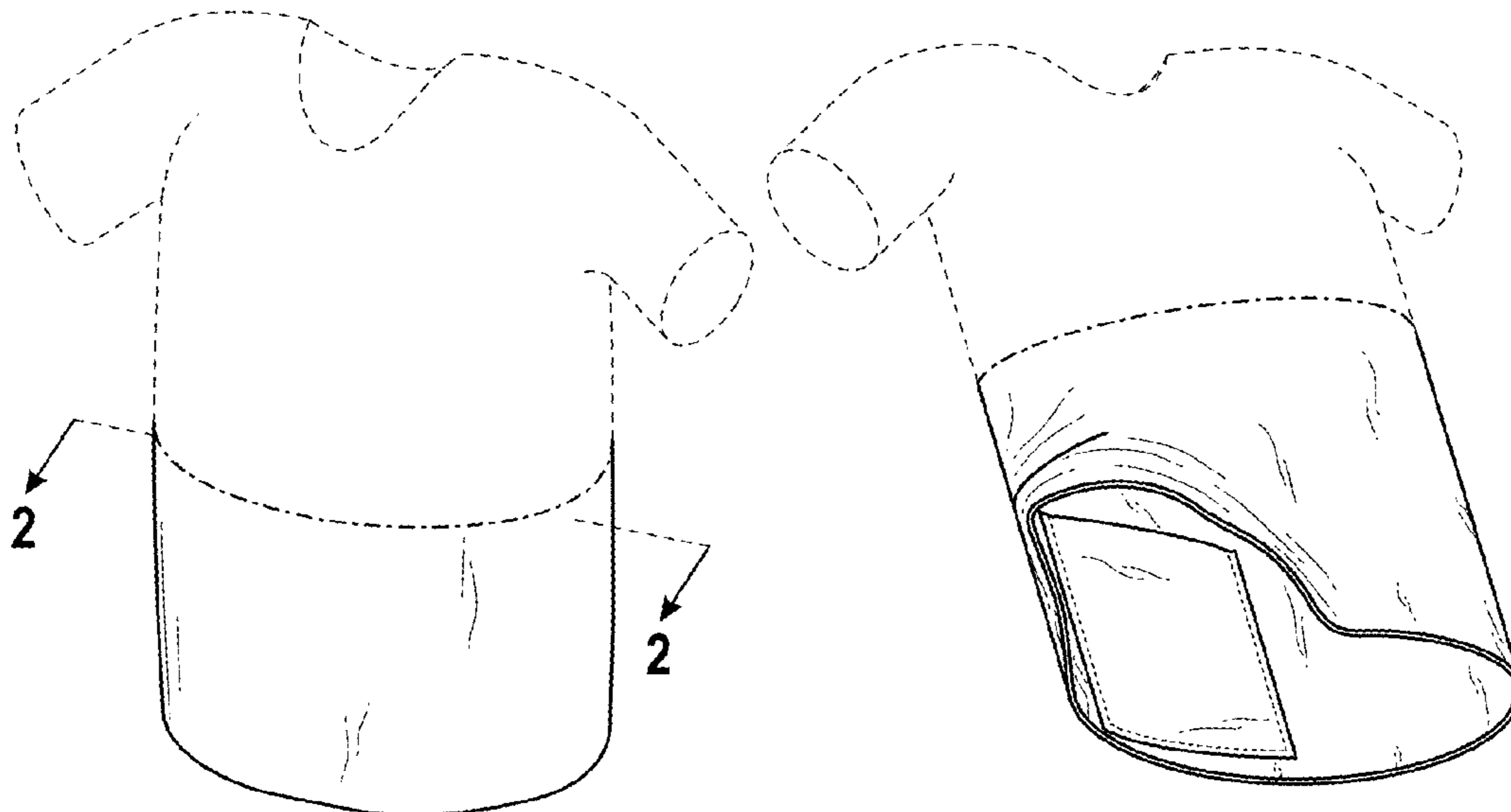
The ornamental design for a garment with pouch, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a design for a garment with pouch;  
FIG. 2 is a cross-sectional view thereof from the front perspective view;  
FIG. 3 is a rear perspective view thereof that illustrates the back of the garment lifted in order to show the pouch on the inside on the front of the garment;  
FIG. 4 is an additional rear perspective view thereof that illustrates the back of the garment lifted in order to show the pouch on the inside on the front of the garment;  
FIG. 5 is a front view thereof;  
FIG. 6 is a rear view thereof;  
FIG. 7 is a left-side view thereof;  
FIG. 8 is a right-side view thereof;  
FIG. 9 is a top view thereof; and,  
FIG. 10 is a bottom view thereof.

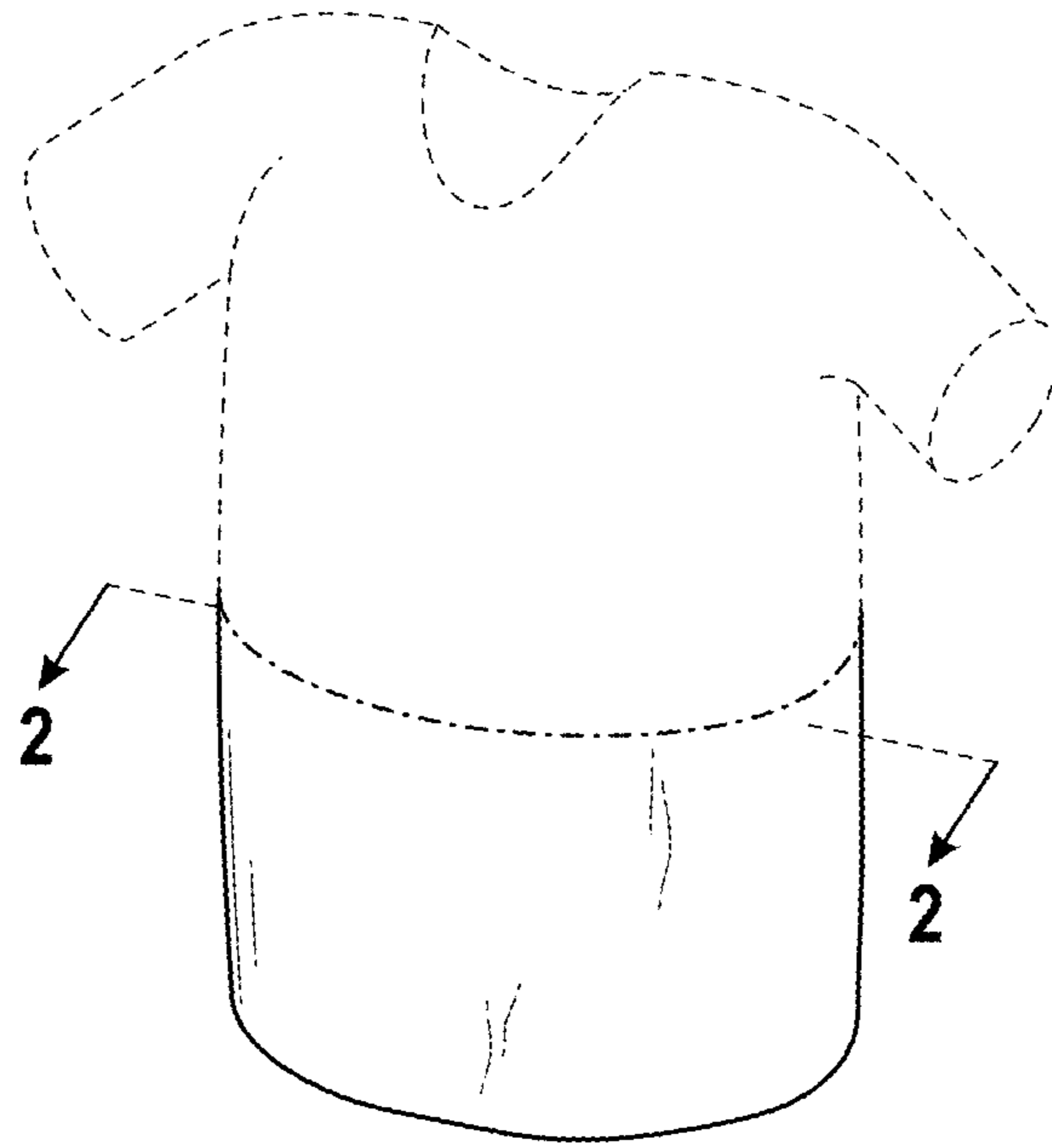

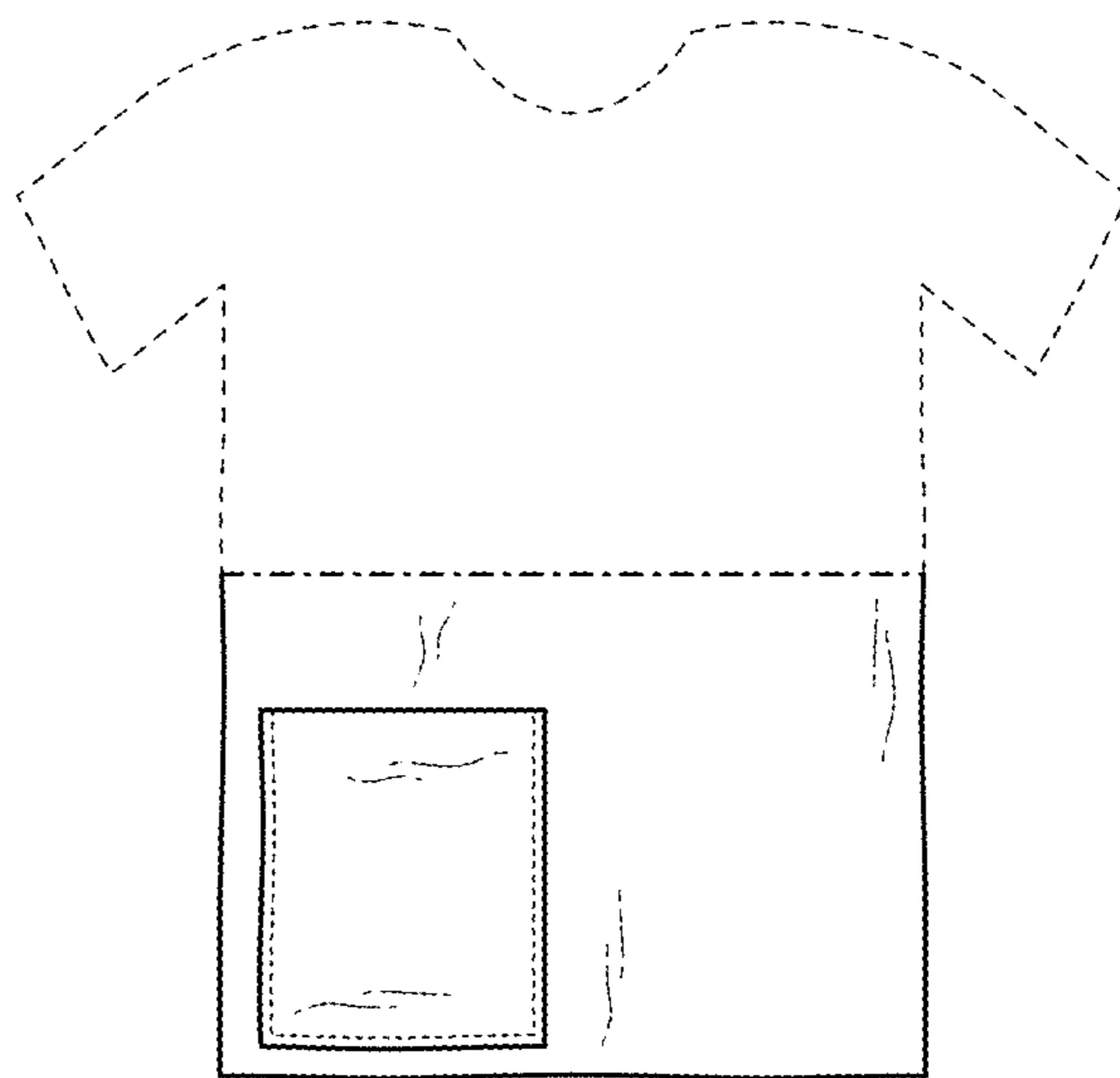

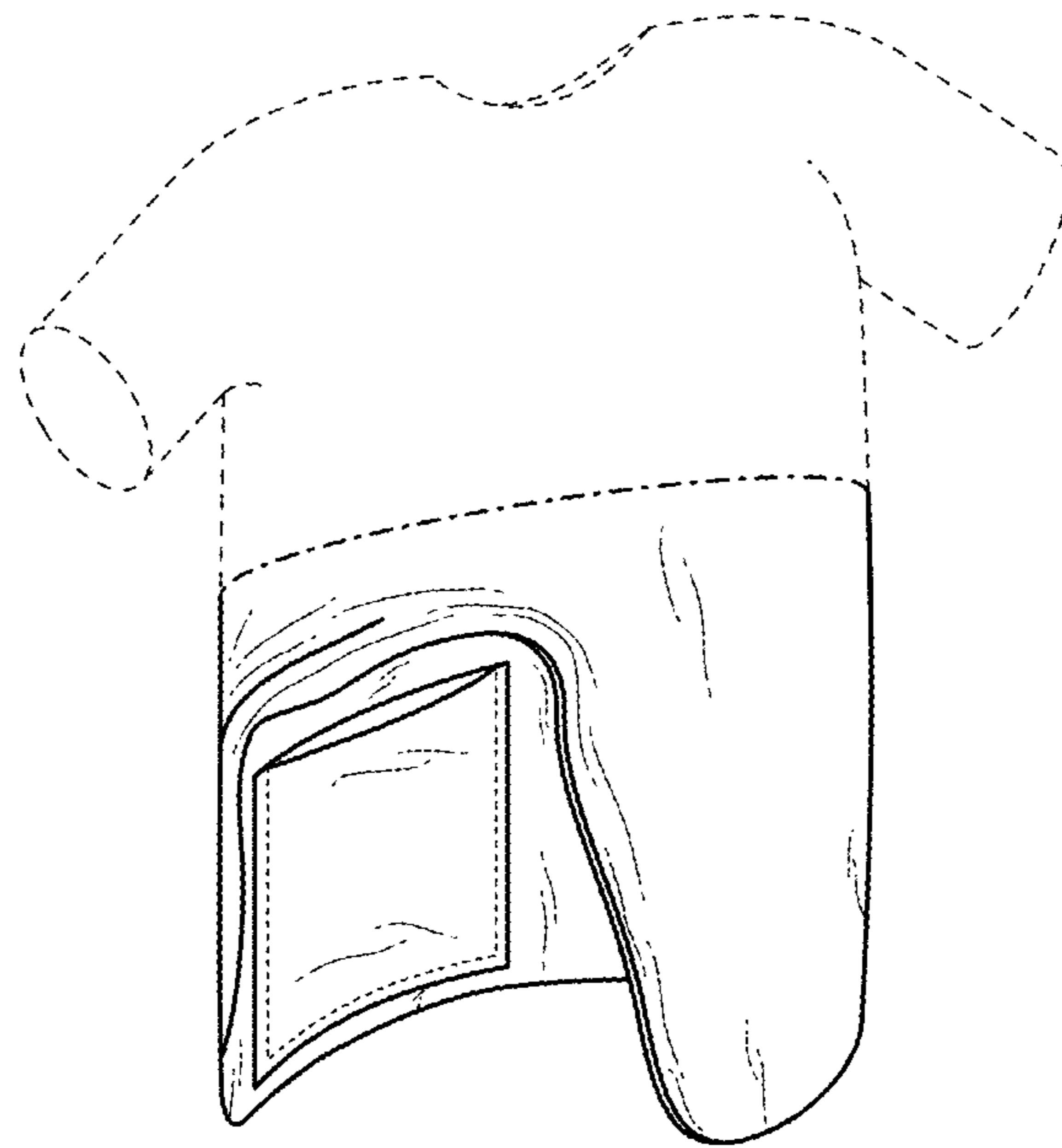

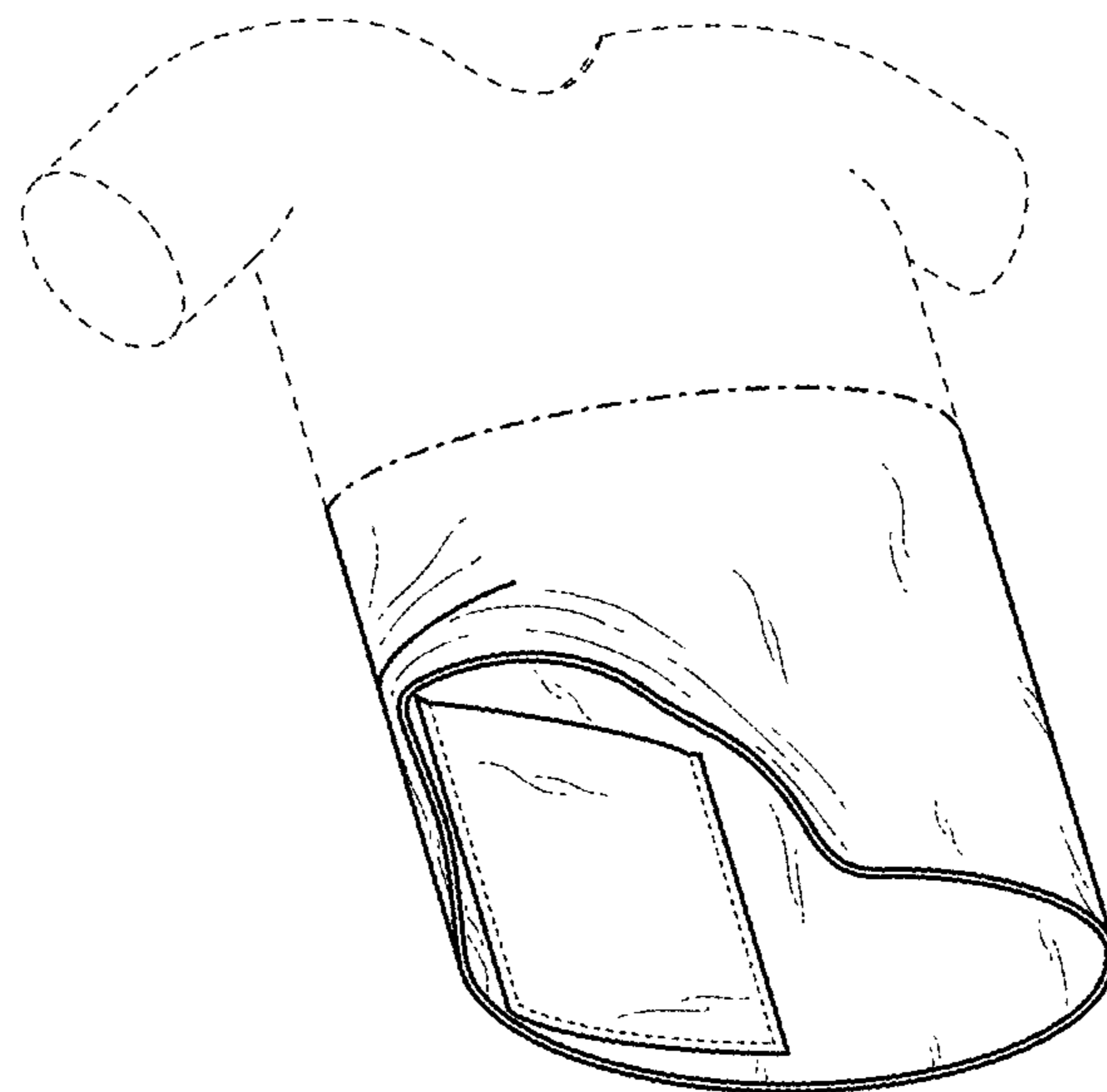

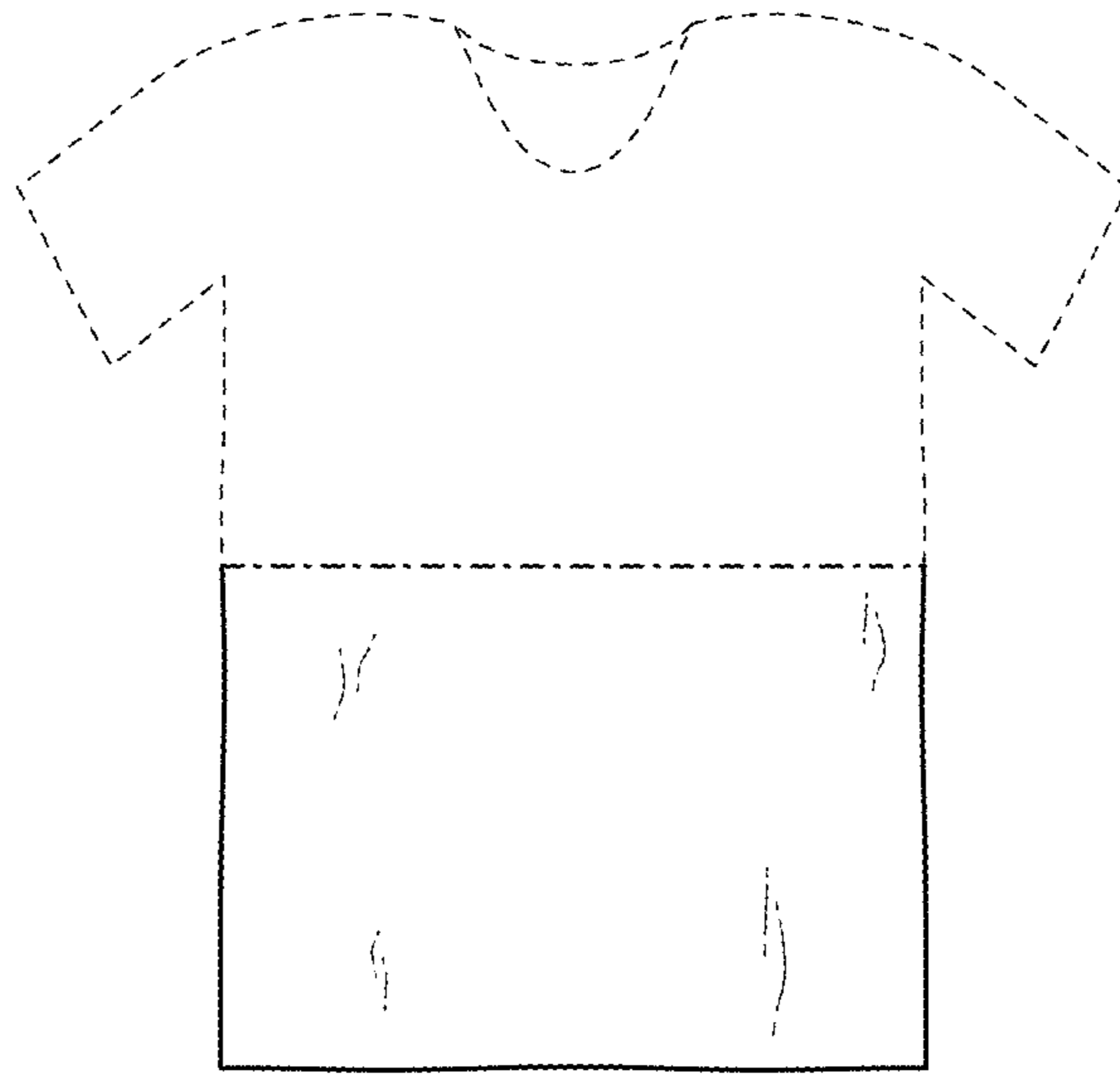

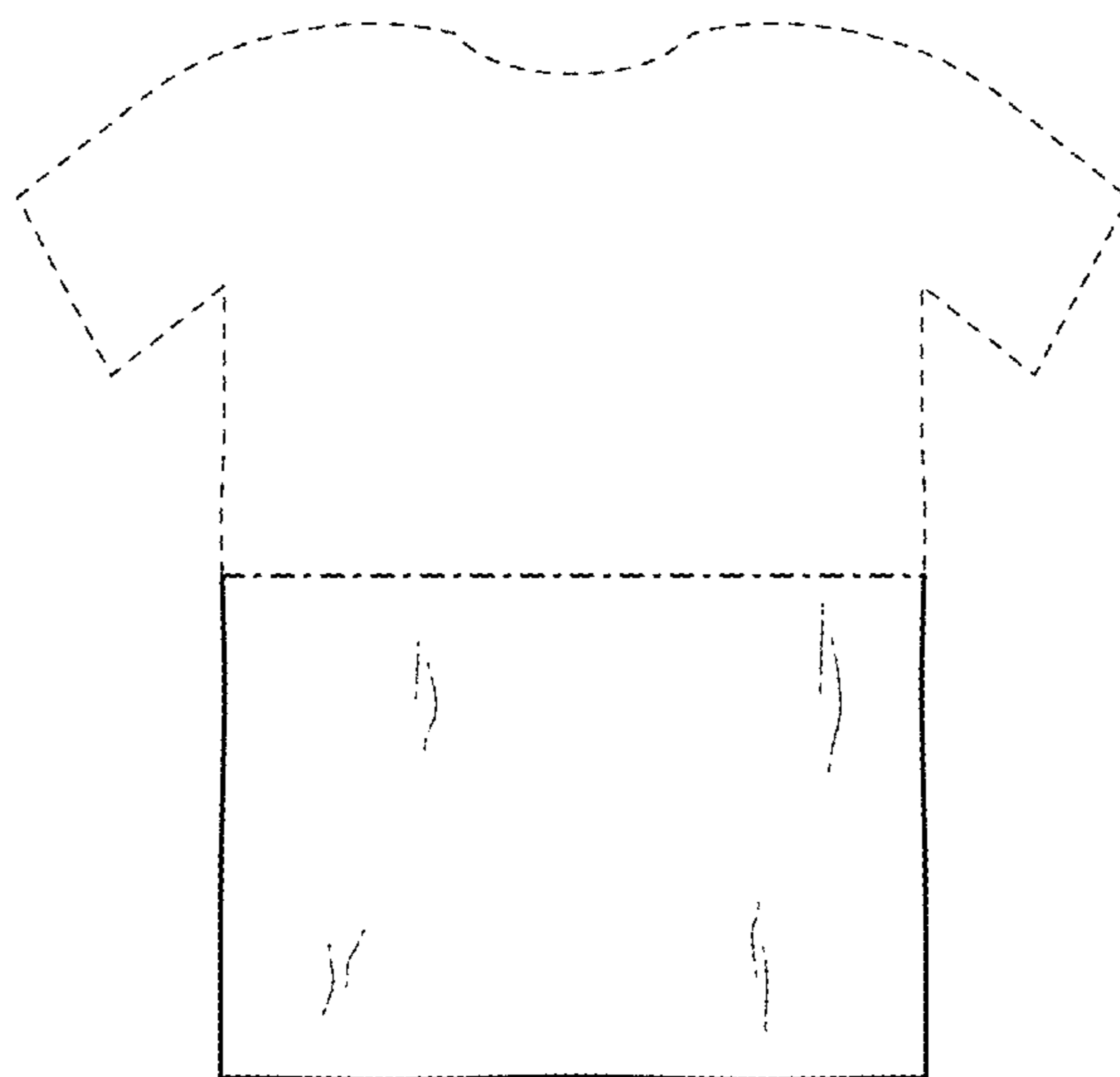

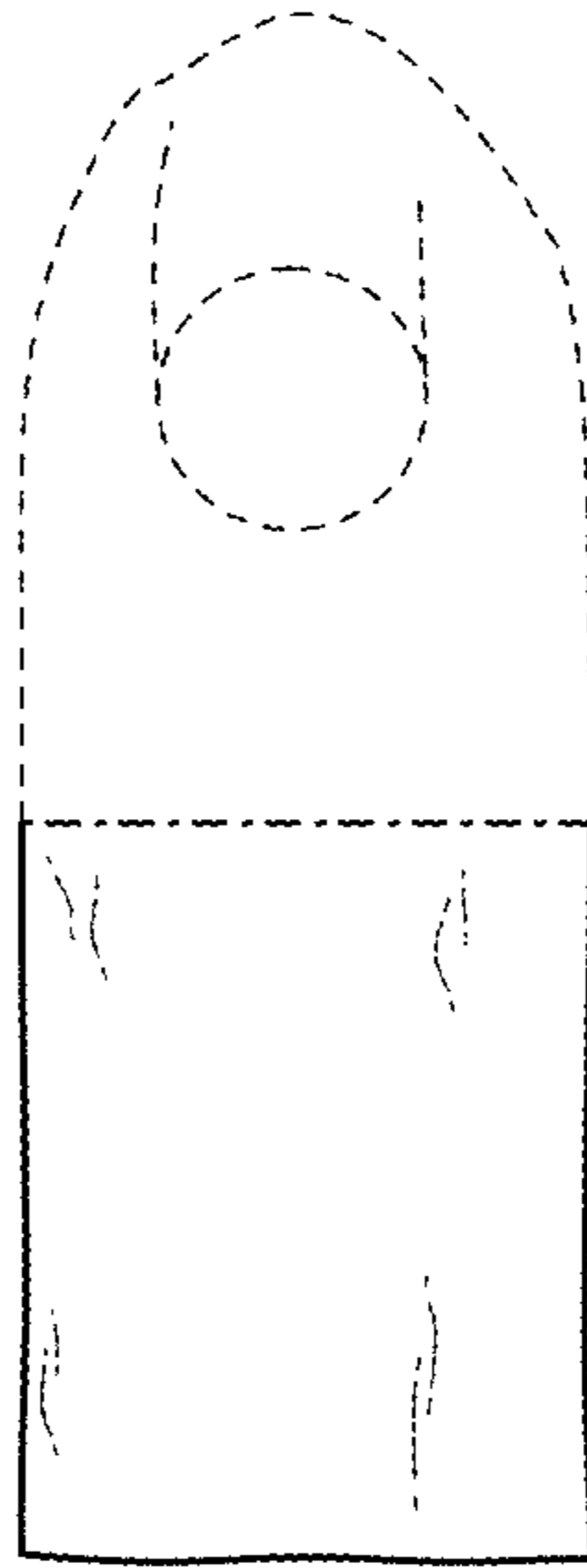

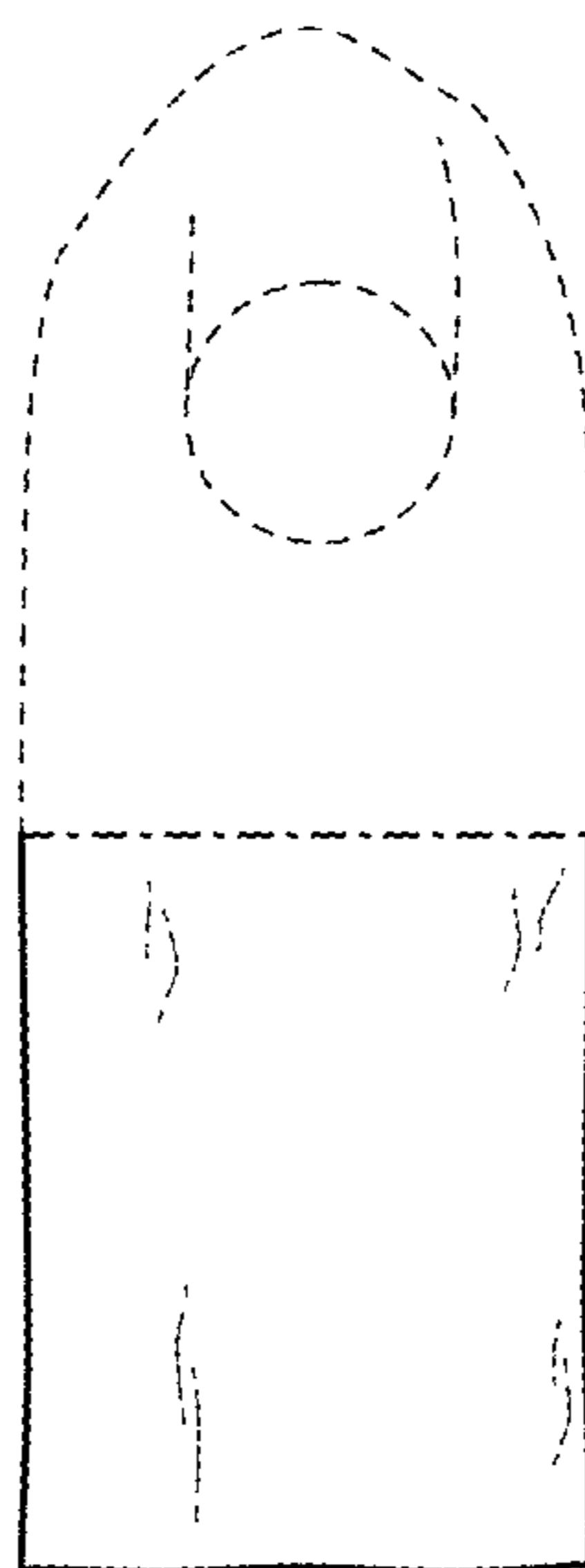
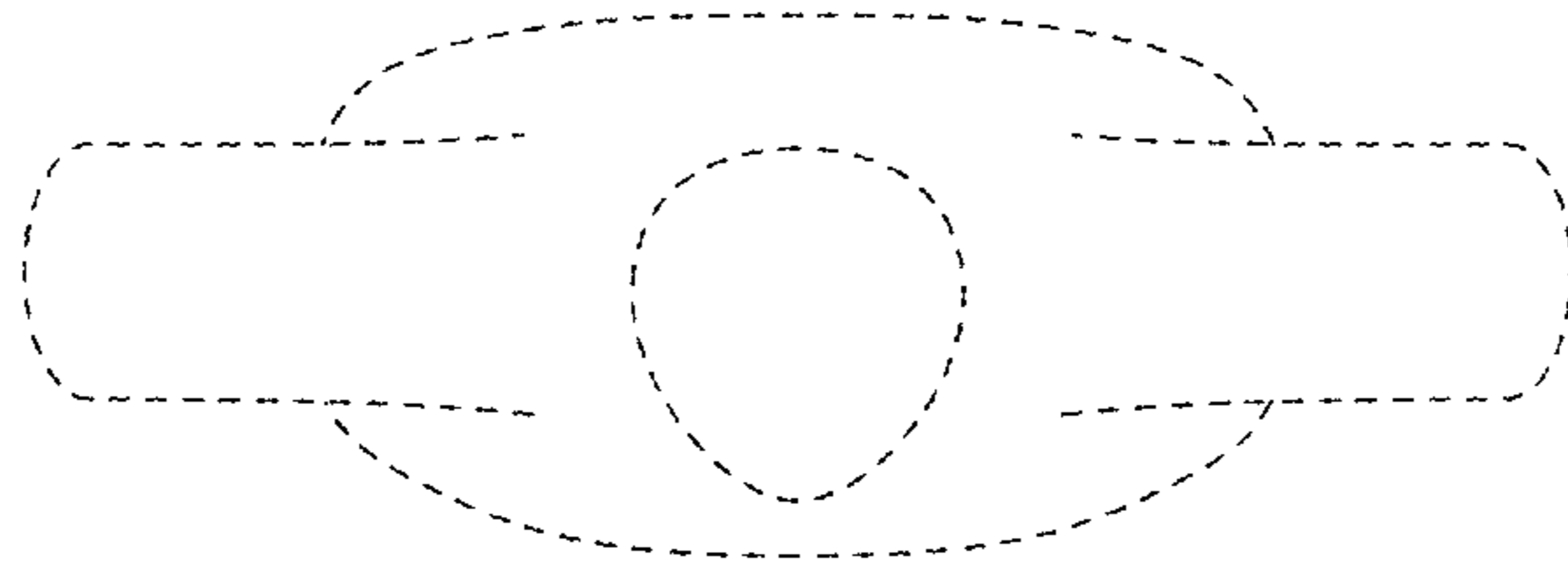
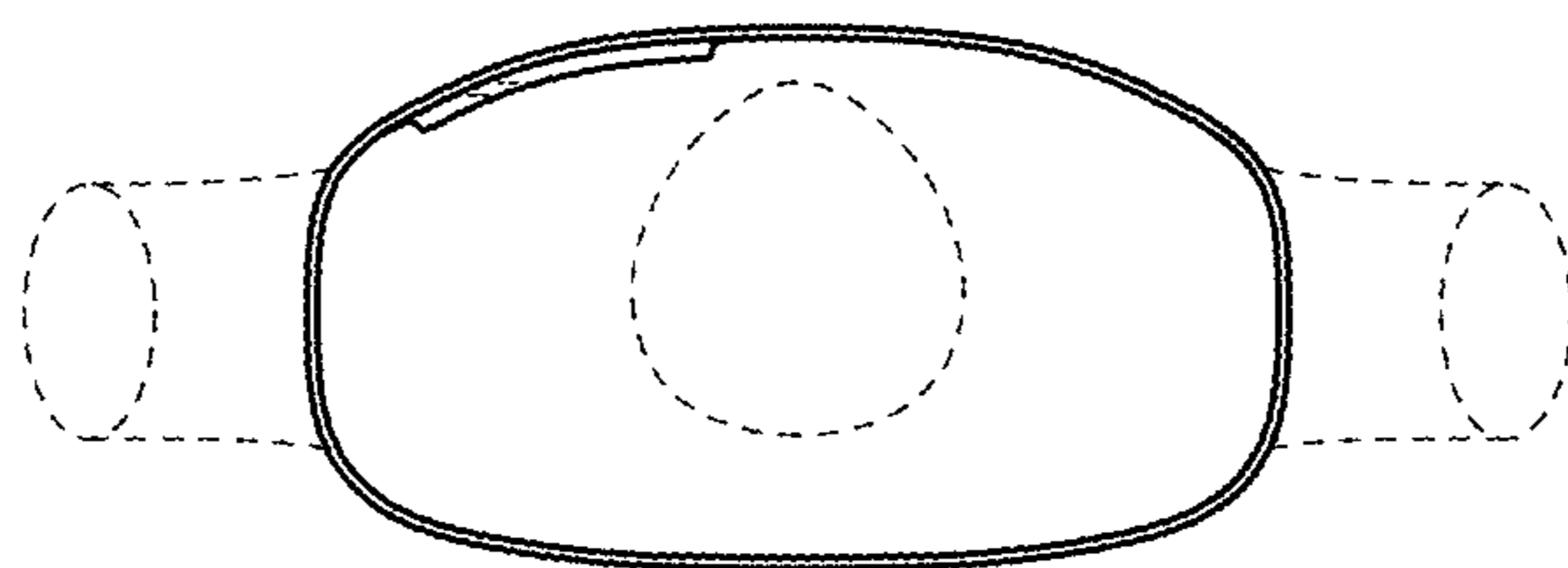
