(57) **CLAIM**

The ornamental design for a surface pattern embodied in a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a surface pattern embodied in a shoe showing my new design; and, FIG. 2 is a right side elevational view thereof; the left side elevational view is a mirror image of the right side. The bottom plan view is flat and unornamented so it is not shown and forms no part of the claimed design. The broken lines depict portions of the shoe that form no part of the claim.

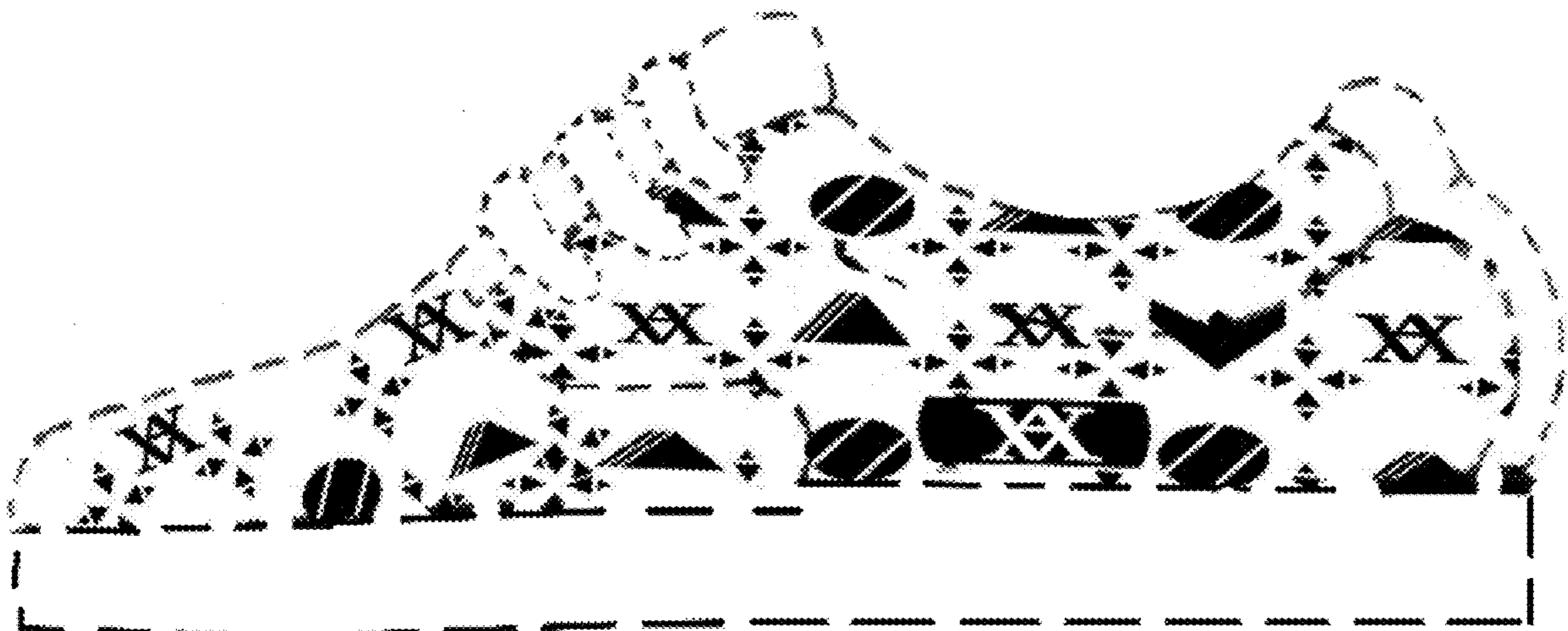

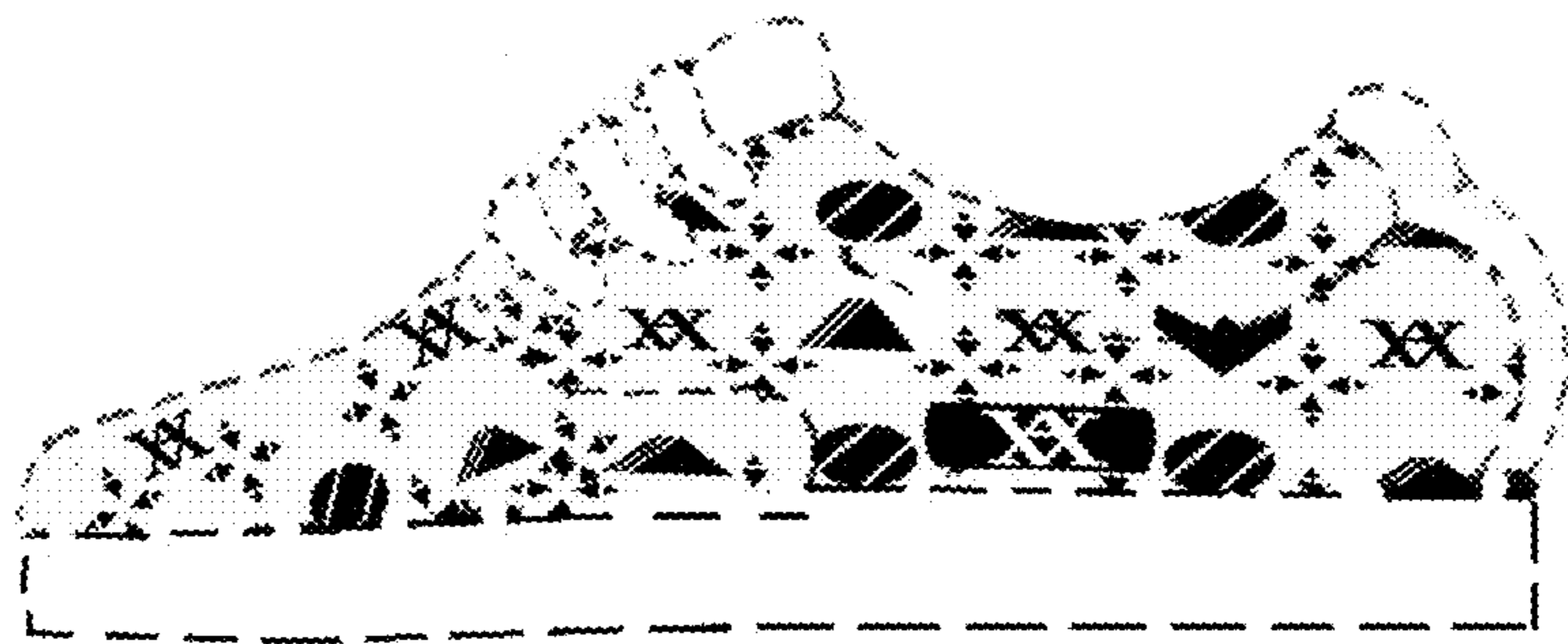
