(57) **CLAIM**

The ornamental design for a footwear midsole covering, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a footwear midsole covering in accordance with the present invention;
FIG. 2 is another front perspective view of the footwear midsole covering in FIG. 1;

FIG. 3 is a front enlarged view of the footwear midsole covering in FIG. 1;

FIG. 4 is a rear perspective view of the footwear midsole covering in FIG. 1;

FIG. 5 is a rear enlarged view of the footwear midsole covering in FIG. 1;

FIG. 6 is a right-side perspective view of the footwear midsole covering in FIG. 1;

FIG. 7 is a right-side view of the footwear midsole covering in FIG. 1;

FIG. 8 is a left-side perspective view of the footwear midsole covering in FIG. 1;

FIG. 9 is a left-side view of the footwear midsole covering in FIG. 1;

FIG. 10 is a top view of the footwear midsole covering in FIG. 1;

FIG. 11 is a bottom view of the footwear midsole covering in FIG. 1;

FIG. 12 is a left-side perspective view of the footwear midsole covering of FIG. 1 coupled to an exemplary piece of footwear;

FIG. 13 is a front perspective view of the footwear midsole covering and exemplary footwear of FIG. 12;

FIG. 14 is a front enlarged view of the footwear midsole covering and exemplary footwear of FIG. 12;

FIG. 15 is a rear enlarged view of the footwear midsole covering and exemplary footwear of FIG. 12;

FIG. 16 is a right-side perspective view of the footwear midsole covering and exemplary footwear of FIG. 12;

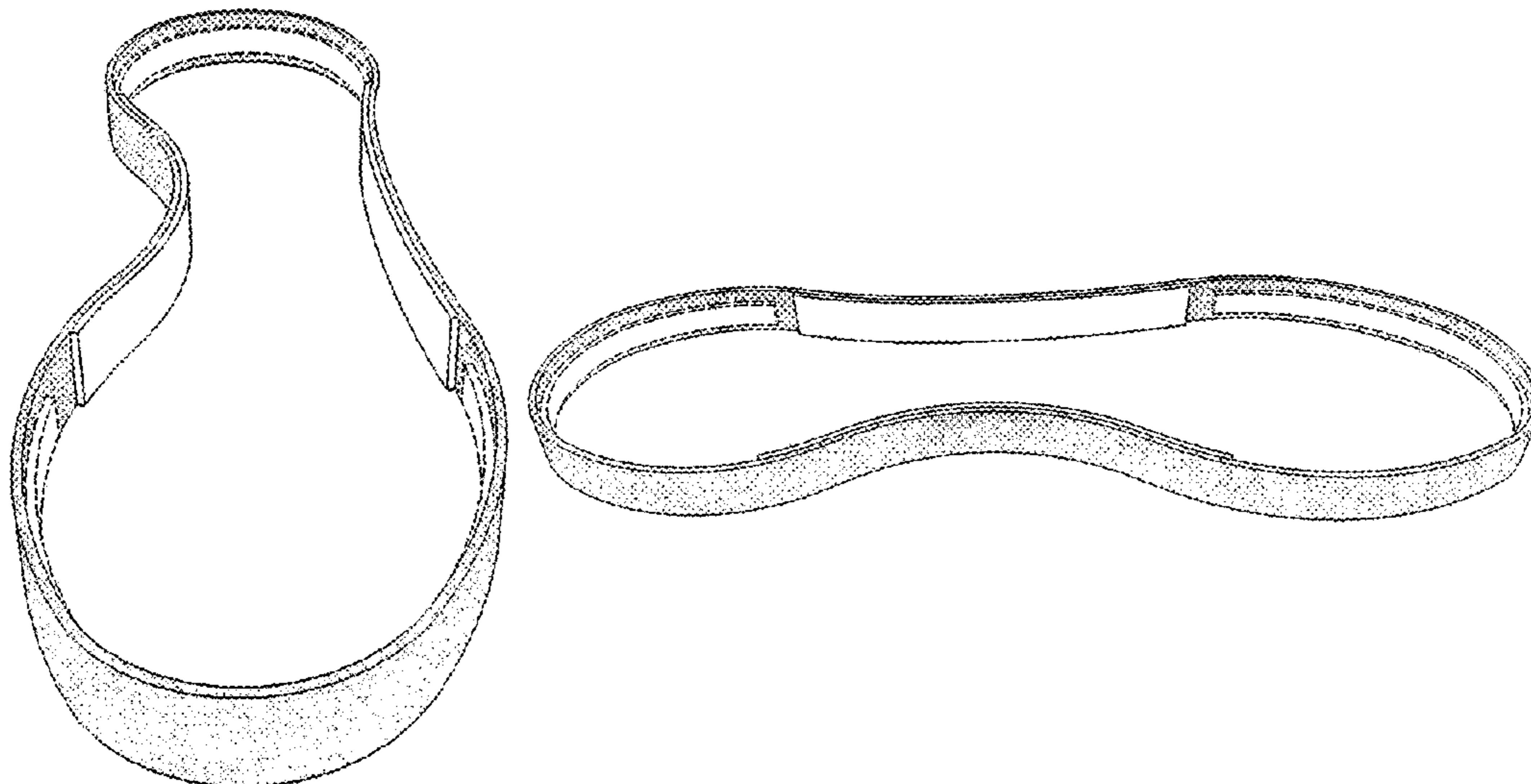
FIG. 17 is right-side perspective view of the footwear midsole covering and exemplary footwear of FIG. 12;

The broken lines and structures they depict form no part of the claimed design.

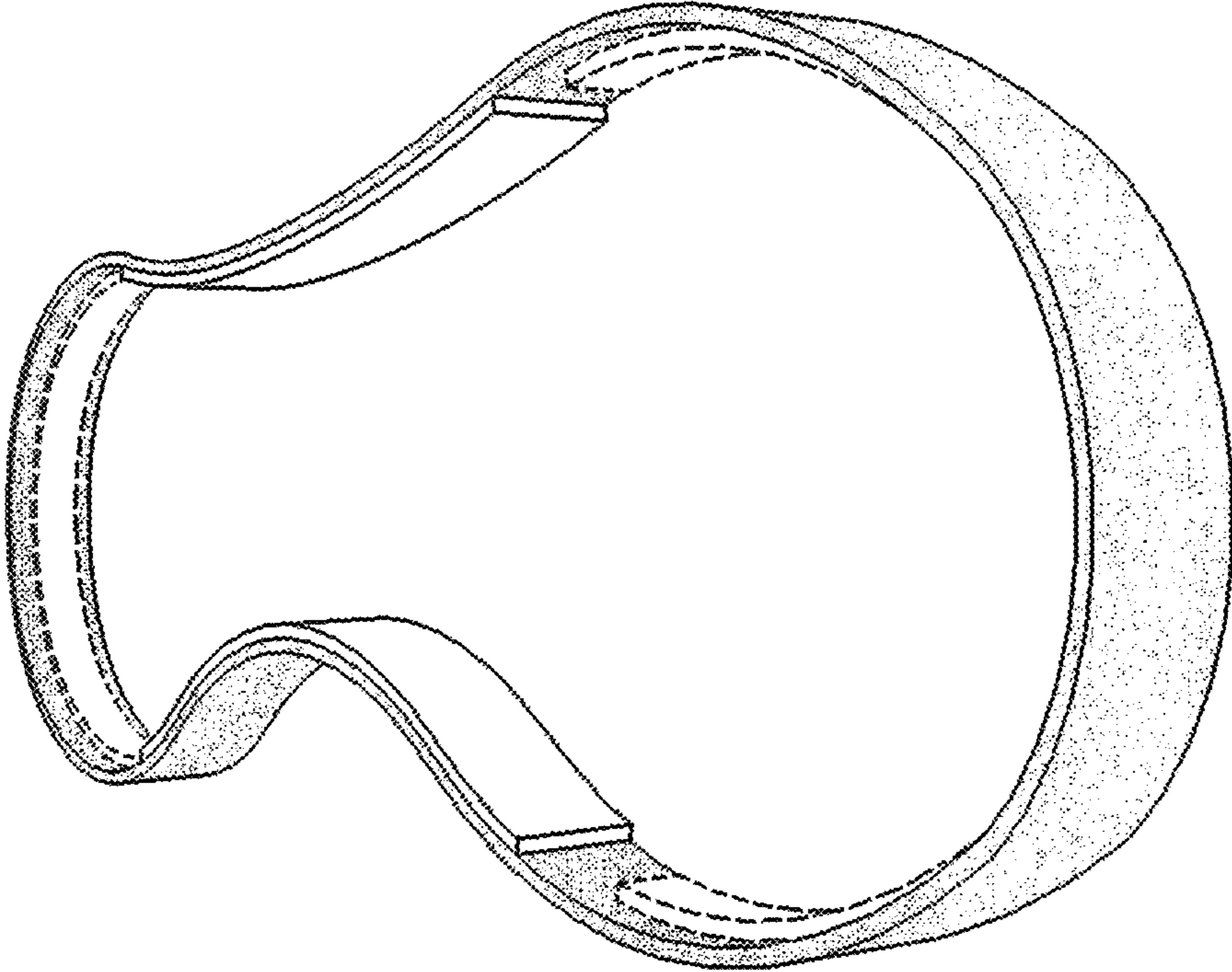

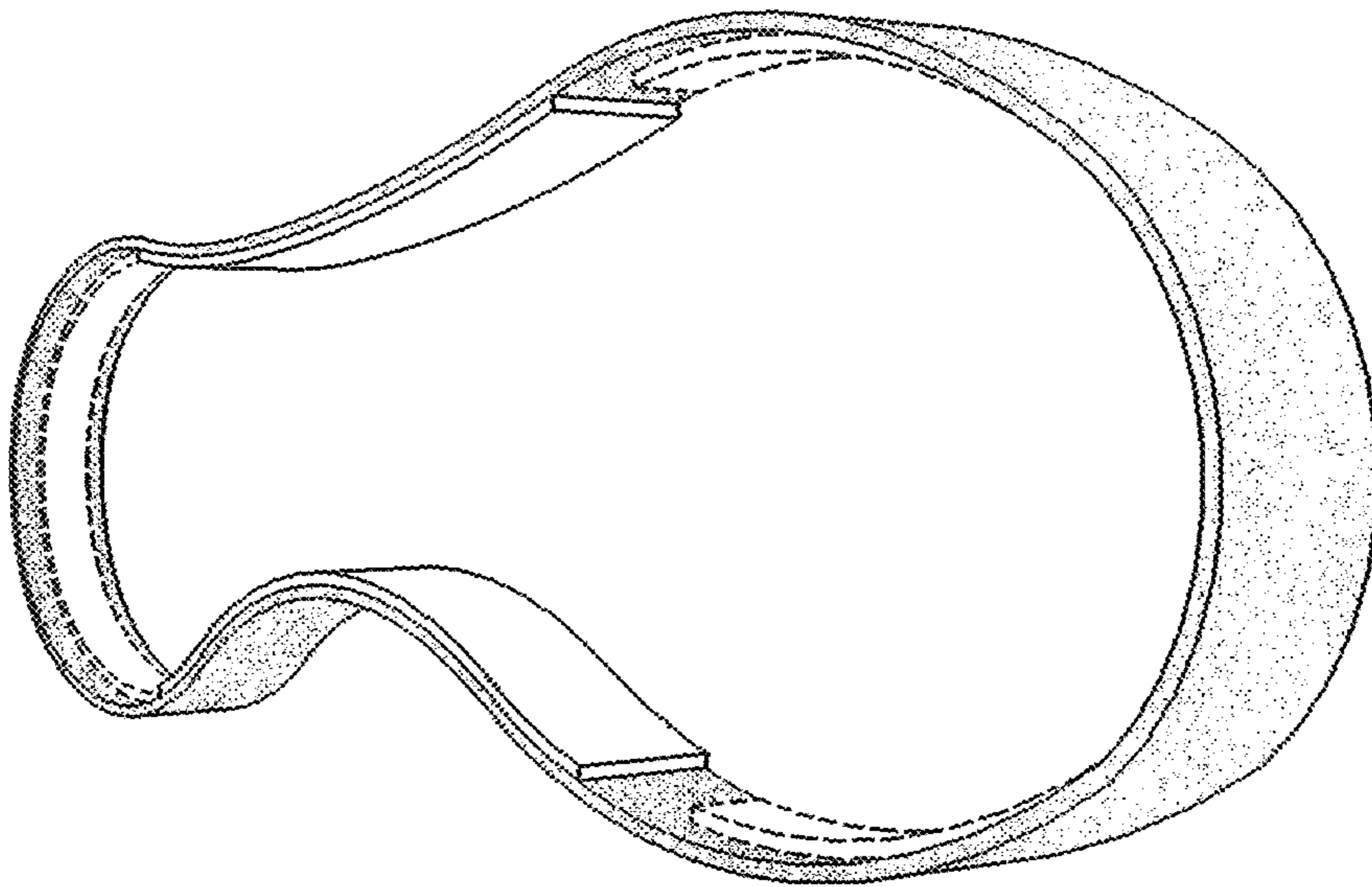

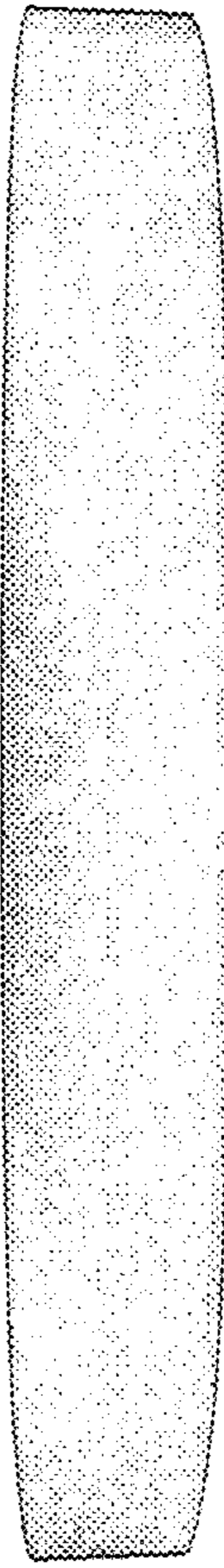

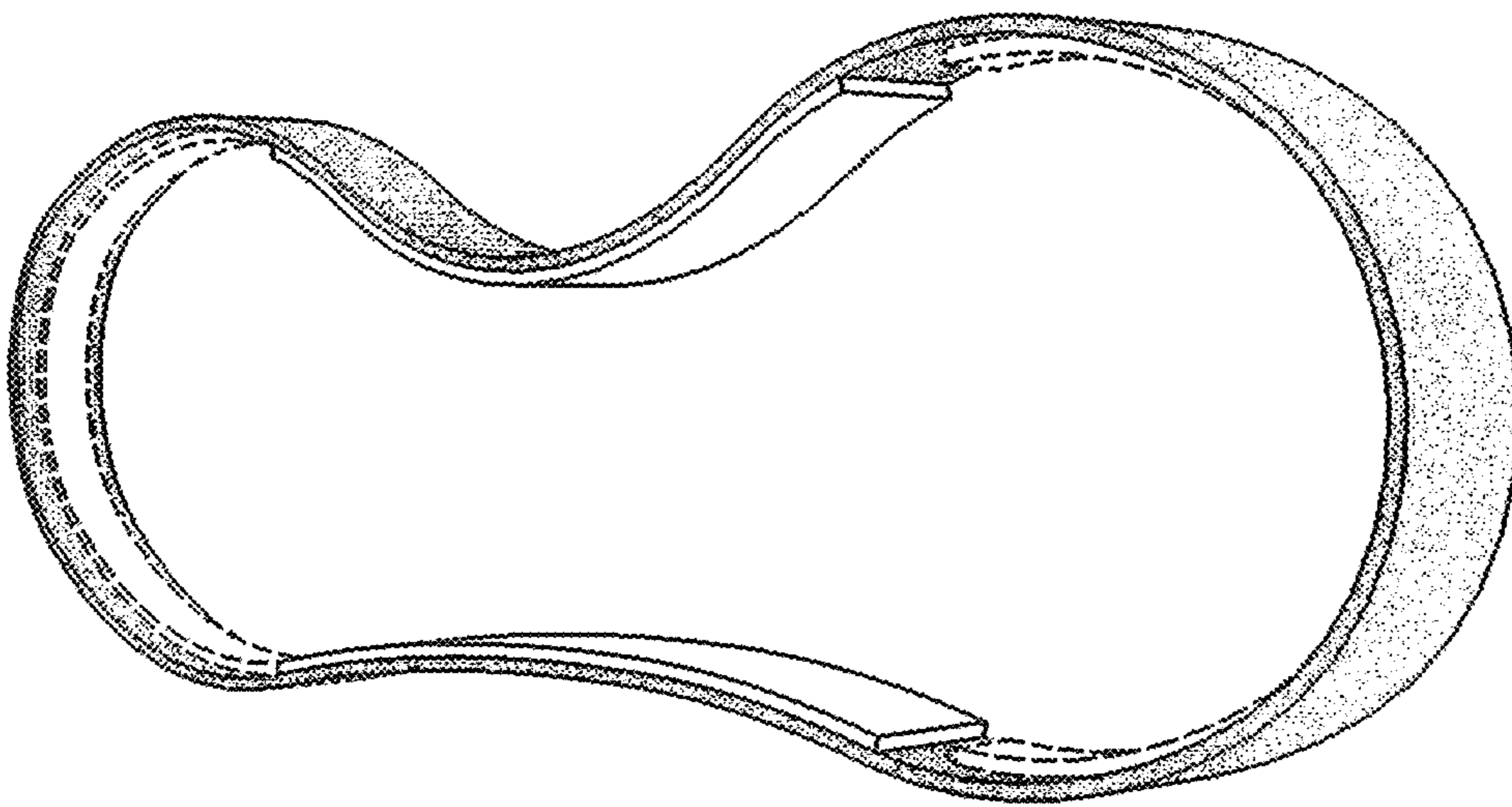

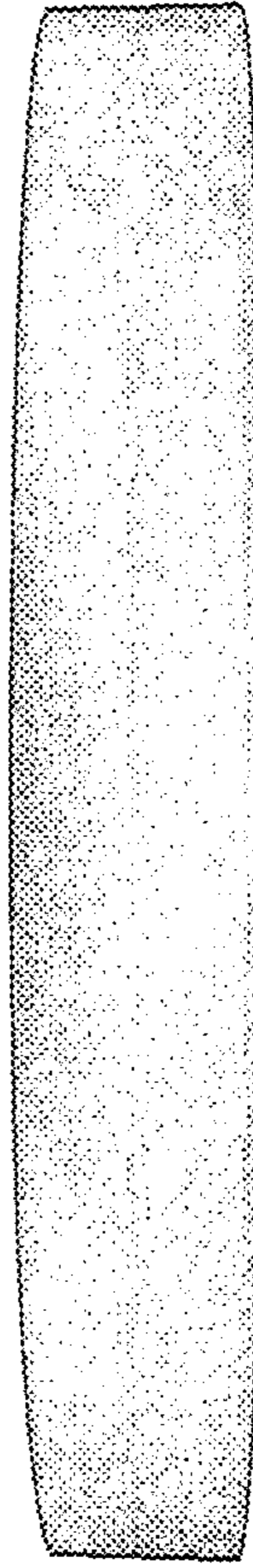

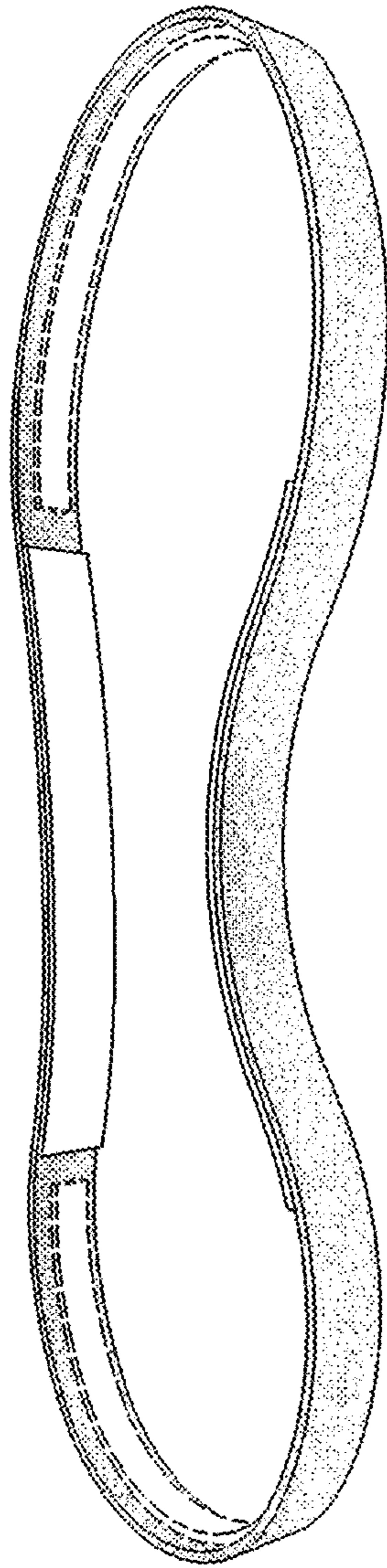

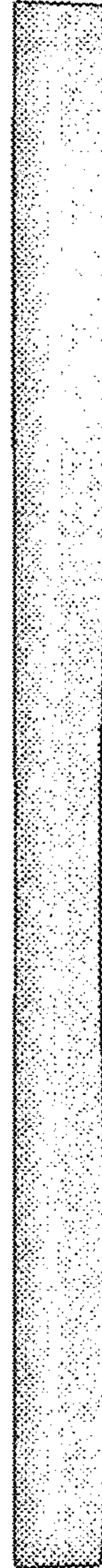

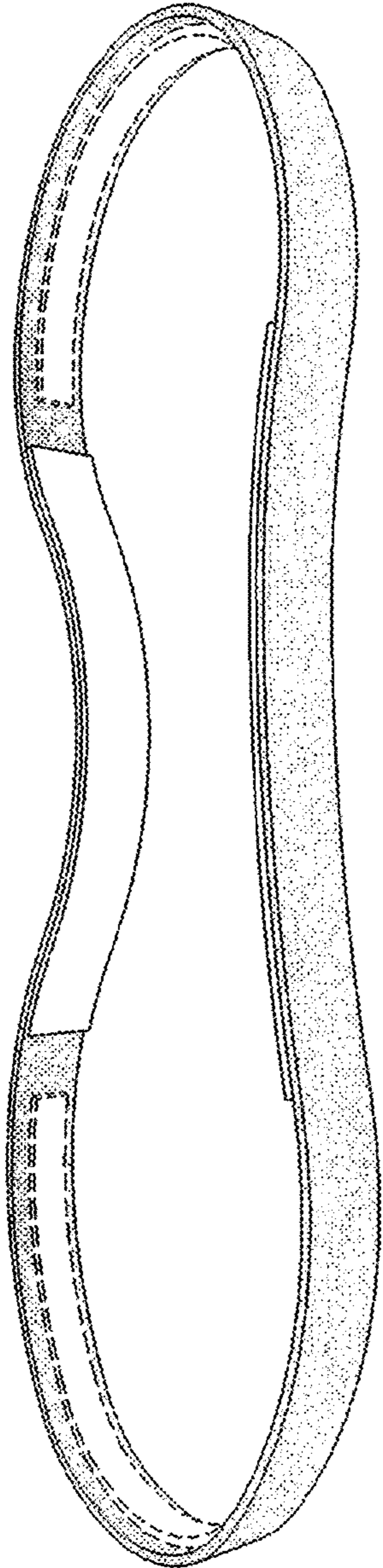

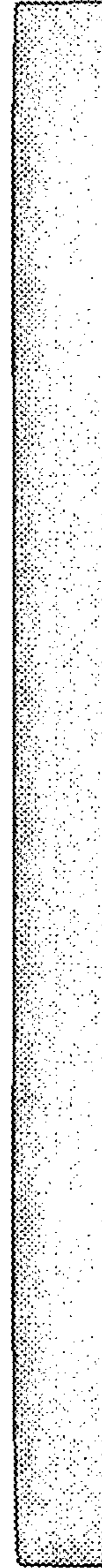

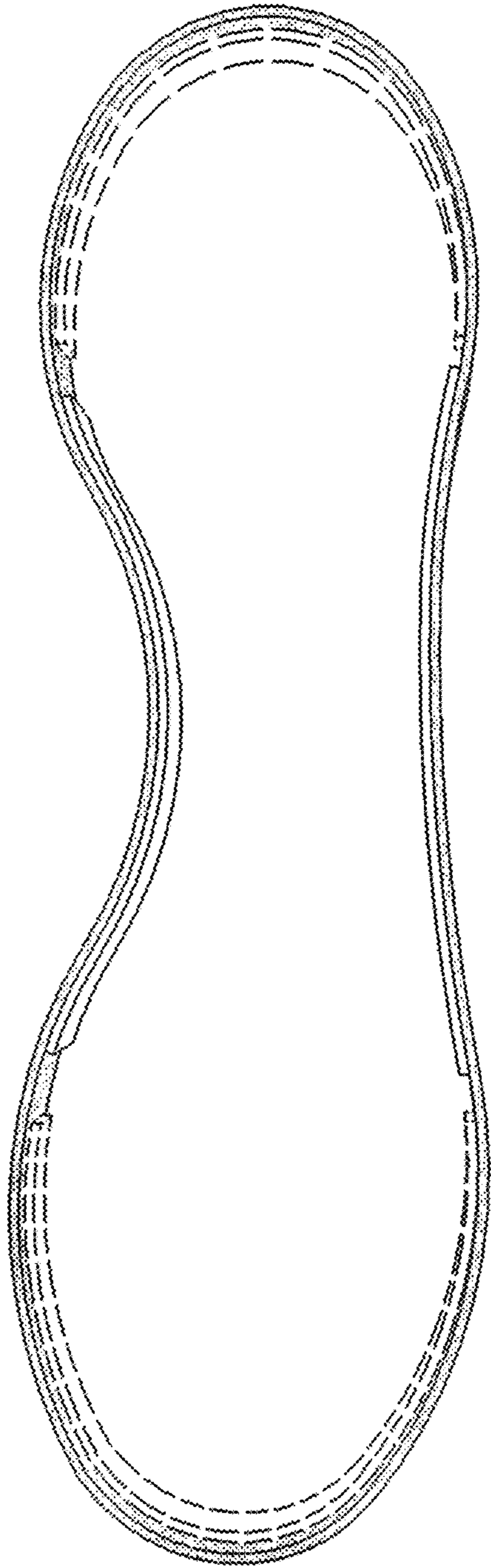

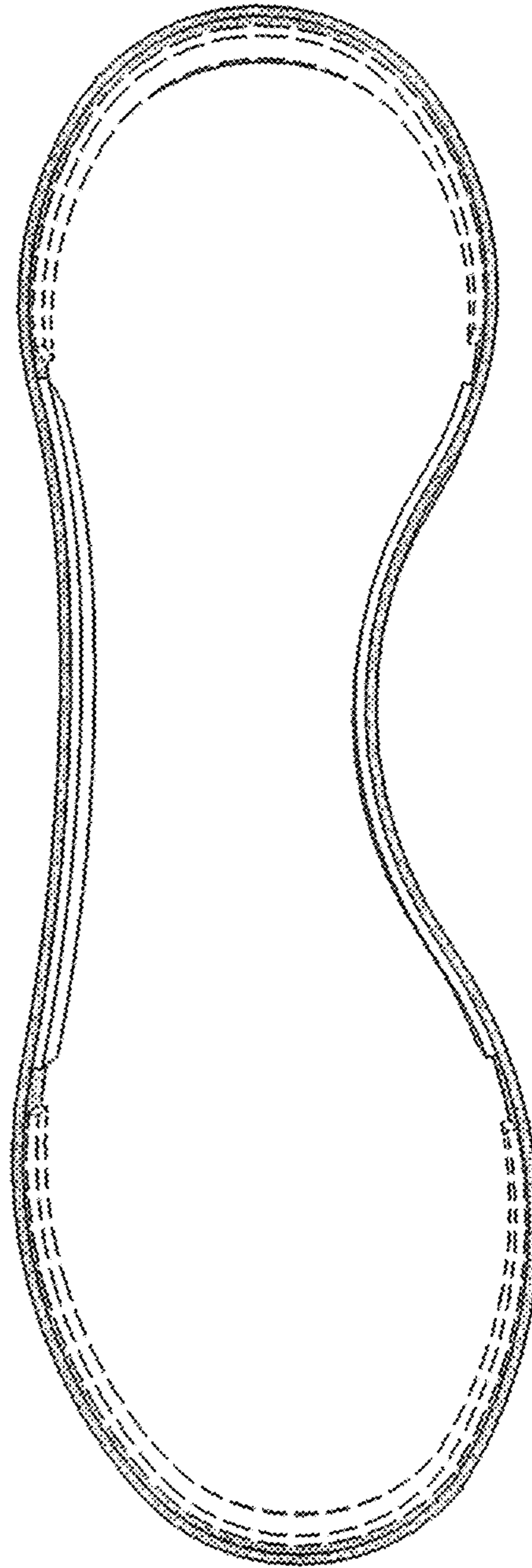

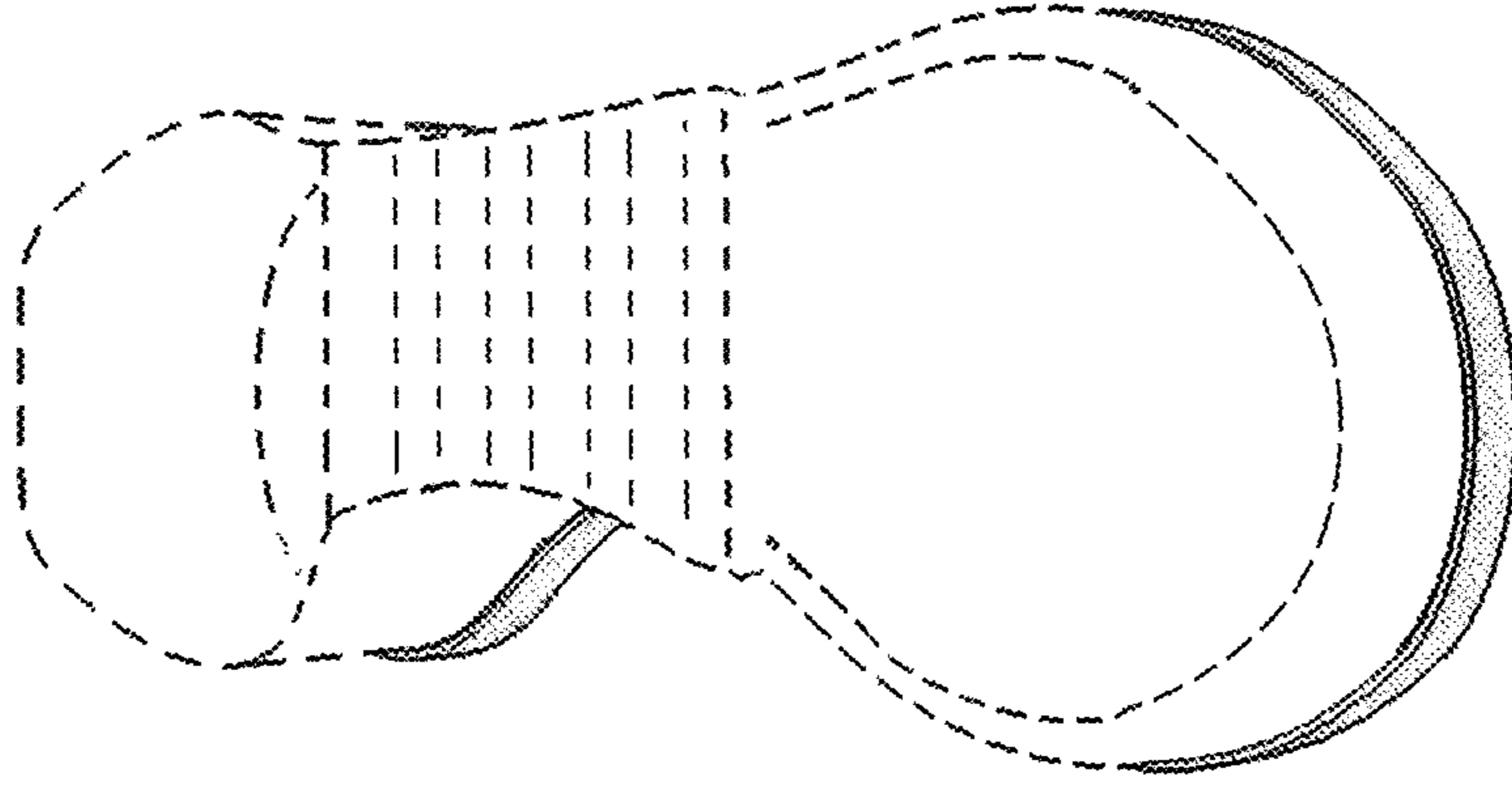

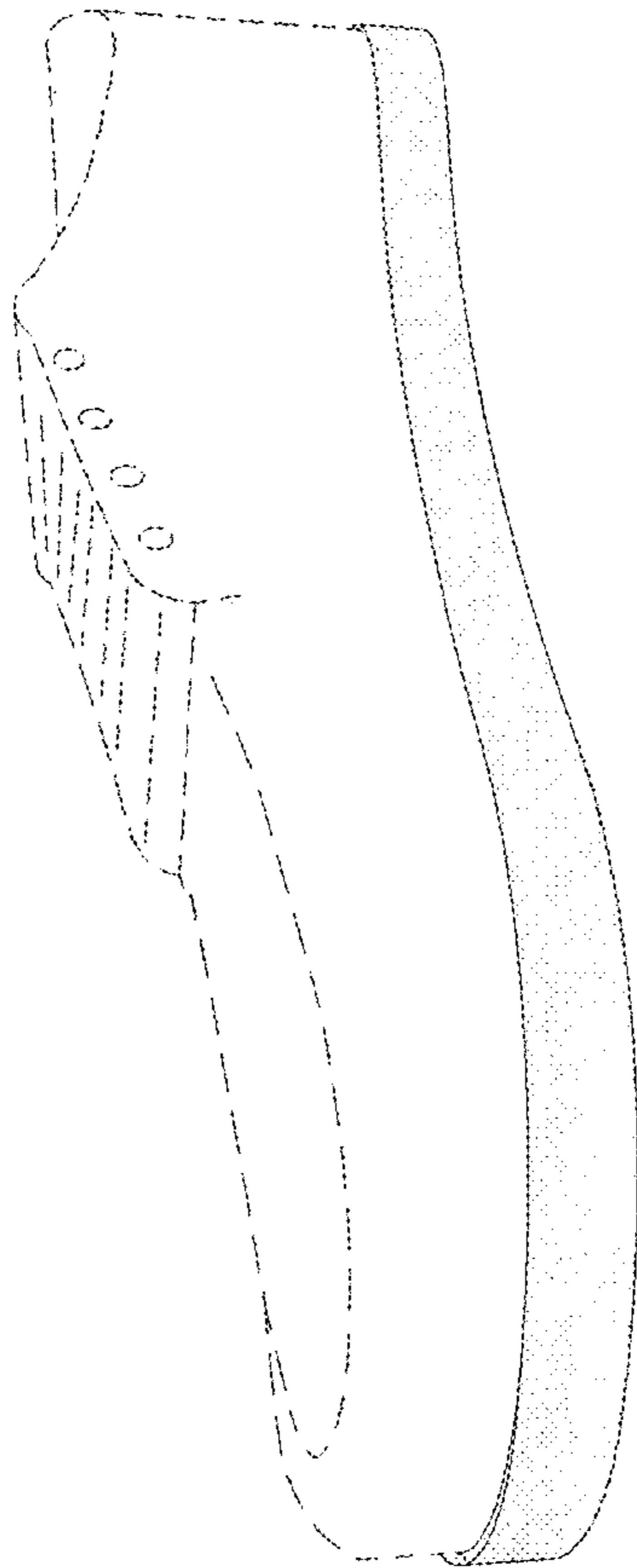

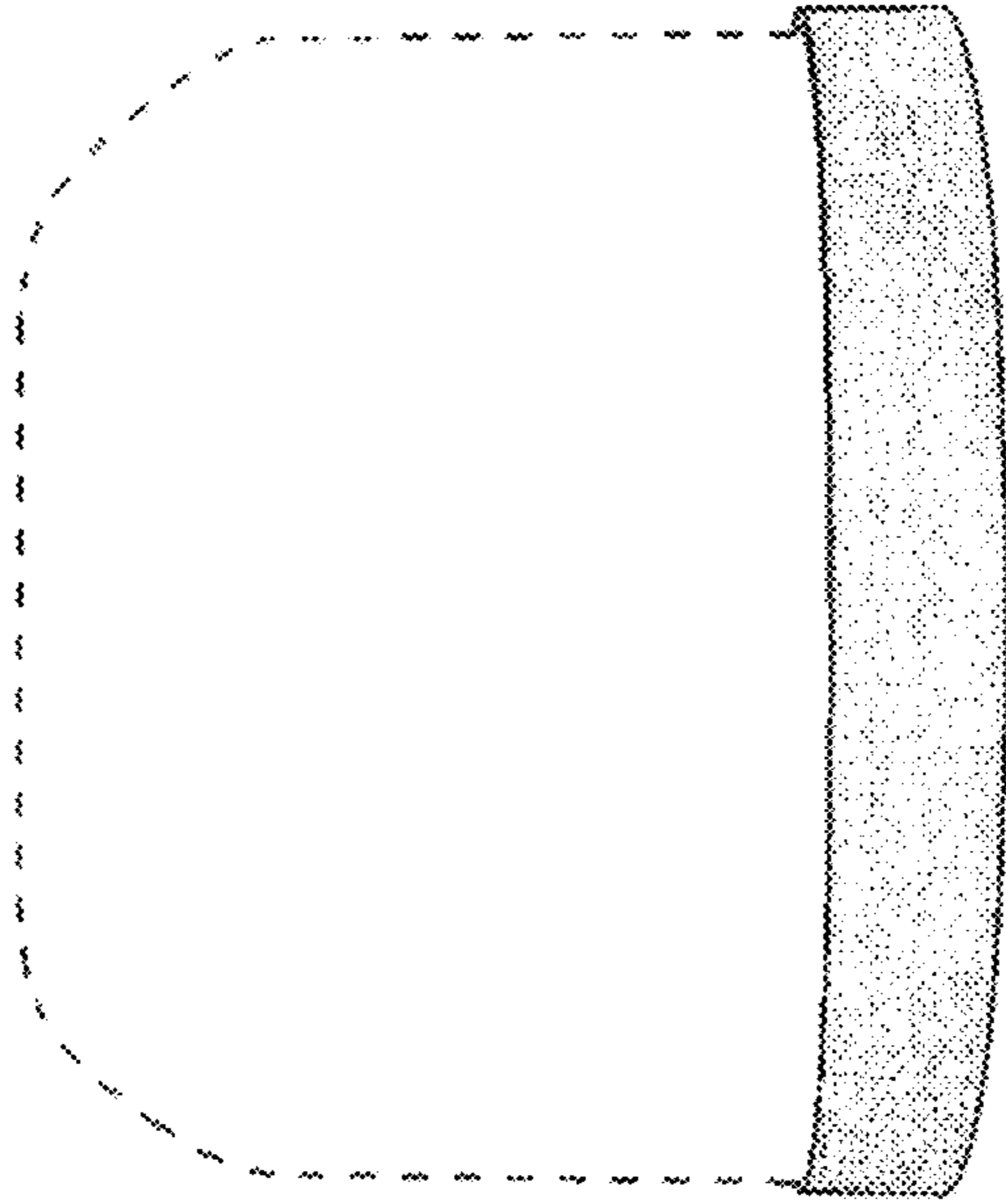

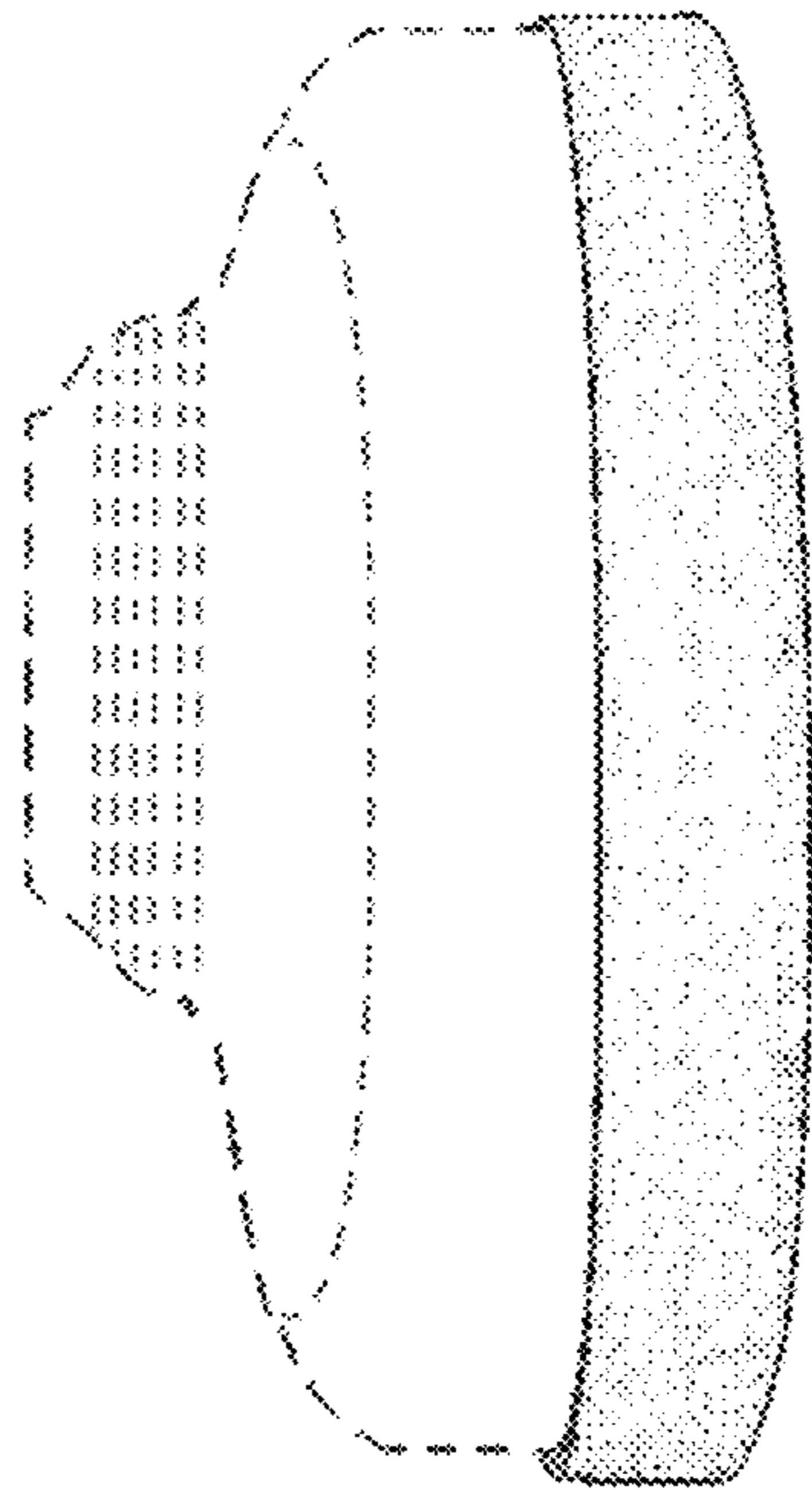

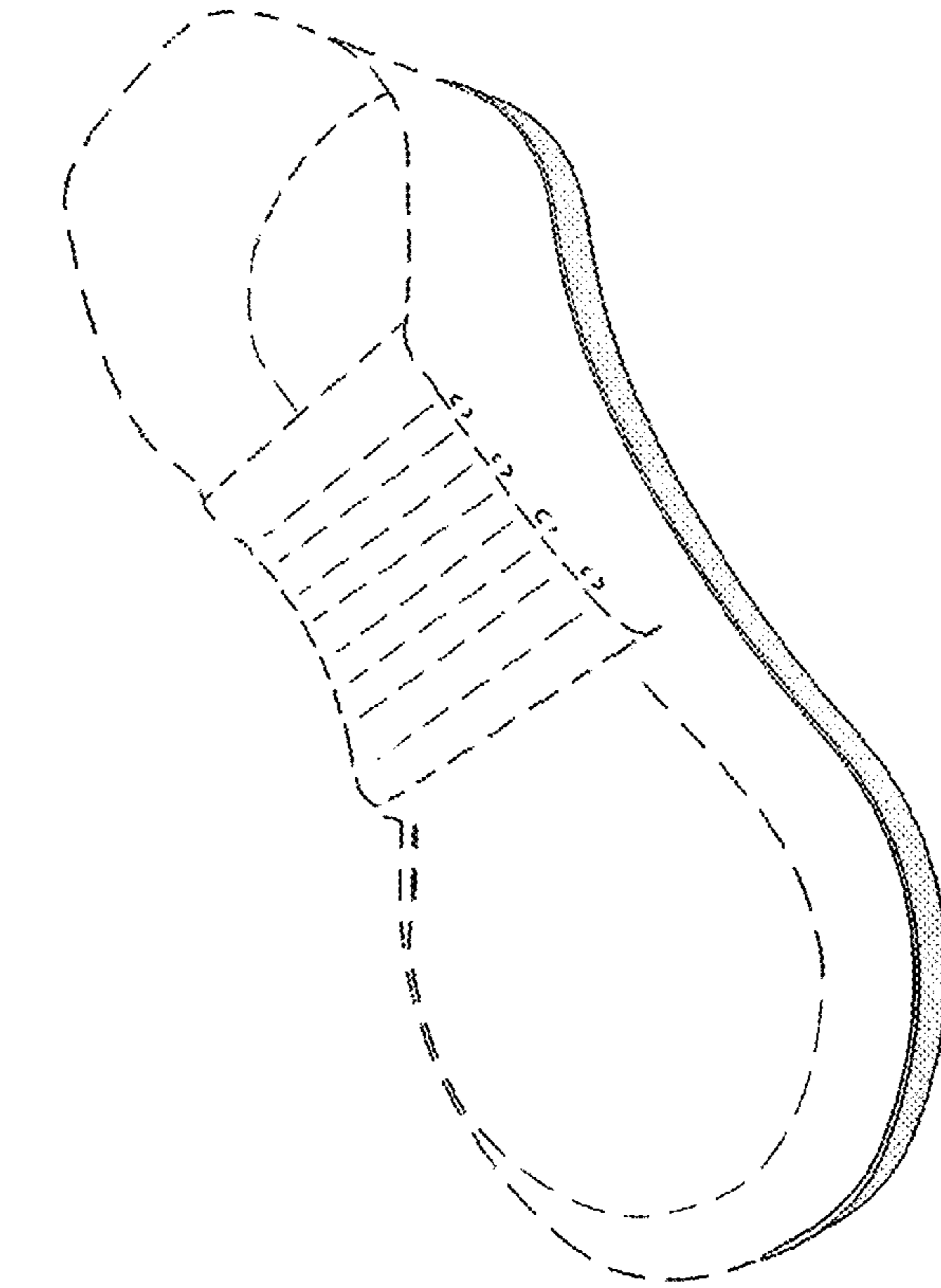

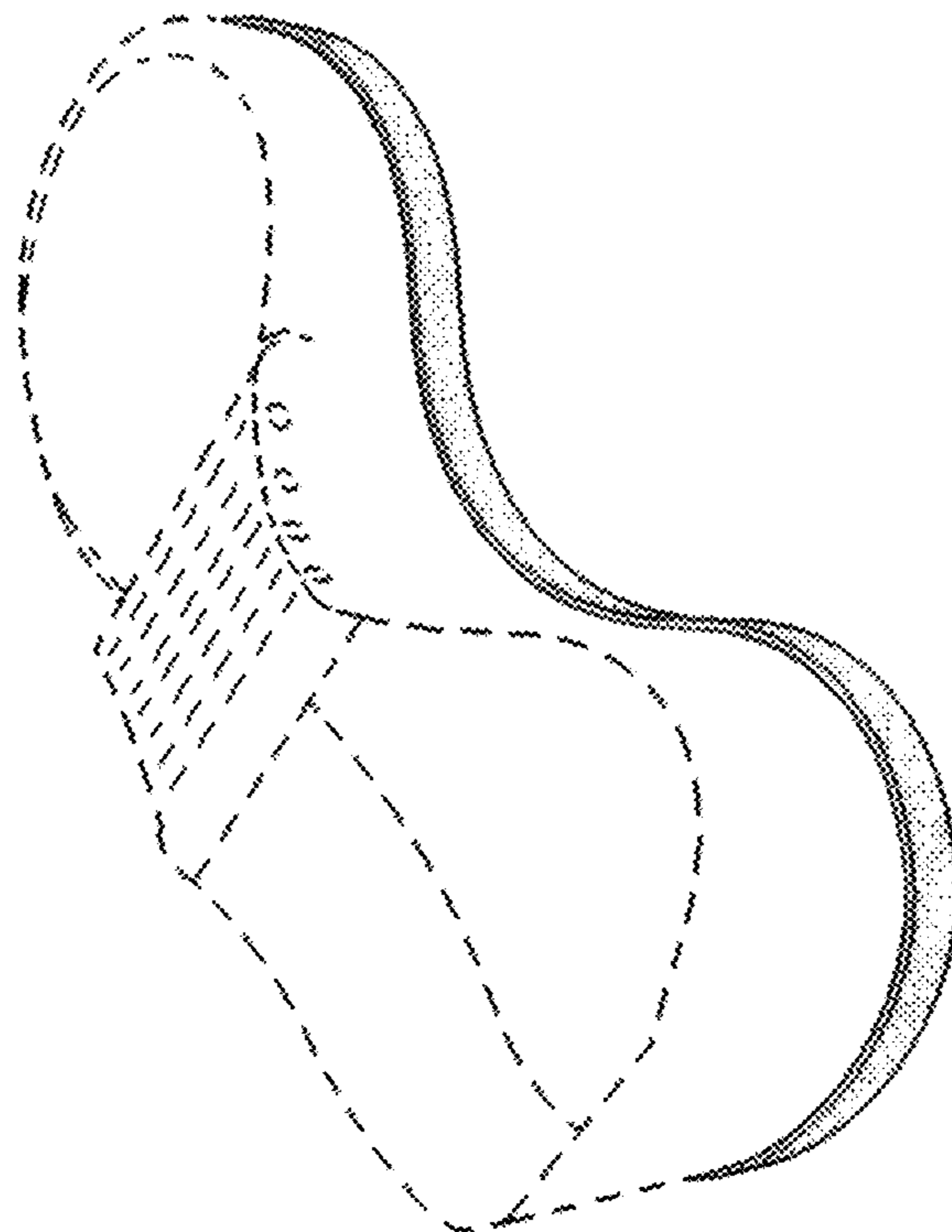

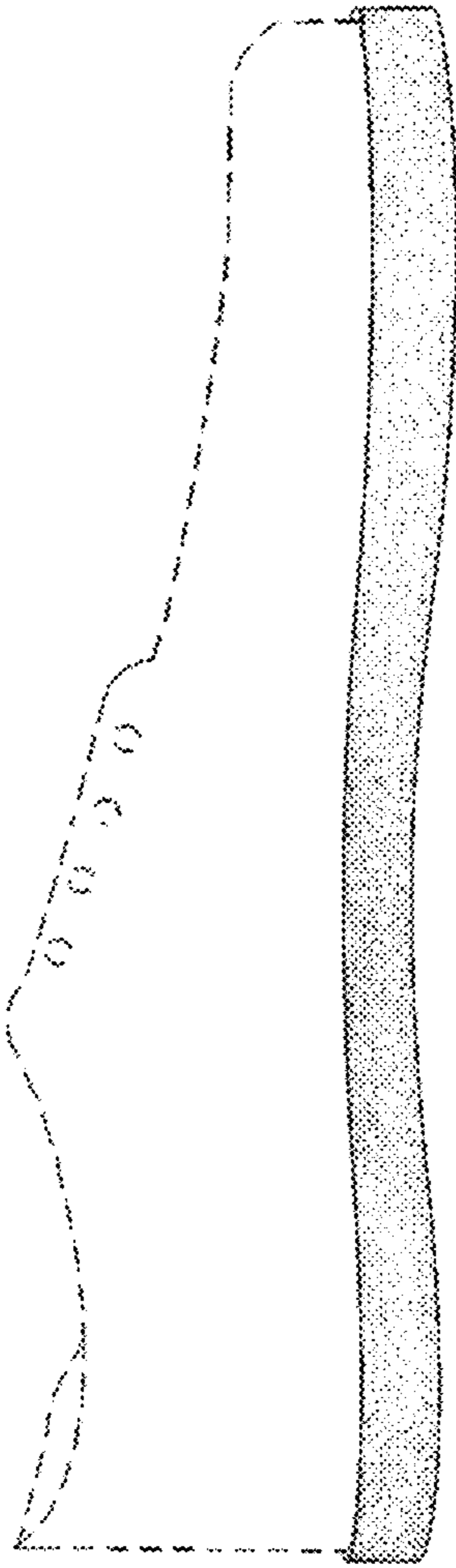

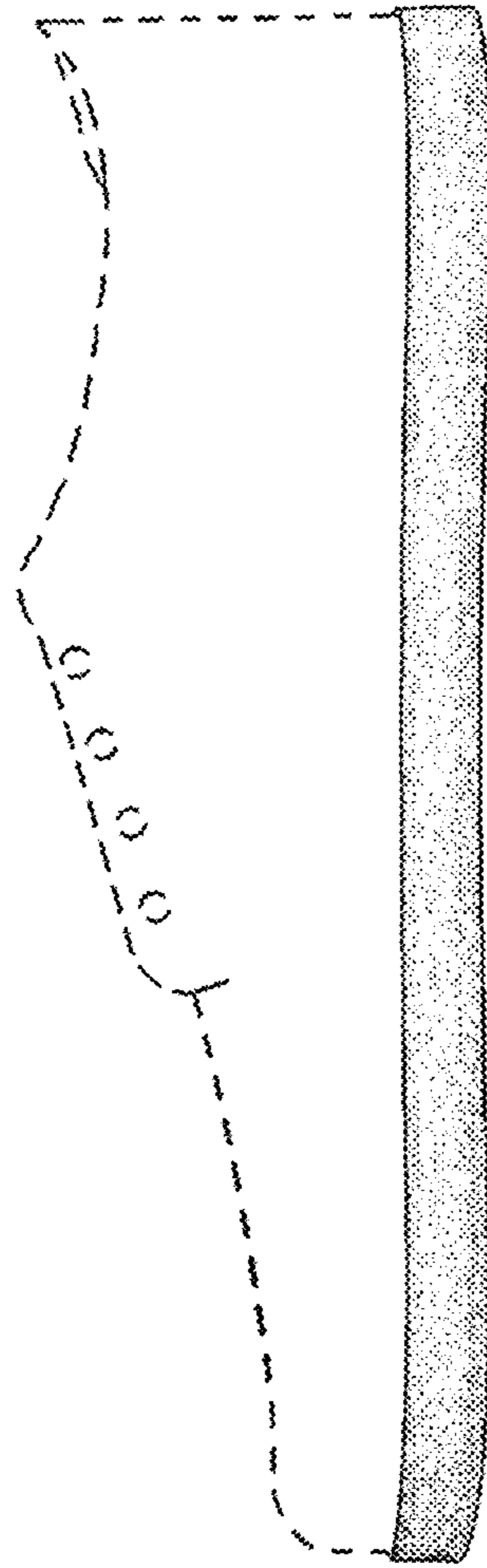
