(57) **CLAIM**

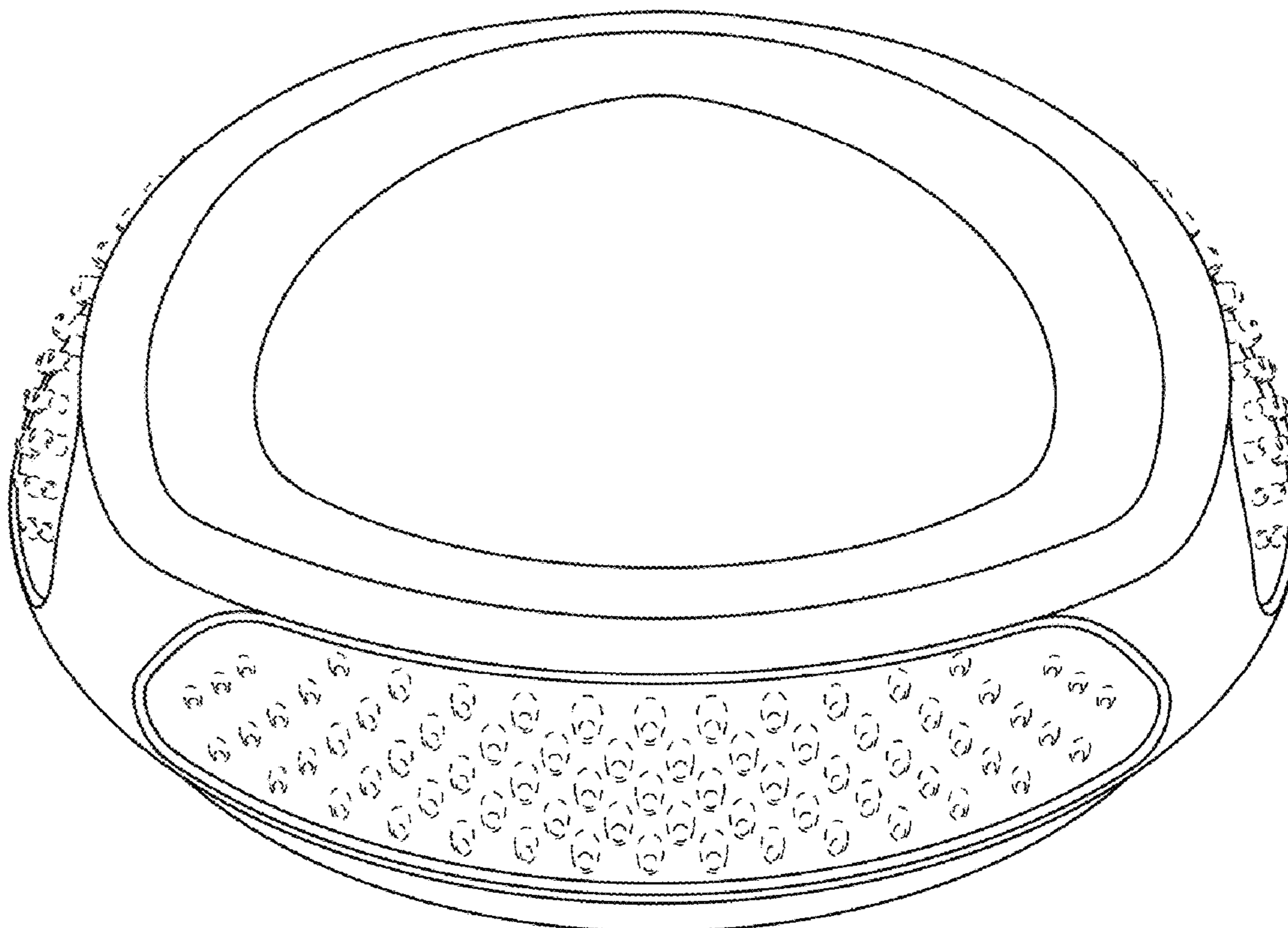
I claim the ornamental design for a lace tightening device dial, substantially as shown and described.

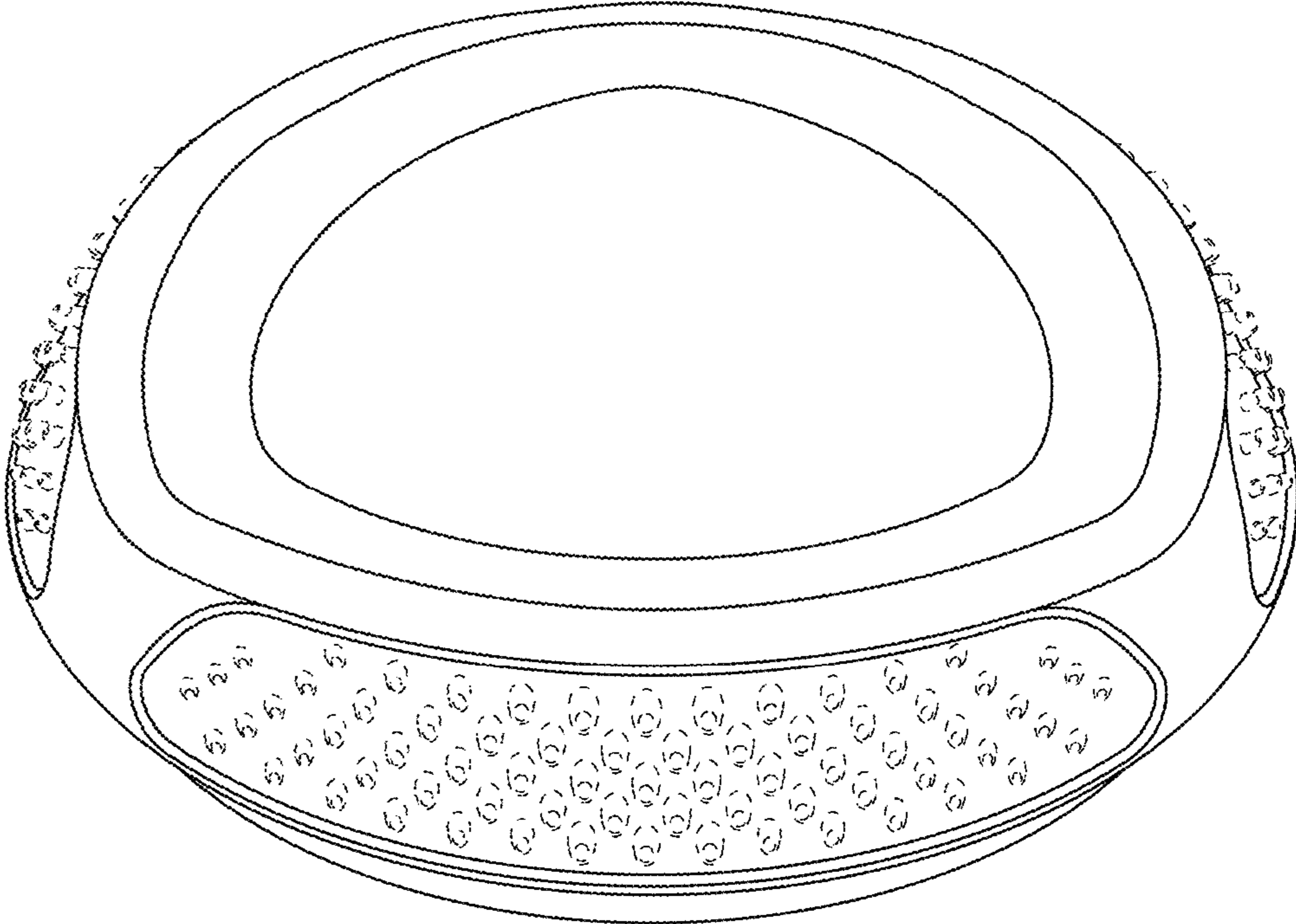

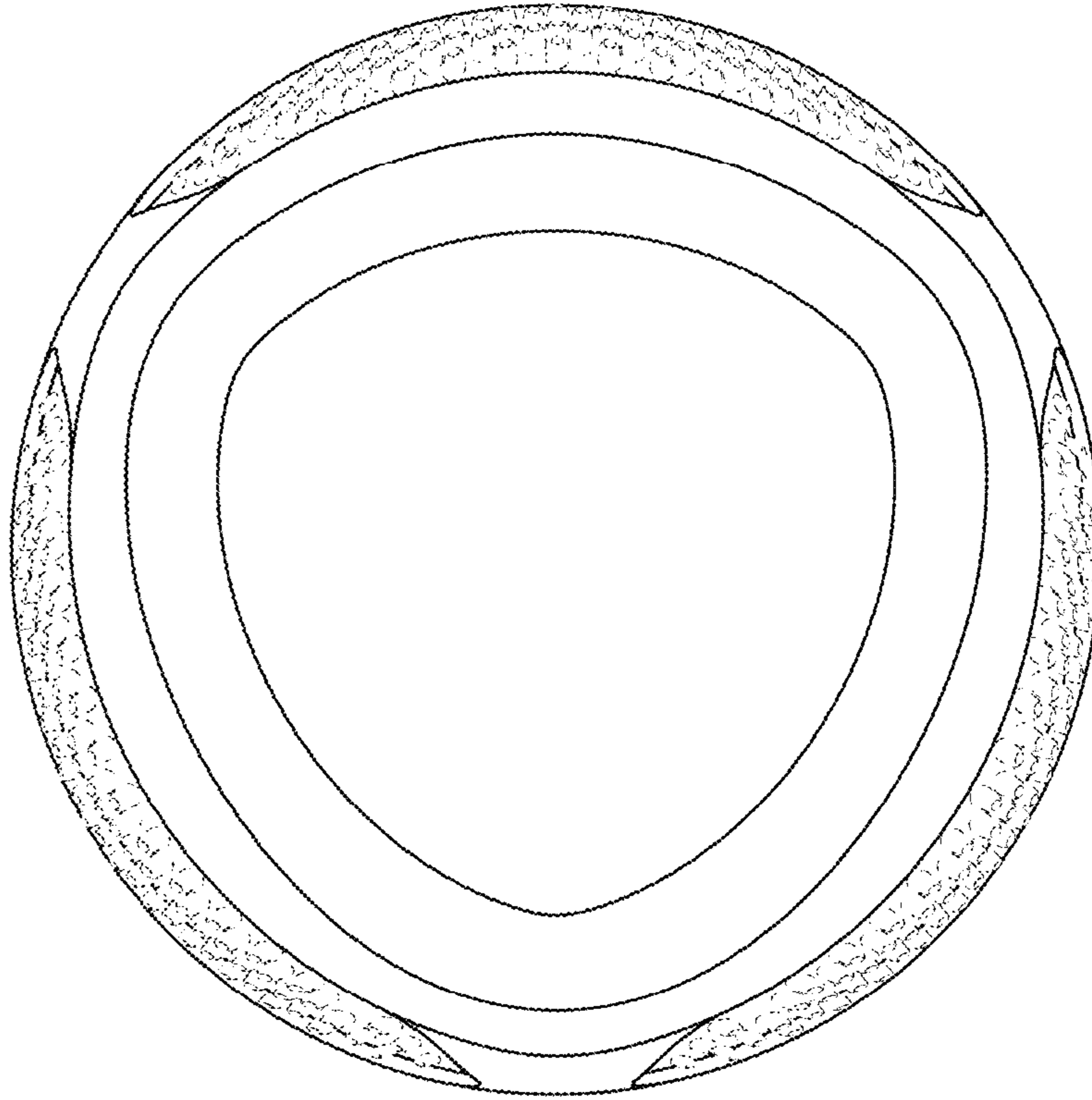

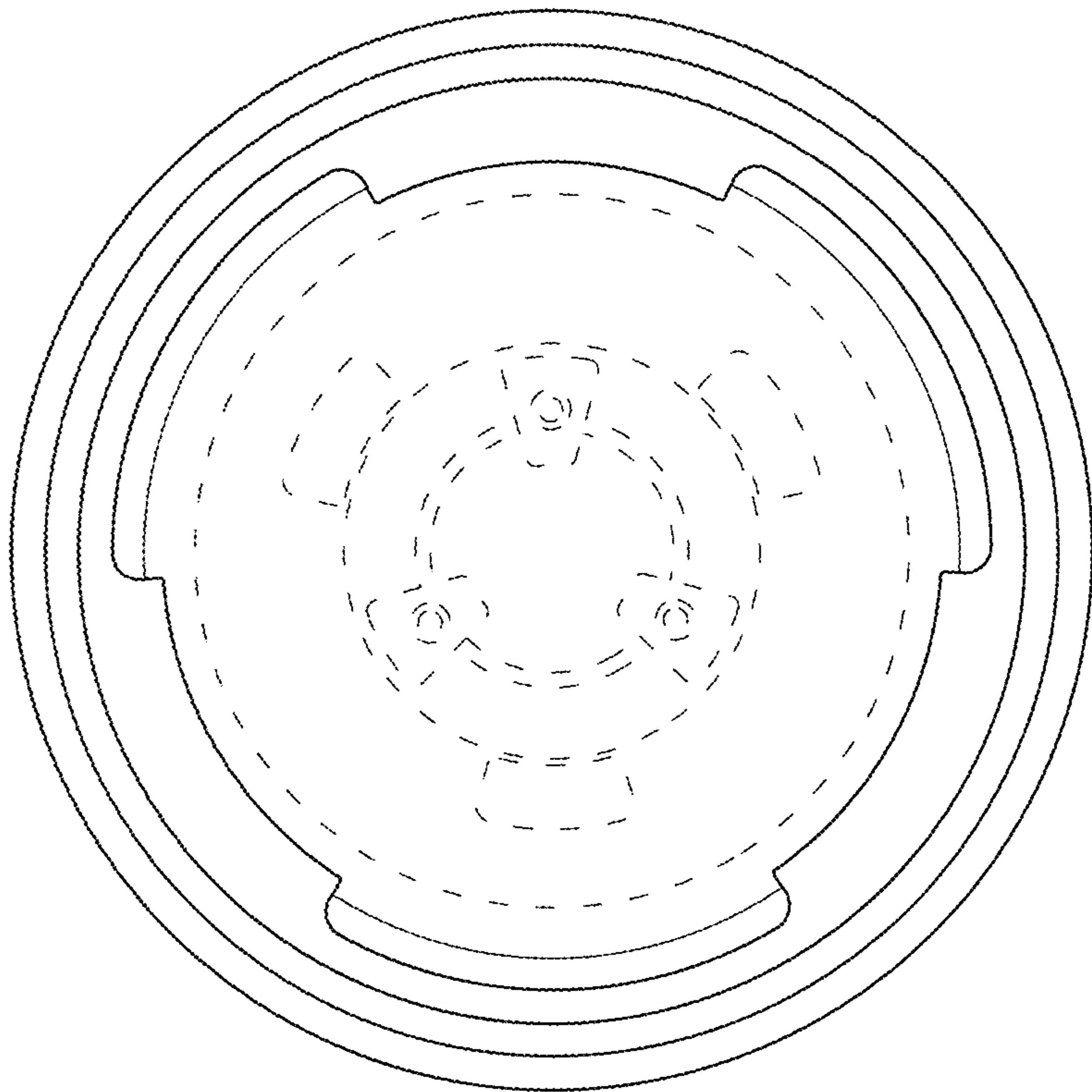

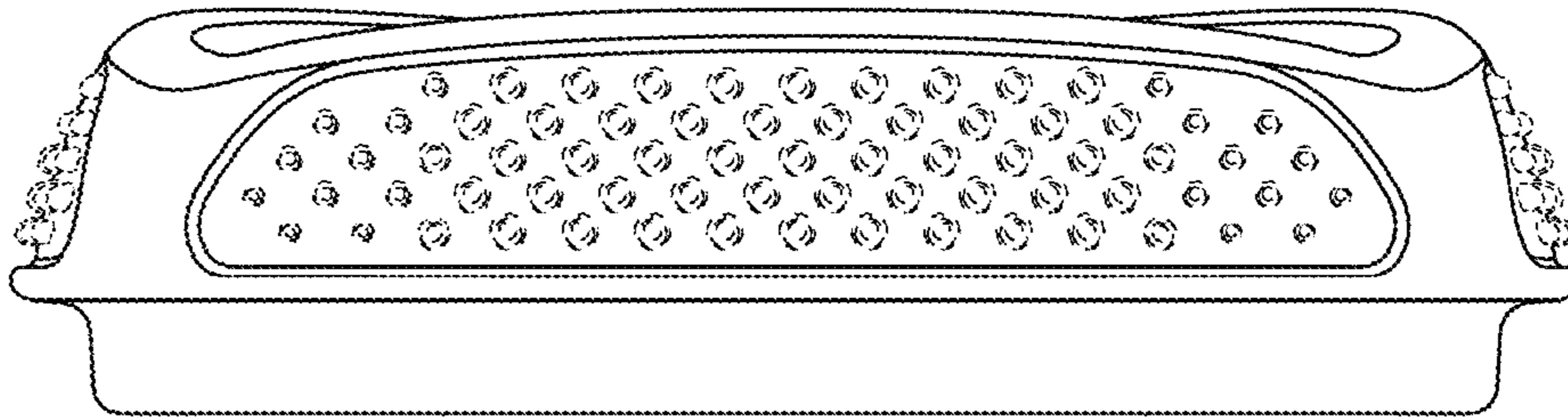

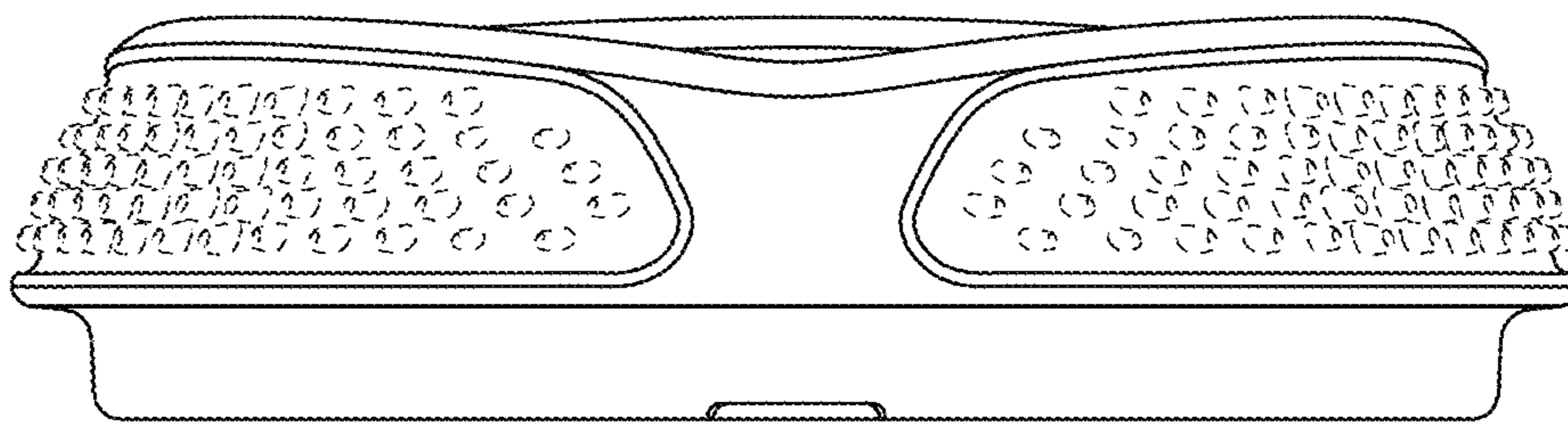

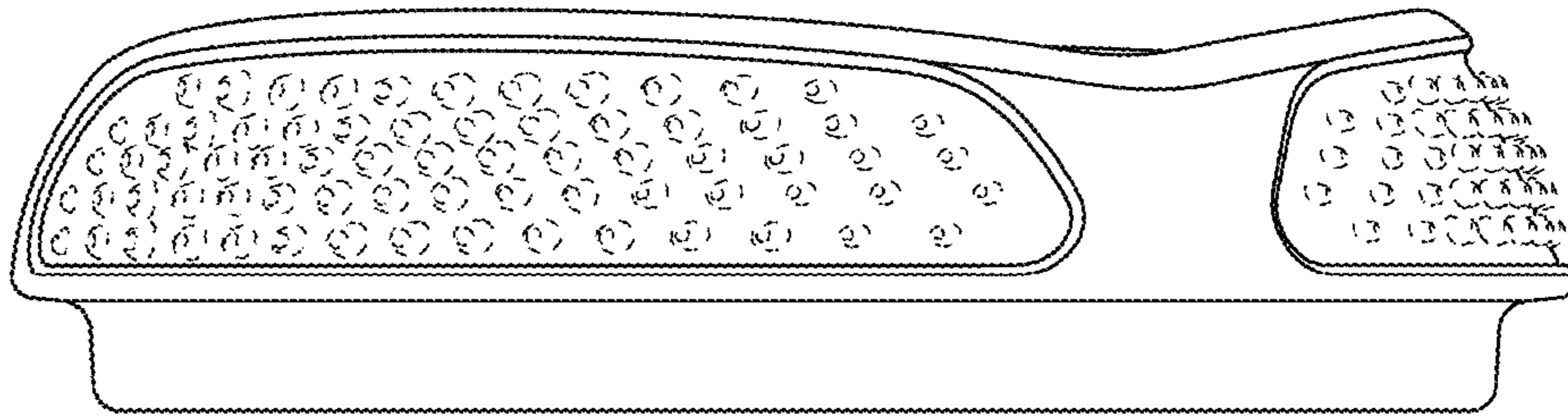

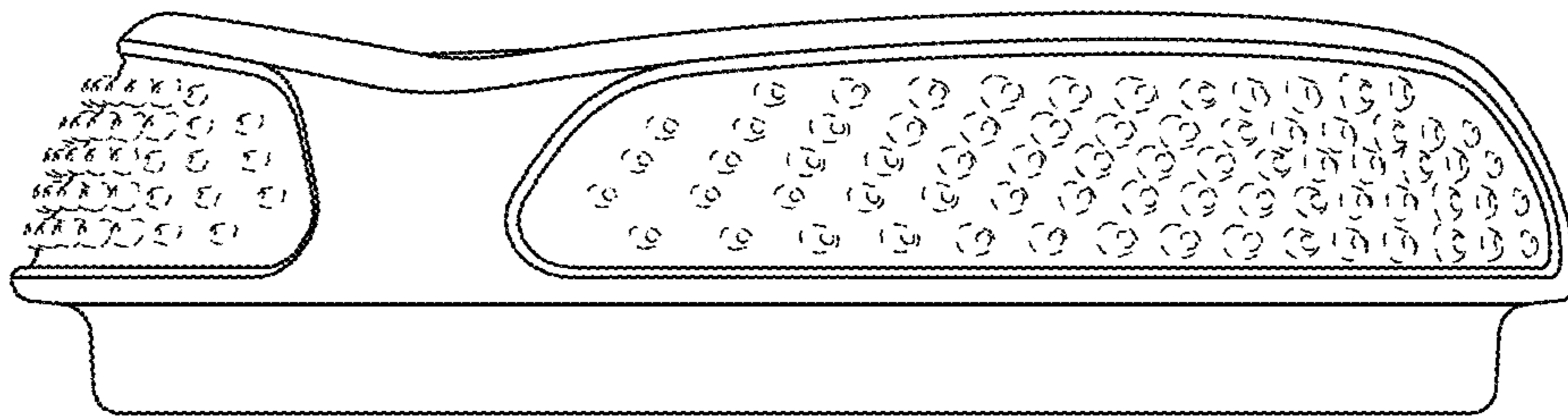
